(57) **CLAIM**

The ornamental design for a motorized umbrella anchor, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the motorized umbrella anchor of the present invention, the rear view being a mirror image thereof;

FIG. 2 is a left side elevational view of the motorized umbrella anchor of FIG. 1;

FIG. 3 is a right side elevational view of the motorized umbrella anchor of FIG. 1;

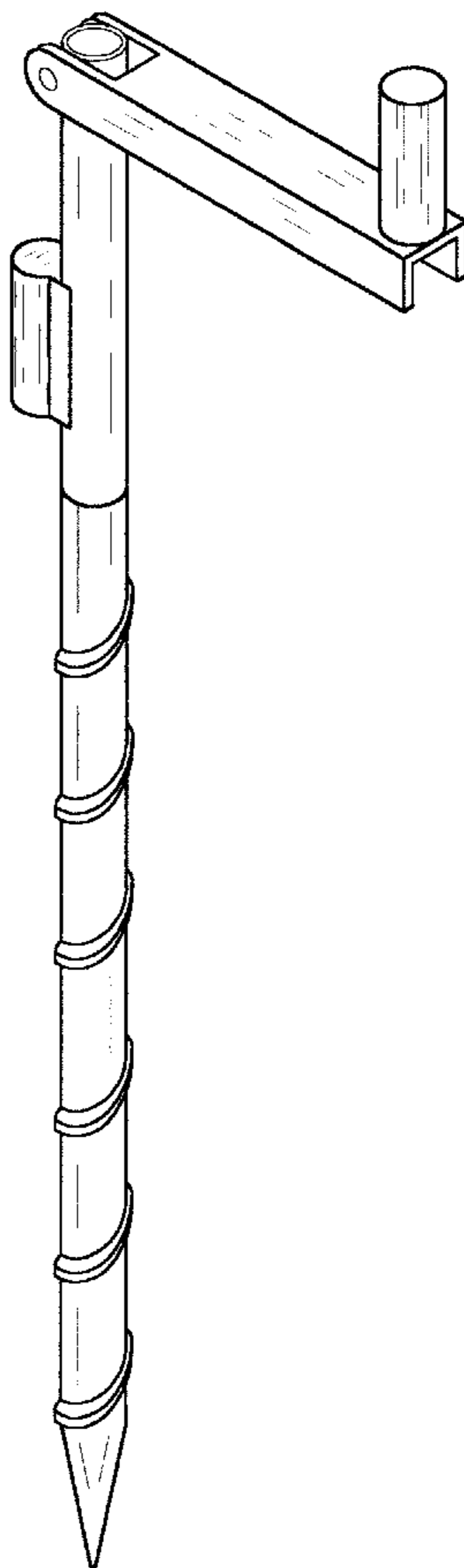
FIG. 4 is a top plan view of the motorized umbrella anchor of FIG. 1;

FIG. 5 is a bottom plan view of the motorized umbrella anchor of FIG. 1;

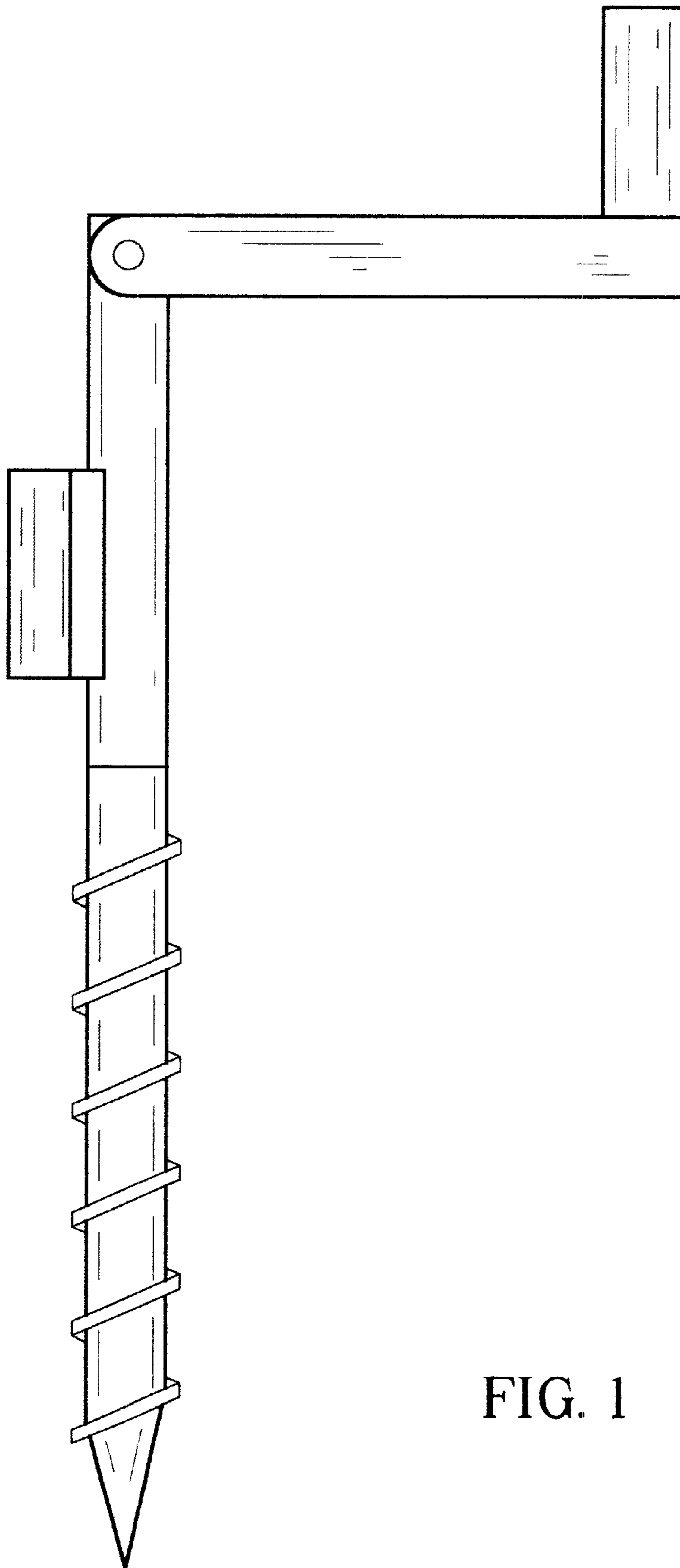

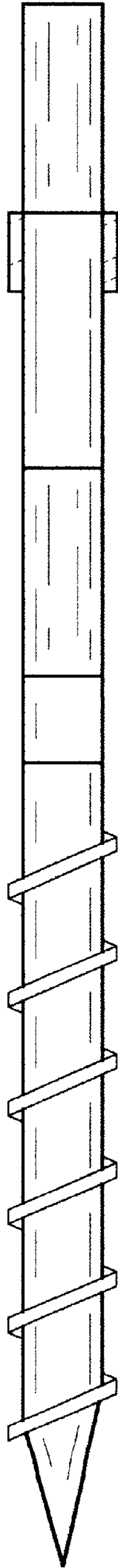

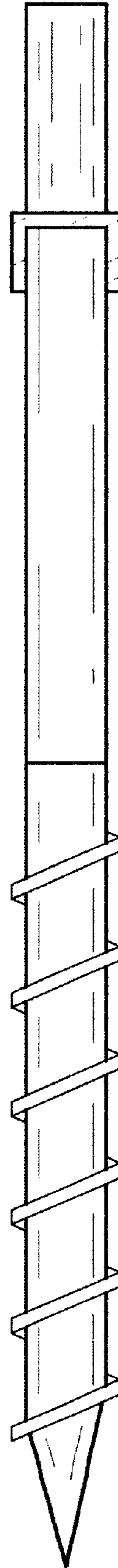

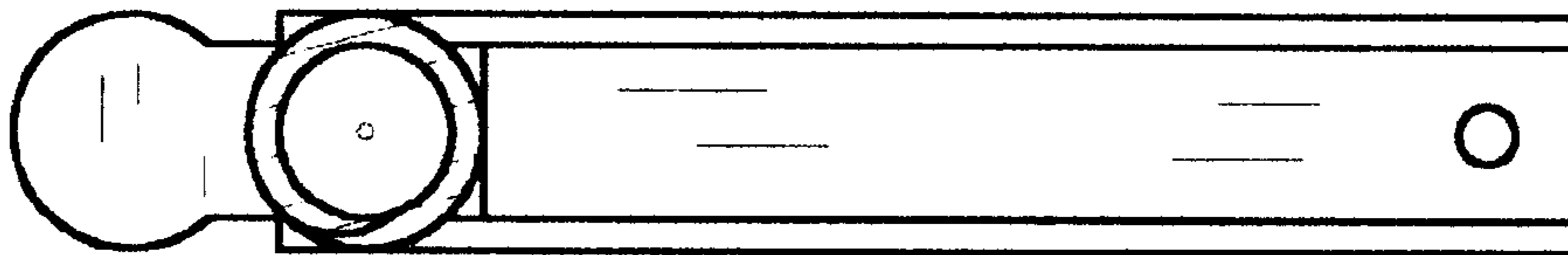
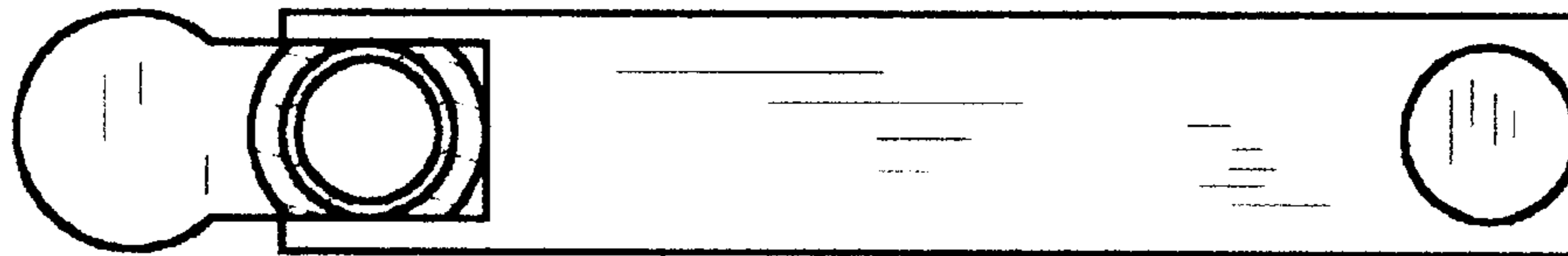

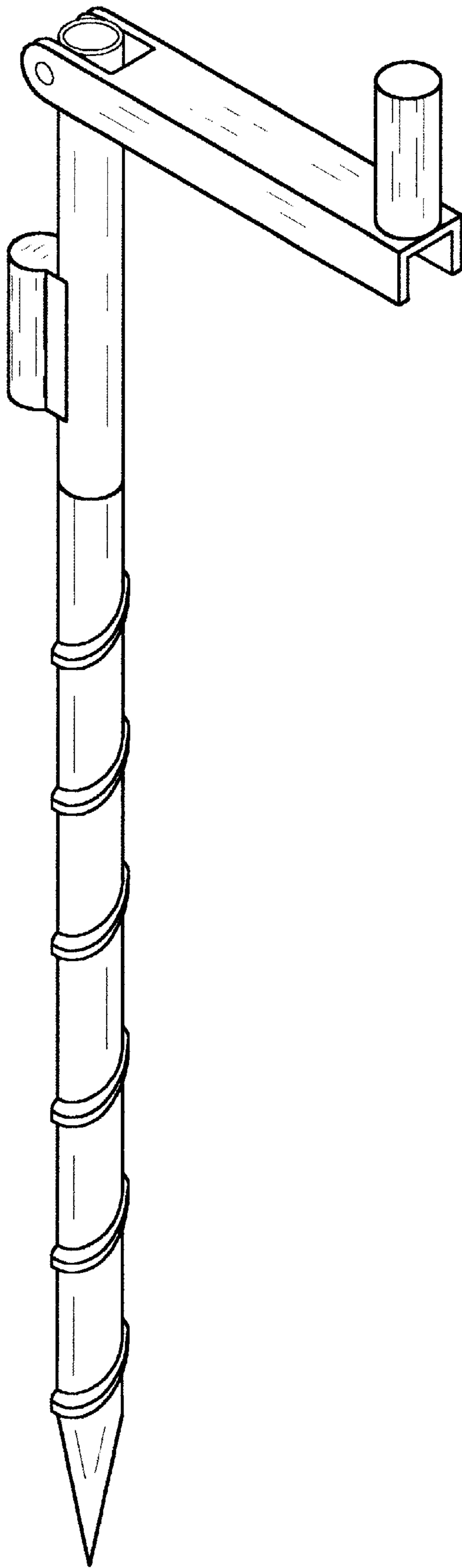

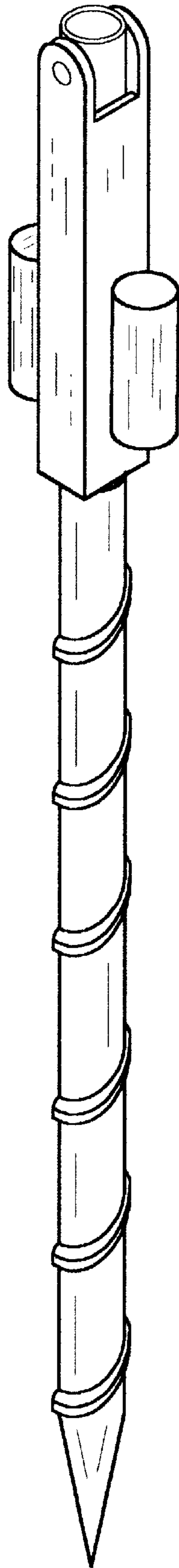
