FIG. 3 is a front view of my invention;

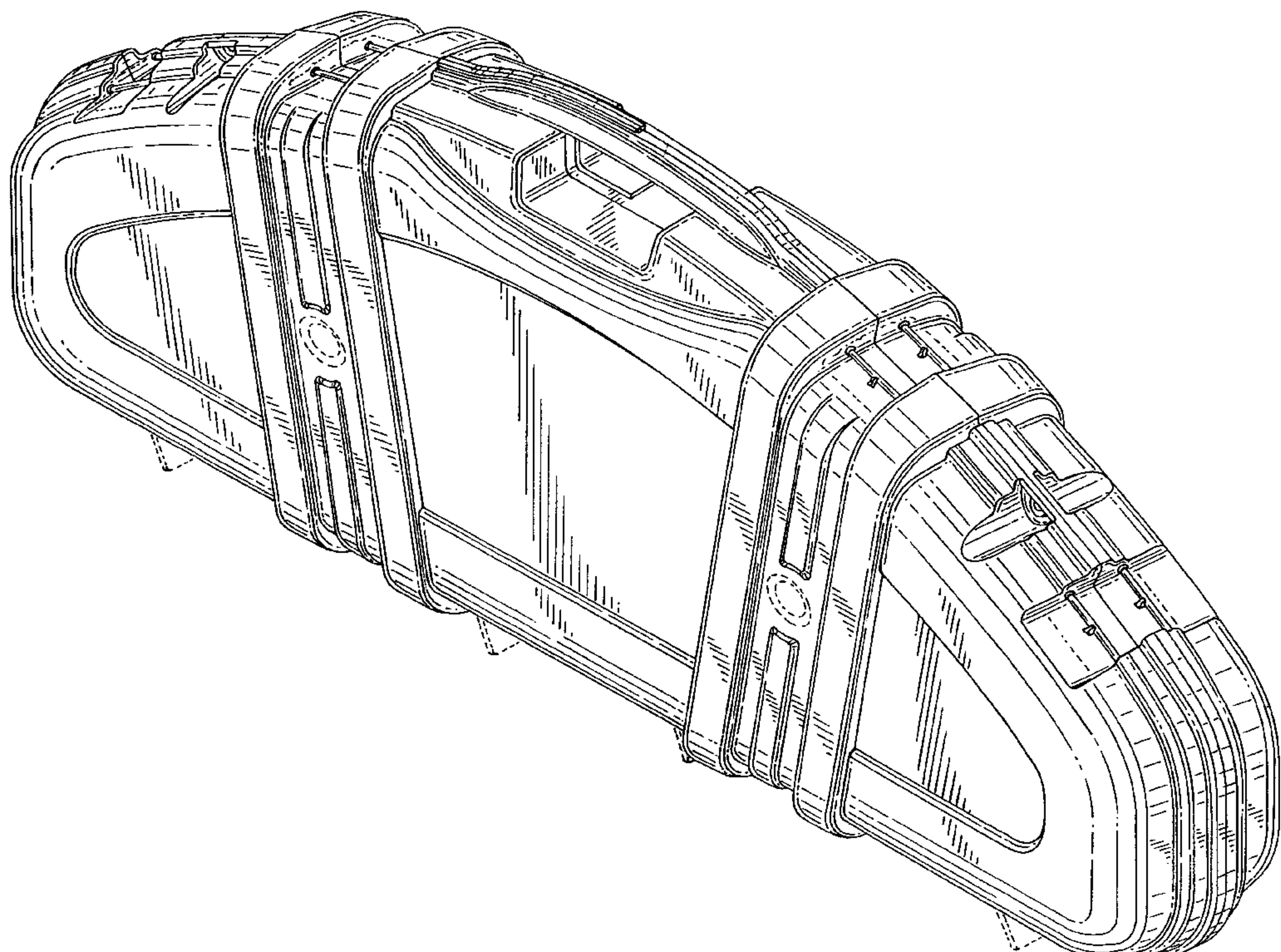
FIG. 4 is a bottom view of my invention;

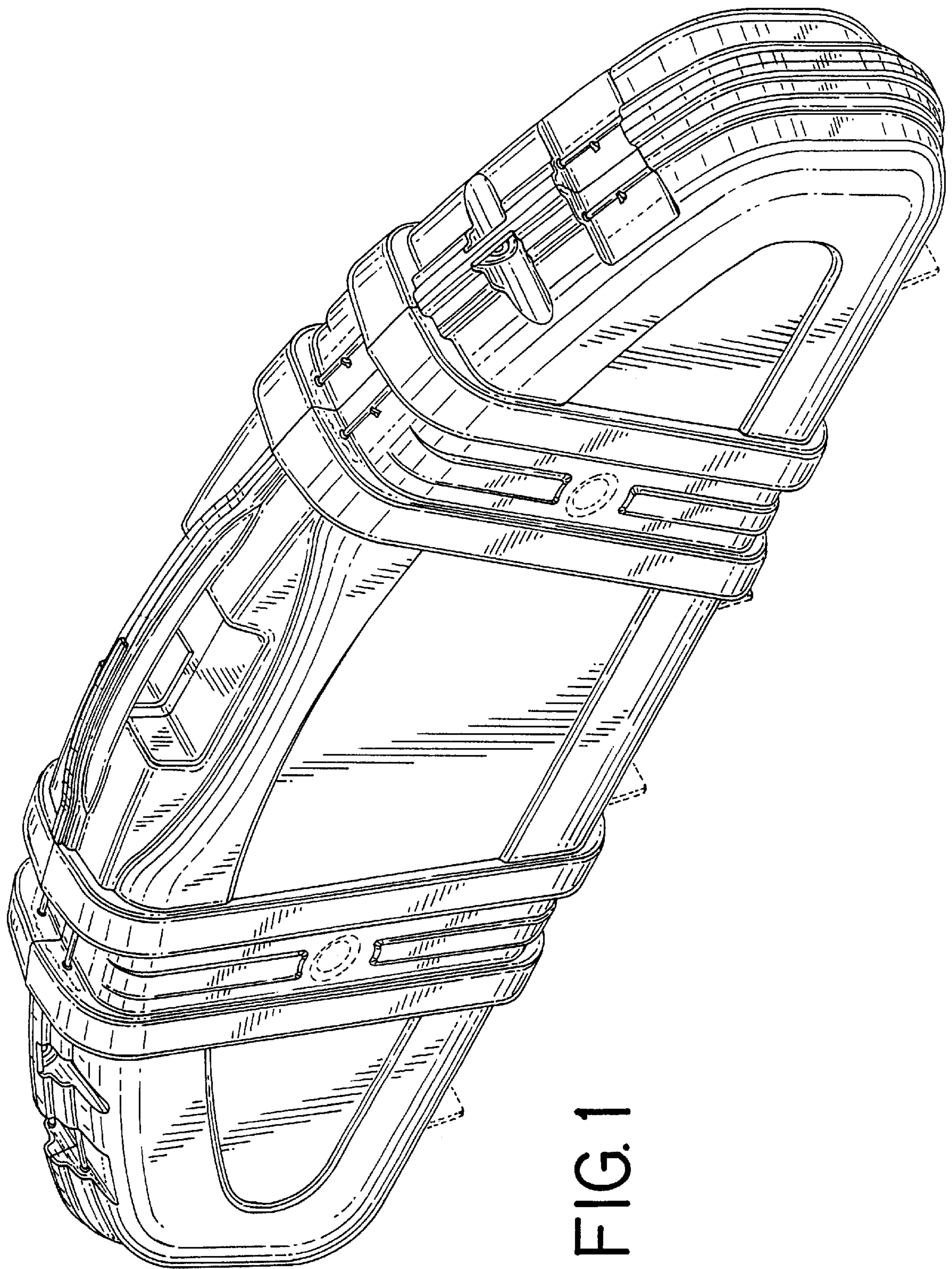
FIG. 5 is a rear view of my invention;

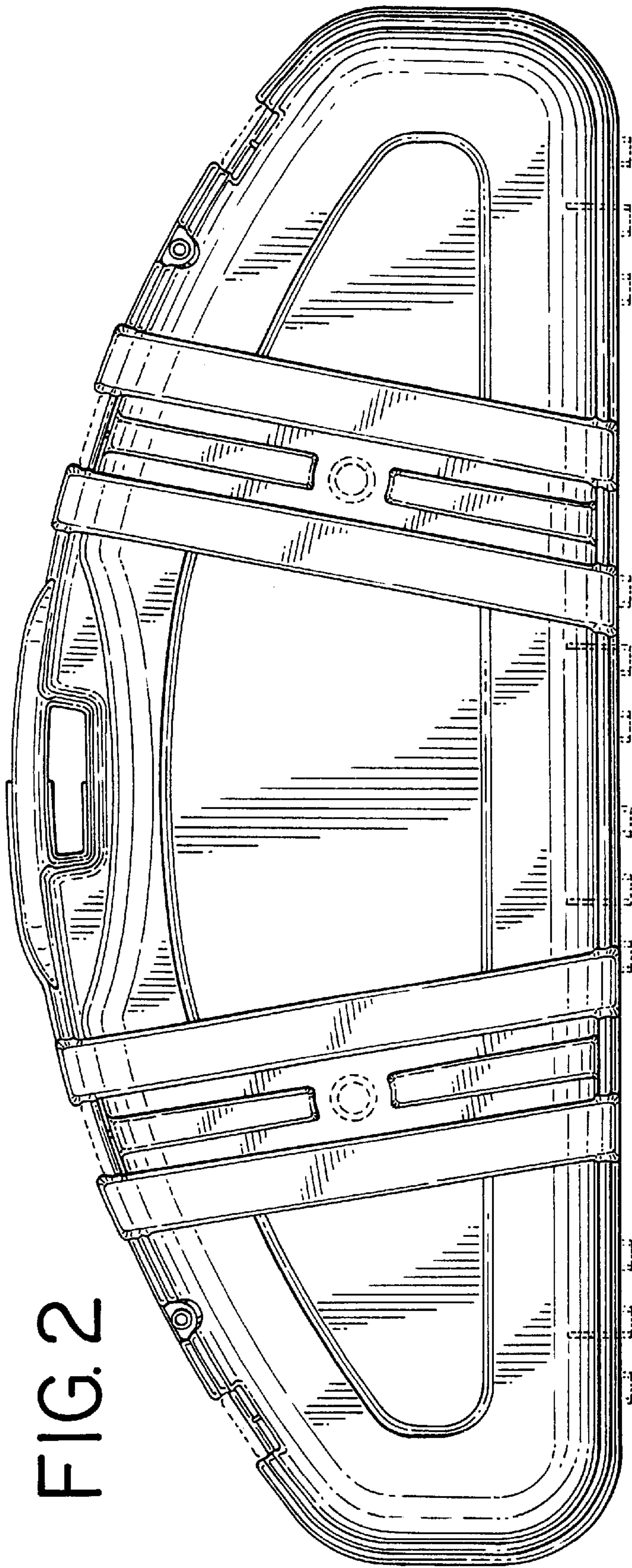
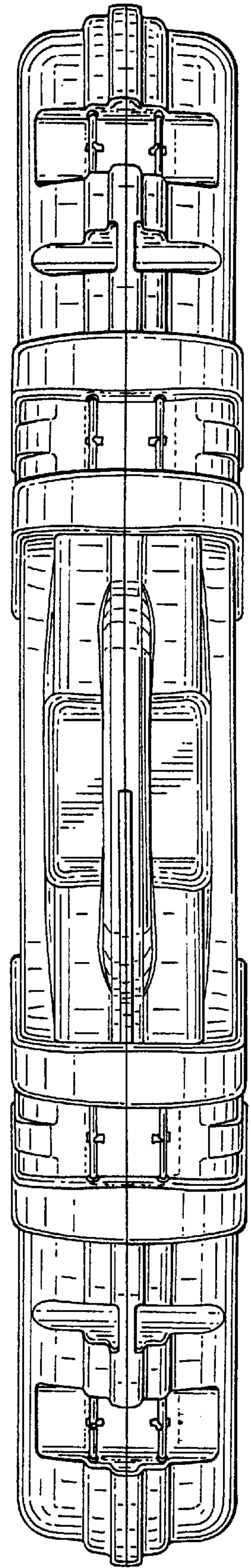

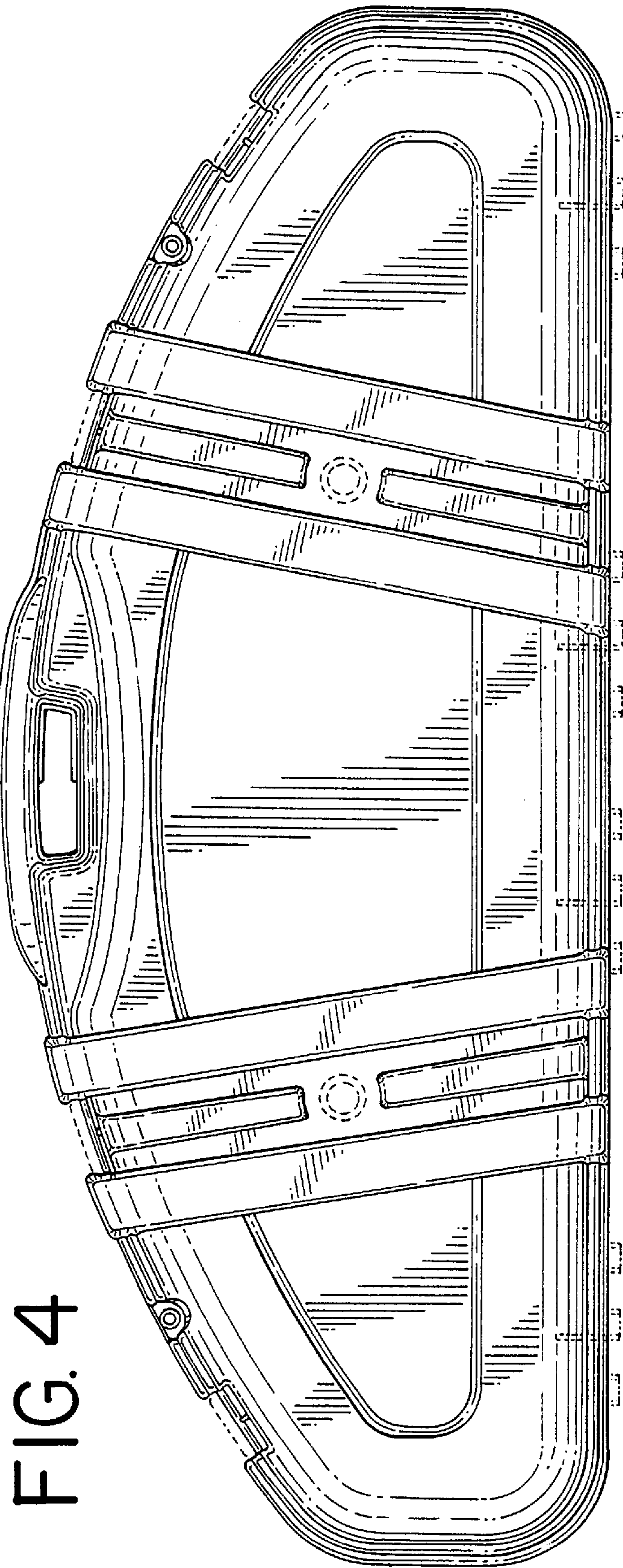

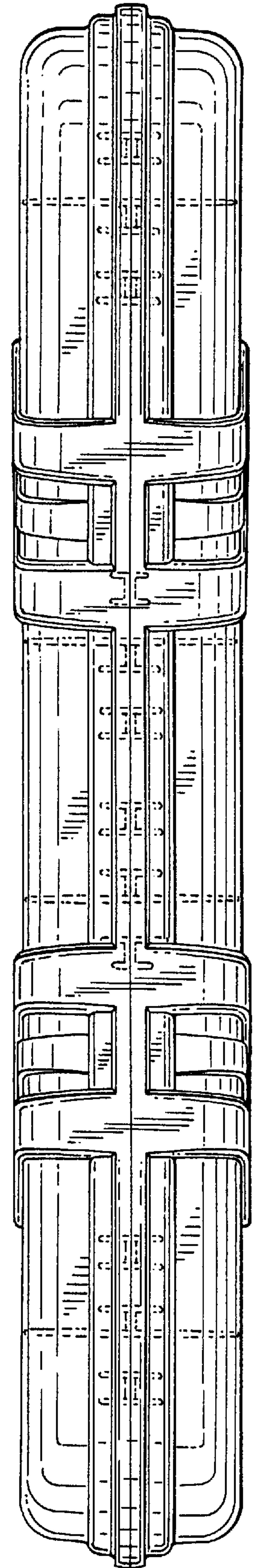

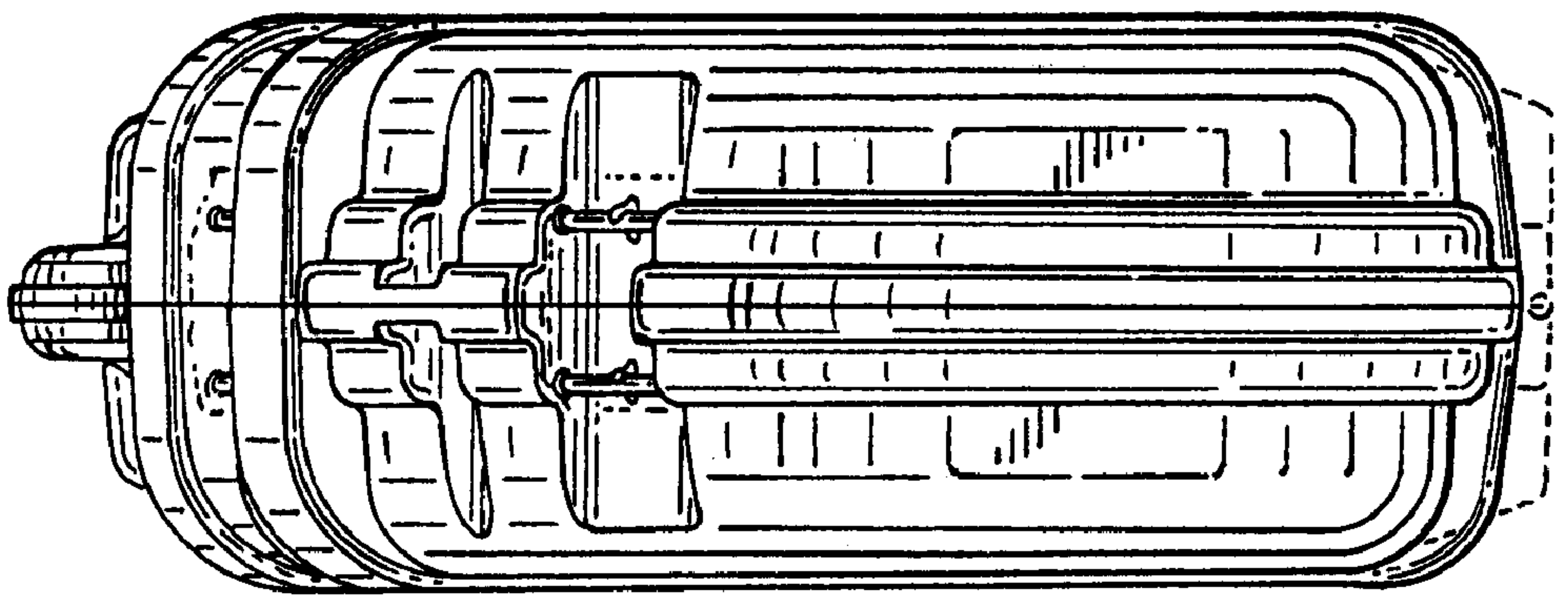
