The ornamental design for a compact disc case, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a compact disc case showing our design;

FIG. 2 is a side view thereof, the opposite side being identical thereto;

FIG. 3 is a top plan view thereof;

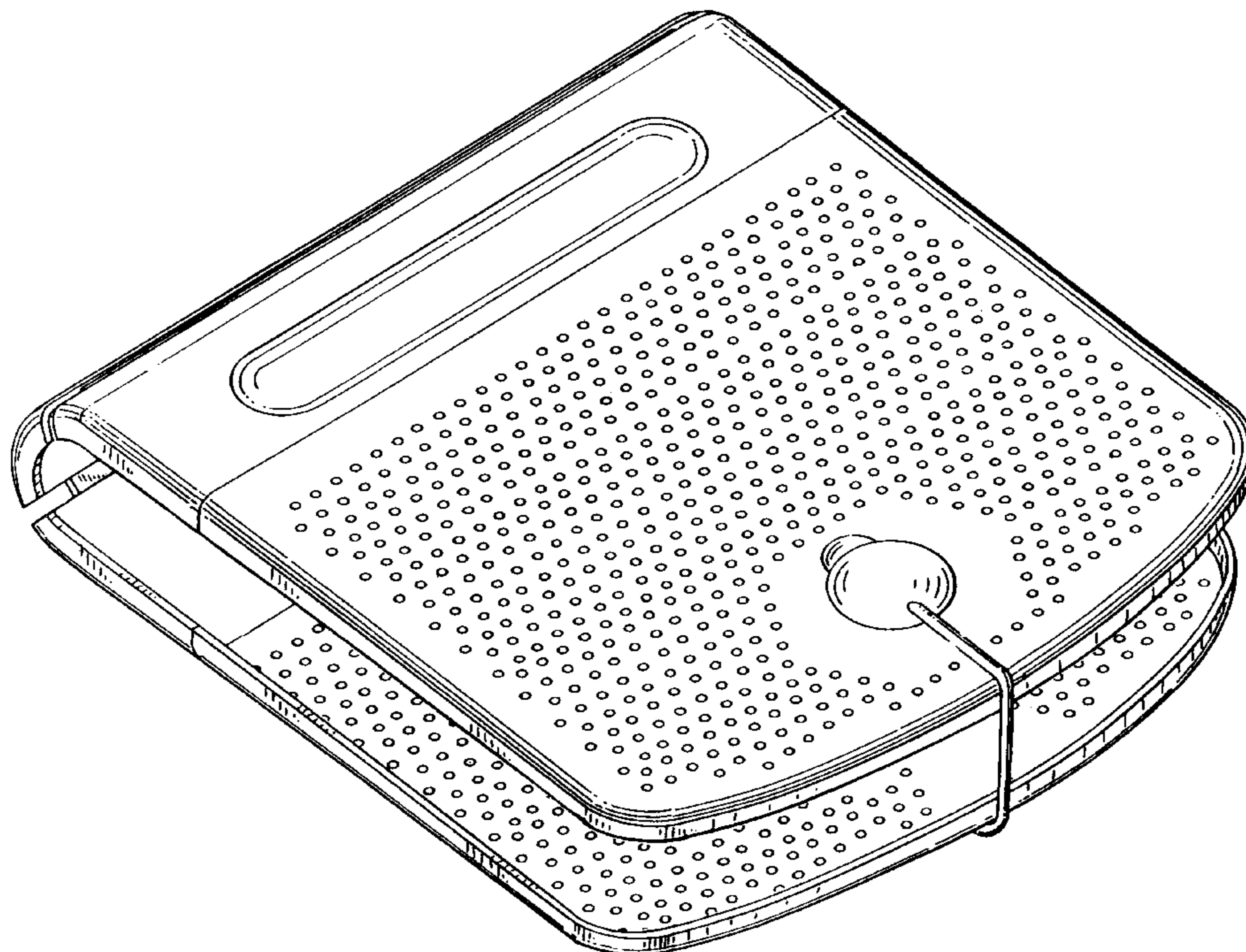
FIG. 4 is a front view thereof;

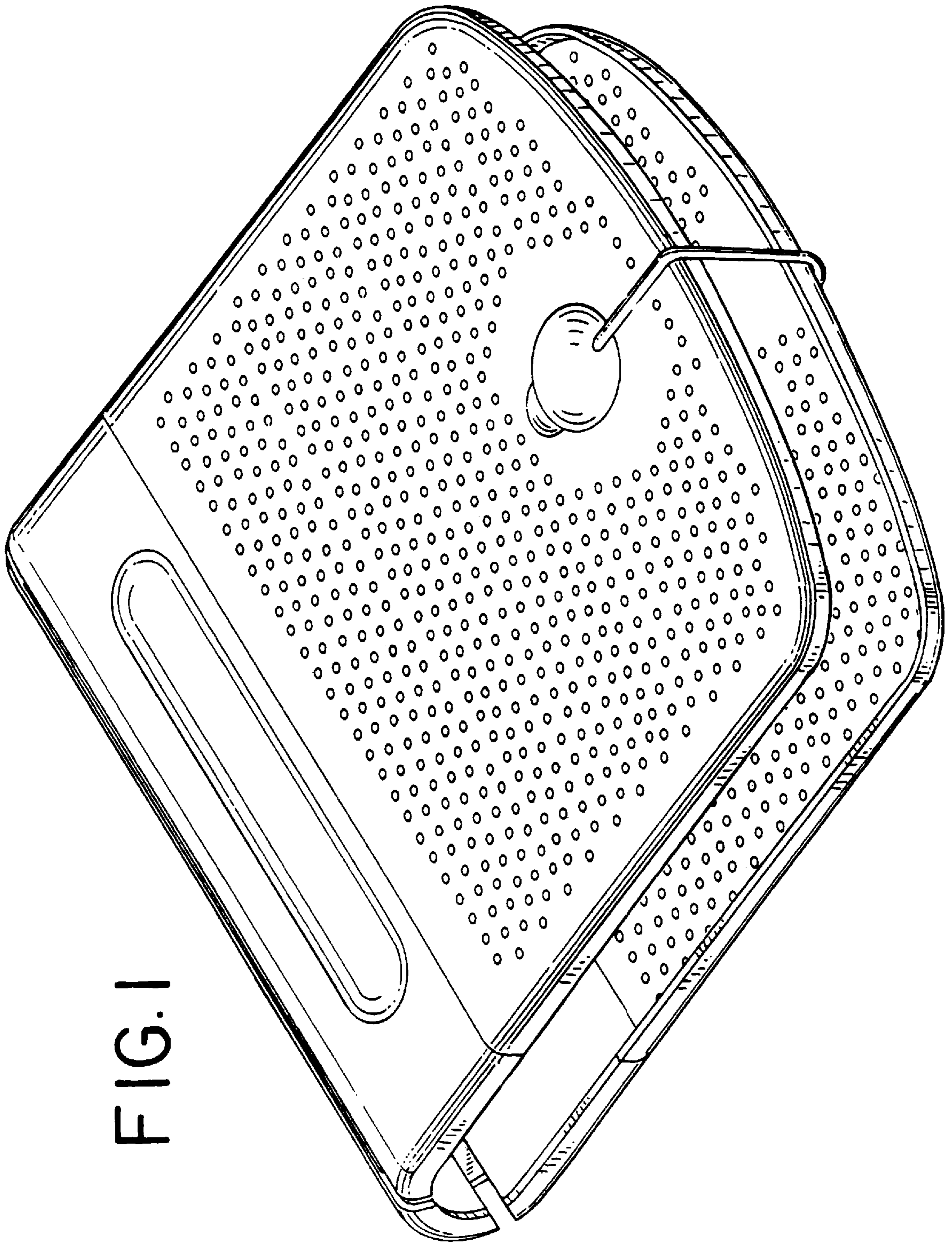

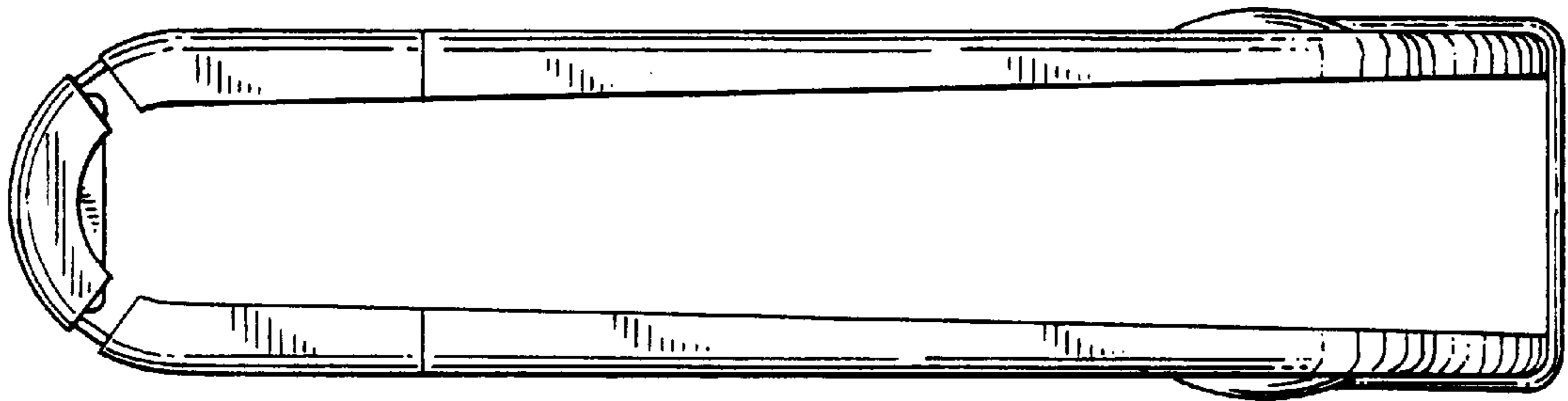

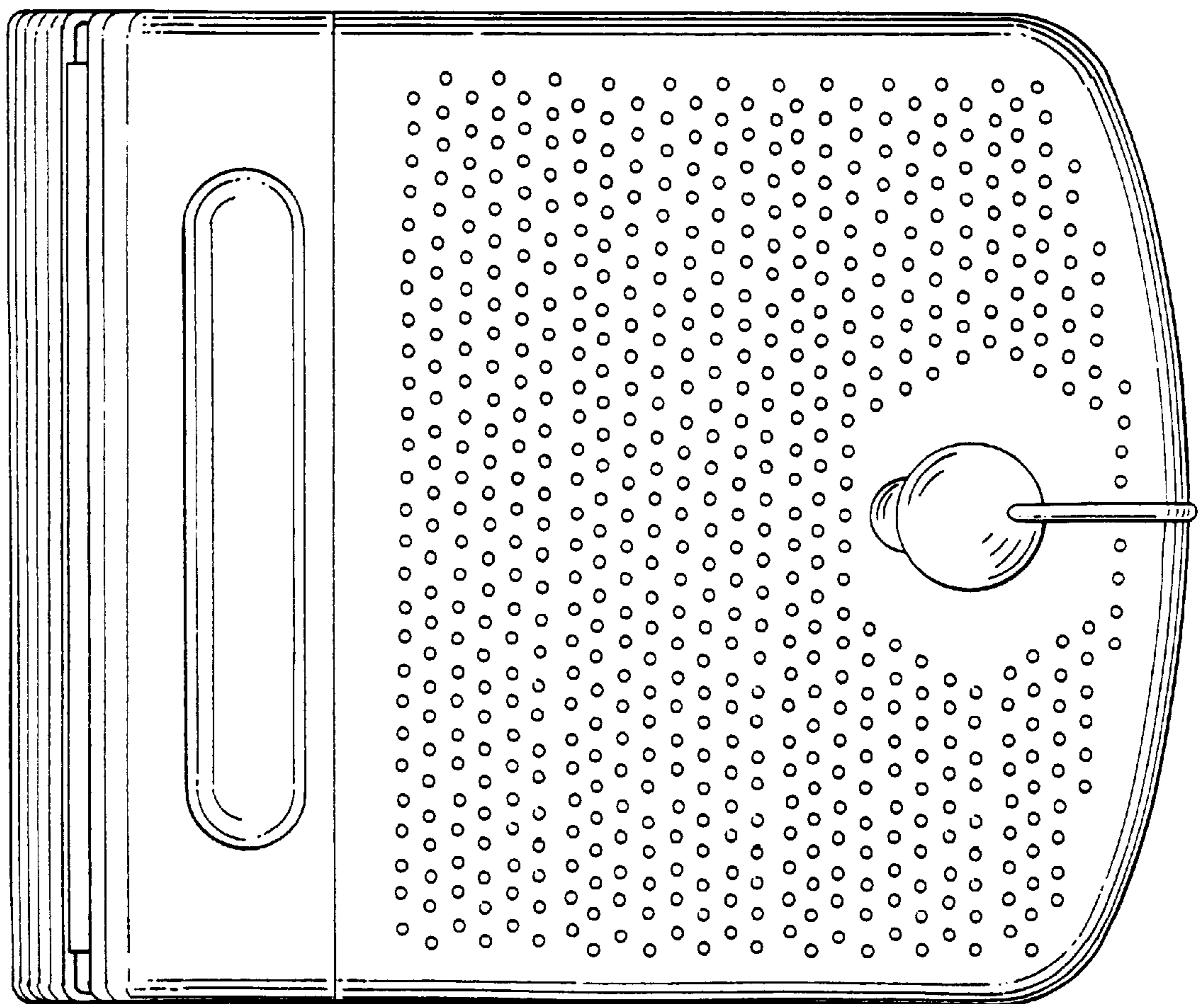

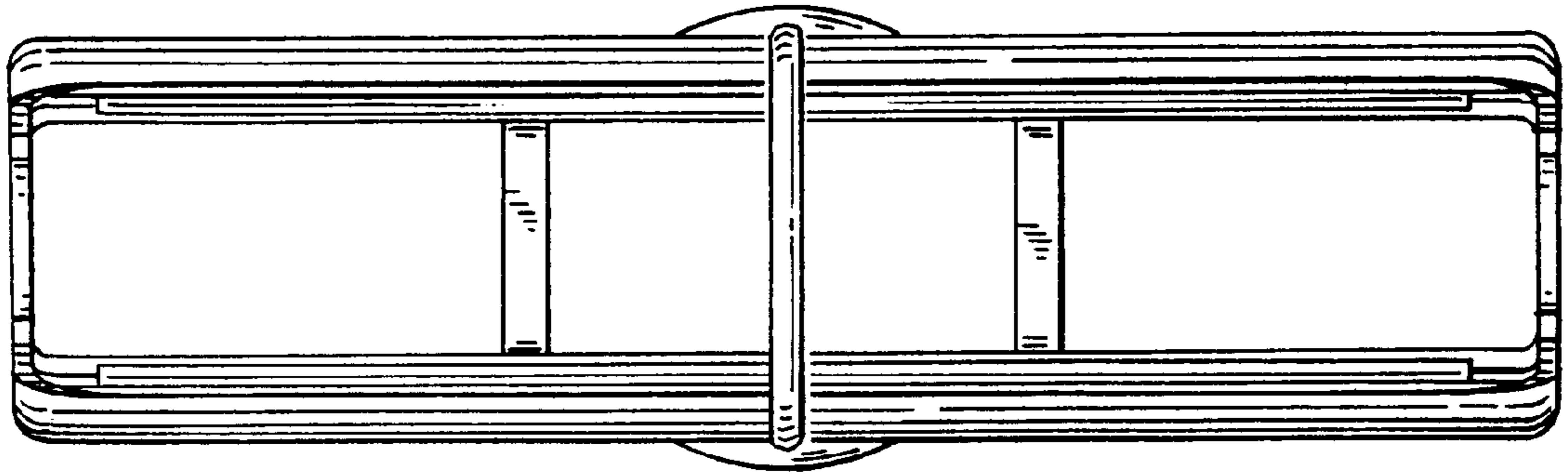

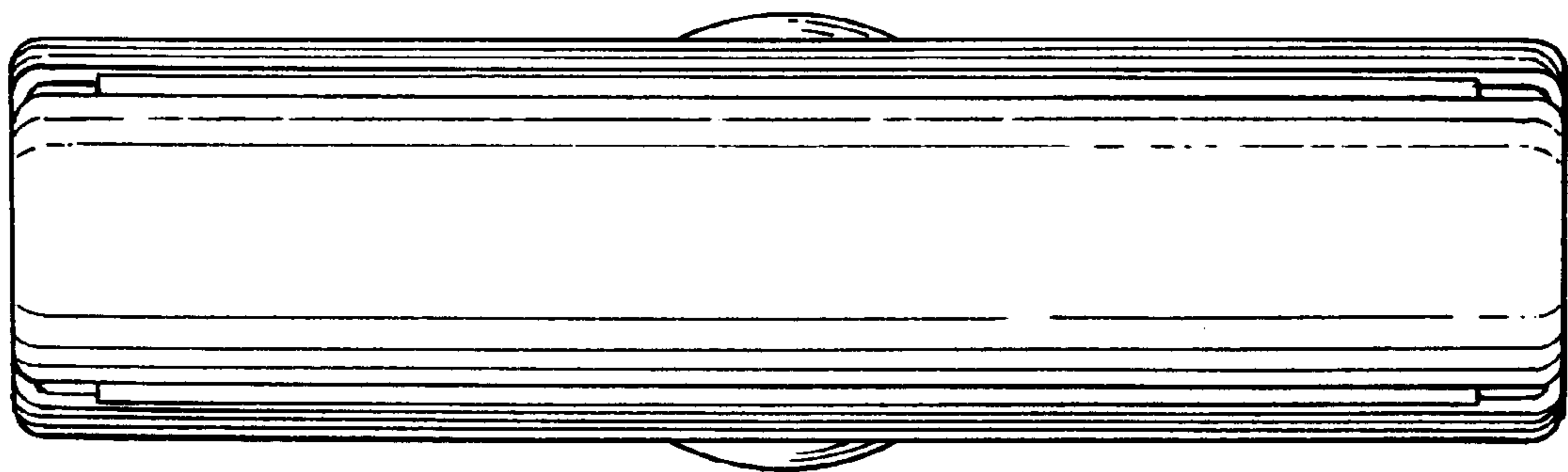

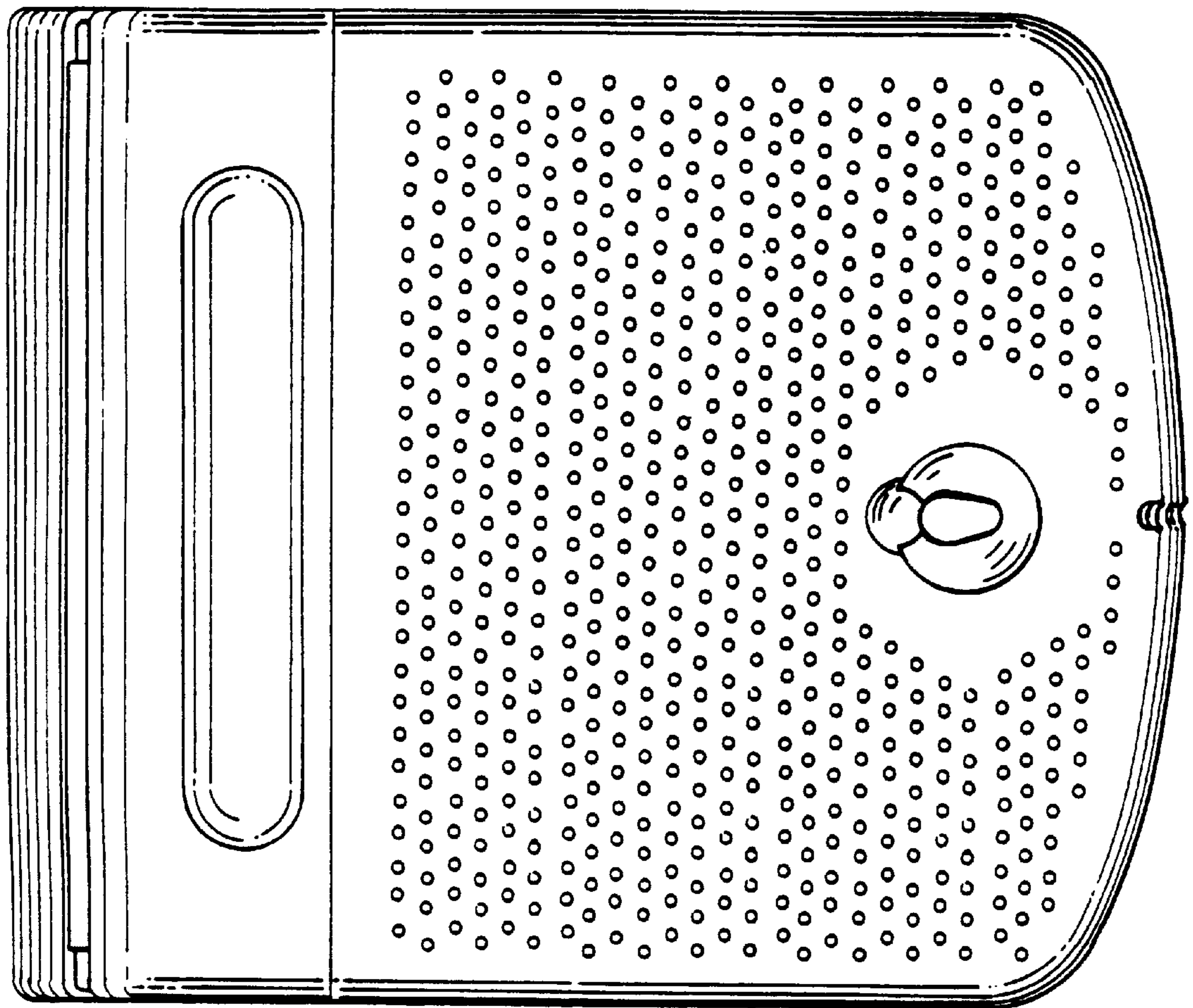
