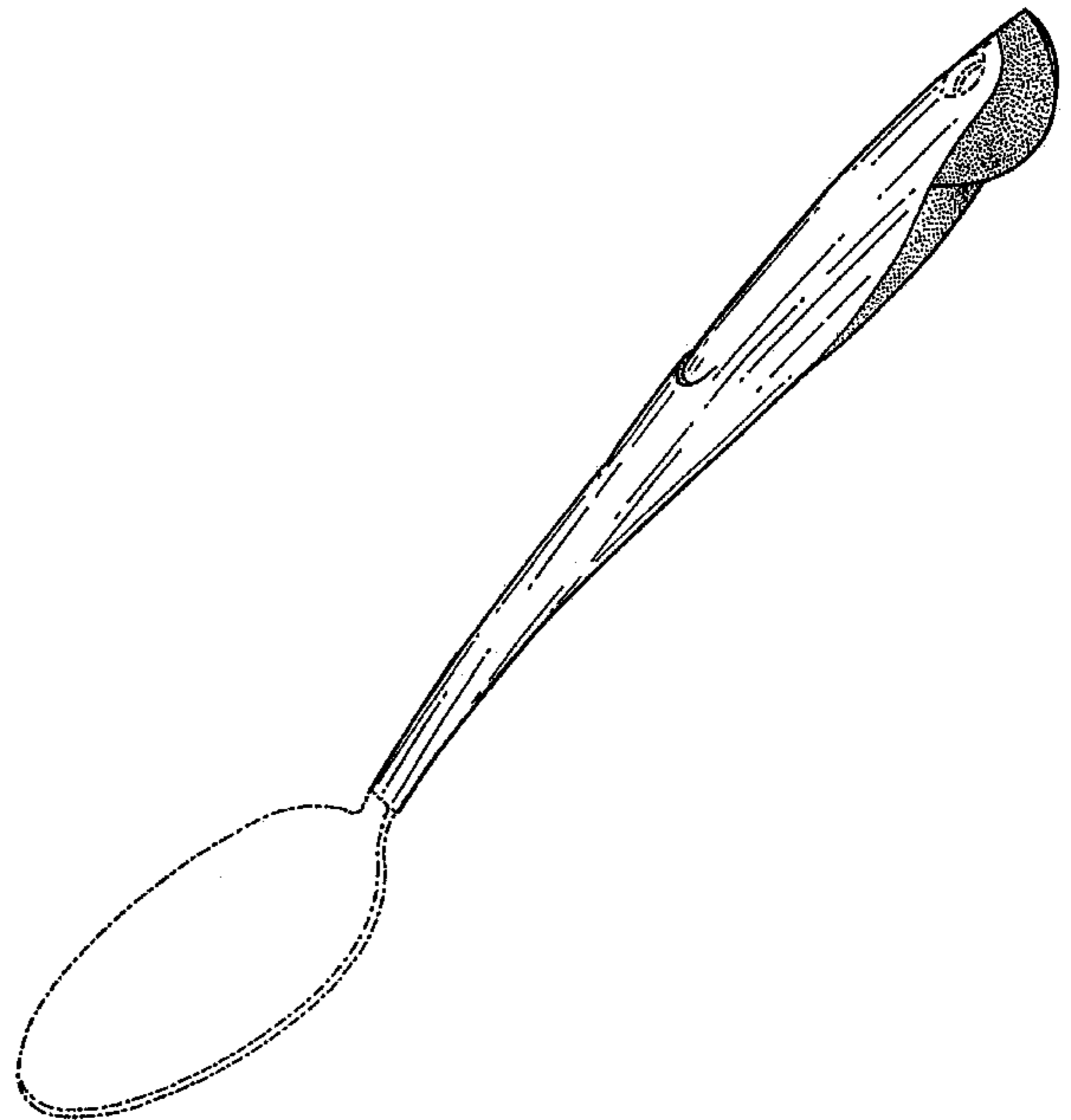
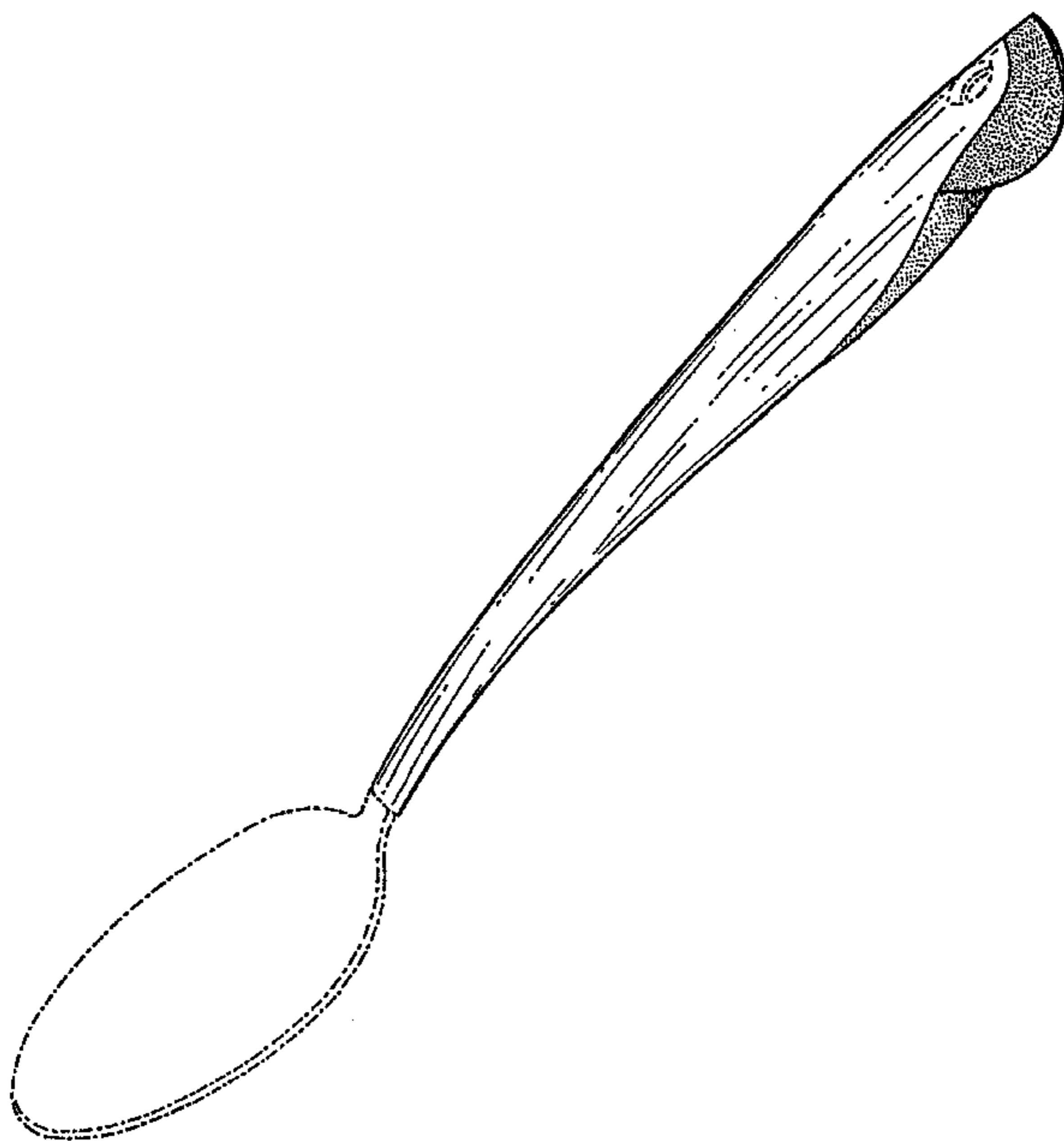

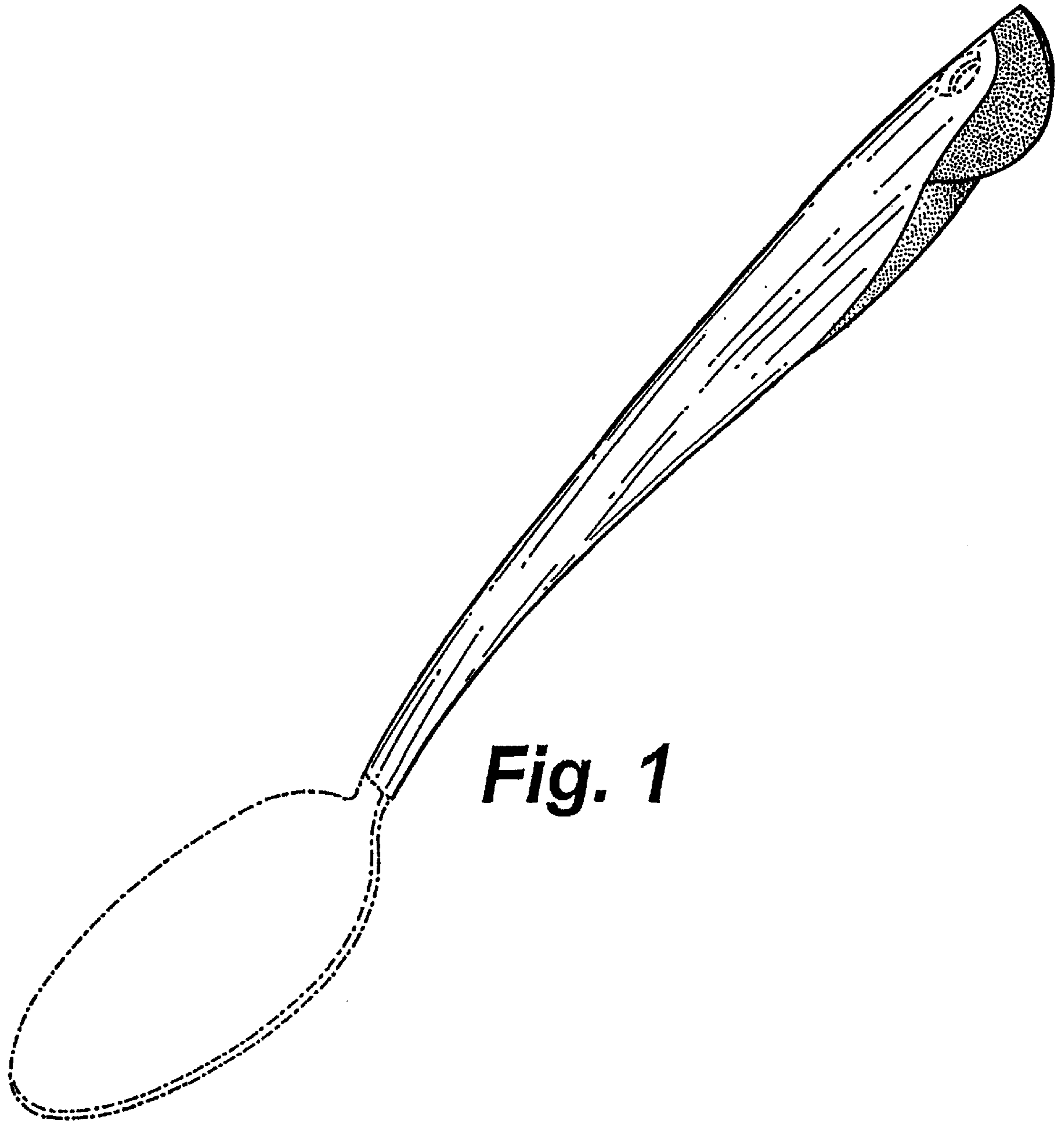
The ornamental design for a utensil handle, as shown and described.

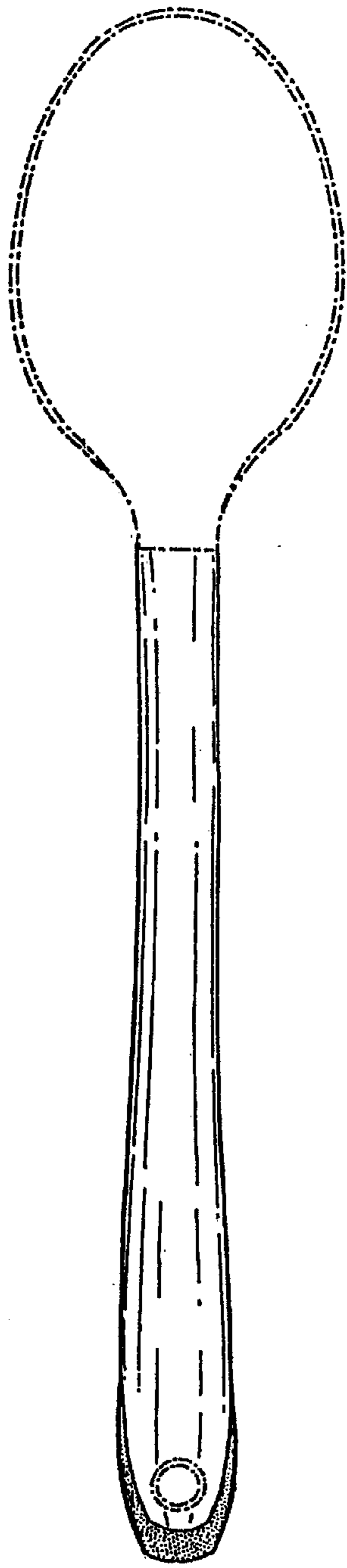
**DESCRIPTION**

FIG. 1 is a side, top perspective view of the utensil handle showing our new design;  
 FIG. 2 is a top view thereof;

 The broken lines shown in FIGS. 1-10 are illustrative purposes only and form no part of the claimed design.

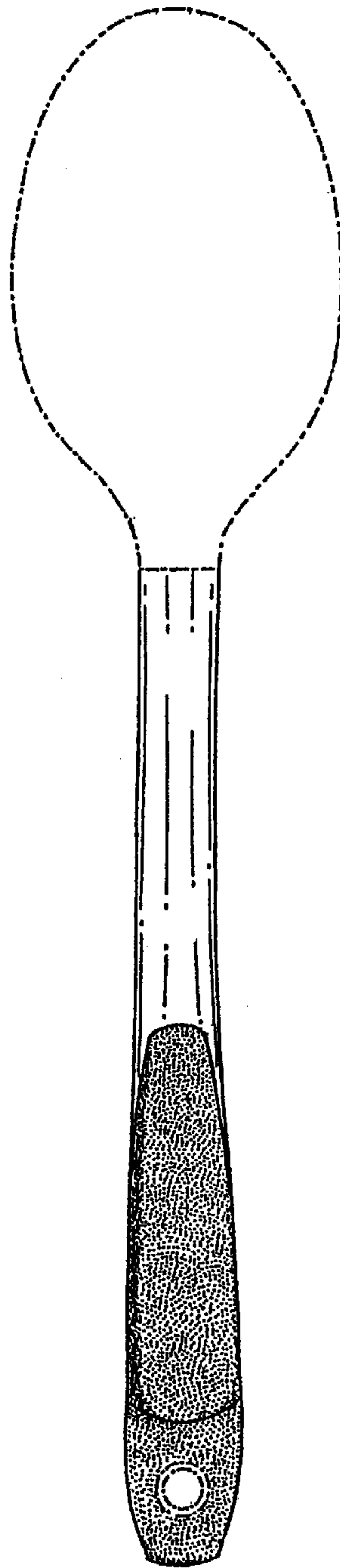

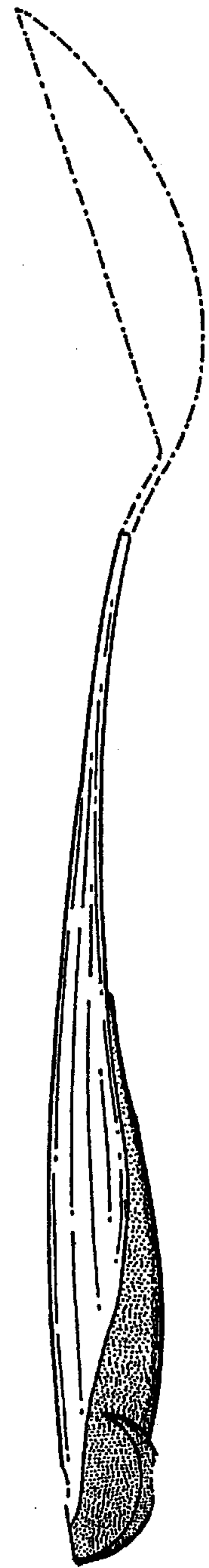




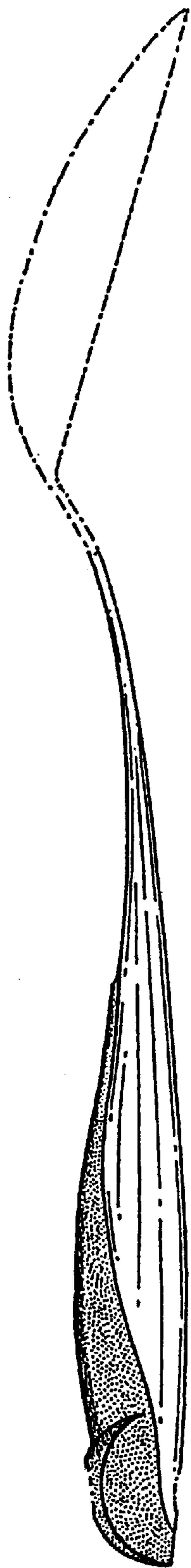

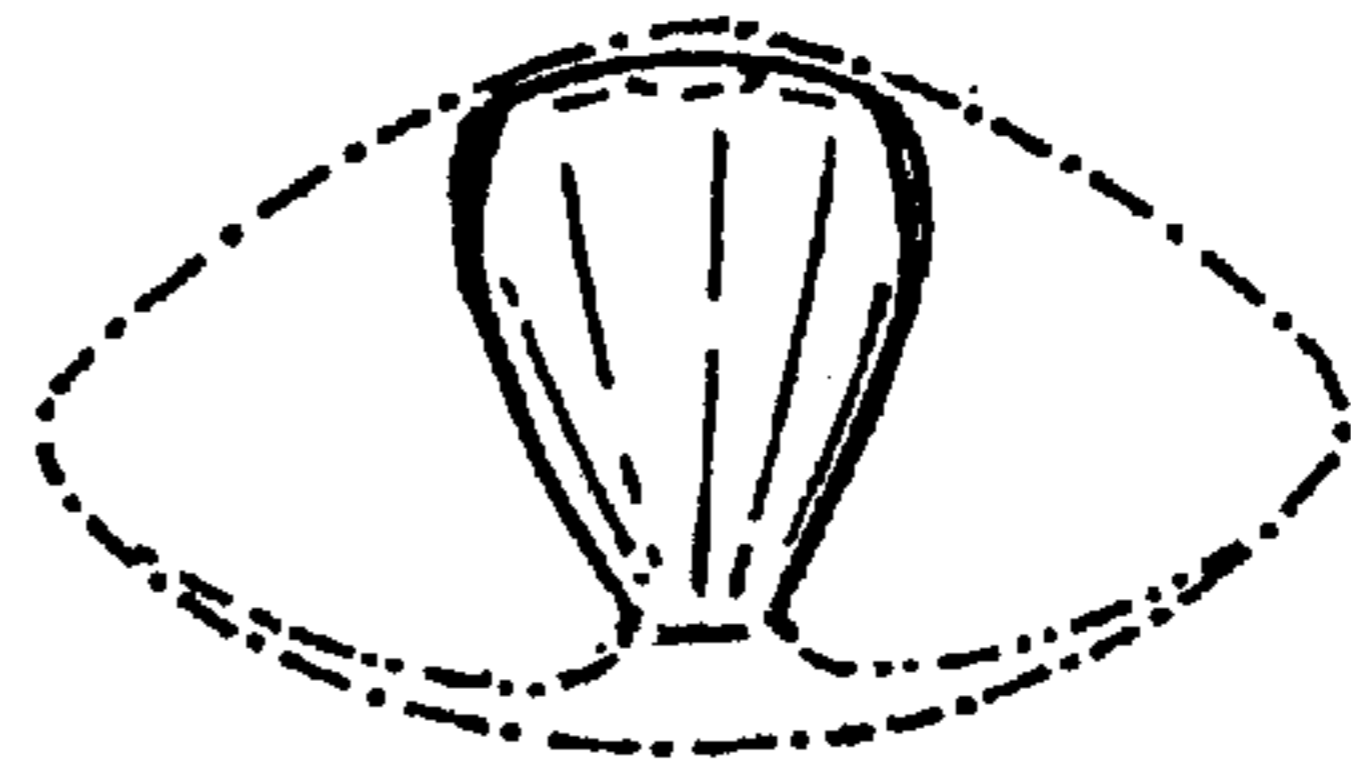

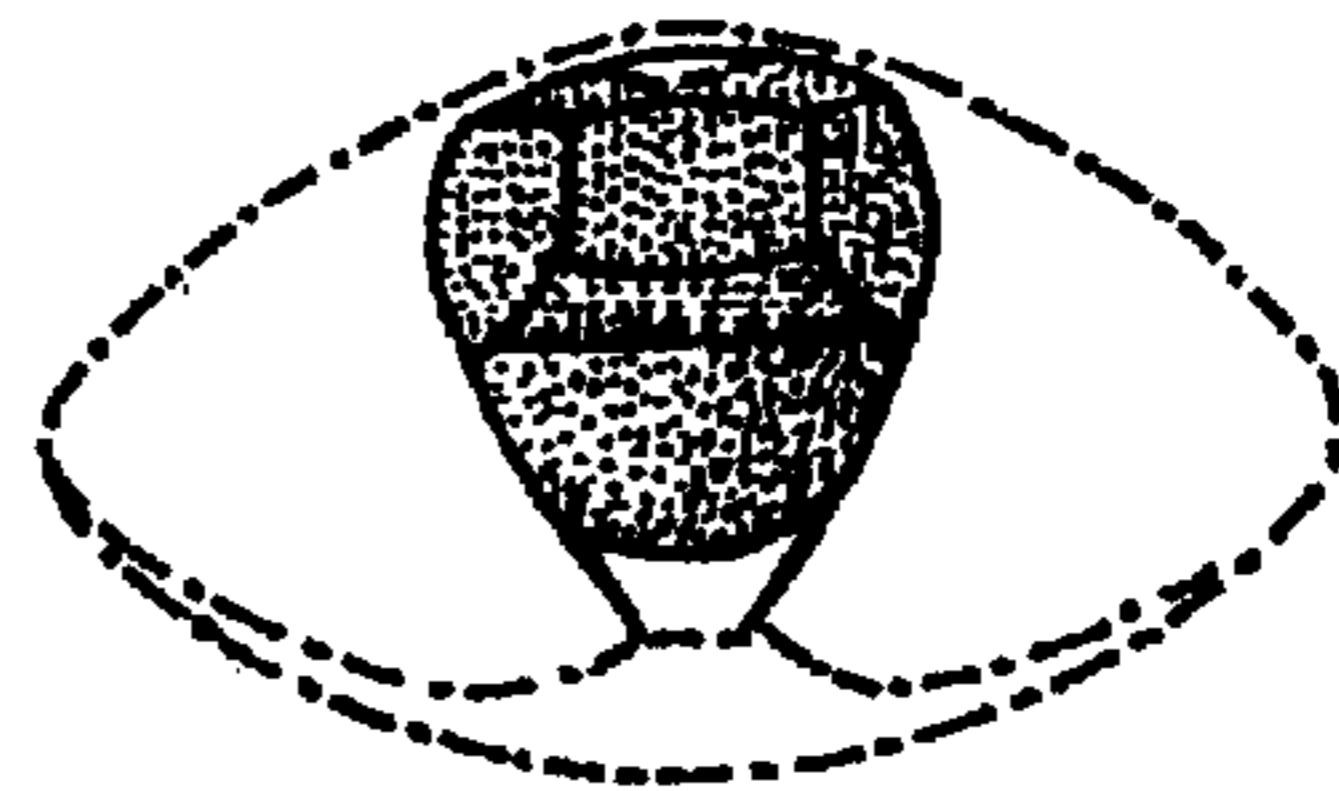

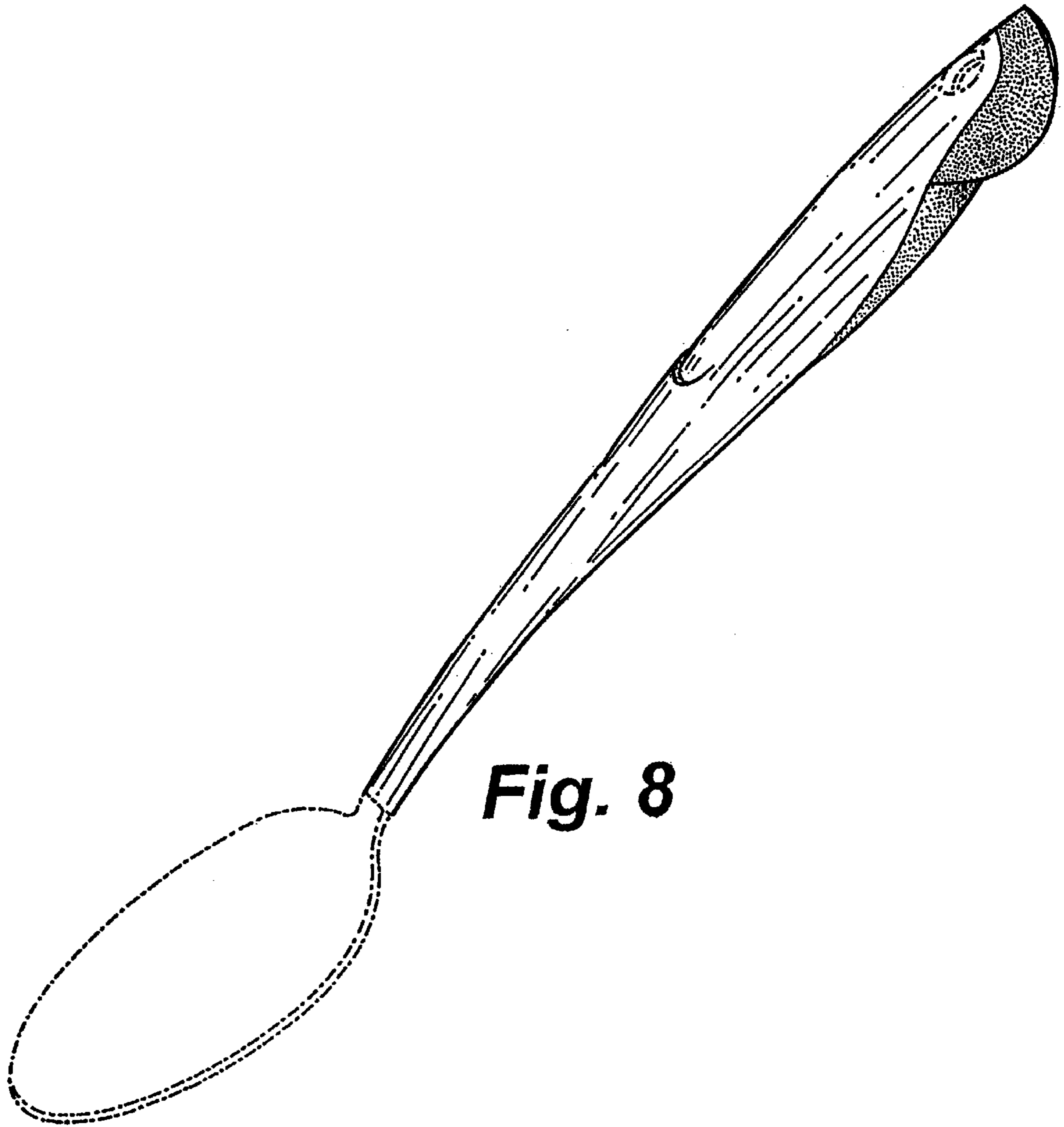

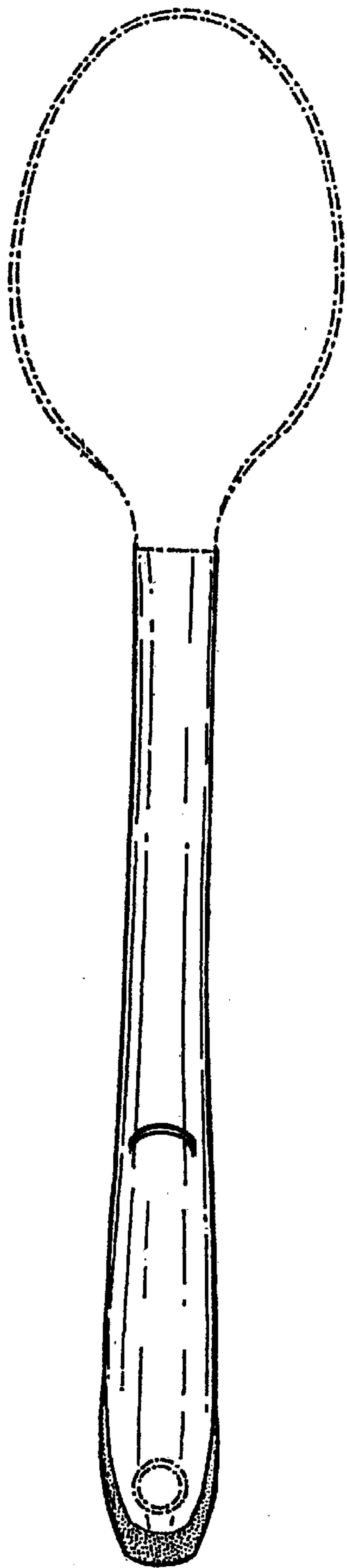

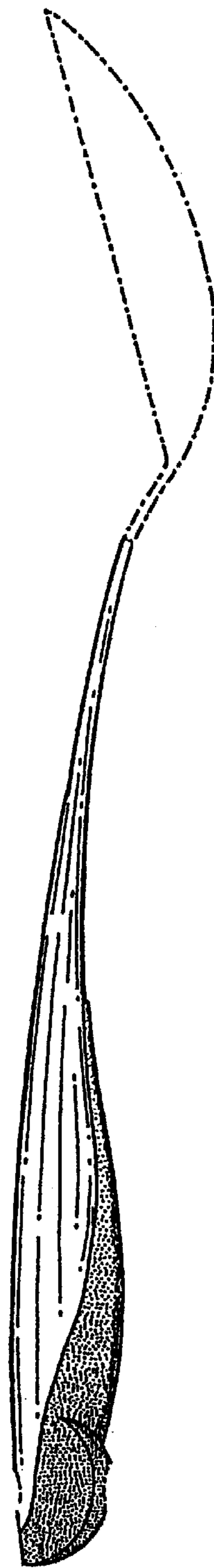
