I claim the ornamental design for a swell latch, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the swell latch of the present invention.

FIG. 2 is a top plan view of the swell latch of FIG. 1.

FIG. 3 is a side view of the swell latch of FIG. 1.

FIG. 4 is a front view of the swell latch of FIG. 1.

FIG. 5 is the back view of the swell latch of FIG. 4; and,

FIG. 6 is a bottom view of the swell latch of FIG. 1.

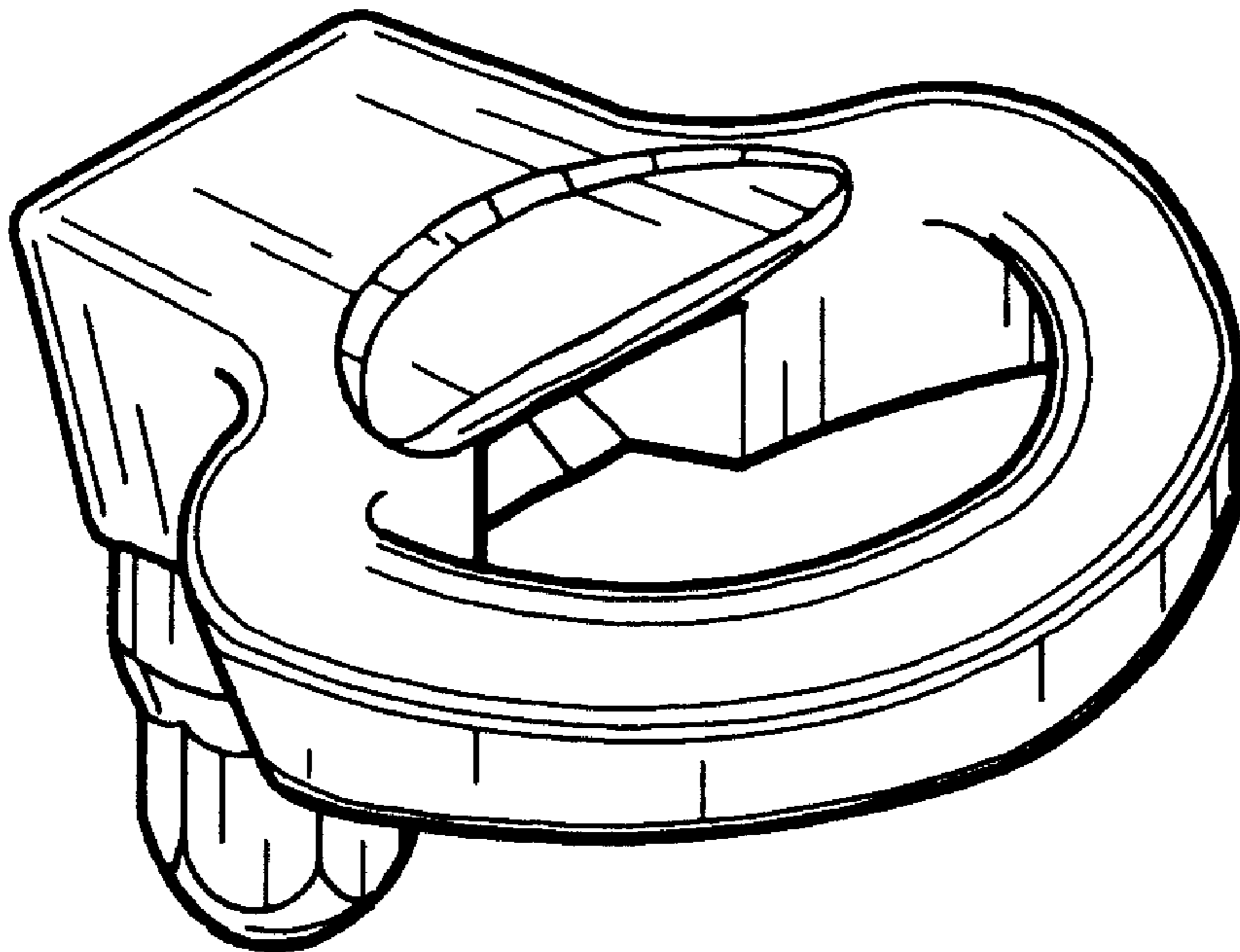

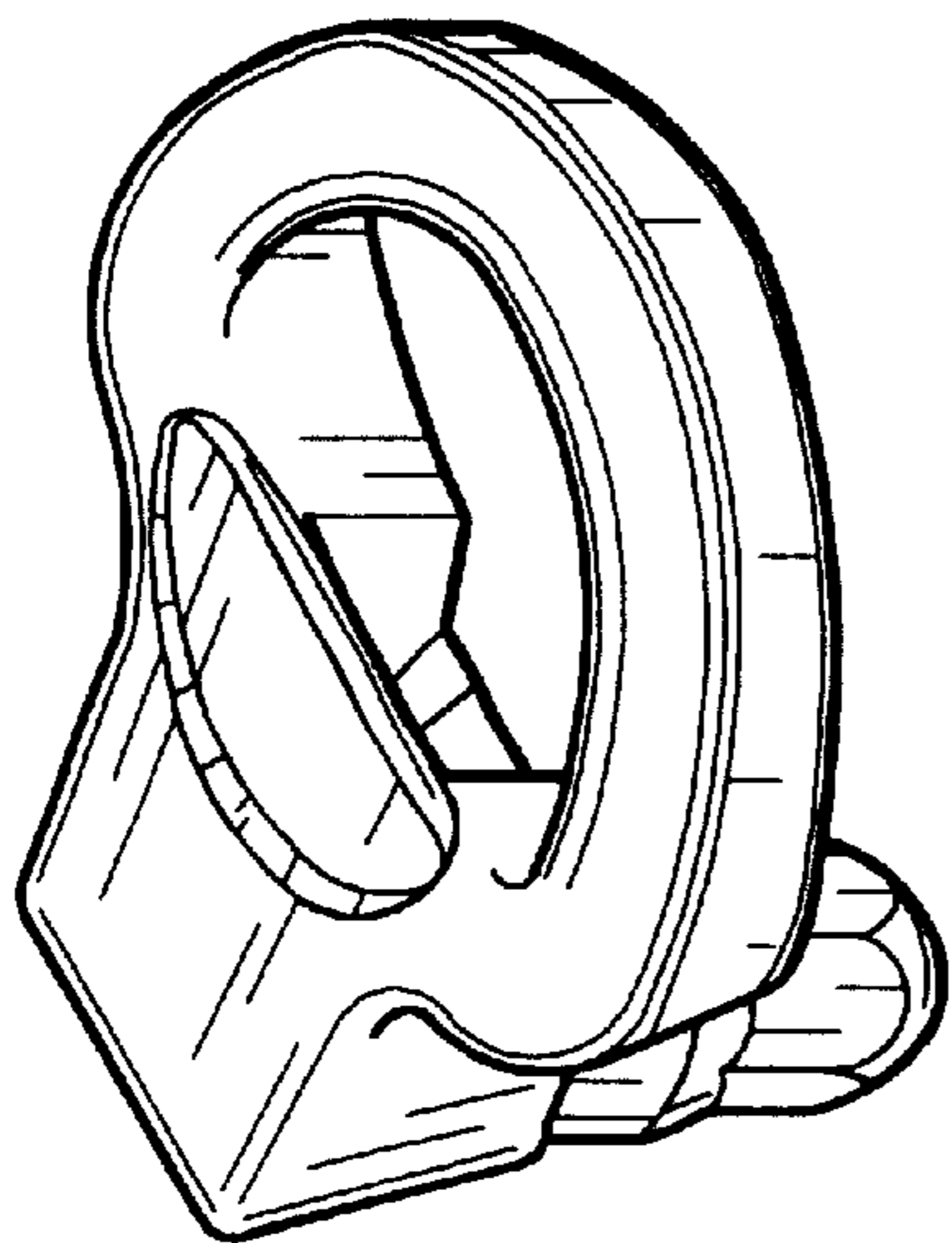

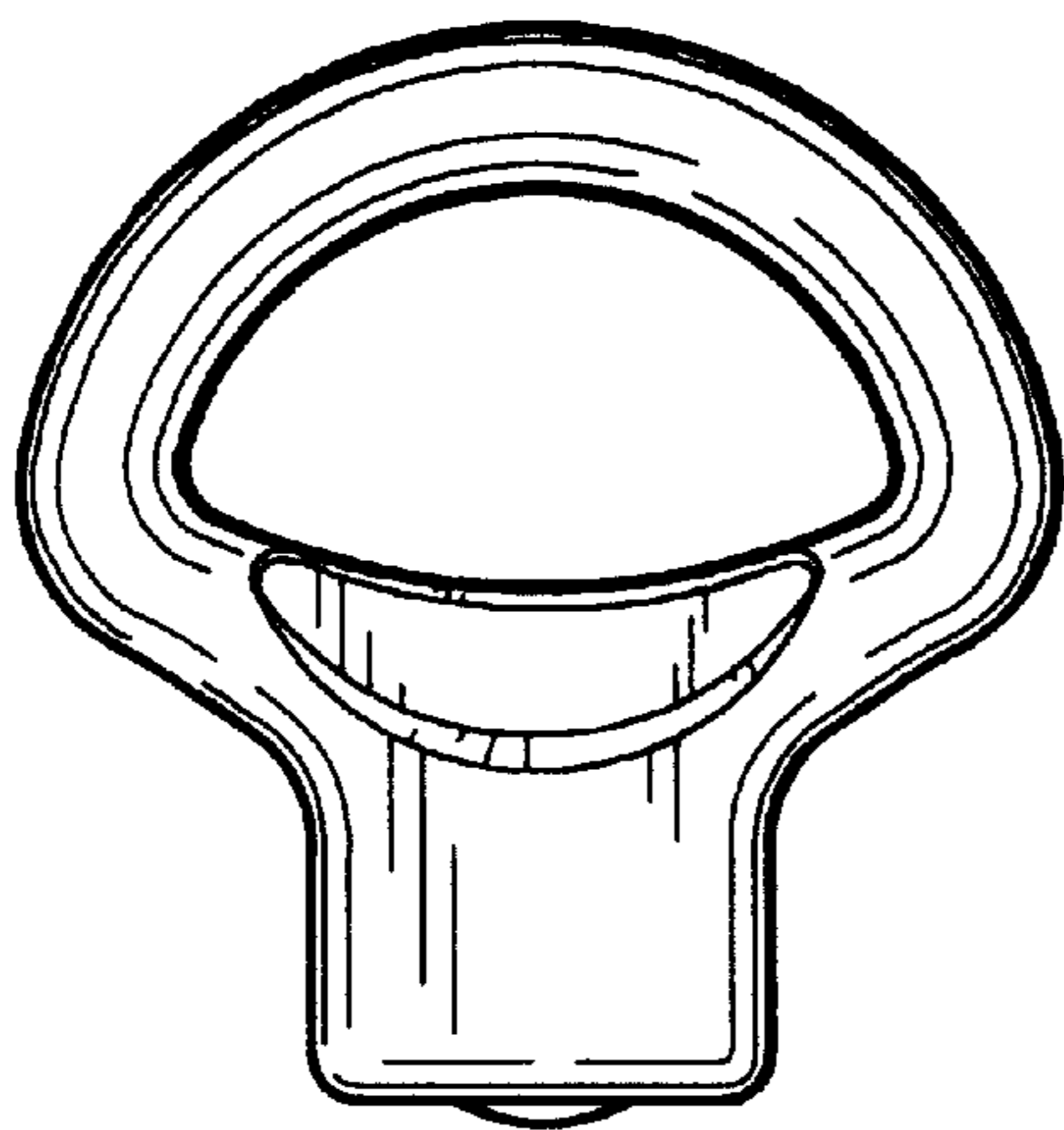

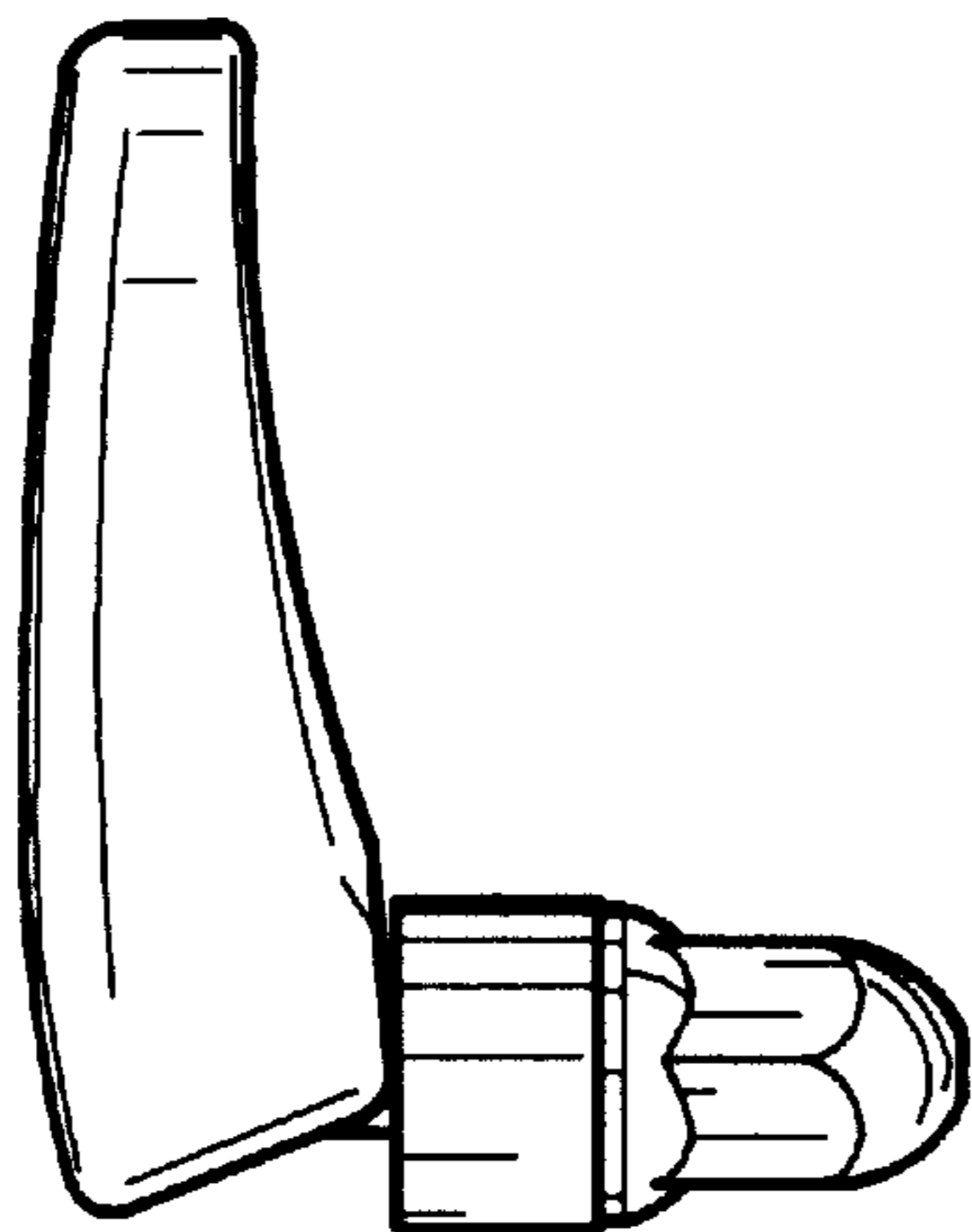

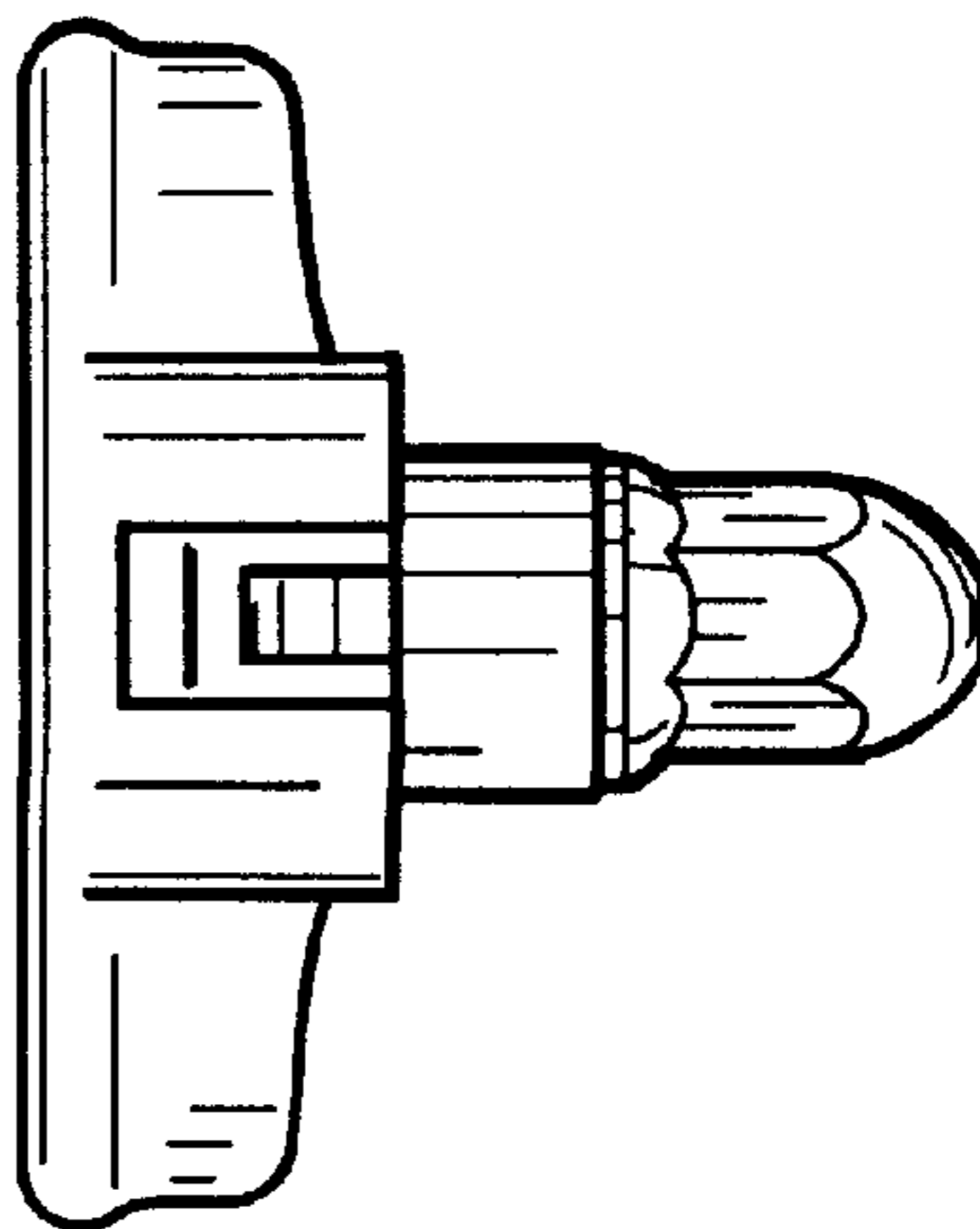

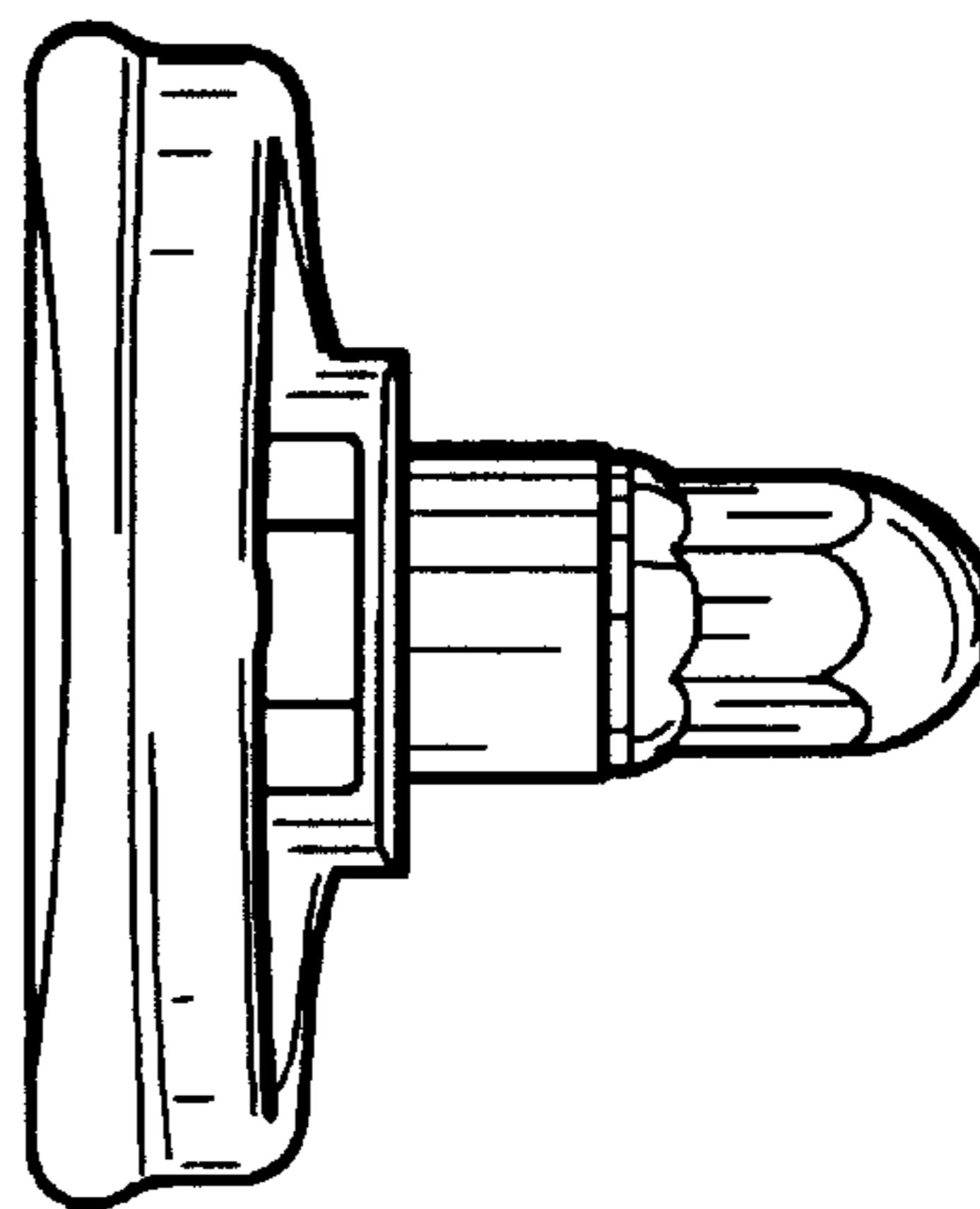
