(57) **CLAIM**

The ornamental design for a watch, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a watch showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a side view of one side thereof, the other side being a mirror image thereof;

FIG. 4 is an end view thereof, the other end being a mirror image thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a perspective view of a second embodiment of a watch showing my new design;

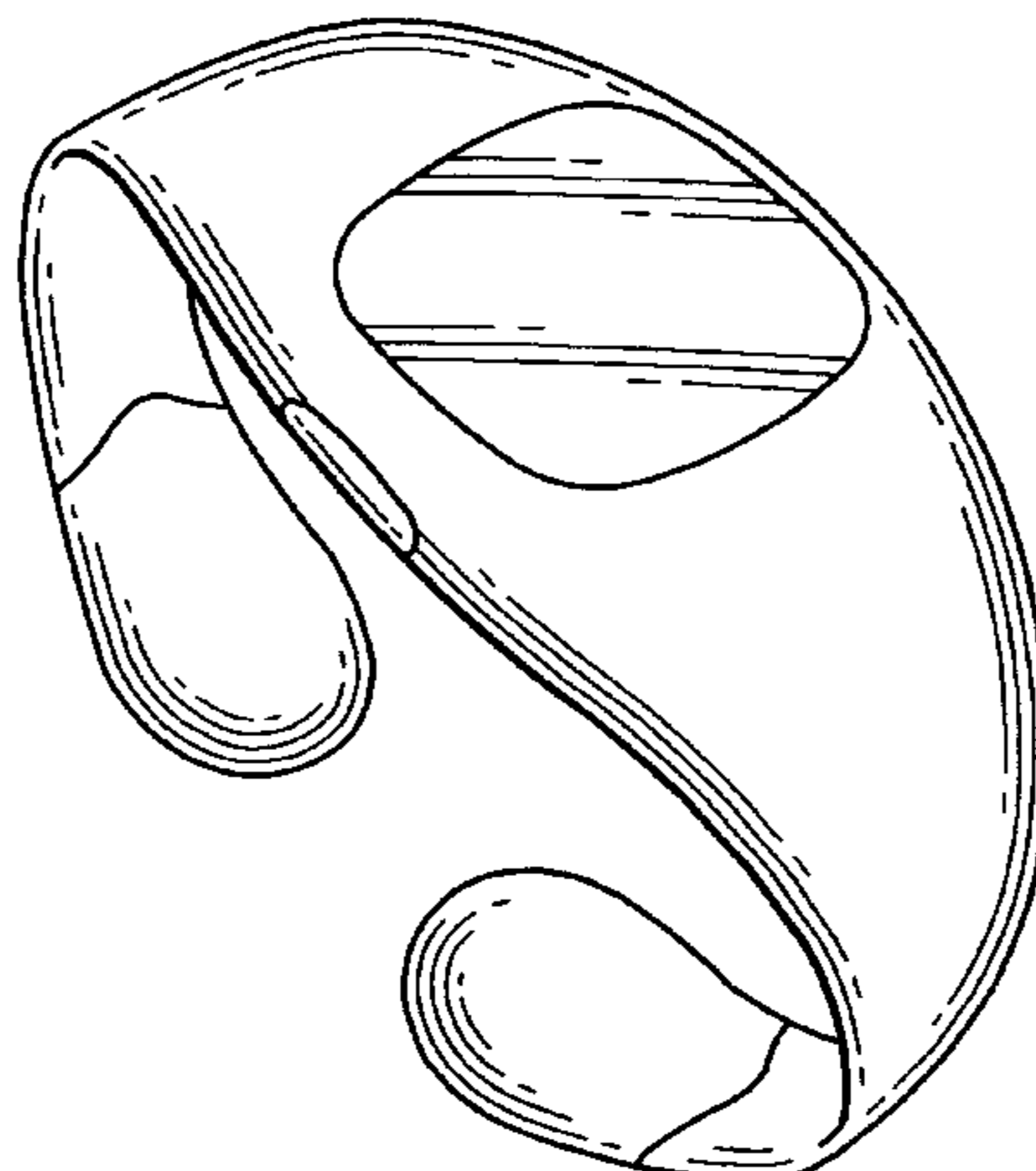
FIG. 7 is a top plan view of the watch of FIG. 6;

FIG. 8 is a side view of one side of the watch of FIG. 6, the other side being a mirror image thereof;

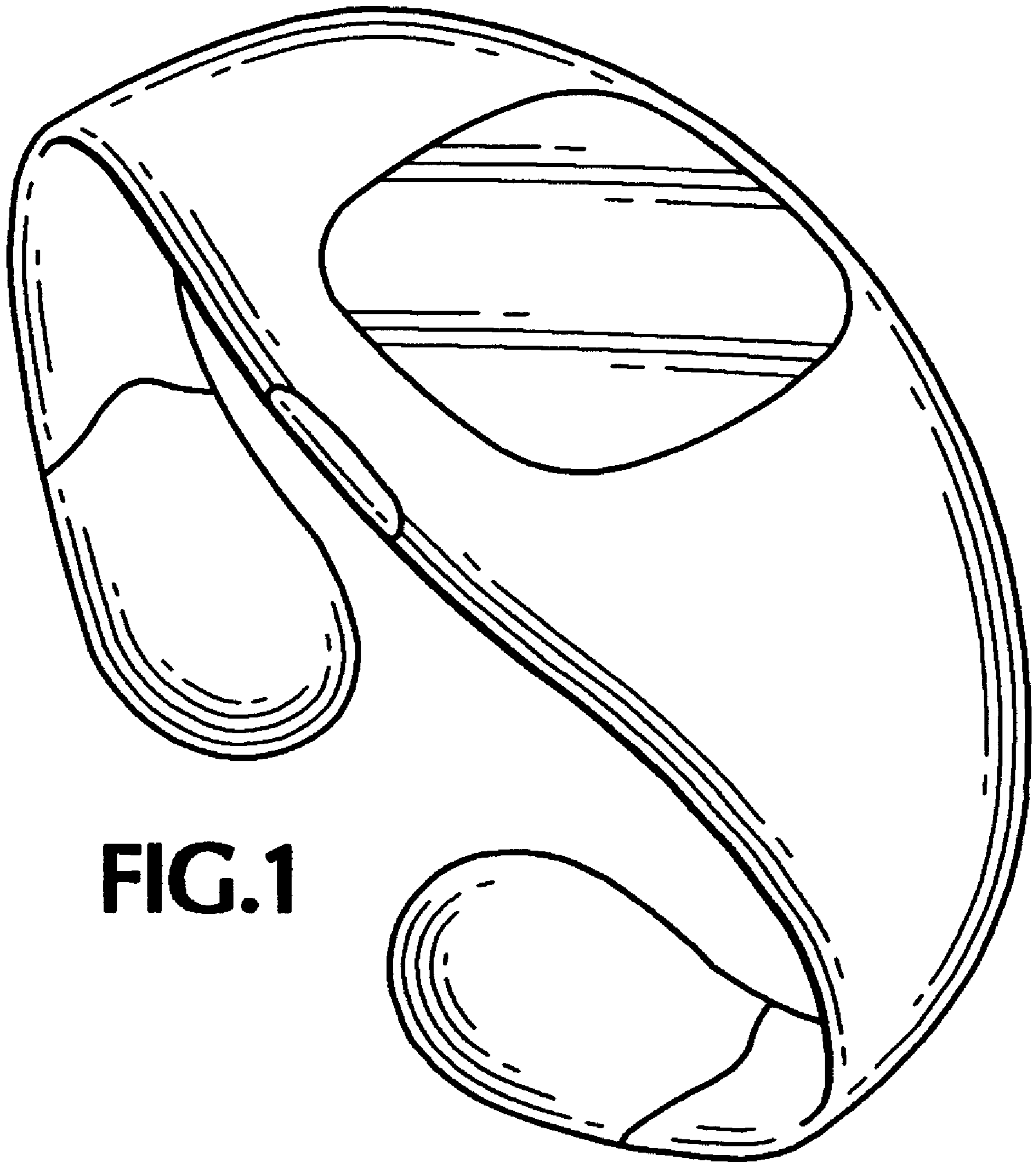

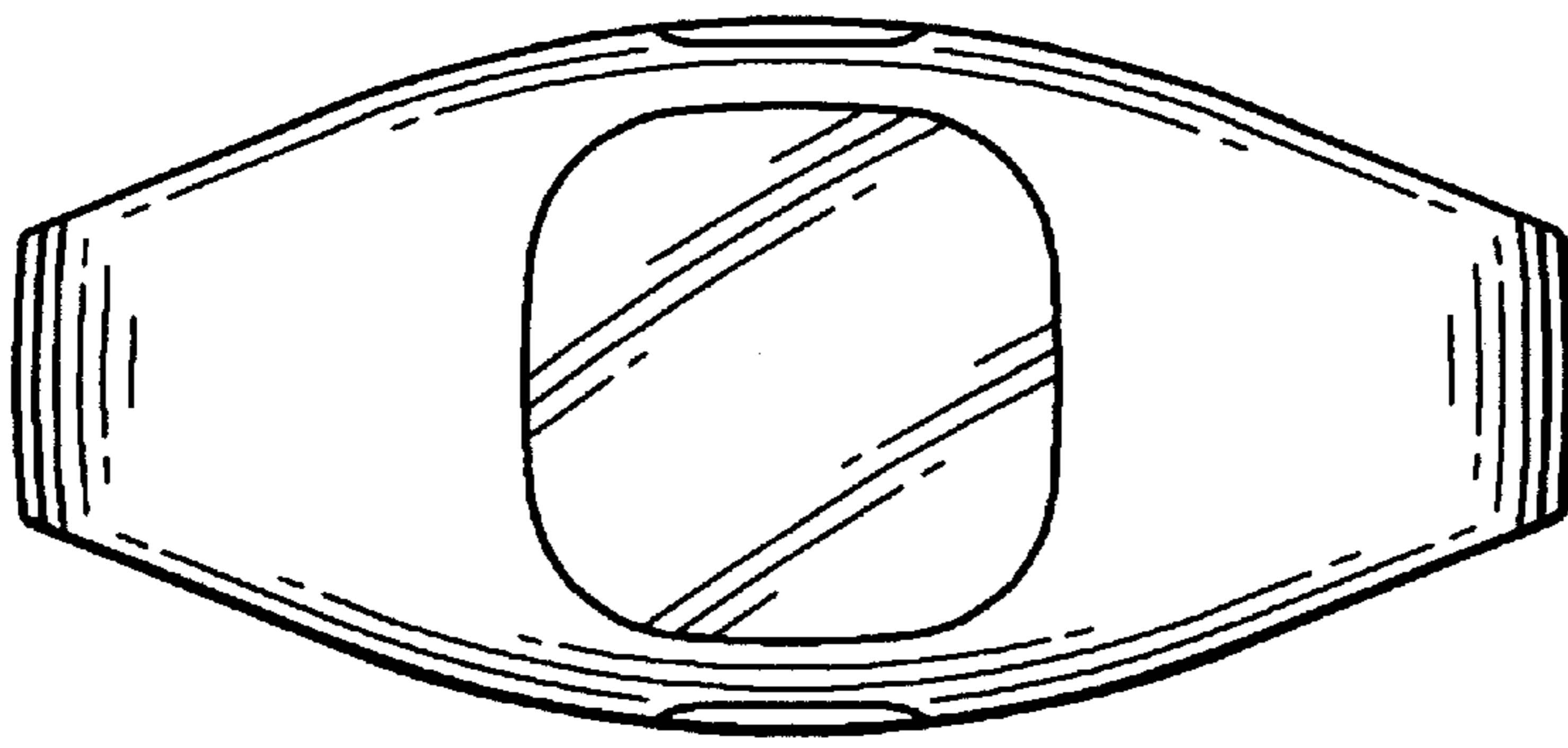

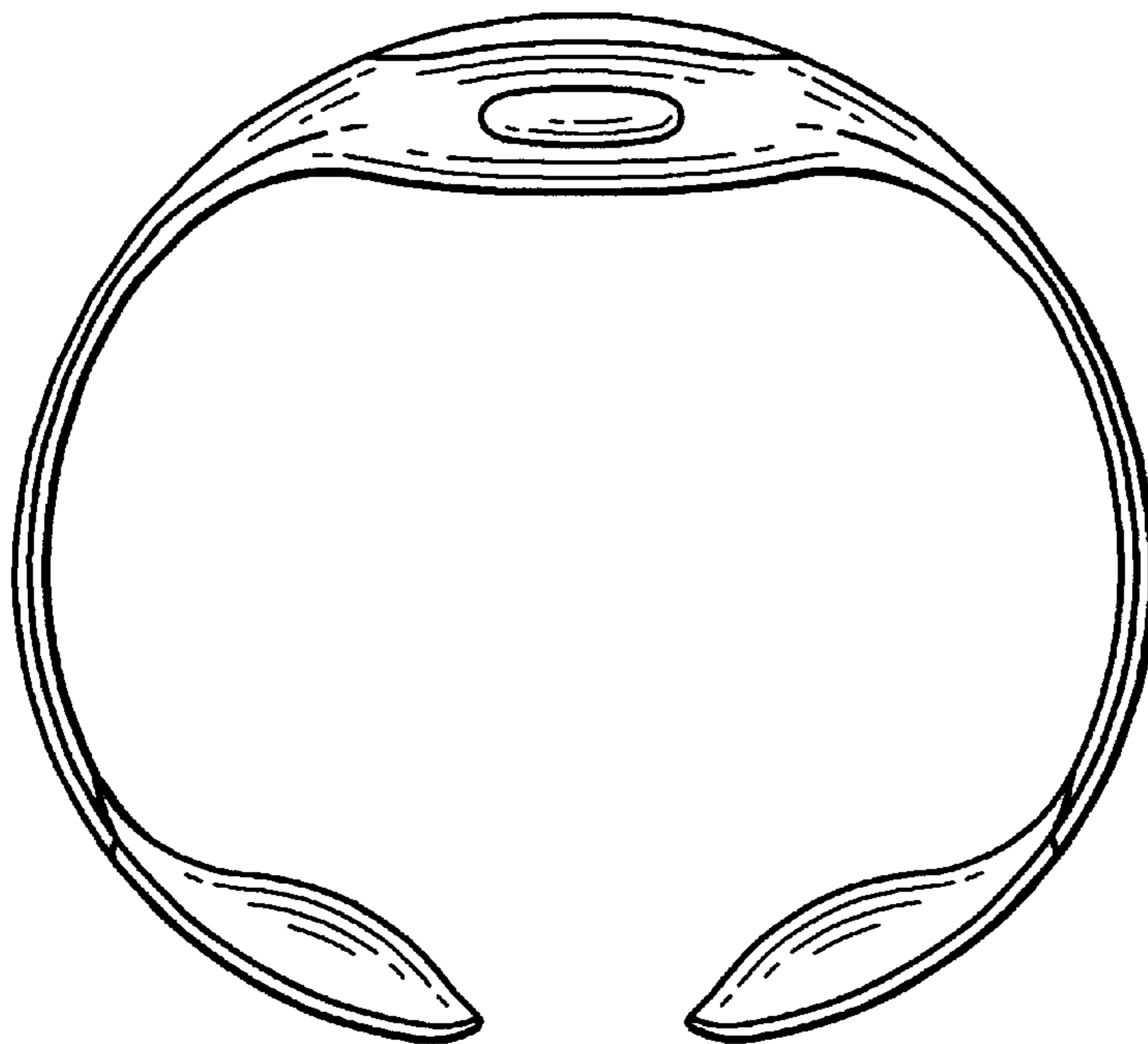

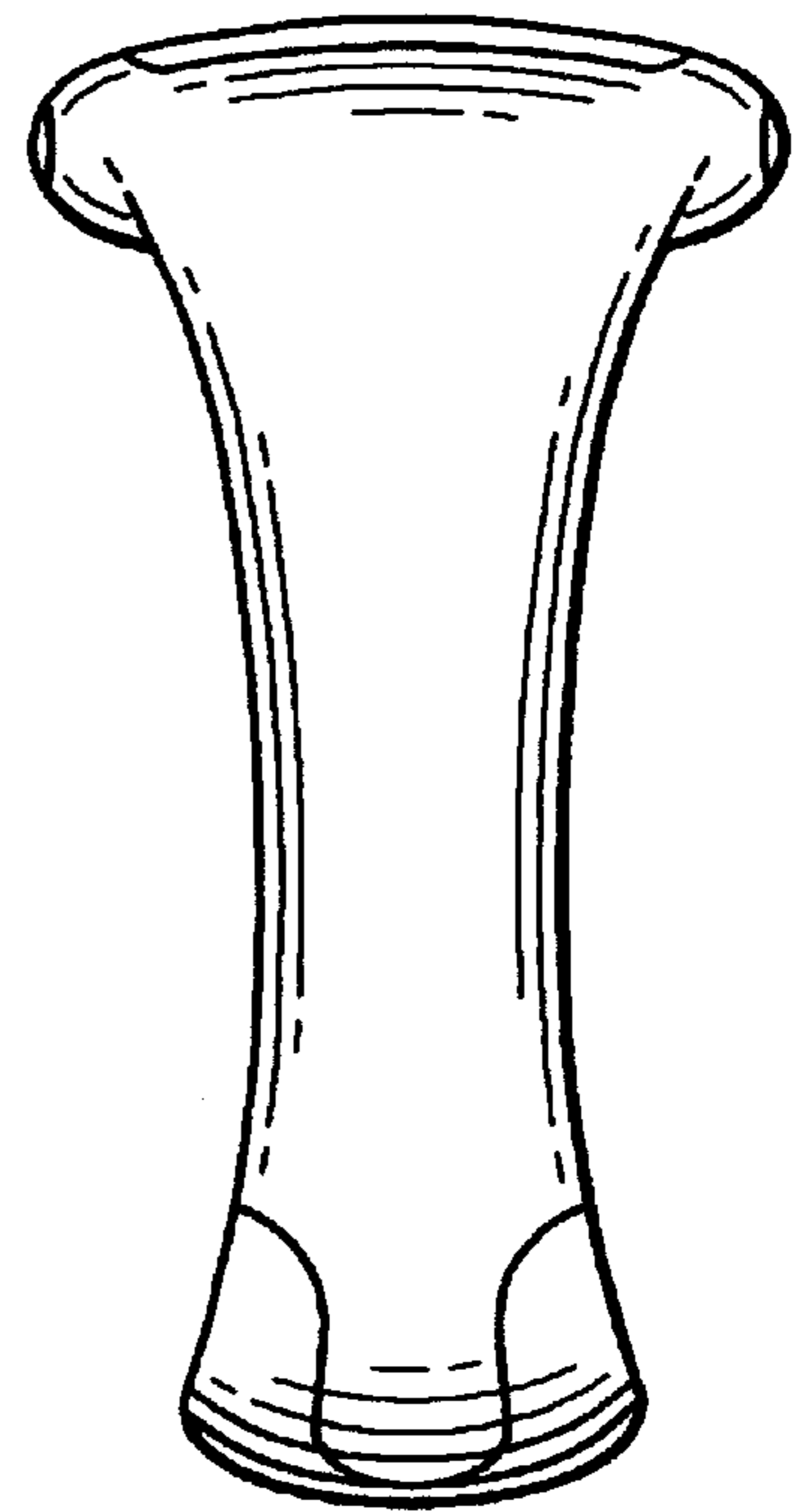

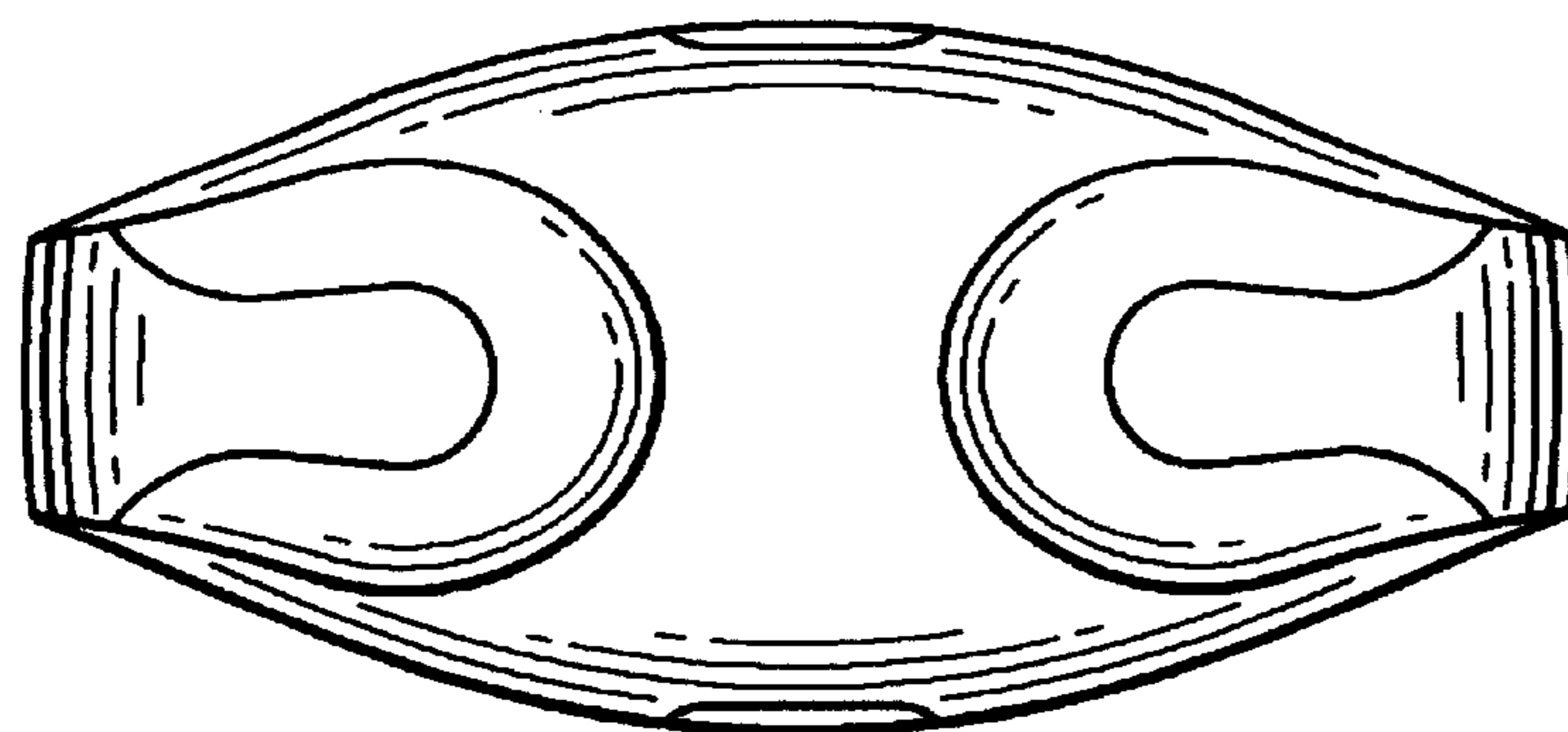

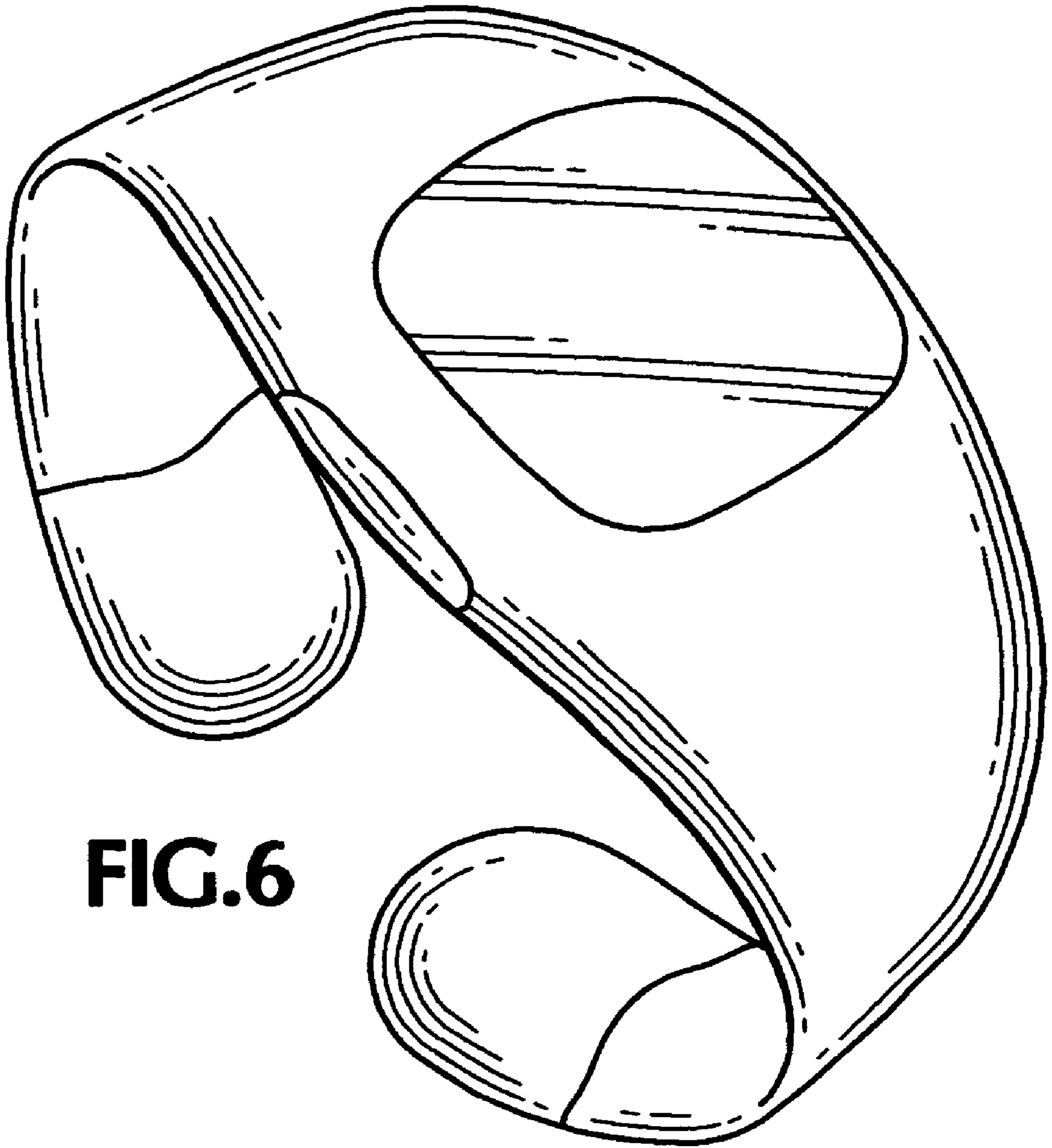

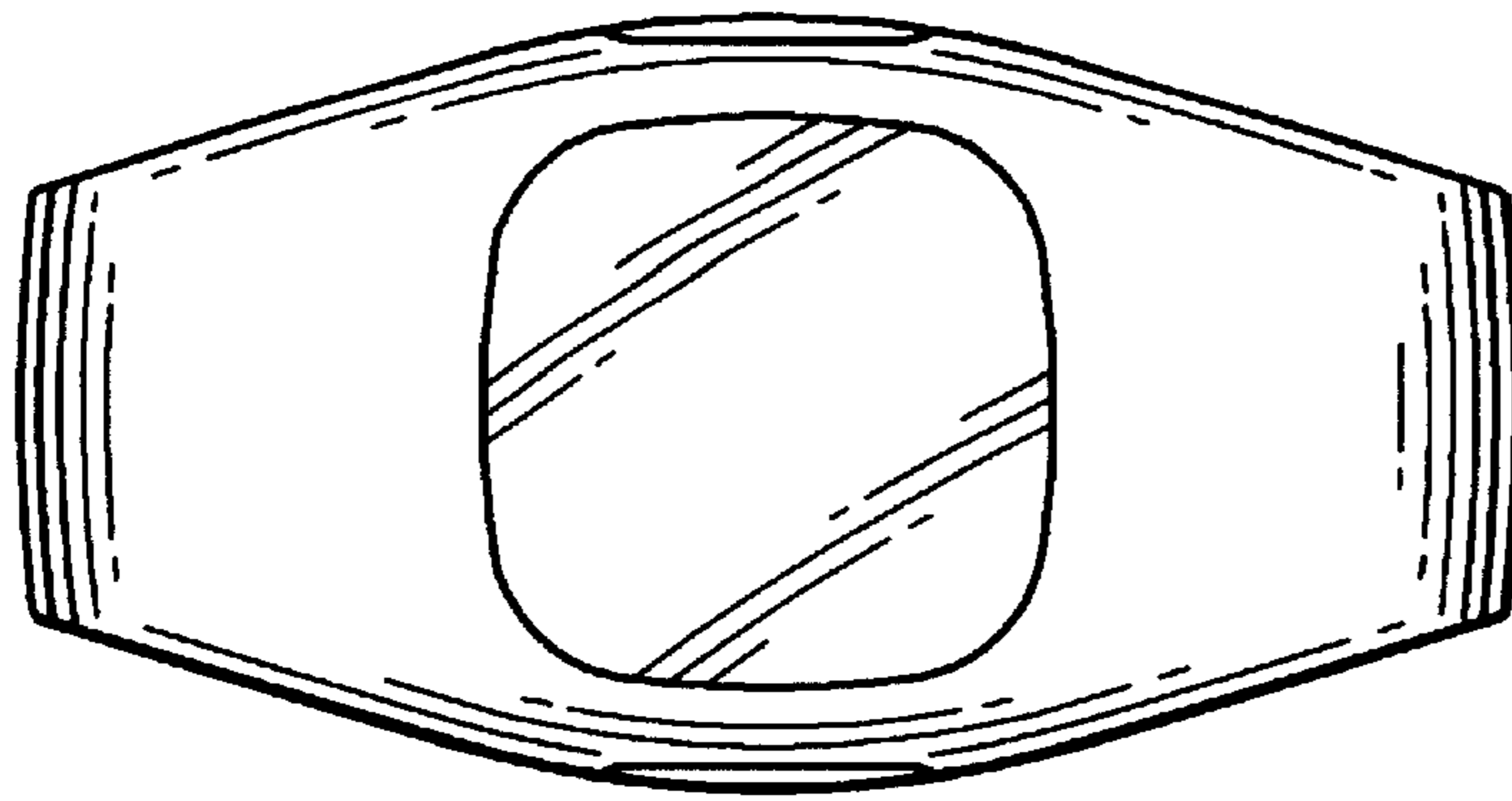

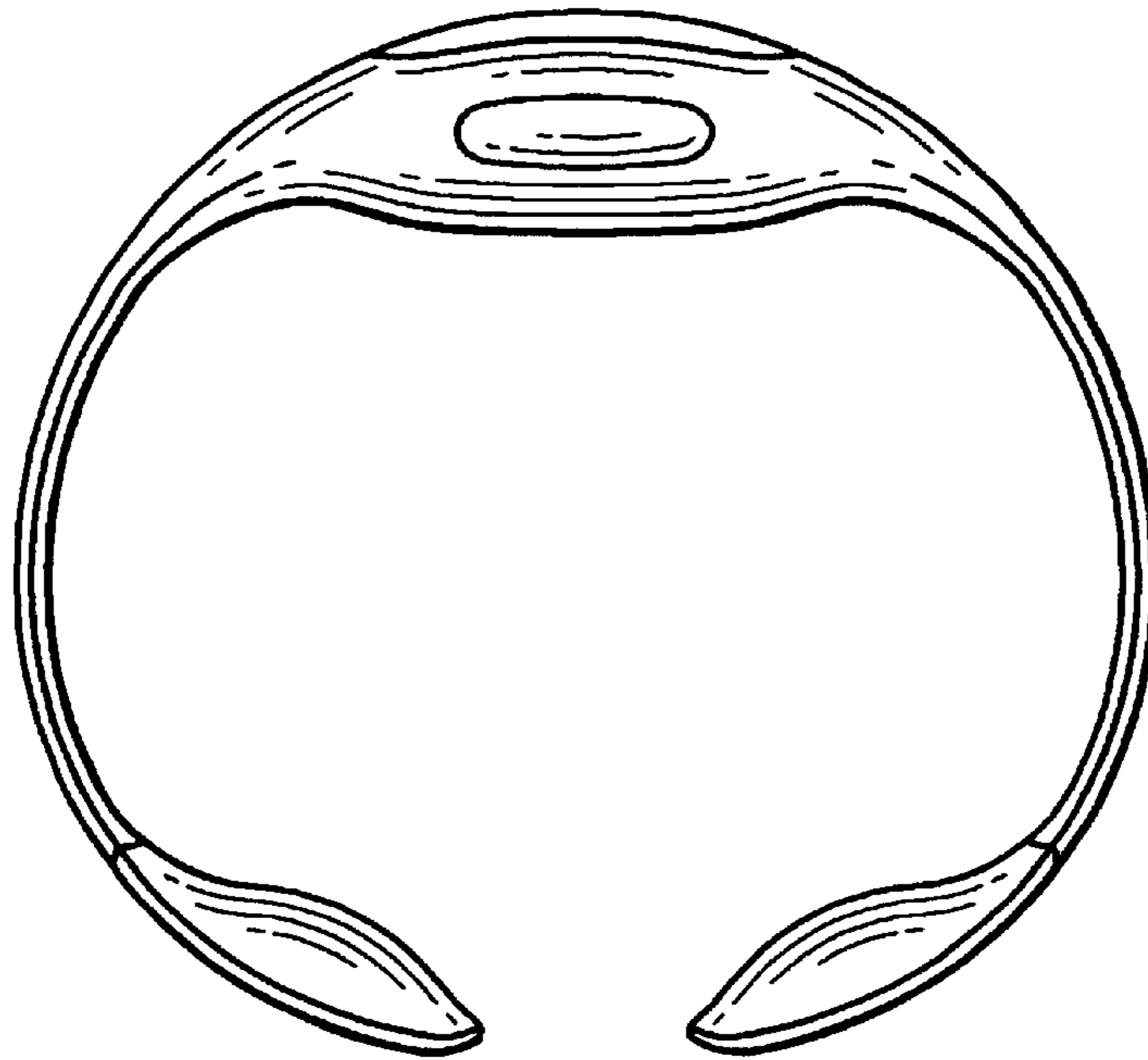

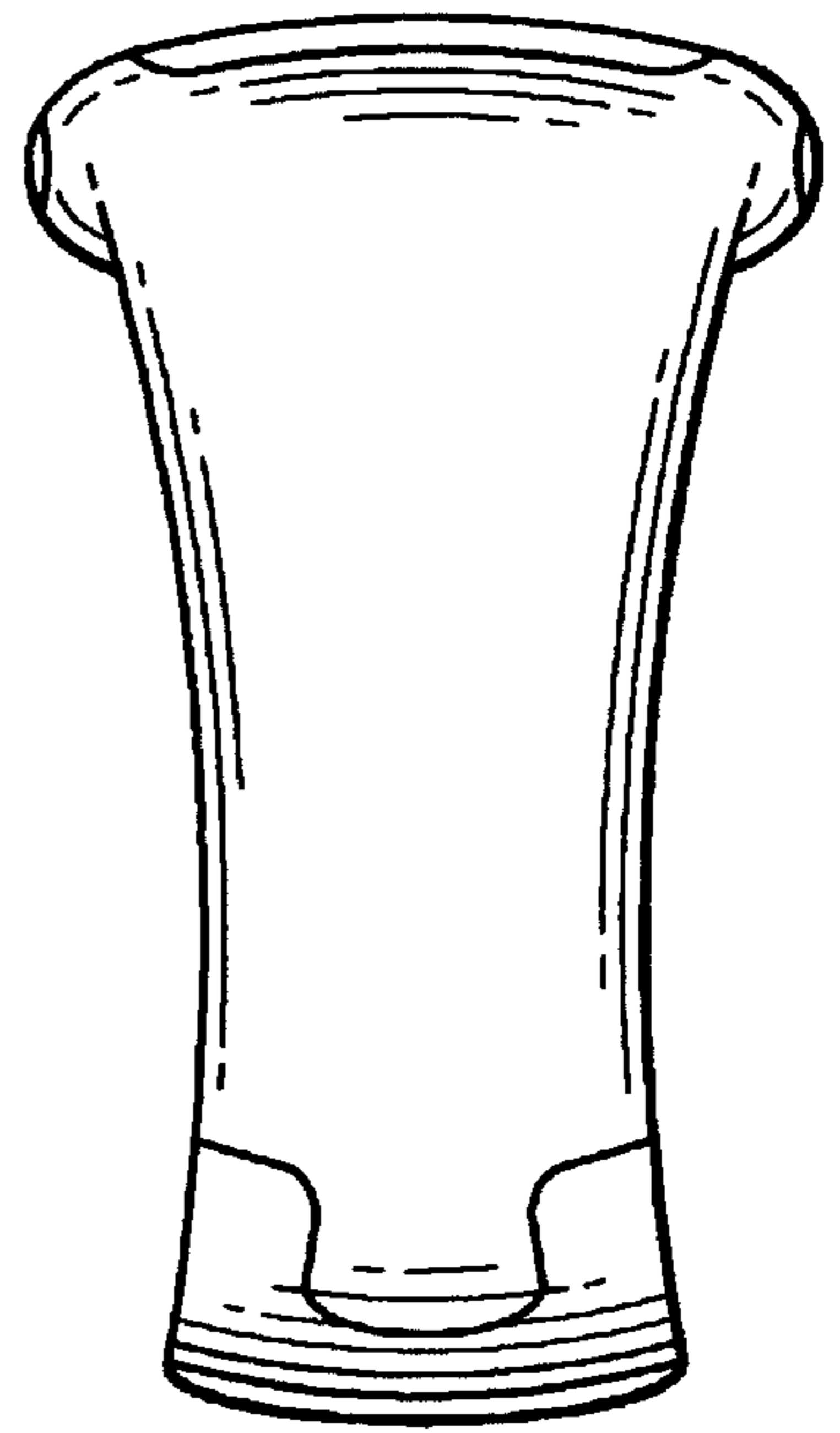

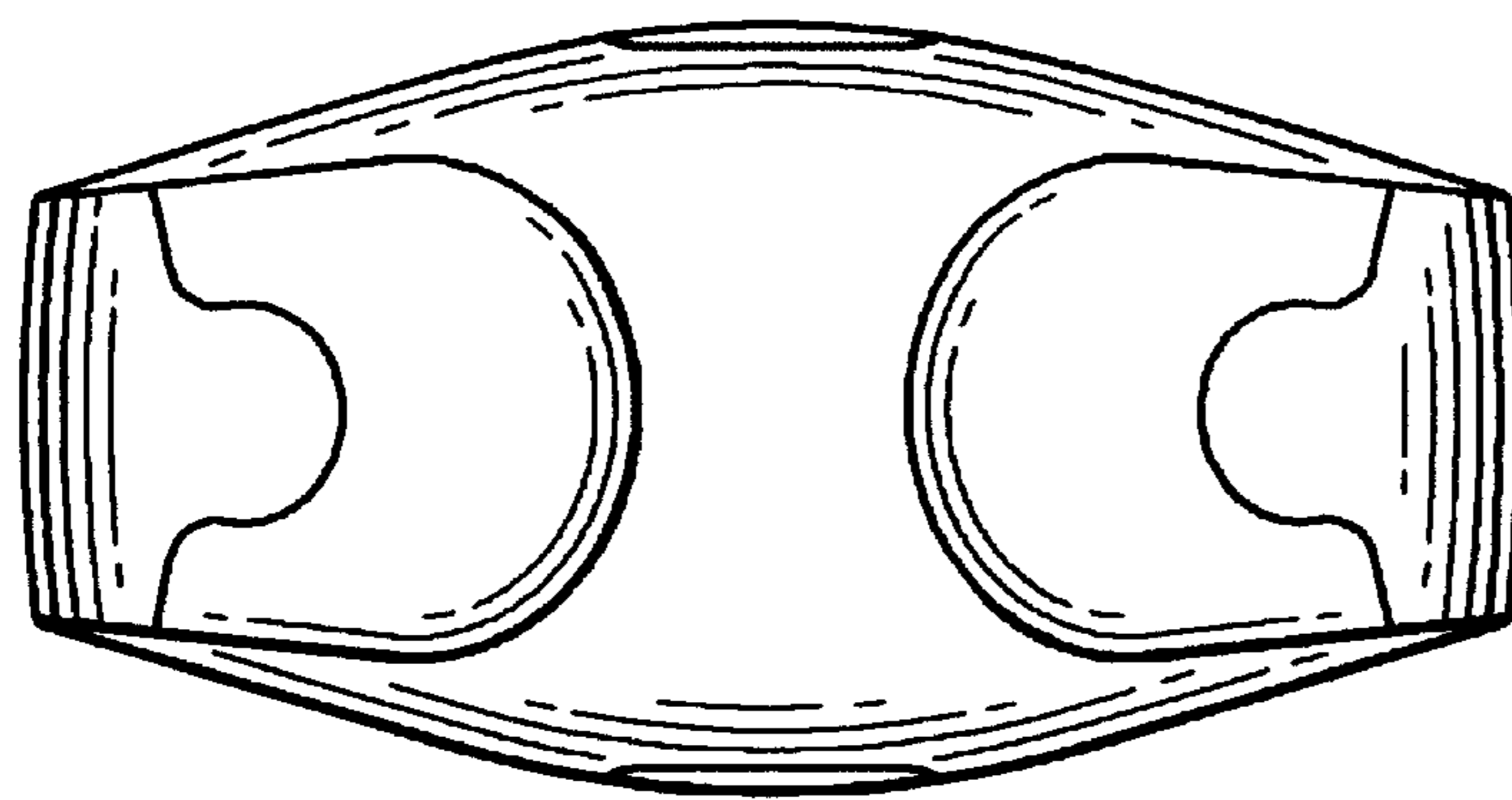
