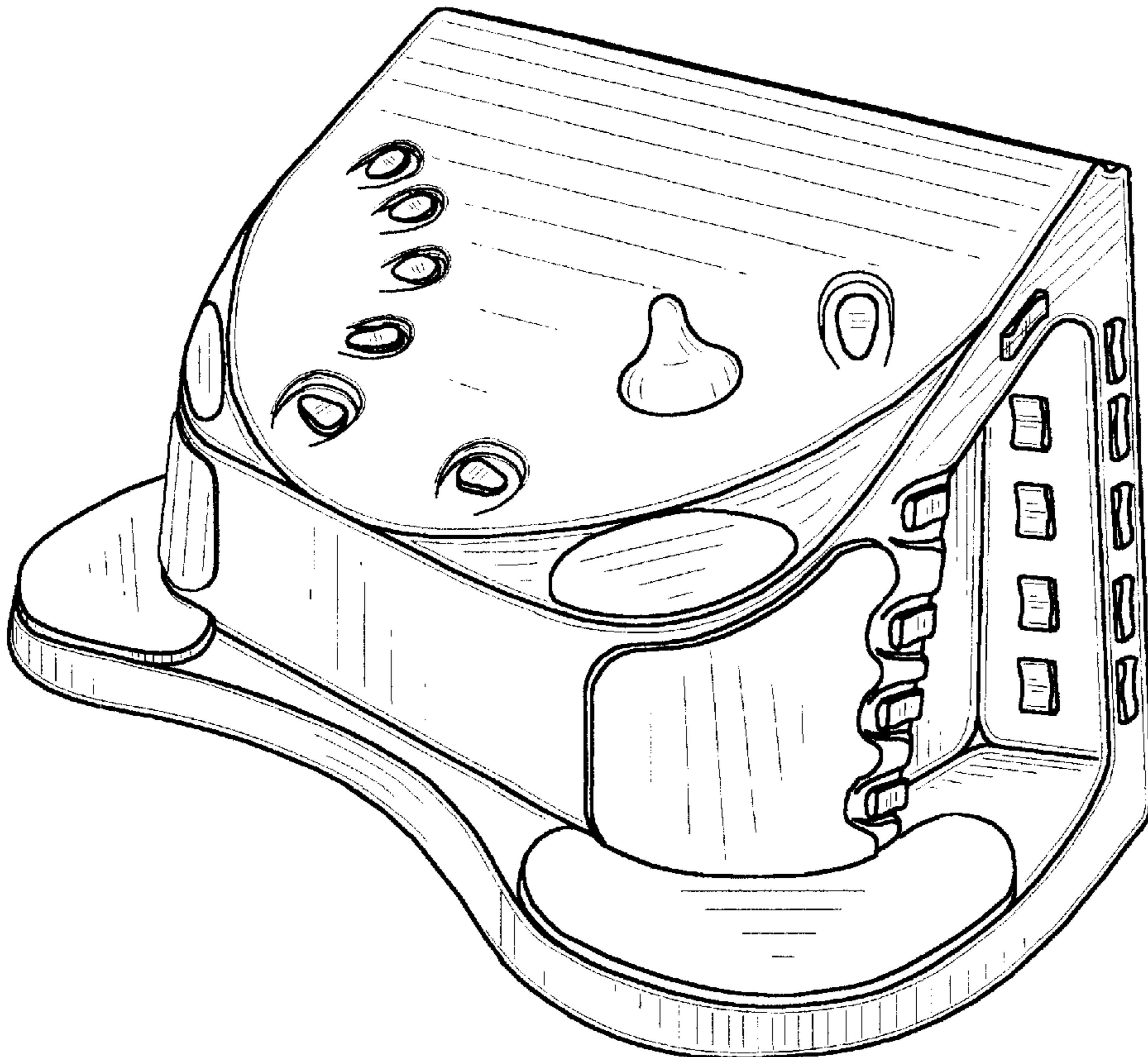
(57) **CLAIM**

I claim the ornamental design for the three dimensional input device, as shown and described.

**DESCRIPTION**

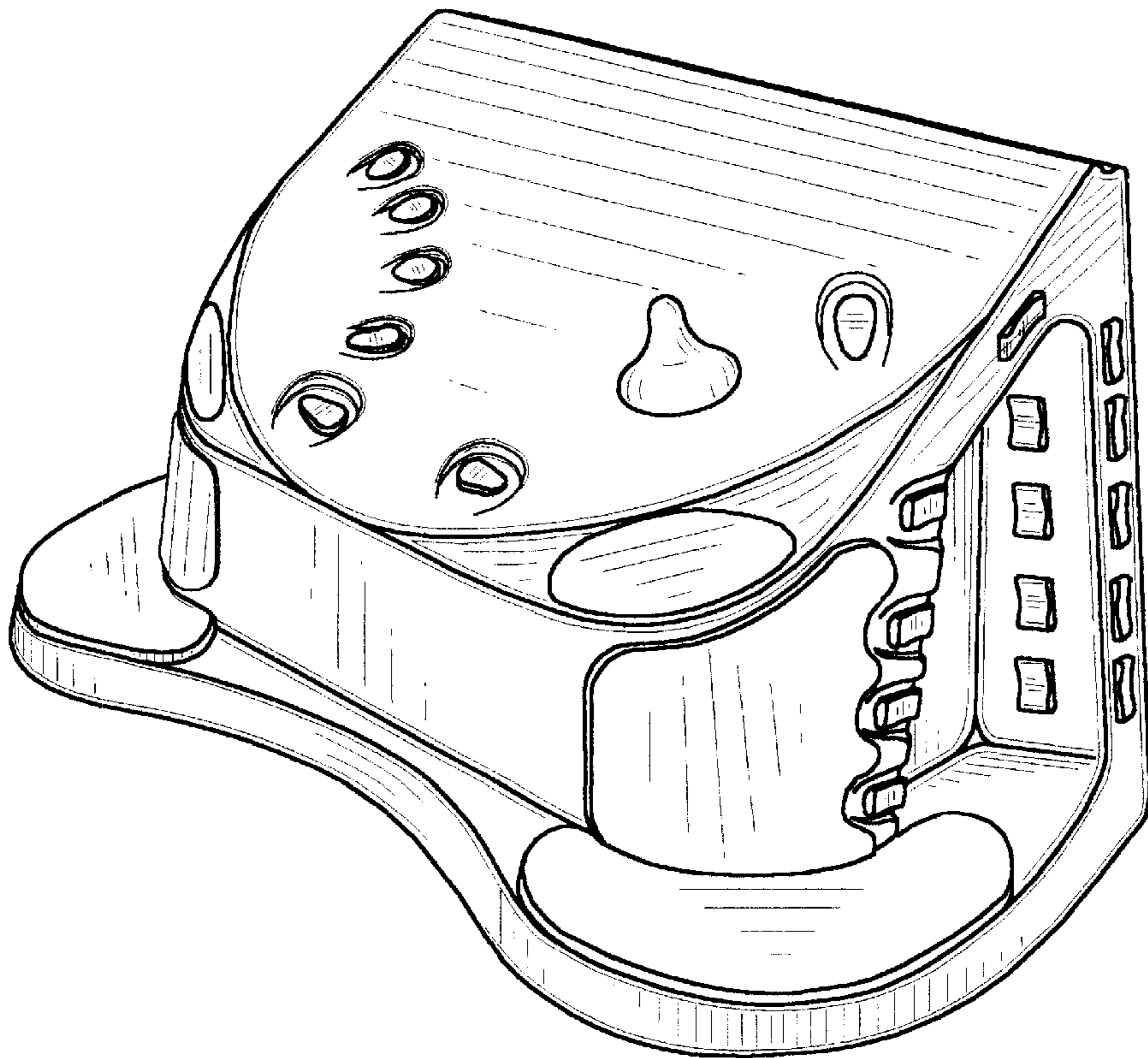

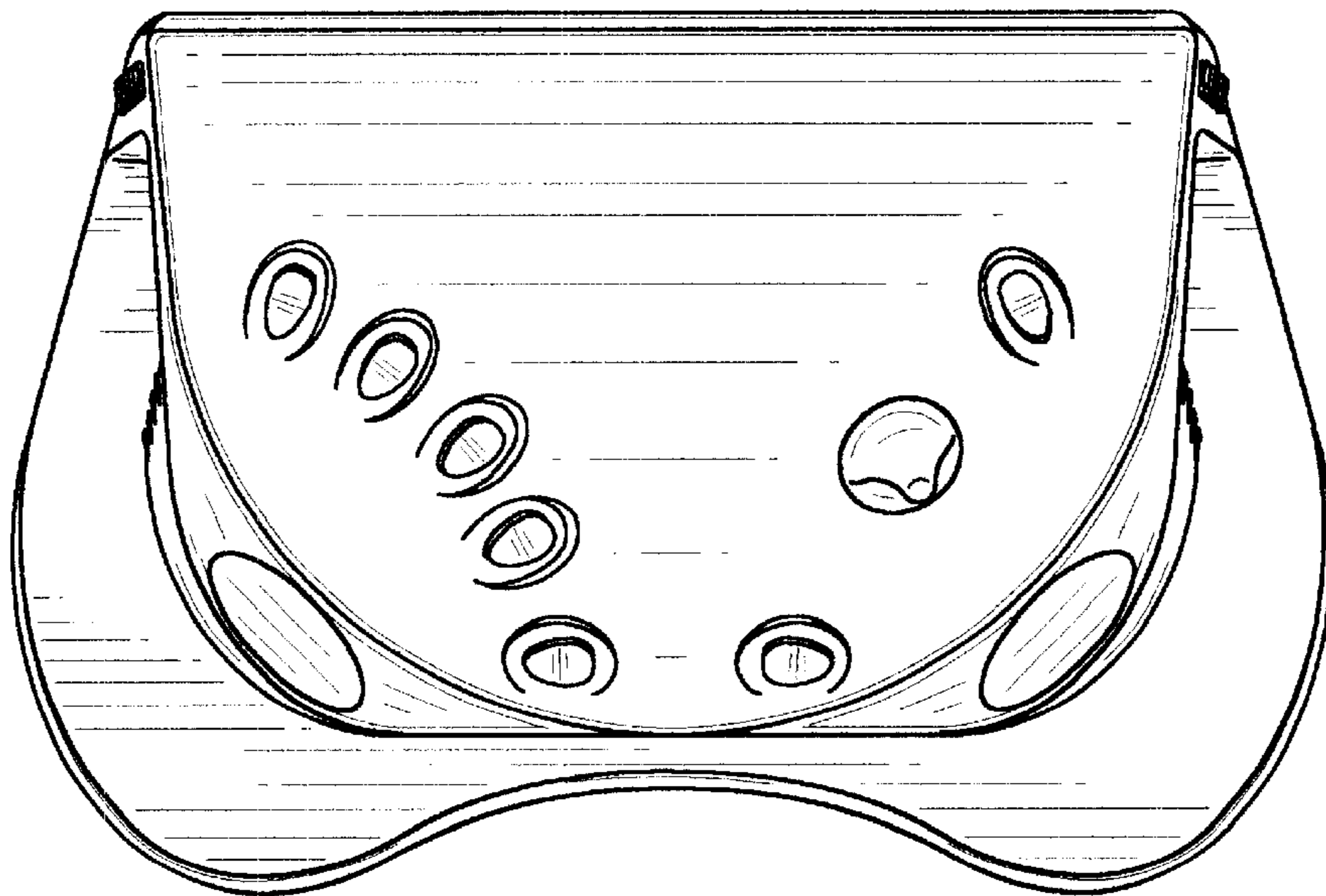

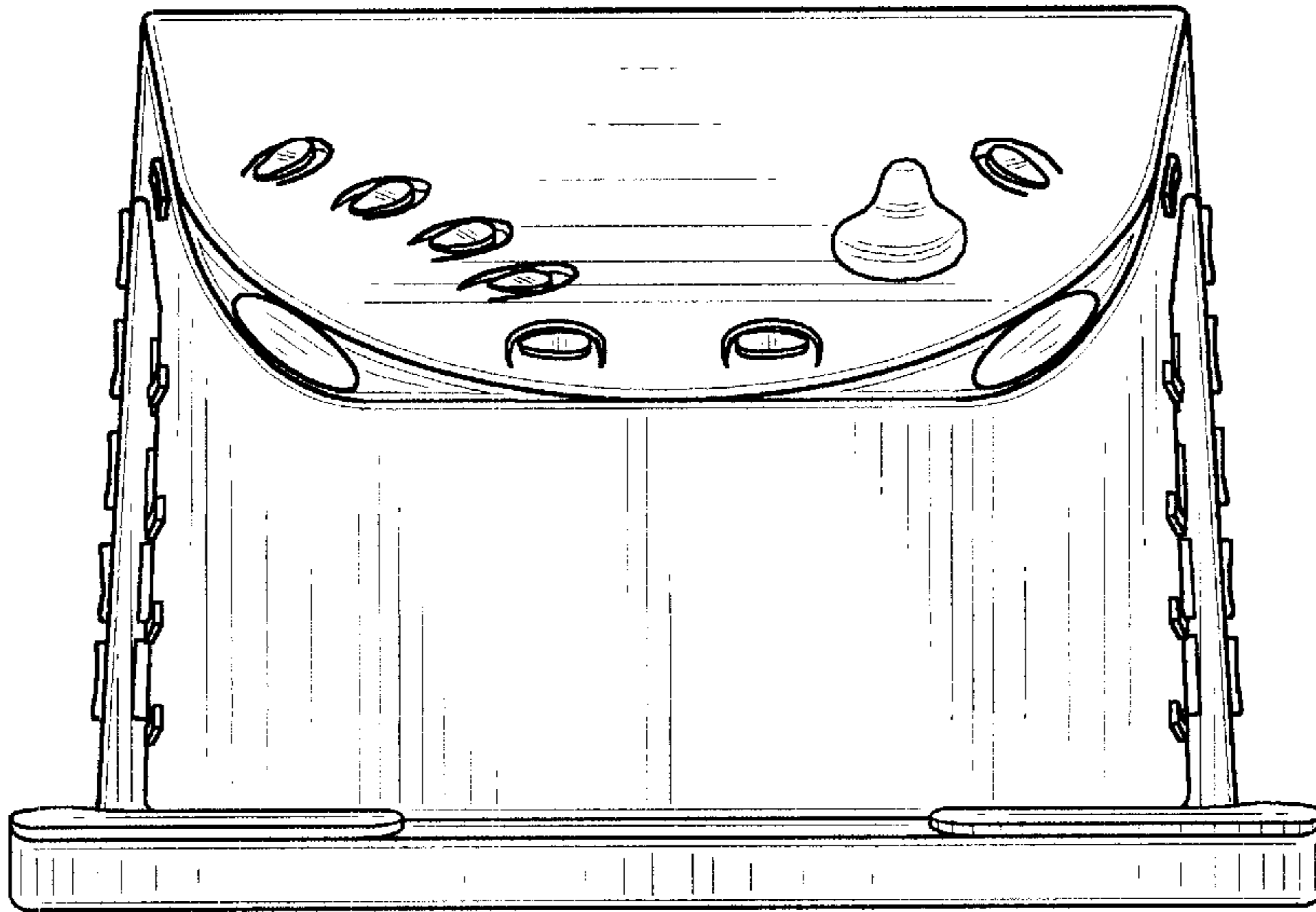

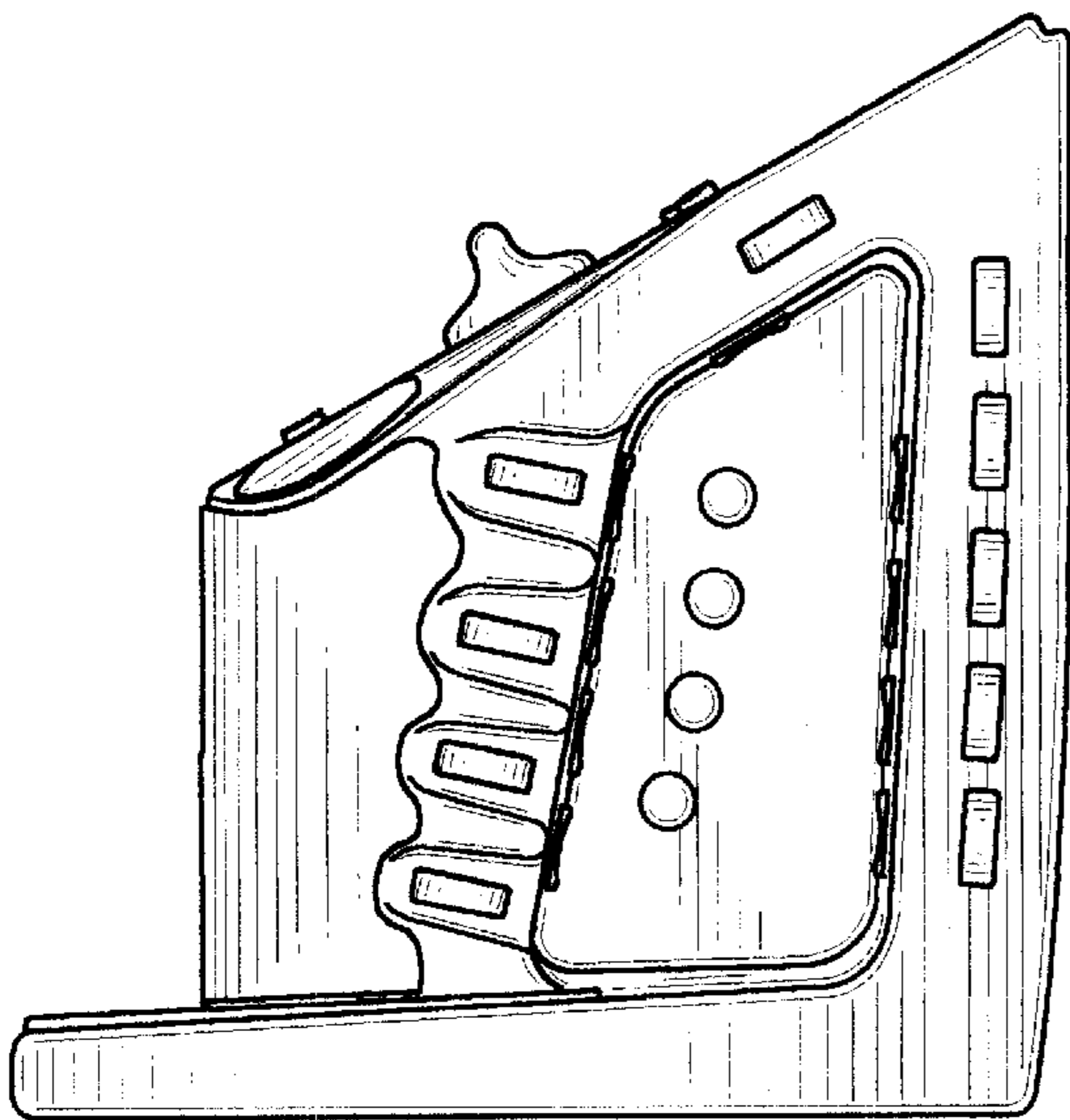

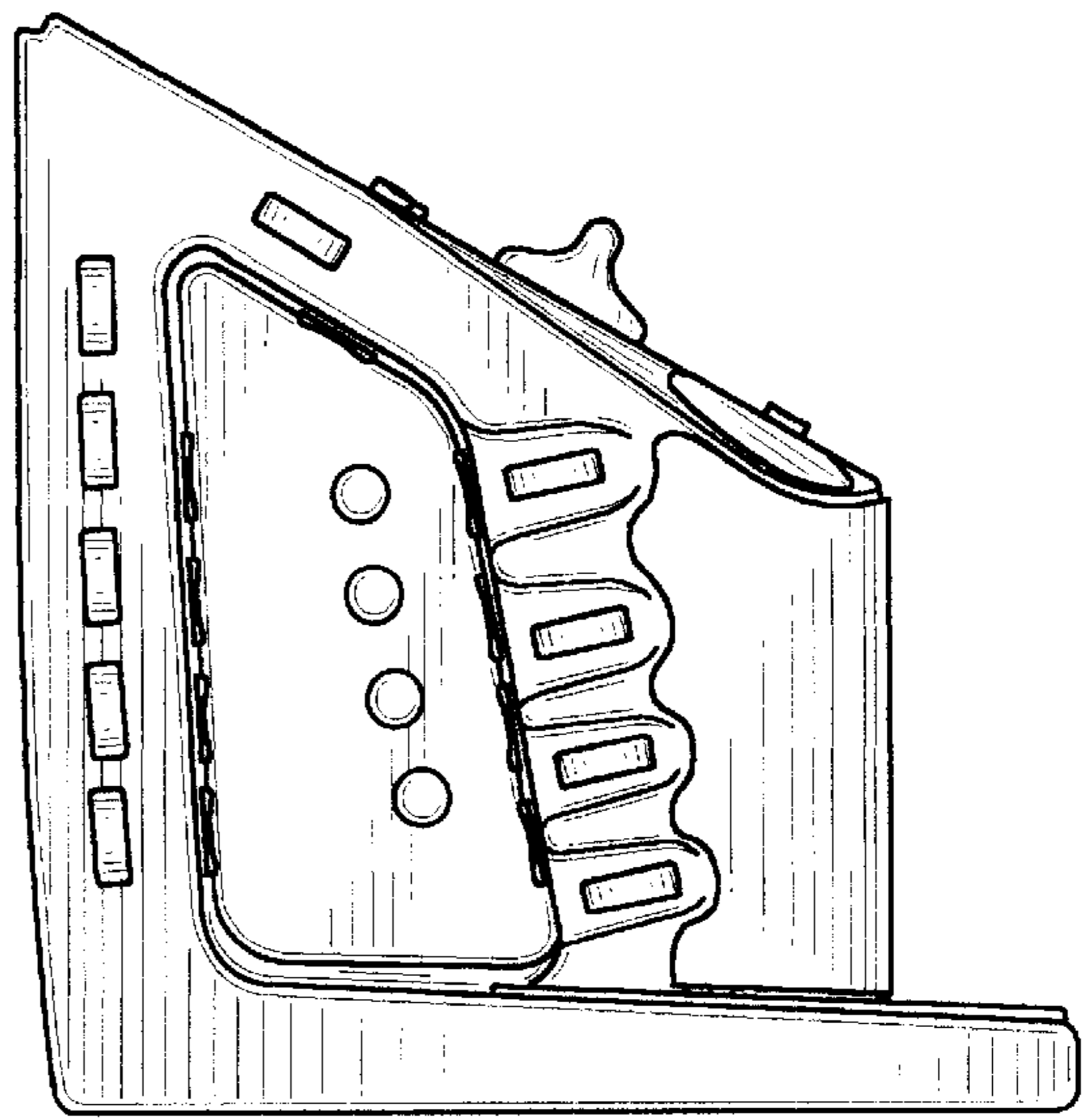
