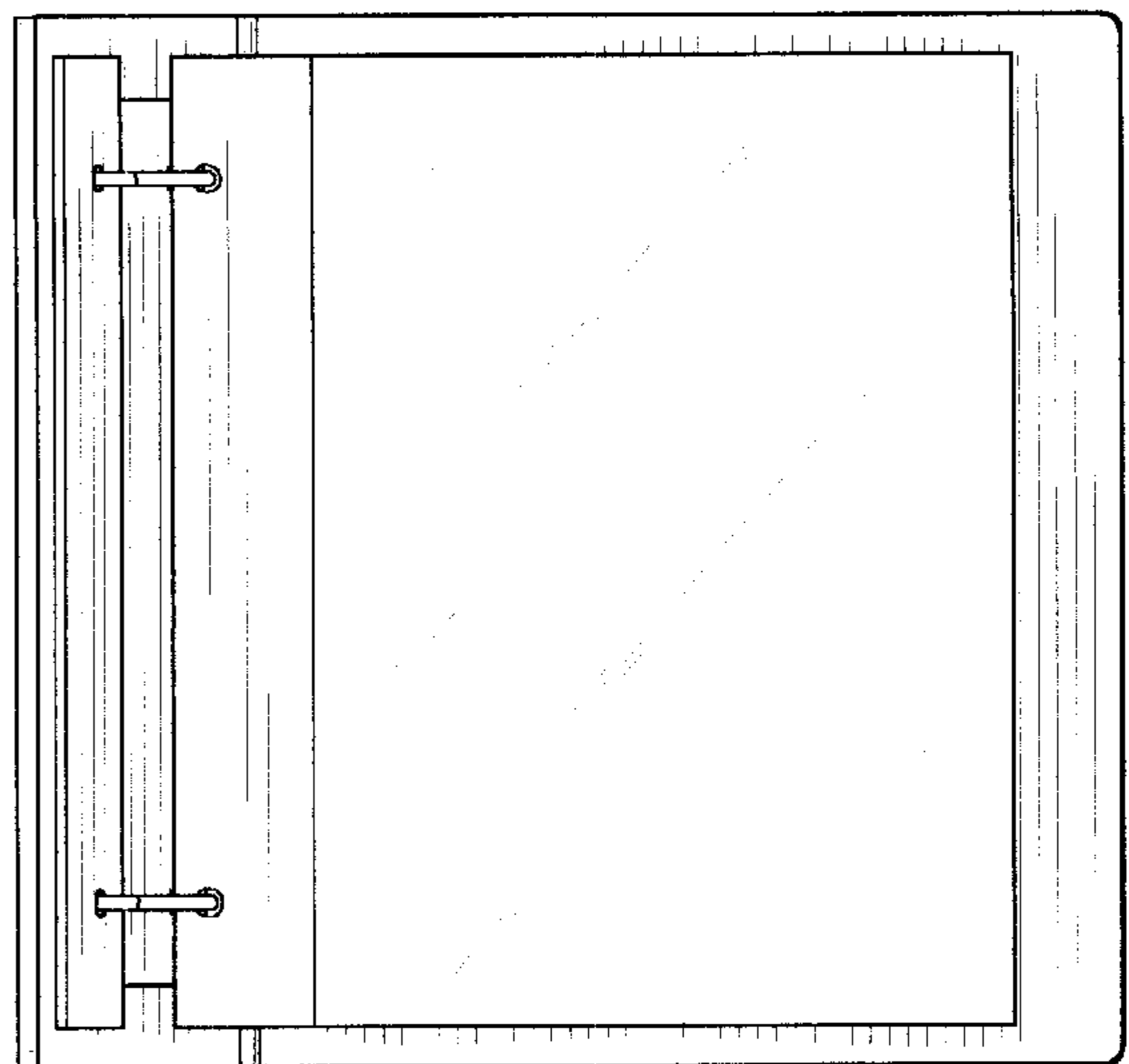
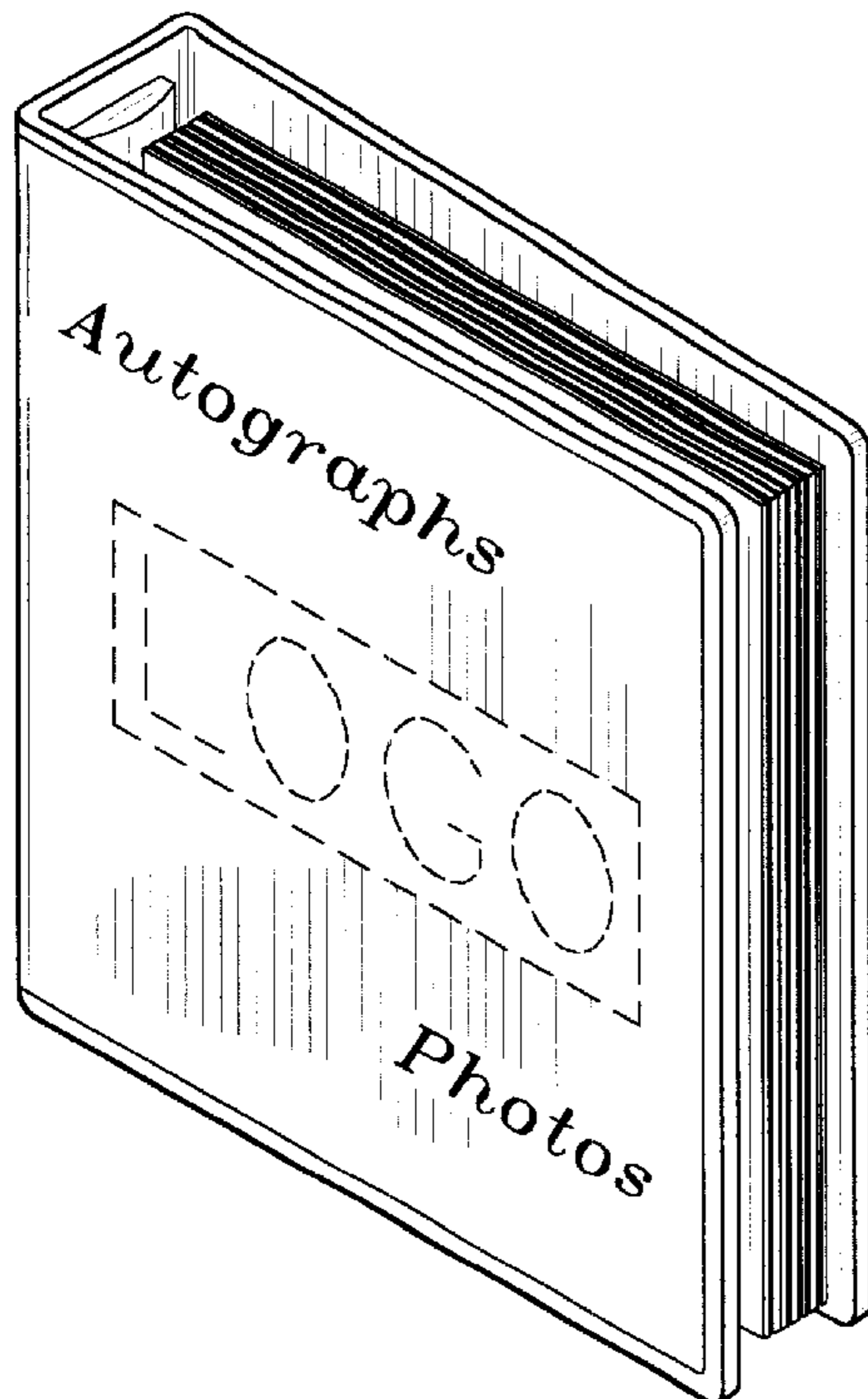
The ornamental design for a combined photo album and autograph book, as shown and described.

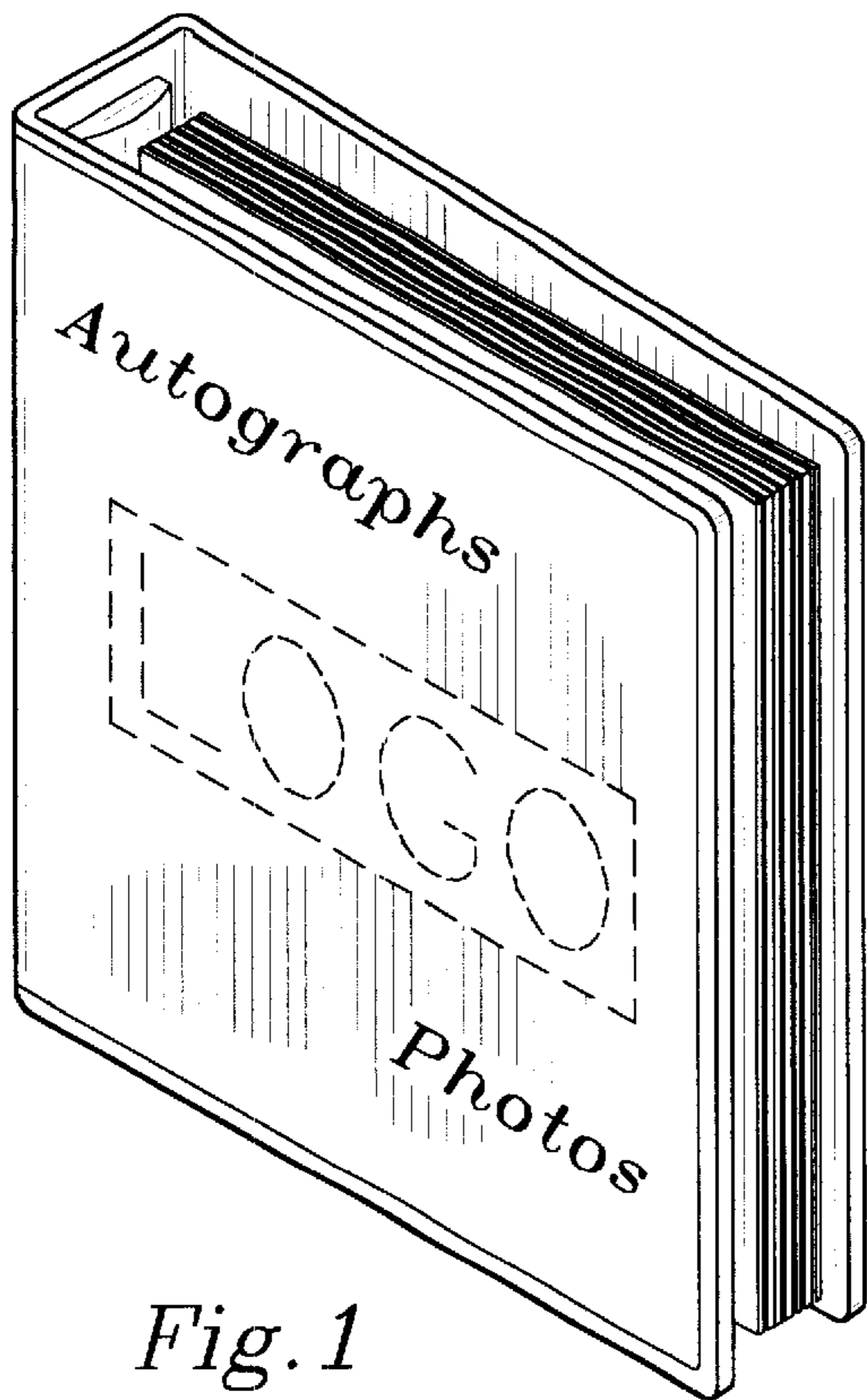
**DESCRIPTION**

FIG. 1 is a top, front, right side perspective in an alternate position (book closed) view of the combined photo album and autograph book of the present invention;  
 FIG. 2 is a front elevational view of the combined photo album and autograph book of FIG. 1;  
 FIG. 3 is a rear elevational view of the combined photo album and autograph book of FIG. 1;  
 FIG. 4 is a left side elevational view of the combined photo album and autograph book of FIG. 1;  
 FIG. 5 is a right side elevational view of the combined photo album and autograph book of FIG. 1; and,  
 FIG. 6 is a top plan view of the combined photo album and autograph book of FIG. 1, the bottom view being a mirror image thereof.

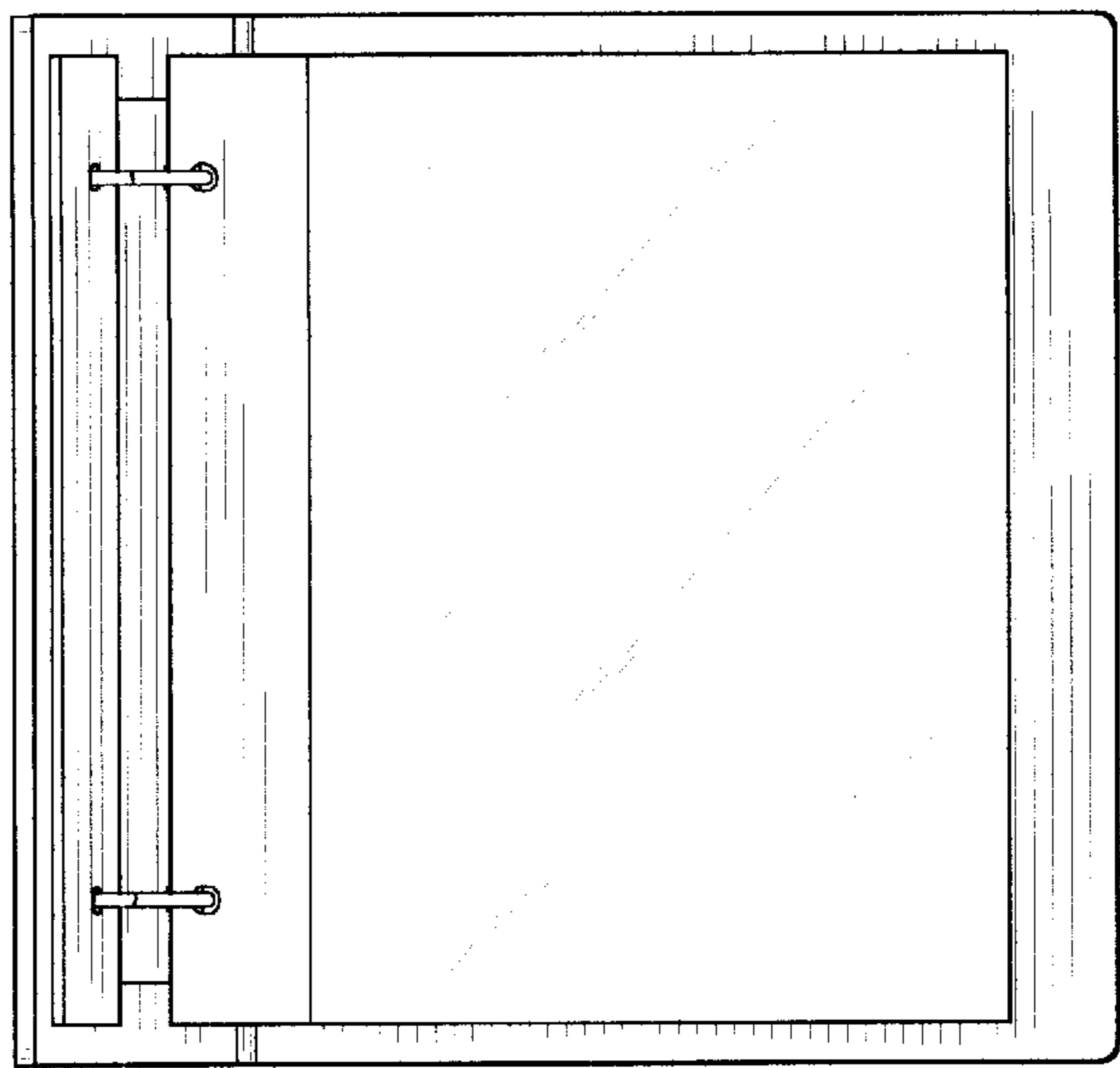
The broken lines showing of a logo in FIGS. 1 and 4 are for illustrative purposes only and form no part of the claimed design.

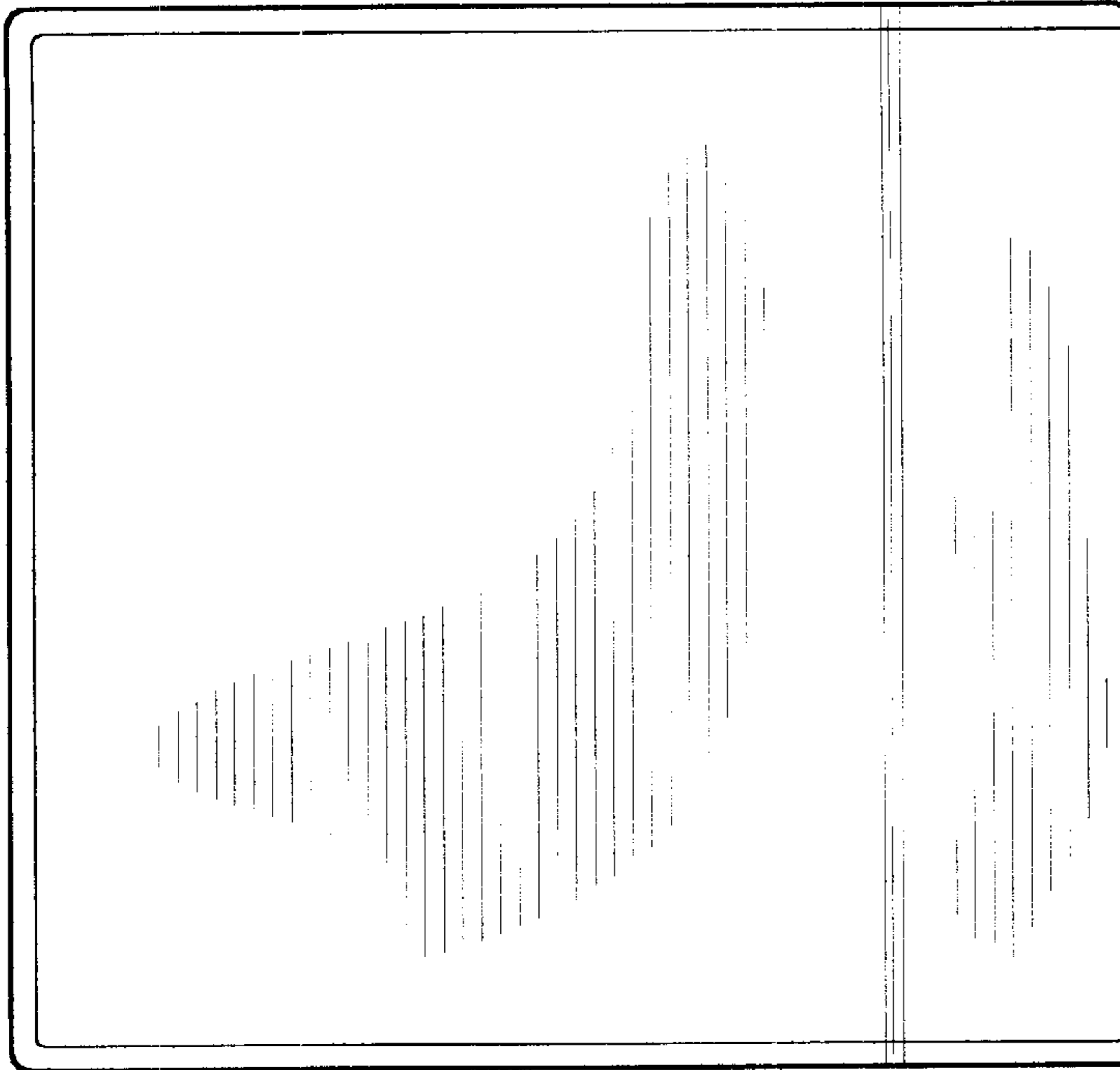




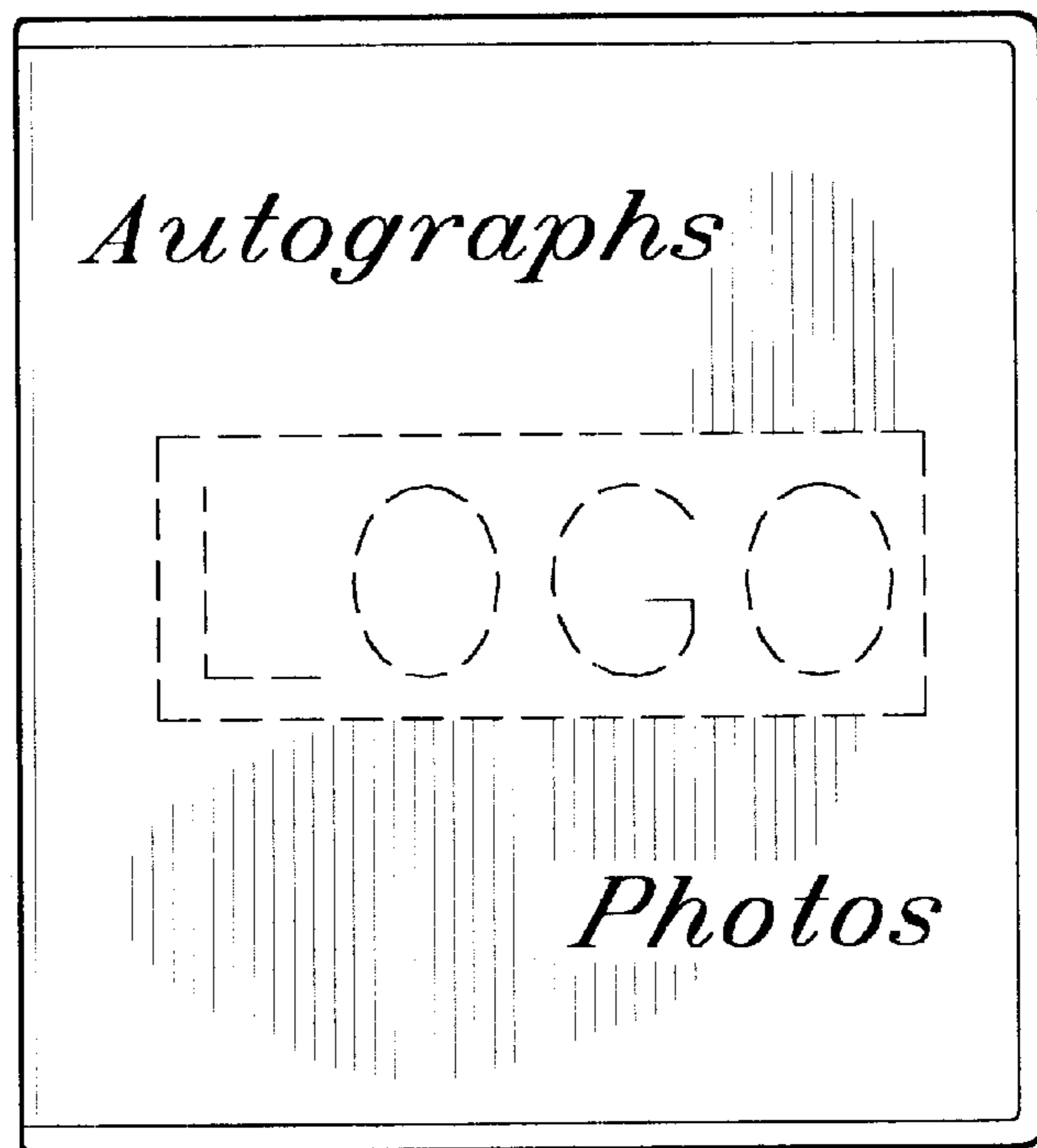

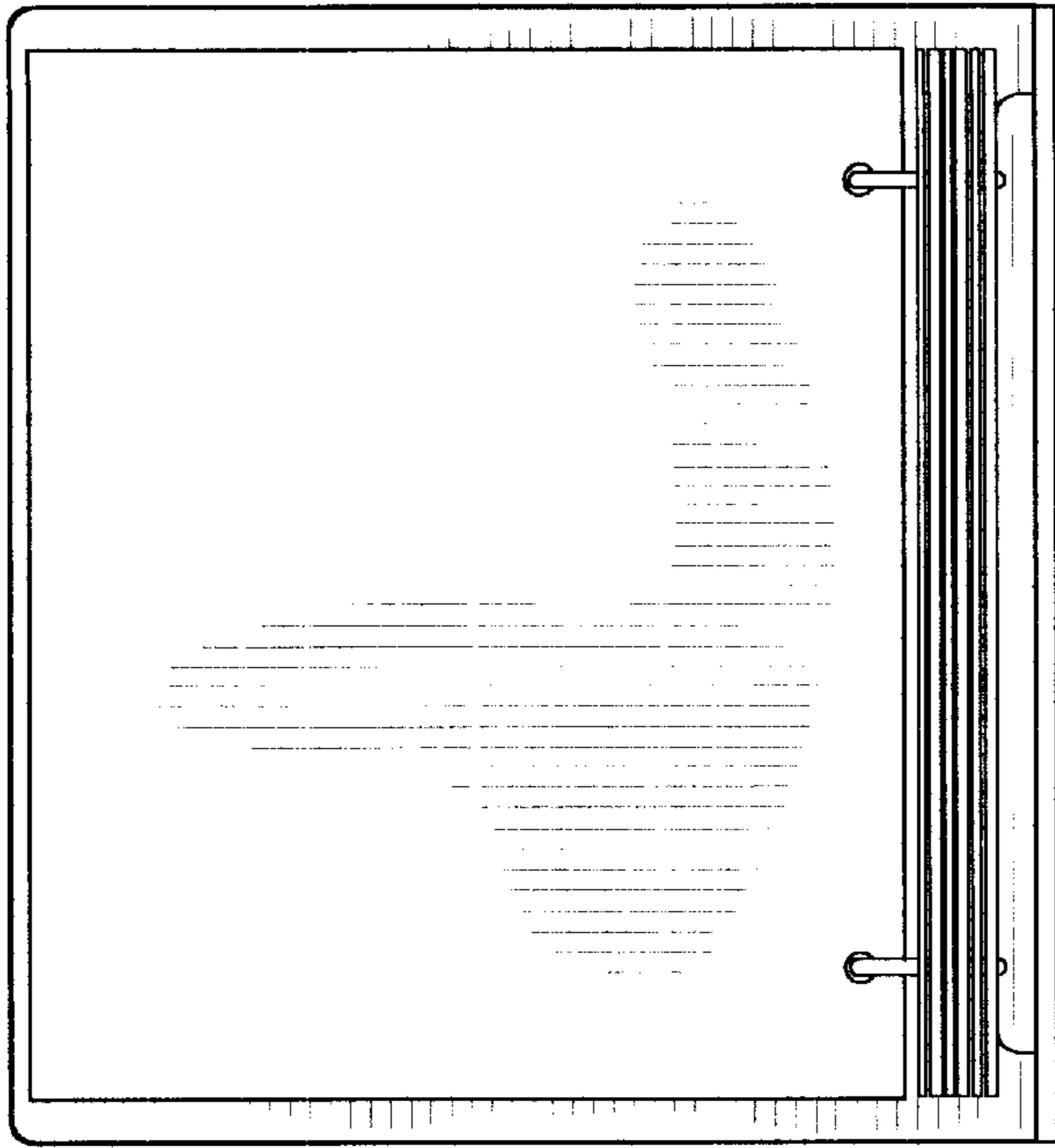

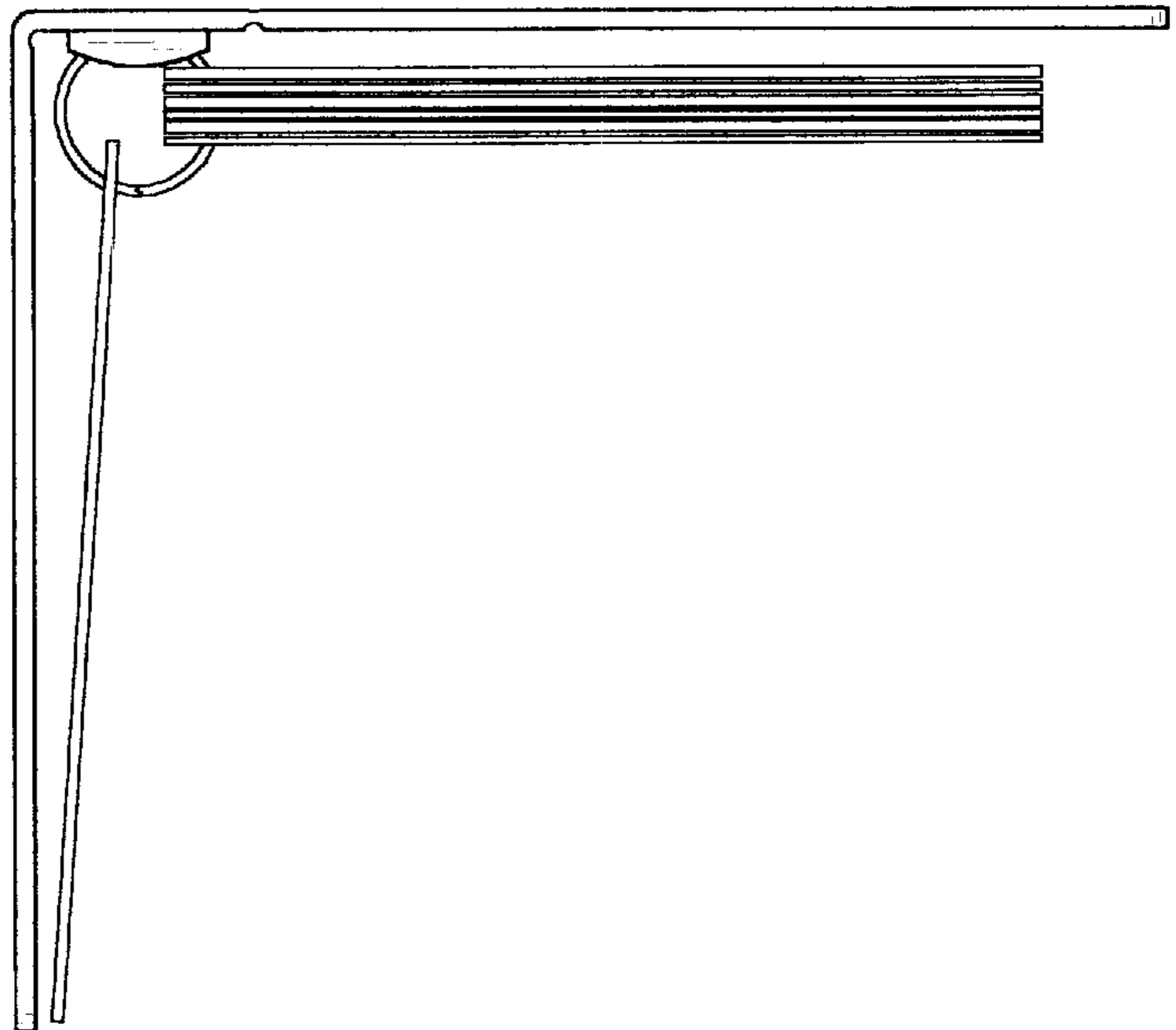
