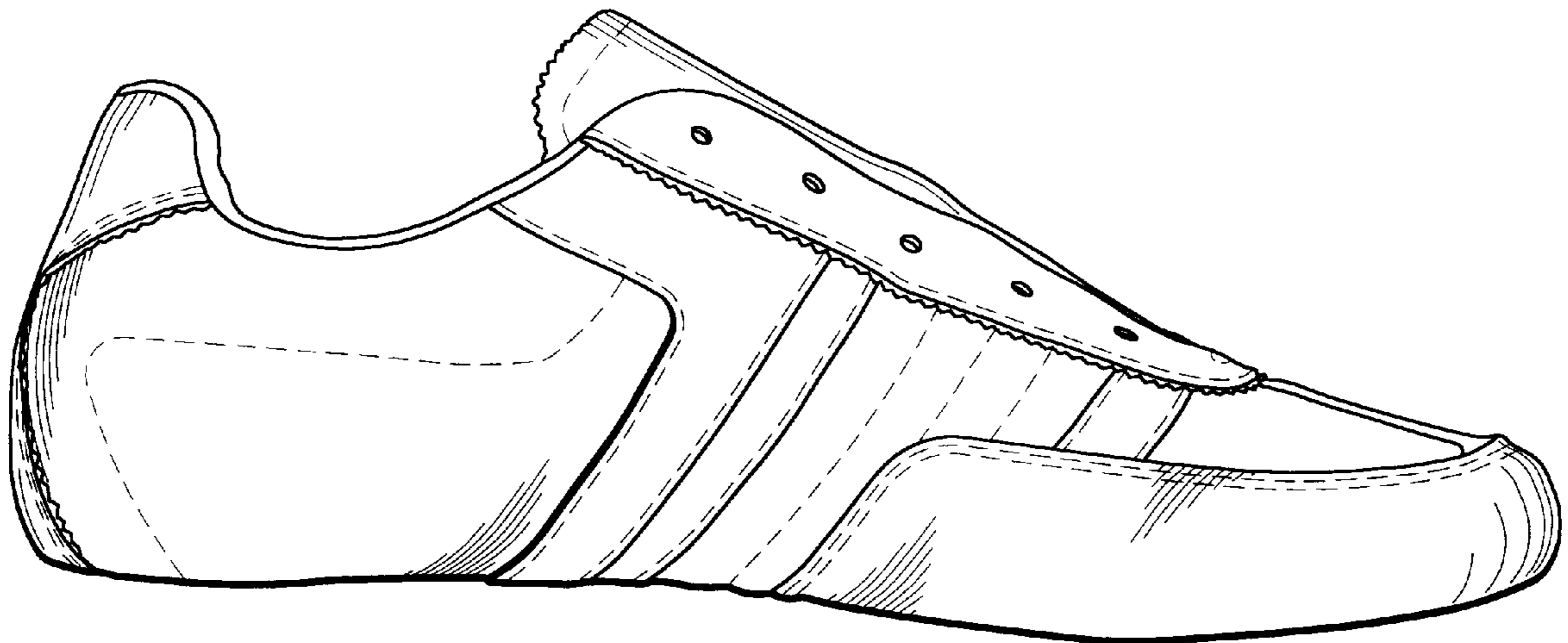

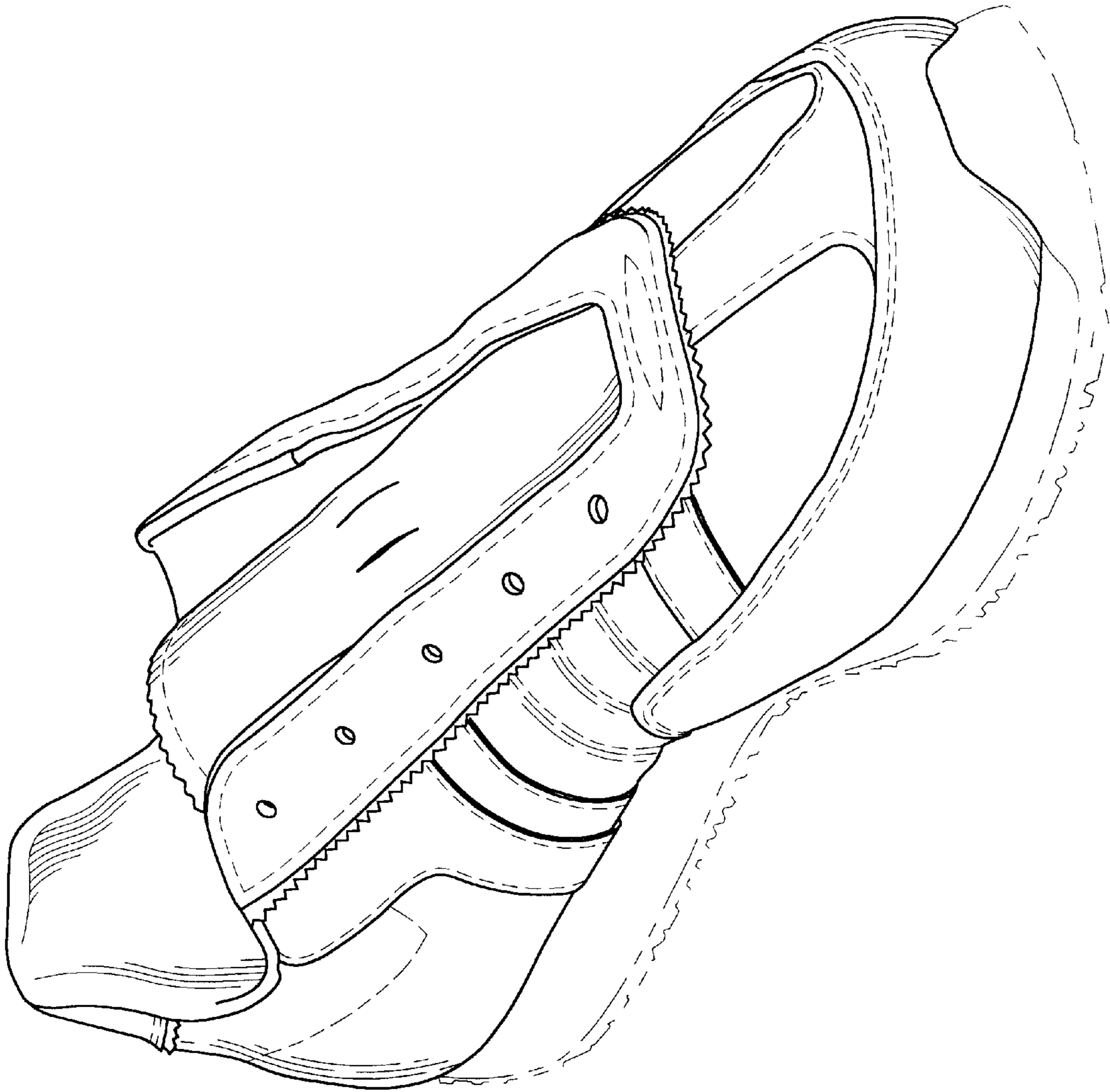
The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

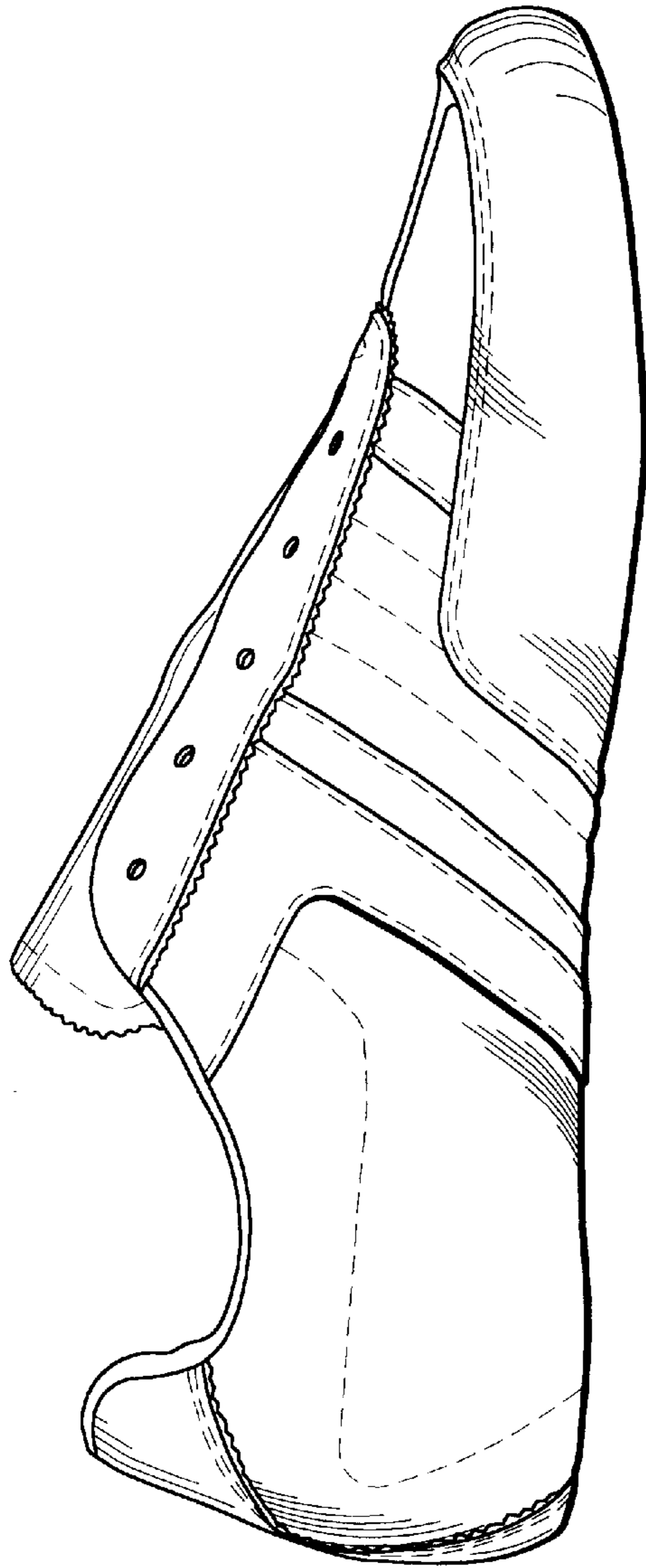
FIG. 1 is a perspective view of the shoe upper showing my new design;

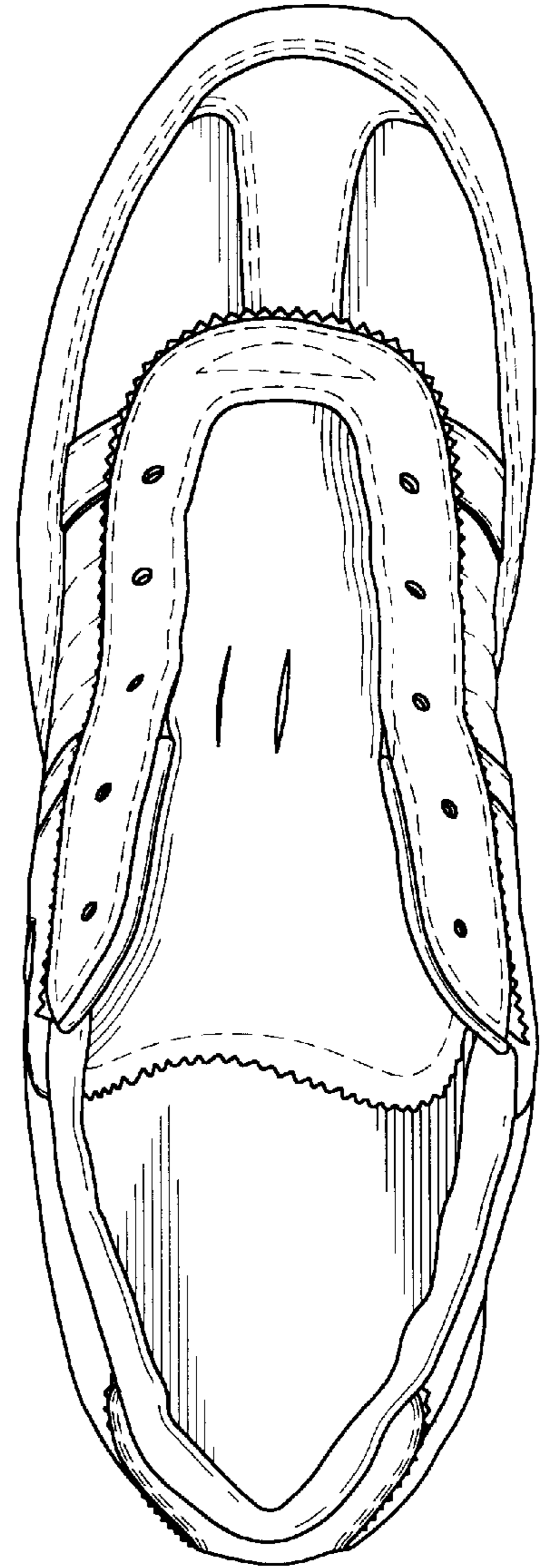

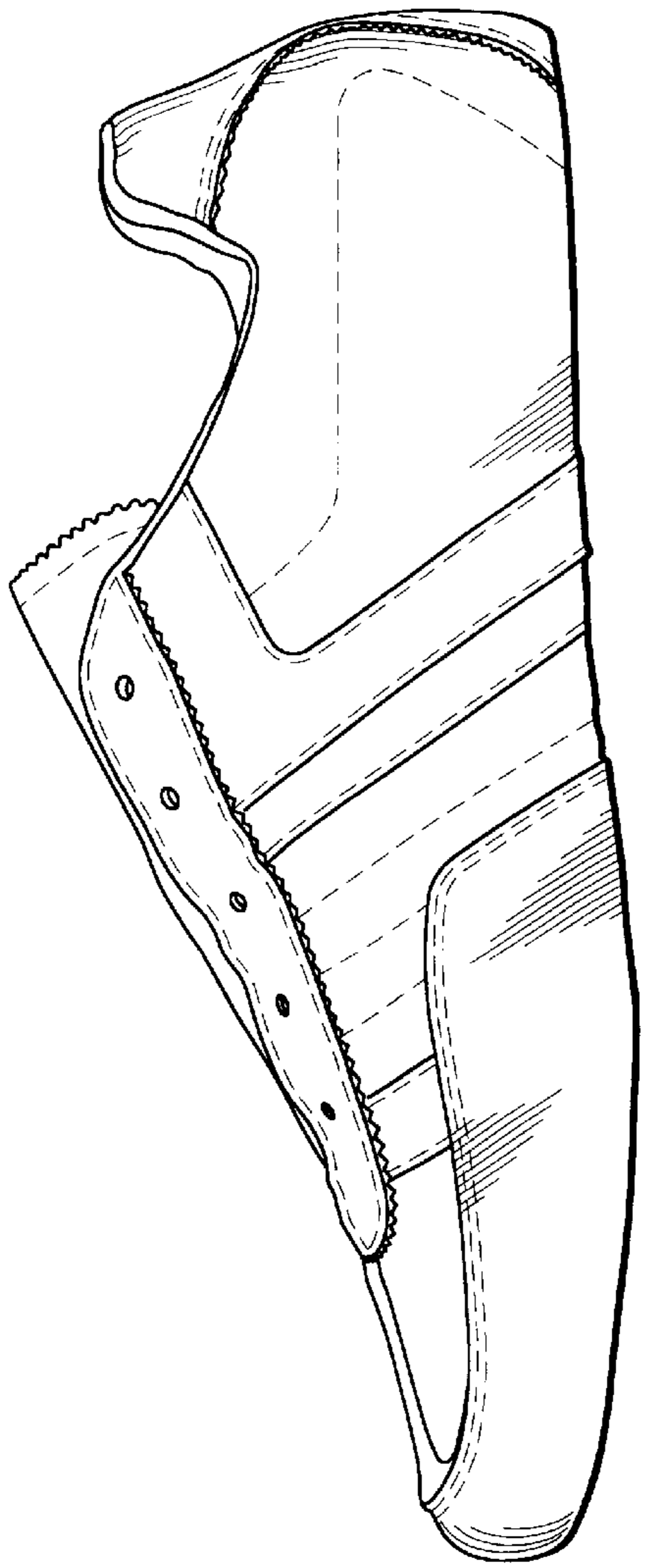

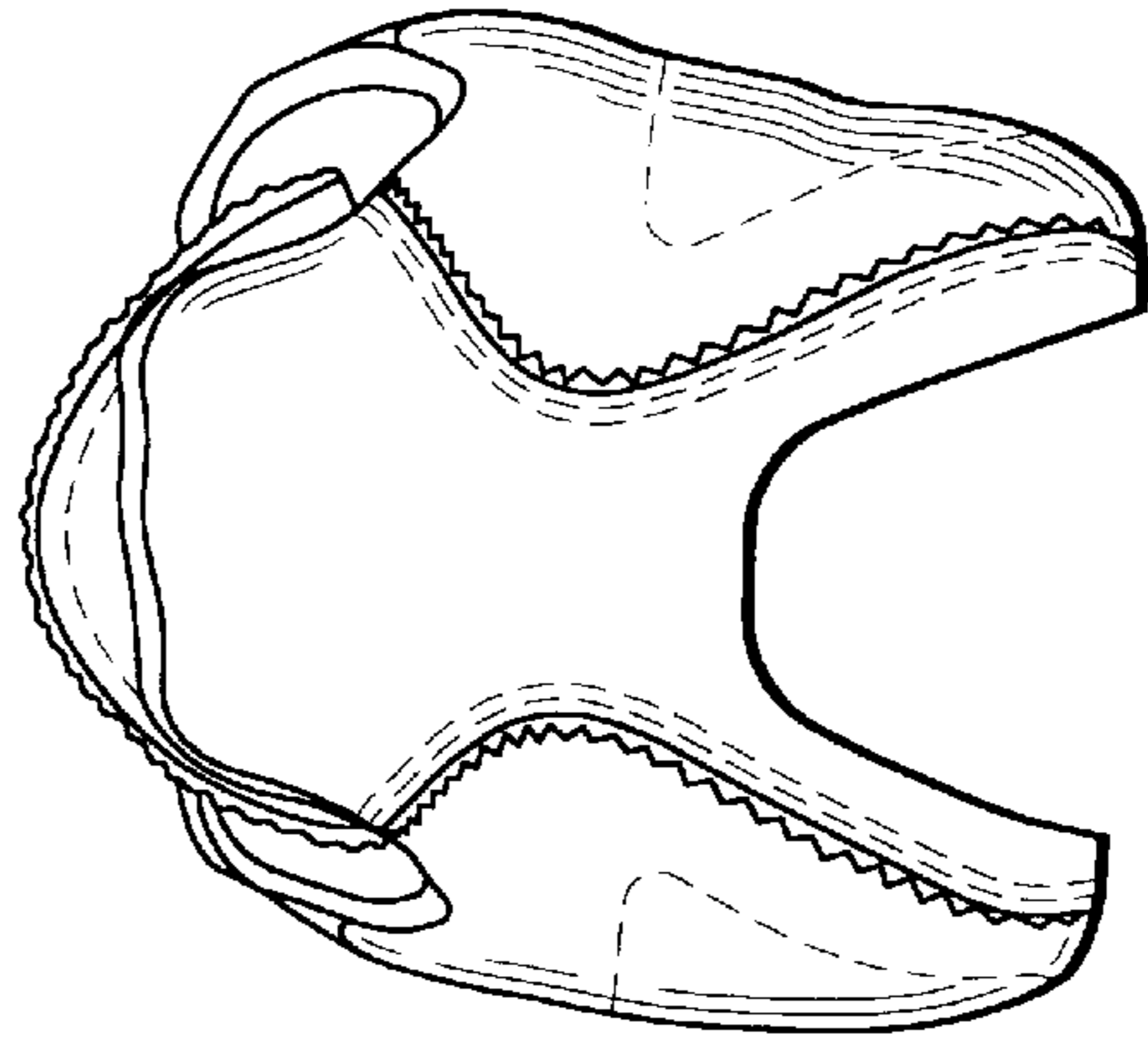

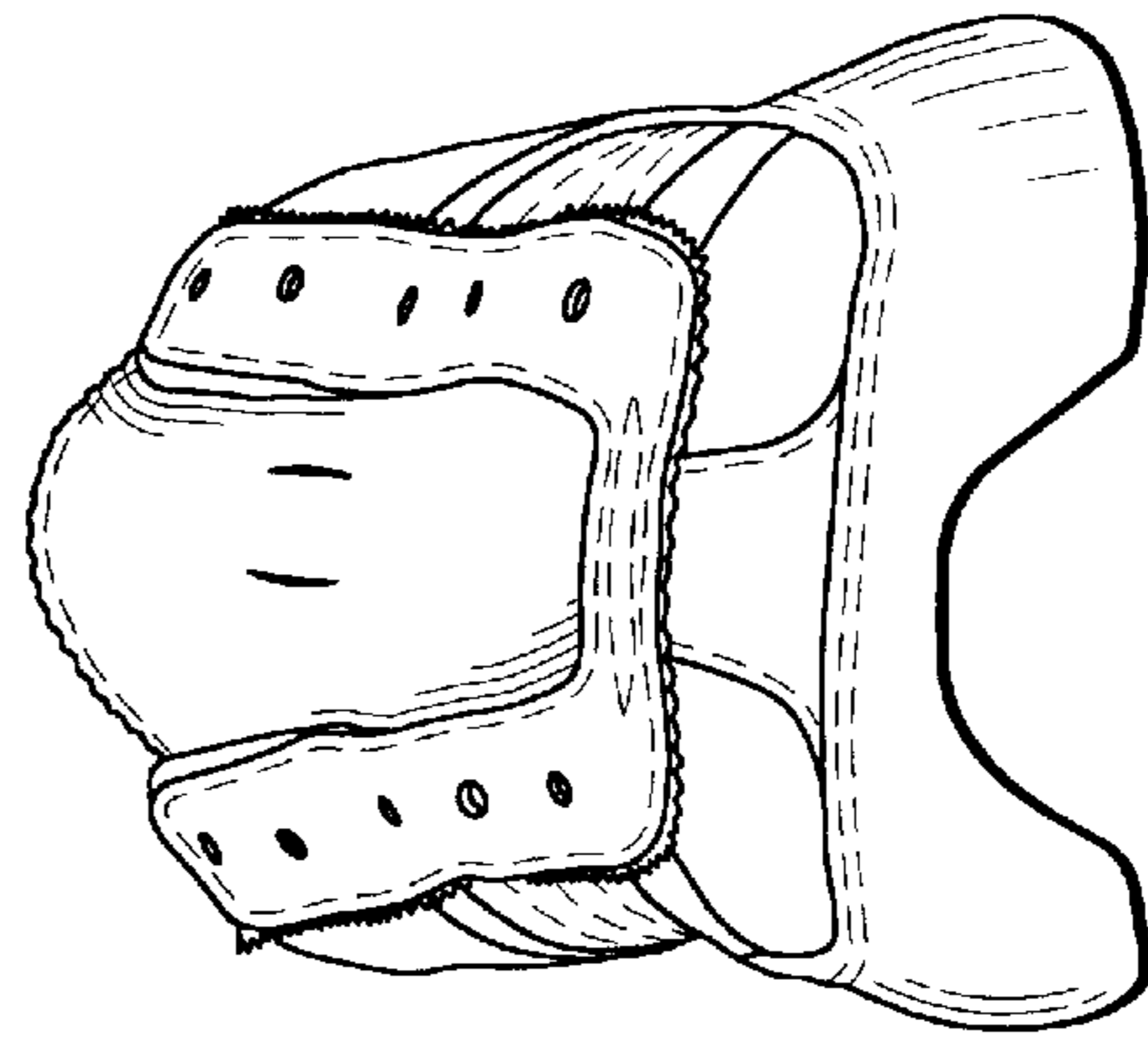
