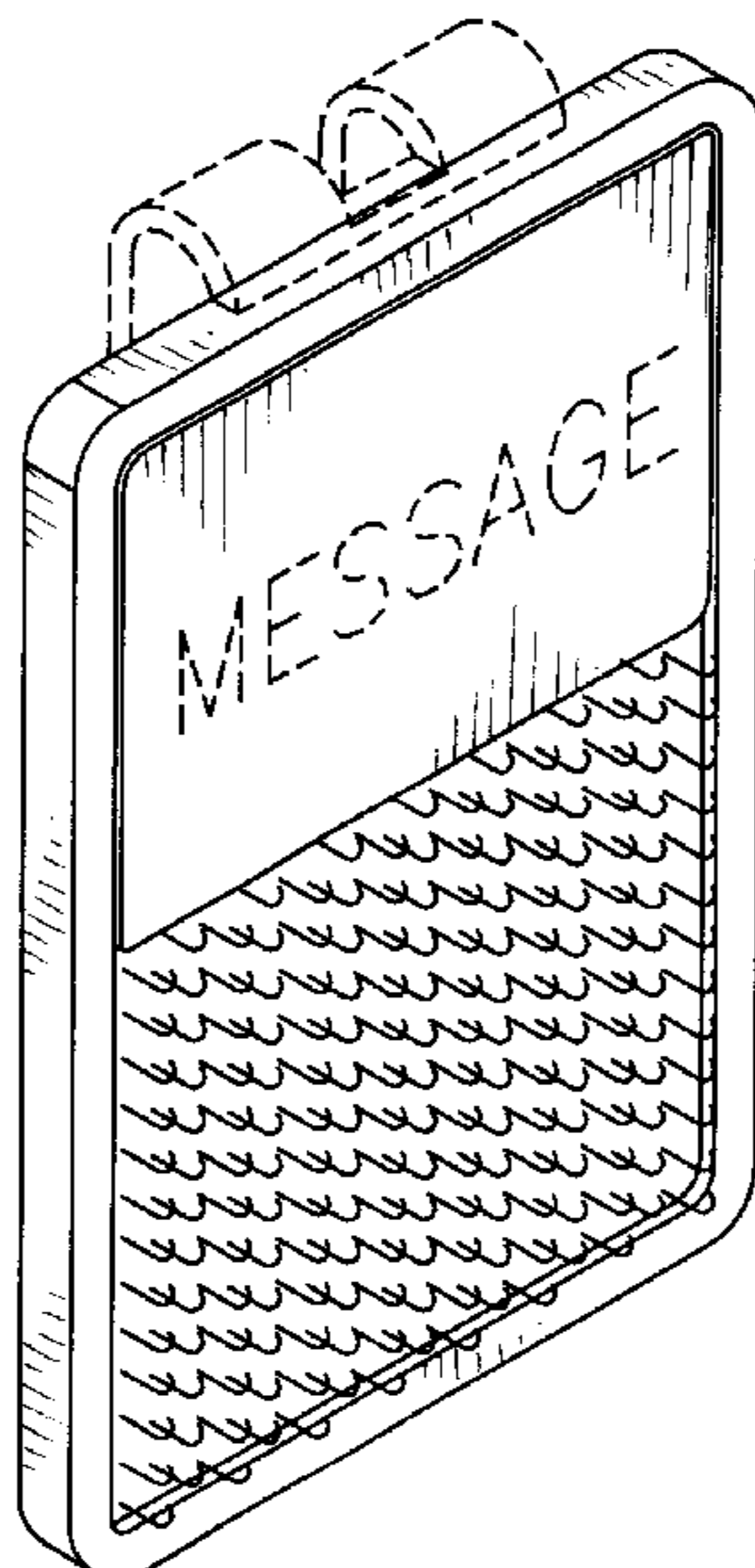
(57) **CLAIM**

The ornamental design for a golf glove caddy, as shown and described.

FIG. 1 is a front perspective view of a golf glove caddy showing our new design;

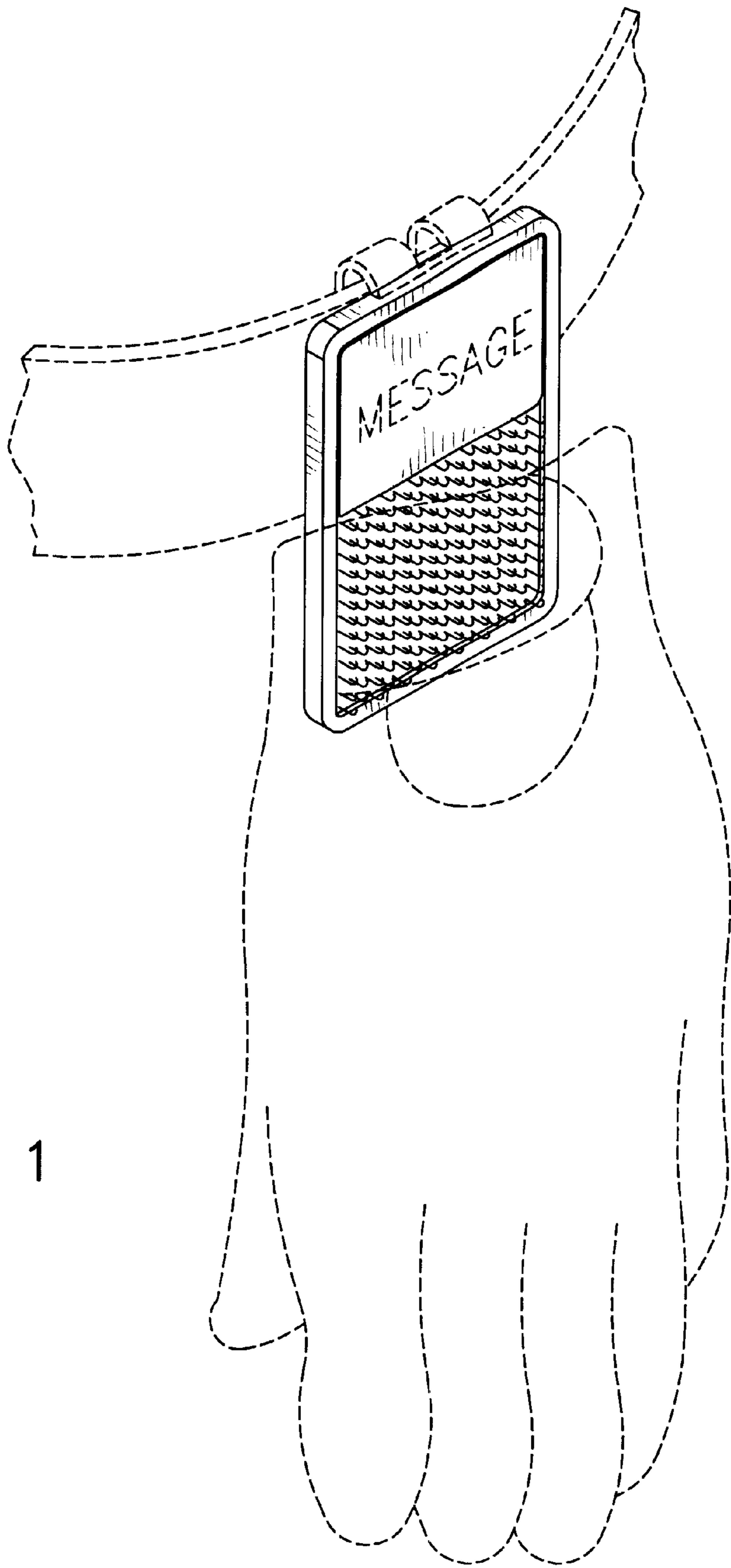

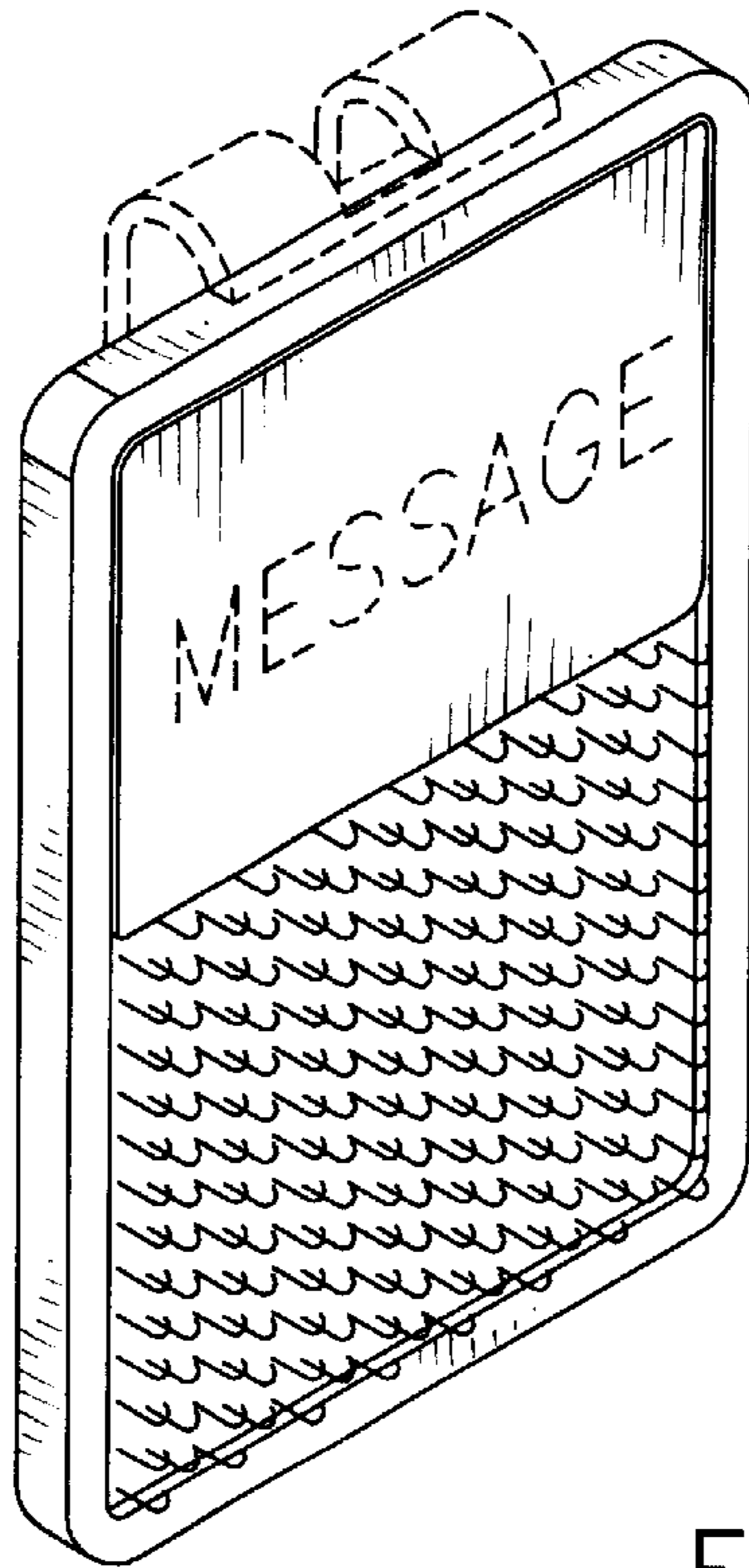

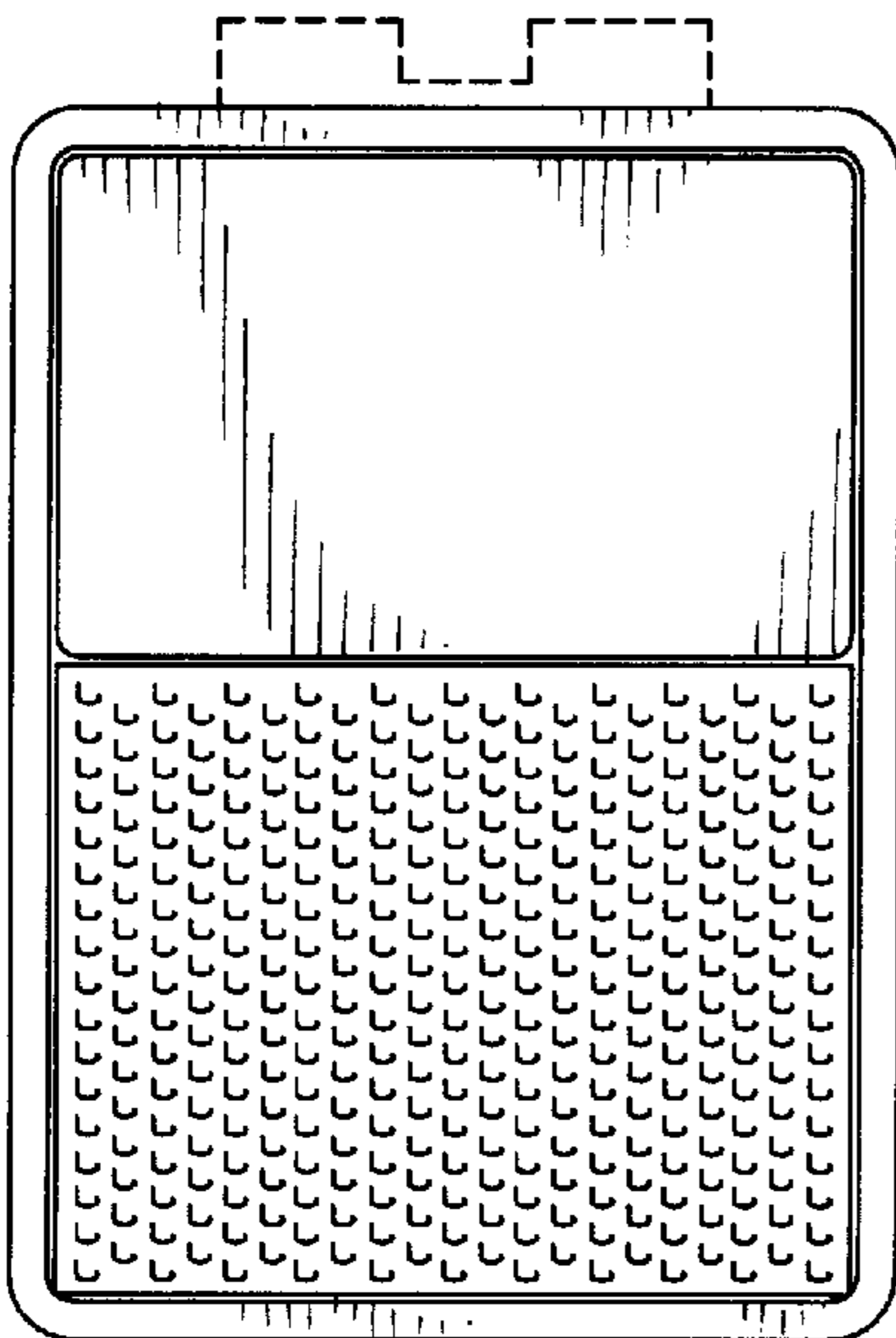

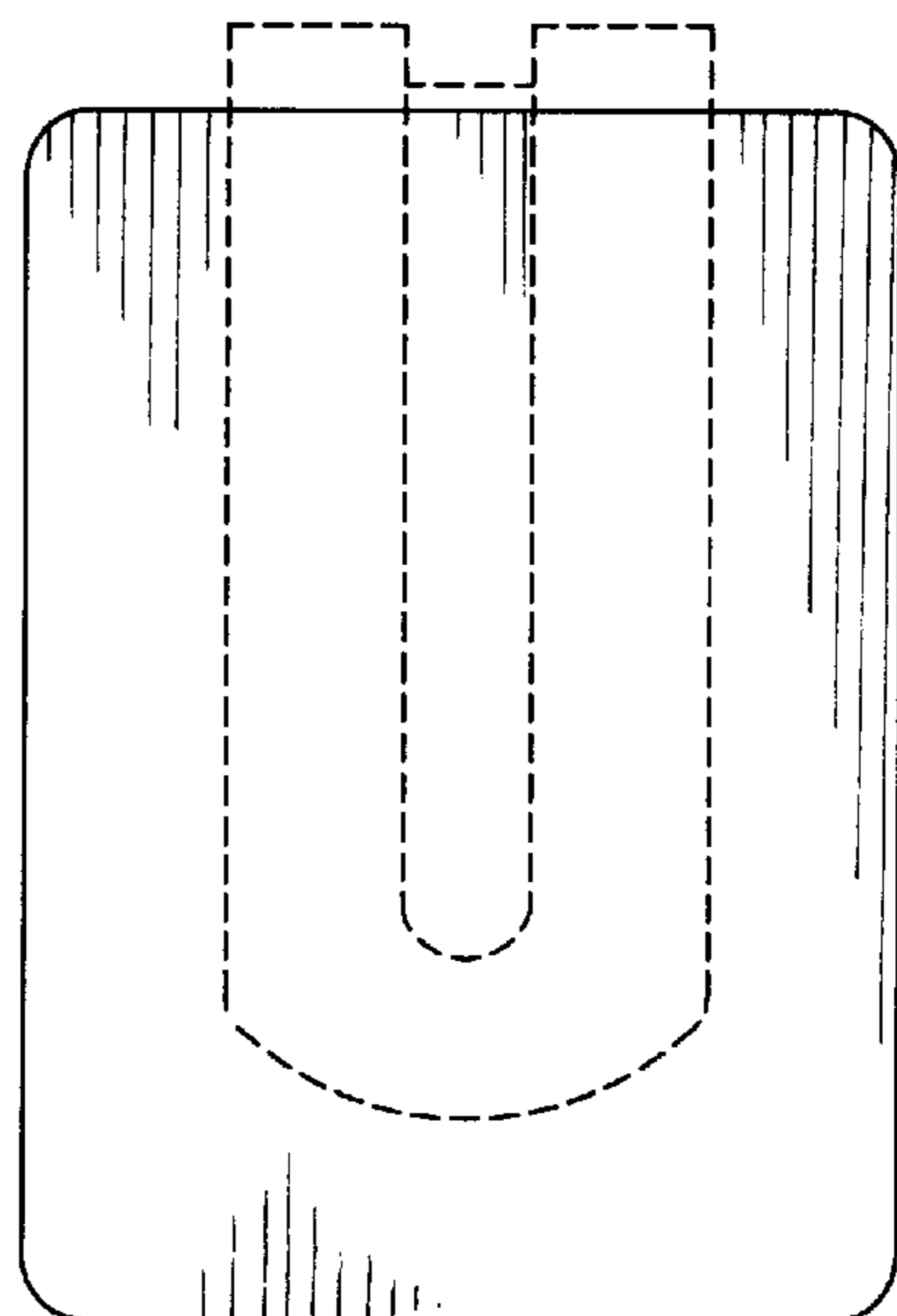

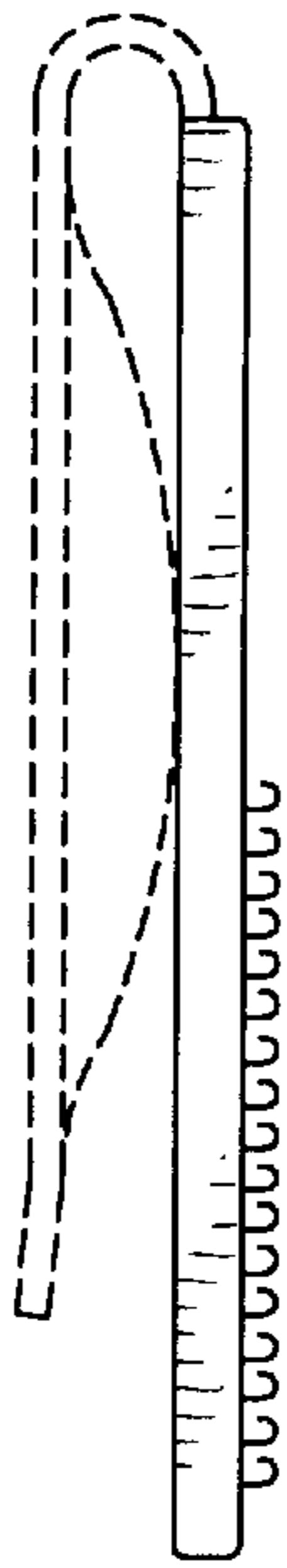

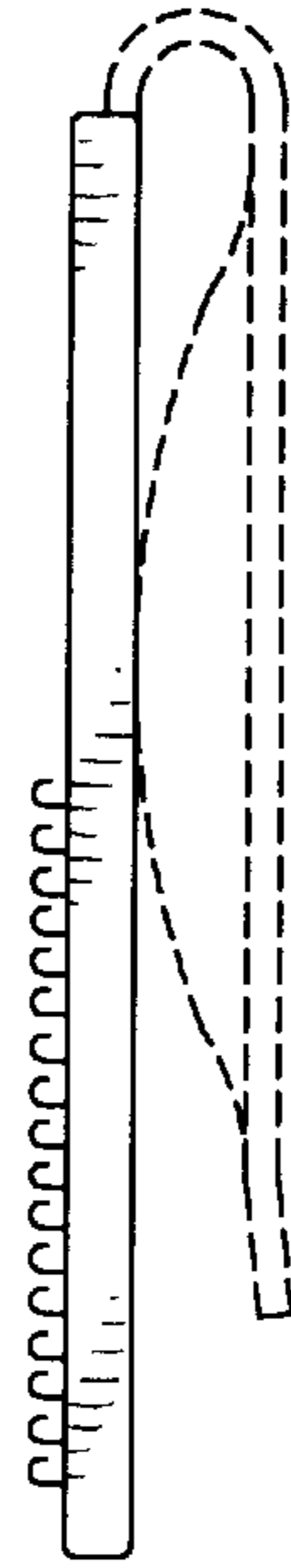

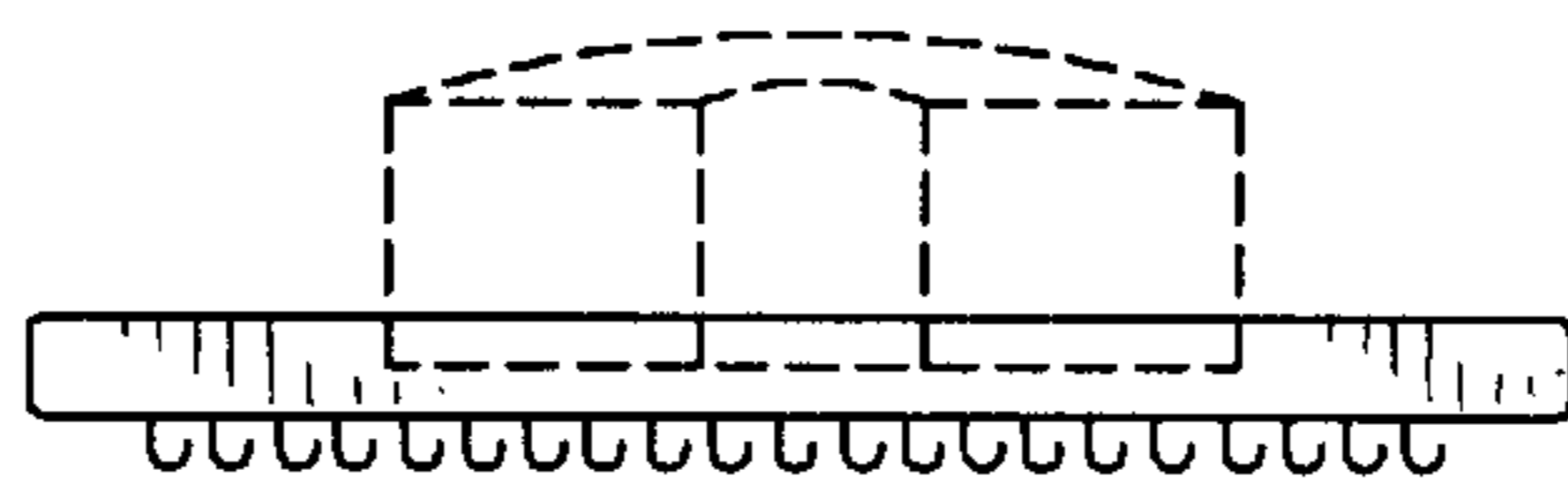

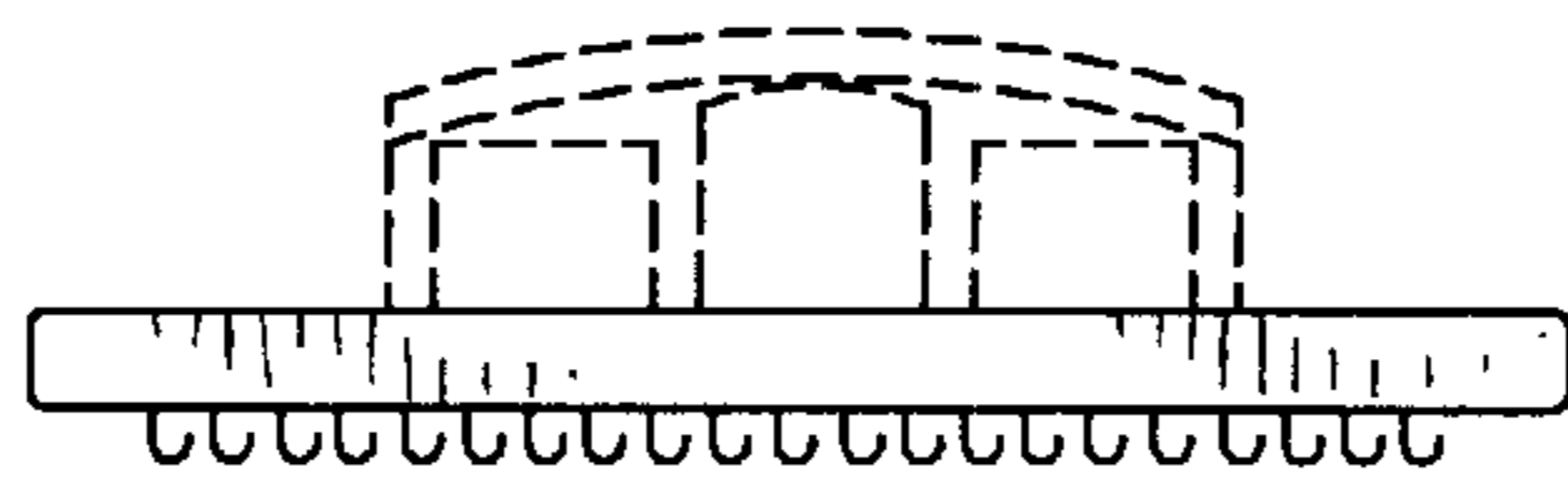

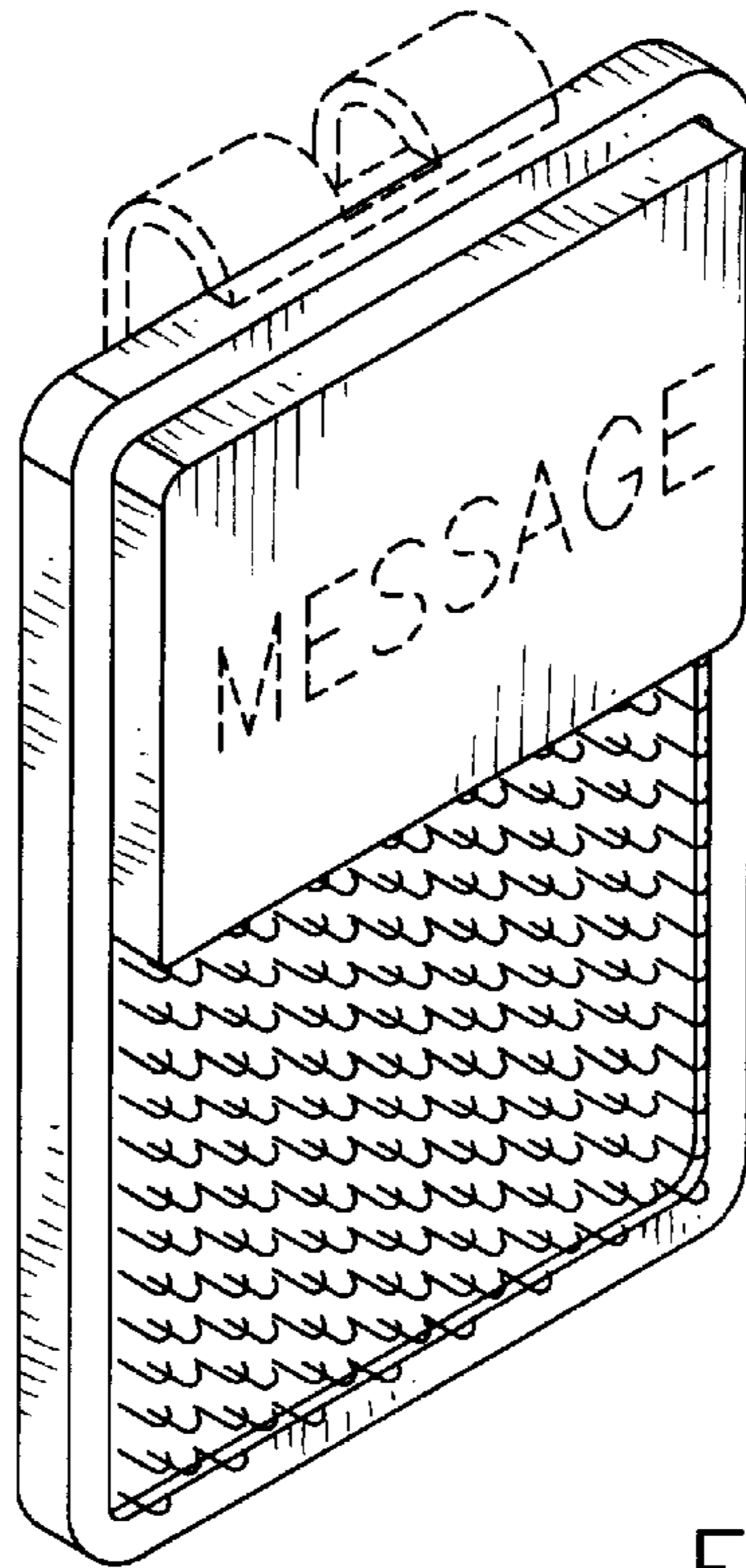

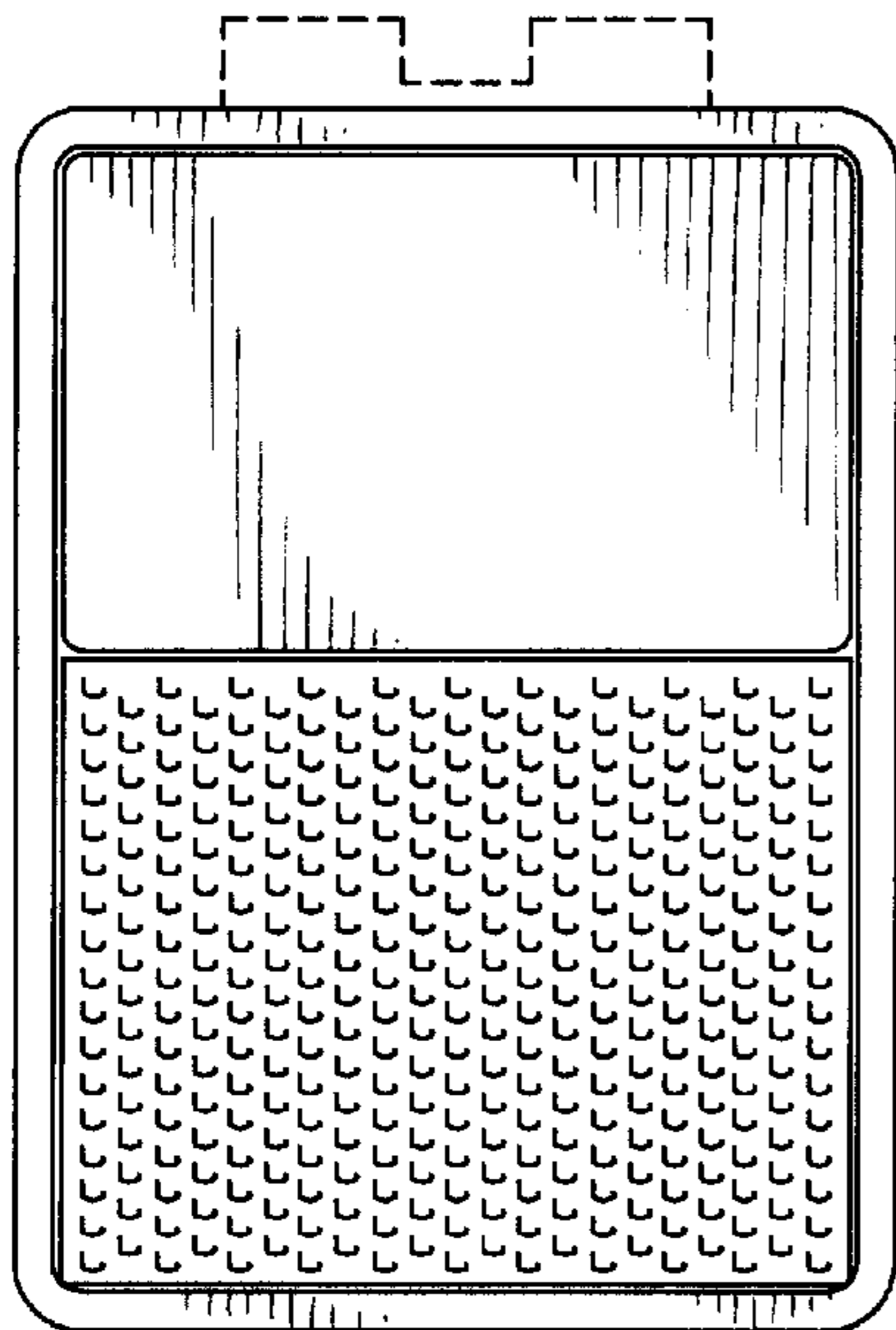

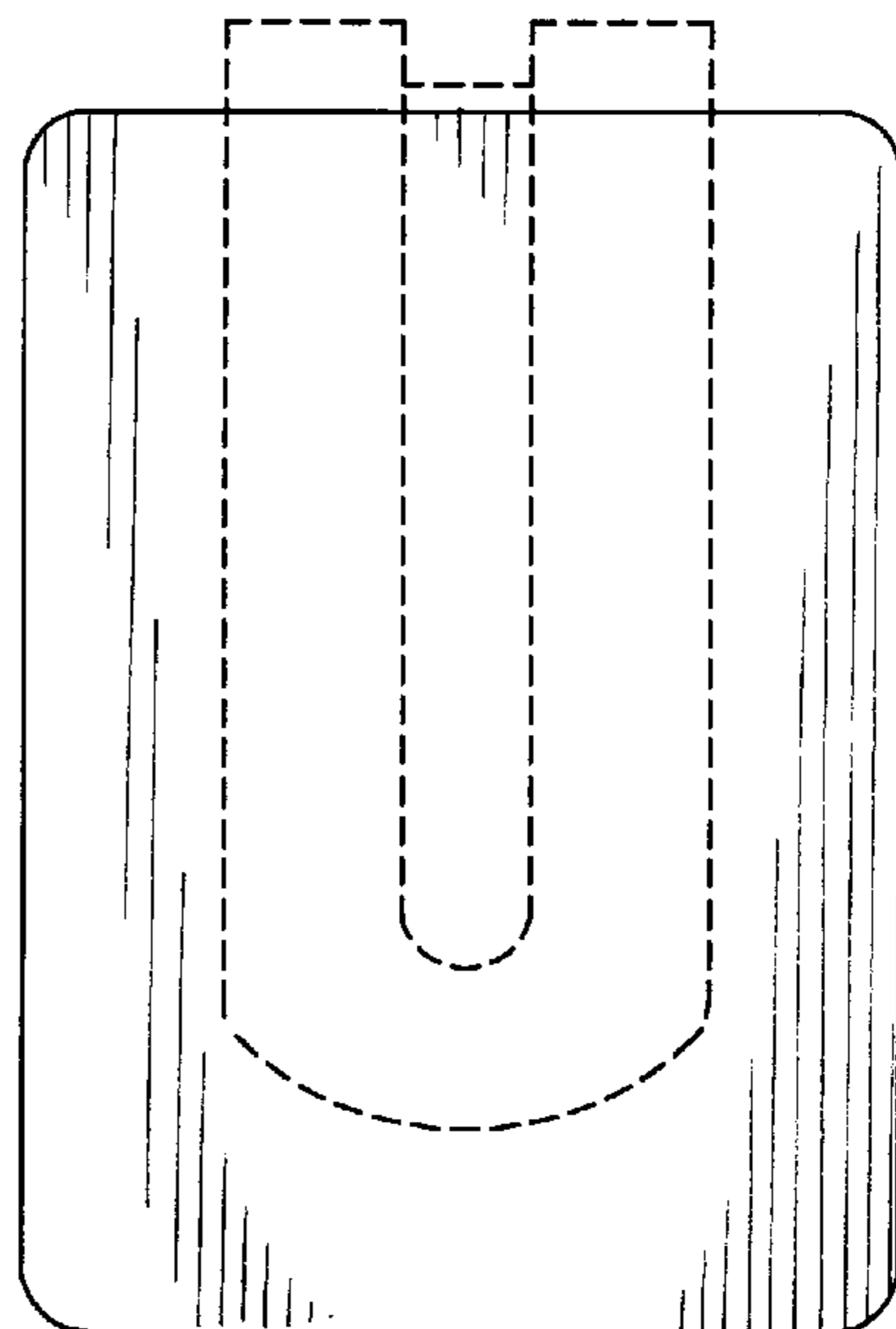

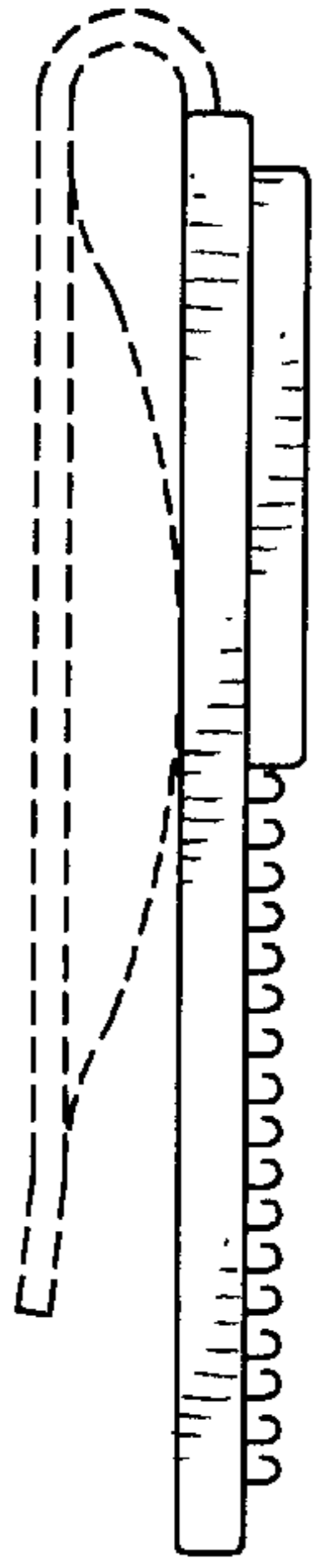

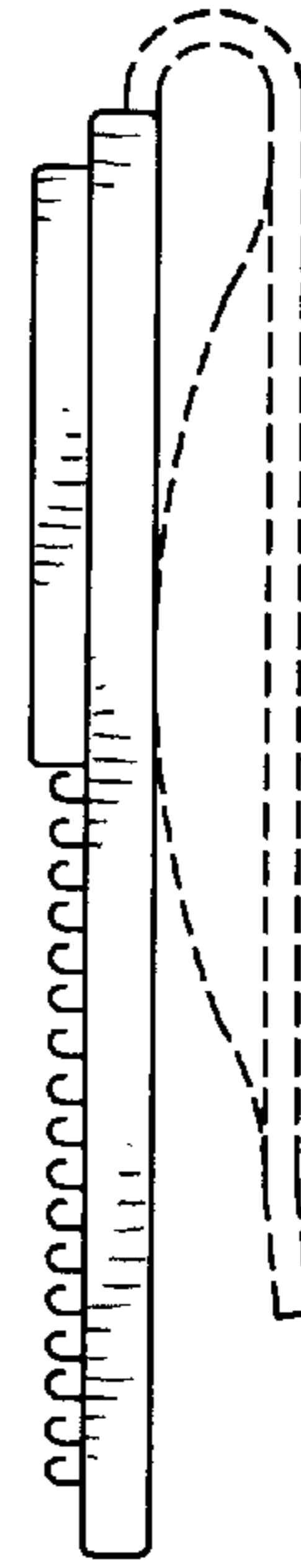

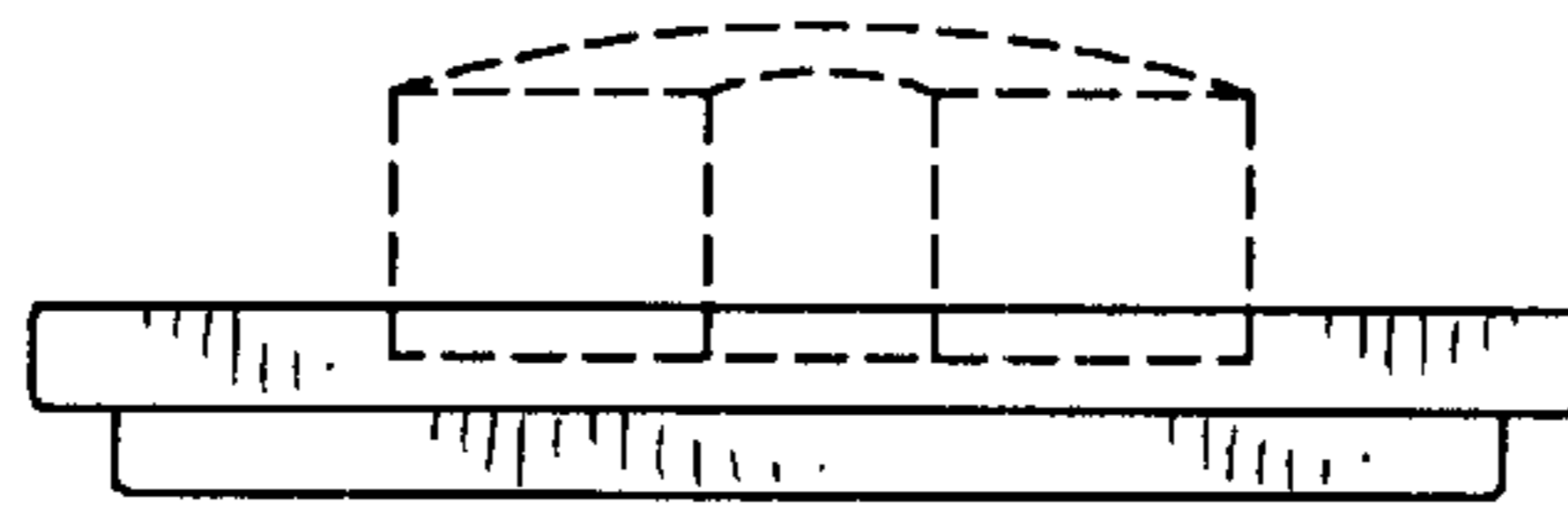

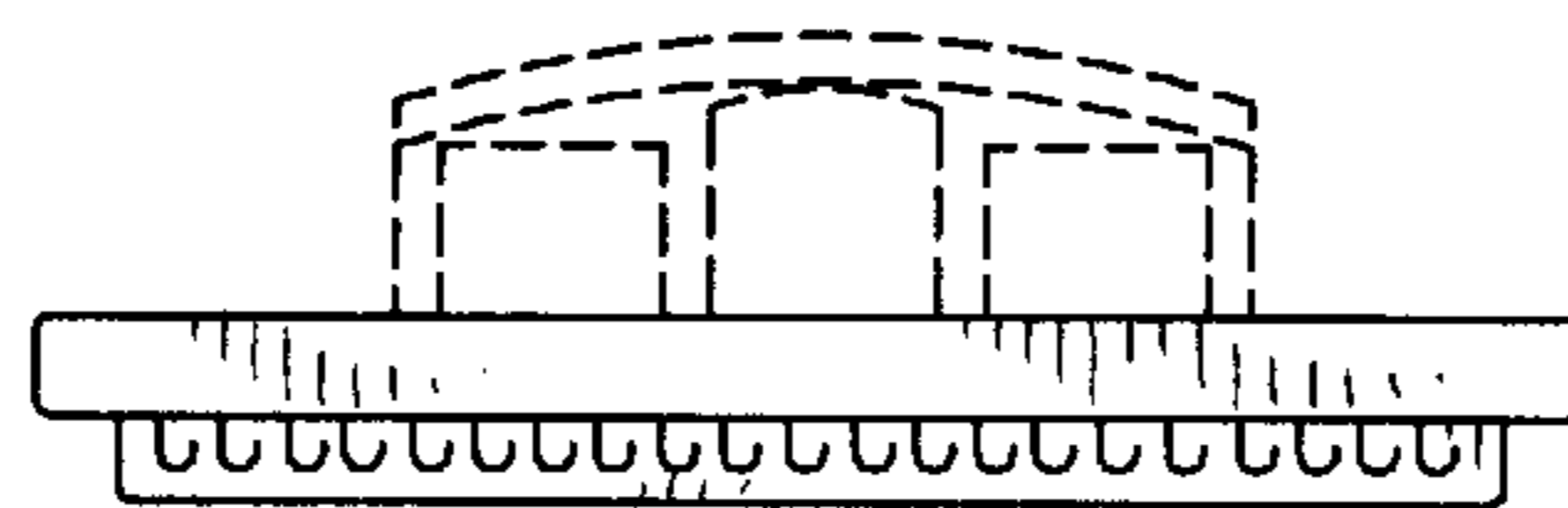

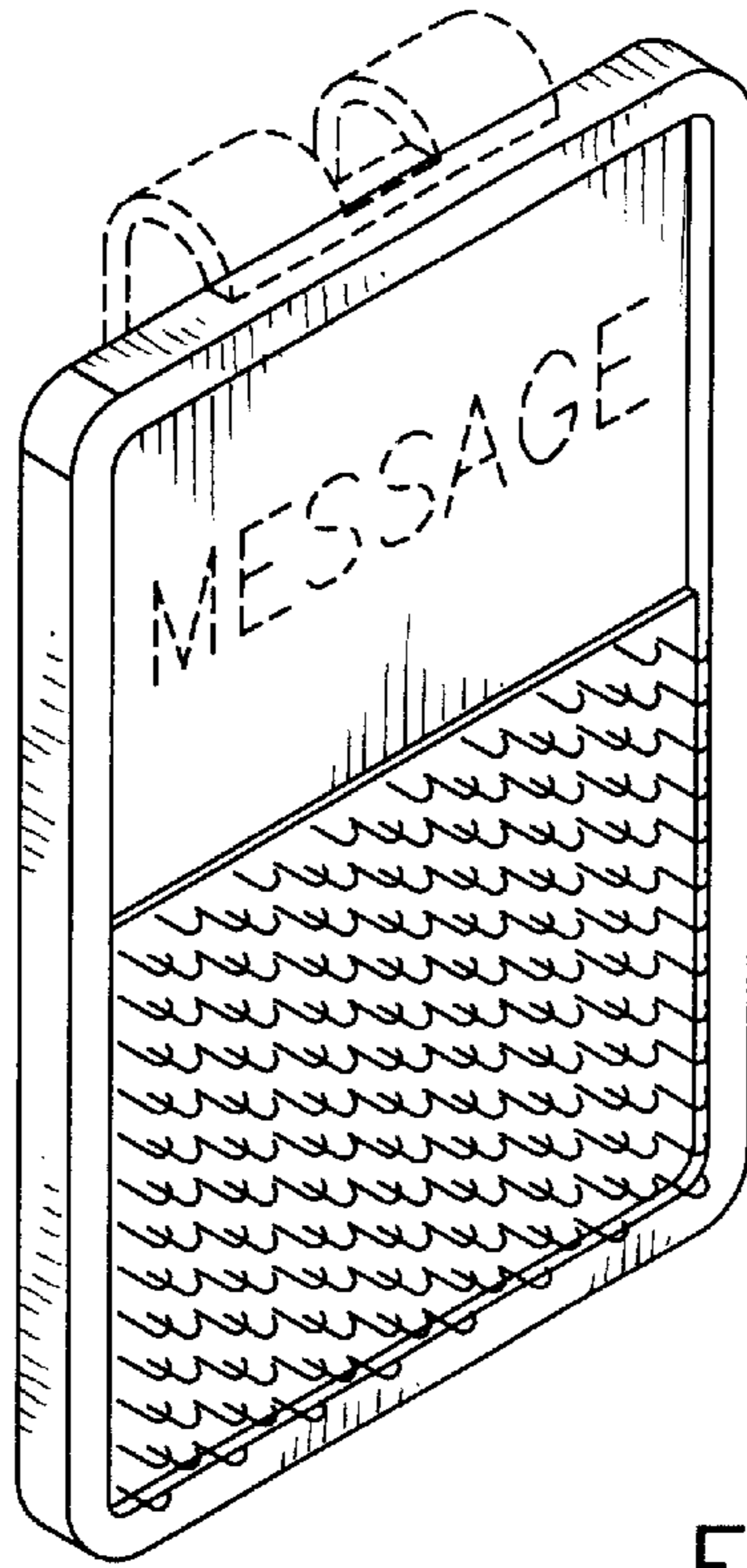

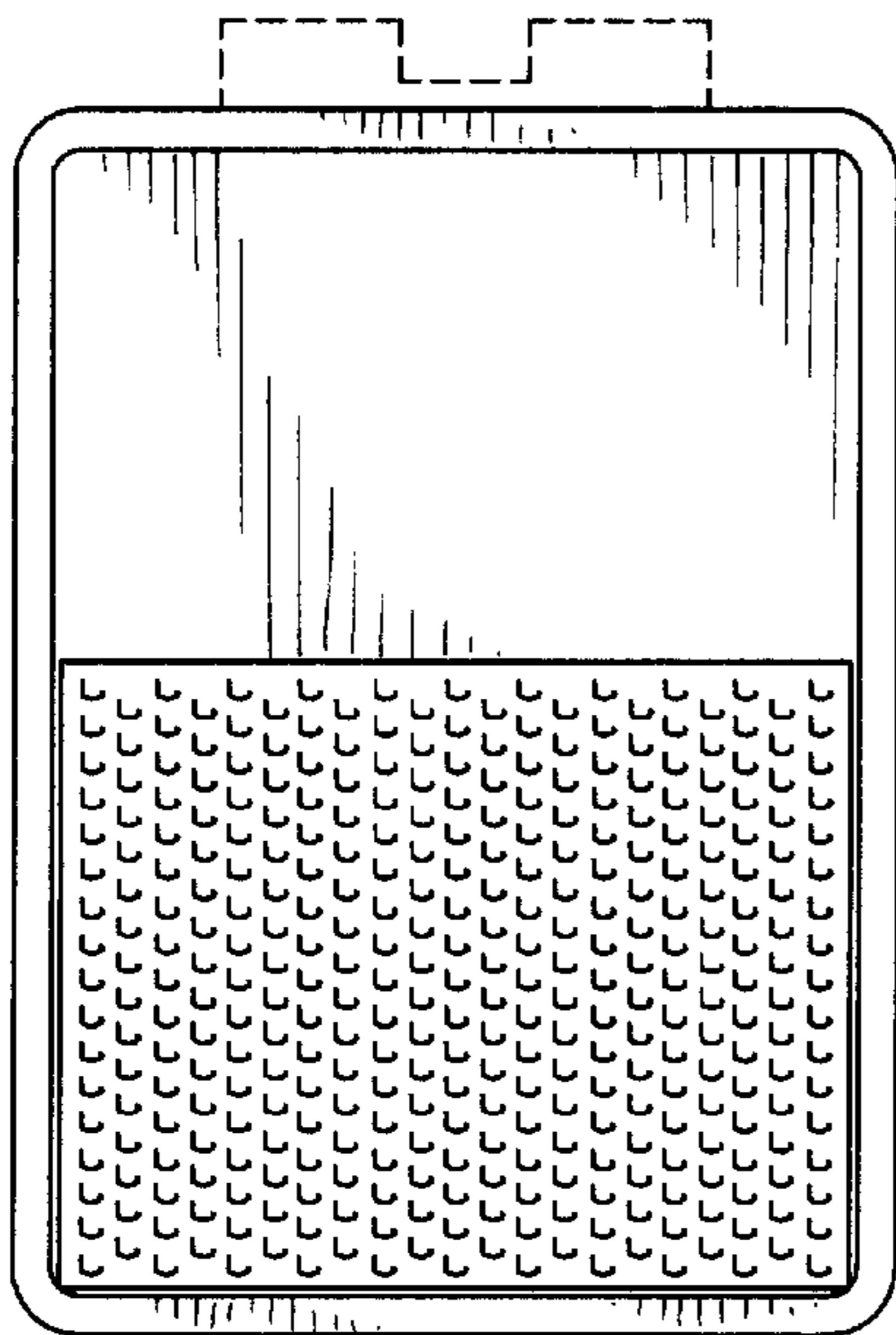

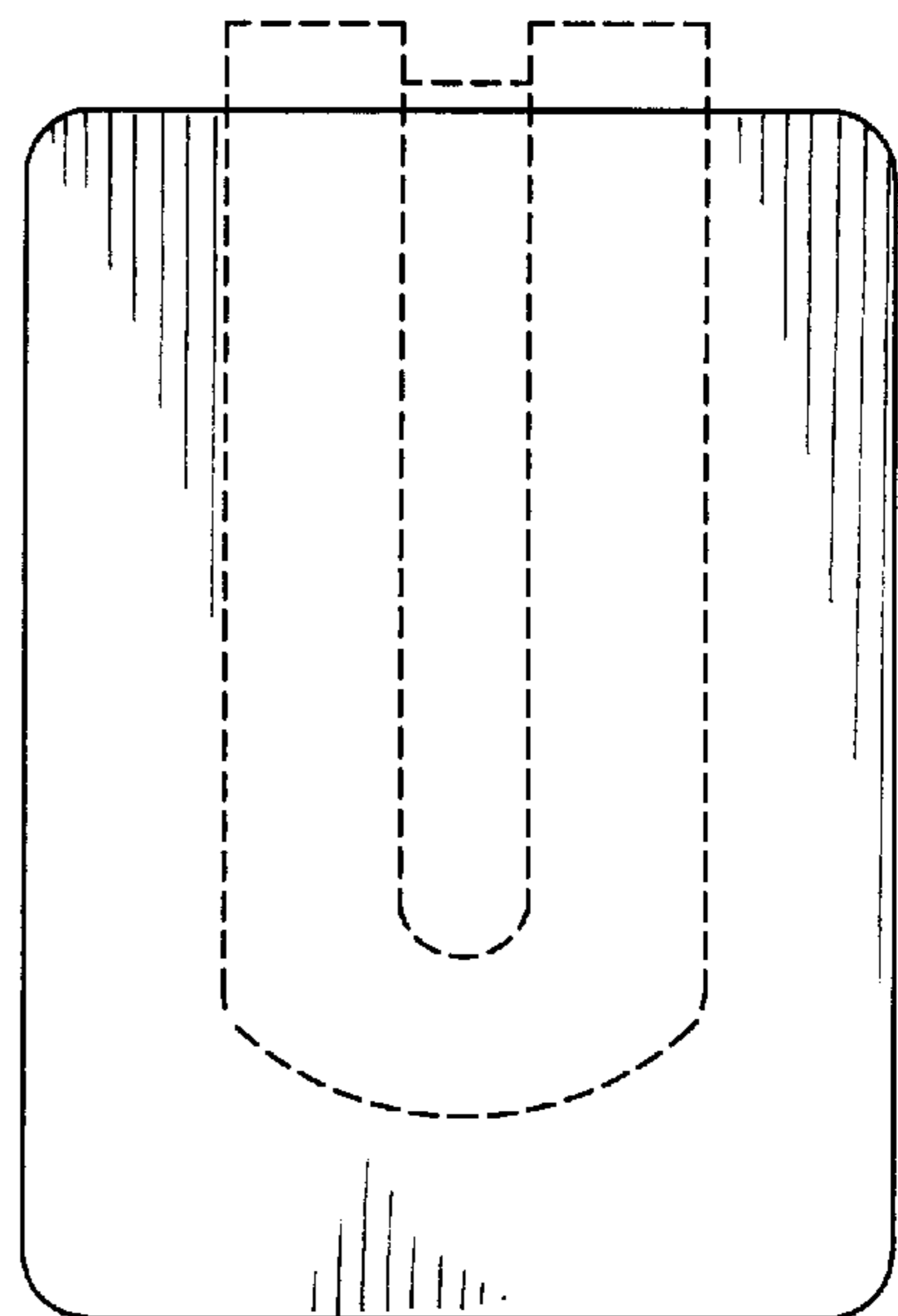

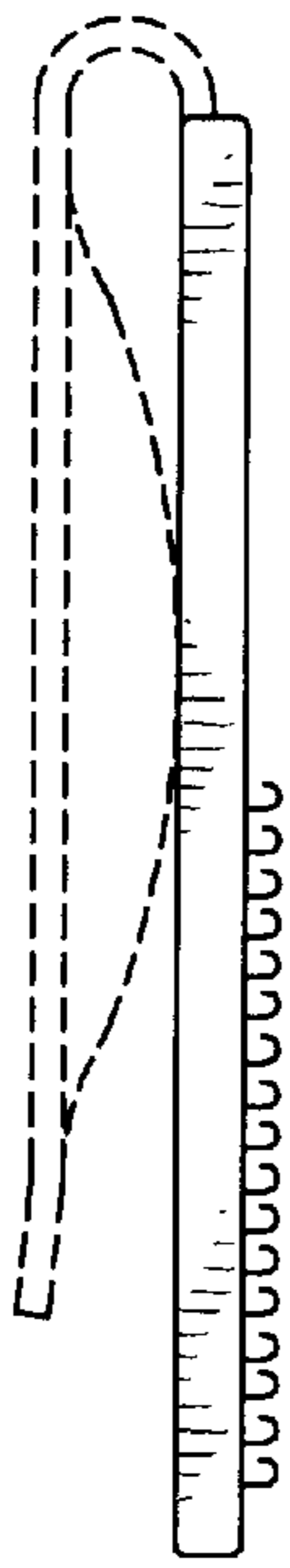

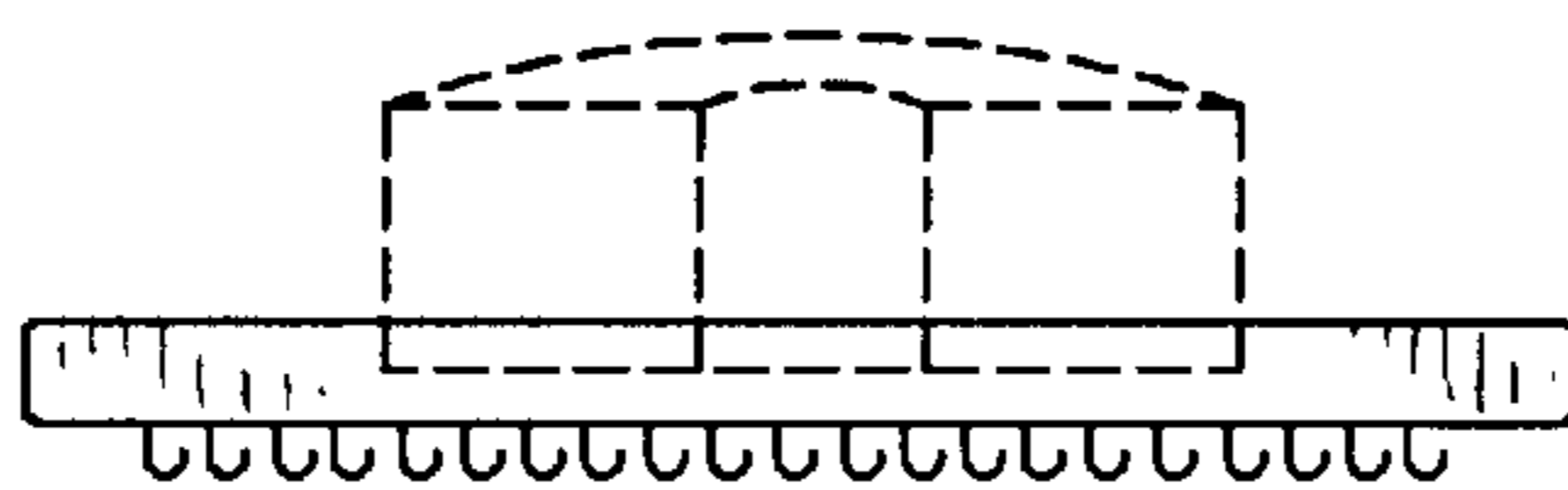

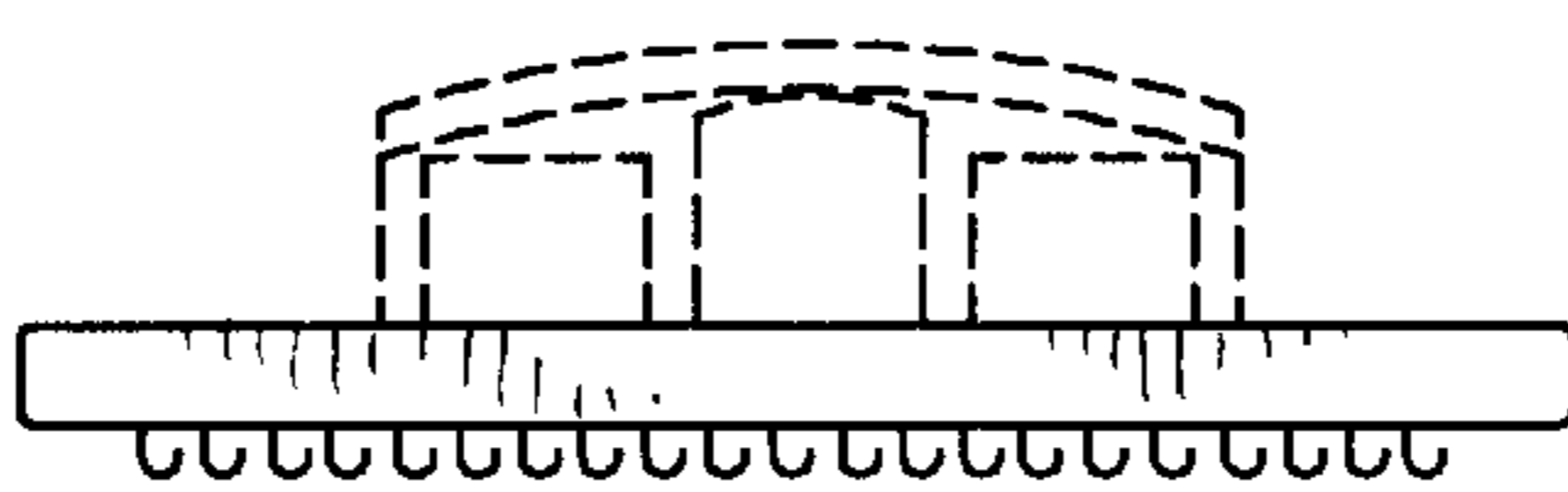
