FIG. 3 is a side view thereof;

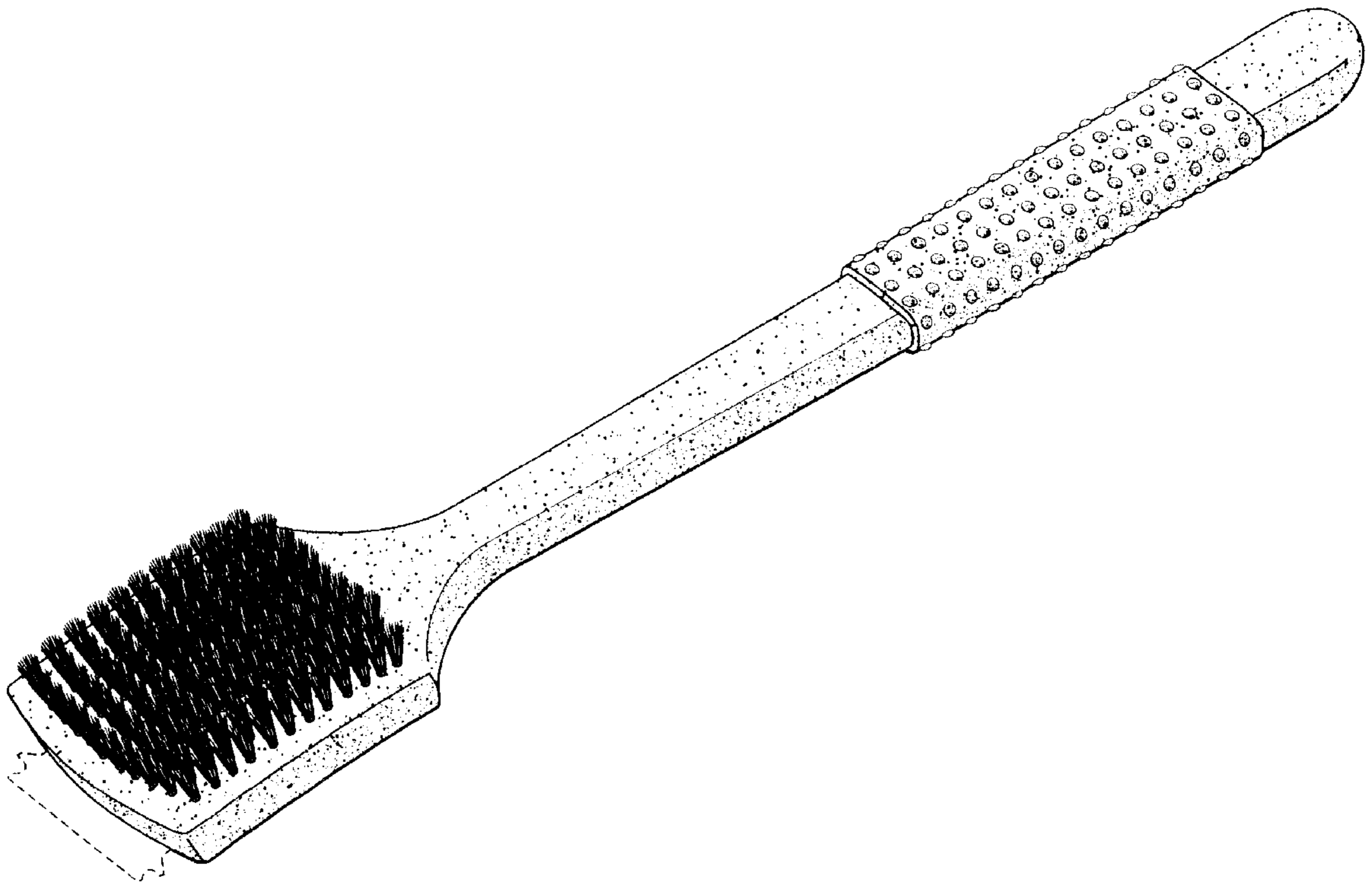
FIG. 4 is an enlarged bottom view thereof;

FIG. 5 is an enlarged top view thereof; and,

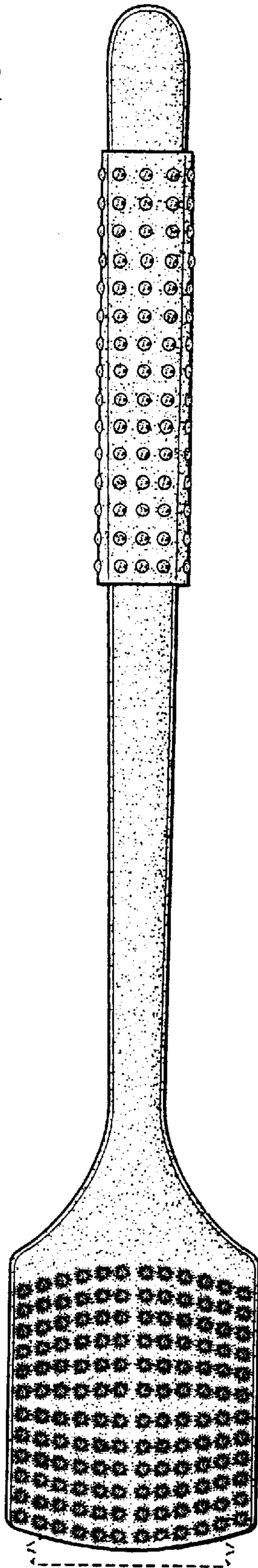
FIG. 6 is a perspective view thereof.

The side not illustrated is a mirror image of the side illustrated in FIG. 3 and the scraper blade illustrated in dashed lines does not form part of the claimed design.

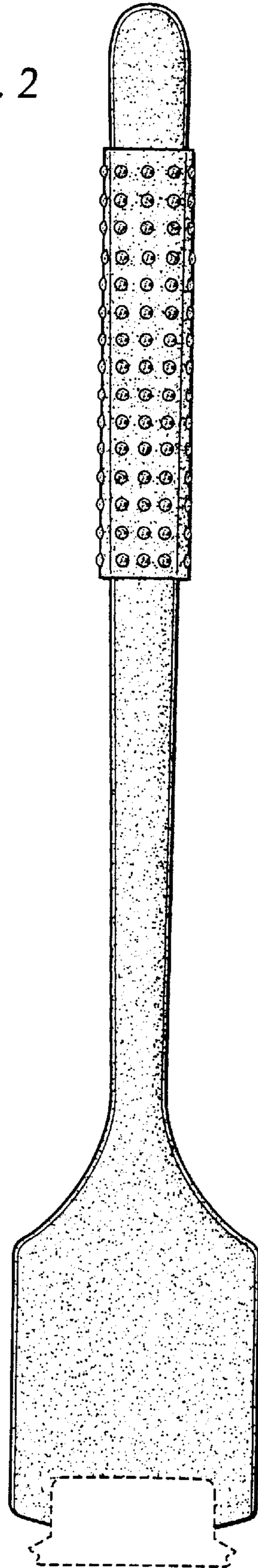

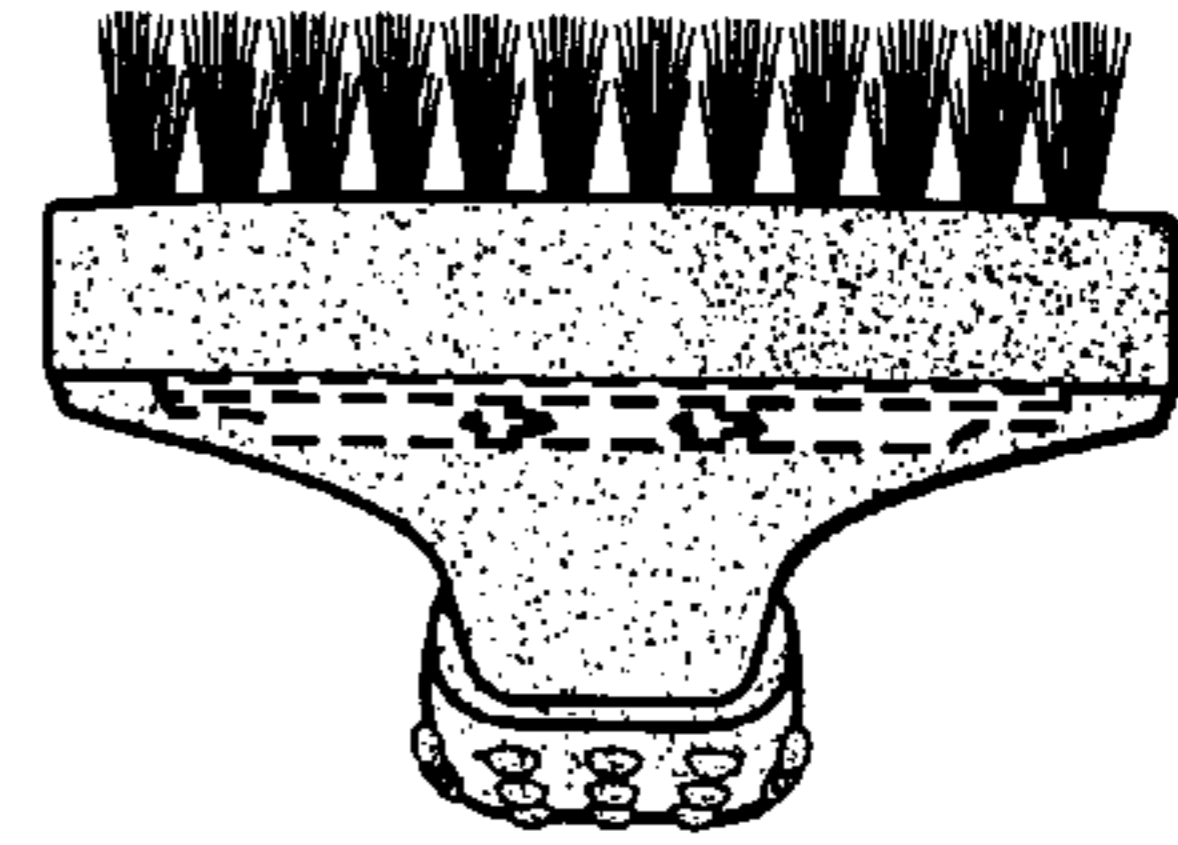
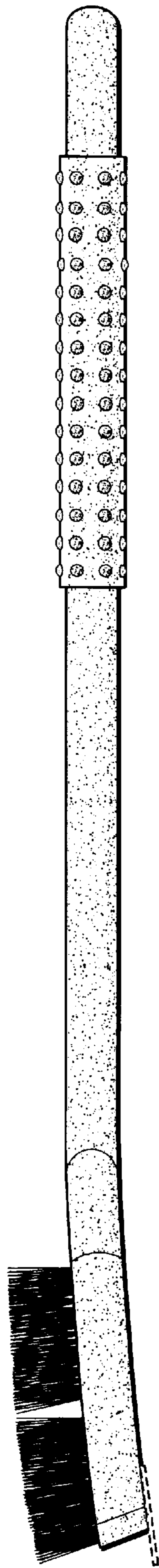

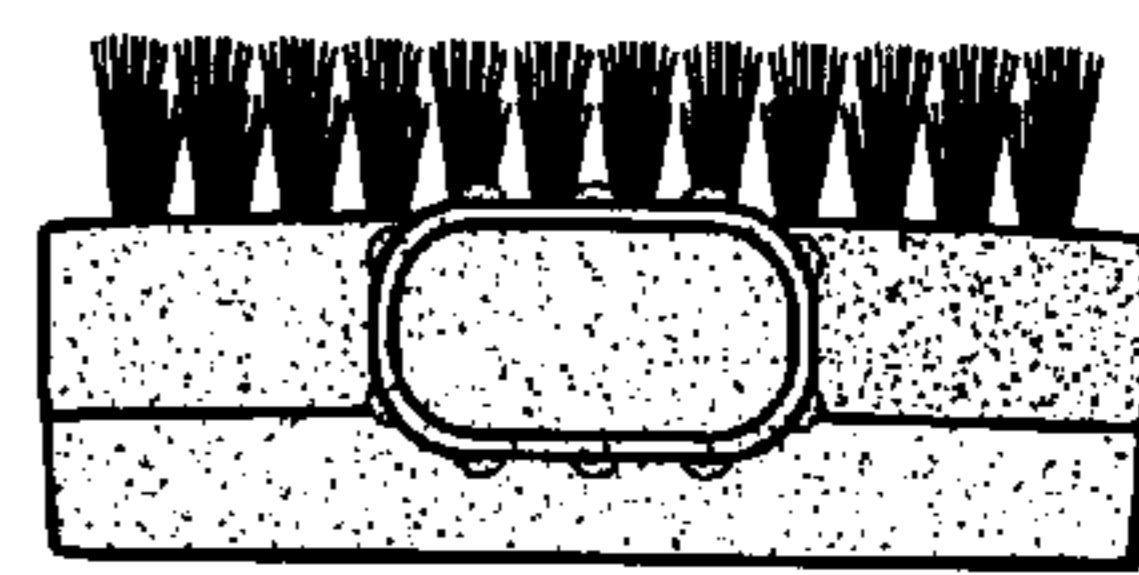

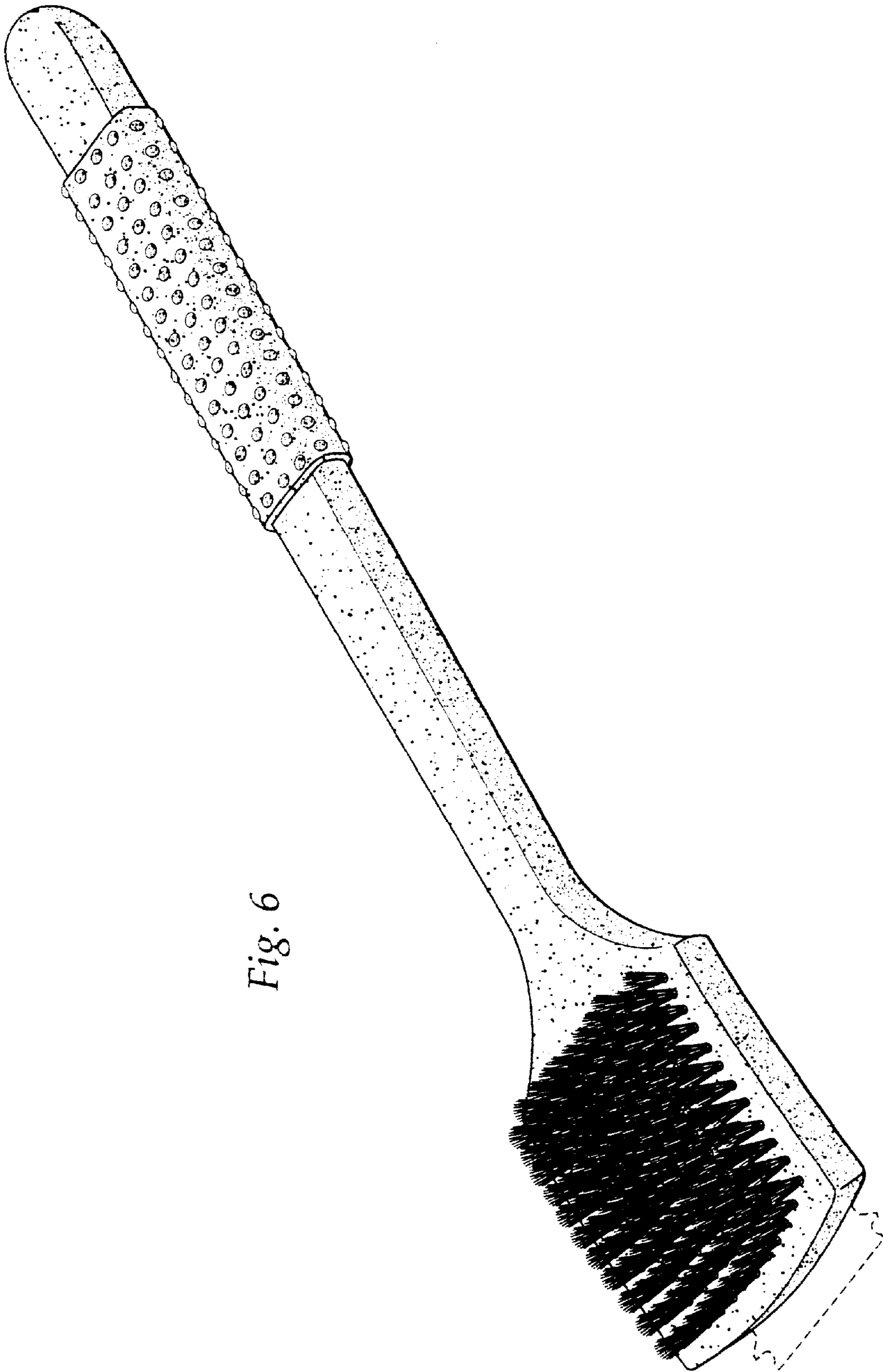
