DESCRIPTION

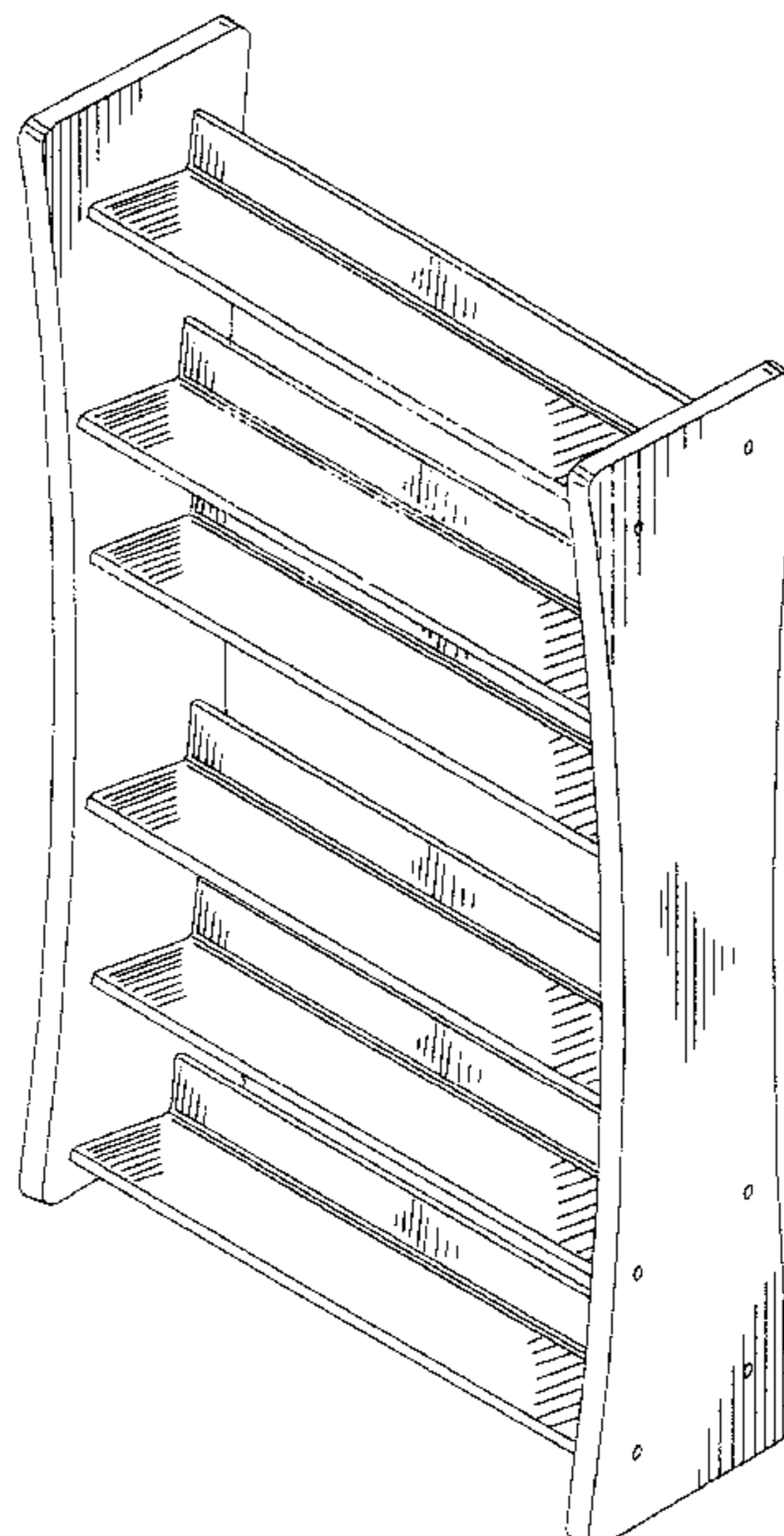

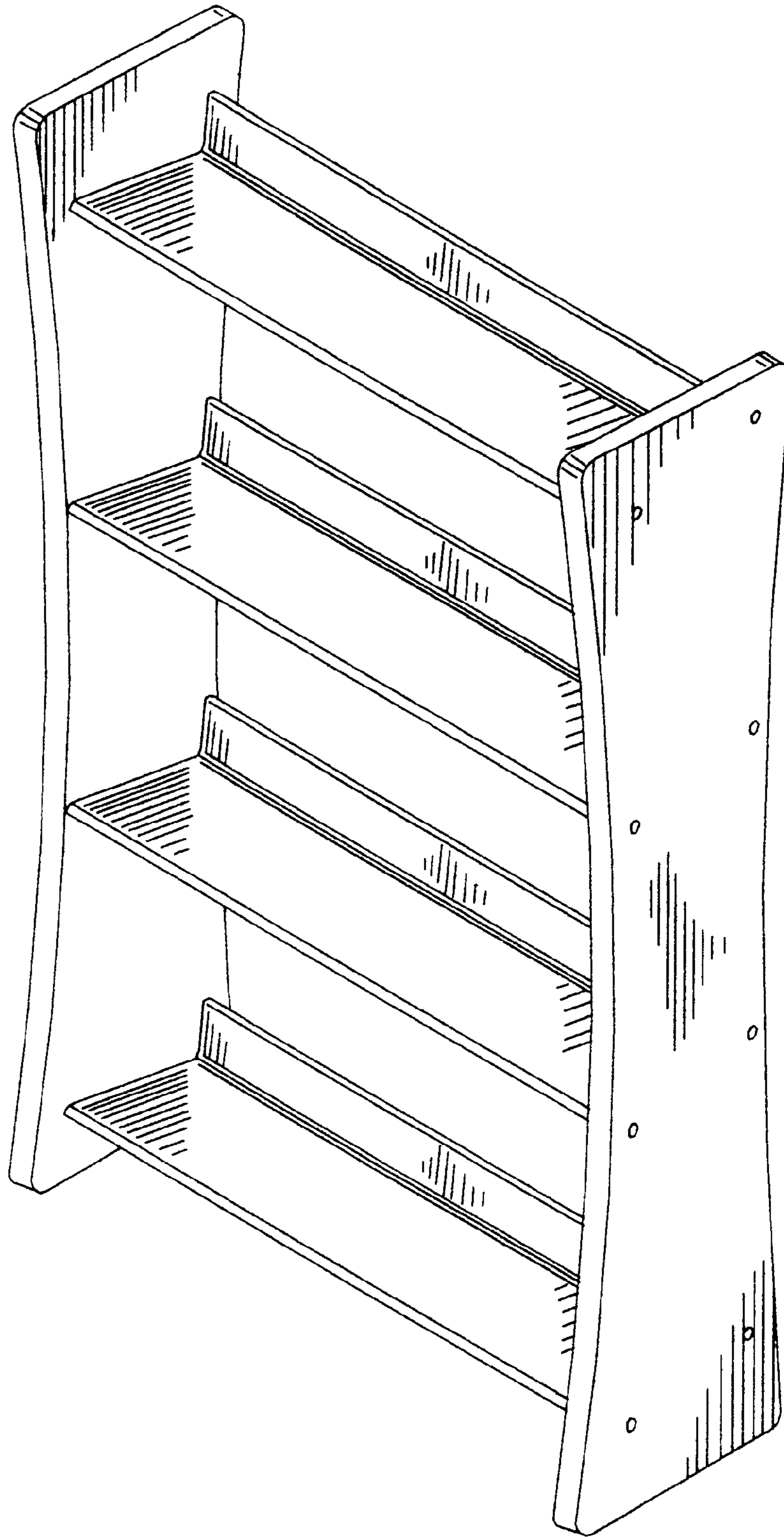

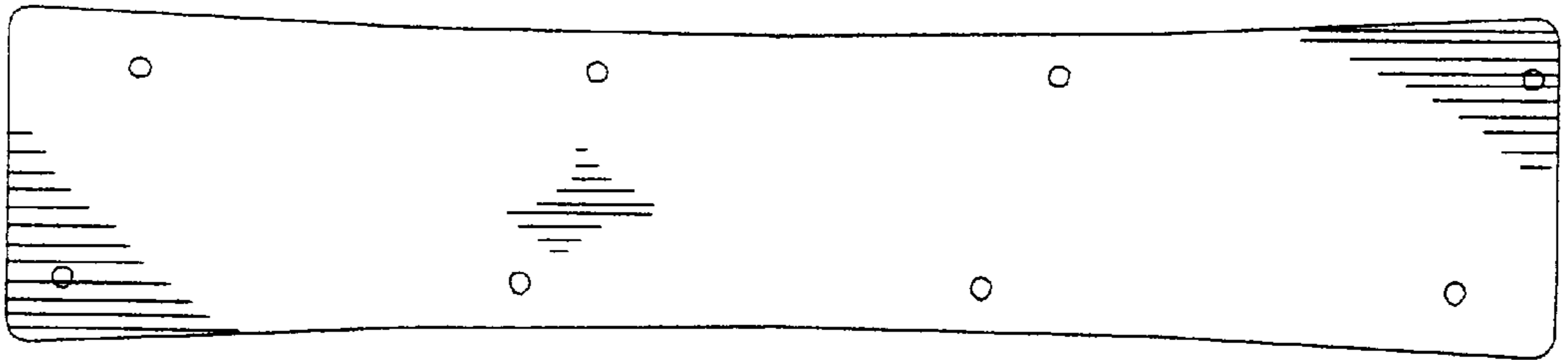

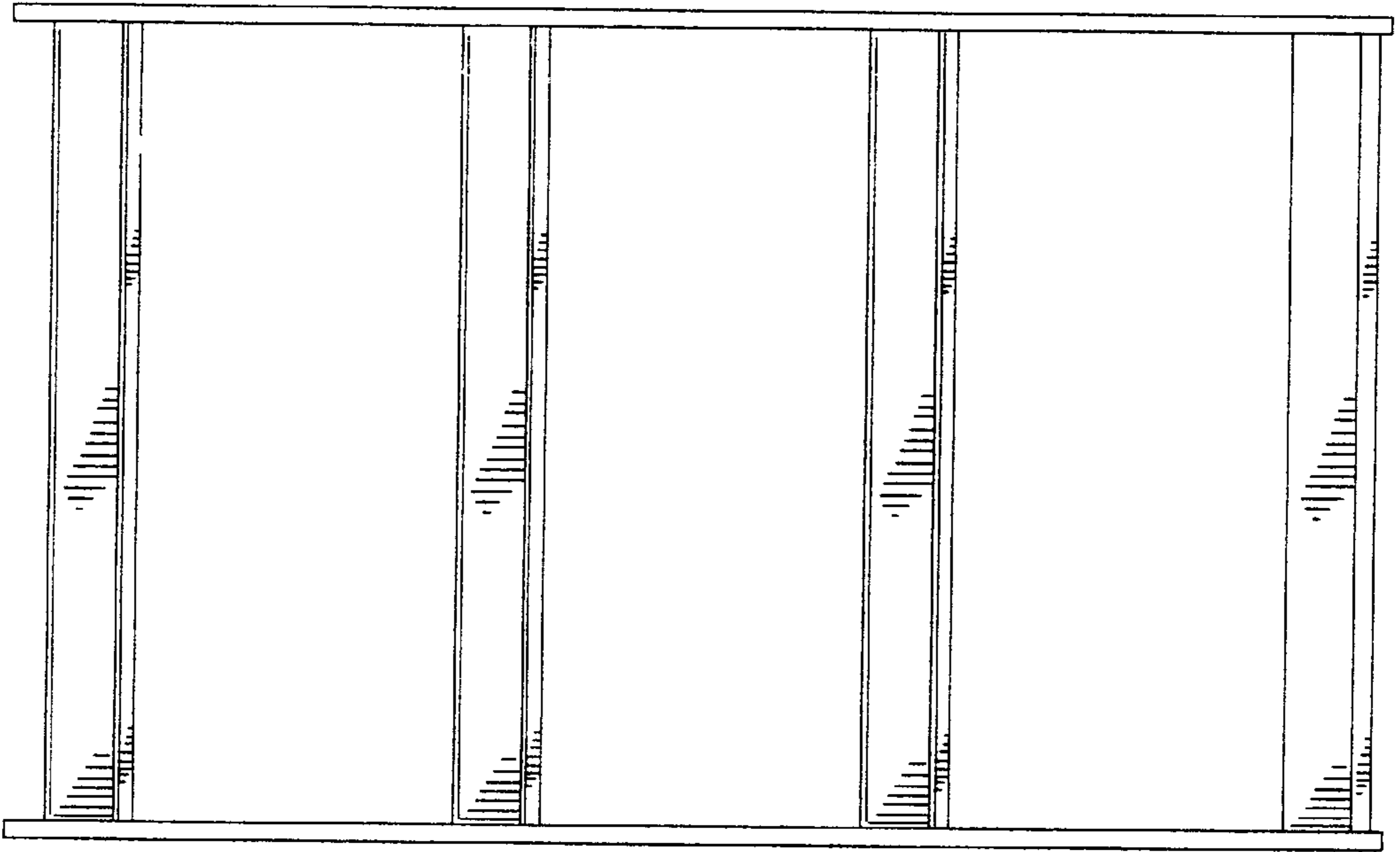

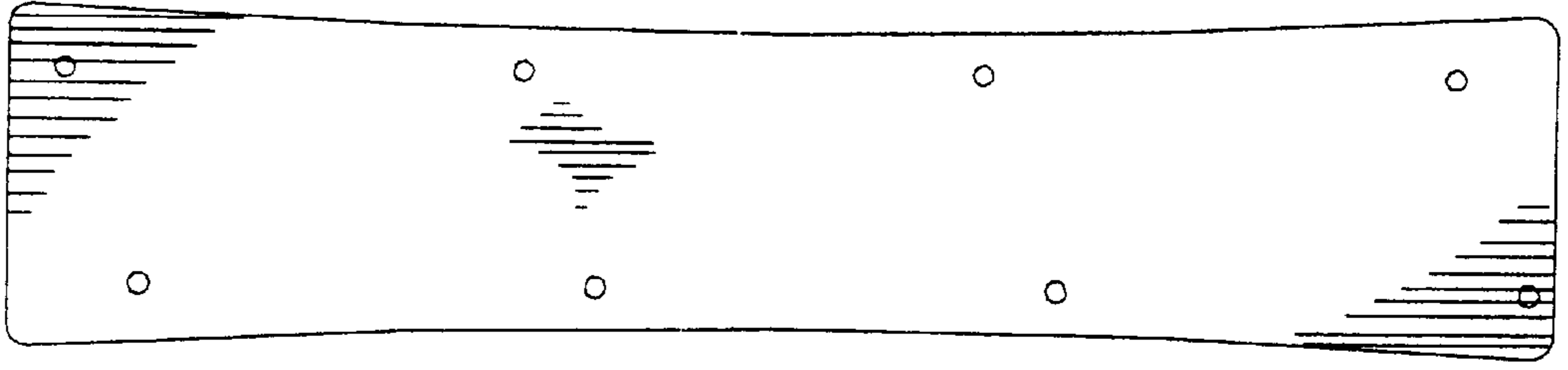

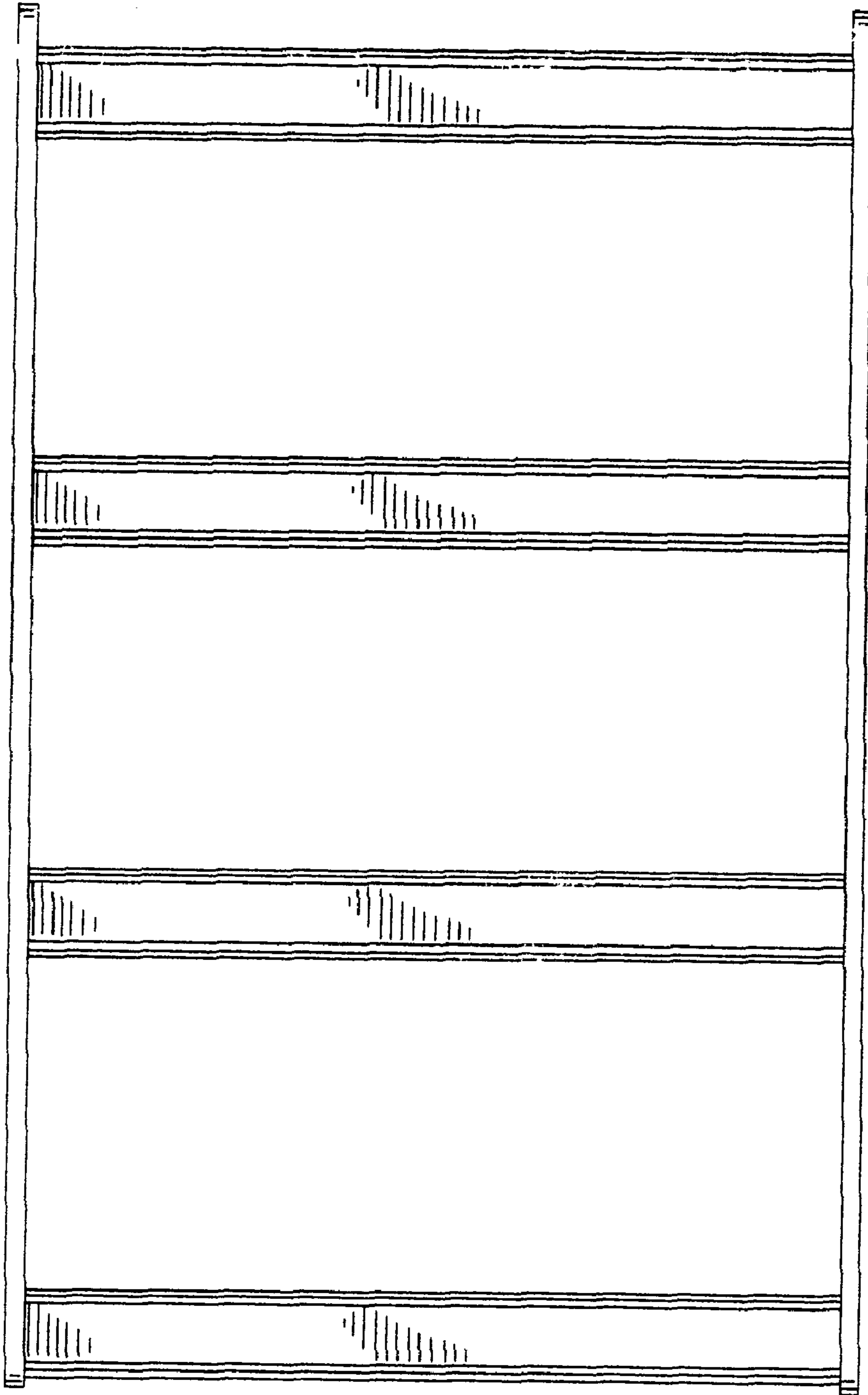

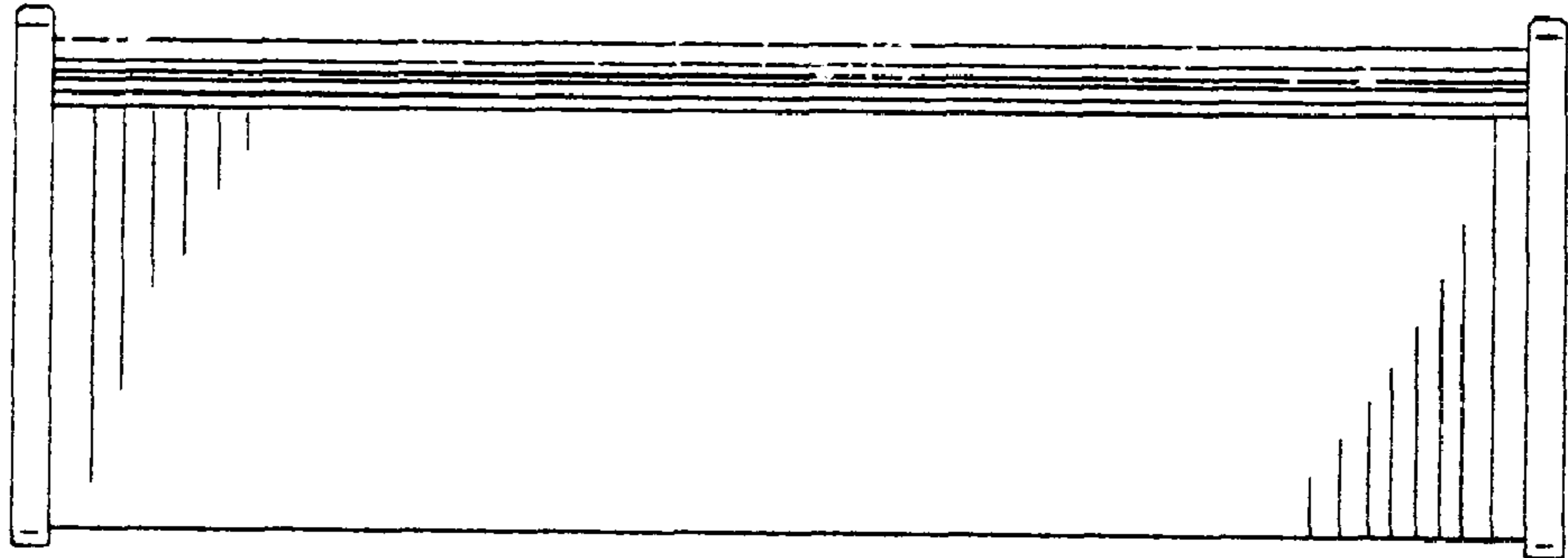

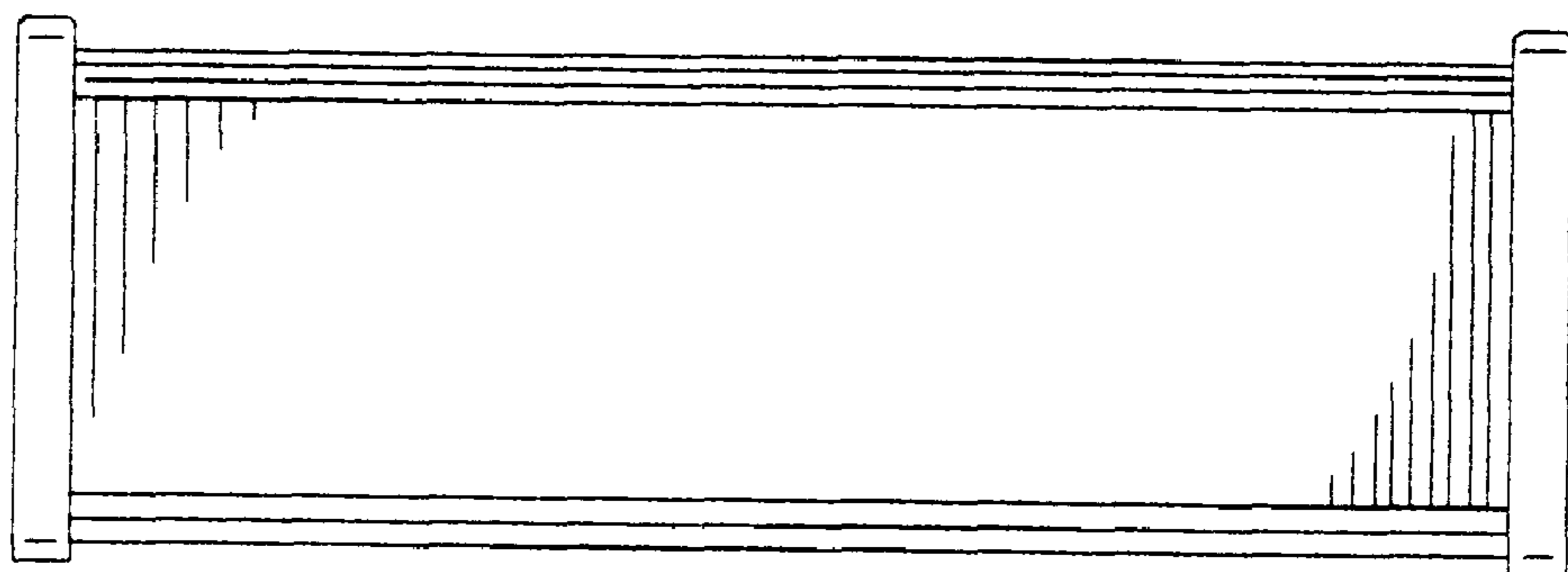

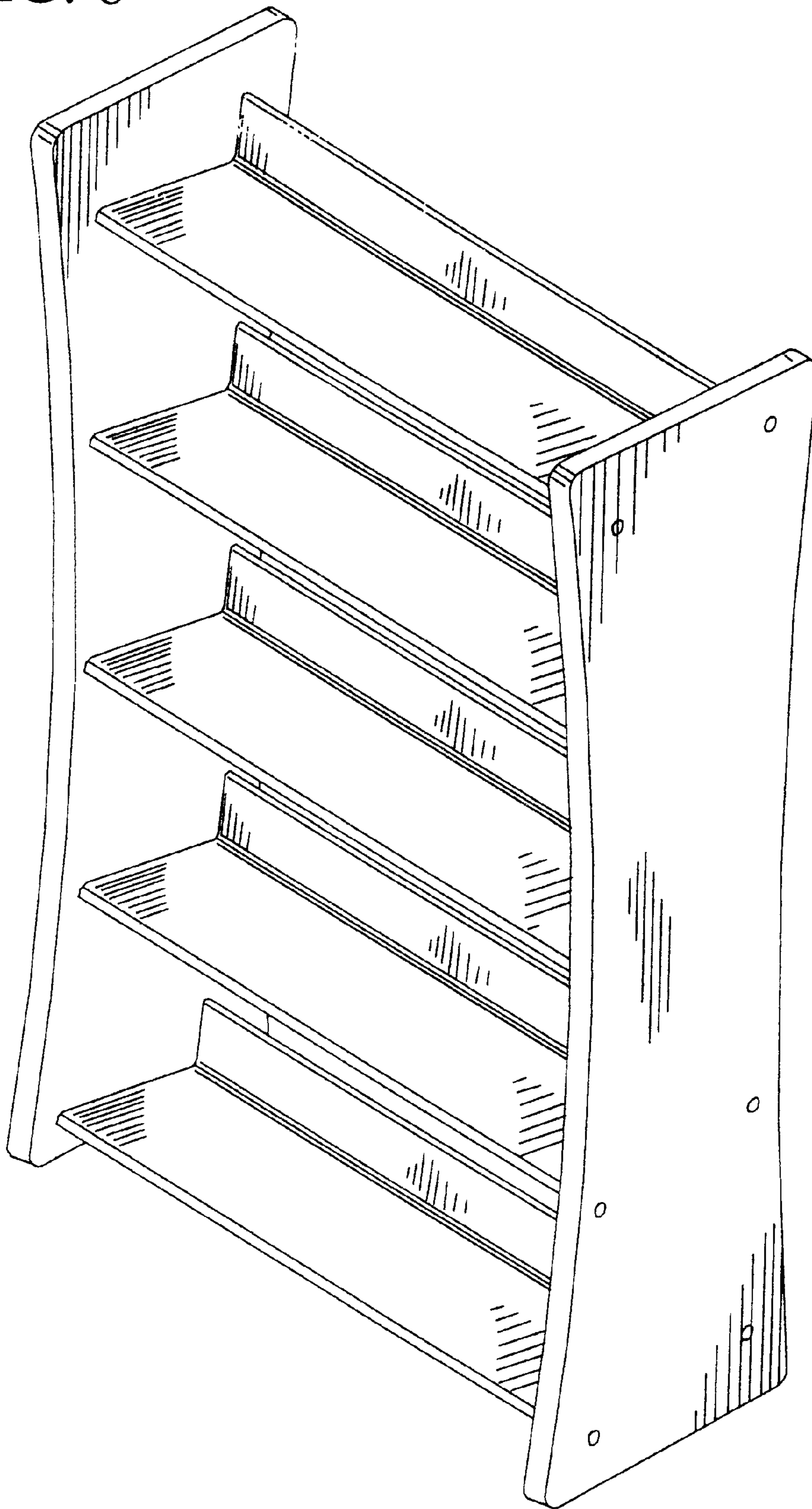

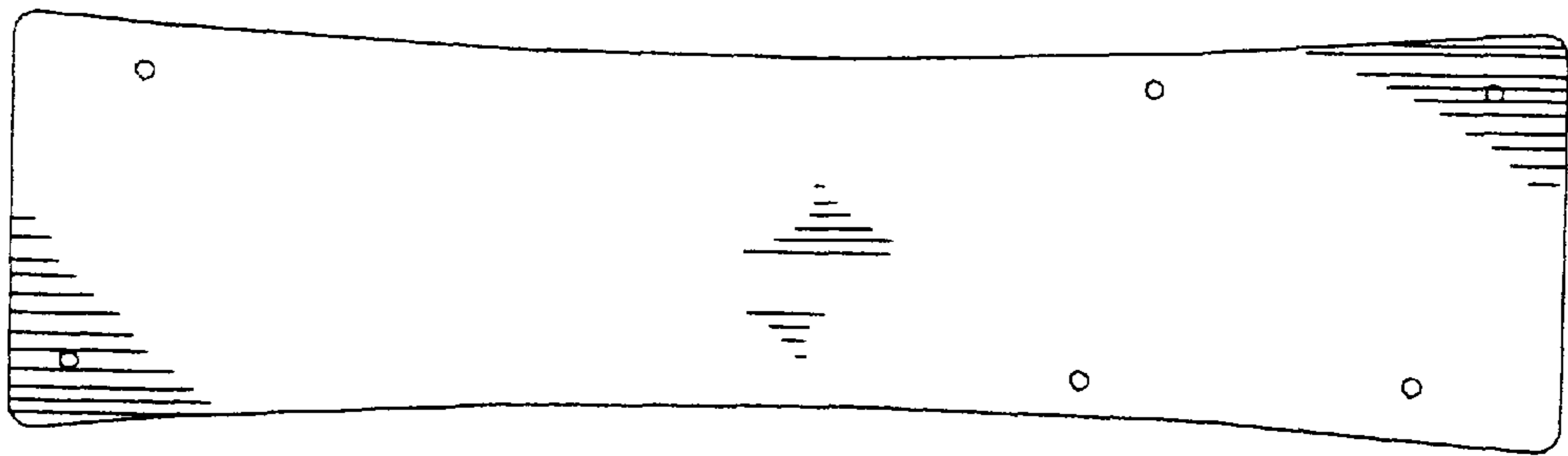

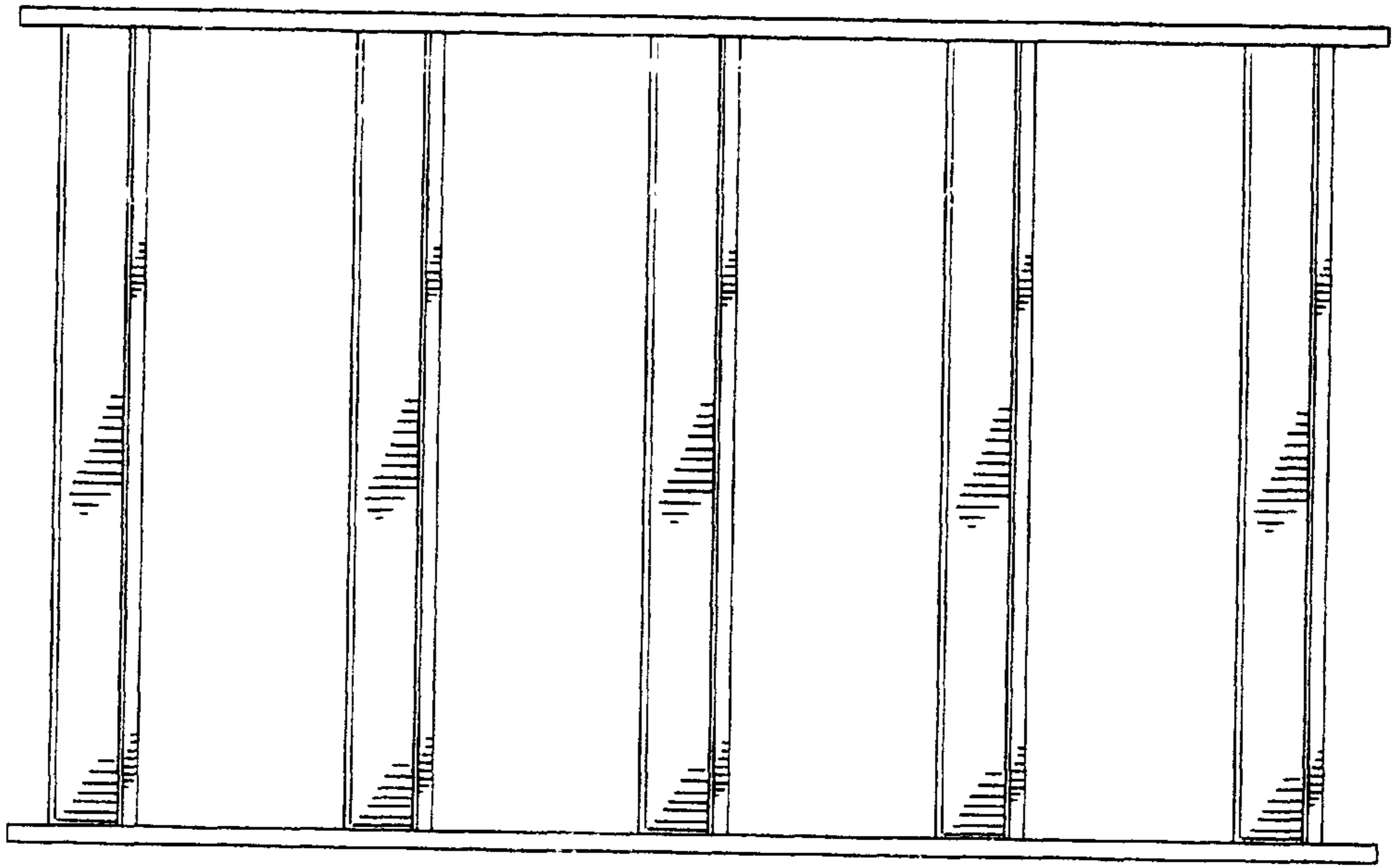

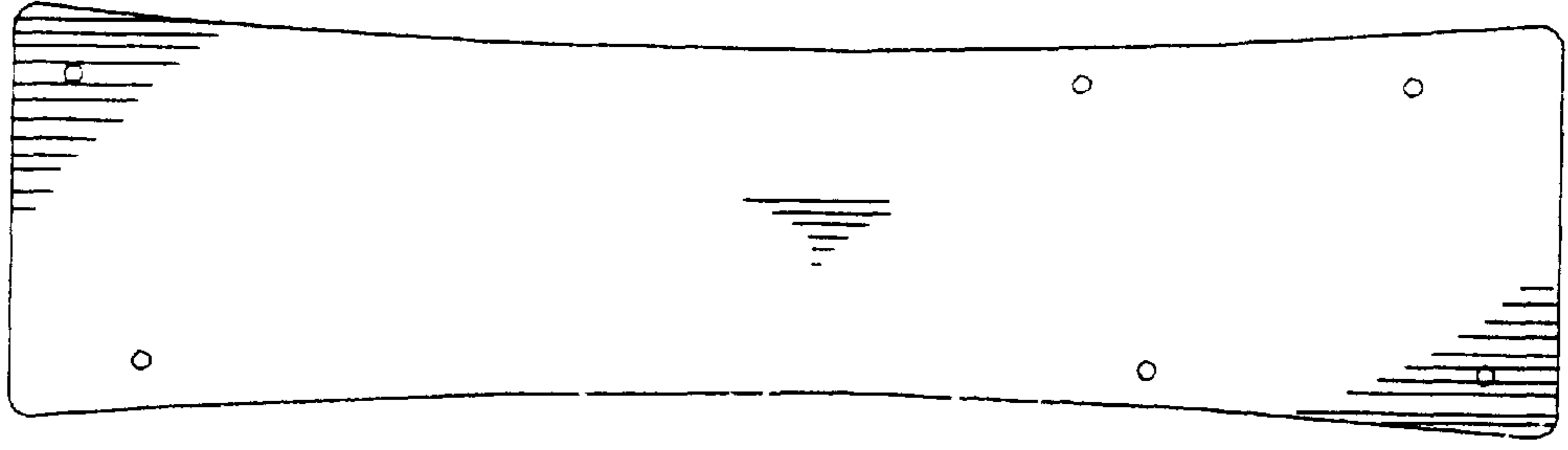

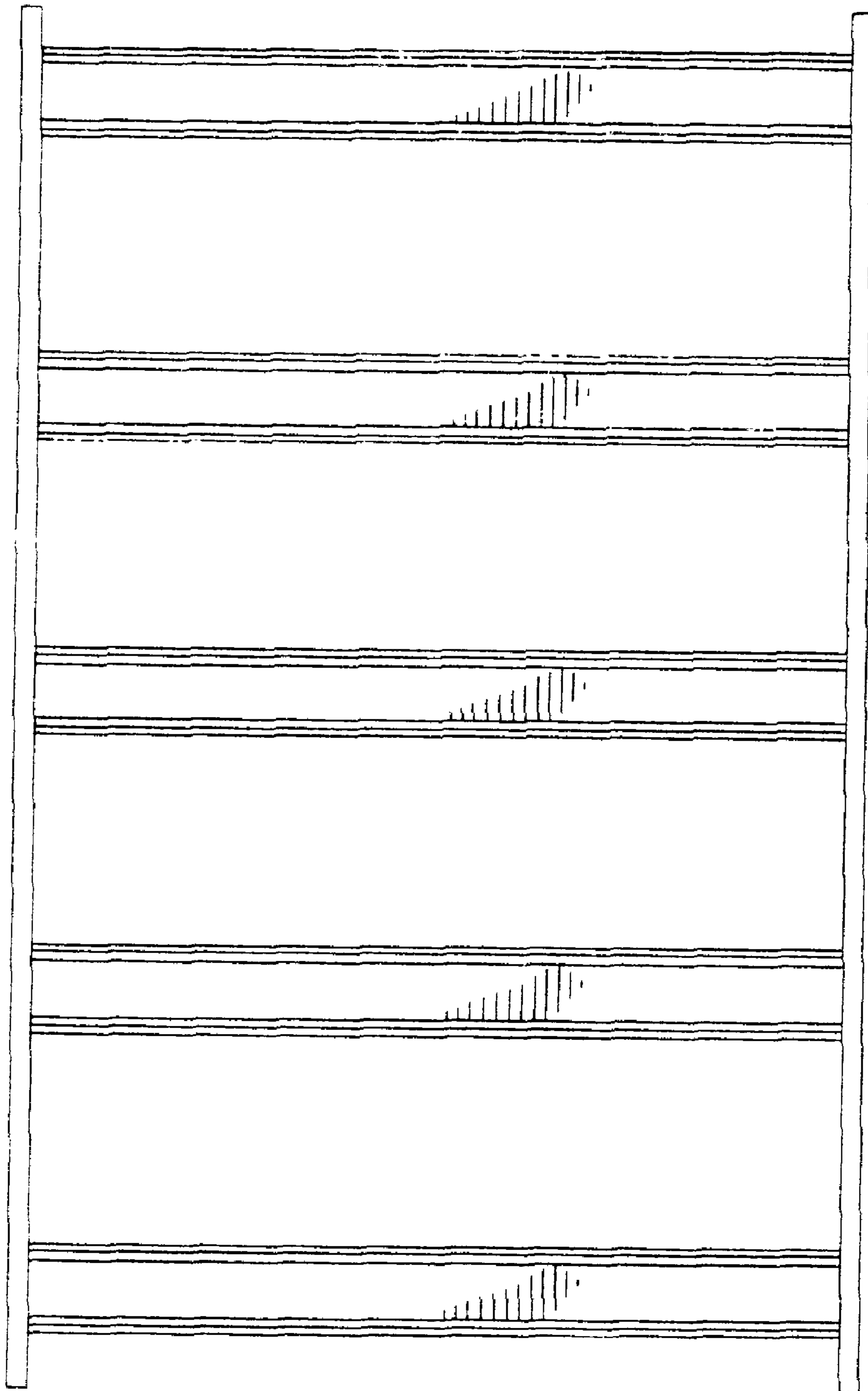

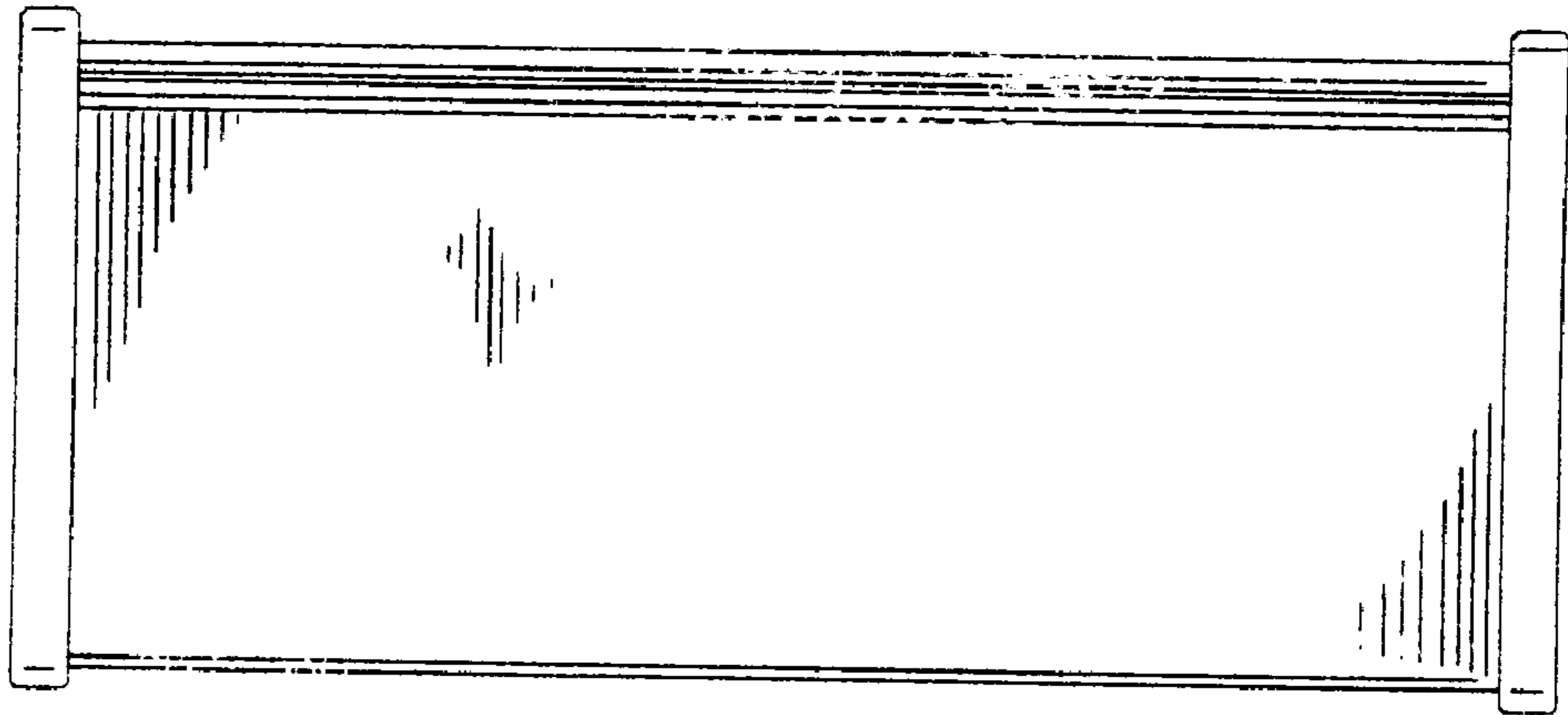

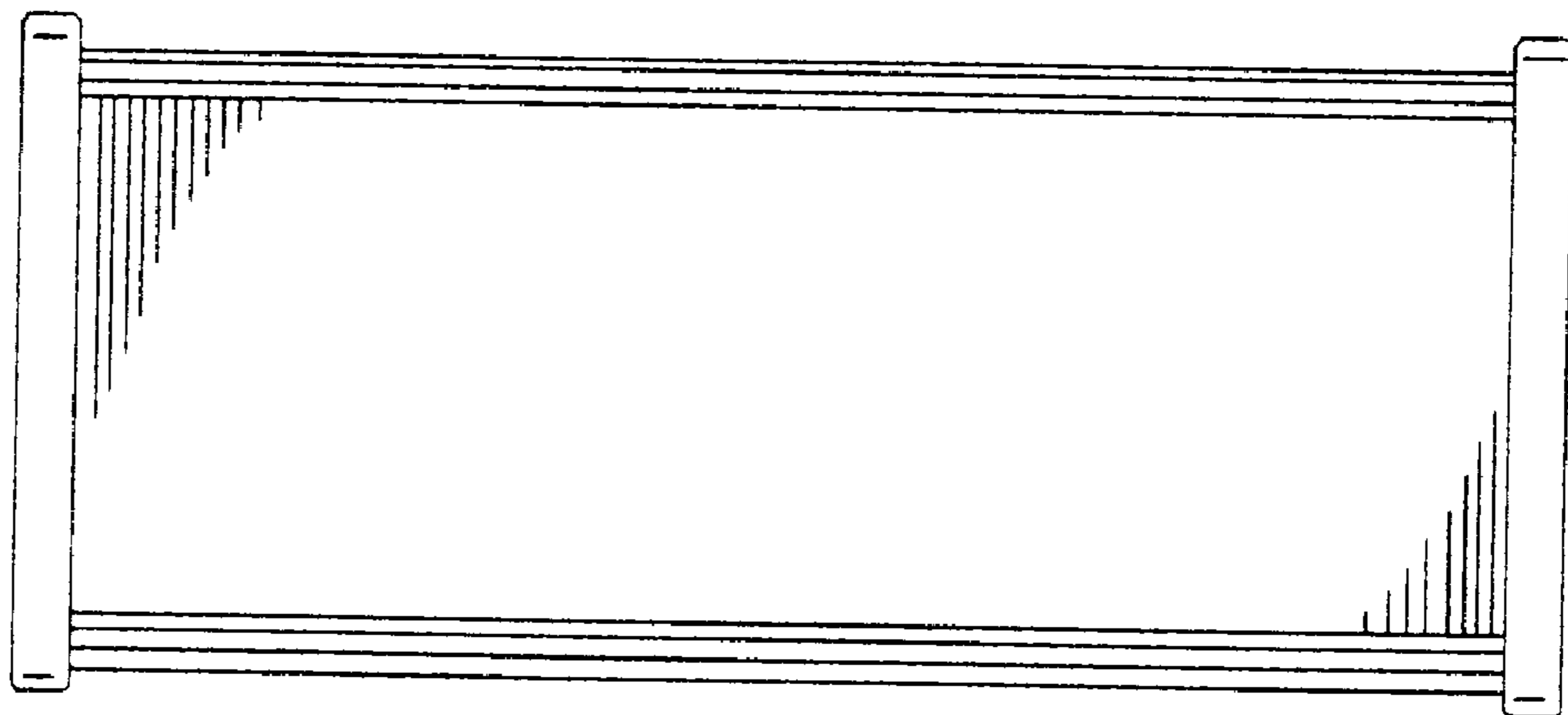

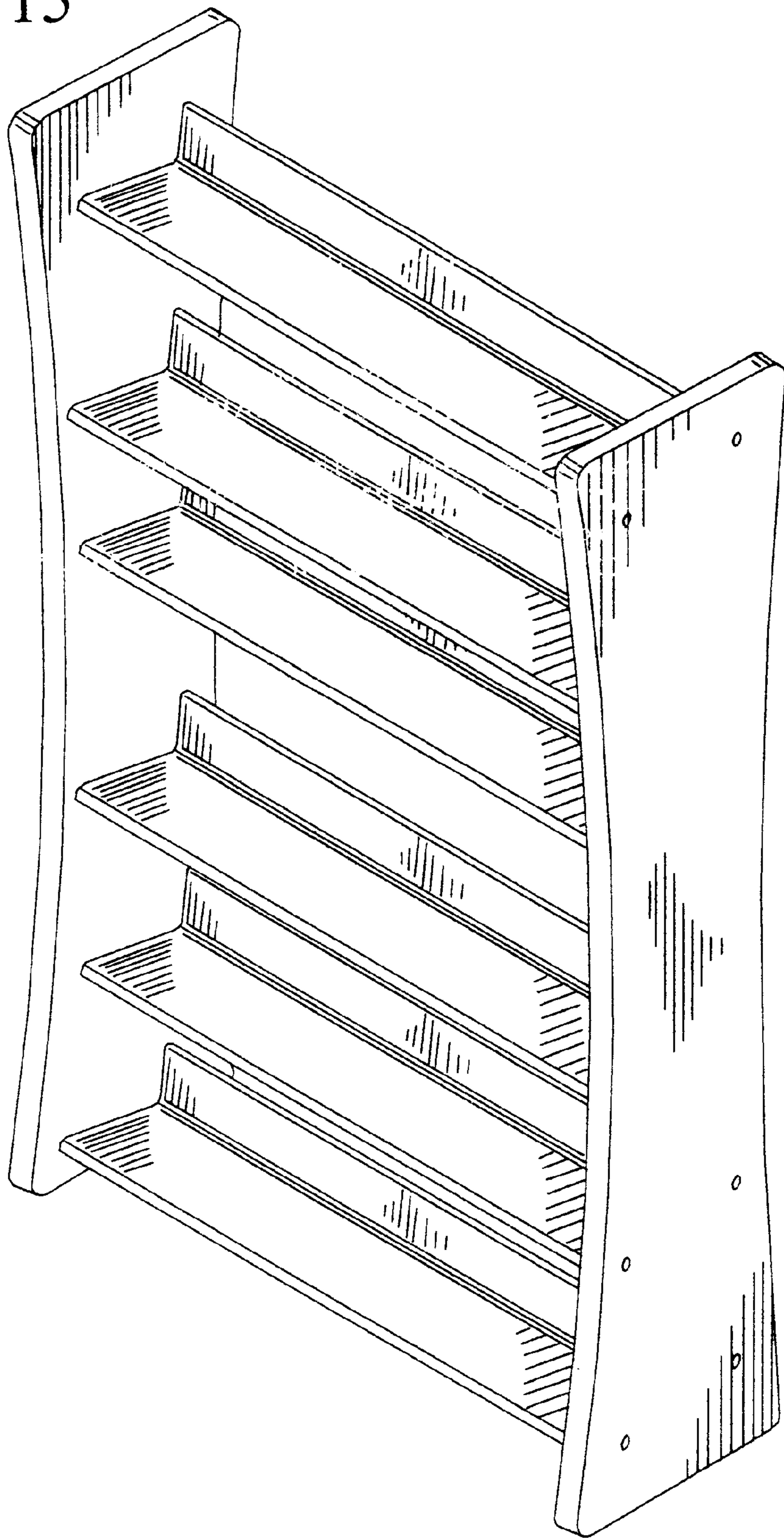

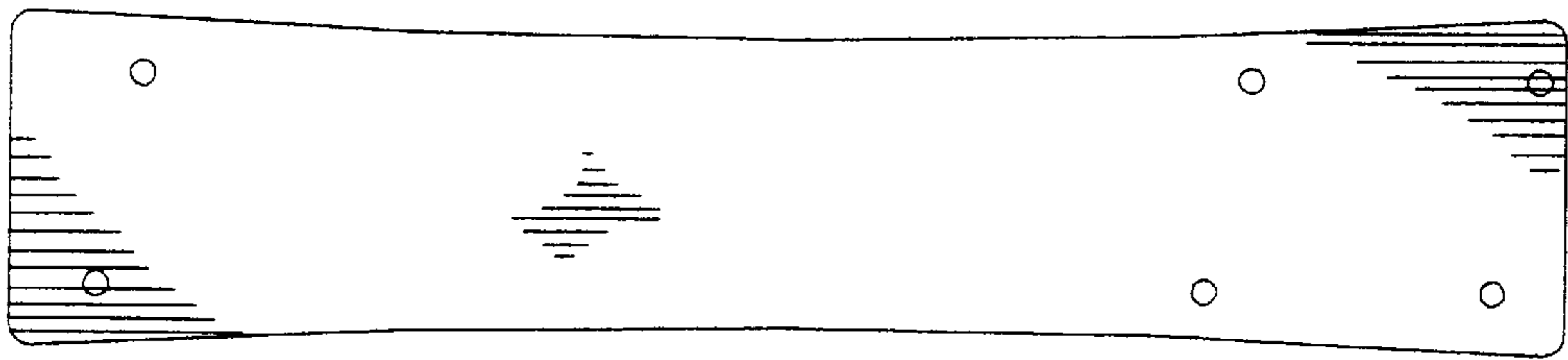

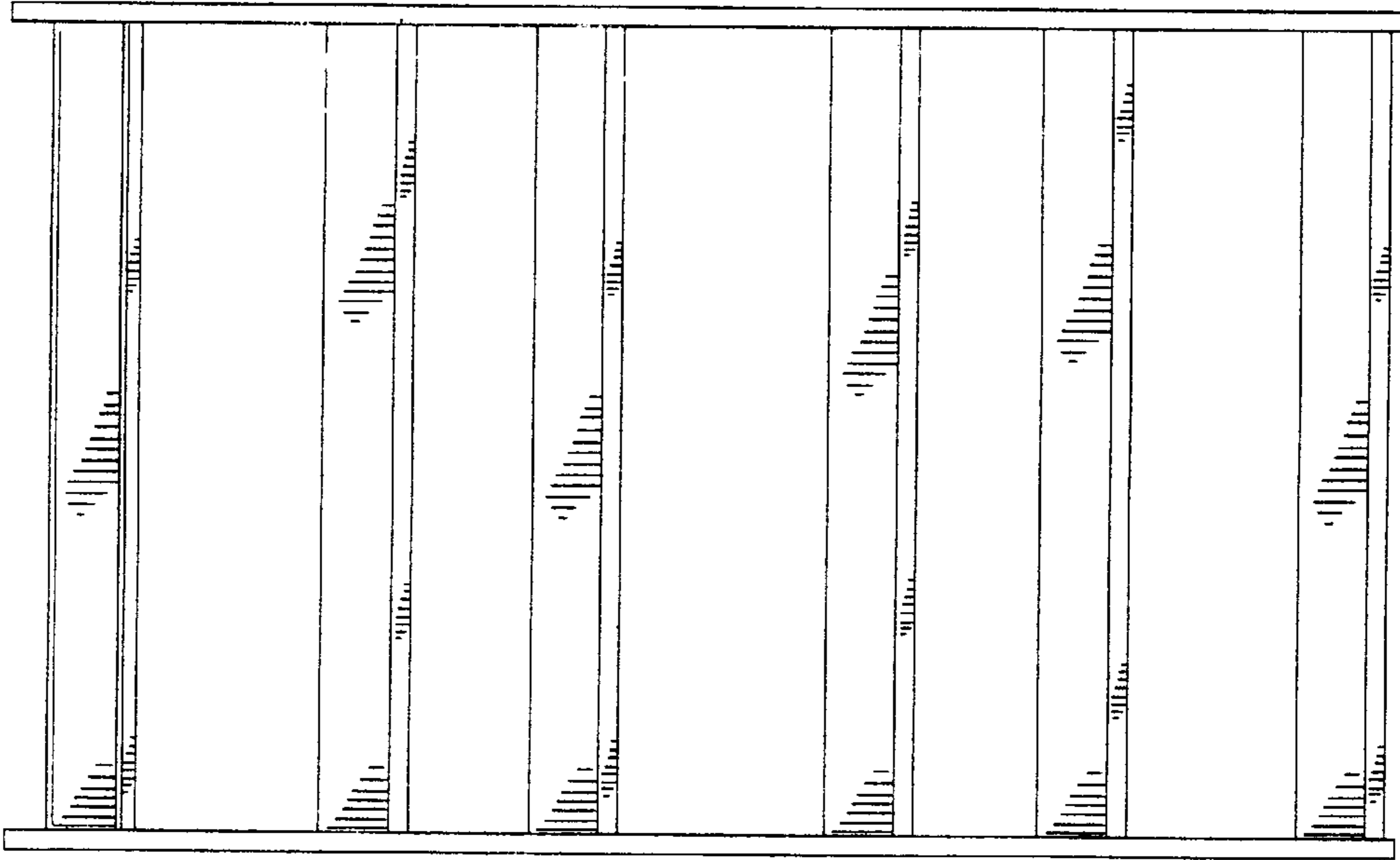

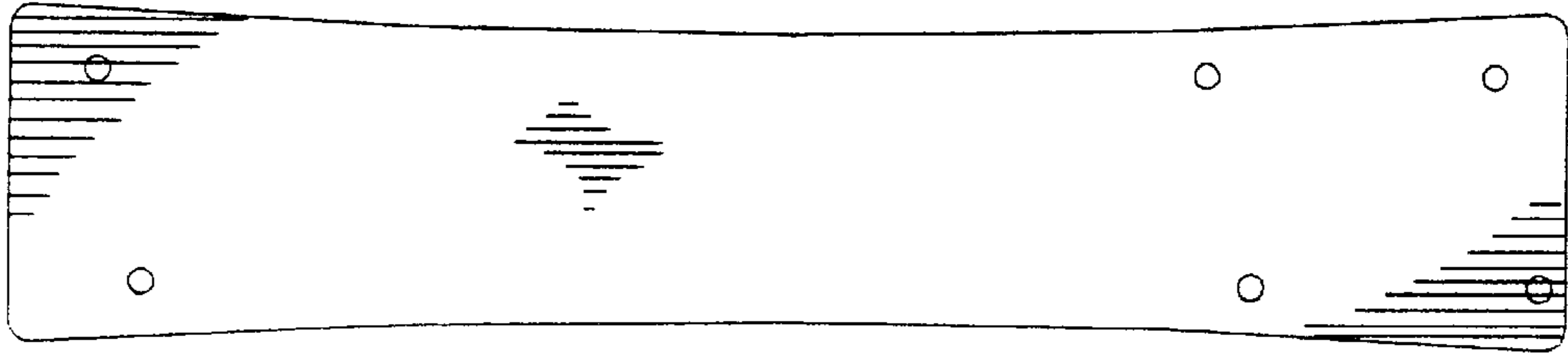

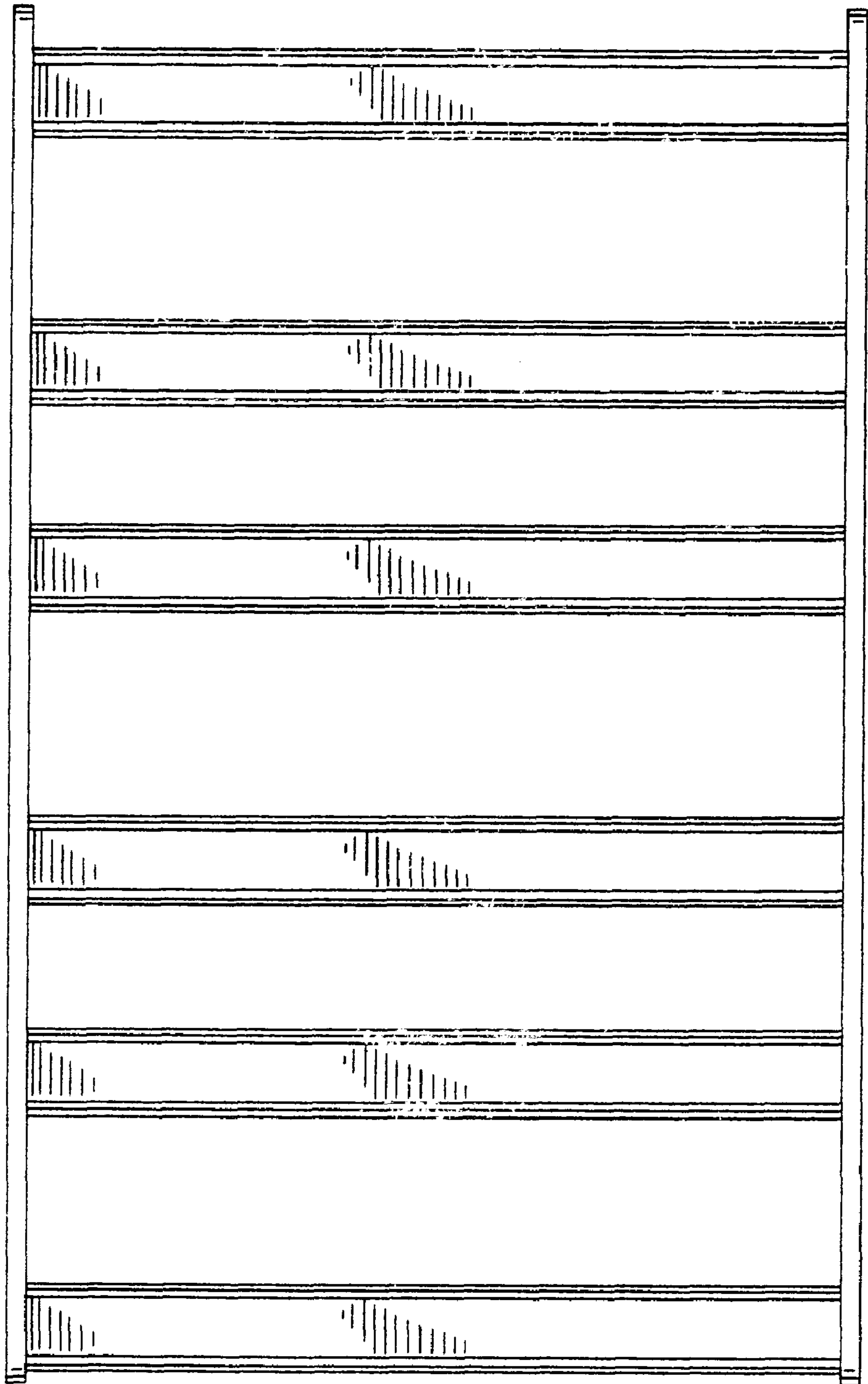

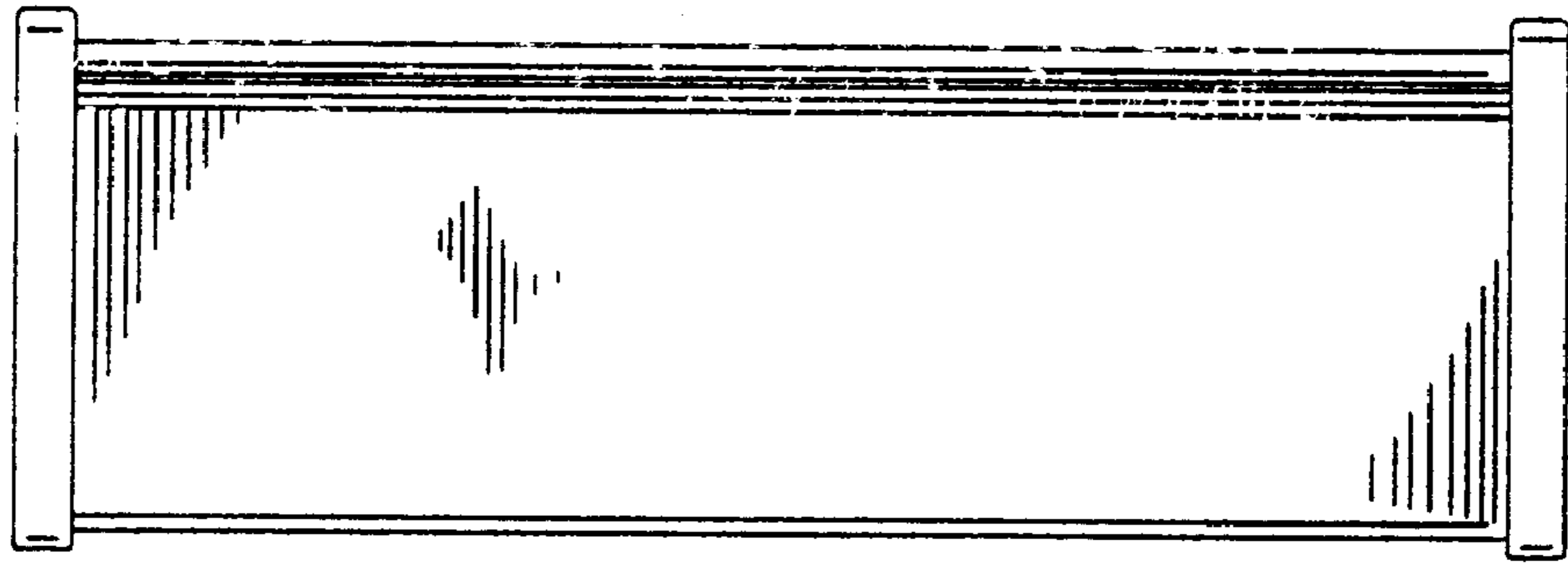
