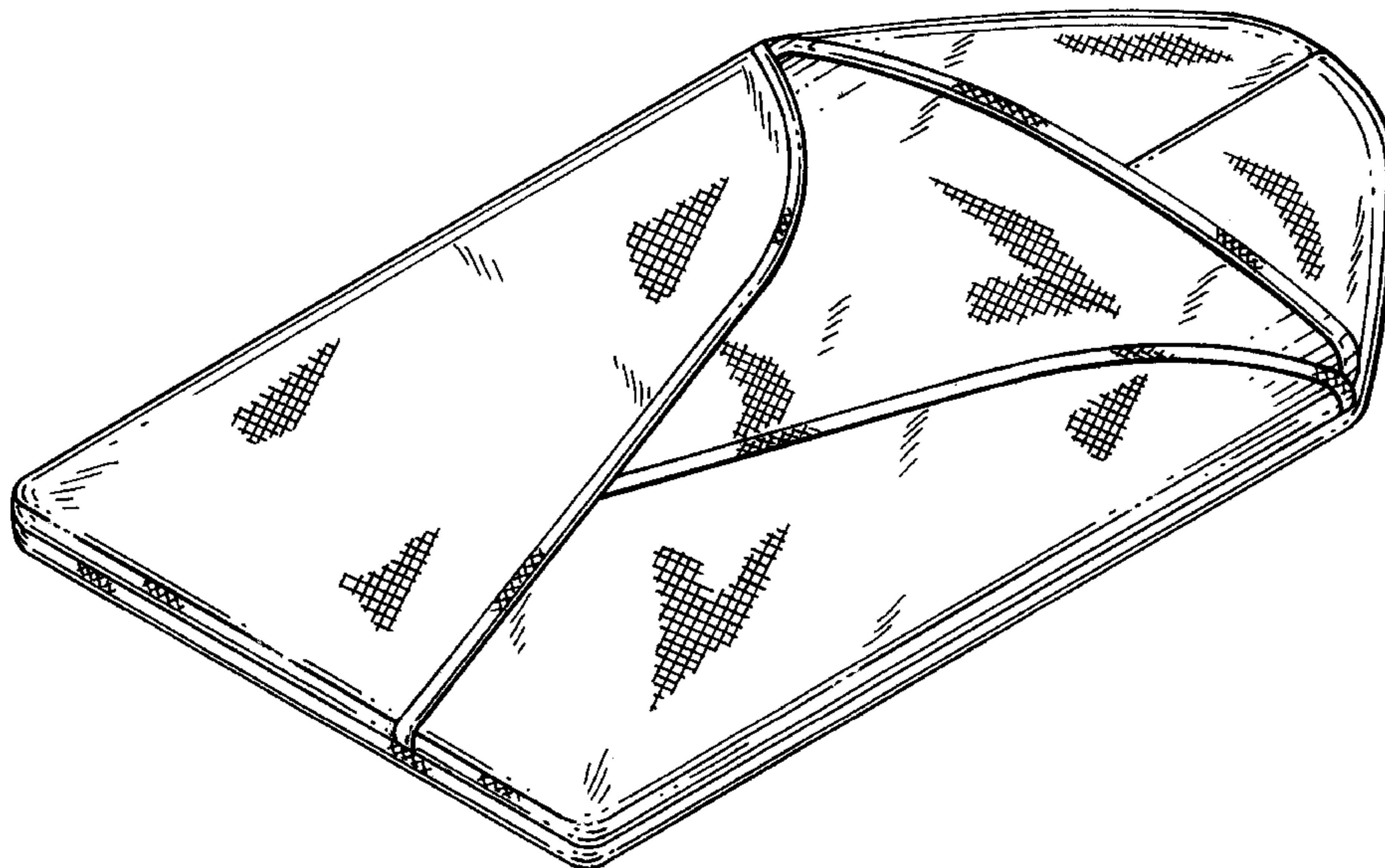
(57) **CLAIM**

The ornamental design for a hooded baby drying towel, substantially as shown.

DESCRIPTION

FIG. 1 is a top, rear and right side perspective view of the hooded baby drying towel of the present invention; FIG. 2 is a front view of the subject invention; FIG. 3 is a rear view of the subject invention; FIG. 4 is a top plan view of the subject invention; FIG. 5 is a right side view of the subject invention; FIG. 6 is a left side view of the subject invention; and, FIG. 7 is a bottom plan view of the subject invention.

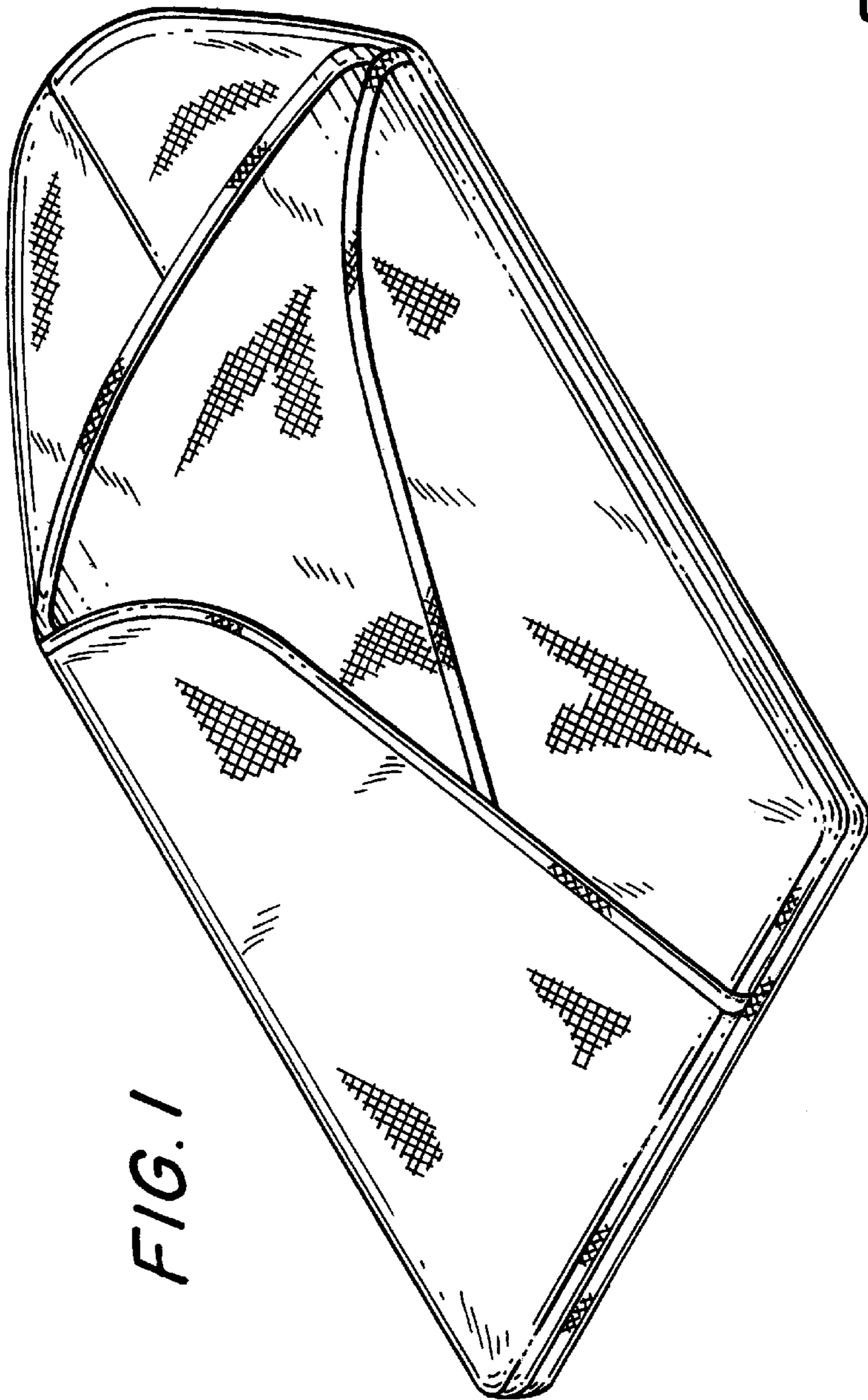

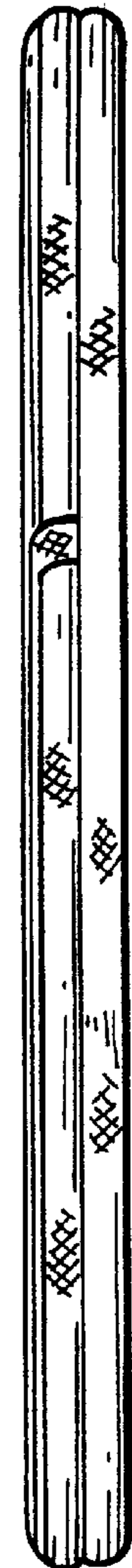

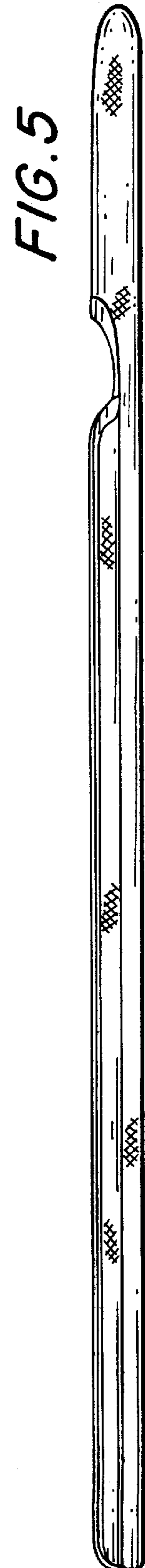
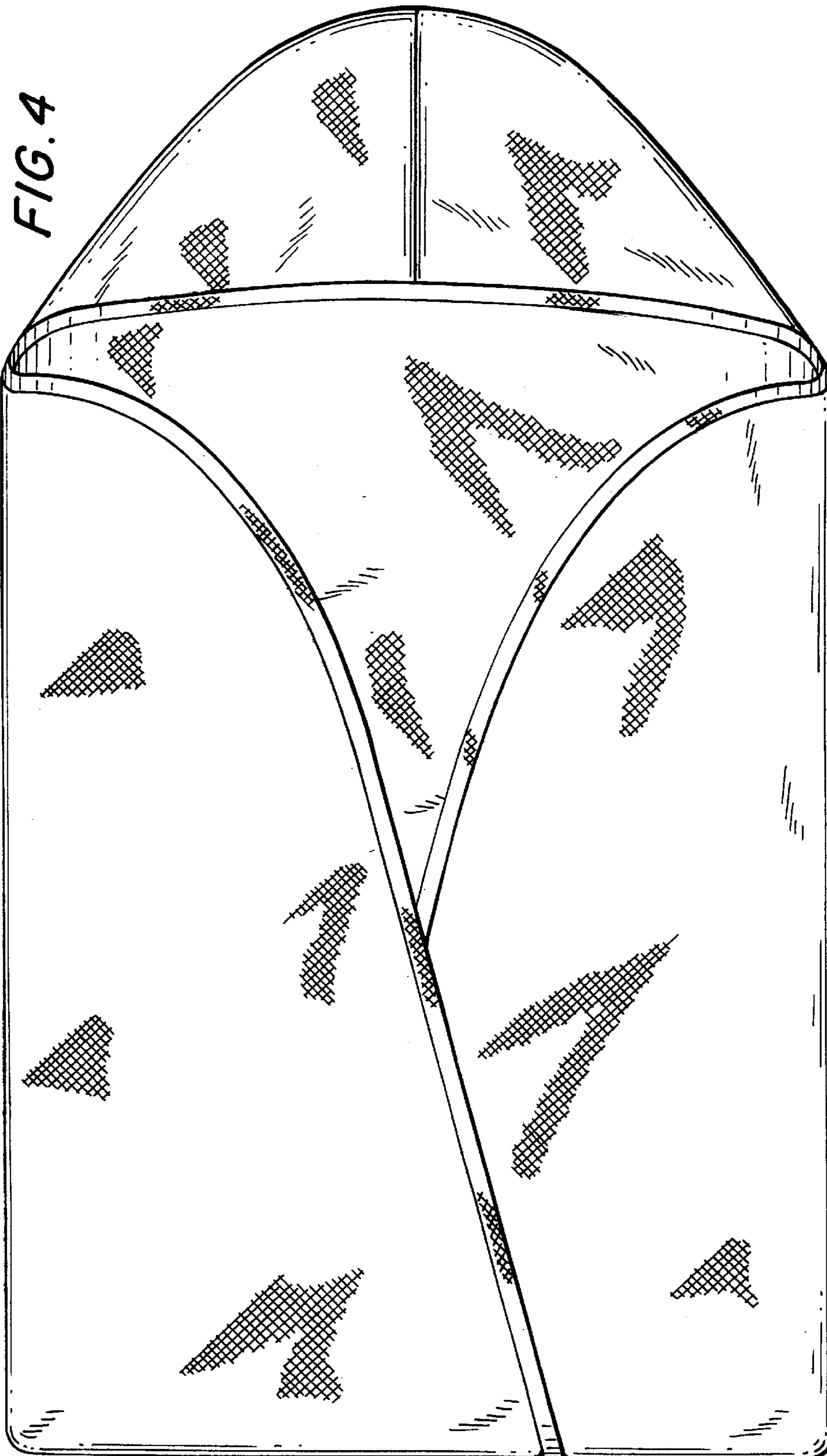

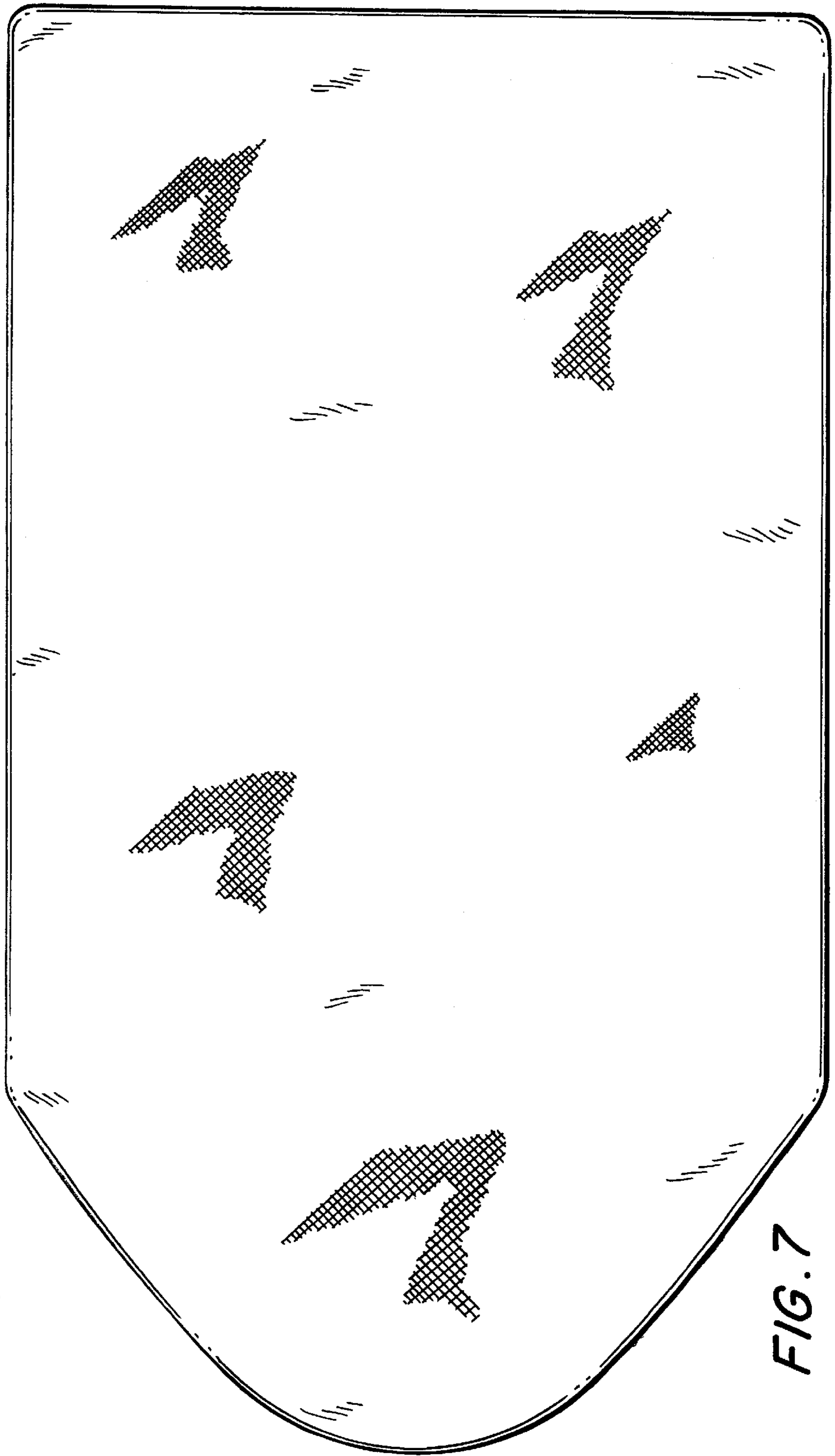
