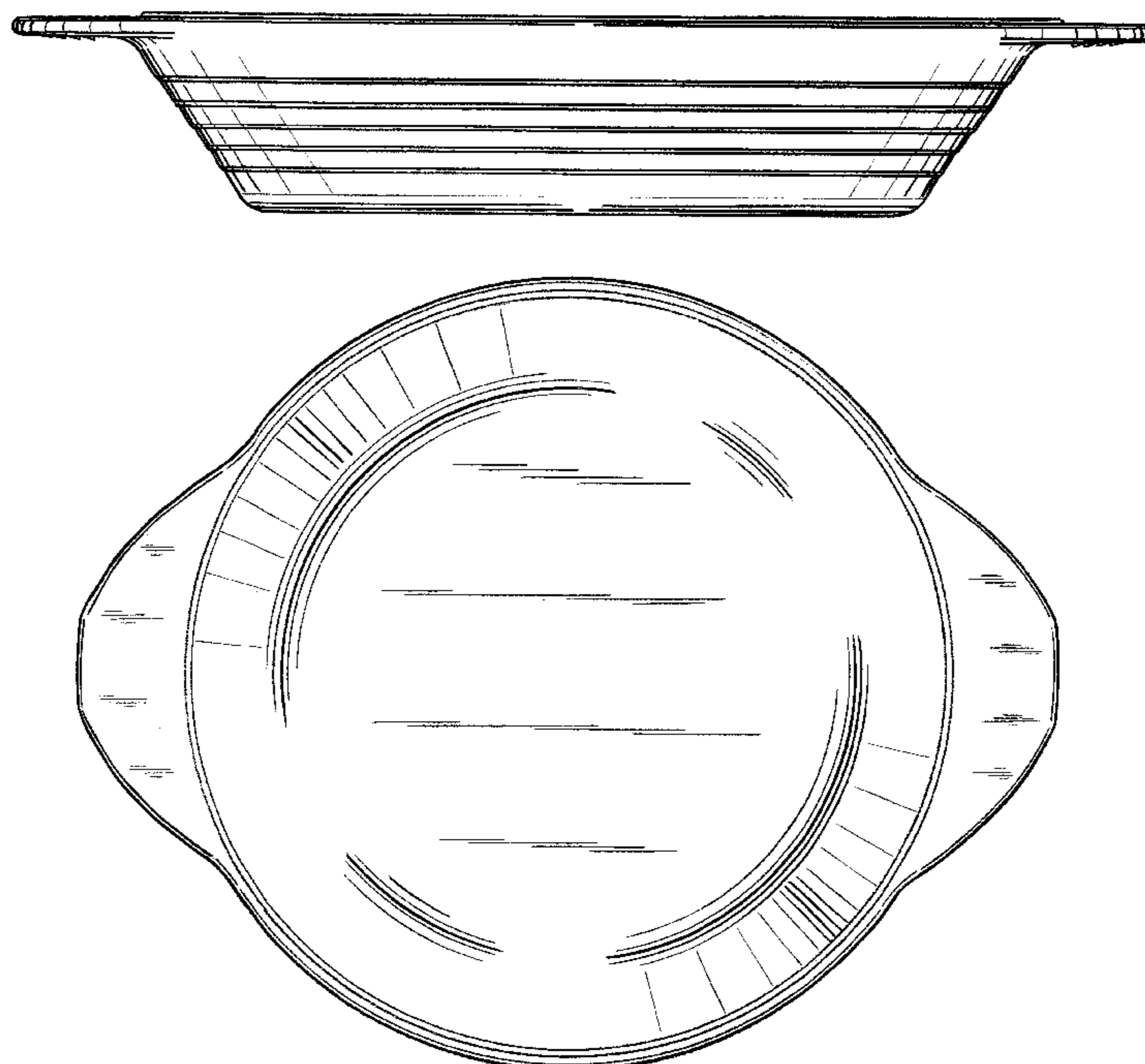
(57) **CLAIM**

The ornamental design for a bowl with handles, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a bowl with handles according to the present design; the back elevational view being the same;  
FIG. 2 is a side elevational view thereof; the other side elevational view being the same;  
FIG. 3 is a top view thereof; and,  
FIG. 4 is a bottom view thereof.

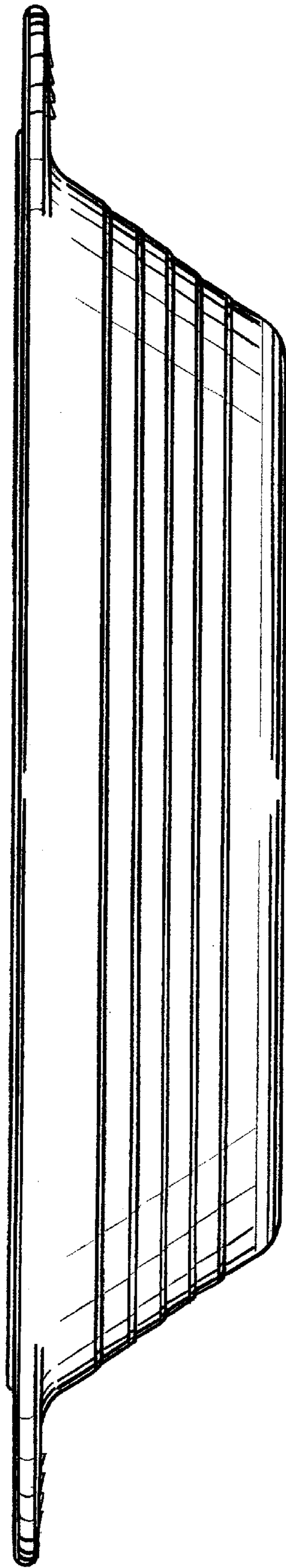

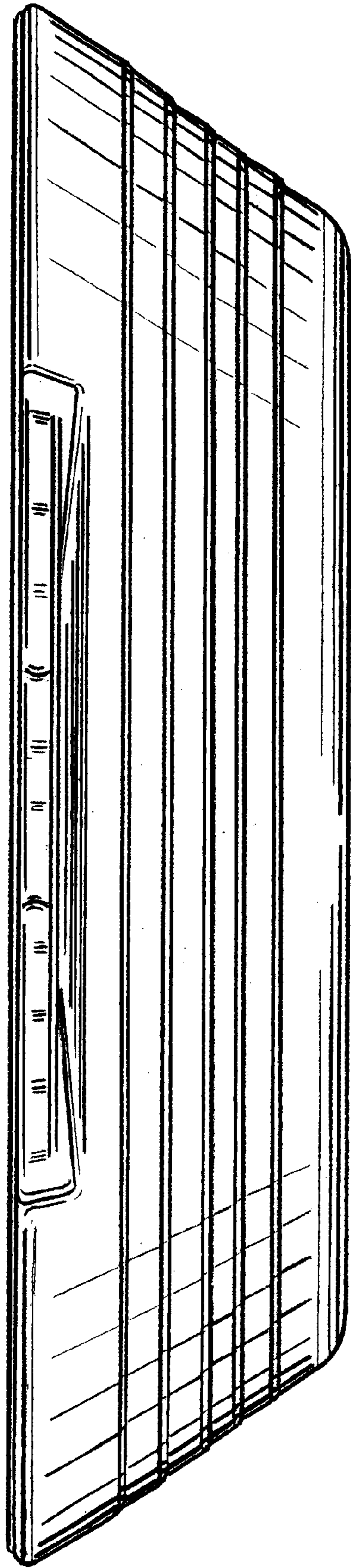
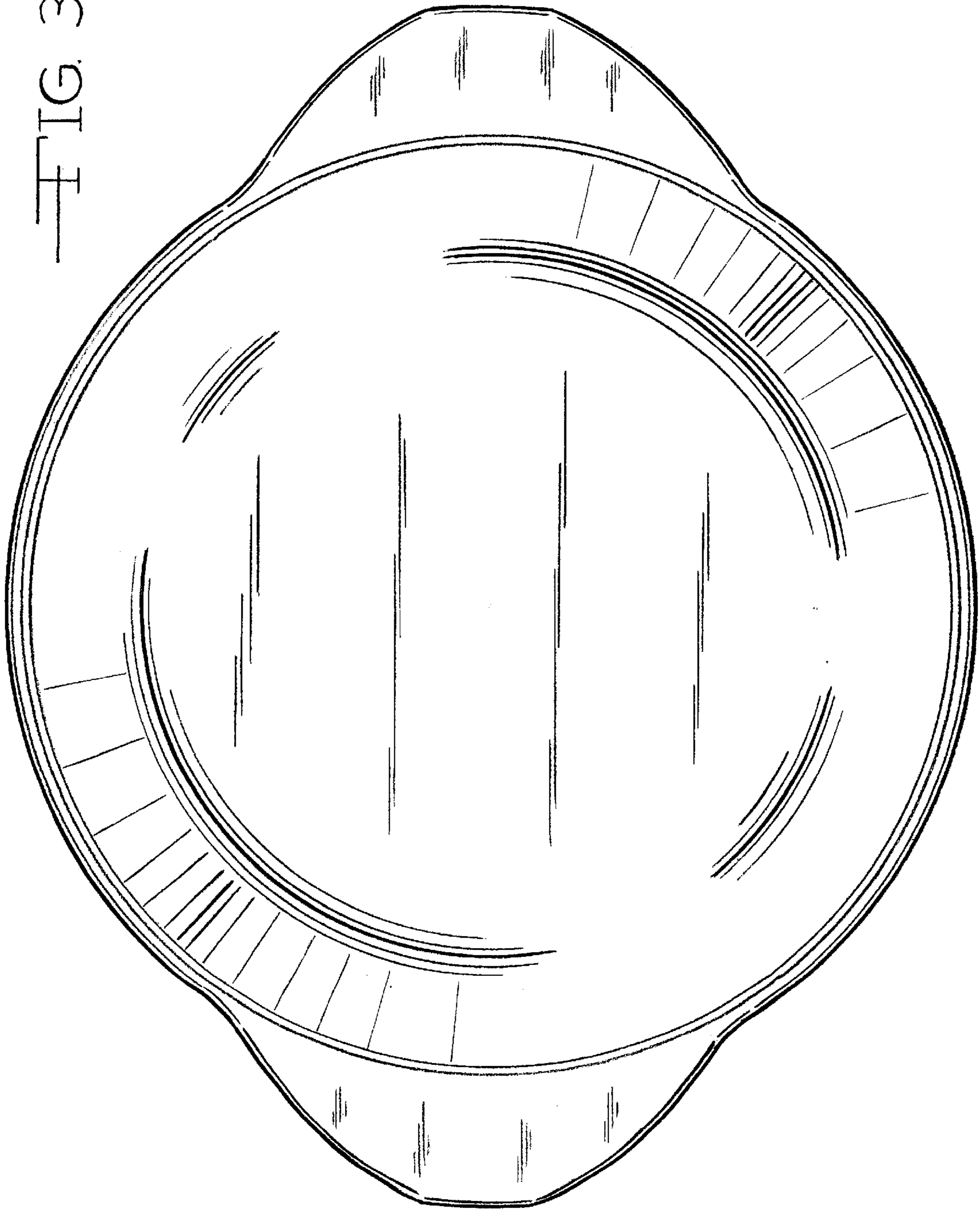

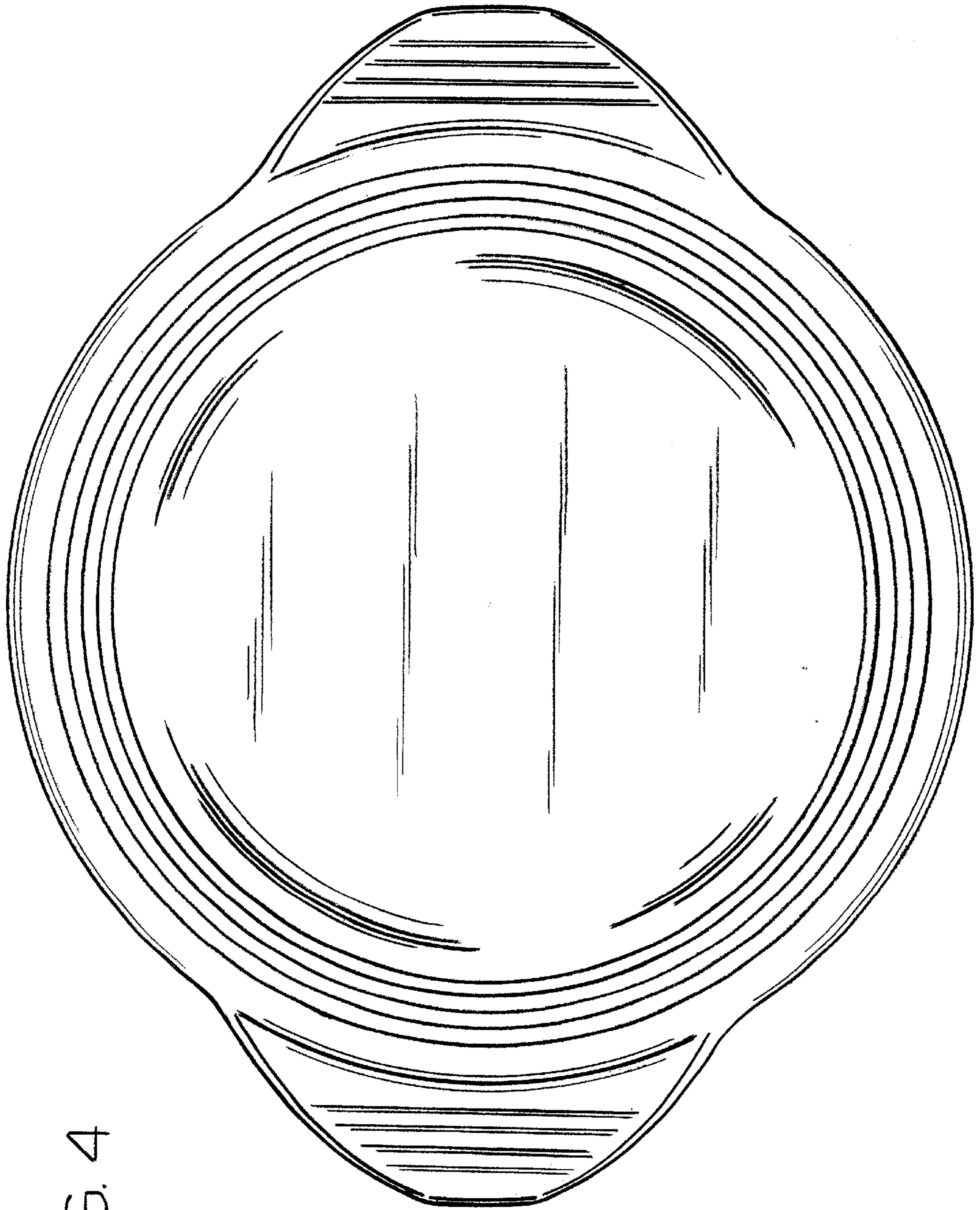
