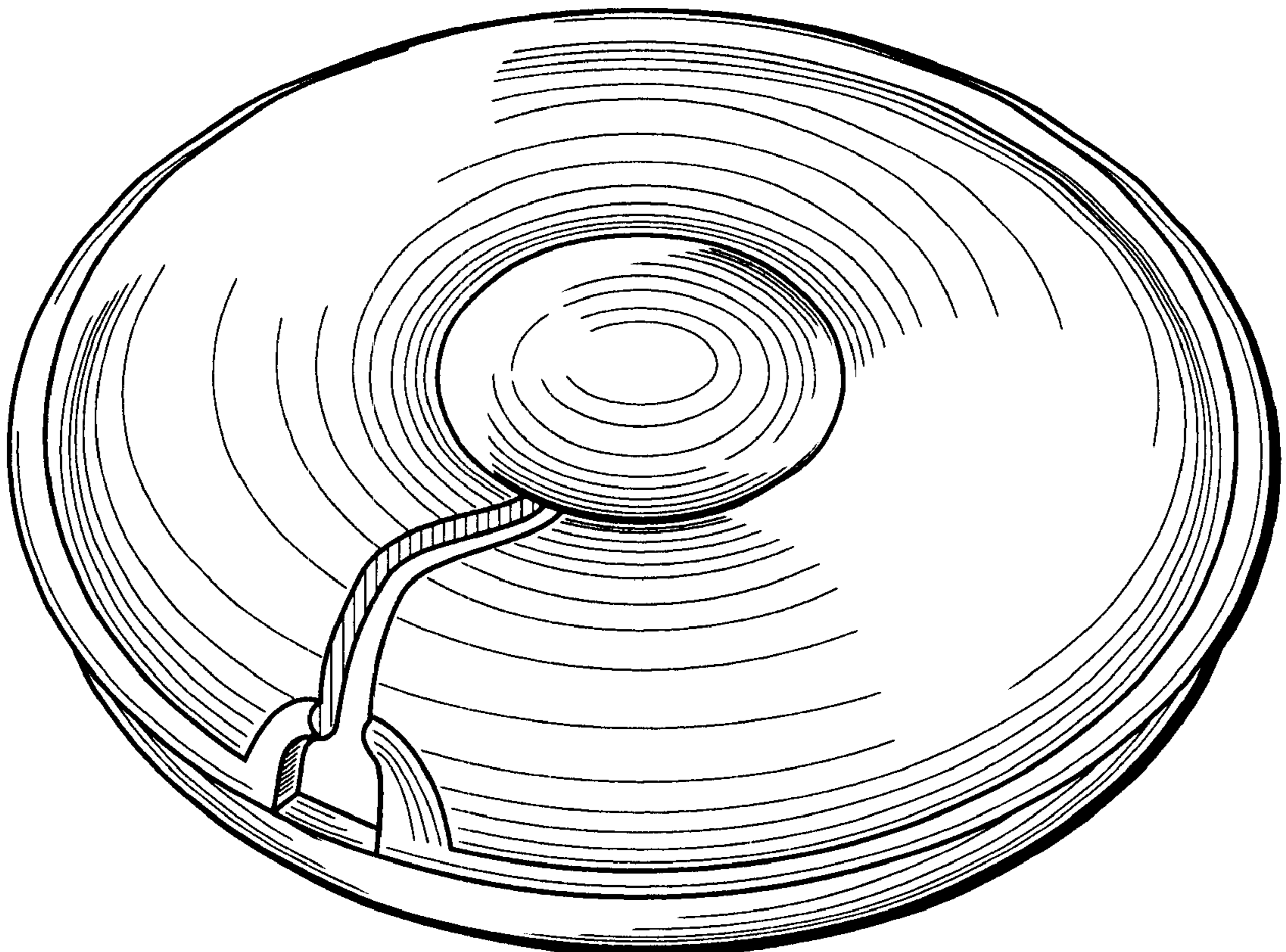

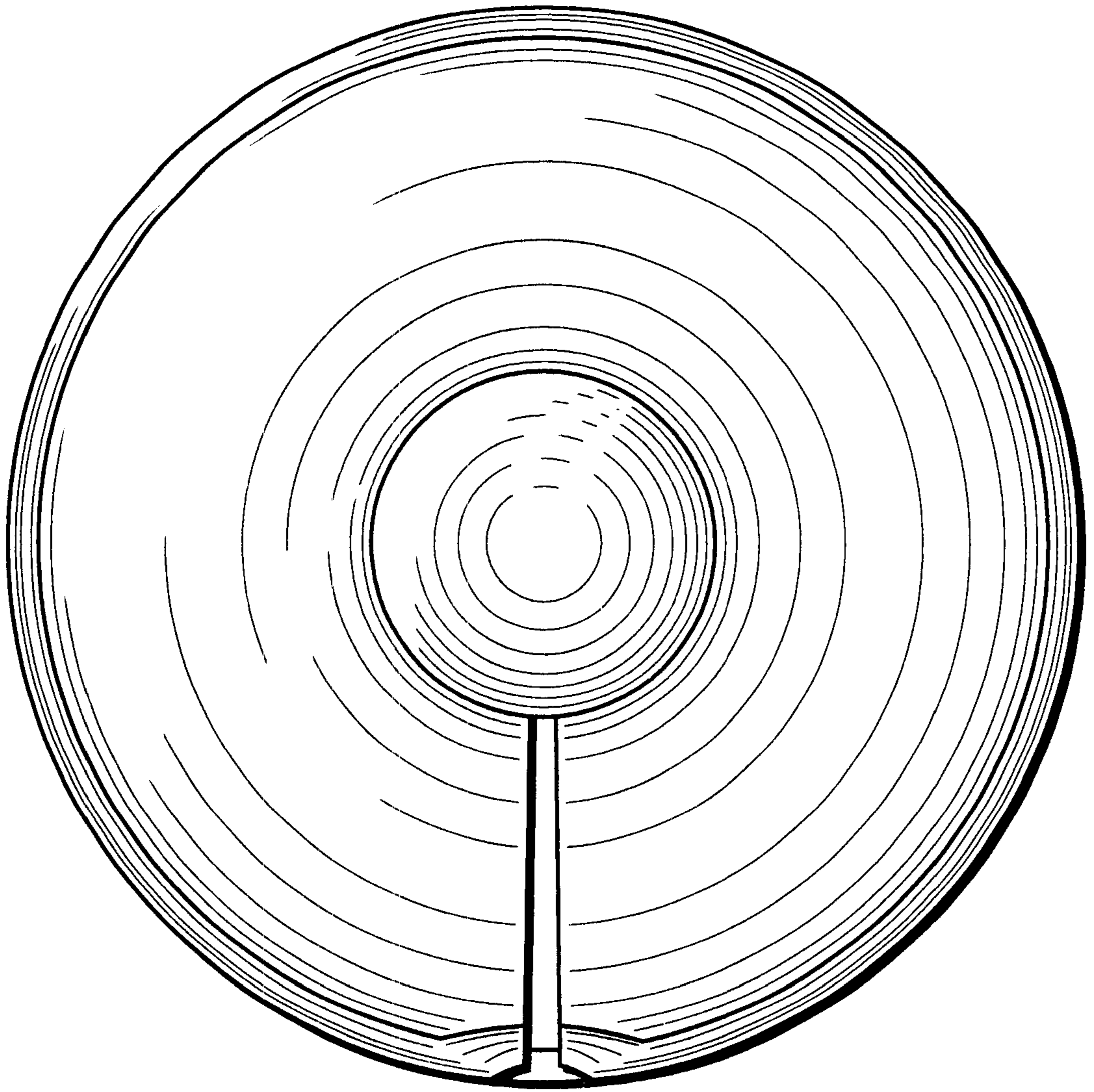

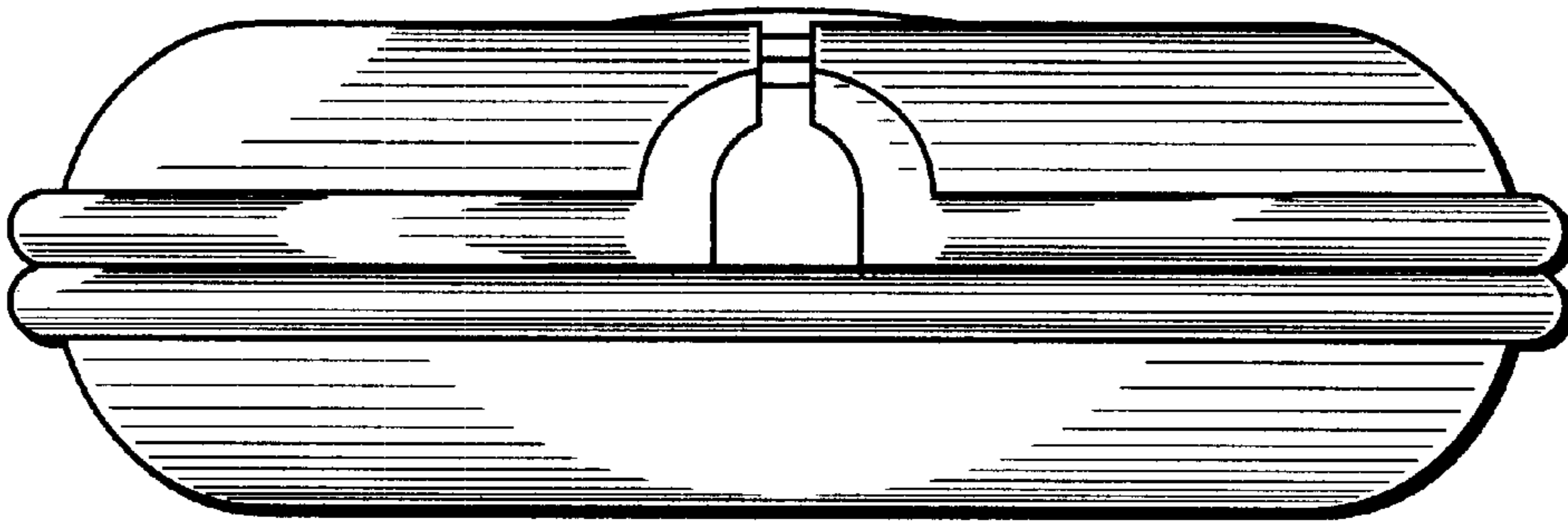
FIG. 1 is a top plan view of a cord holder showing my new design;

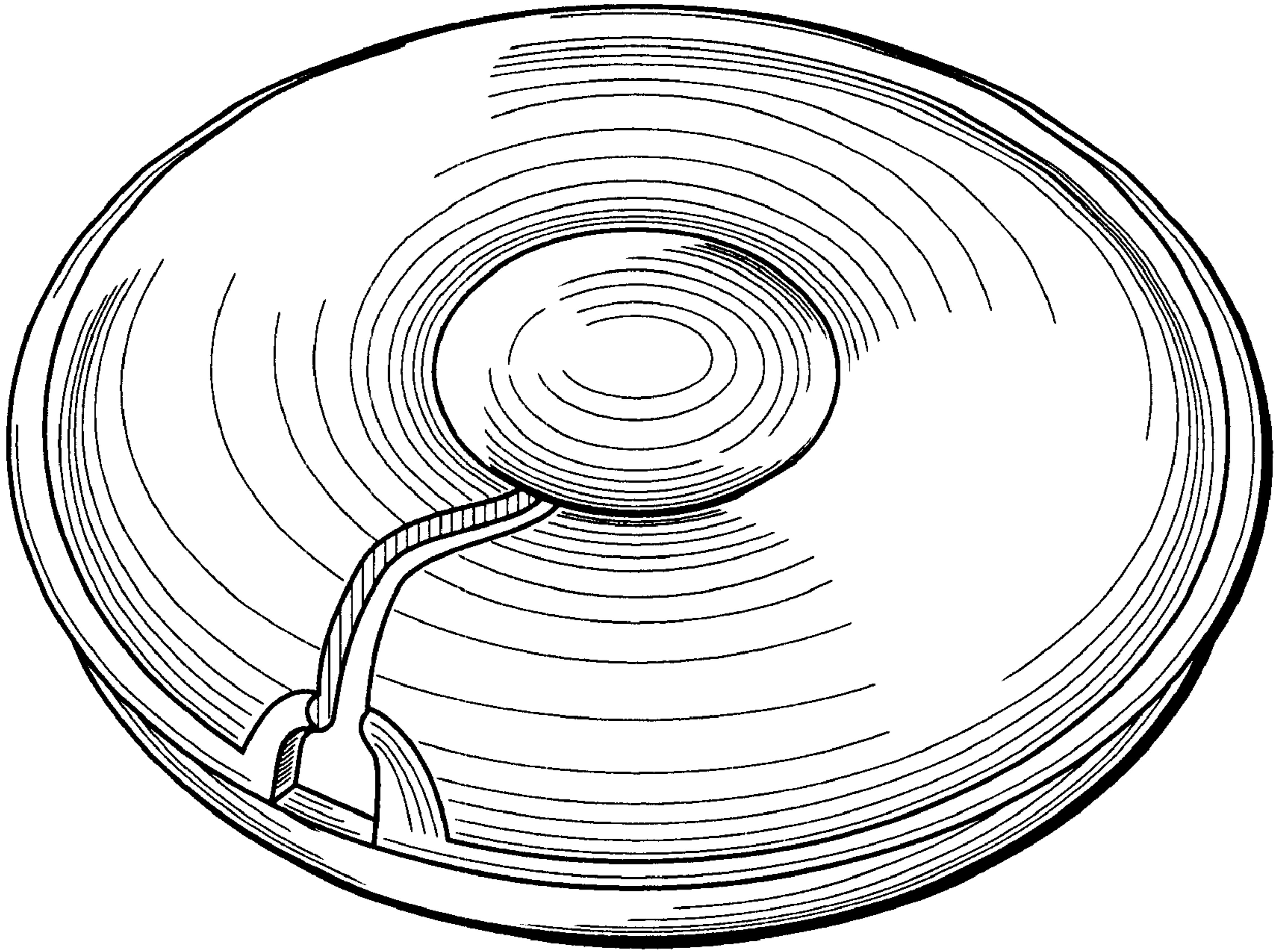




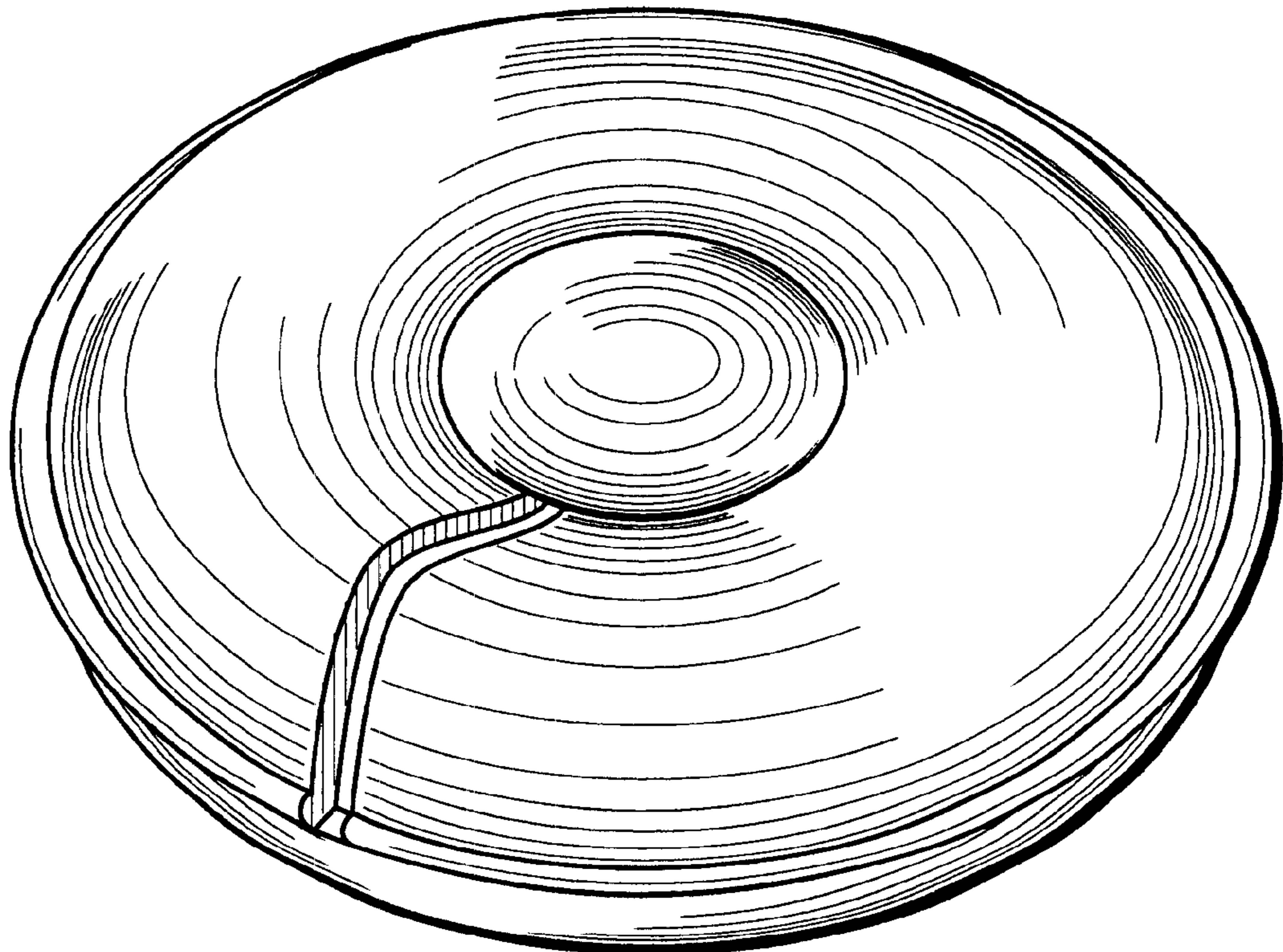

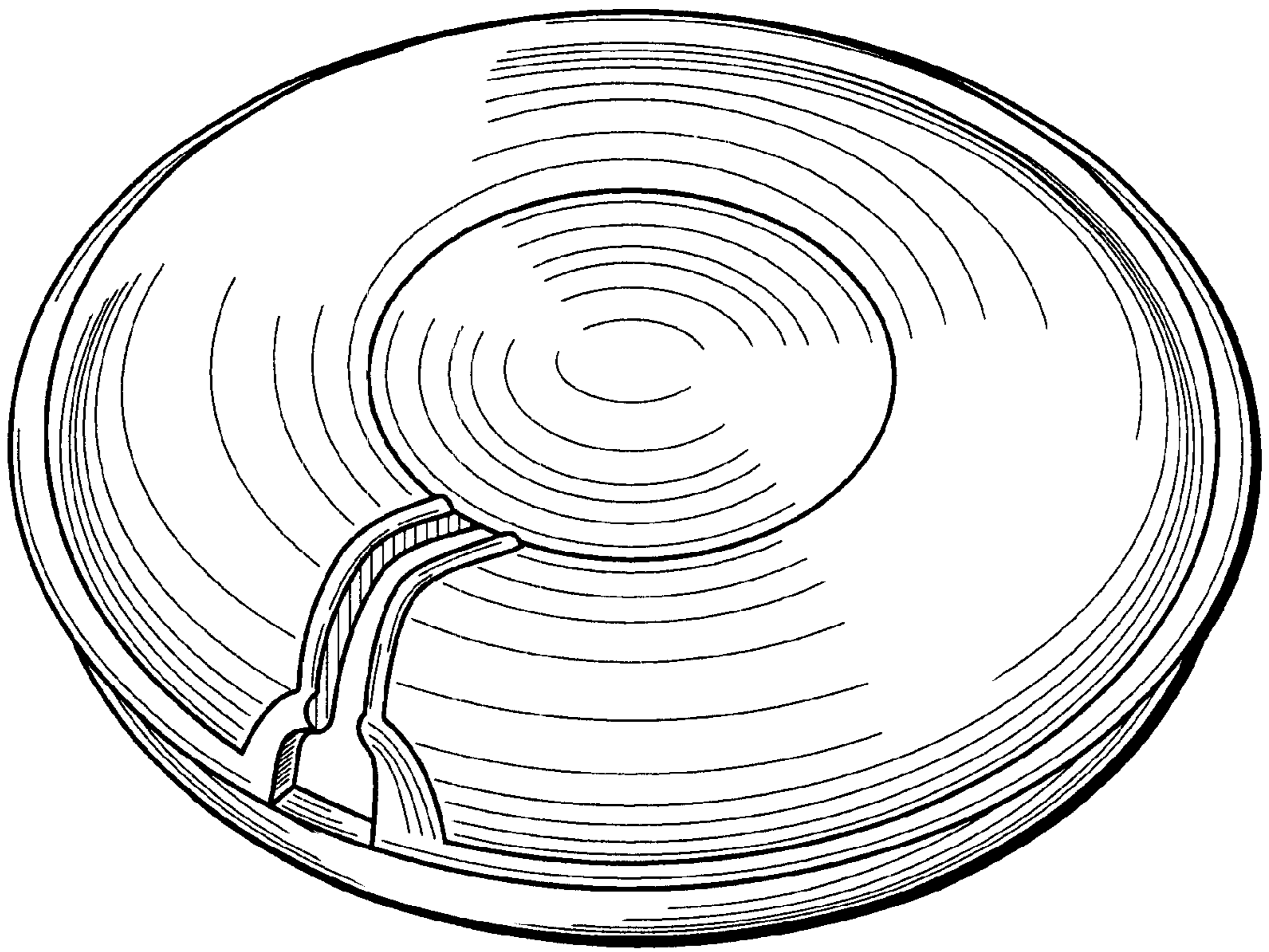

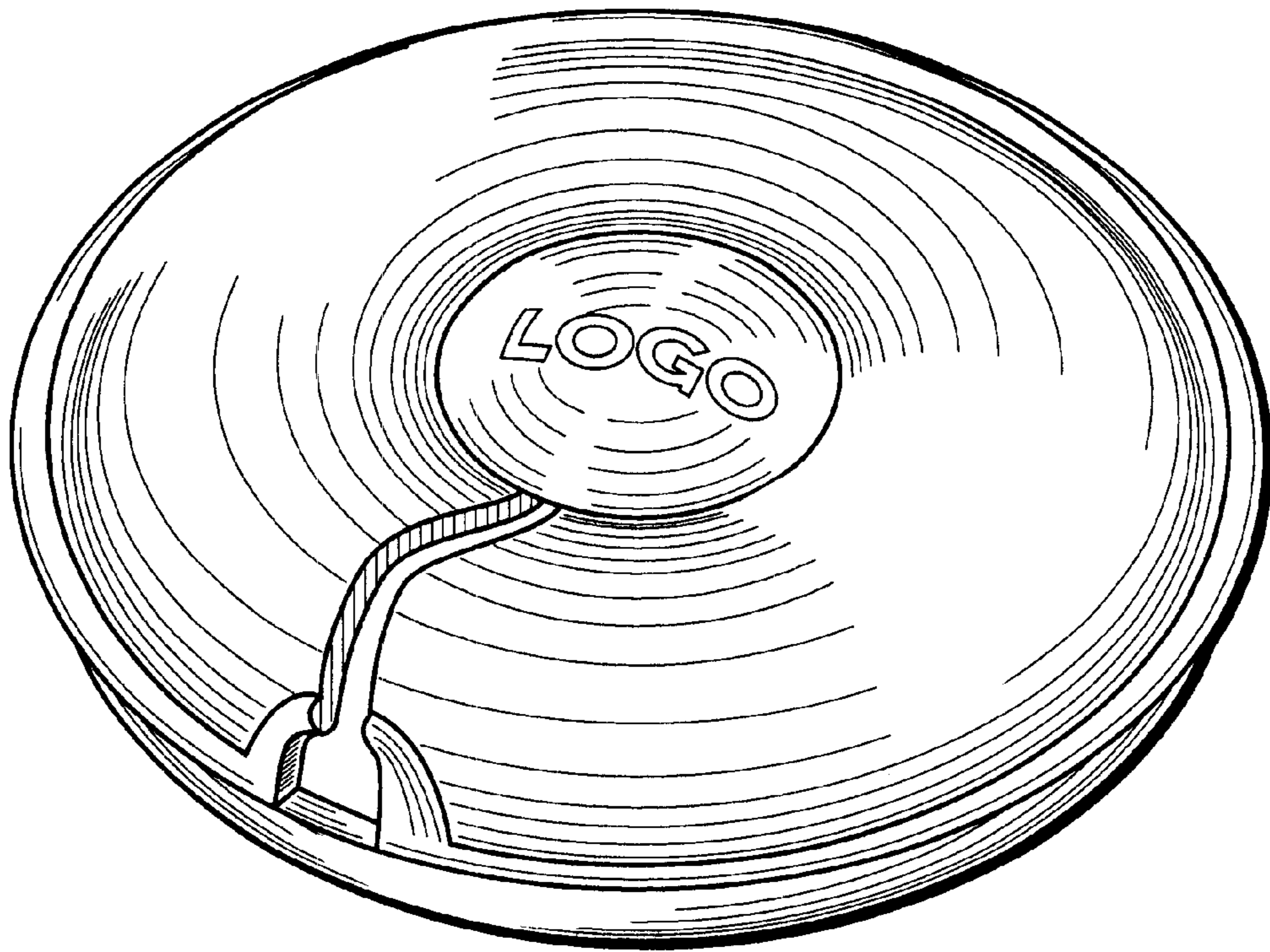
