FIG. 4 is a right side view of the embodiment of FIG. 1;

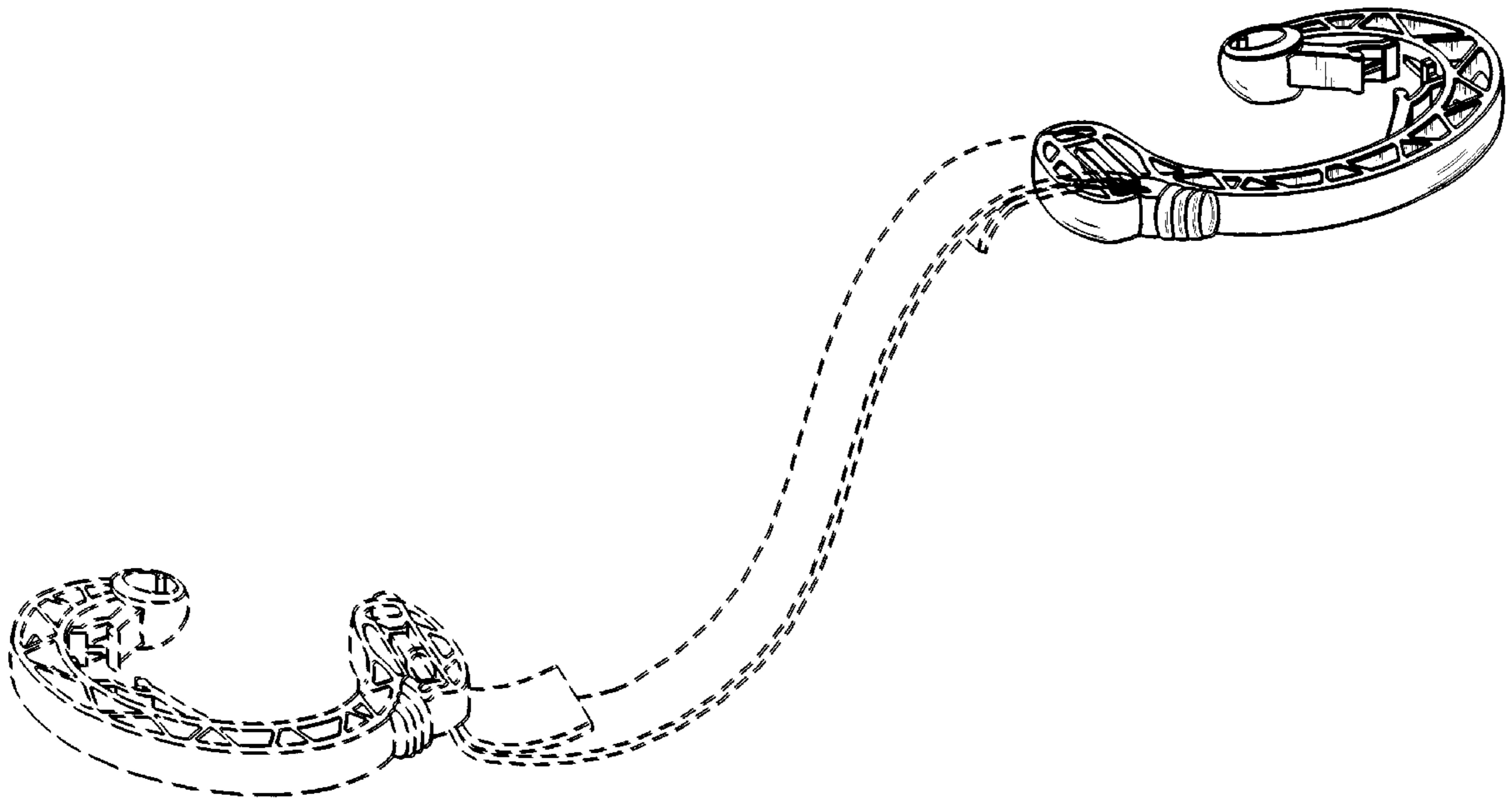
FIG. 5 is a back view of the embodiment of FIG. 1;

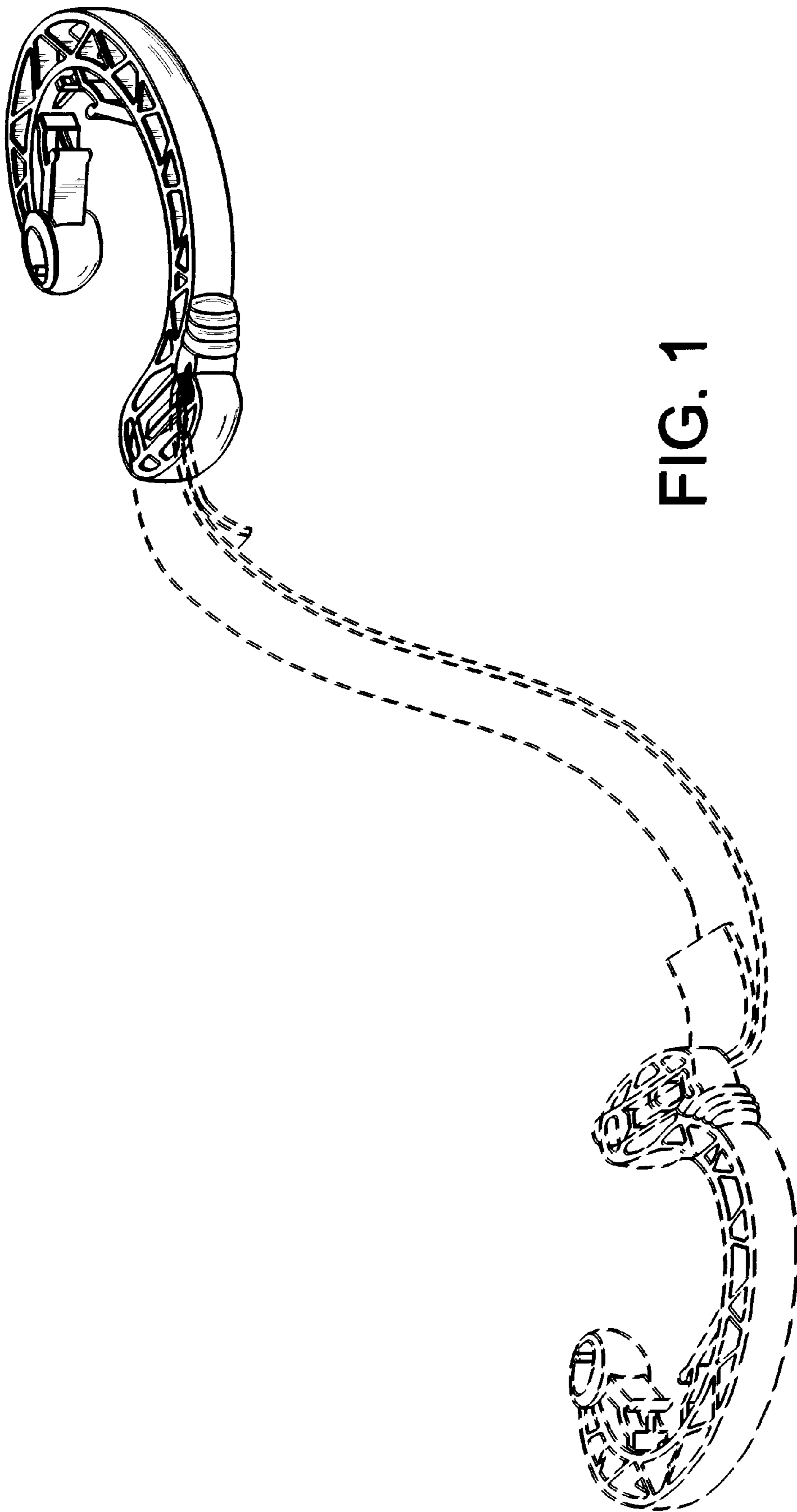

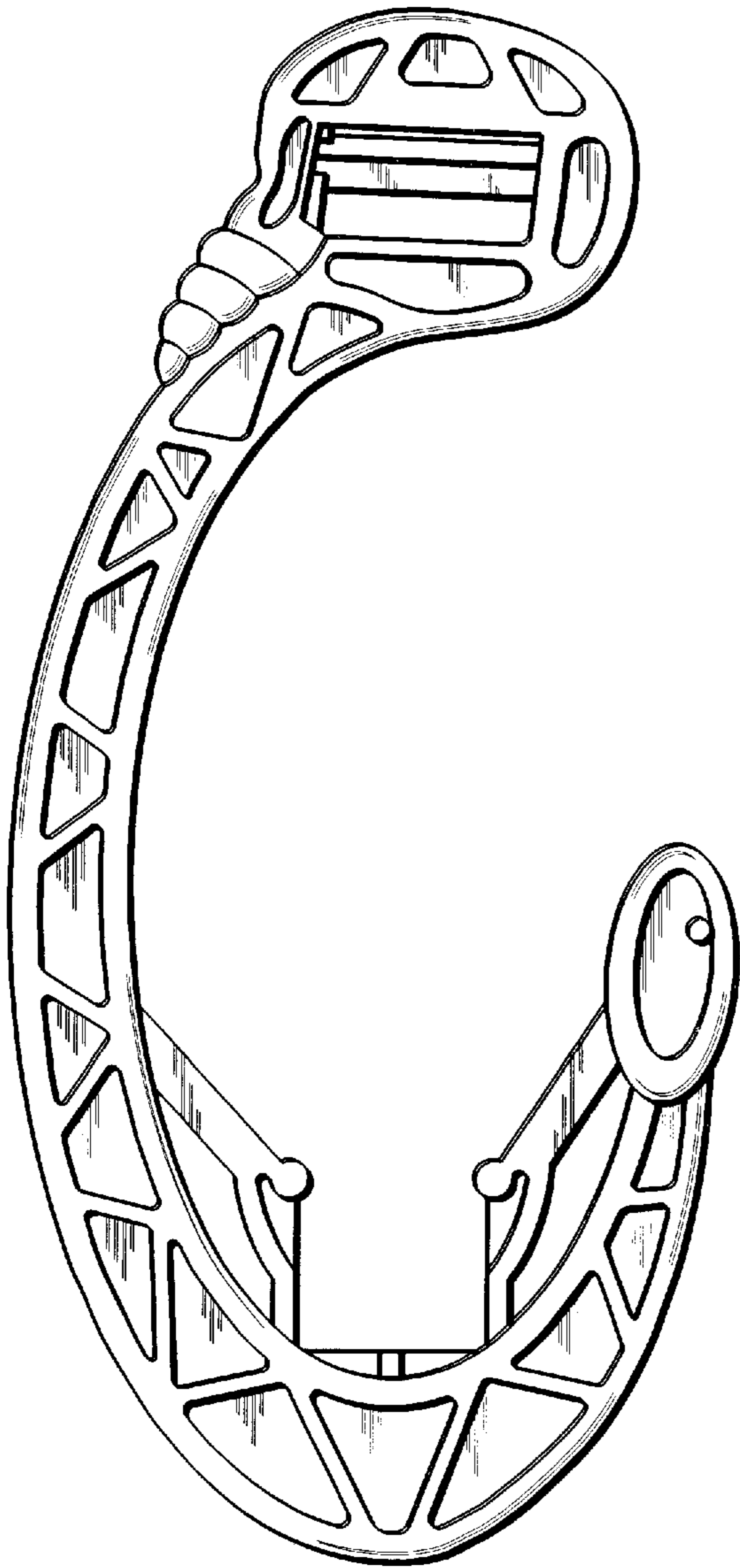

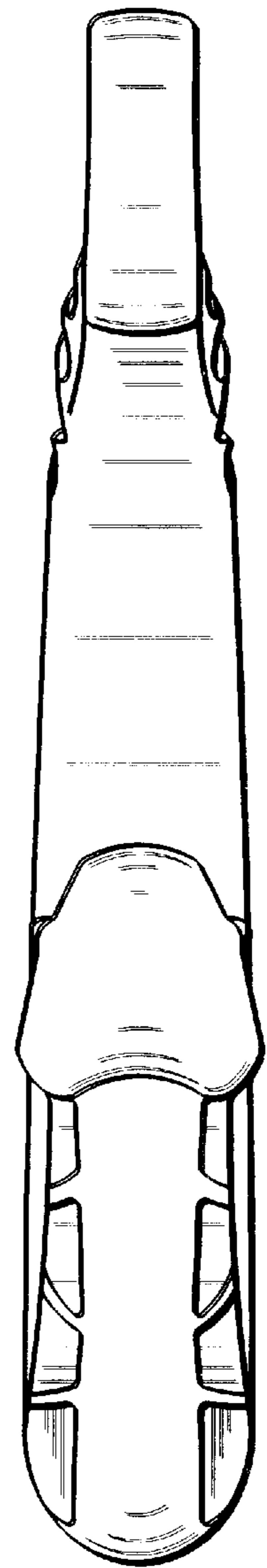

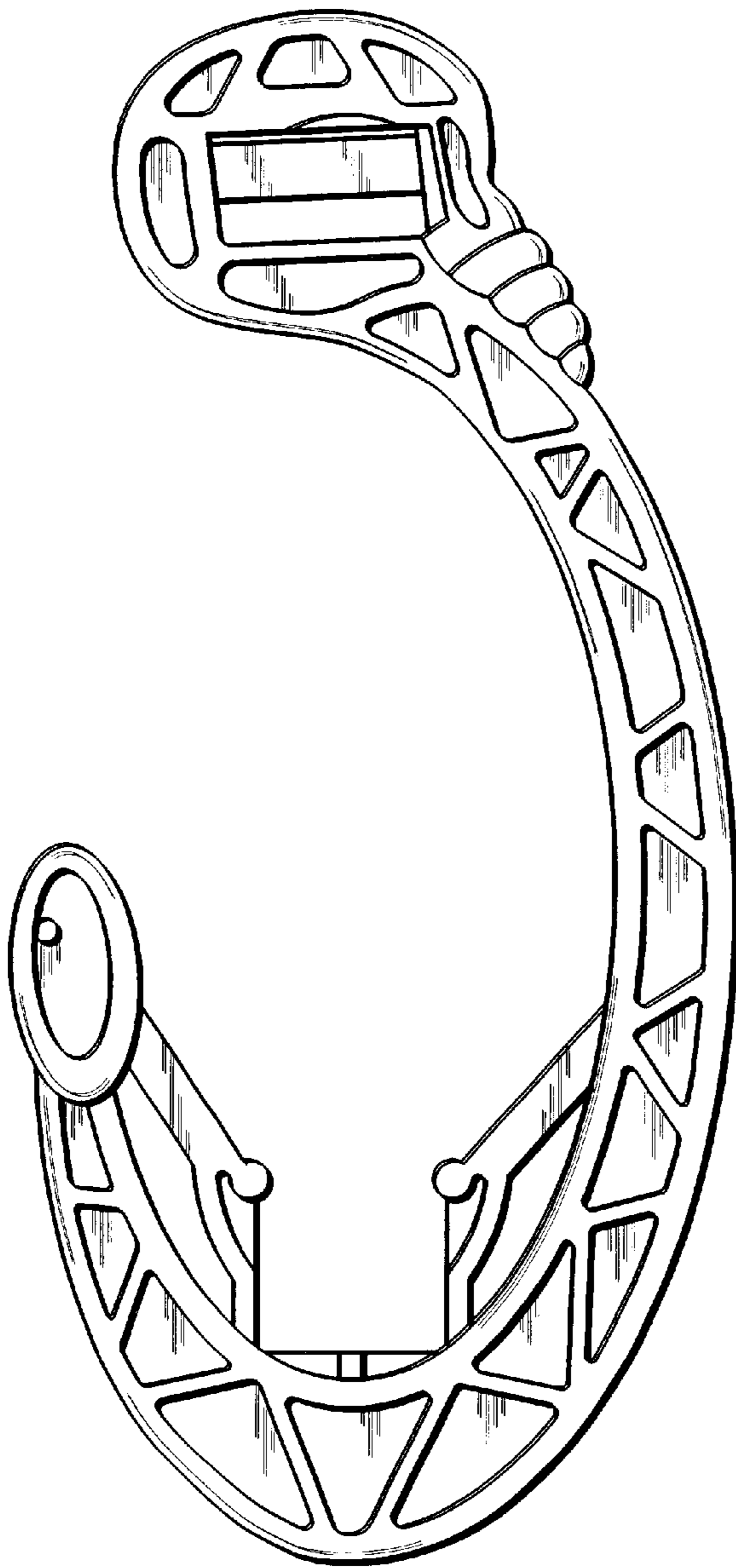

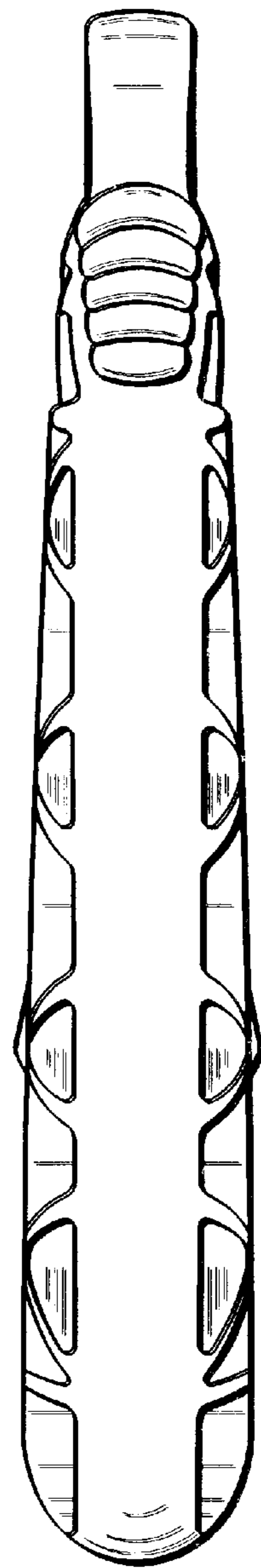
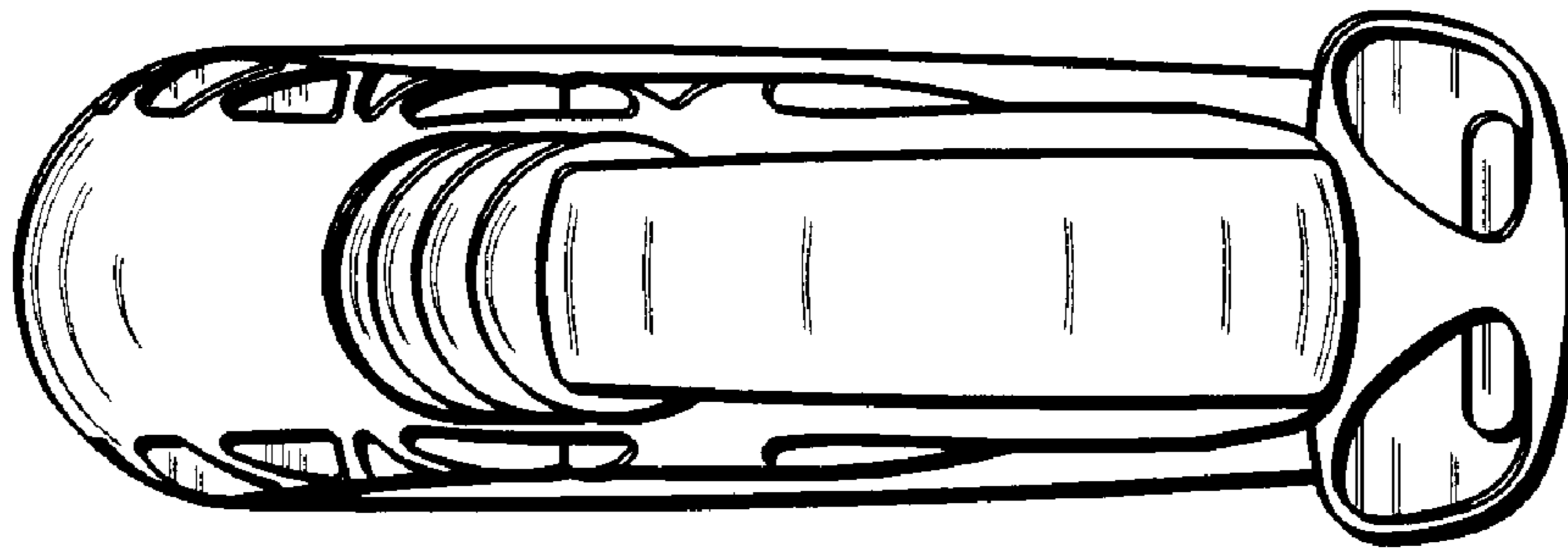
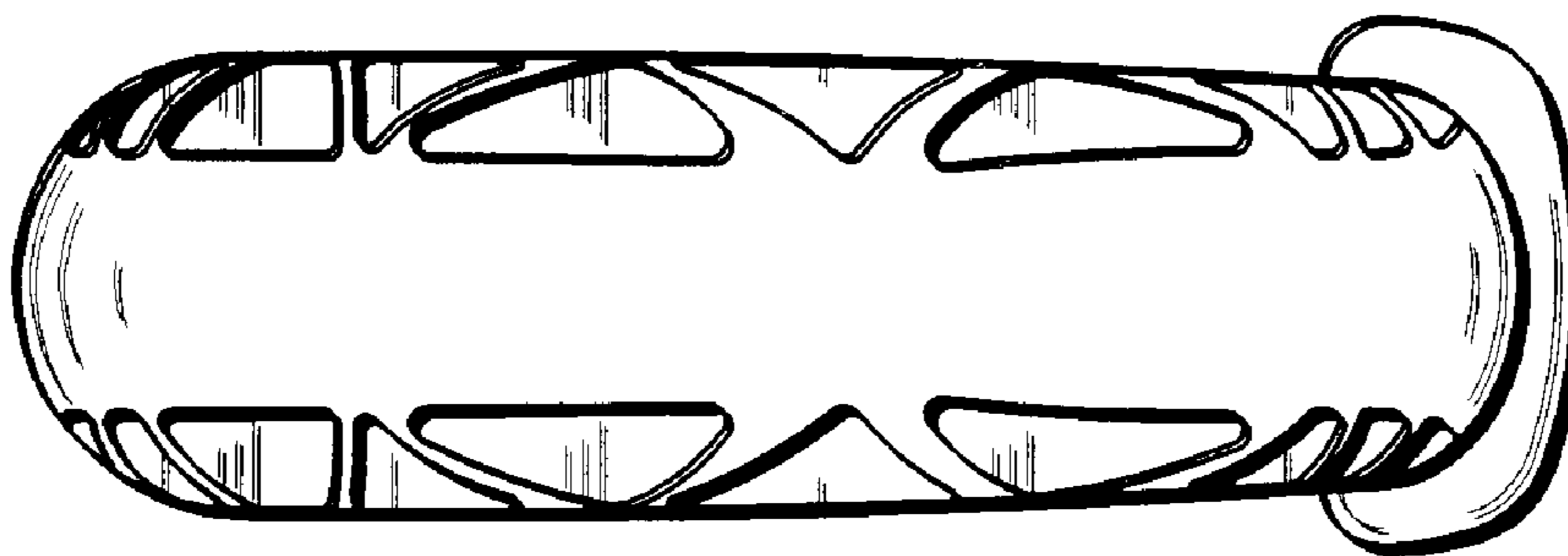
