(57) **CLAIM**

I claim a one piece assembly of containers with utensils, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container assembly showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 4 is an elevational view taken from either side thereof;

FIG. 5 is a elevational view taken from the front or rear thereof;

FIG. 6 is a perspective view showing an alternative embodiment of a container assembly according to my new design;

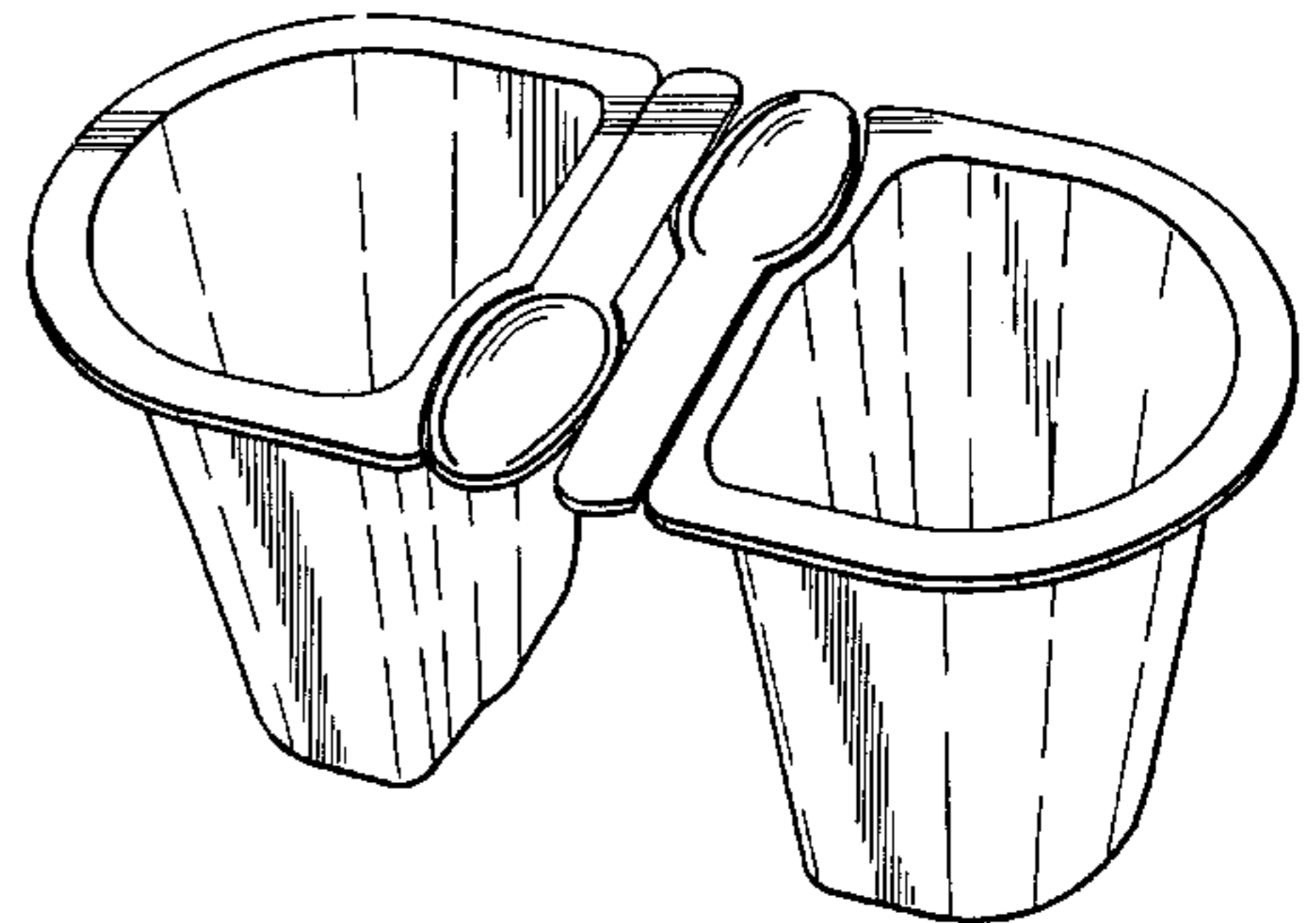
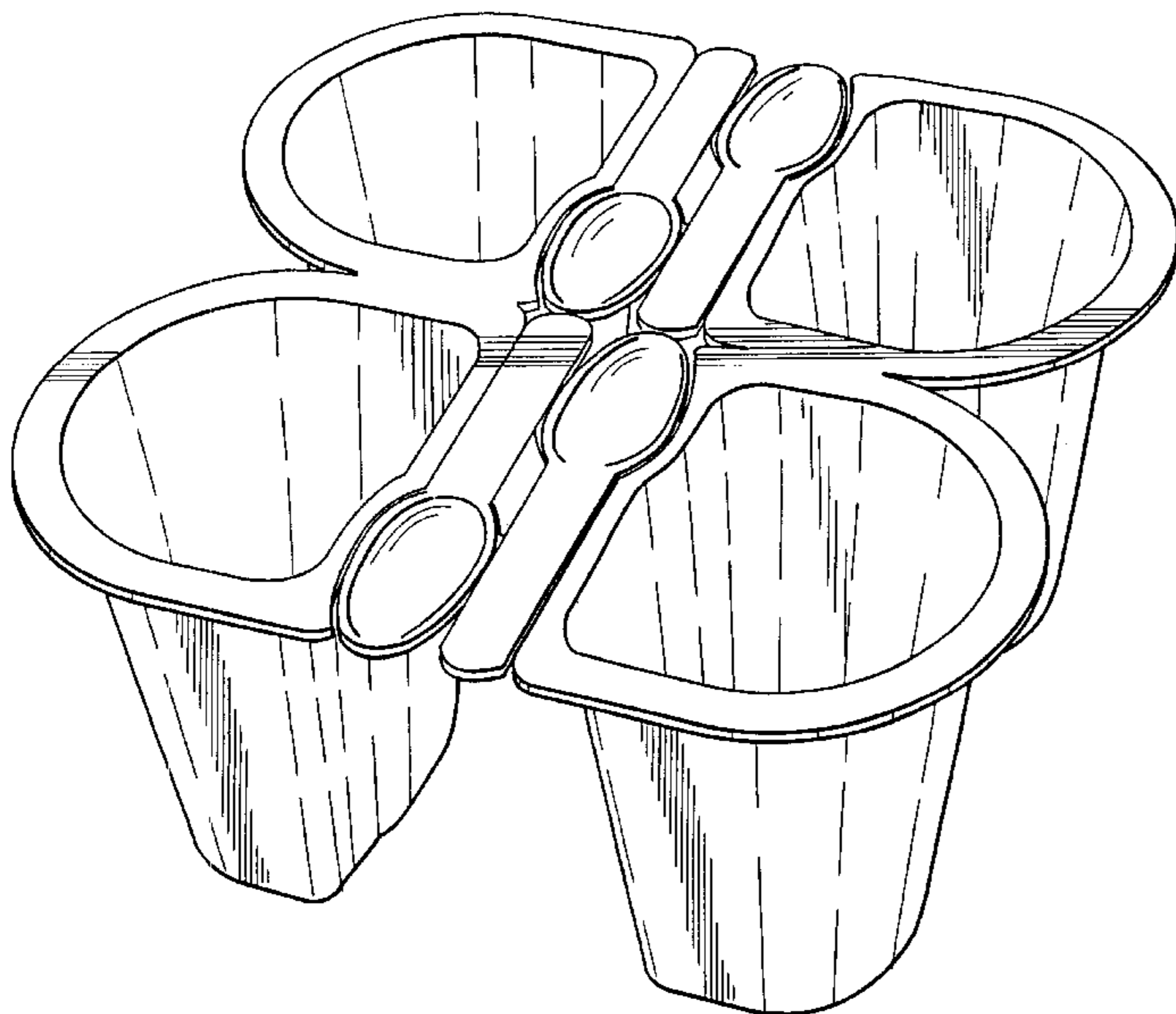
FIG. 7 is a top plan view thereof;

FIG. 8 is a bottom plan view thereof;

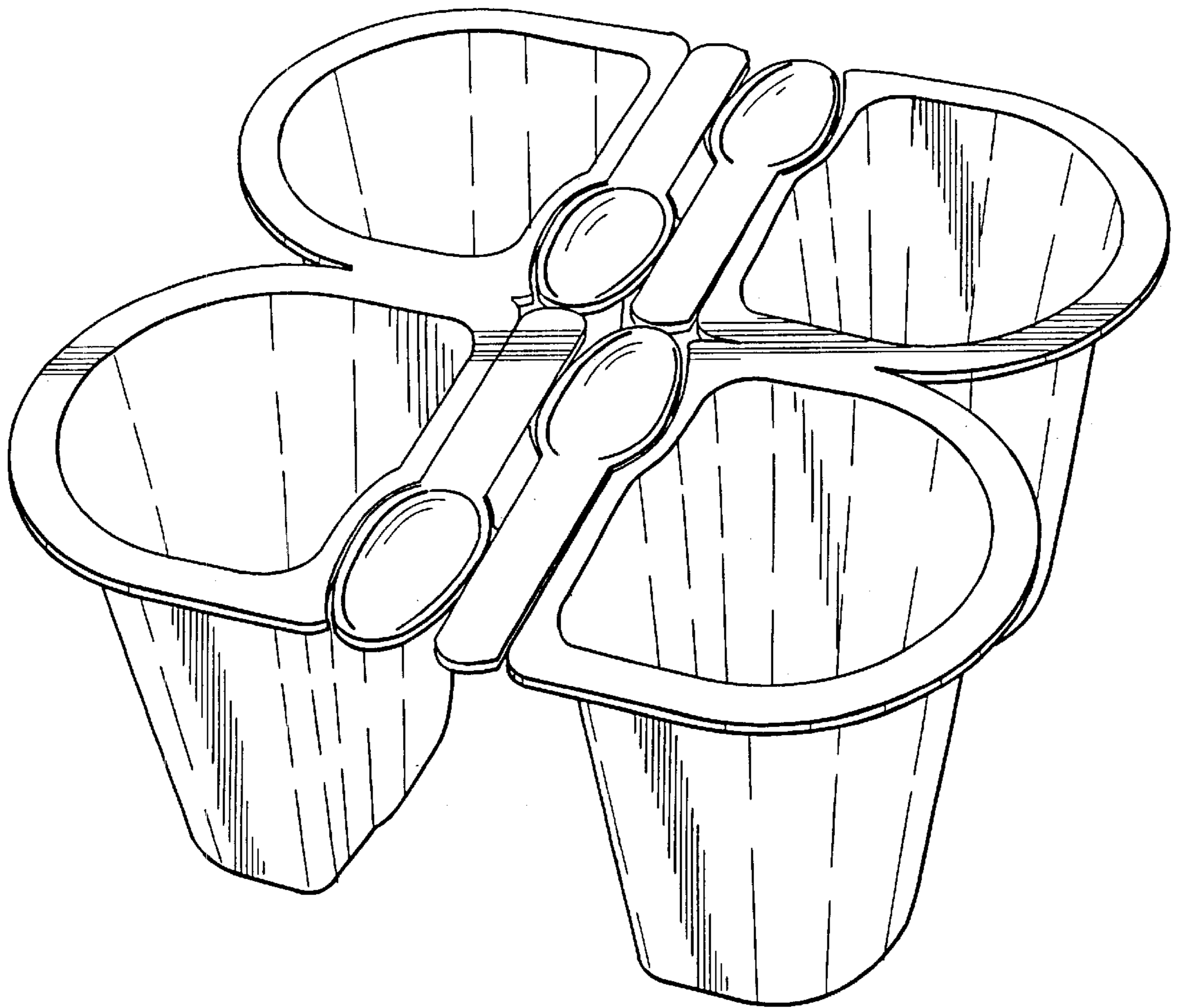
FIG. 9 is an elevational view taken from either end thereof; and,

FIG. 10 is an elevational view taken from the front or rear thereof.

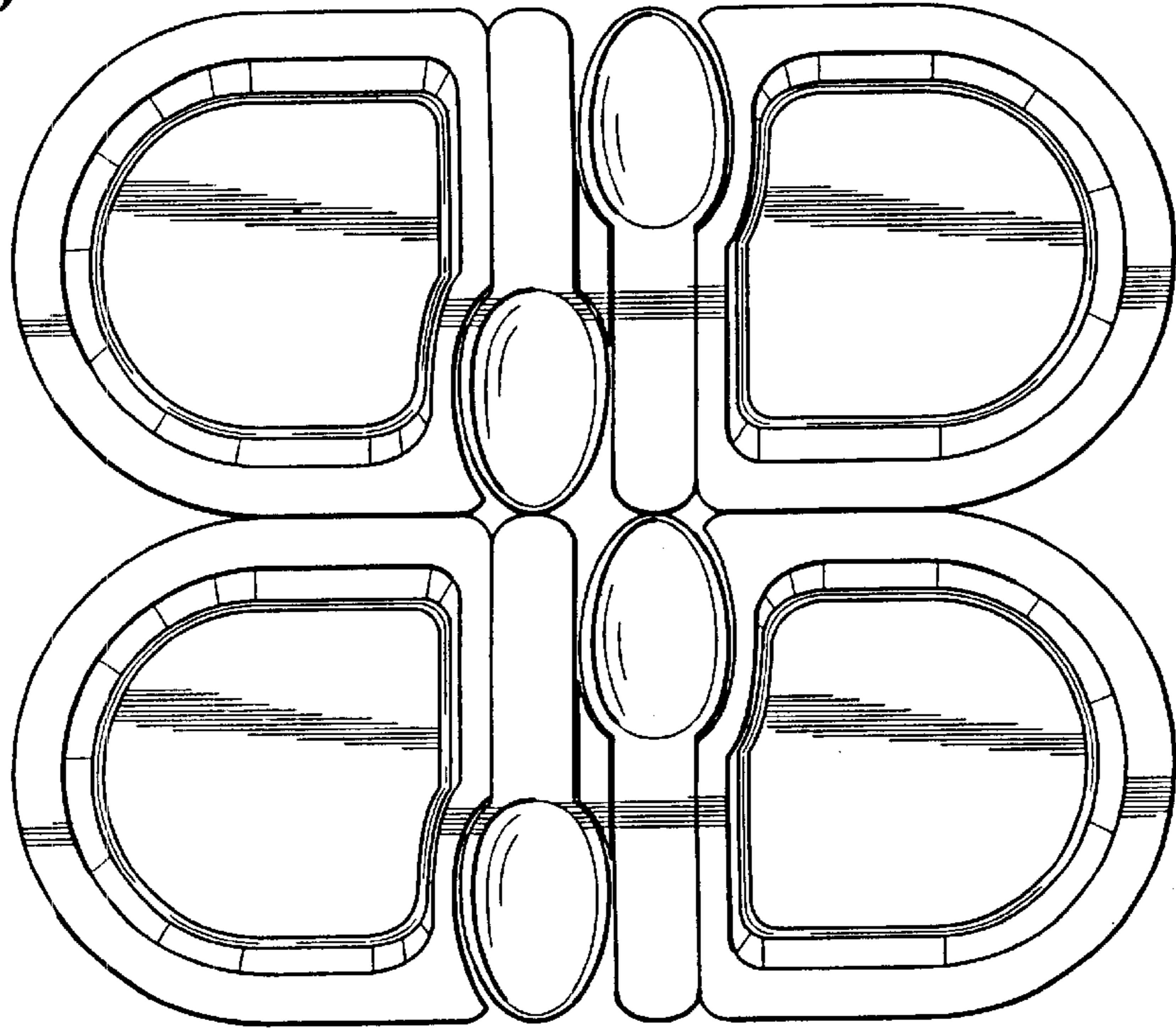

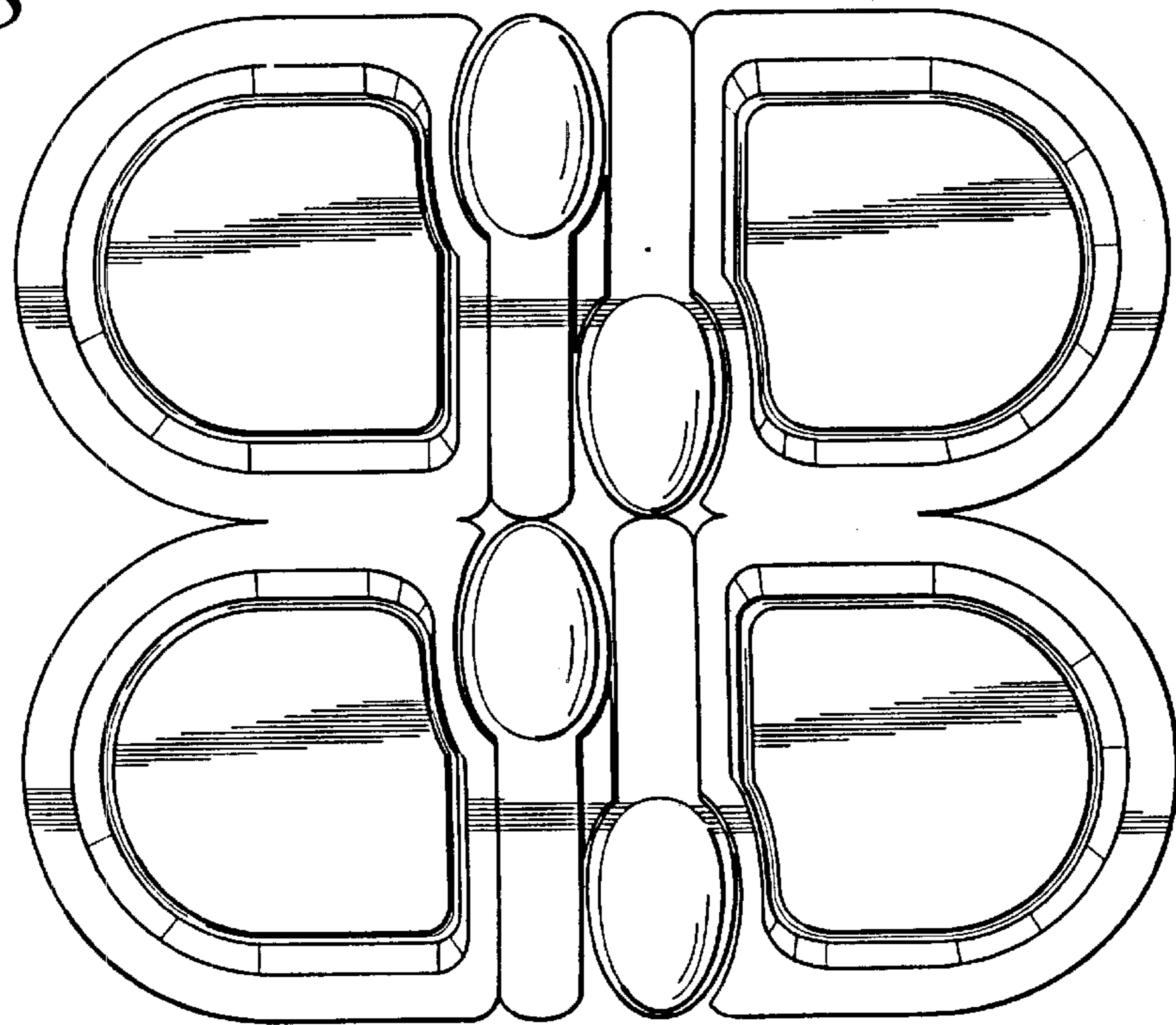

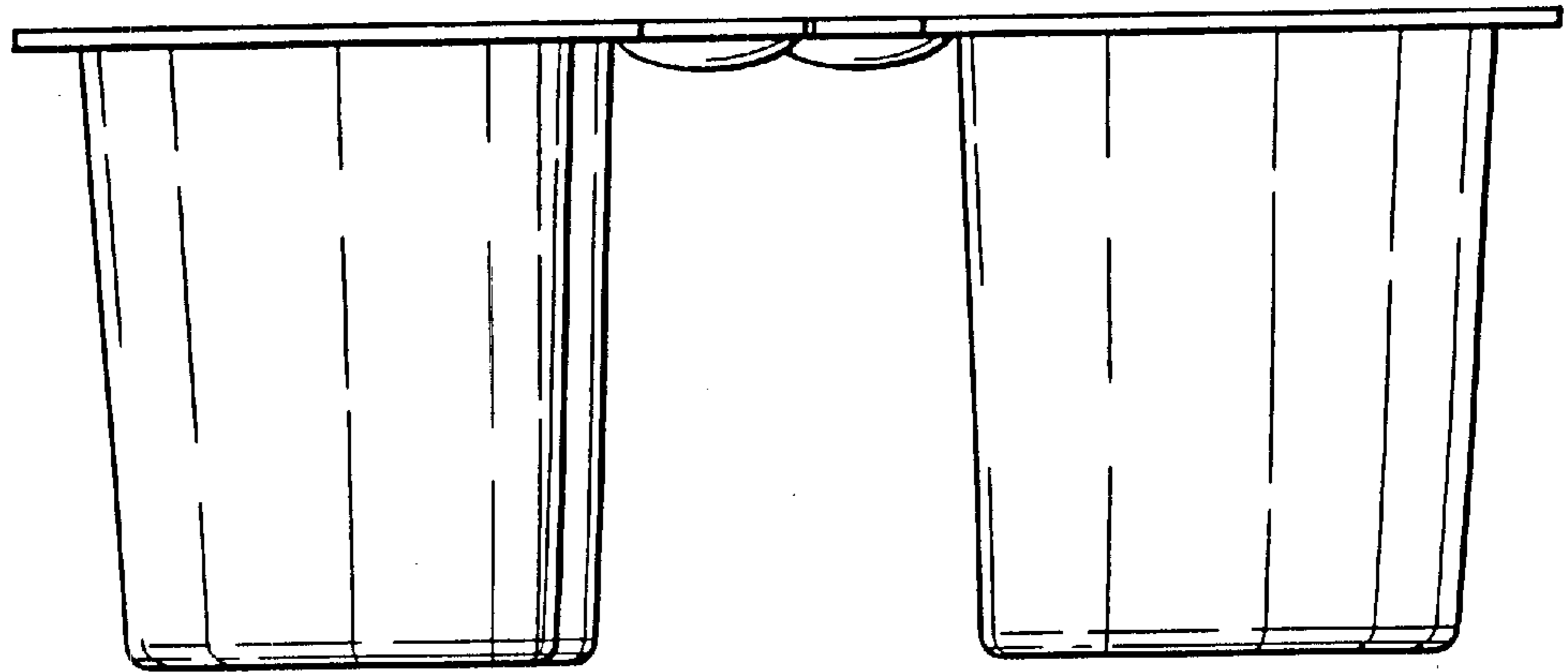

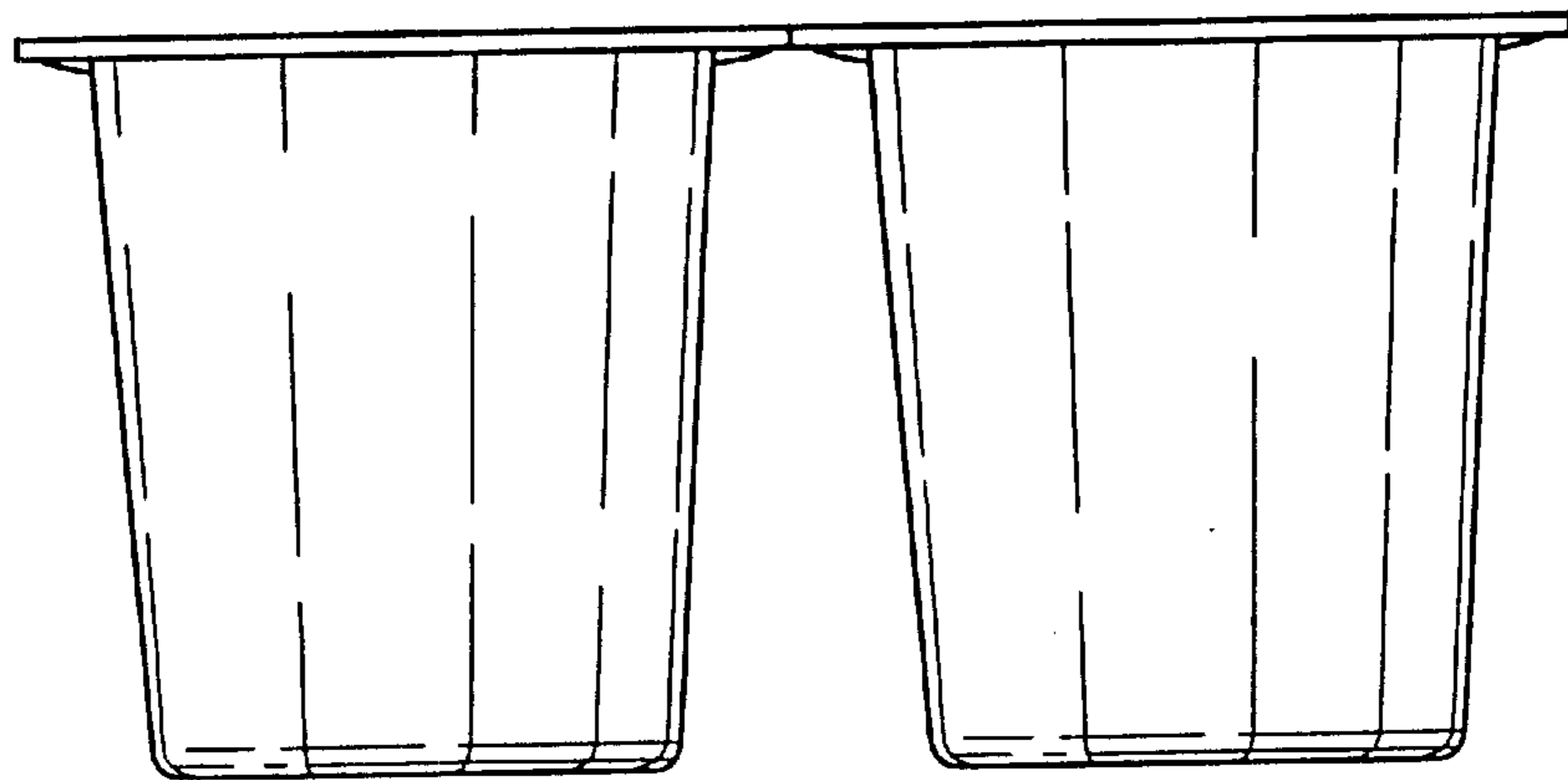

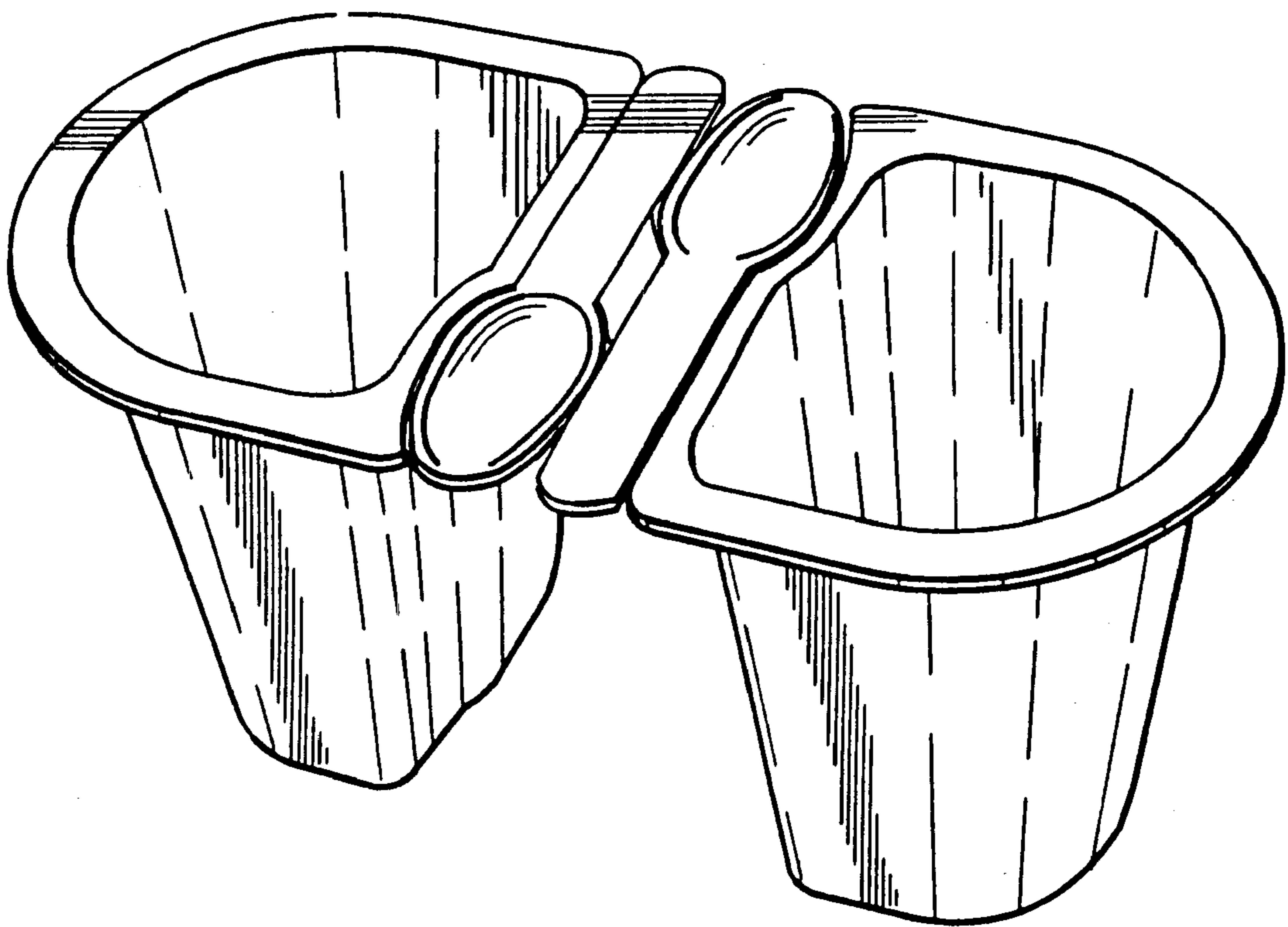

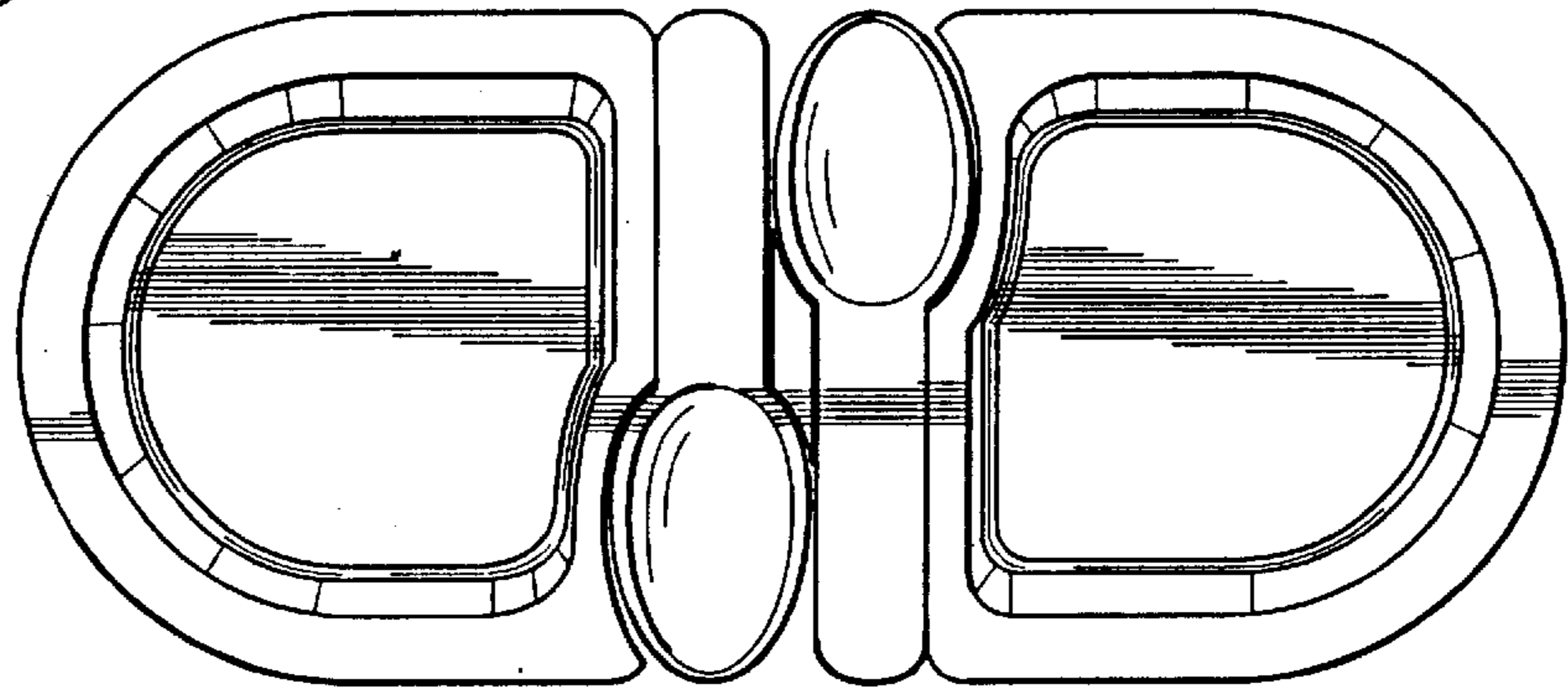

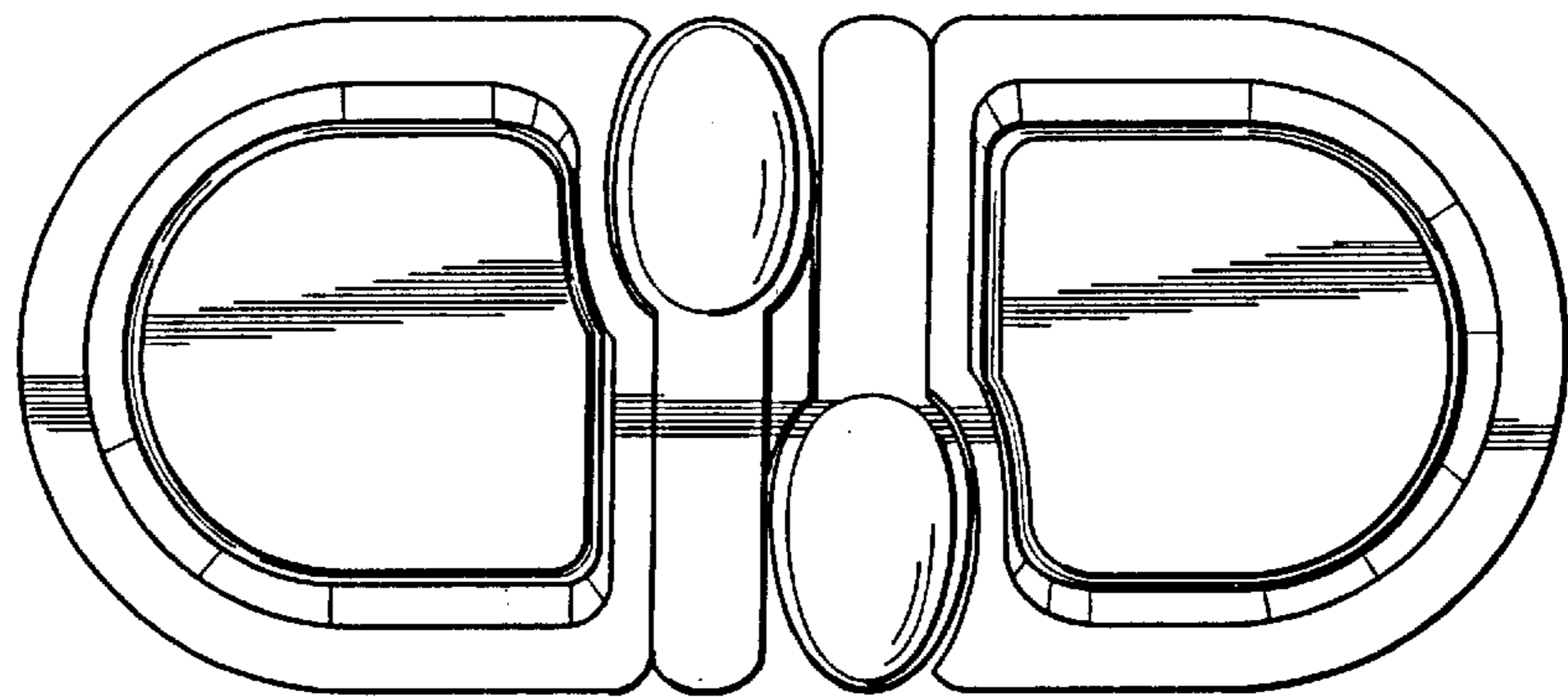

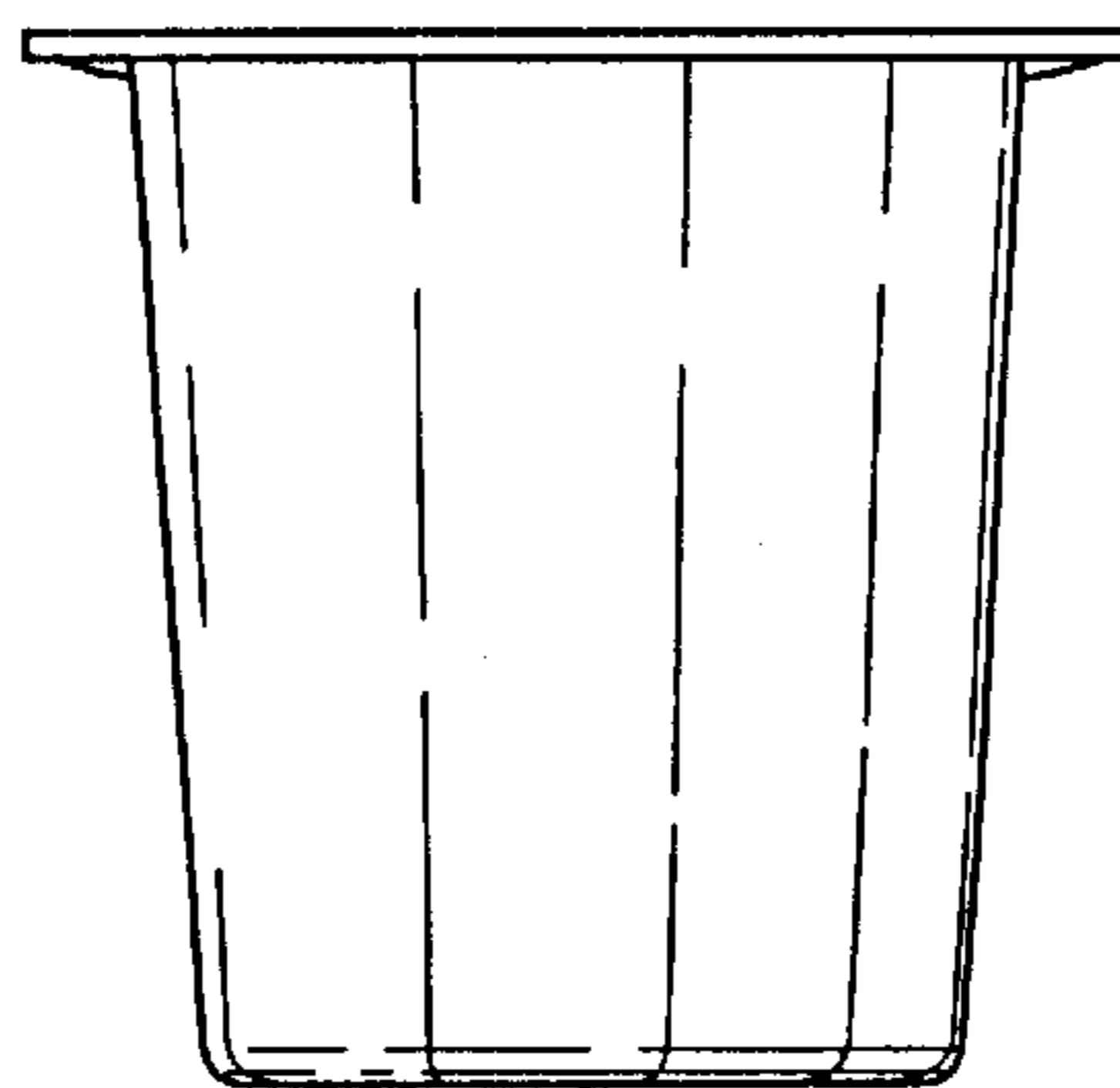
