FIG. 3 is an exploded rear view of a bowl of the present invention;

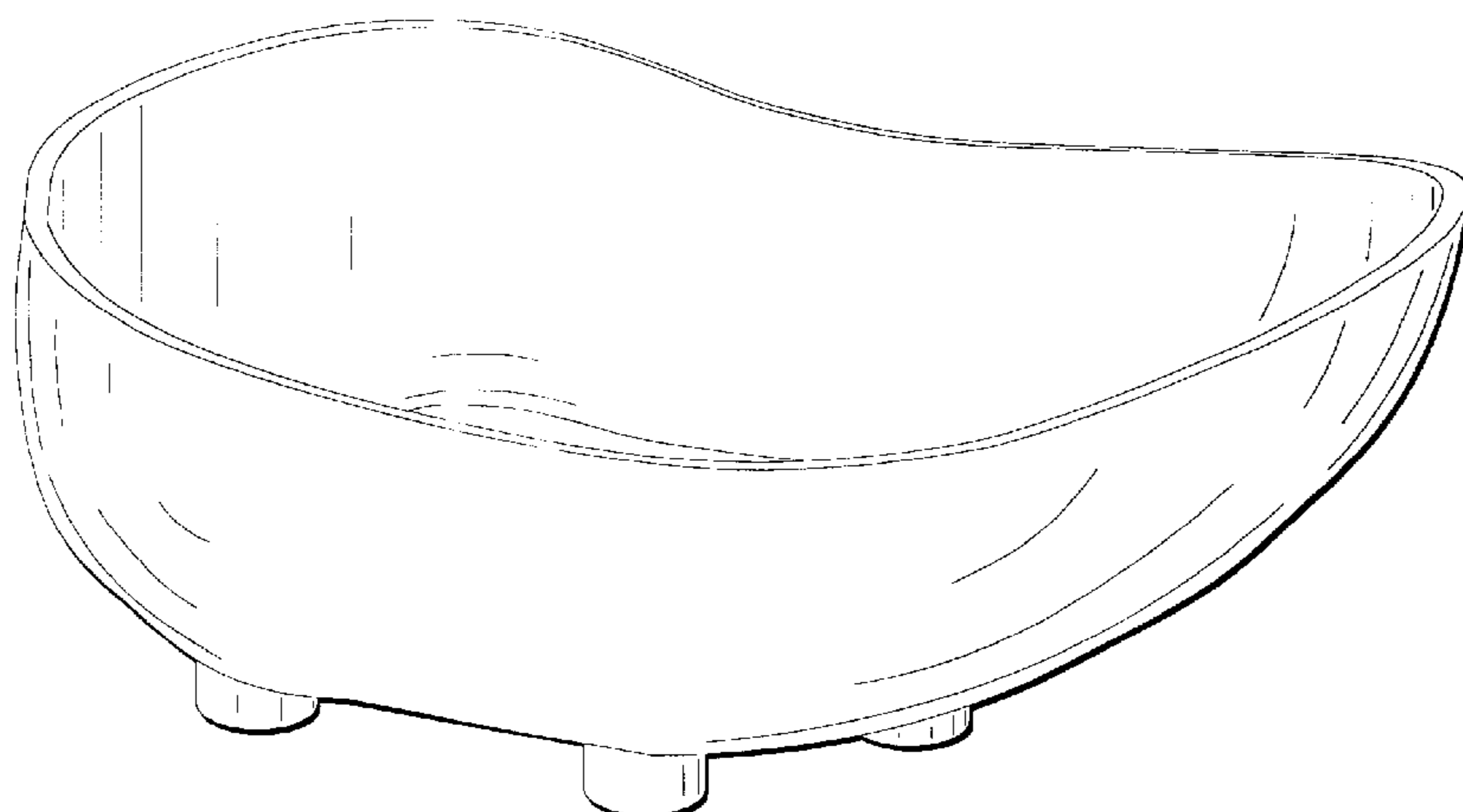
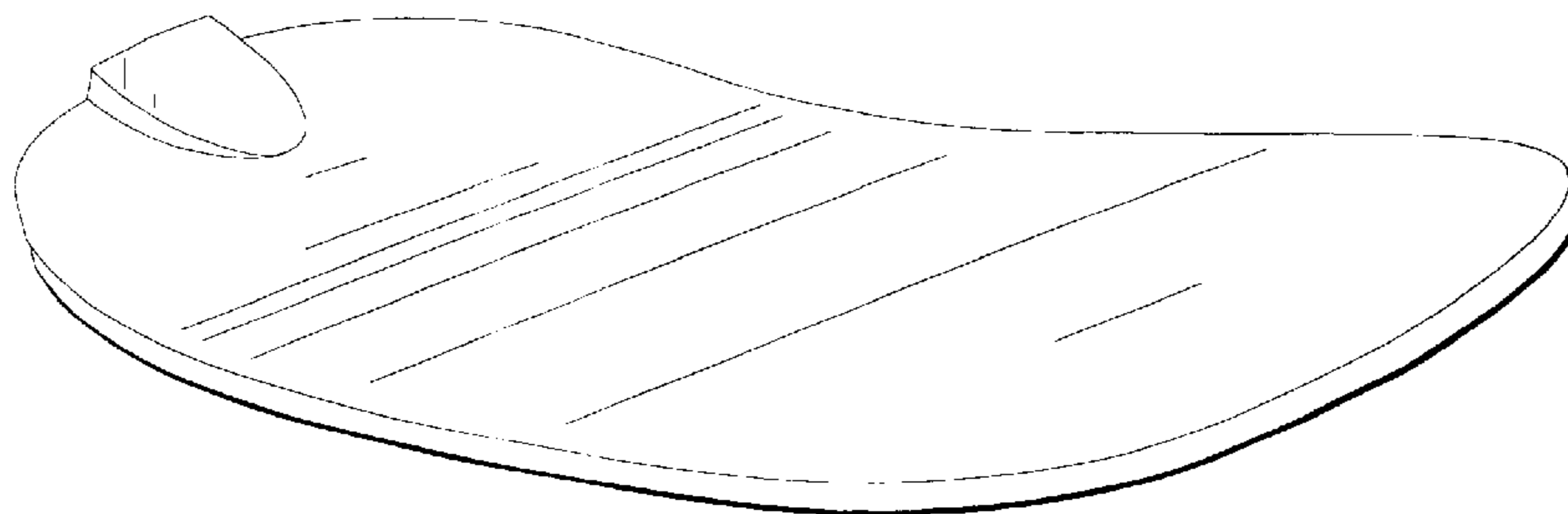
FIG. 4 is an exploded front view of a bowl of the present invention;

FIG. 5 is an exploded top plan view of a bowl of the present invention; and,

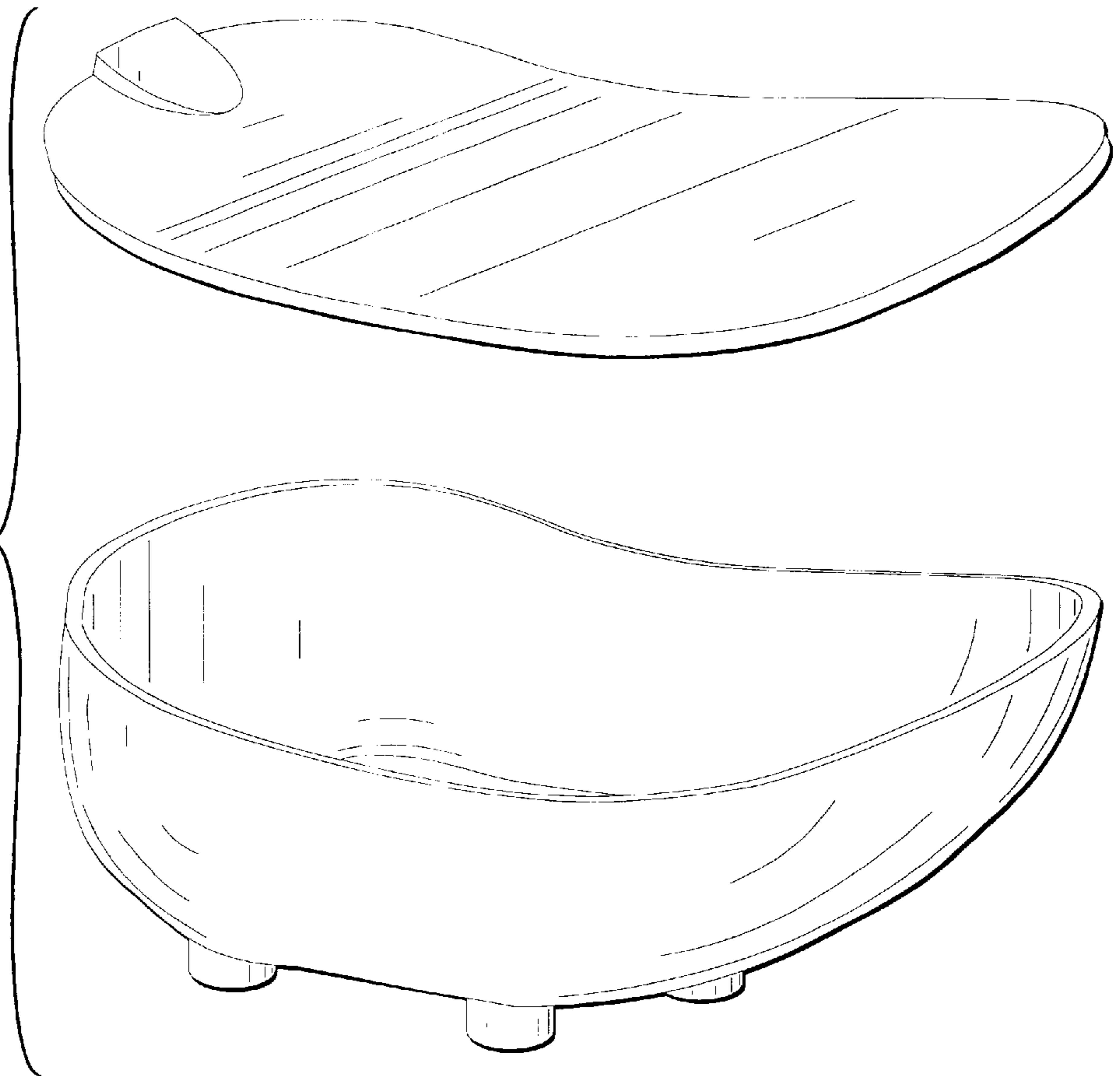
FIG. 6 is an exploded bottom plan view of a bowl of the present invention.

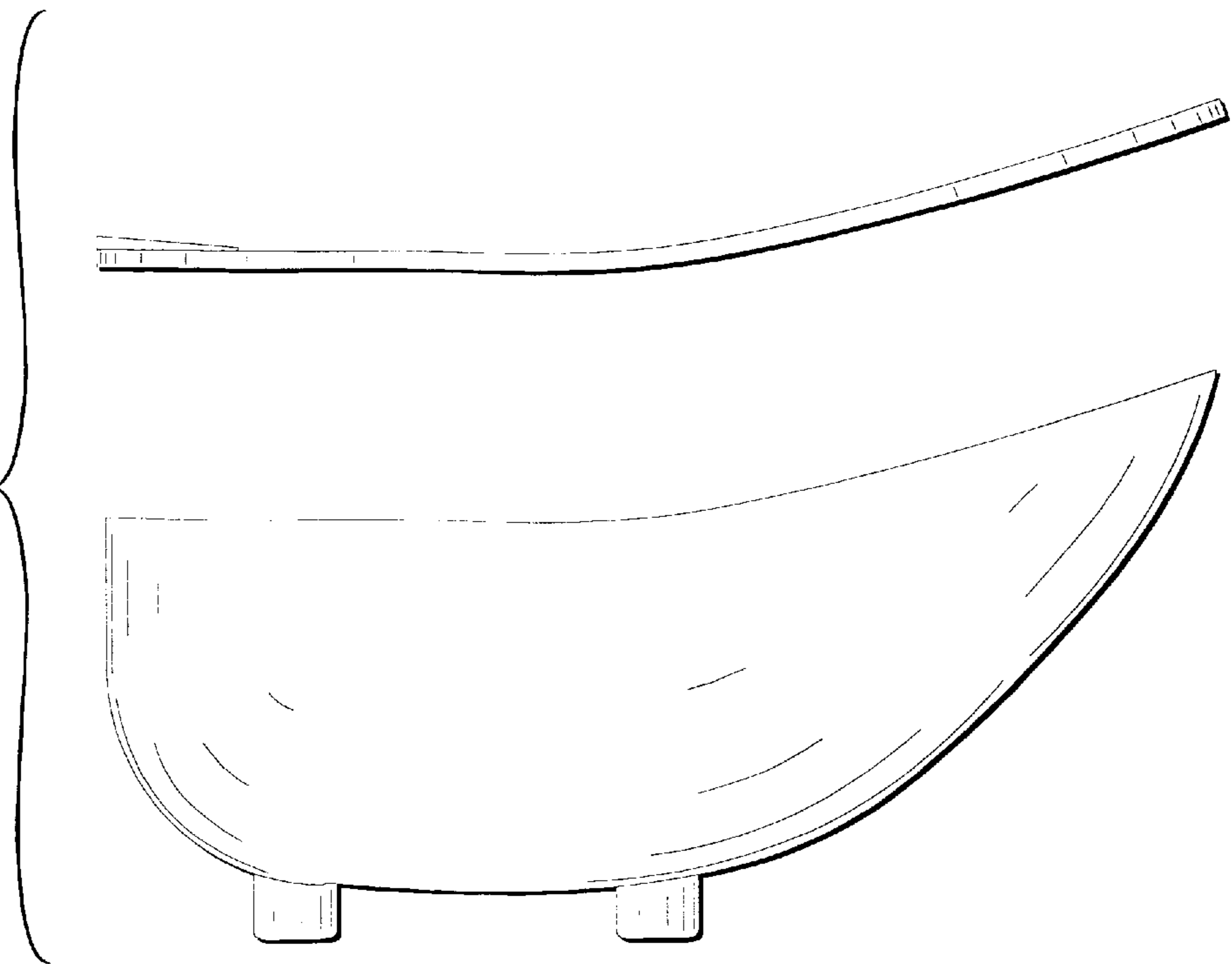

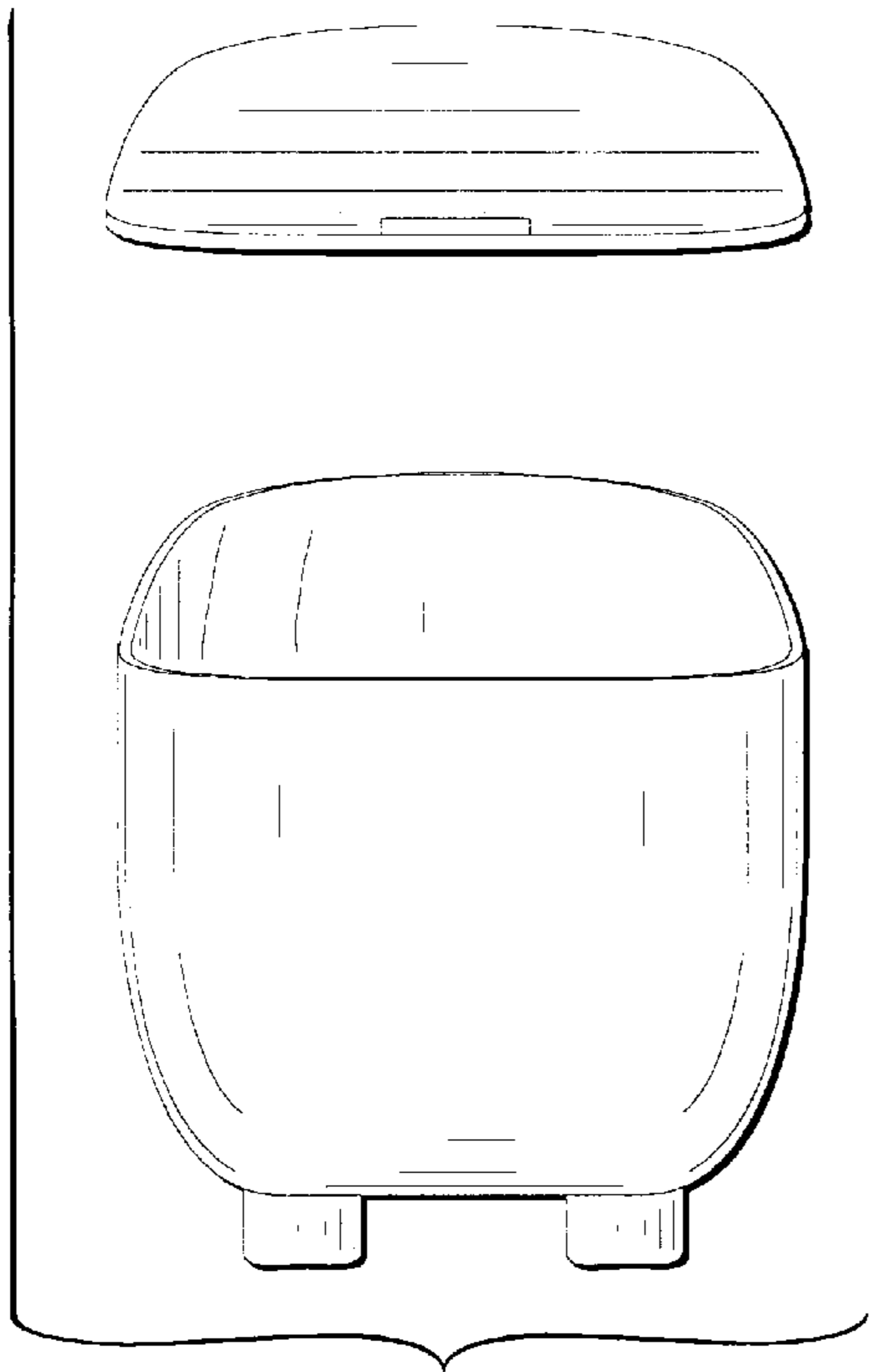

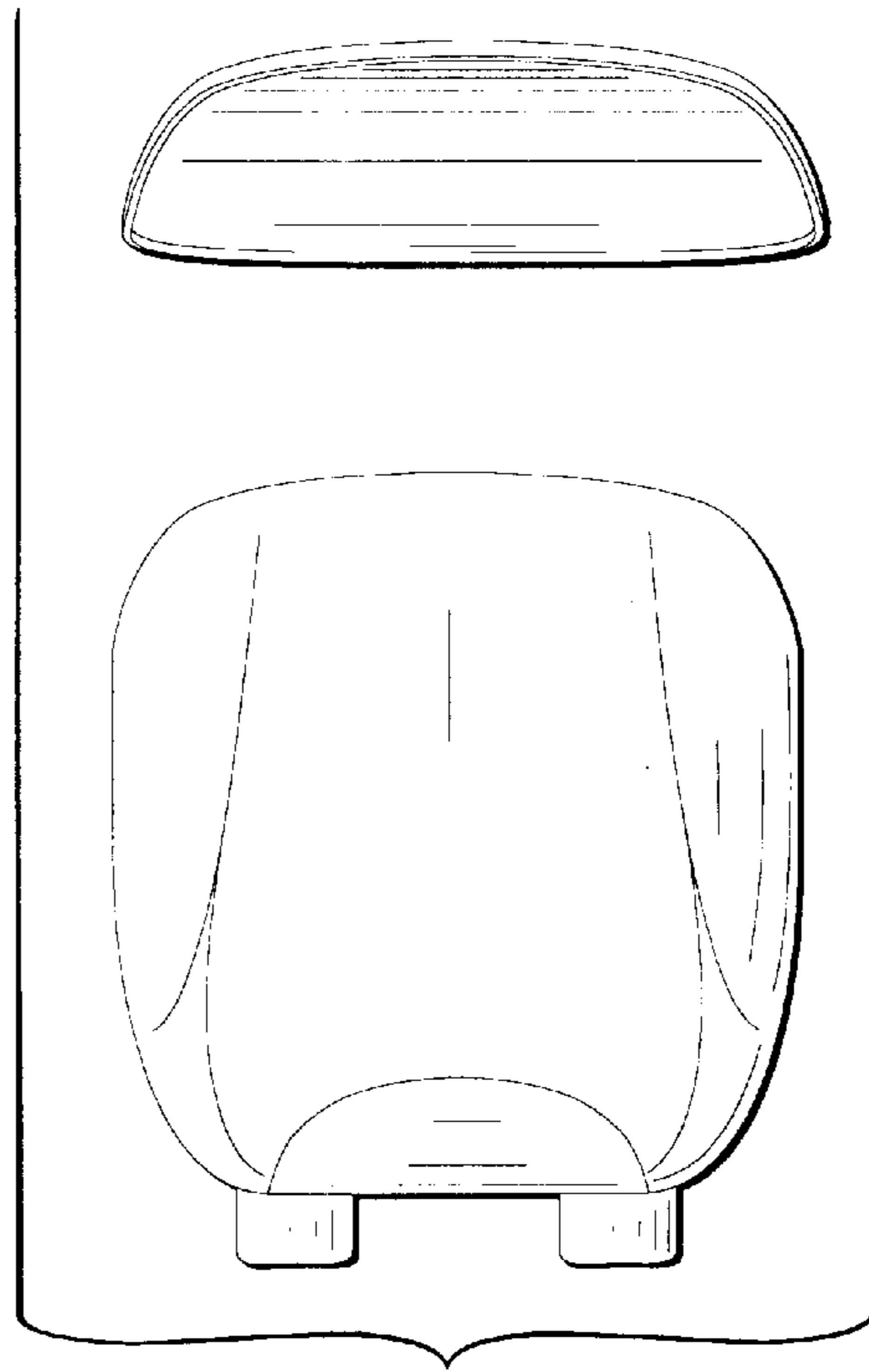

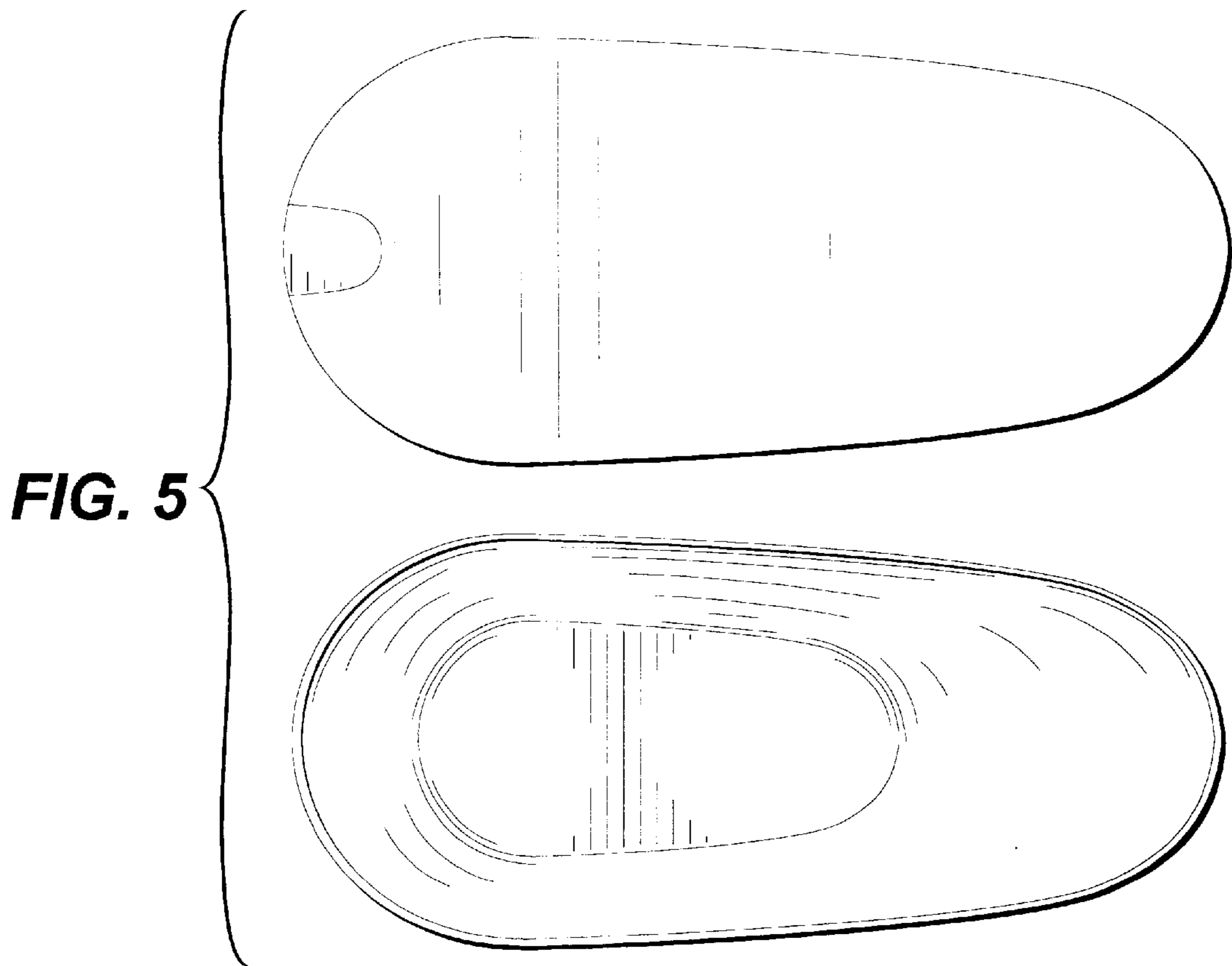
