FIG. 1 shows a front perspective view from above and one side.

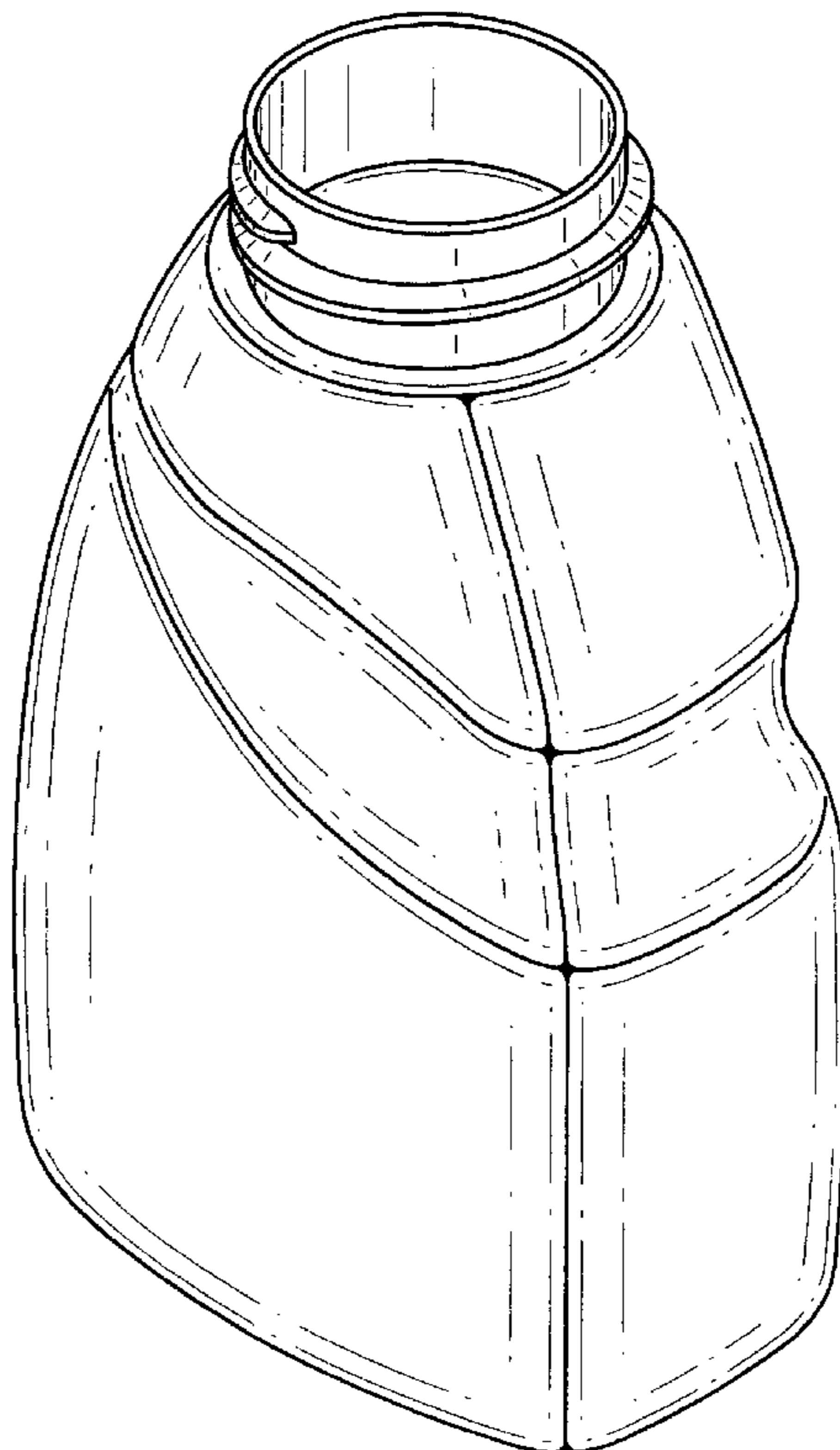
FIG. 2 shows a rear view.

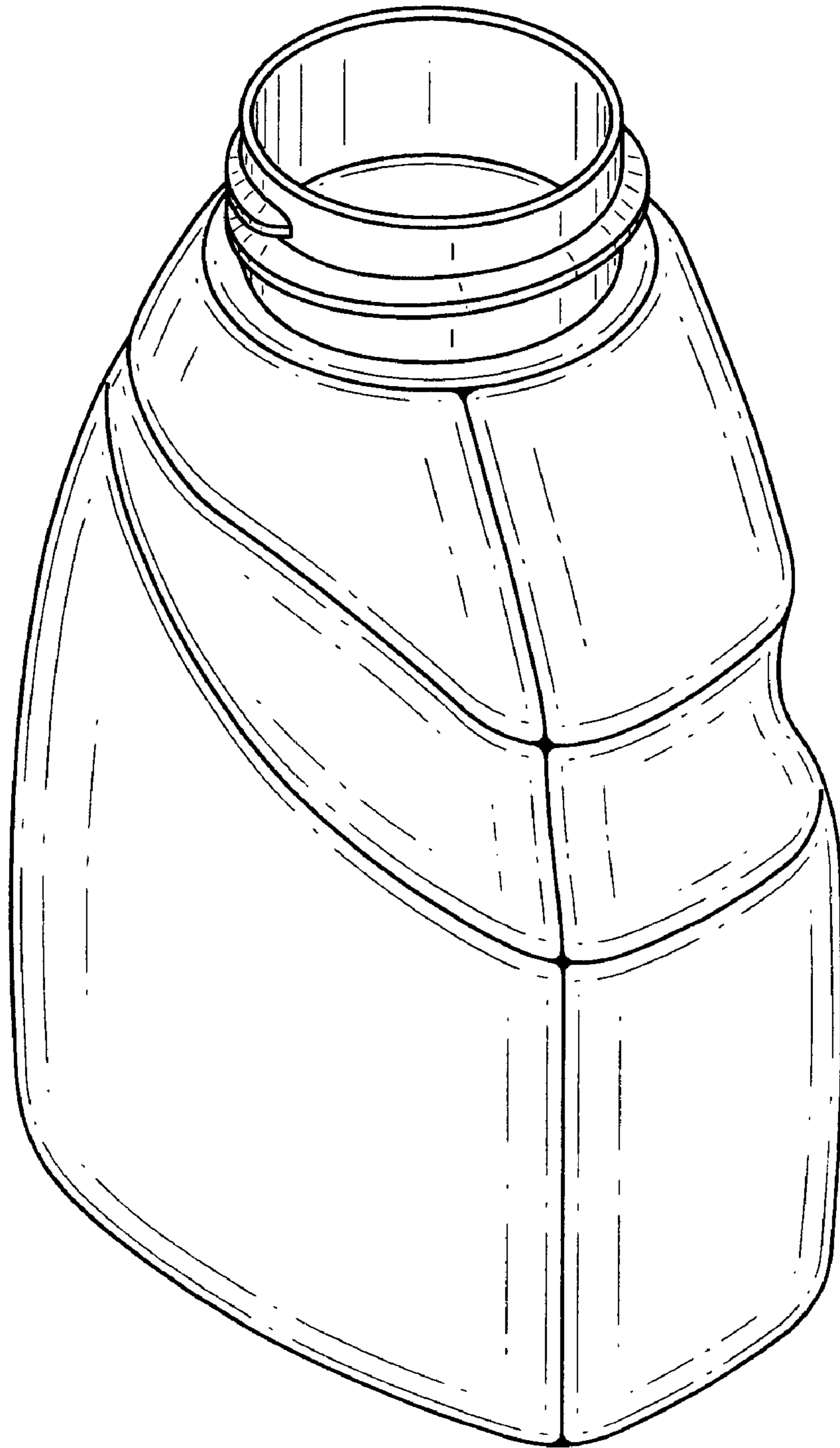

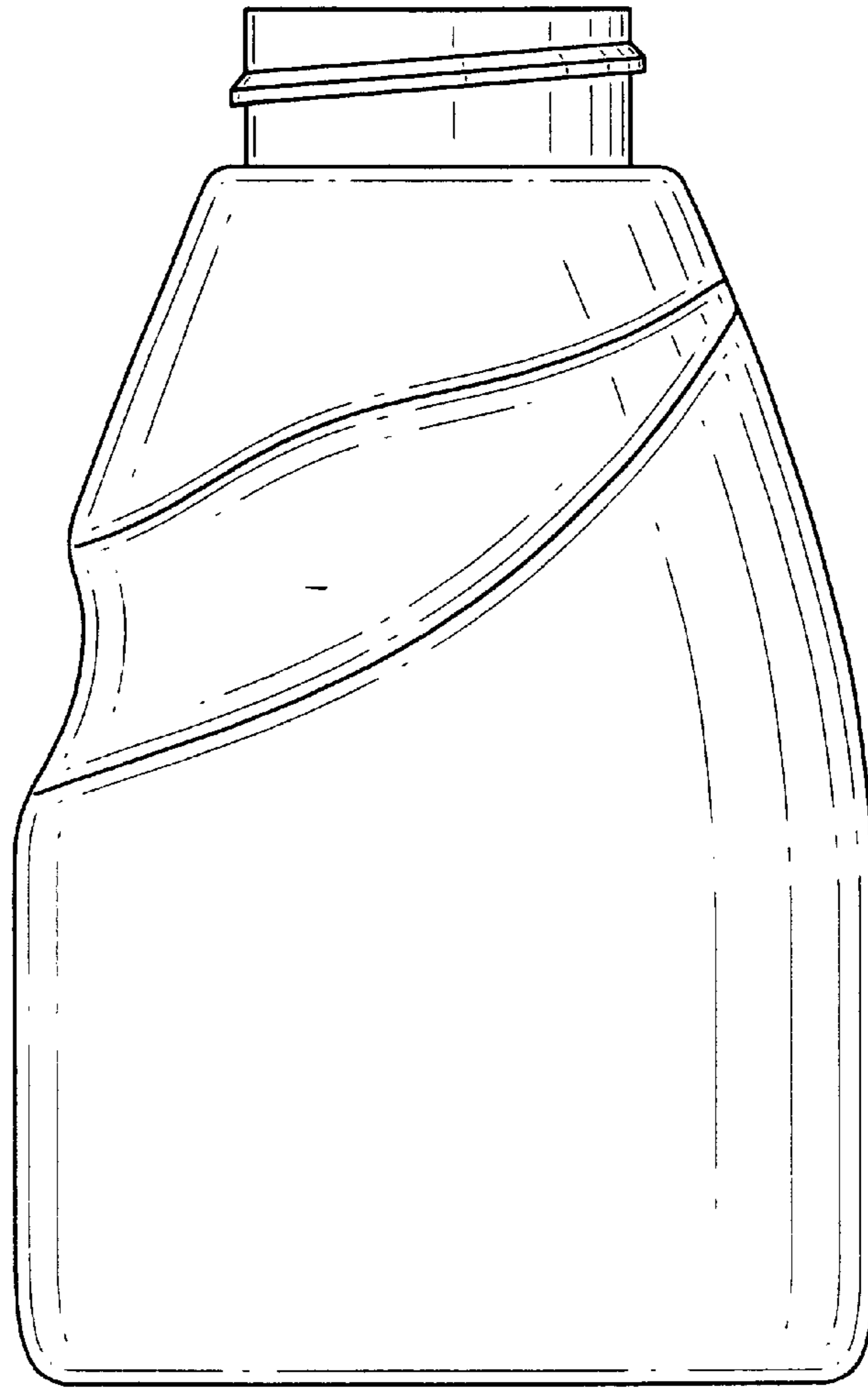
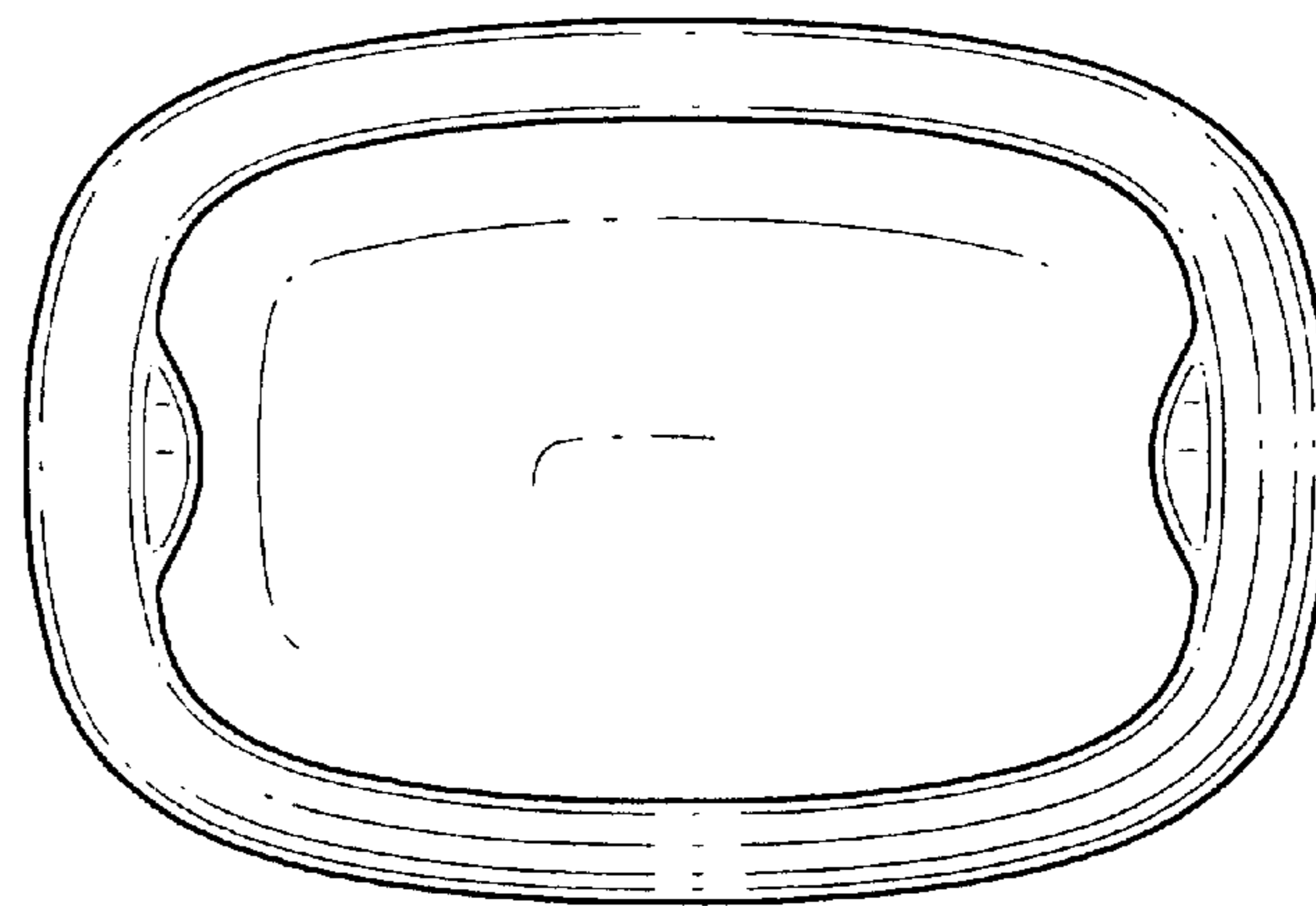

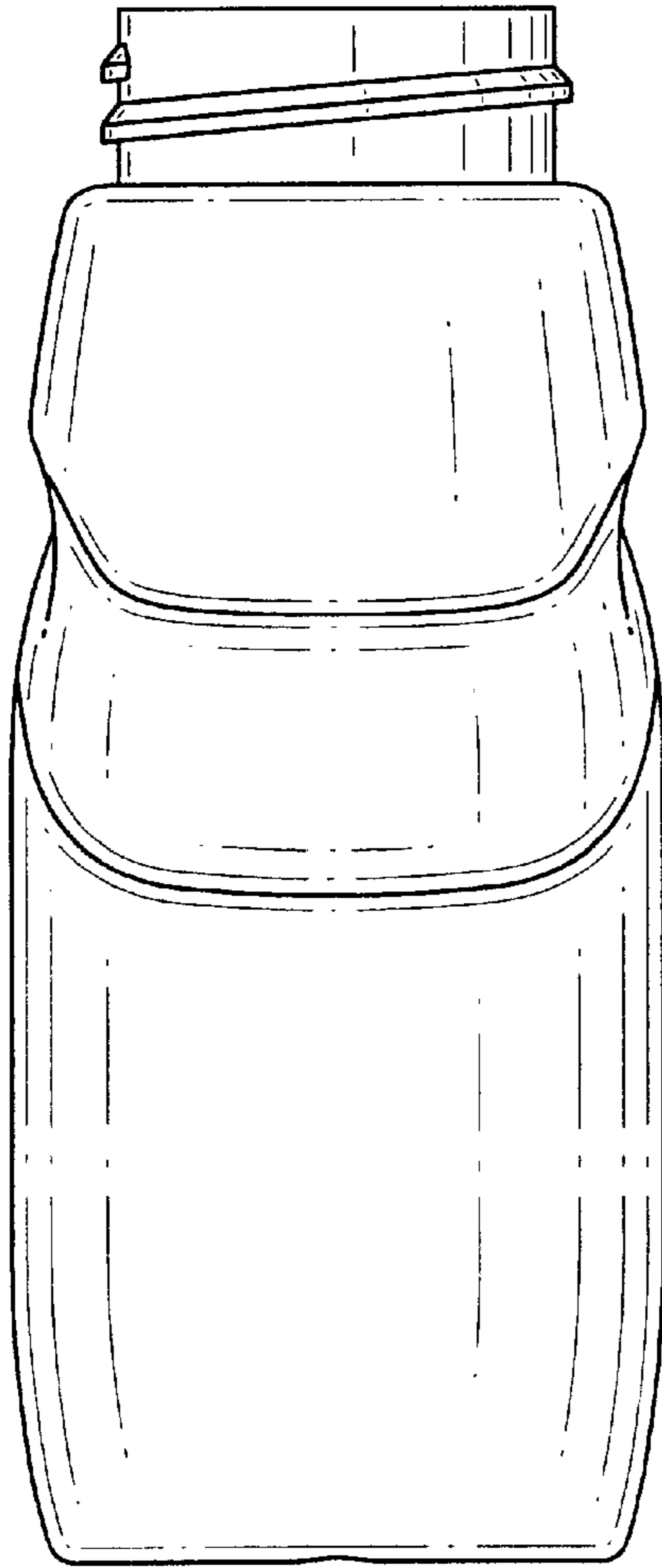

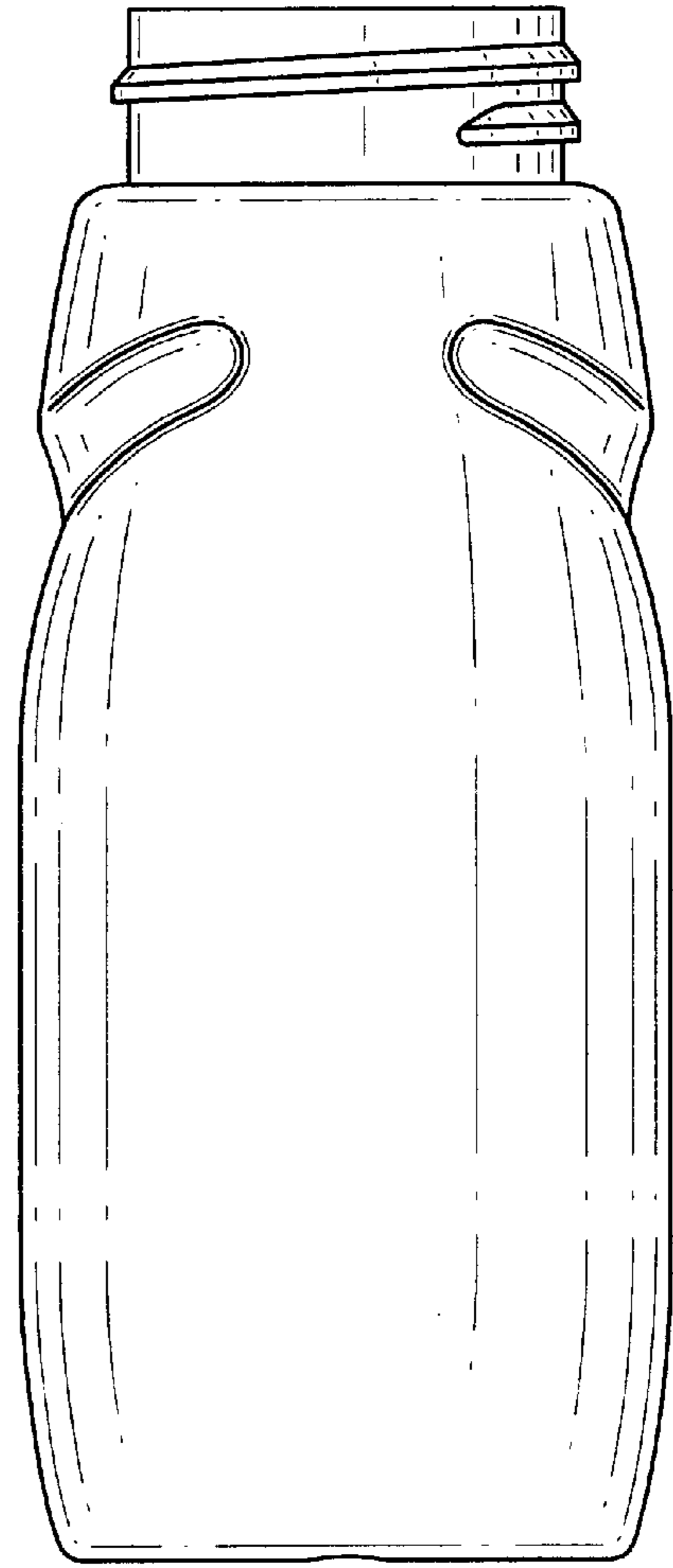
