FIG. 8 is a left side view thereof with the antenna in an open position;

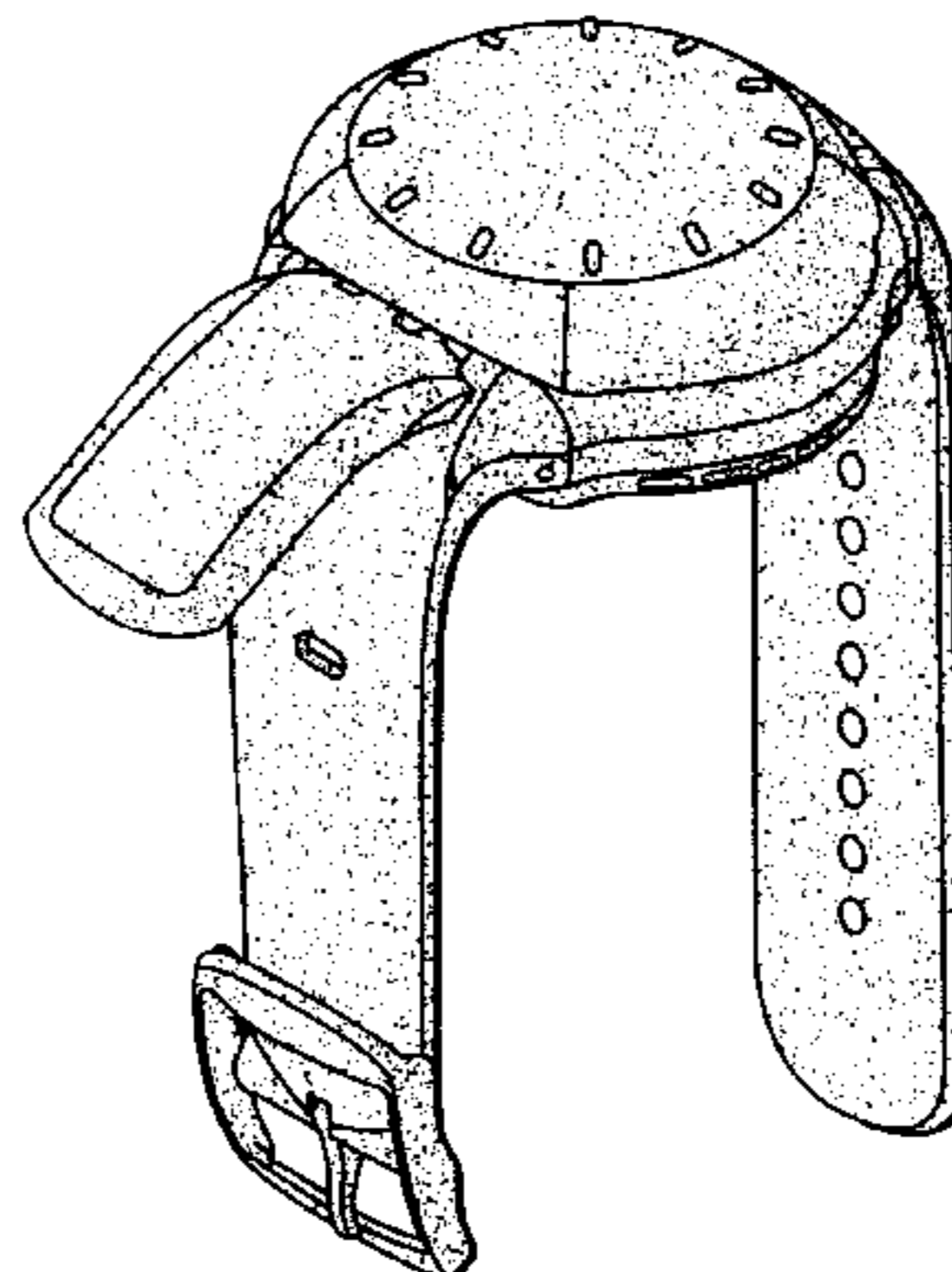
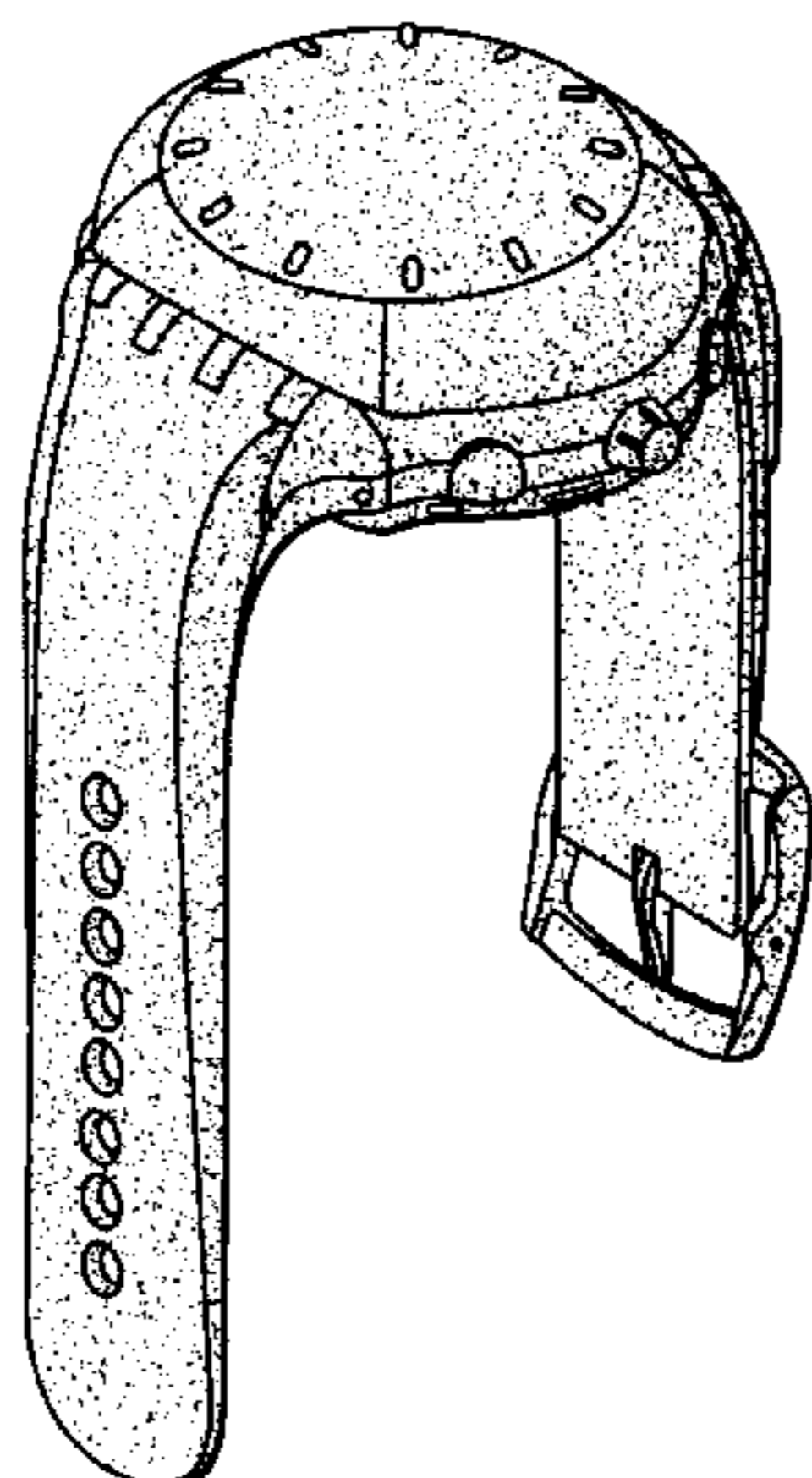
FIG. 9 is a right side view thereof with the antenna in an open position;

FIG. 13 is a right perspective view thereof with the antenna in an open position.



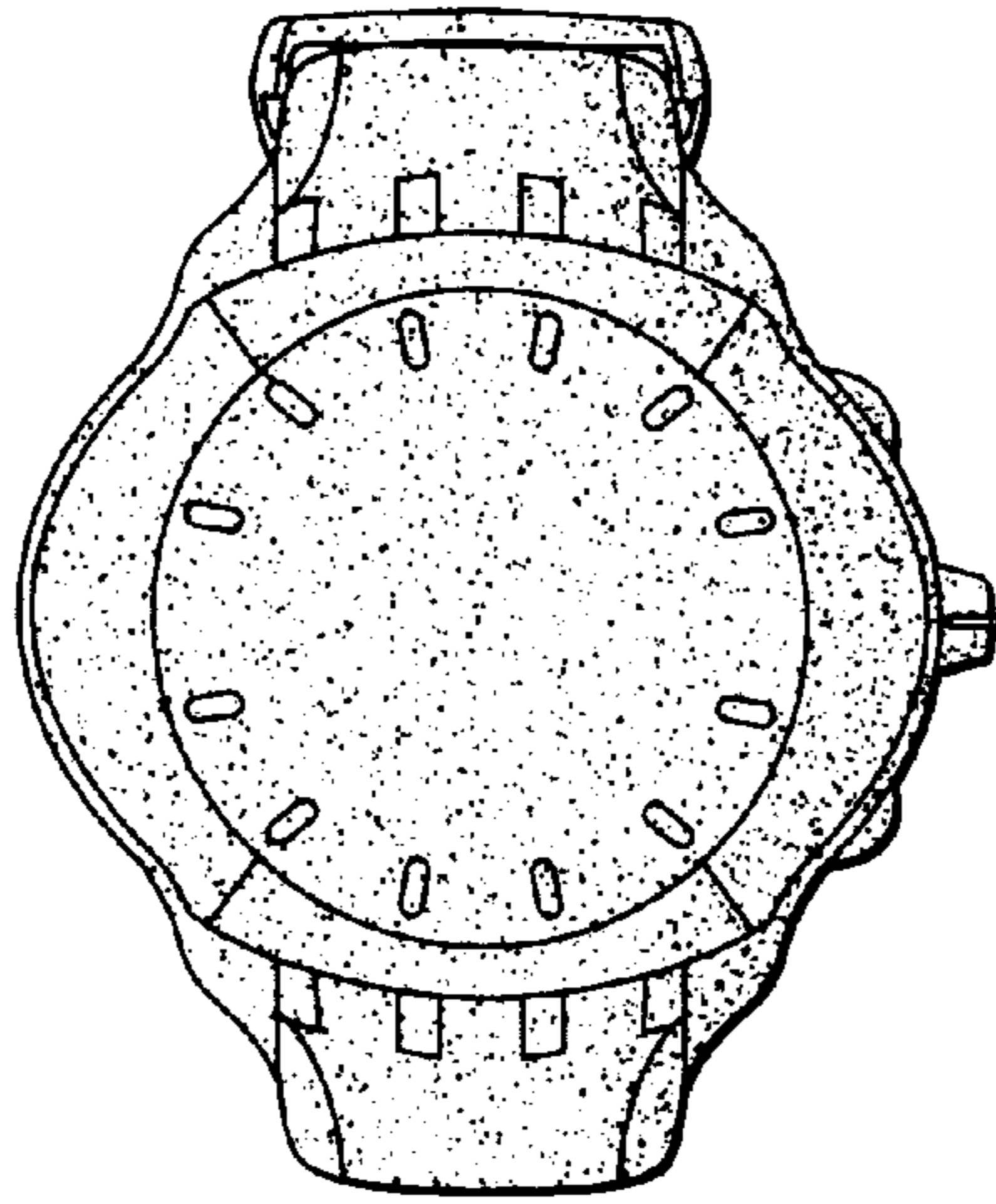

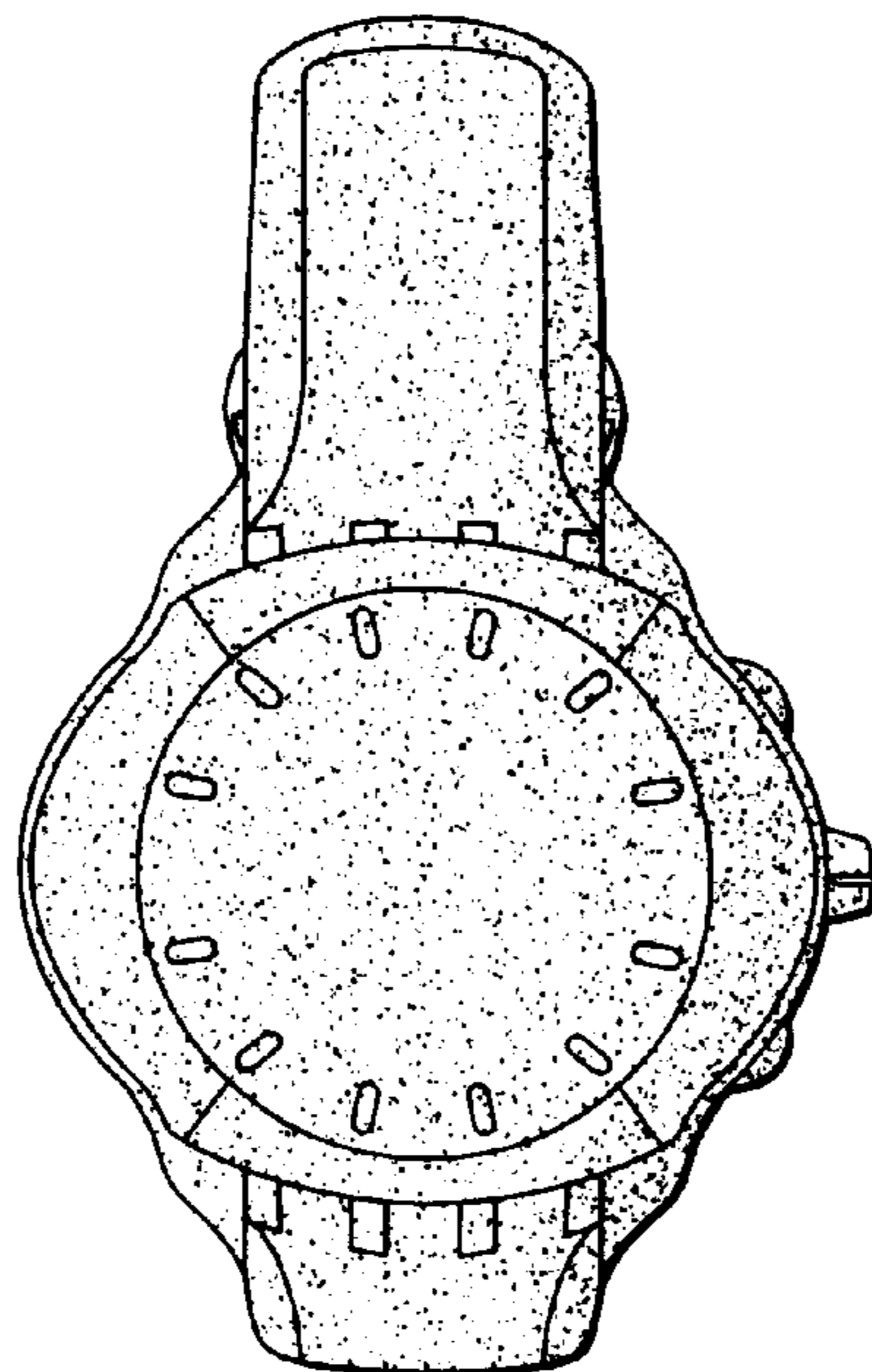

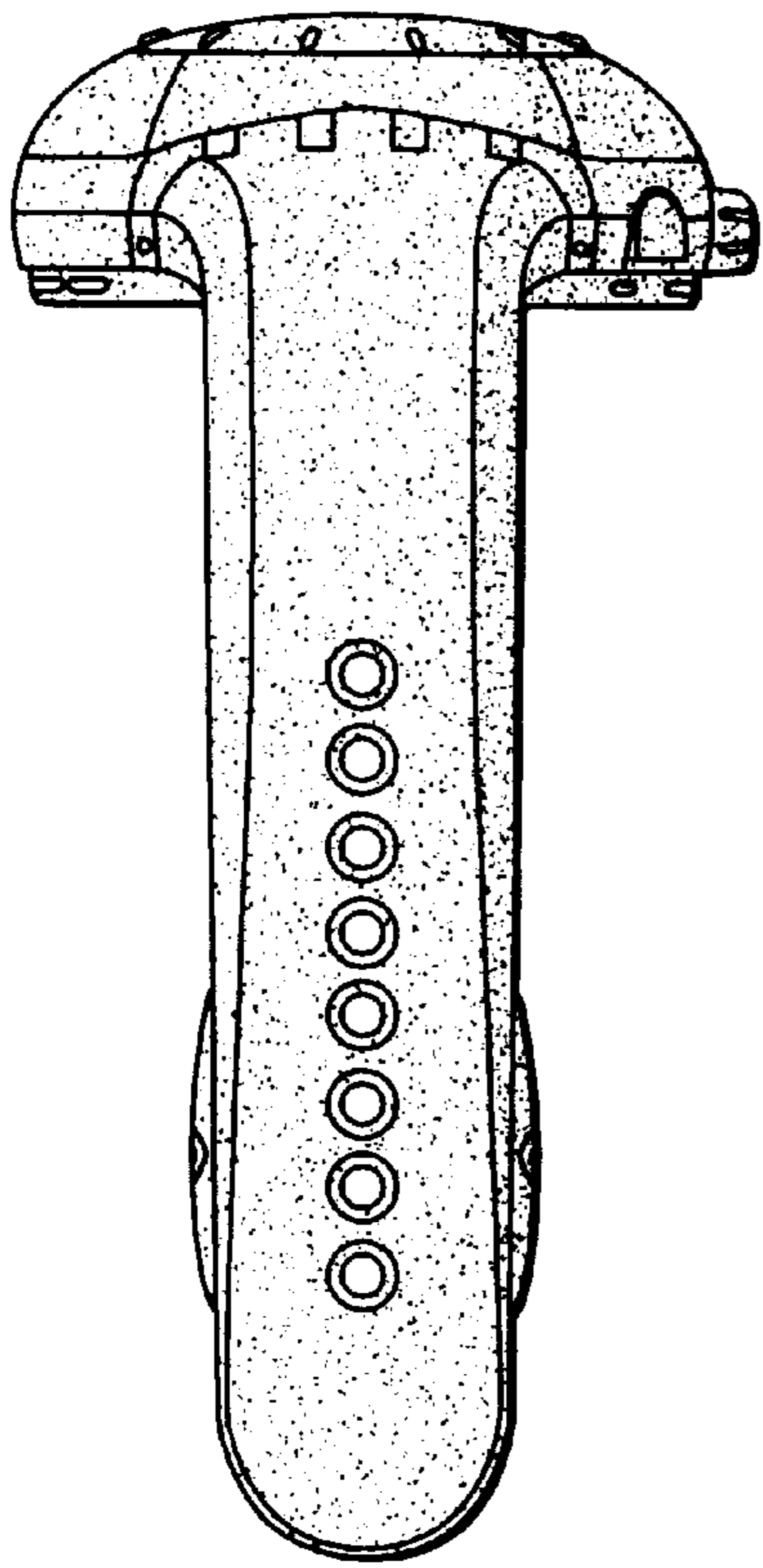

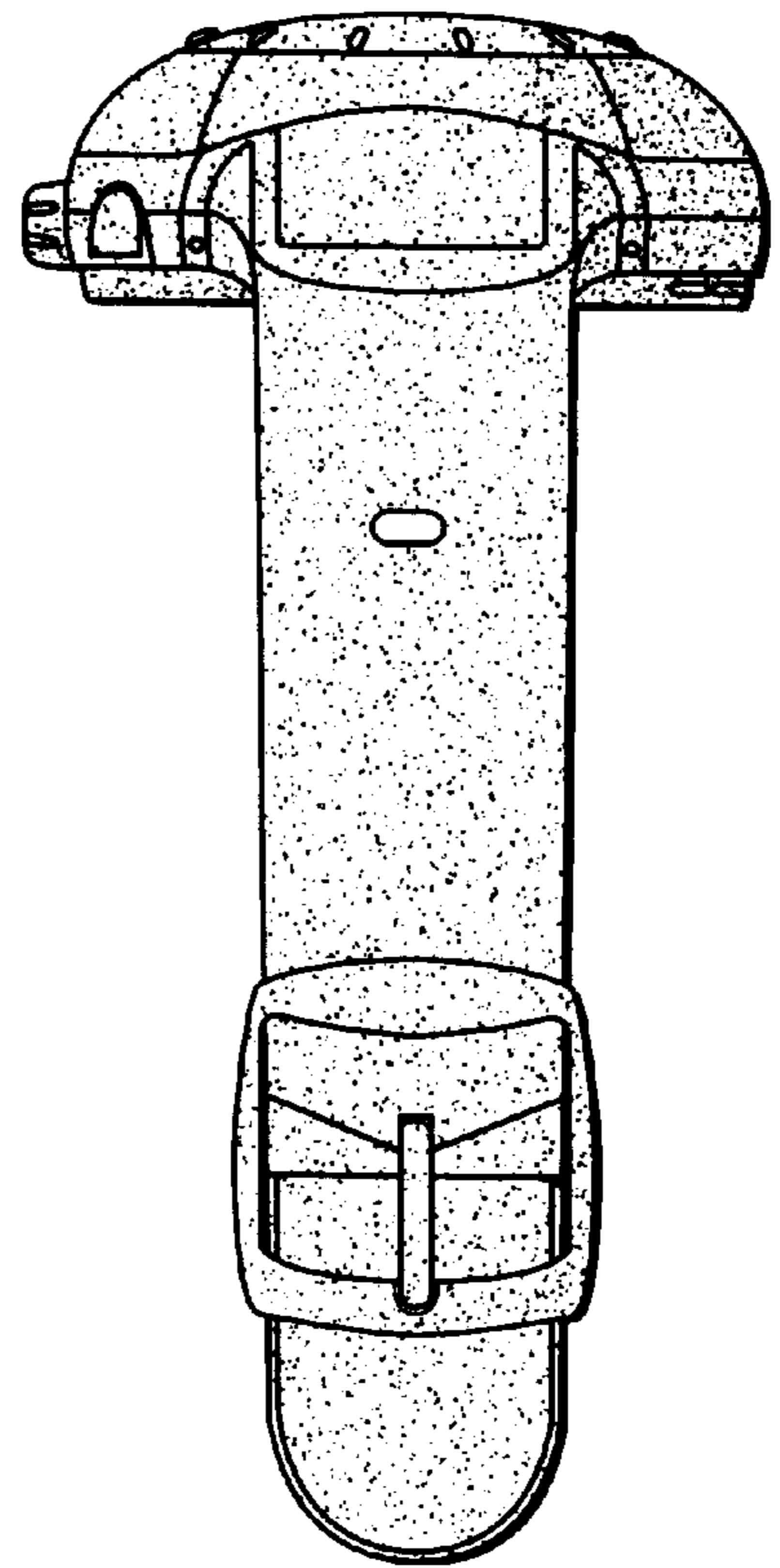

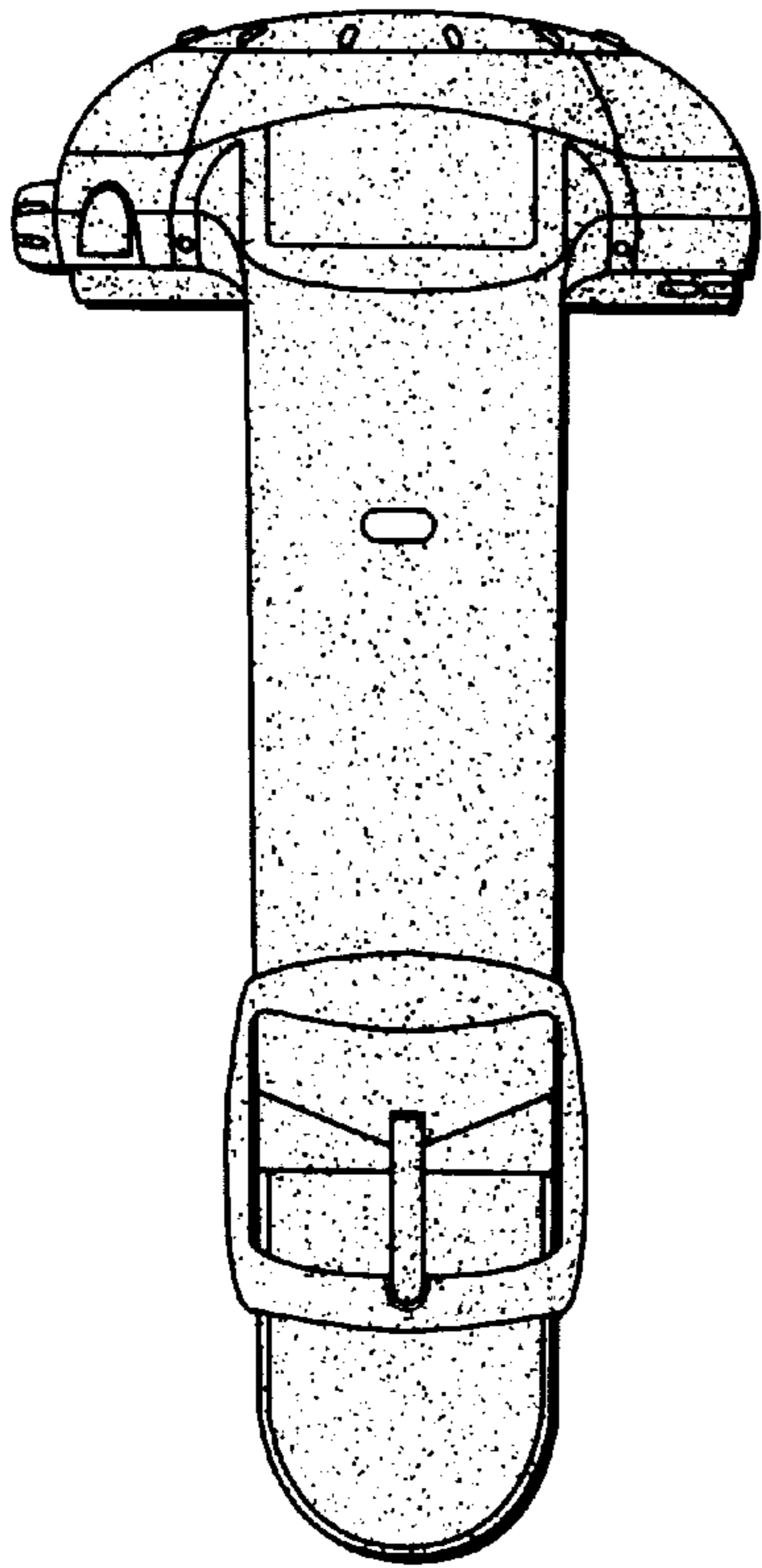

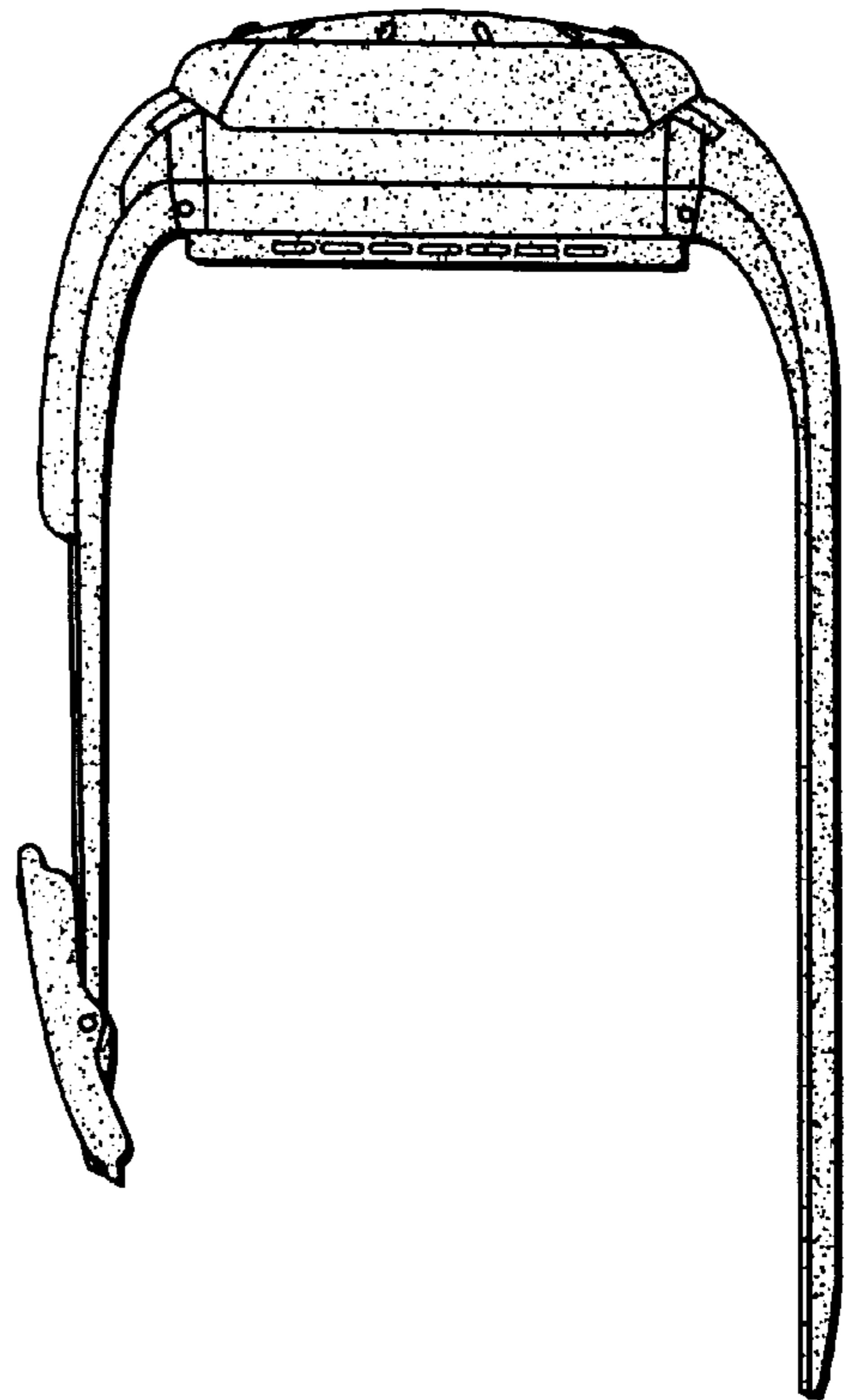

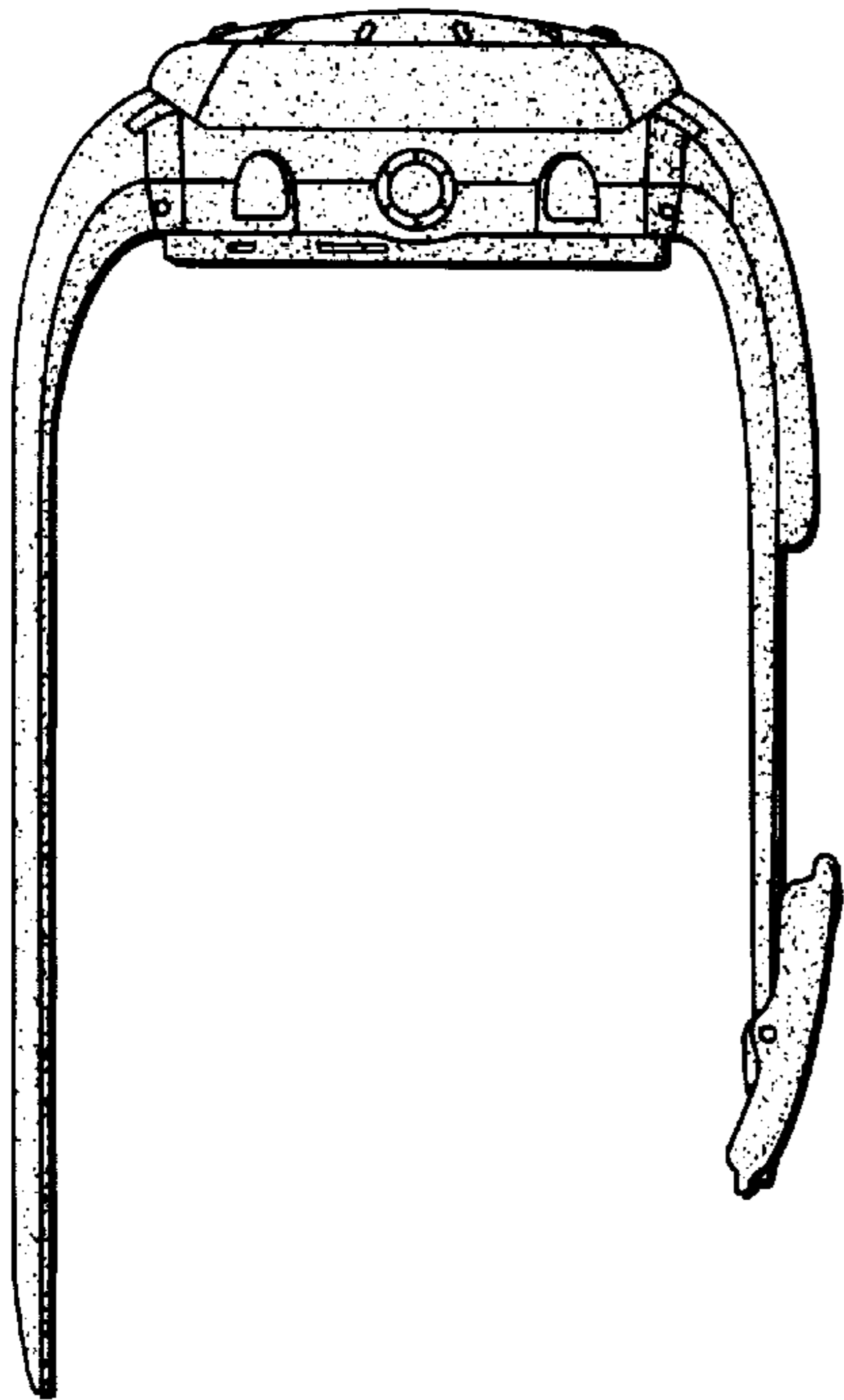

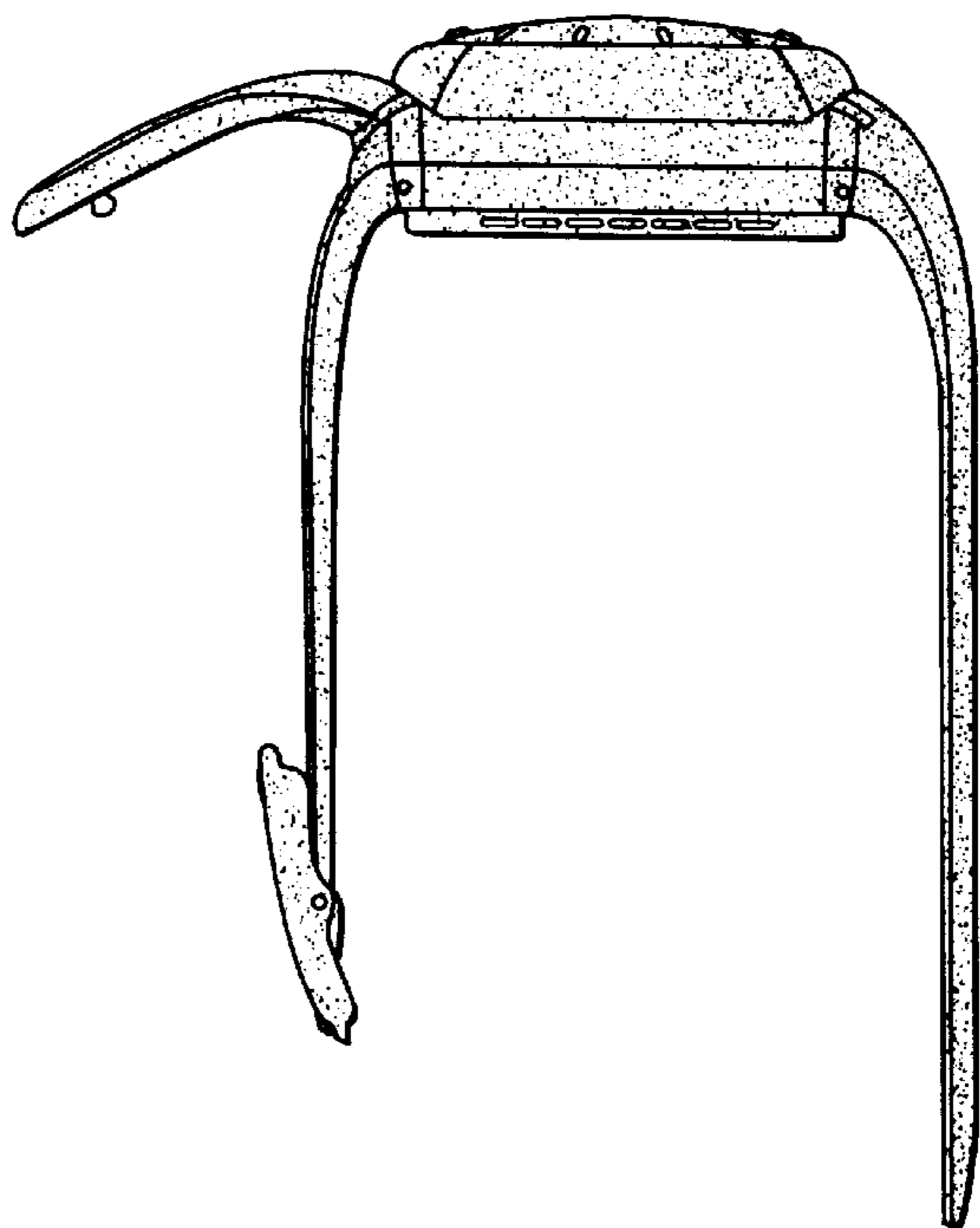

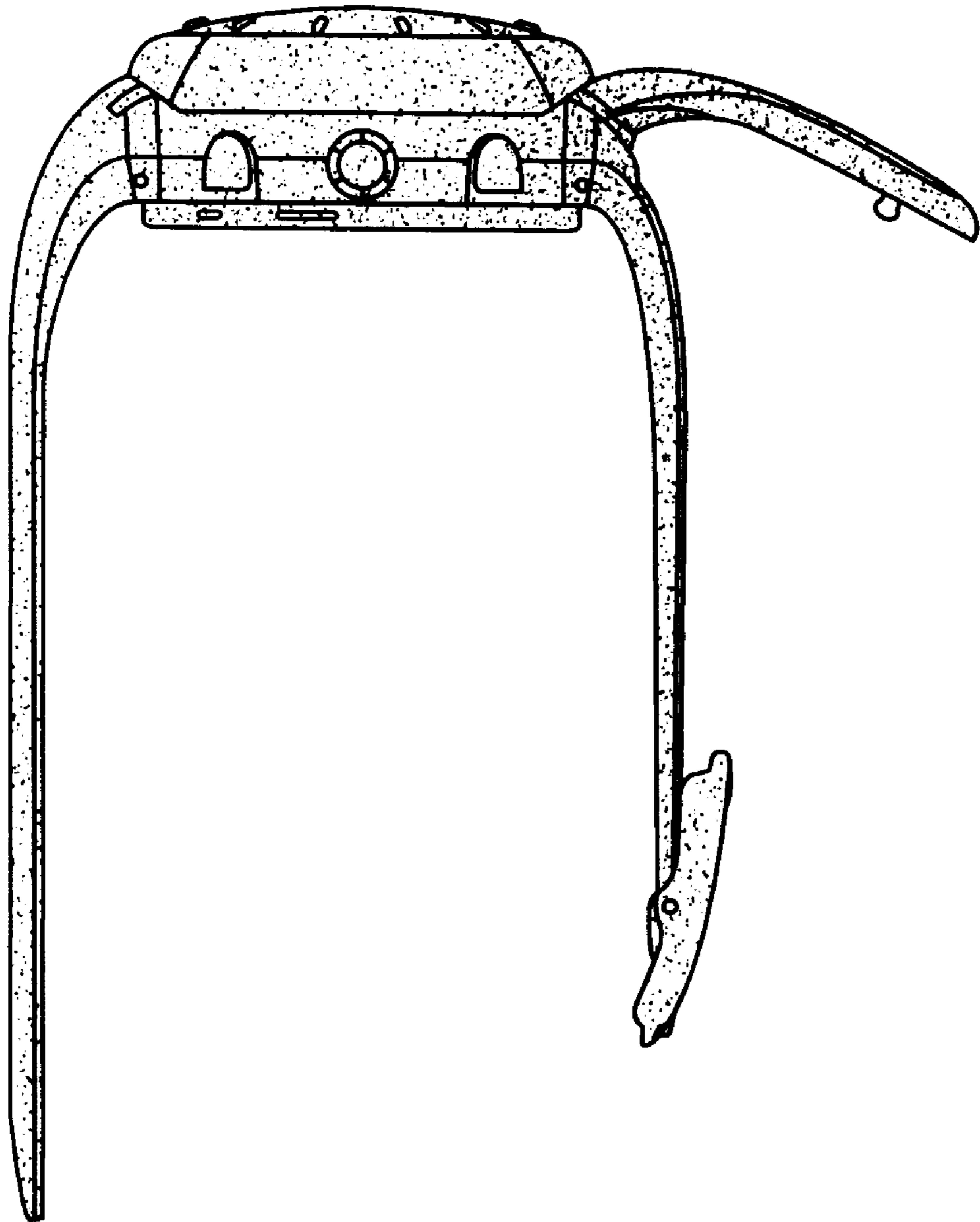

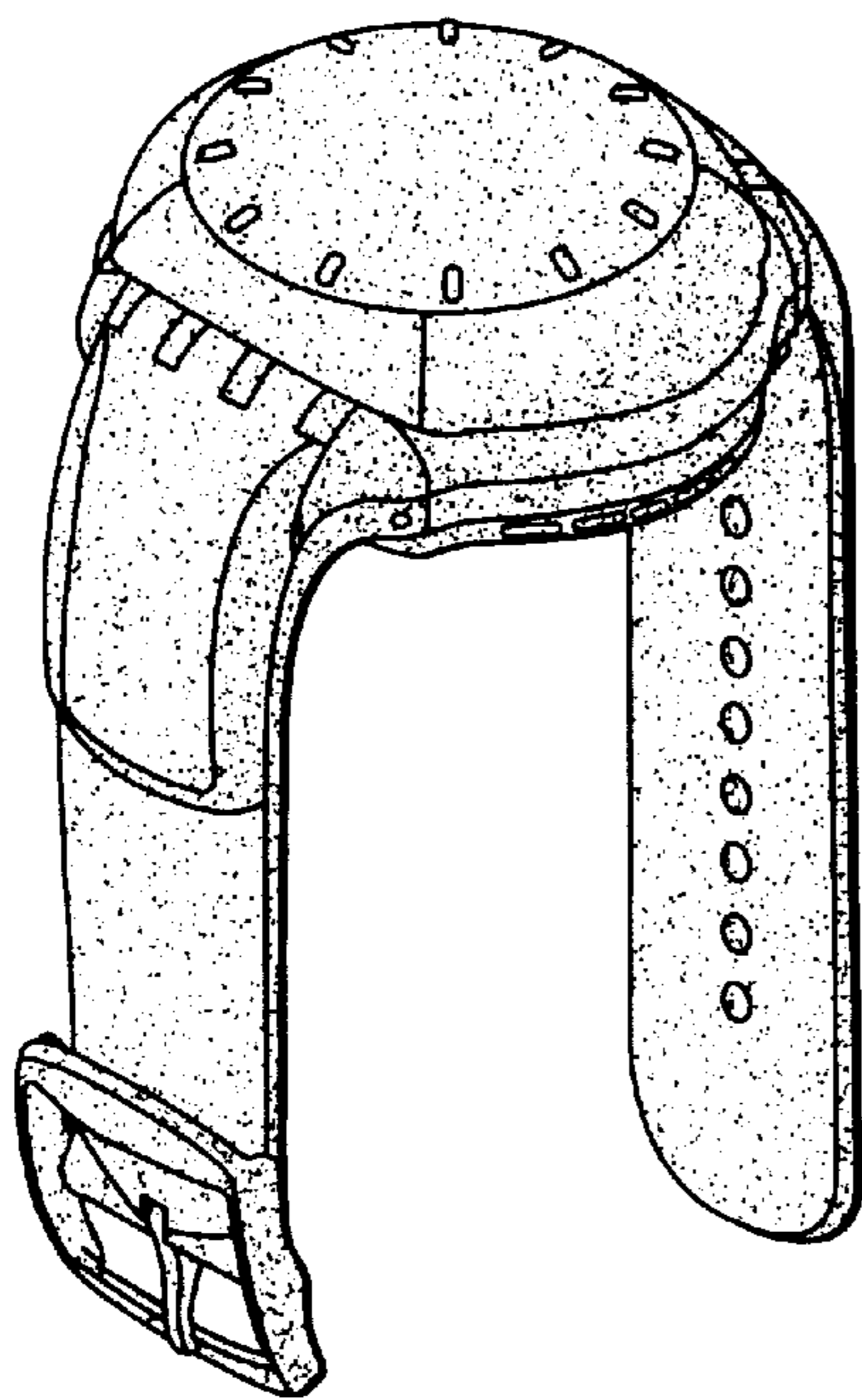

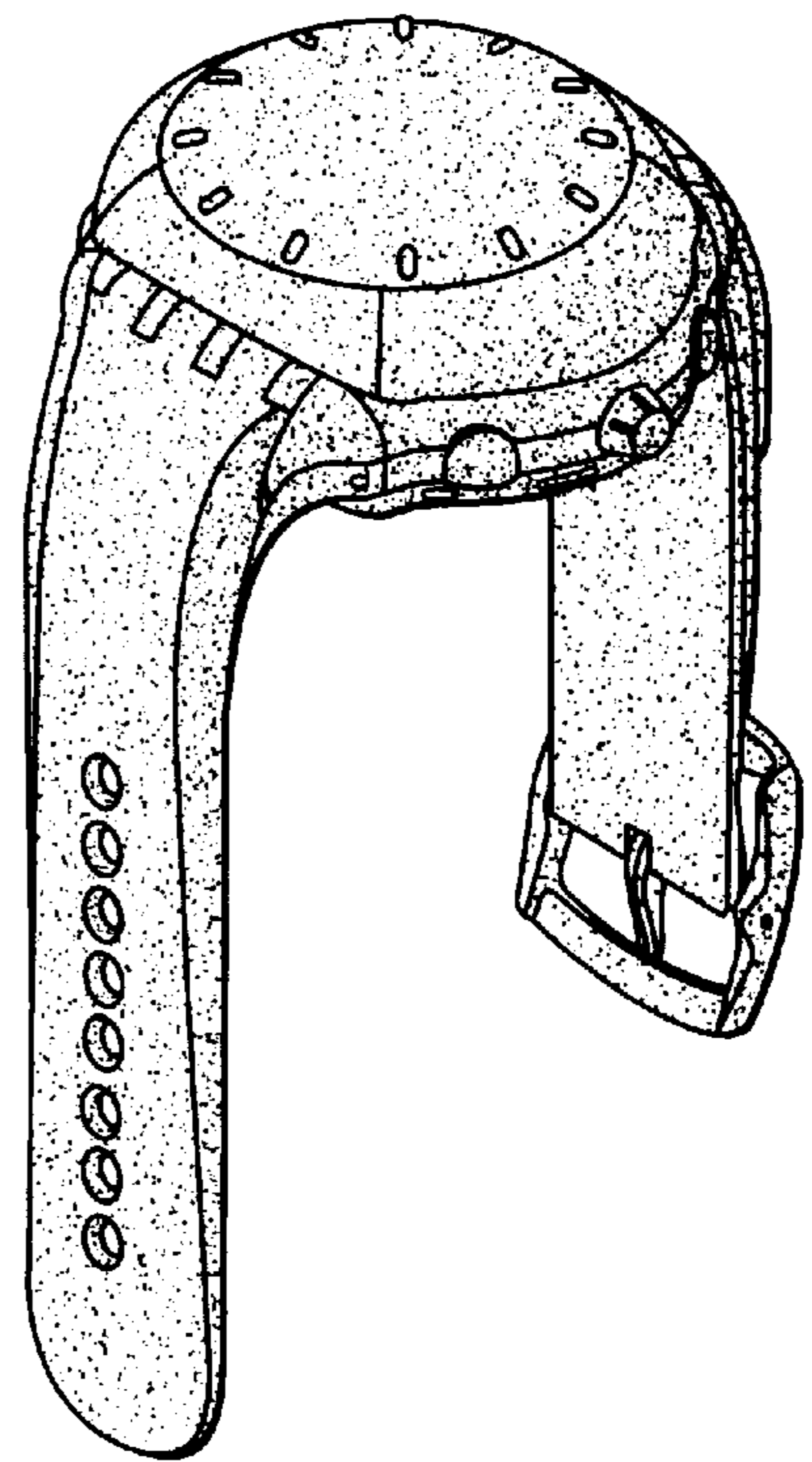

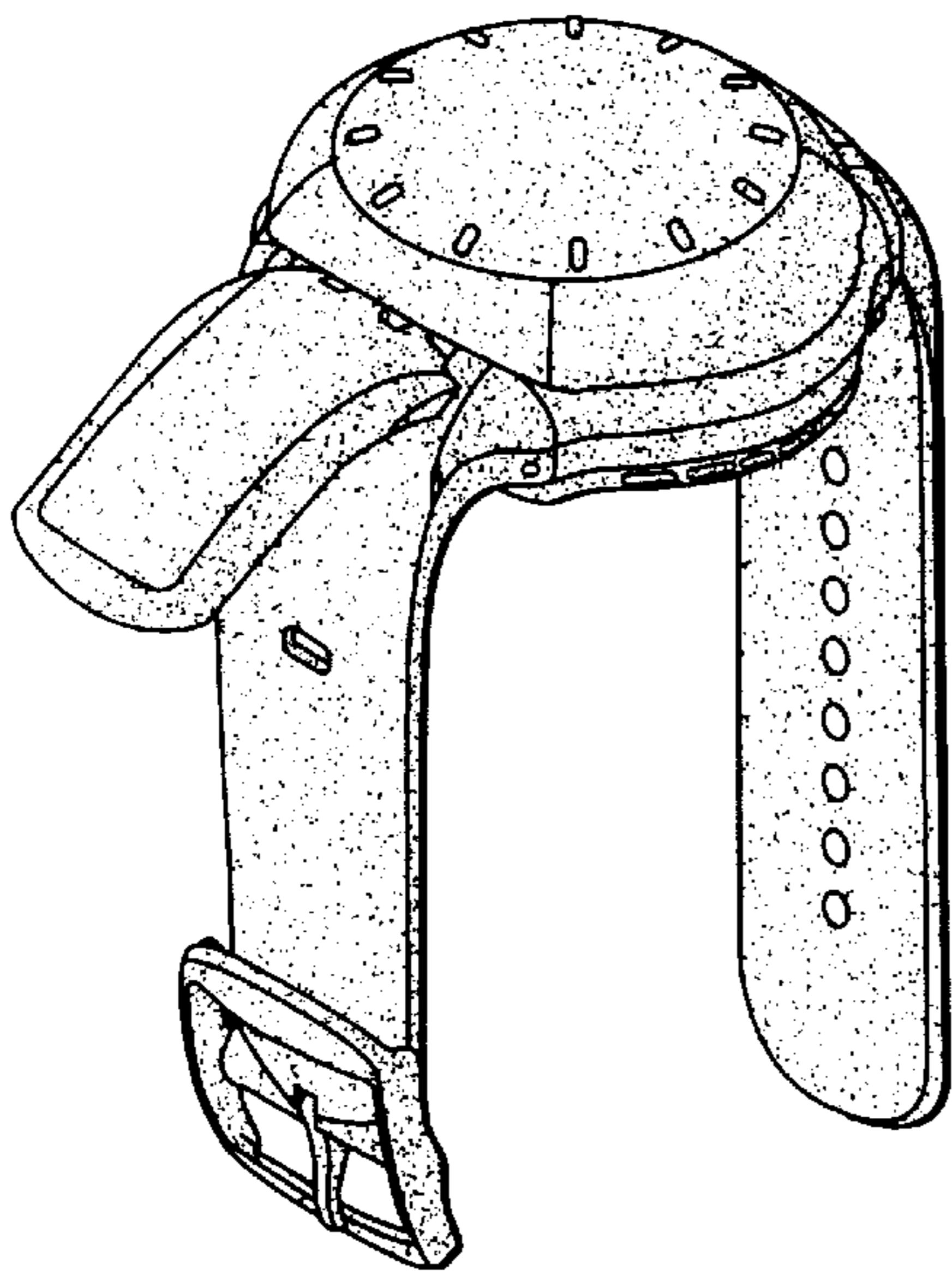

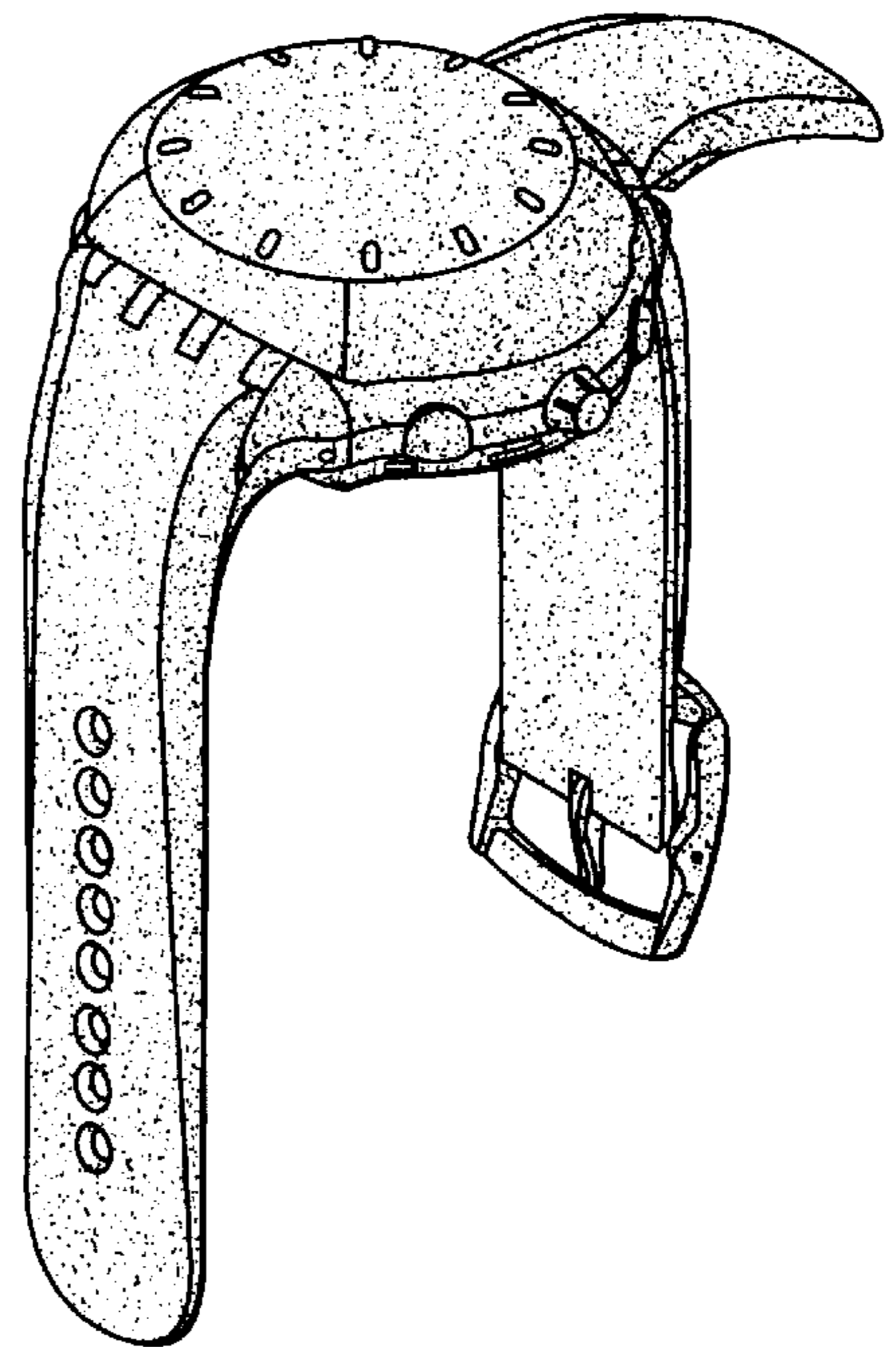
