**DESCRIPTION**

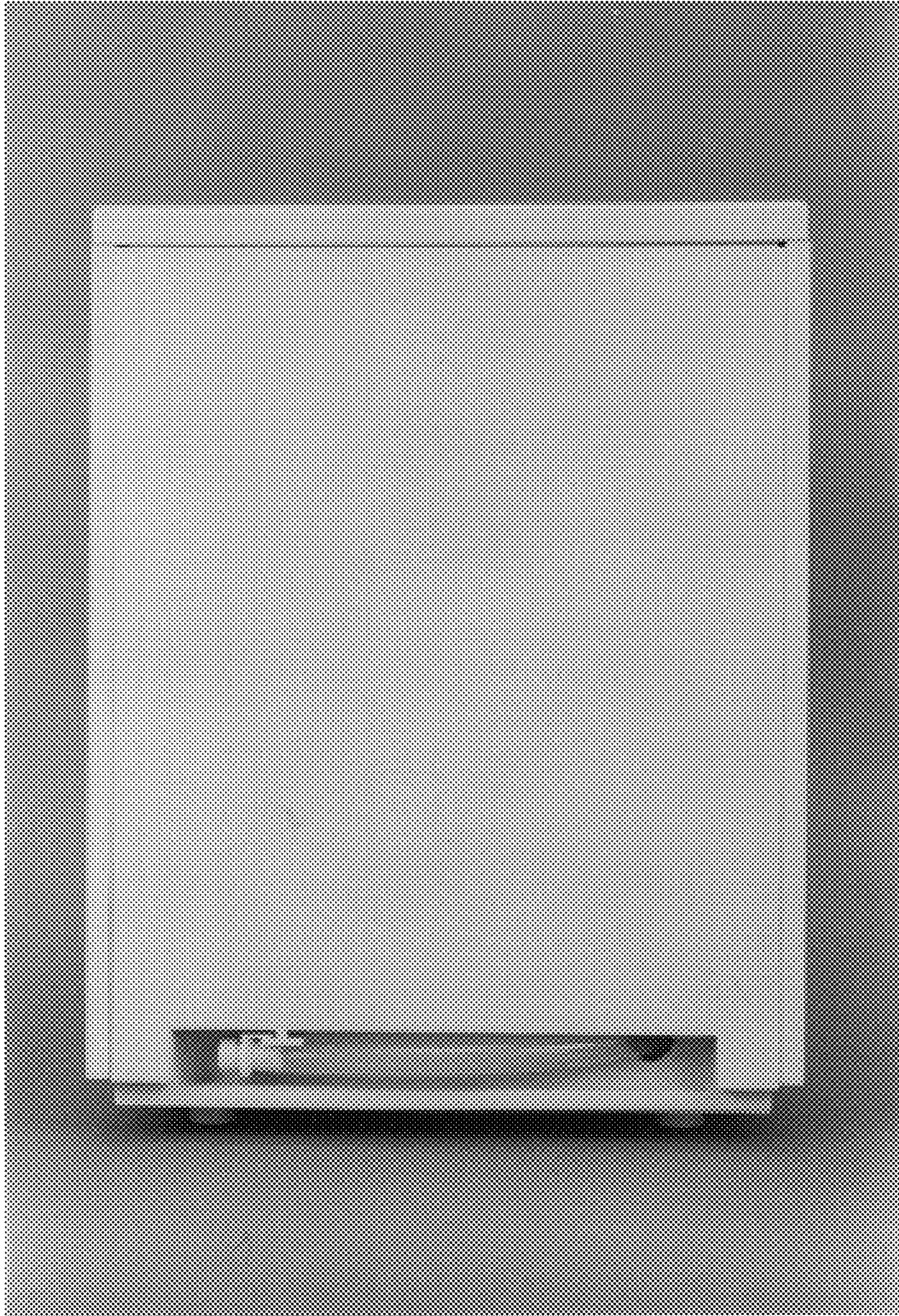
FIG. 1 is a front elevational view thereof;

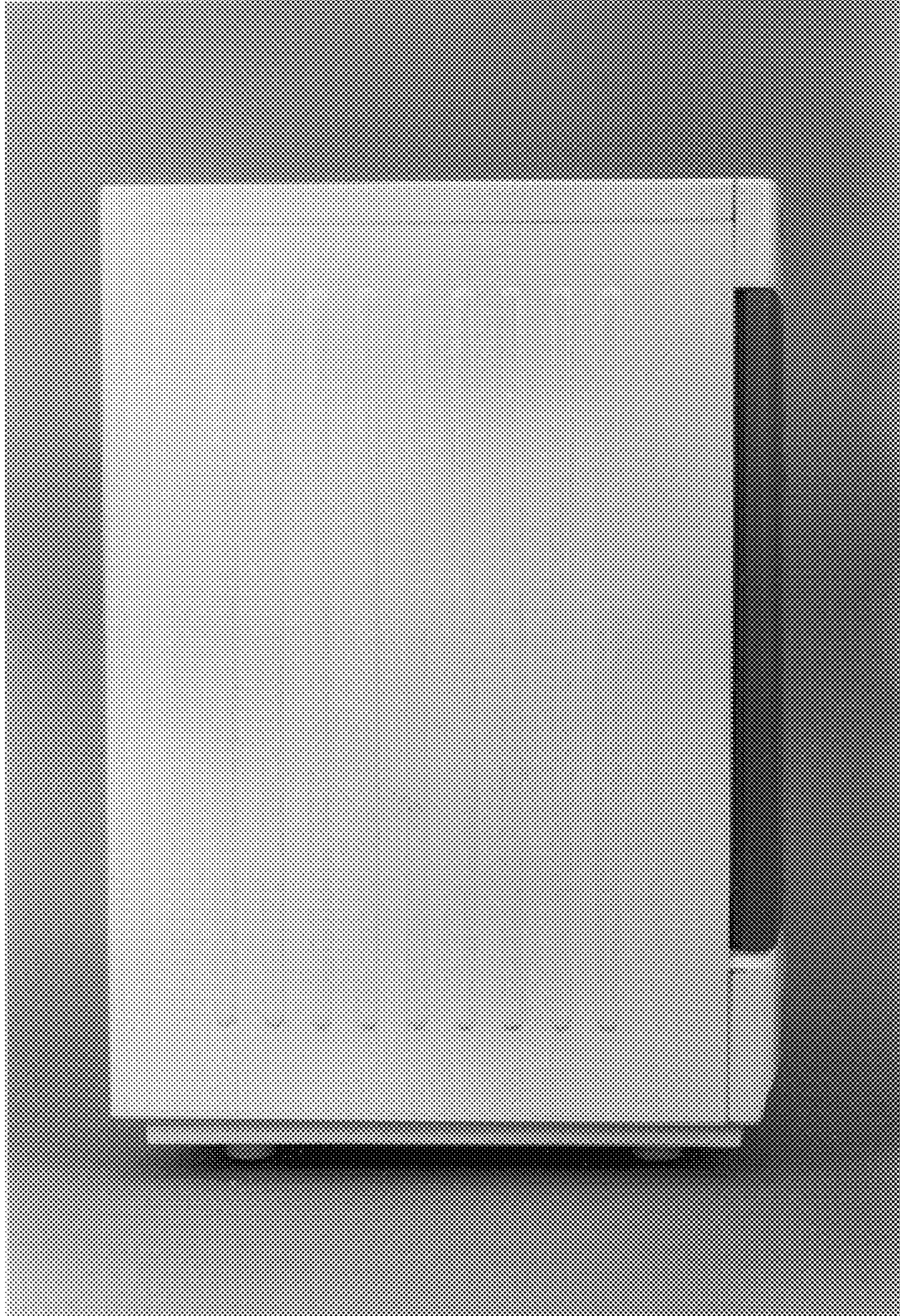




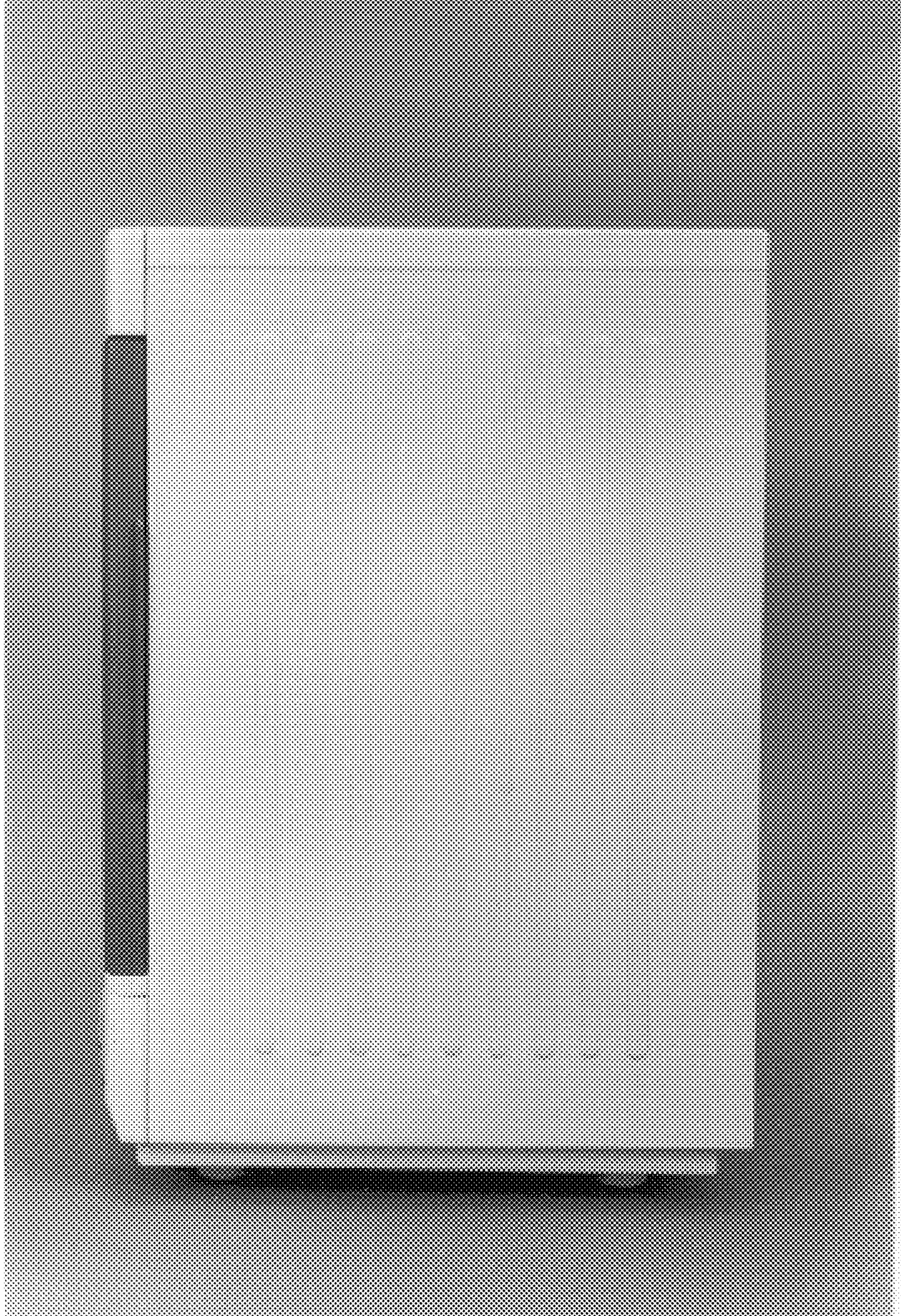

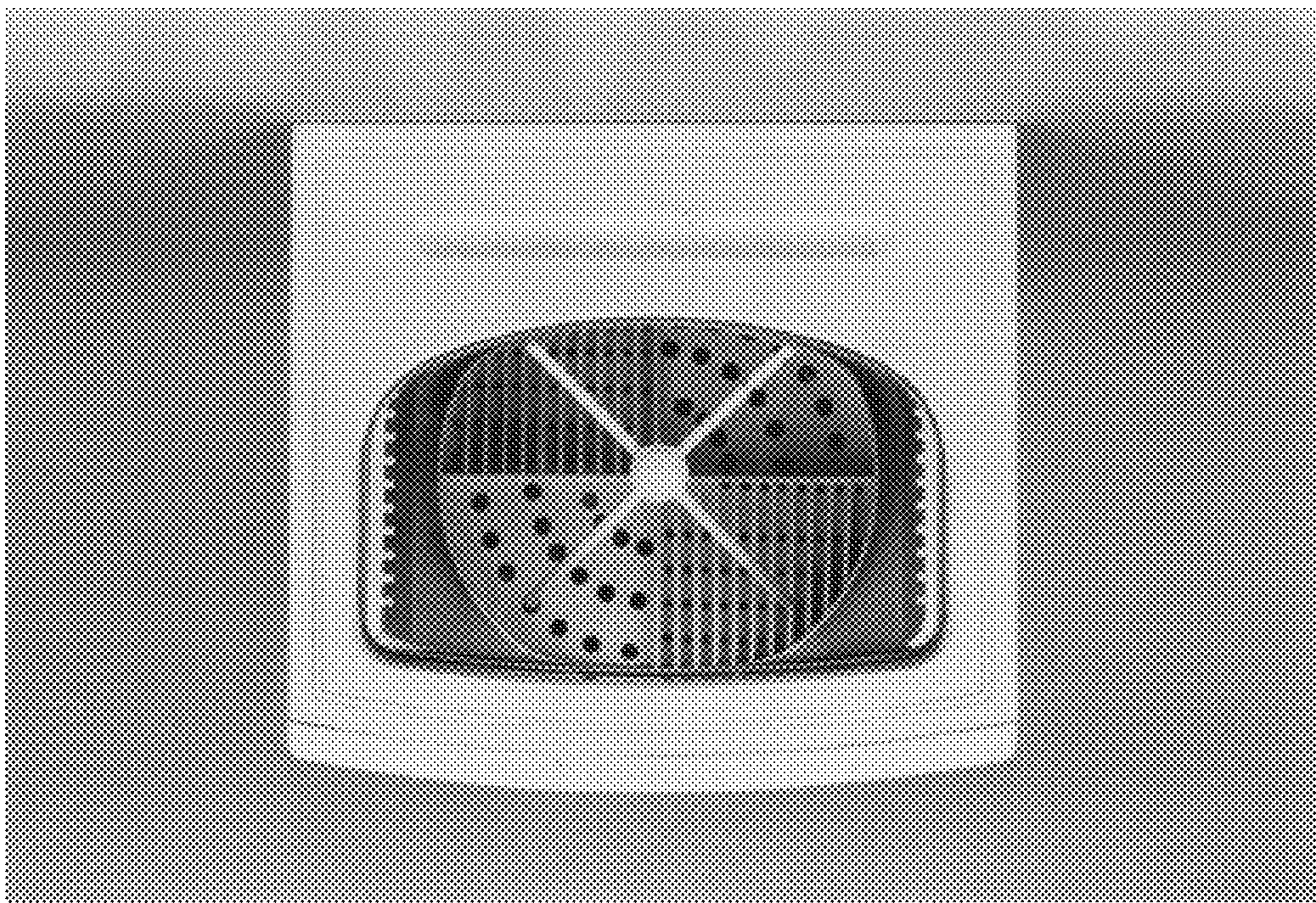

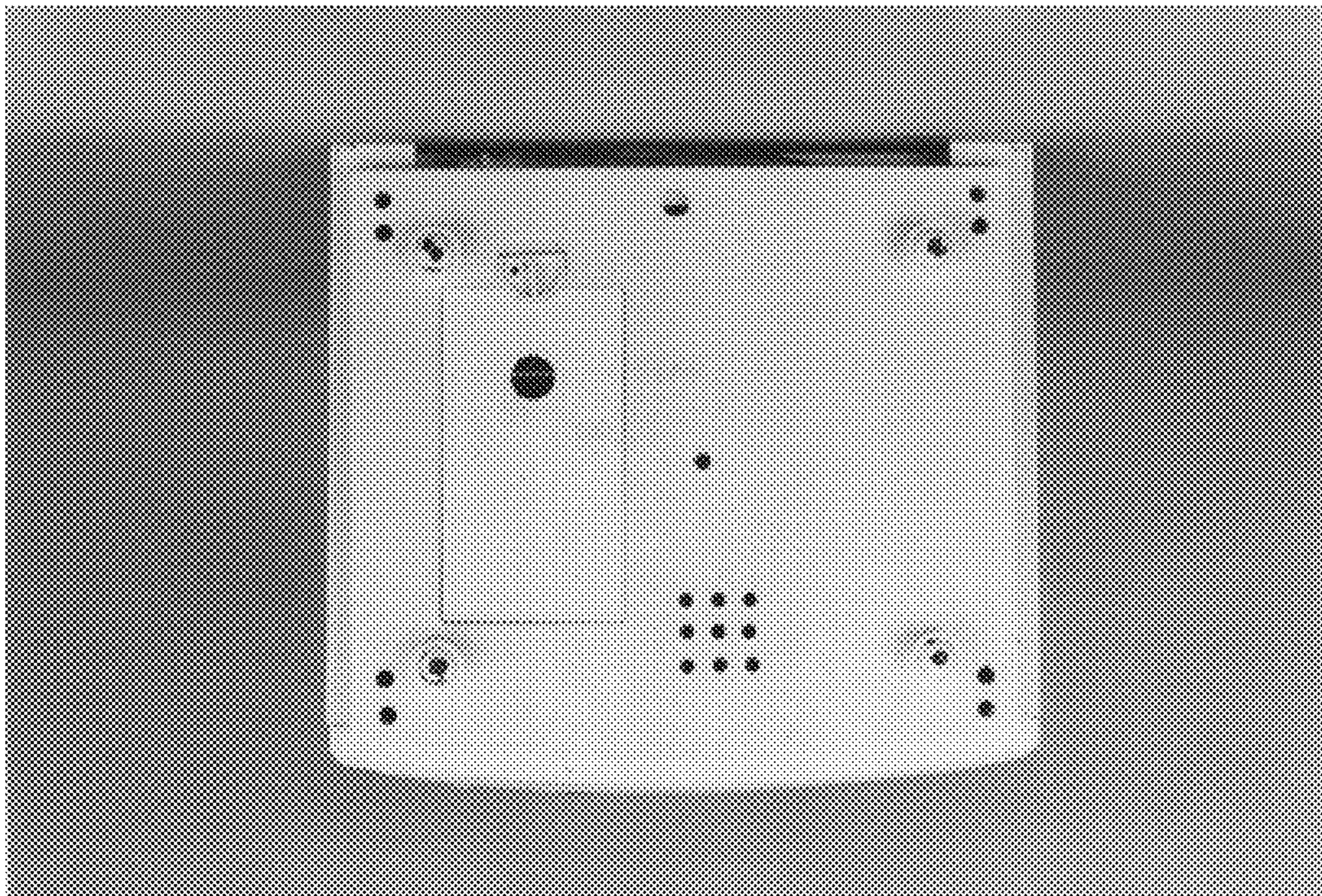
