FIG. 5 is a top plan view of the combined key chain and car alarm remote of FIG. 1.

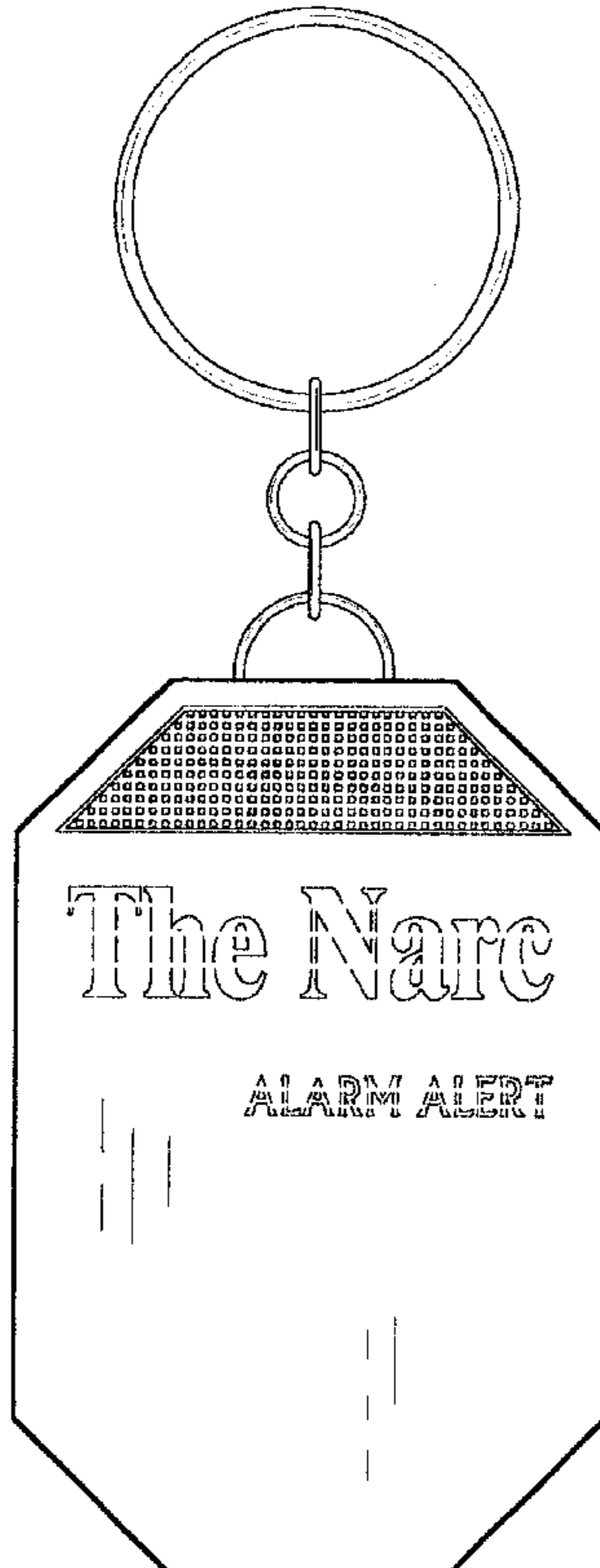

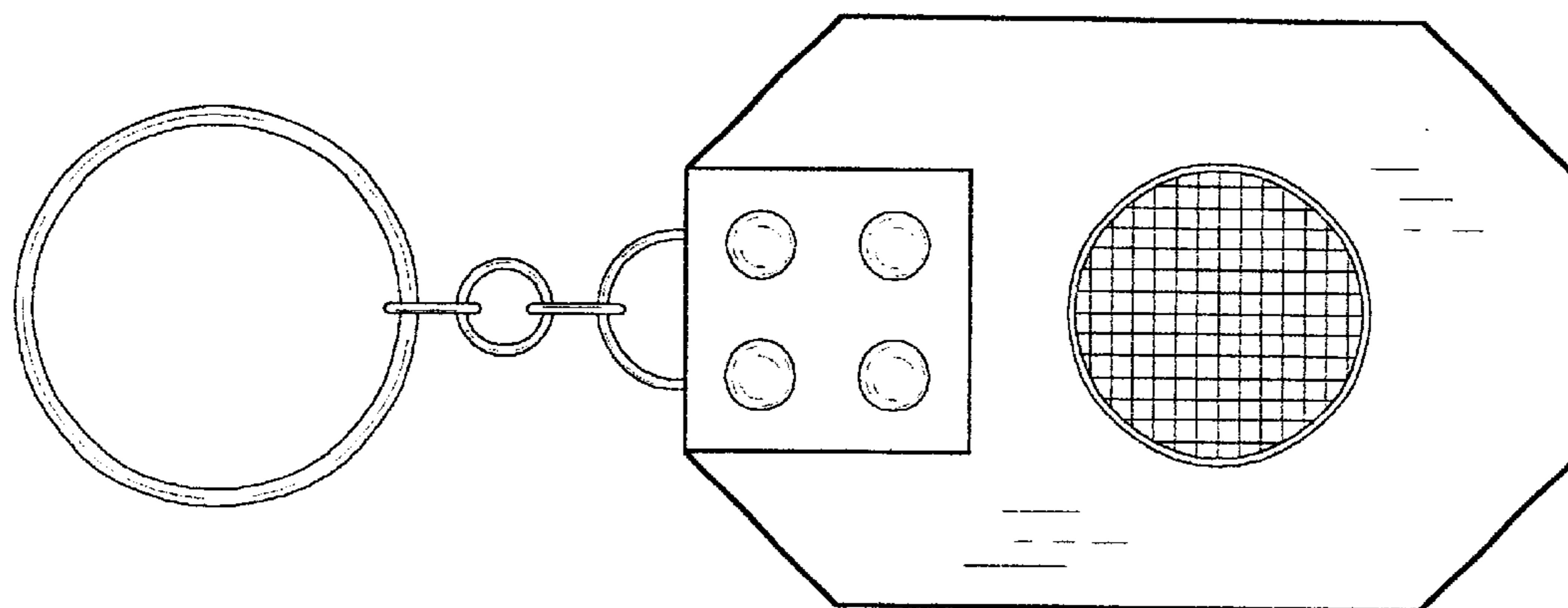

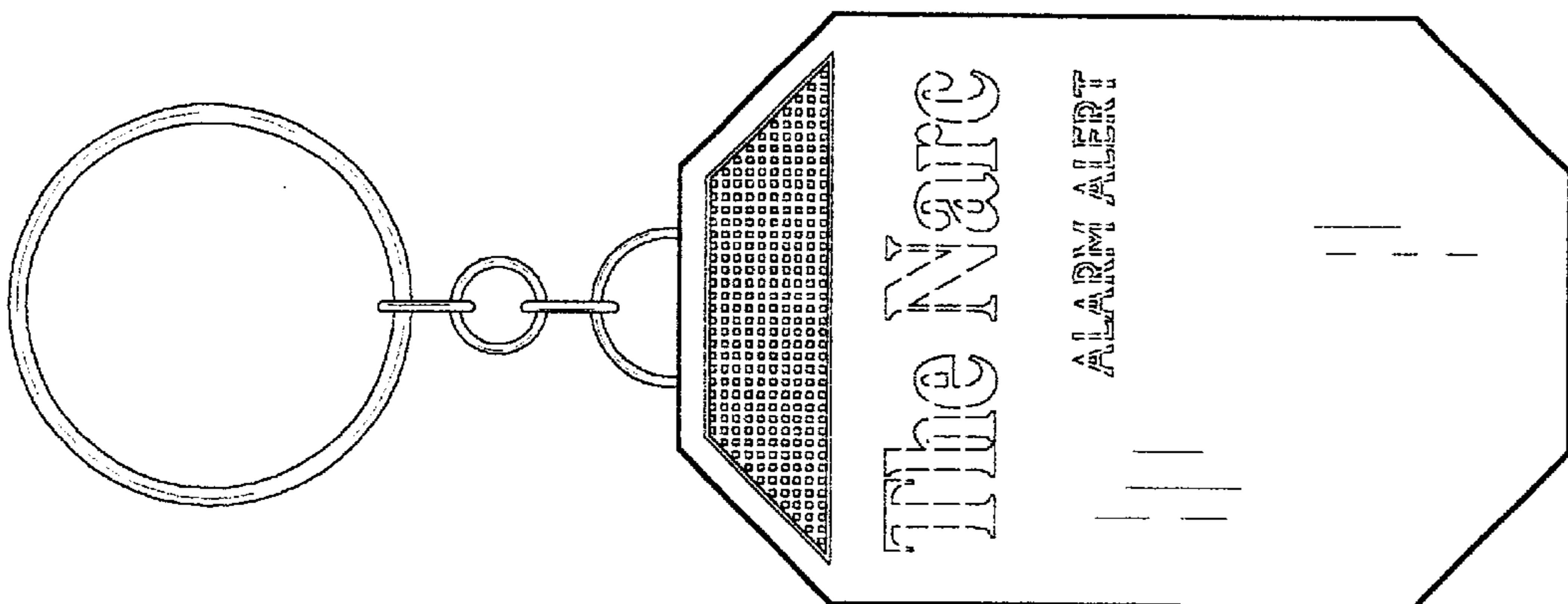

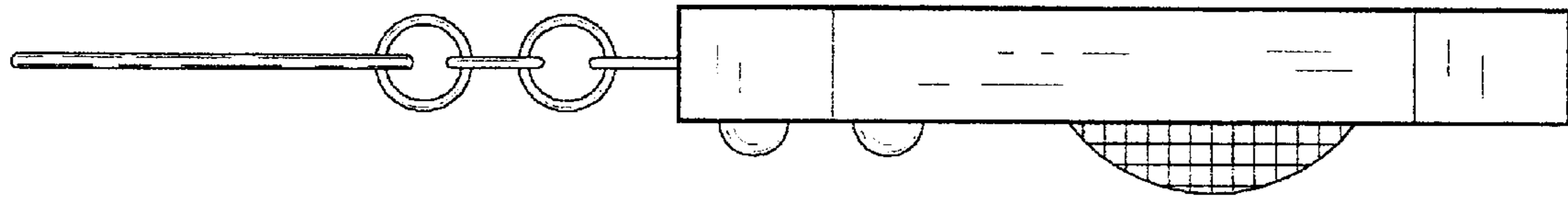

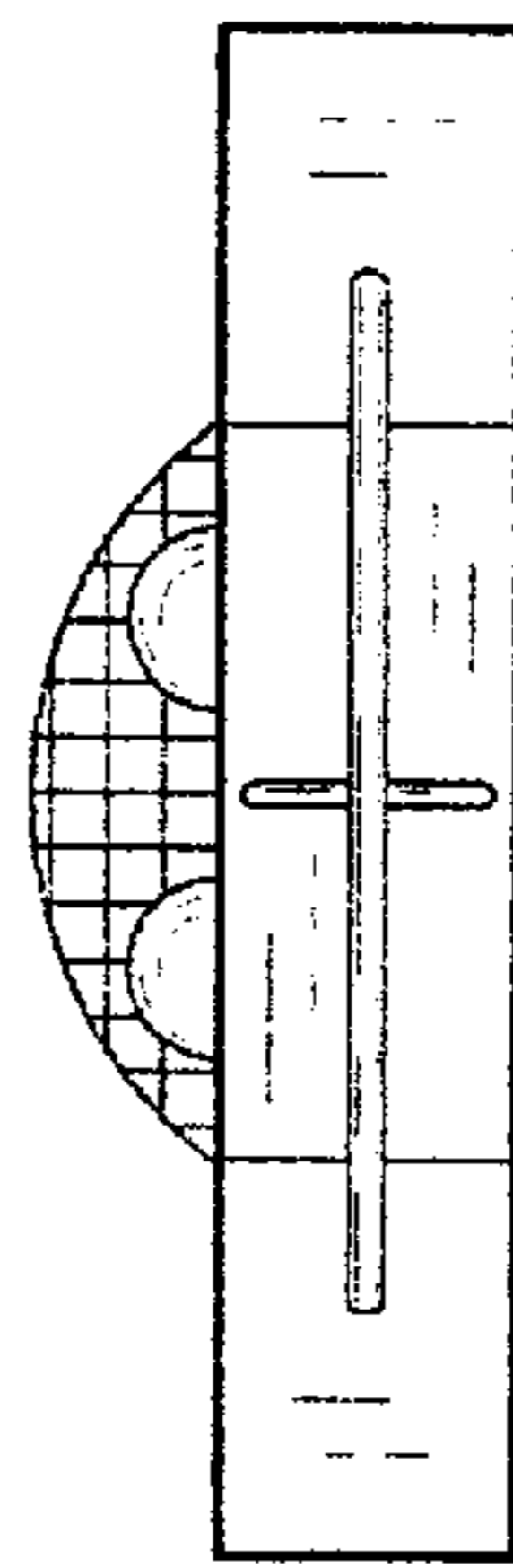
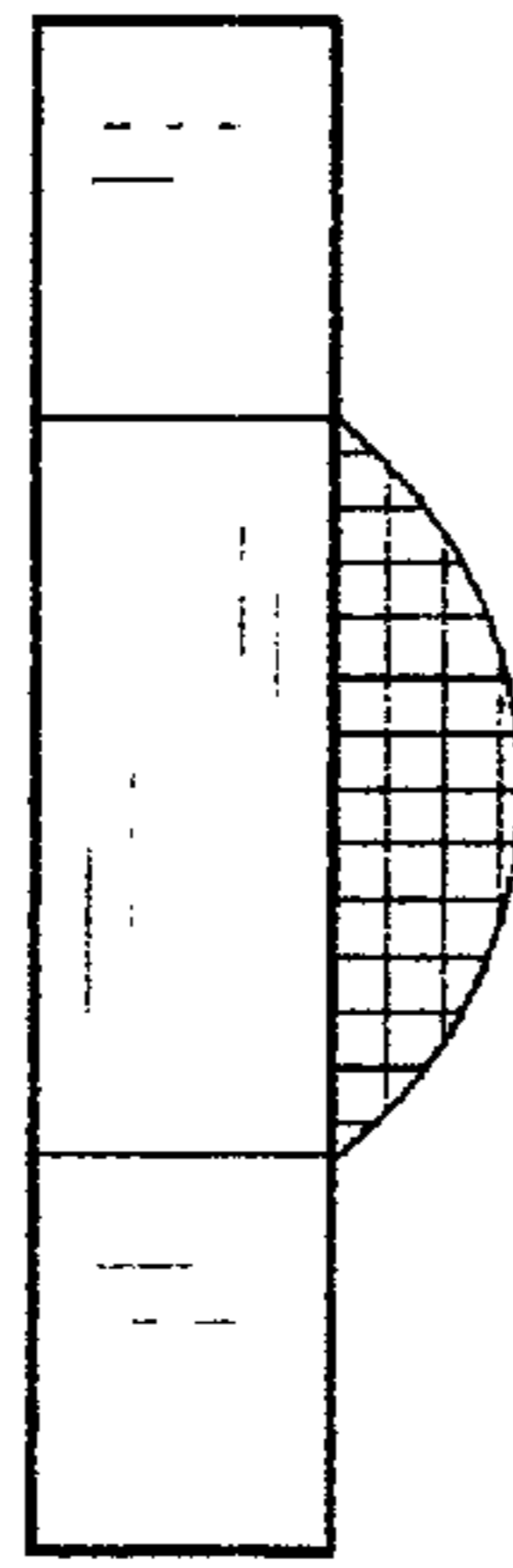
