FIG. 1 is a front elevational view of a product merchandising unit showing my new design.

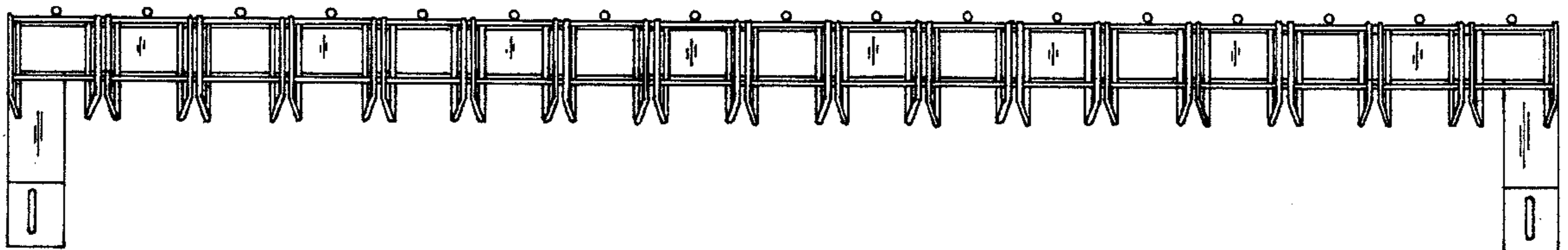
FIG. 2 is a left side elevational view thereof, the opposite side being a mirror image thereof.

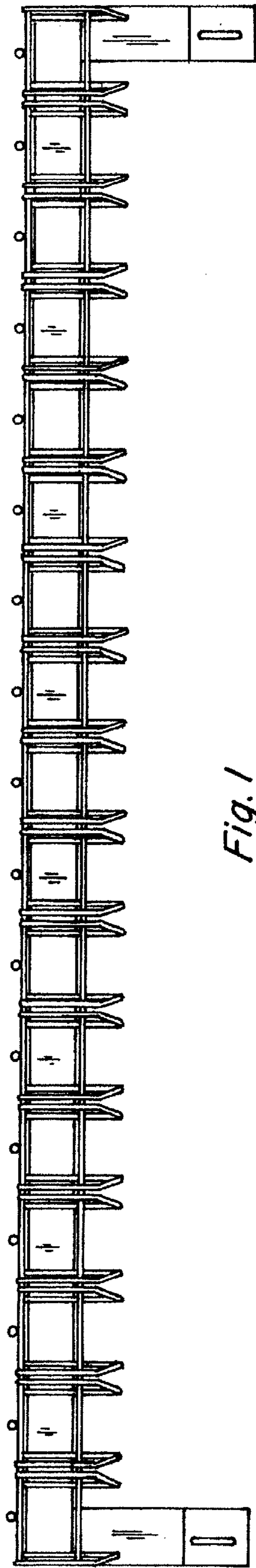

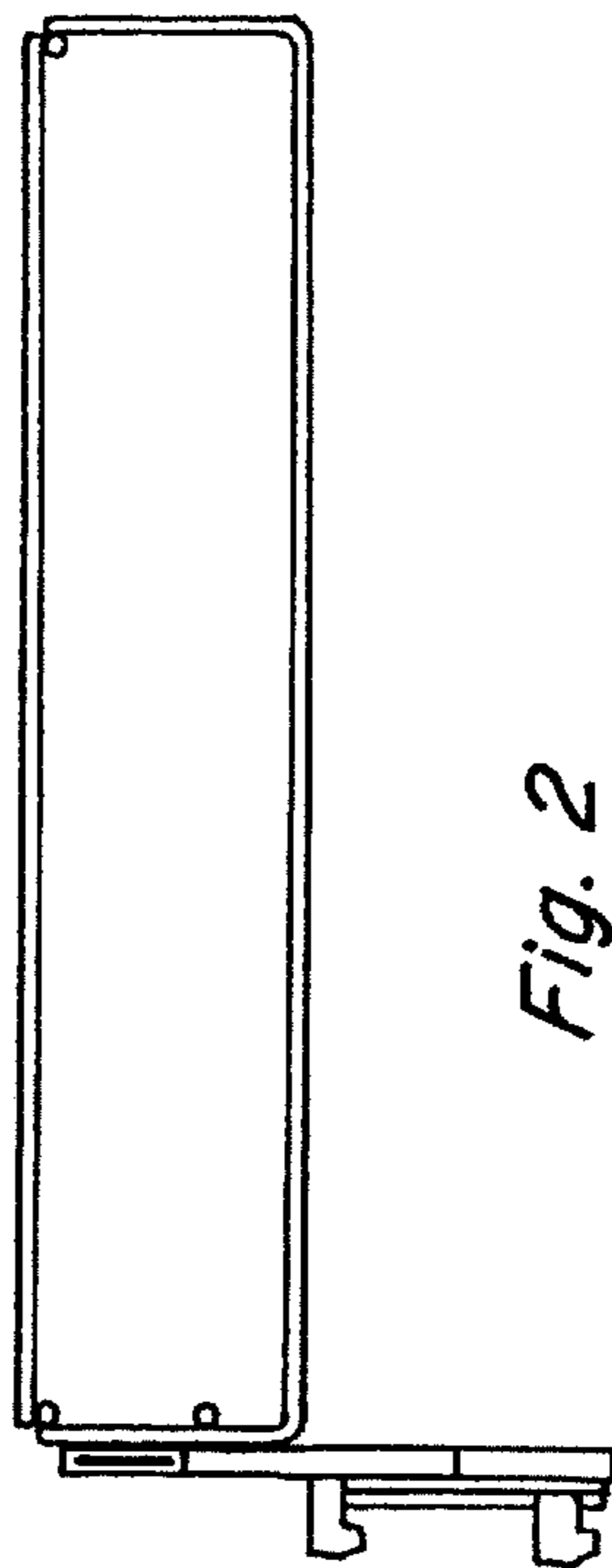

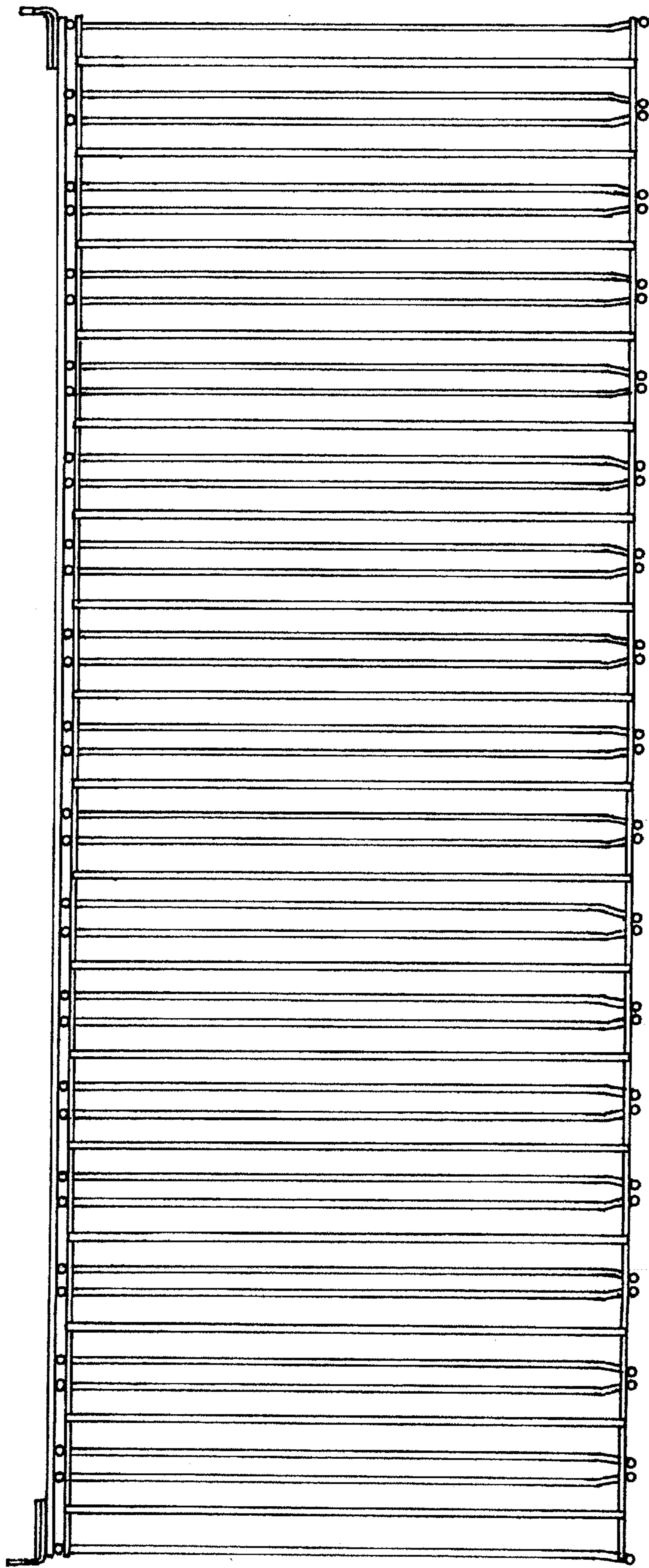

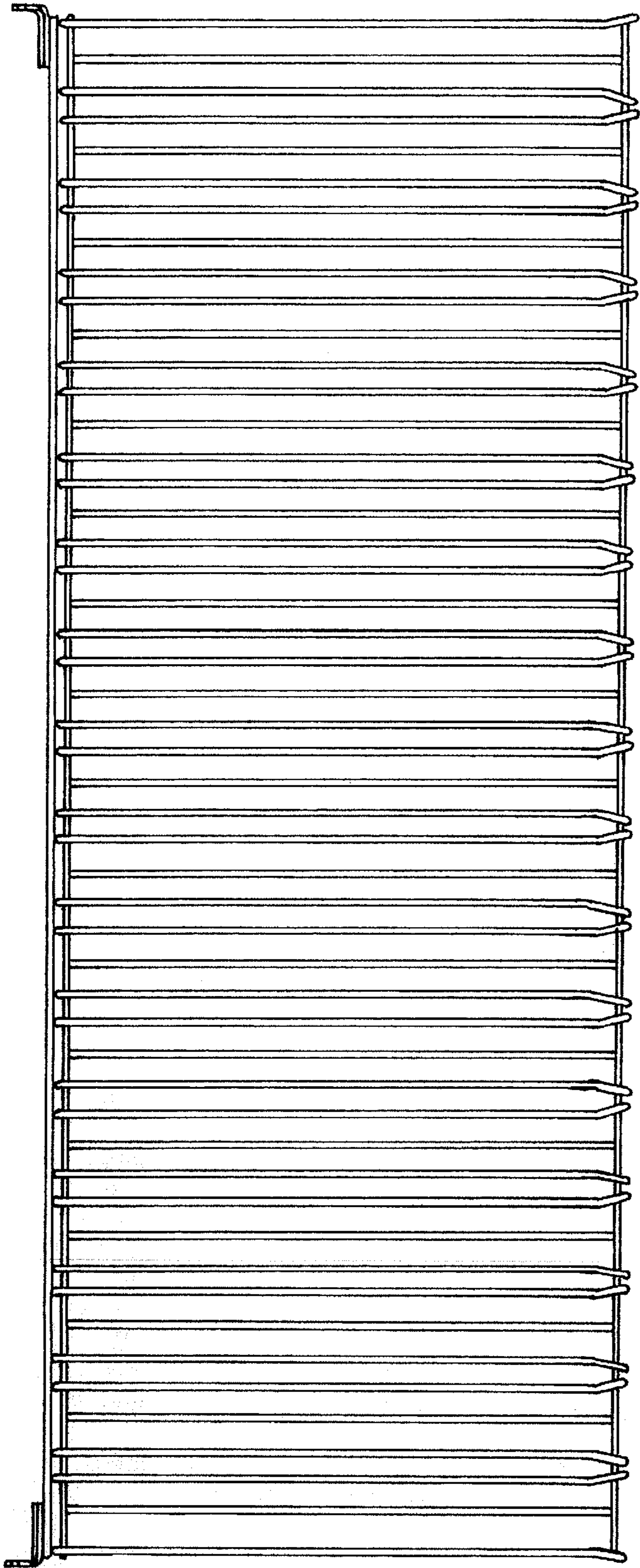

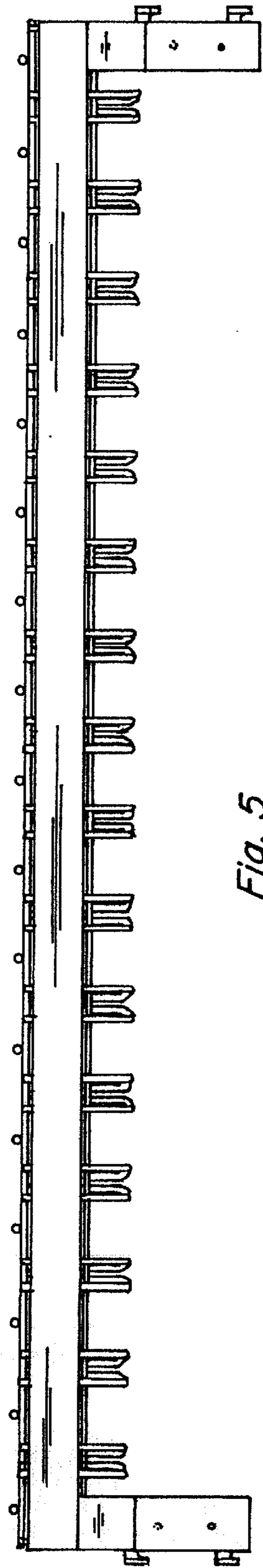
