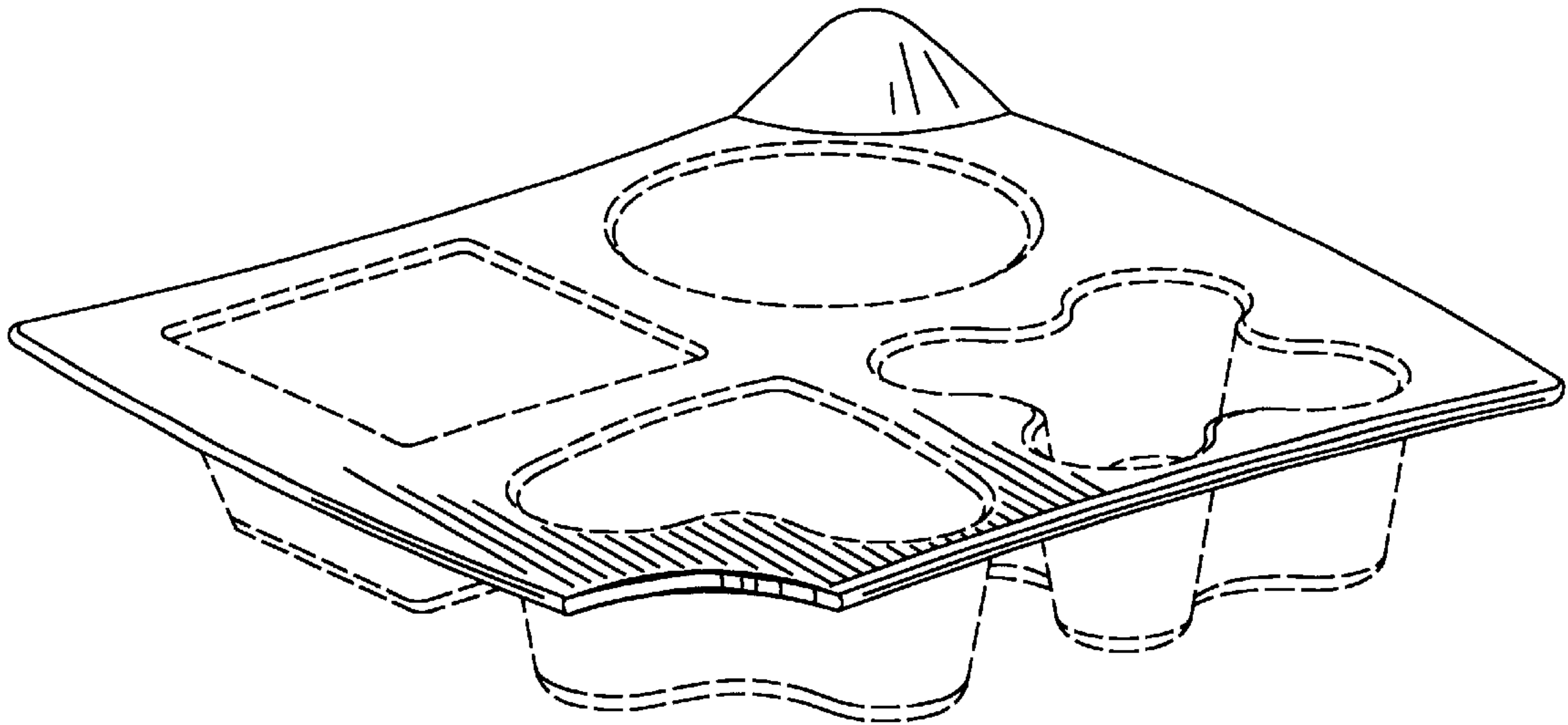
(57) **CLAIM**

The ornamental design for a raised handle for baking form, as shown and described.

DESCRIPTION

FIG. 1 is a top, side and front perspective view of a raised handle for baking form showing the new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken line showing environmental structure is for illustrative purposes only and forms no part of the claimed design.

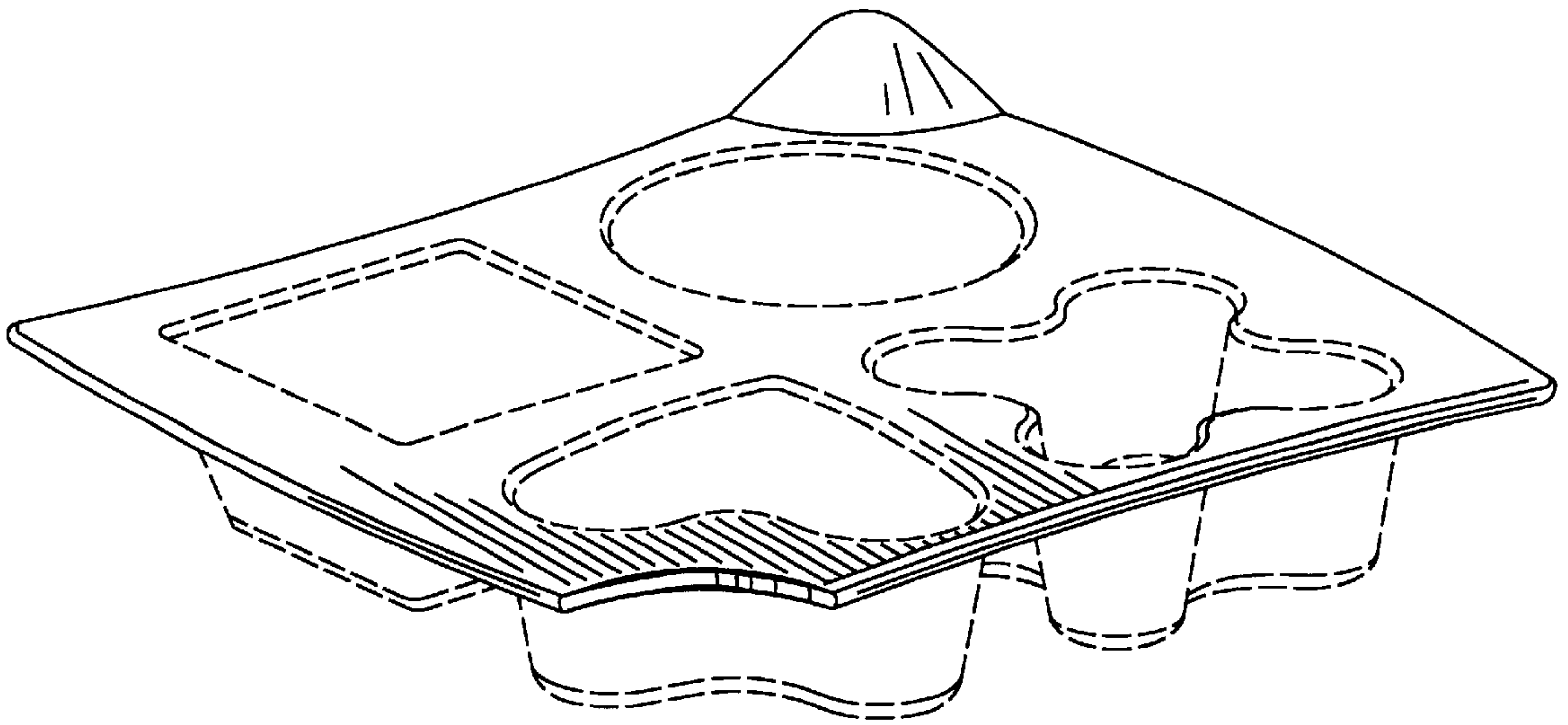

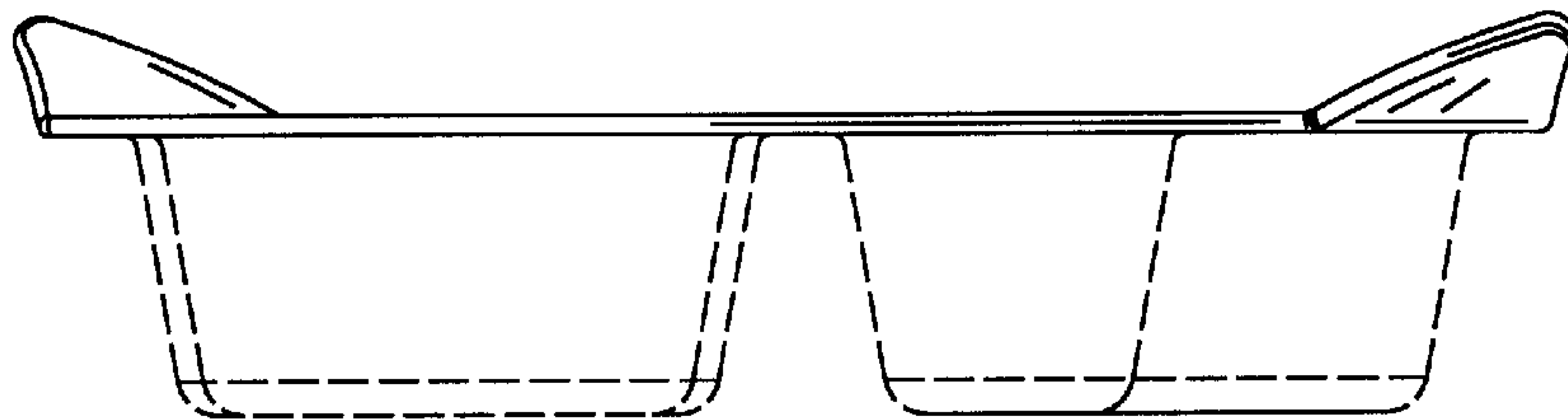

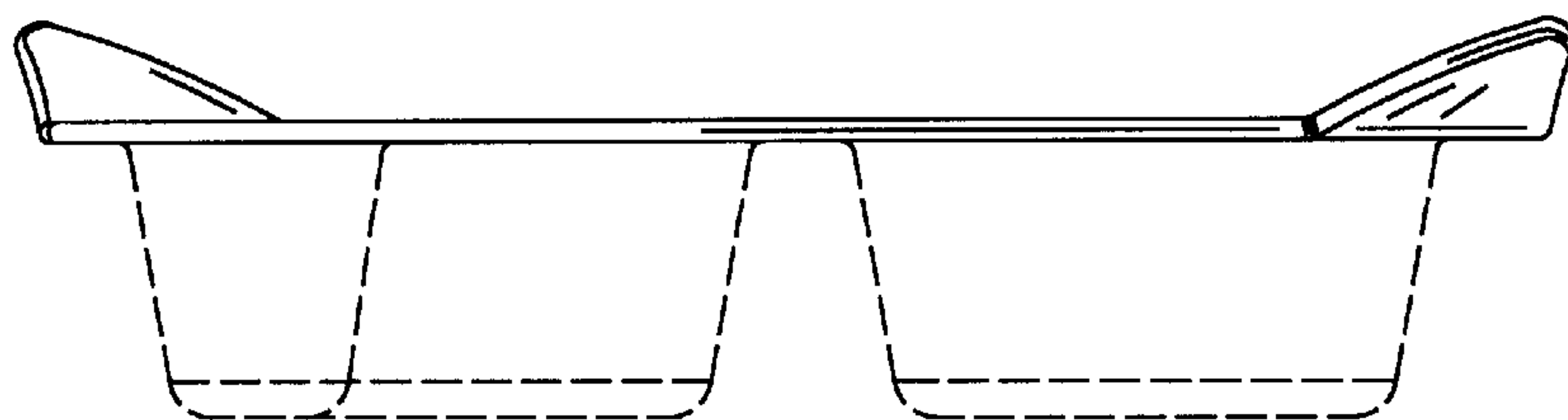

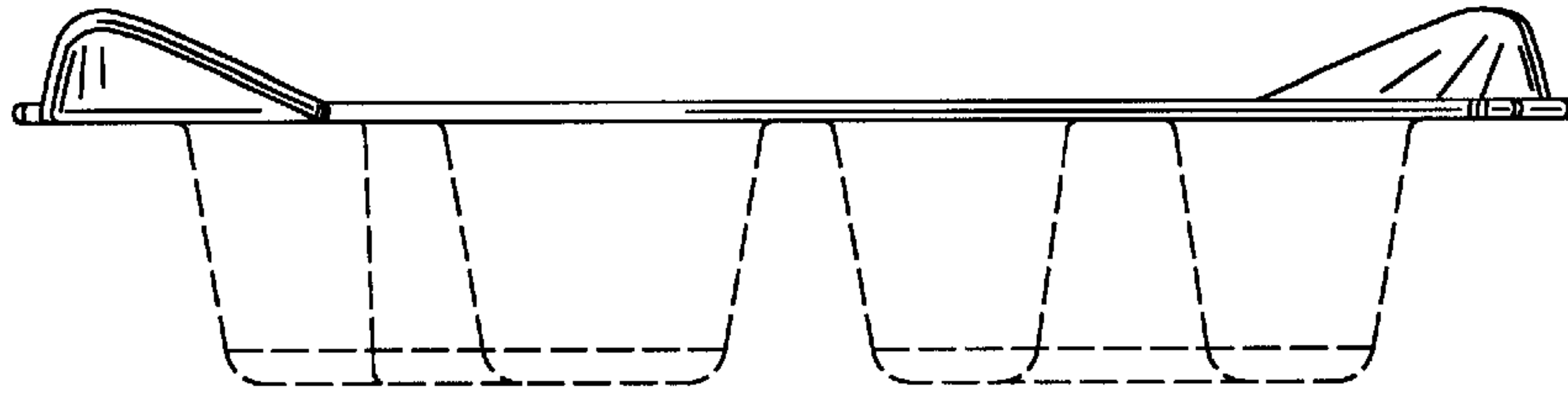

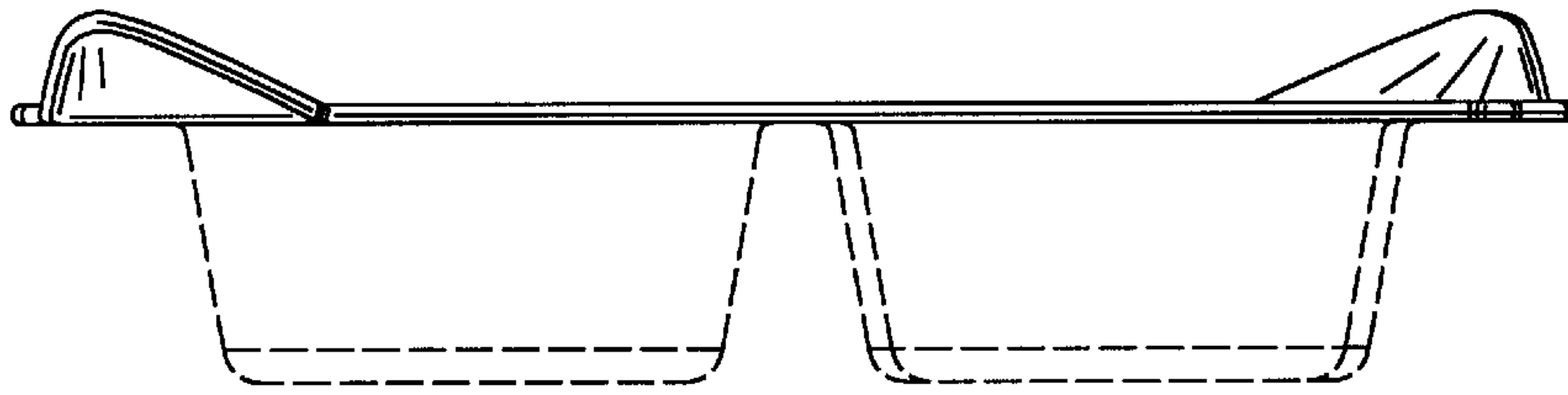

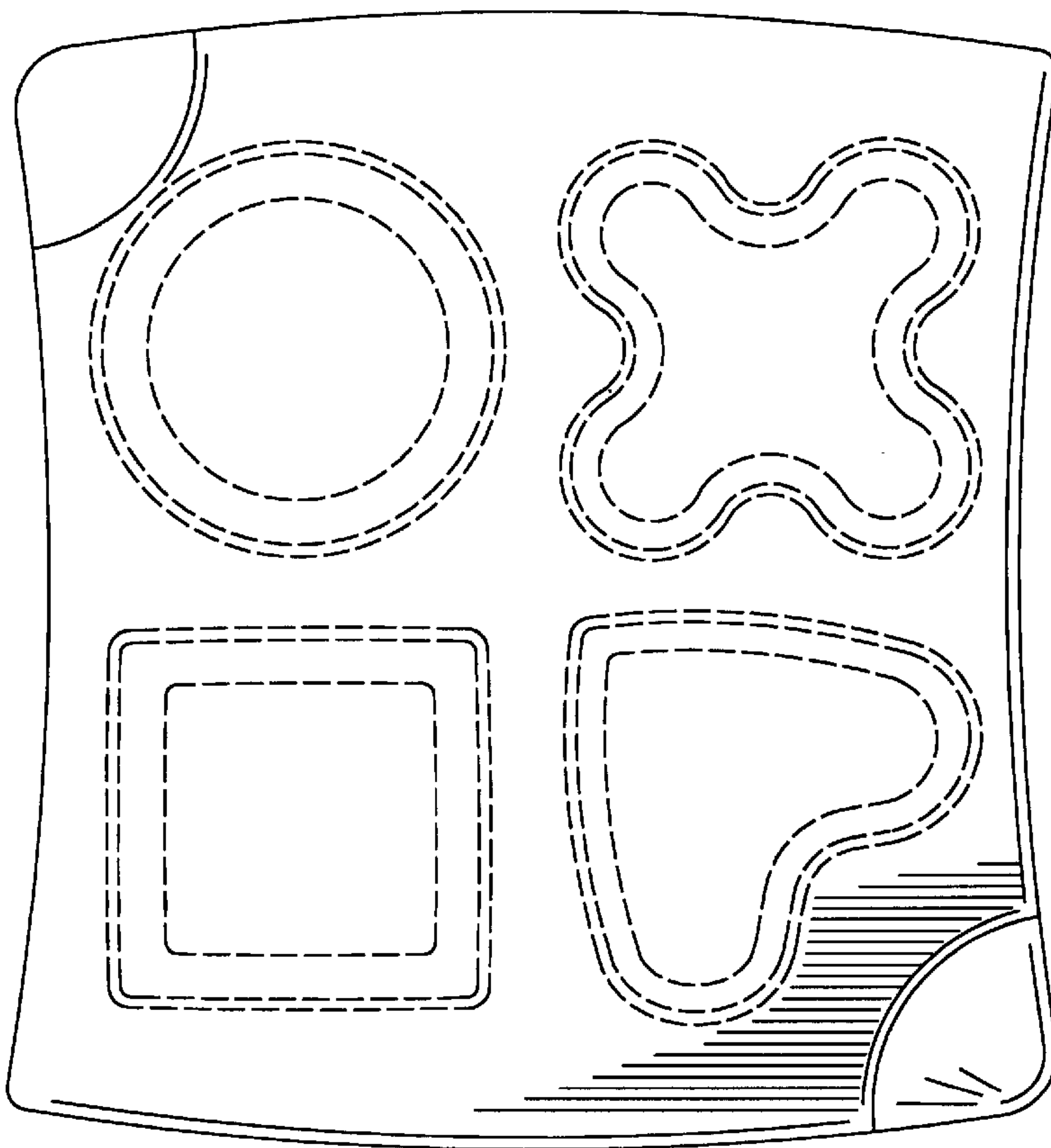

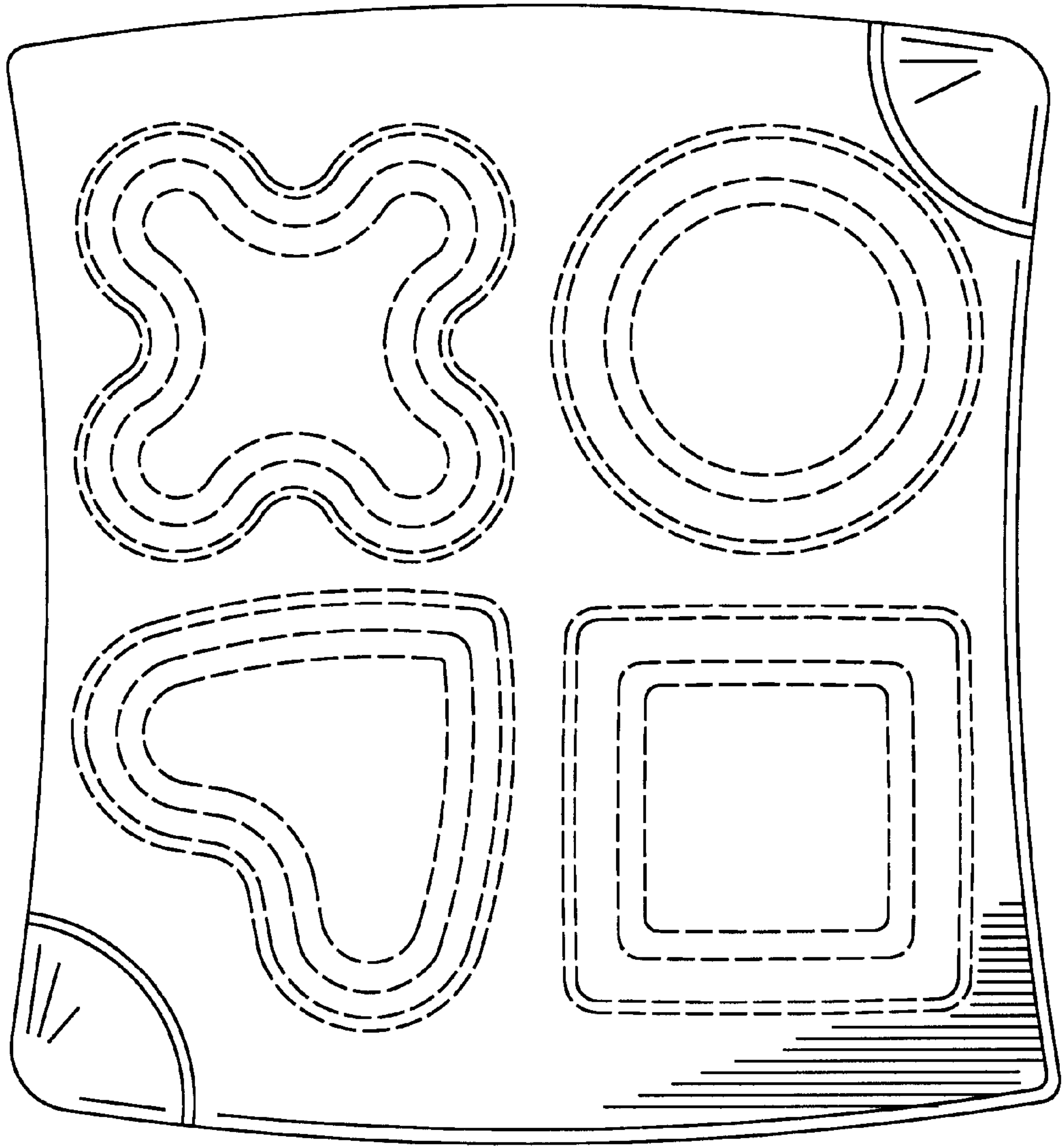
