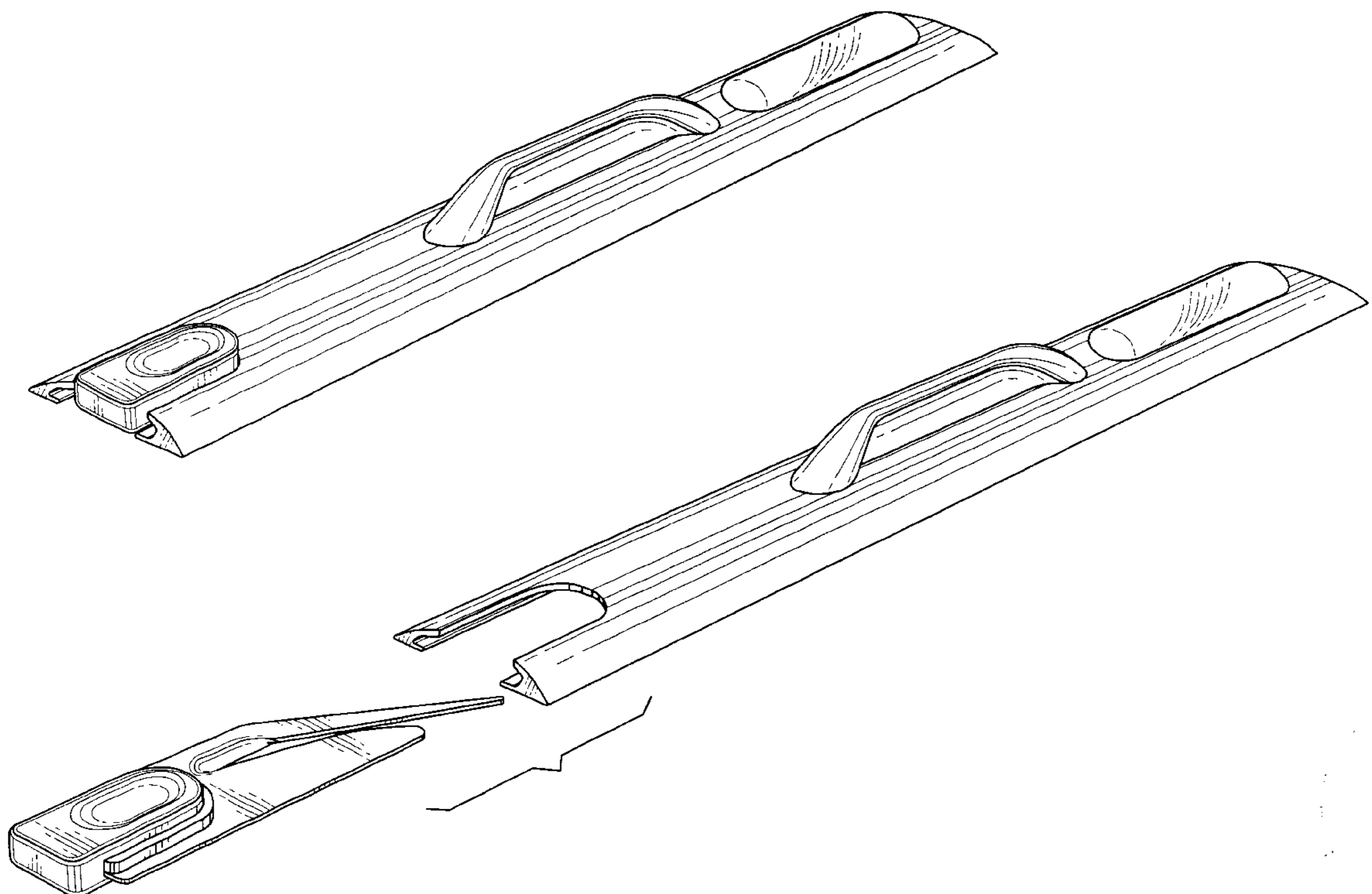
(57) **CLAIM**

The ornamental design for ruler with letter opener and magnifier, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and left perspective view of the ruler with letter opener and magnifier showing my new design;  
 FIG. 2 is top plan view of the ruler with letter opener and magnifier of FIG. 1;  
 FIG. 3 is a front elevation view, the rear elevation view is a mirror image thereof;  
 FIG. 4 is a bottom view of the ruler with letter opener and magnifier of FIG. 1;  
 FIG. 5 is a left end view of the ruler with letter opener and magnifier of FIG. 1;  
 FIG. 6 is a right end view of the ruler with letter opener and magnifier of FIG. 1;  
 FIG. 7 is an exploded top and left view thereof;  
 FIG. 8 is a top plan view of the letter opener shown separately for ease of illustration, drawn on an enlarged scale;  
 FIG. 9 is a front view of the letter opener of FIG. 8;  
 FIG. 10 is a bottom plan view of the letter opener of FIG. 8;  
 FIG. 11 is a rear view of the letter opener of FIG. 8;  
 FIG. 12 is a left side view of the letter opener of FIG. 8; and,  
 FIG. 13 is a right side view of the letter opener of FIG. 8.

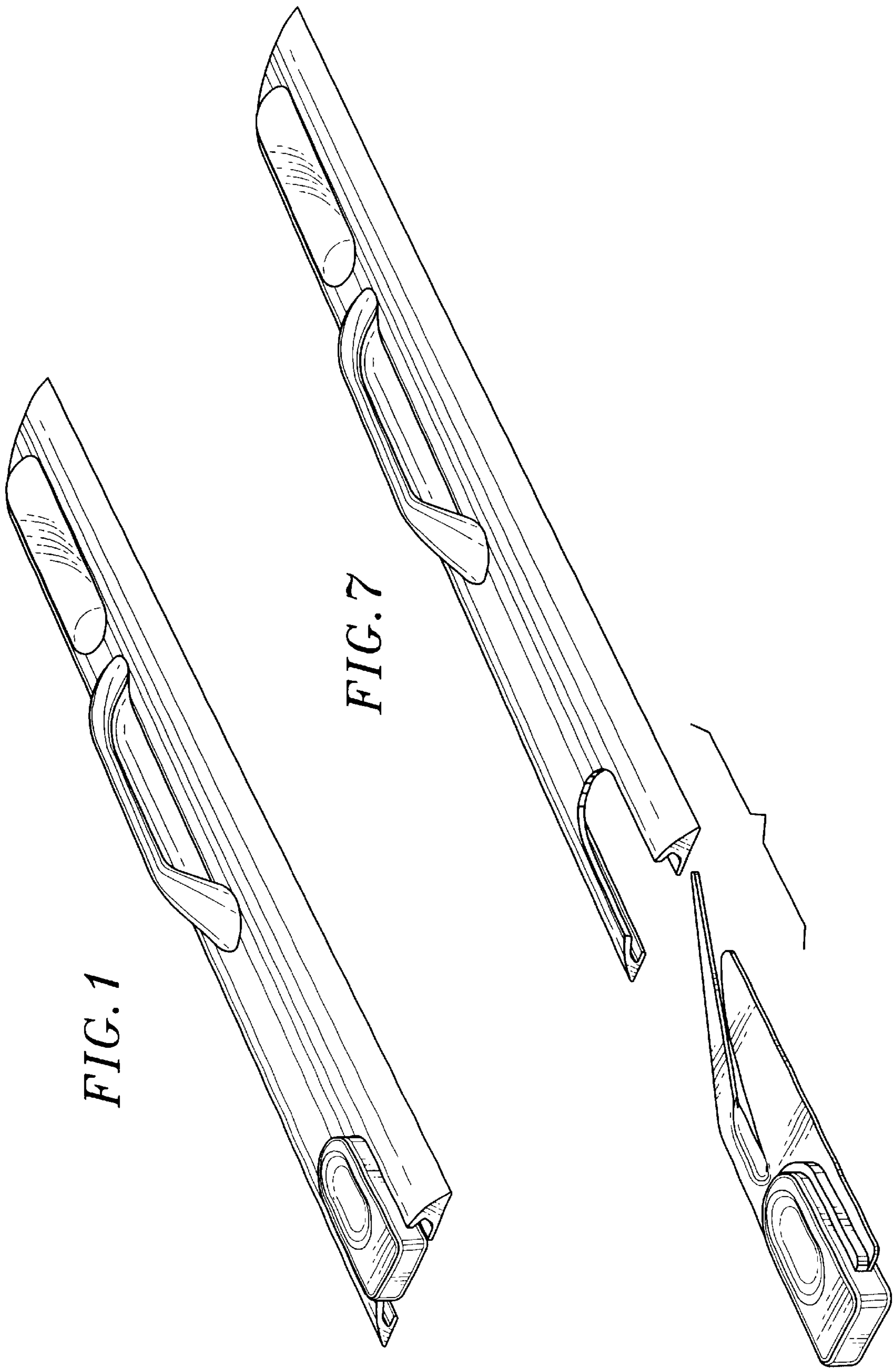

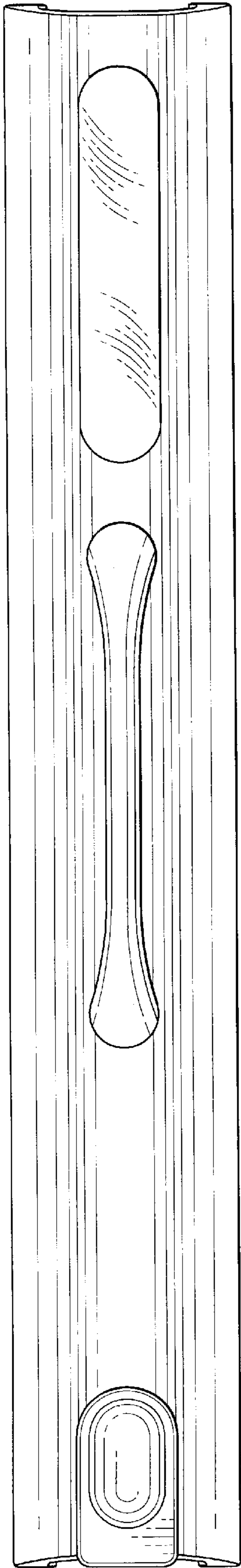
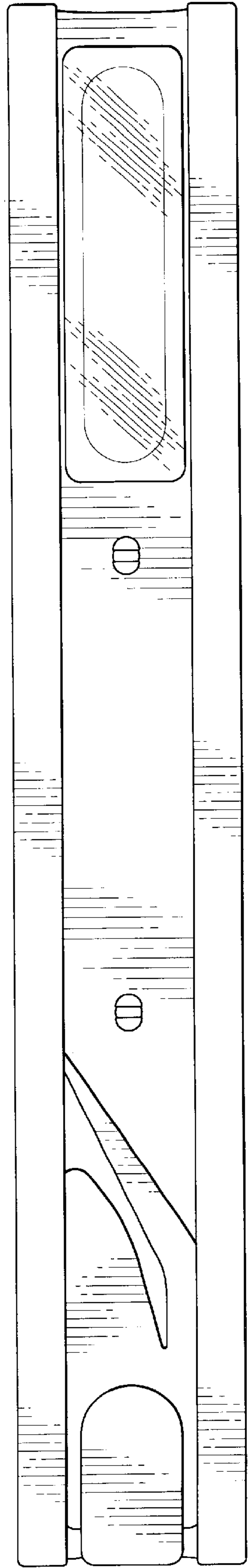


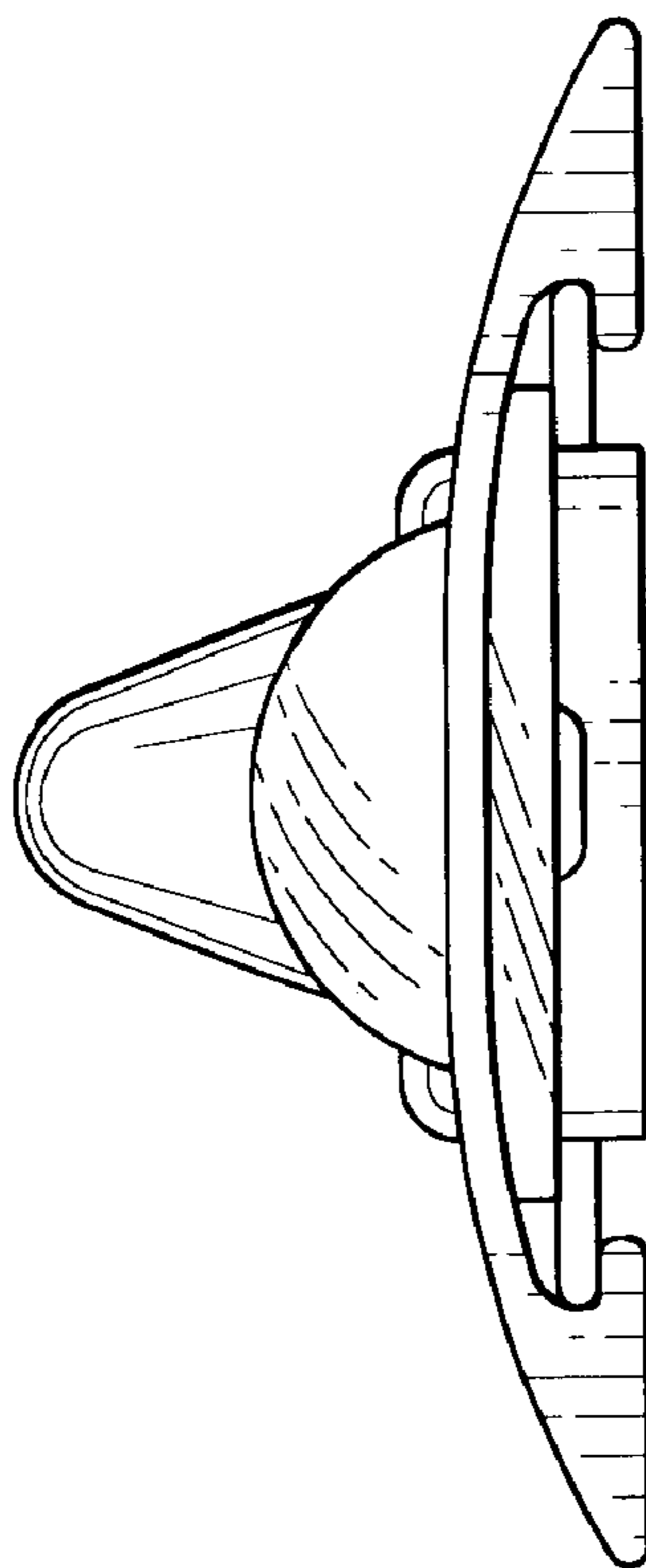

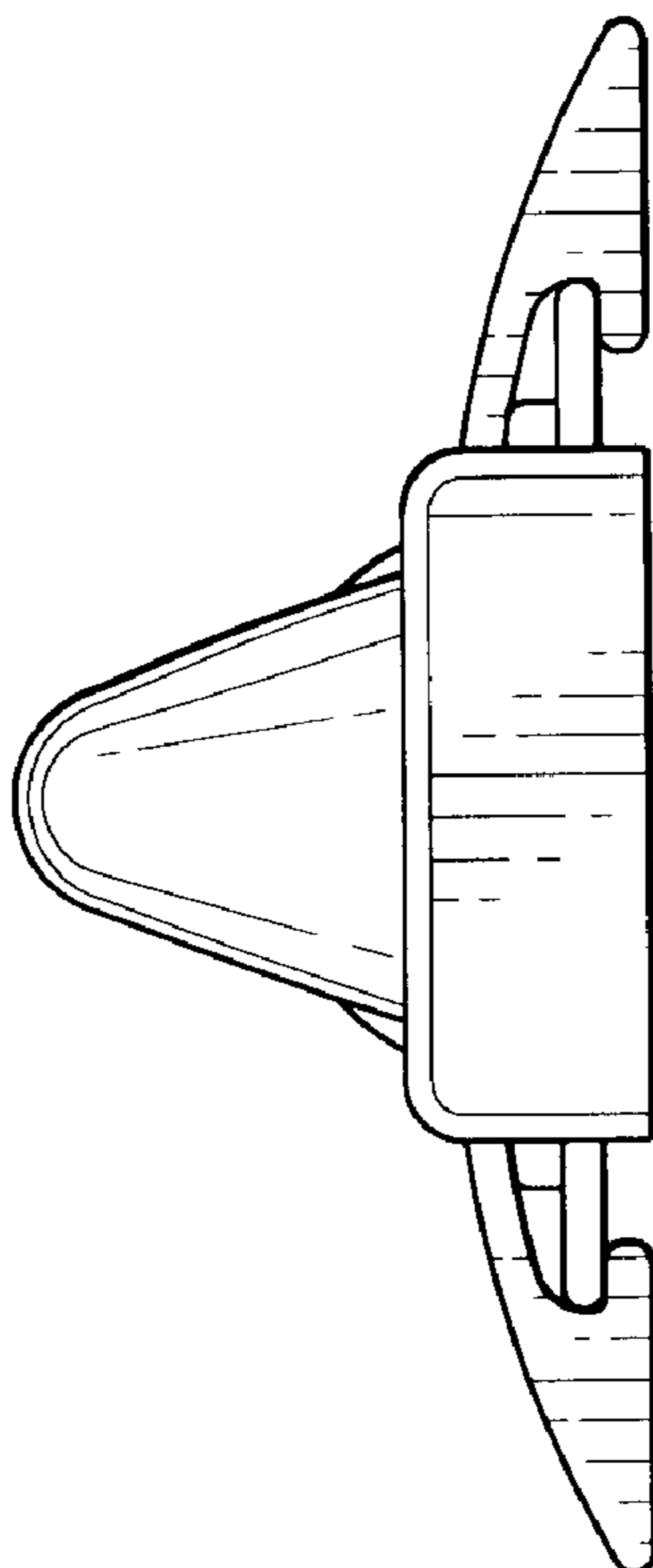

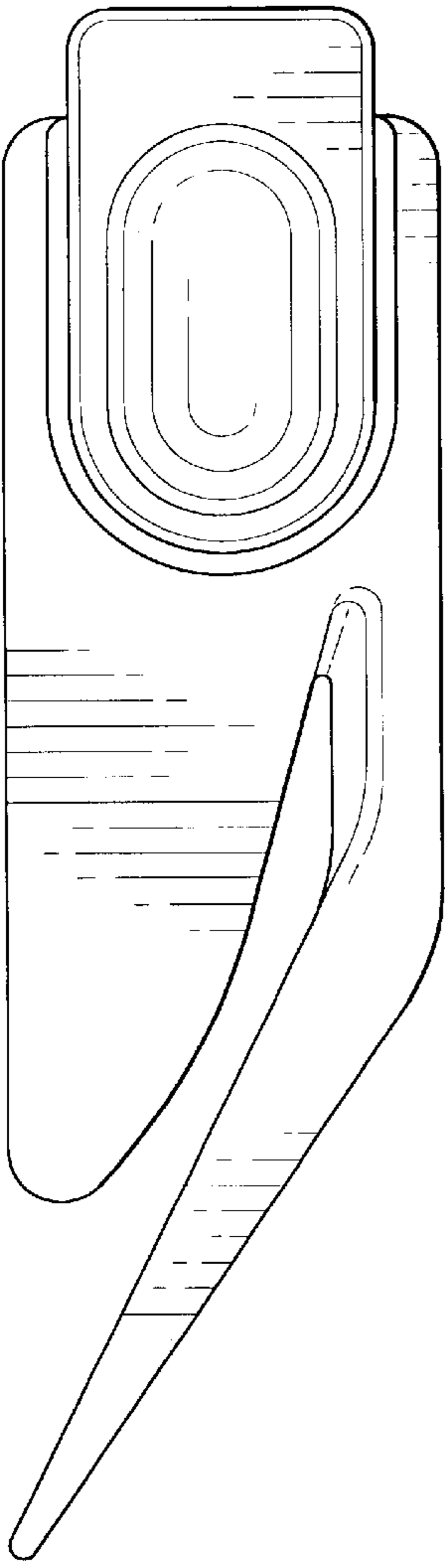

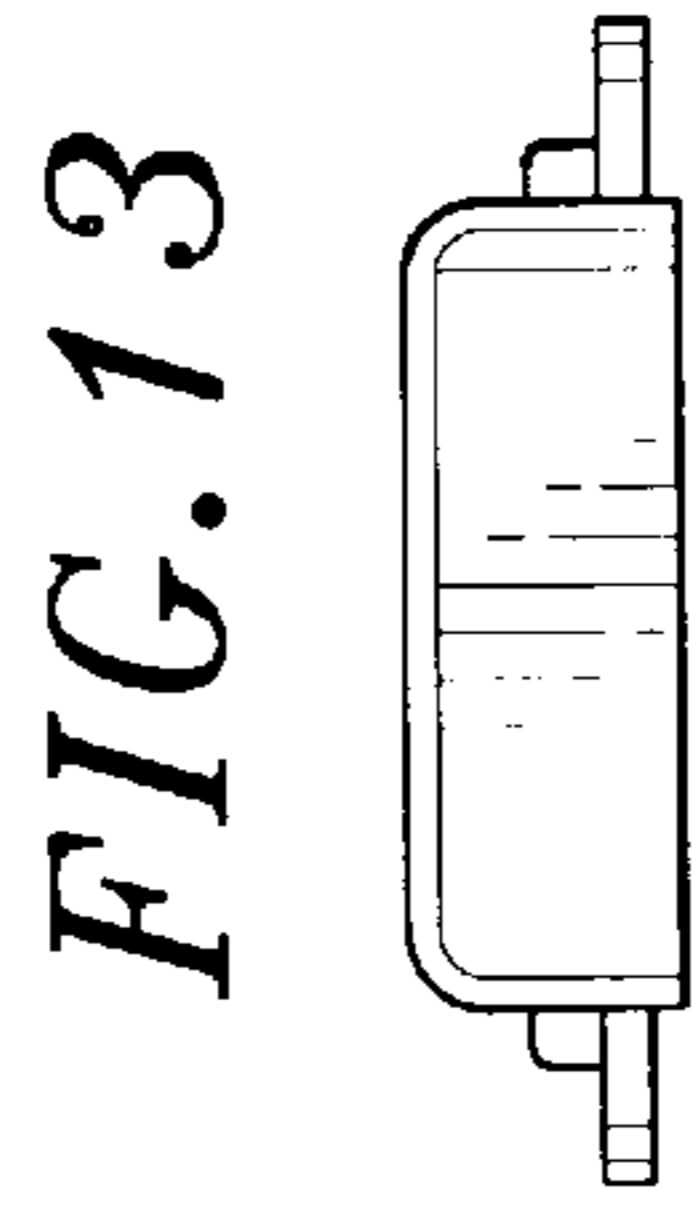

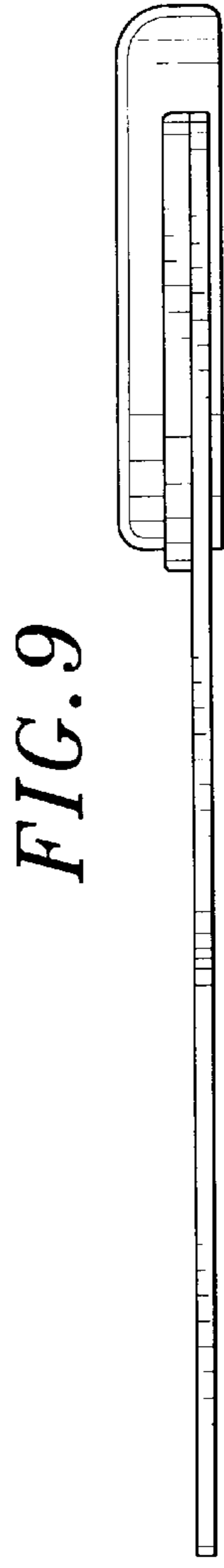

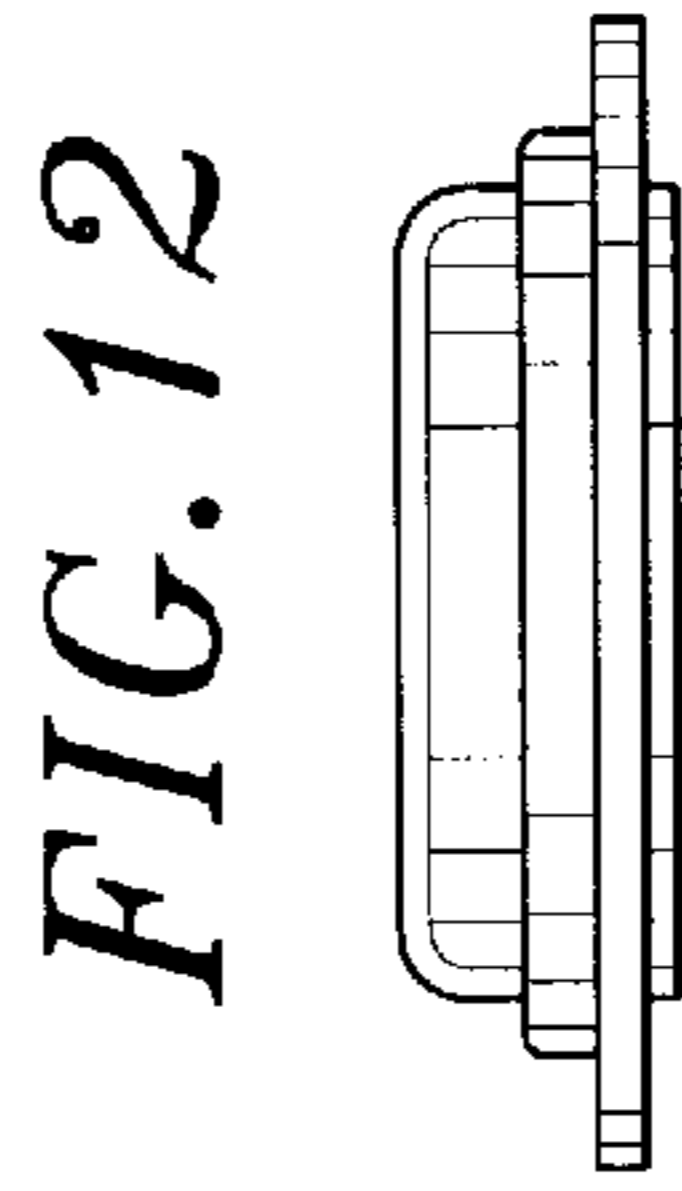

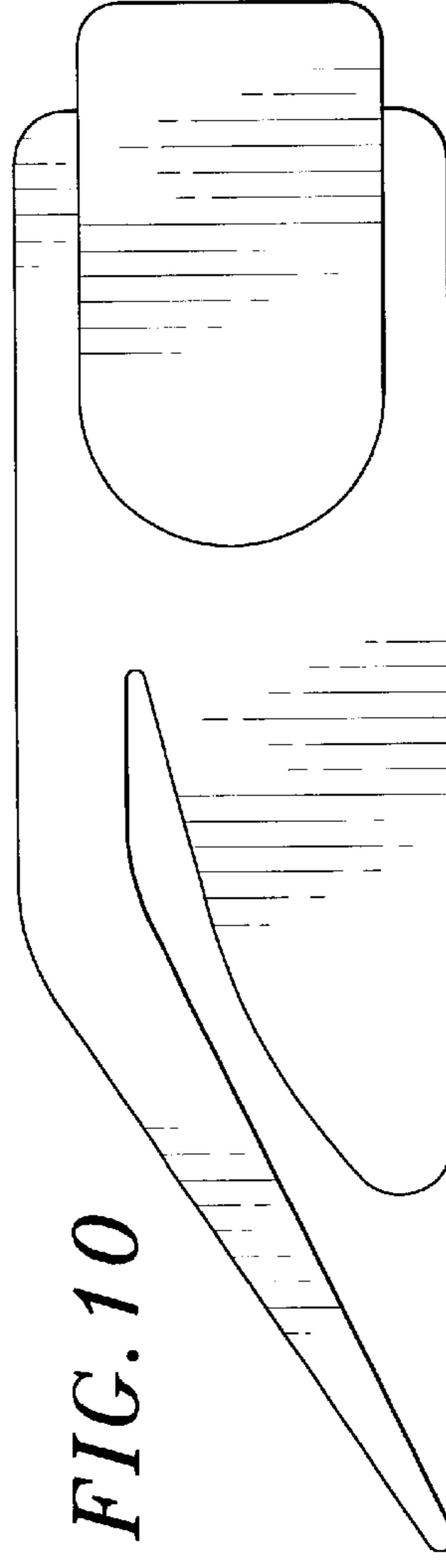
