(57) **CLAIM**

The ornamental design for a boxed, protected candy or chocolate egg, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a boxed, protected candy or chocolate egg showing the new design;

FIG. 2 is a sectional view thereof taken along a vertical plane along line 2—2 in FIG. 1.

FIG. 3 is a front elevational view thereof;

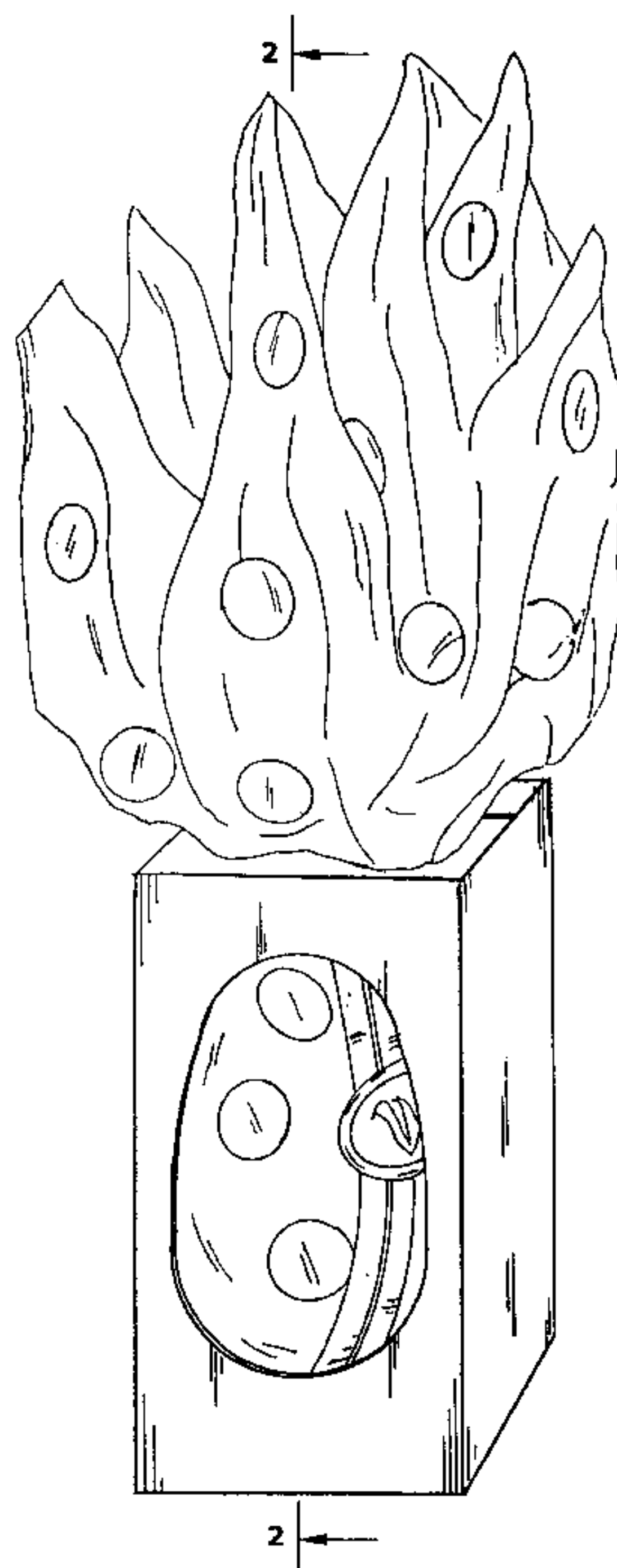
FIGS. 4, 5 and 6 are rear, left side and right side views thereof, respectively;

FIG. 7 is a bottom view thereof;

FIG. 8 is a horizontal sectional top view along line 8—8 in FIG. 3; and,

FIG. 9, 10 and 11 are, respectively, right side, and left side elevational views of a second embodiment of a boxed, protected candy or chocolate egg, the rear side, top and bottom views thereof being identical to FIGS. 4, 8 and 7, respectively.

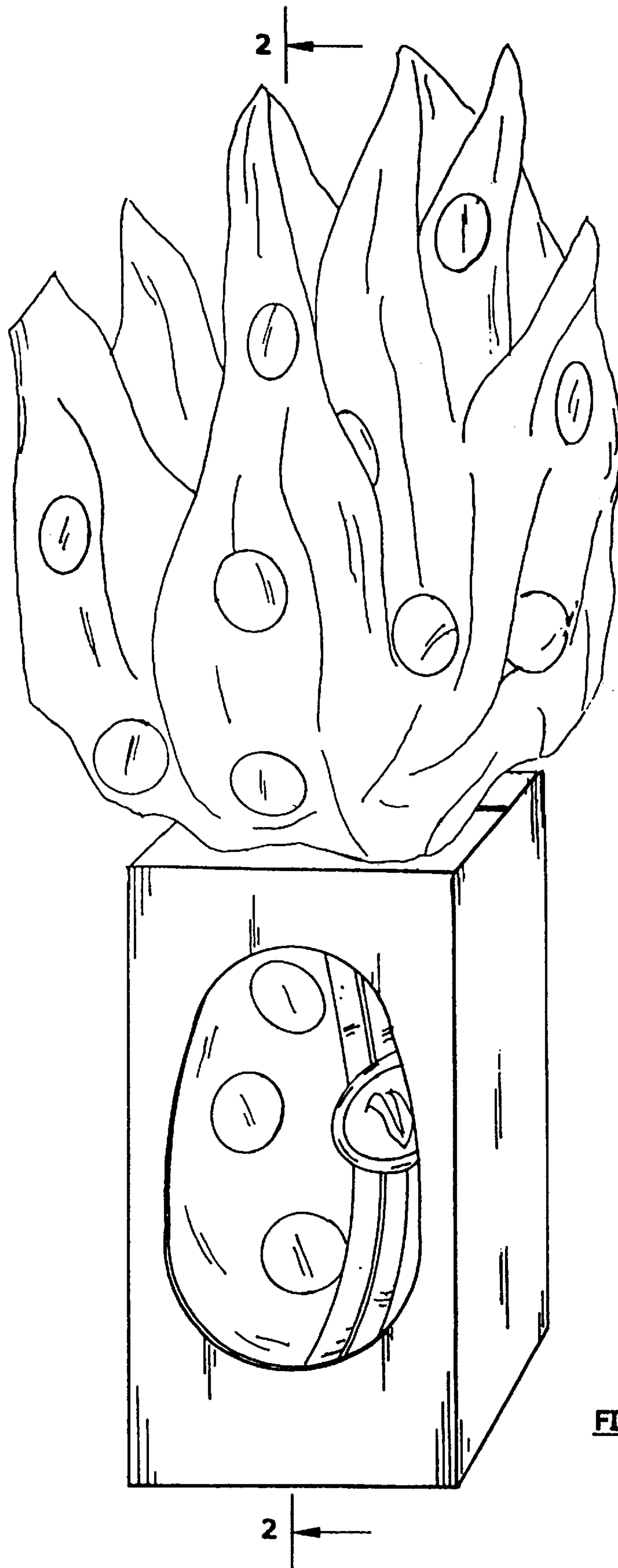

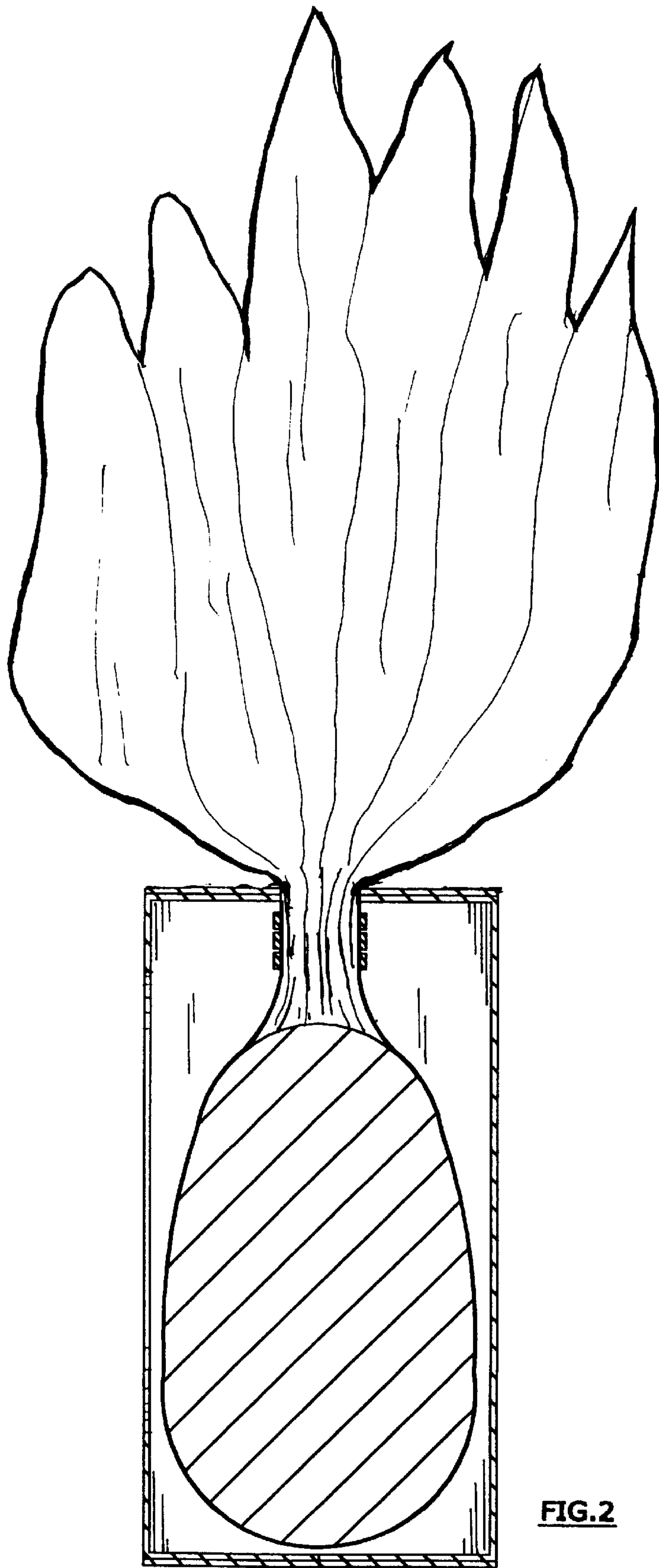

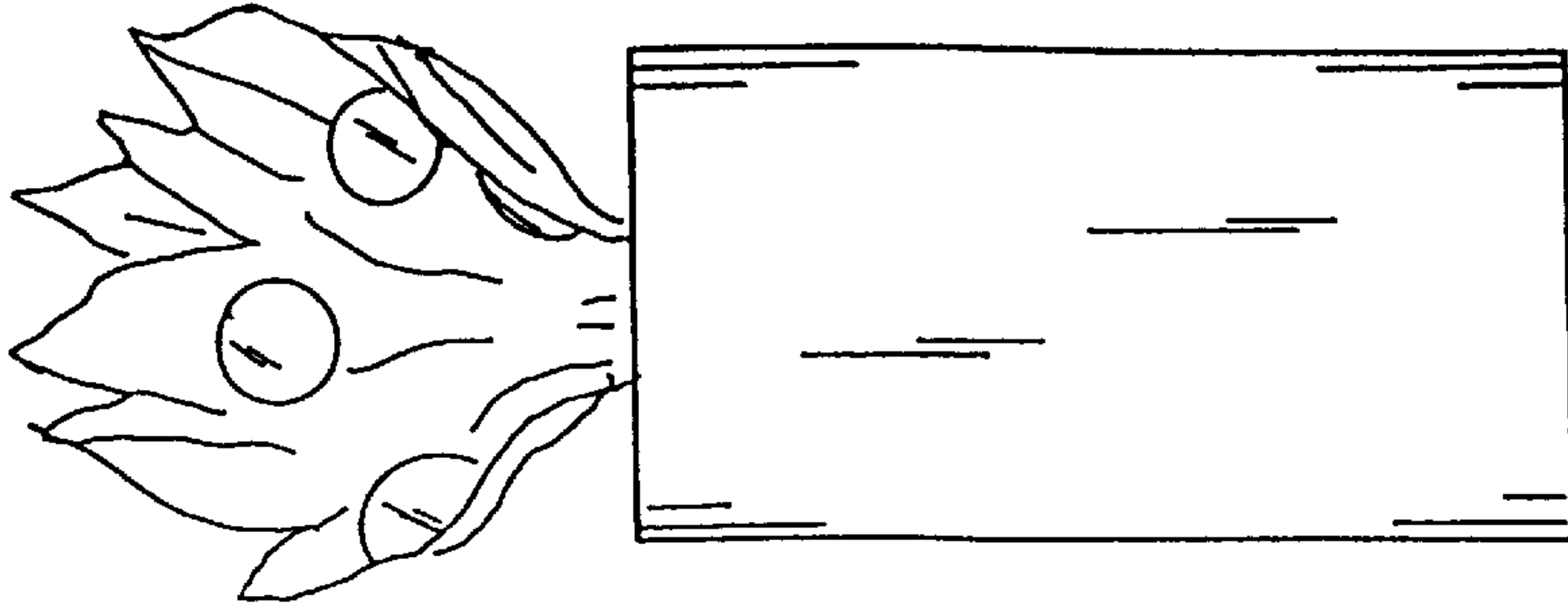

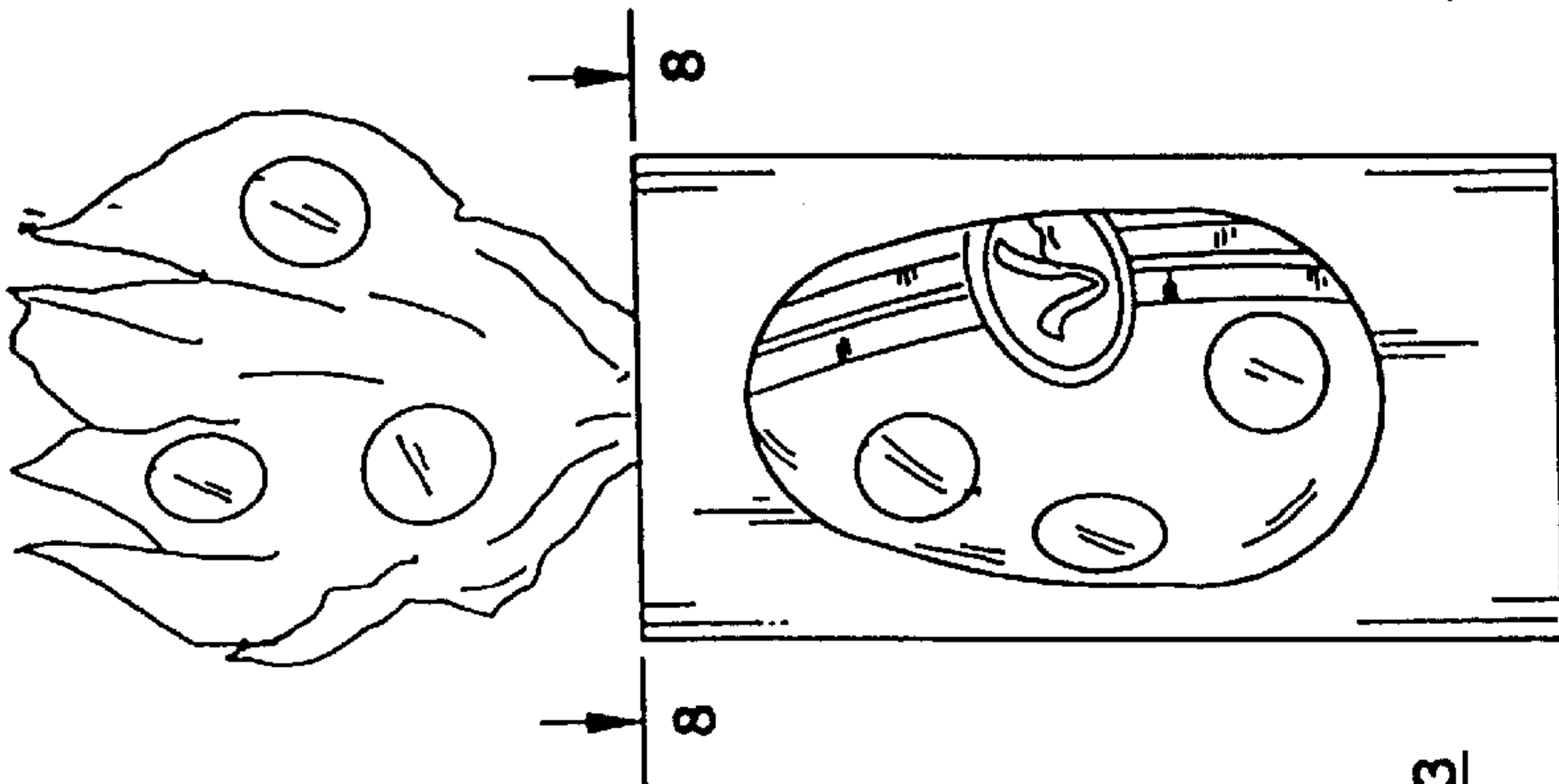

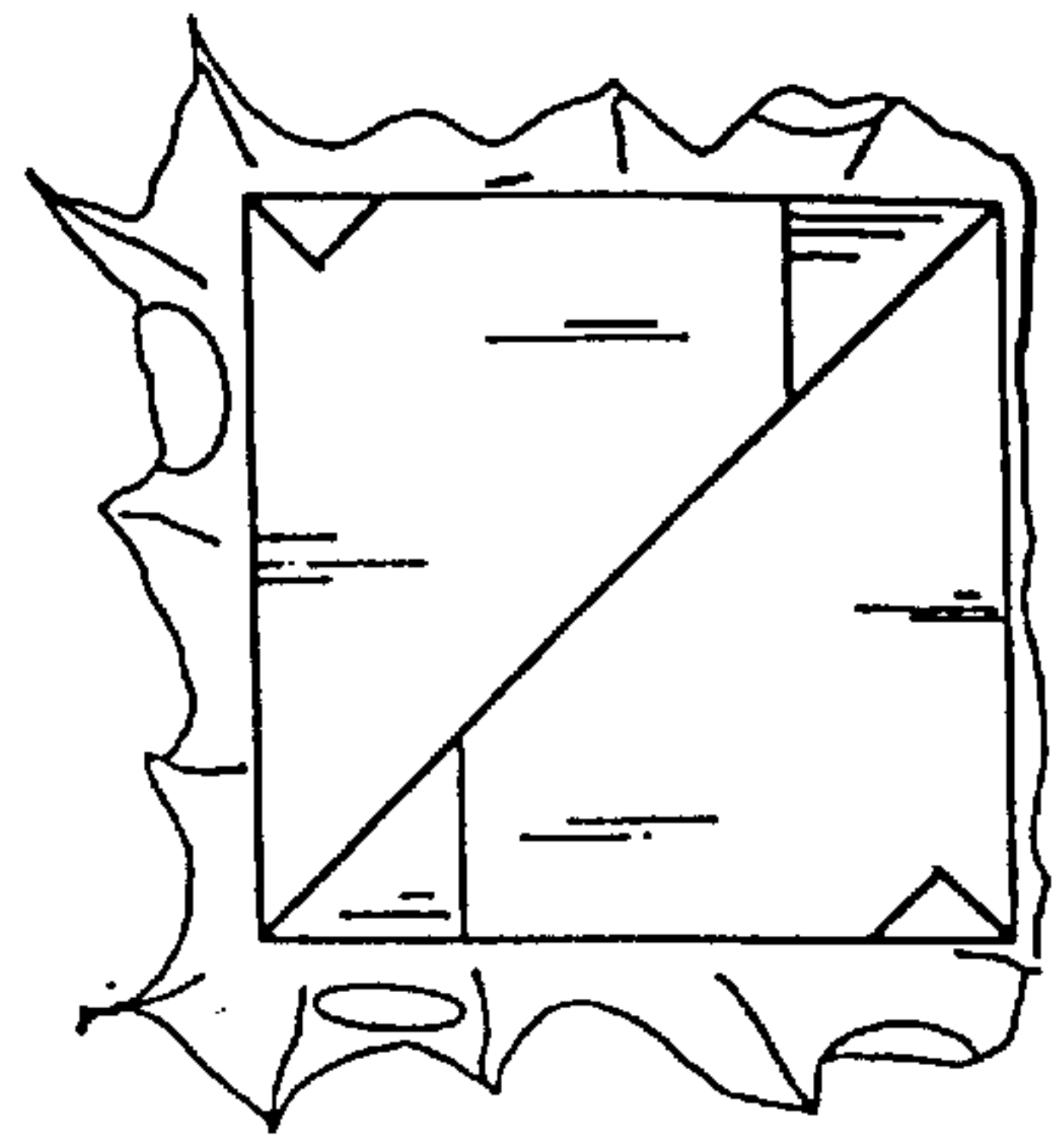

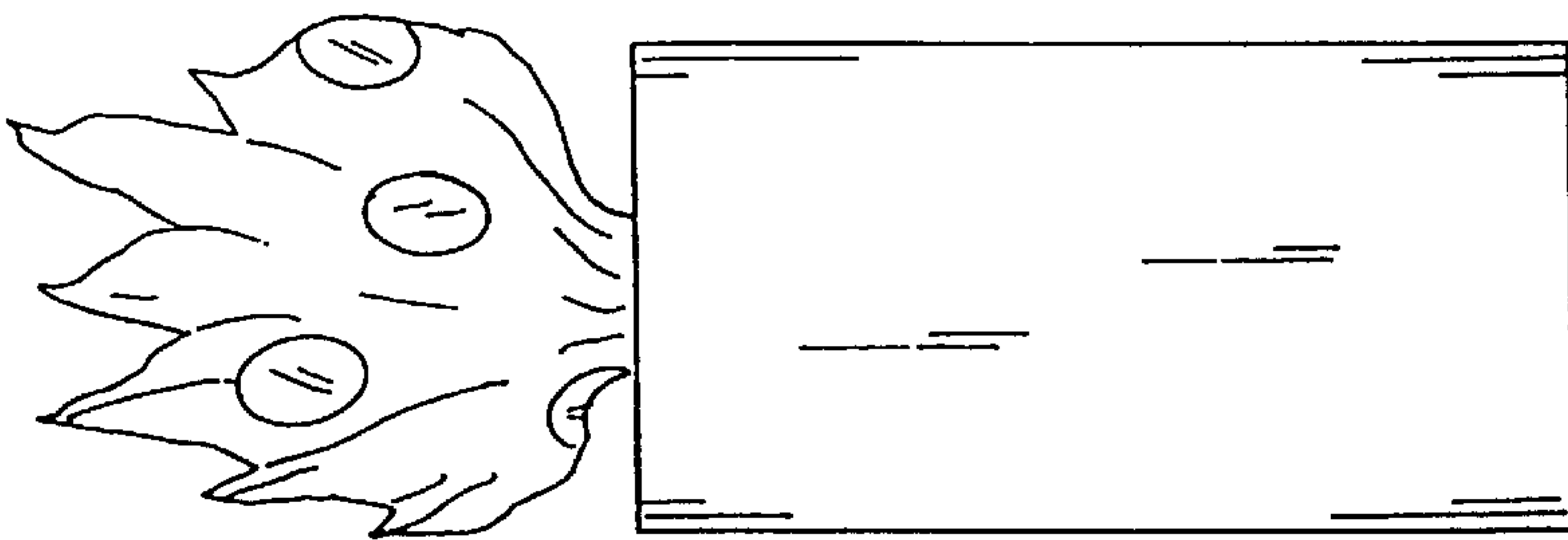

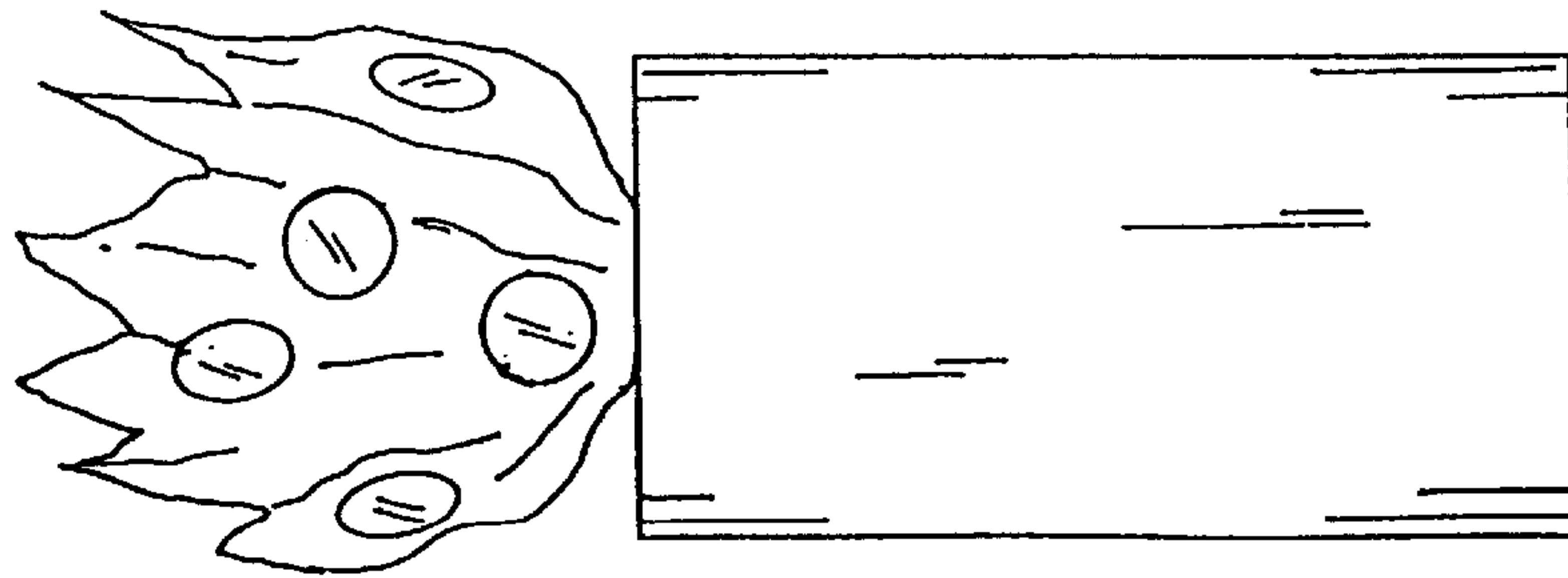

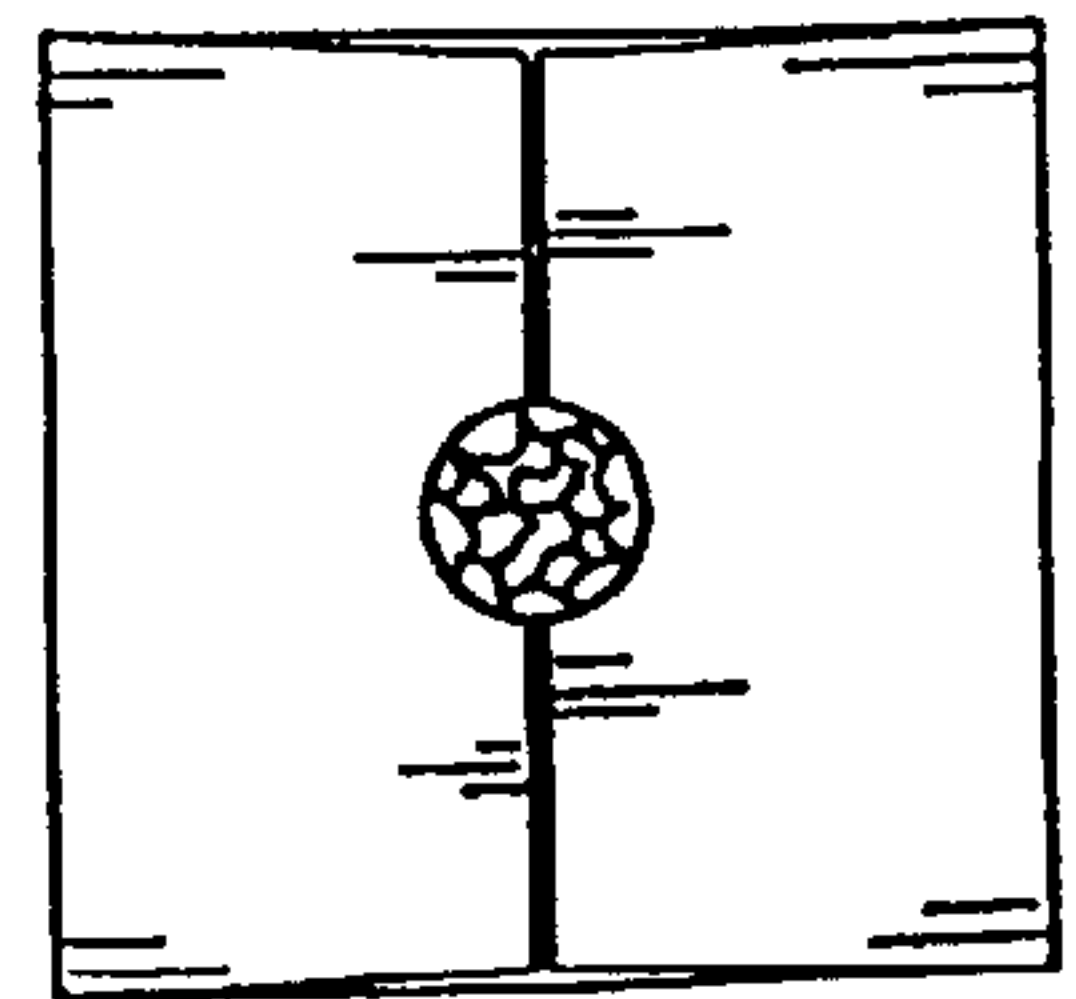

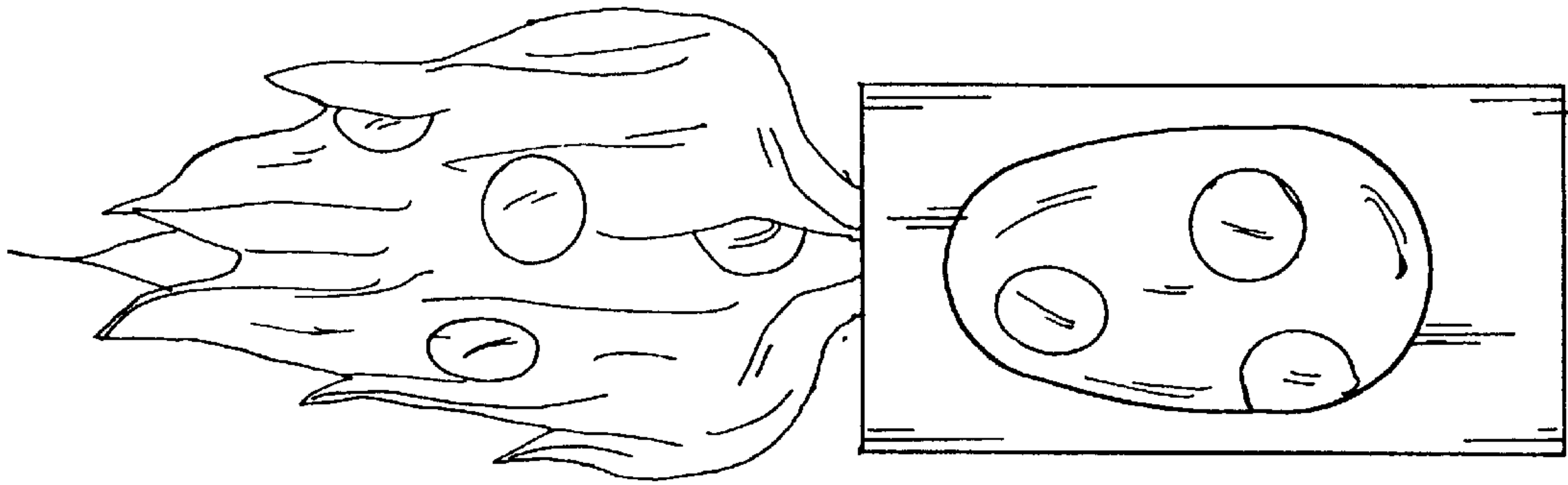

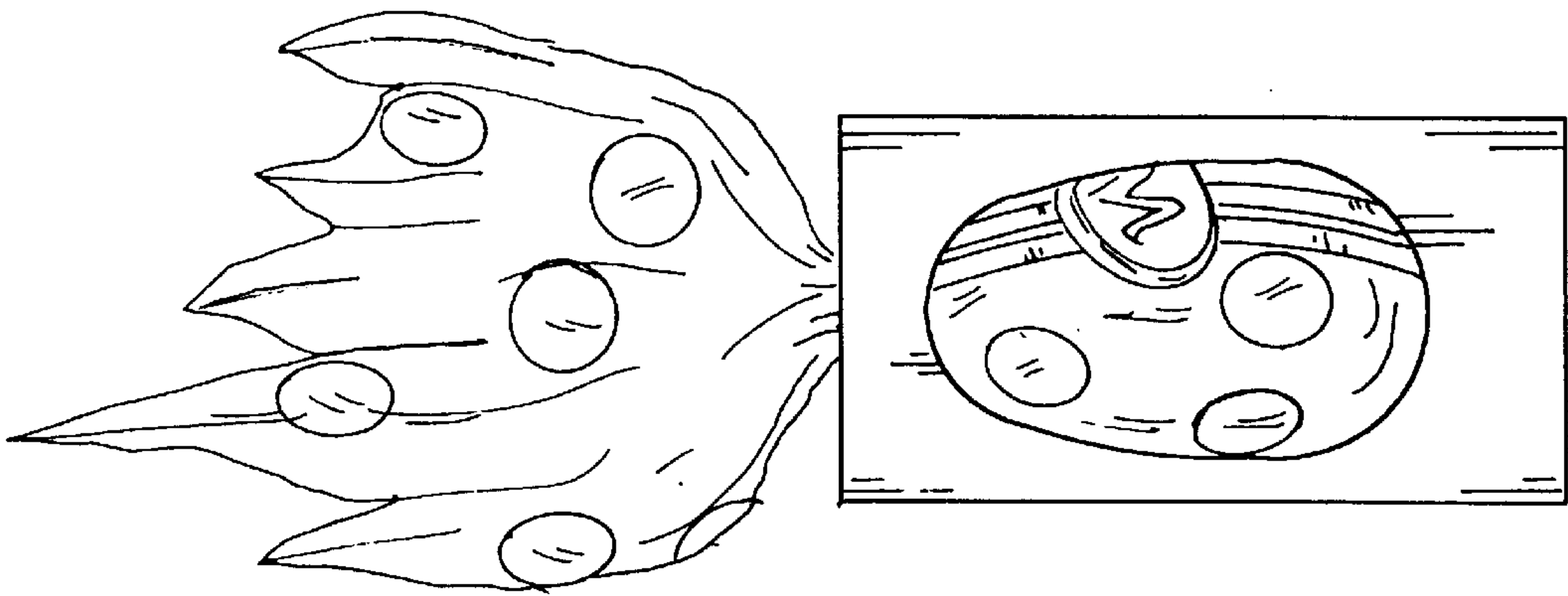

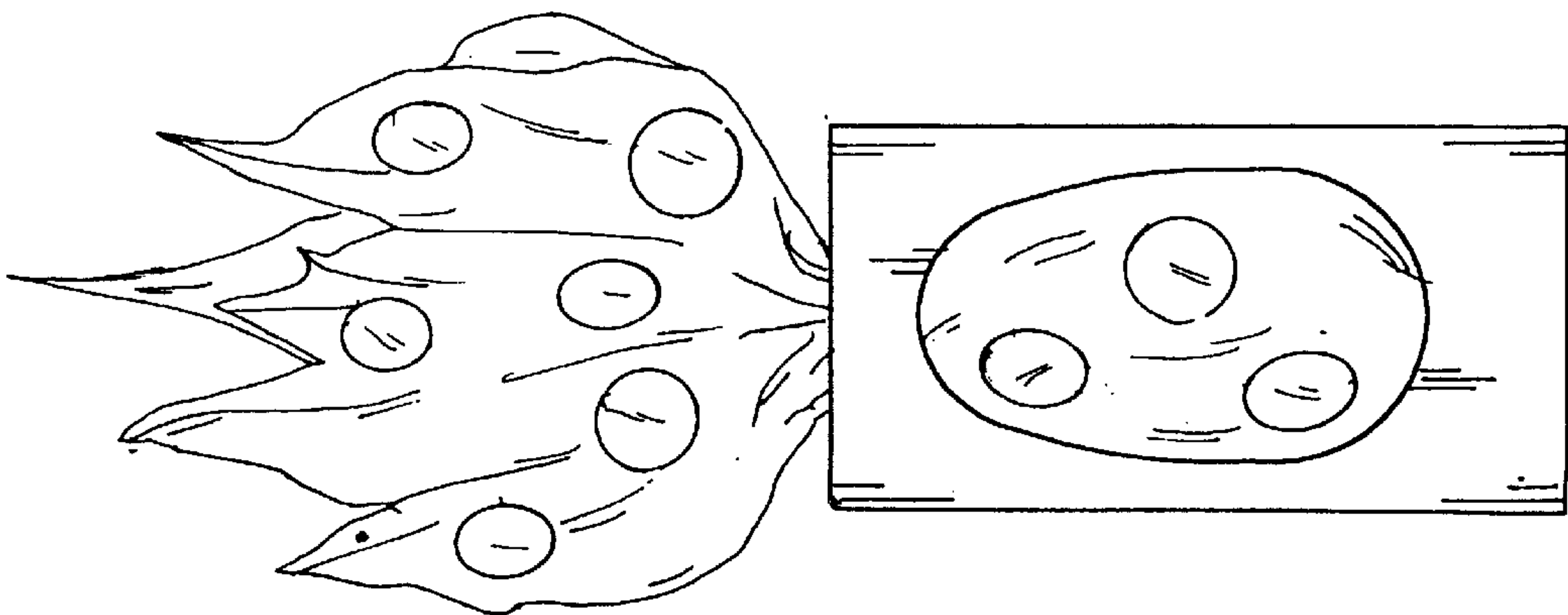
