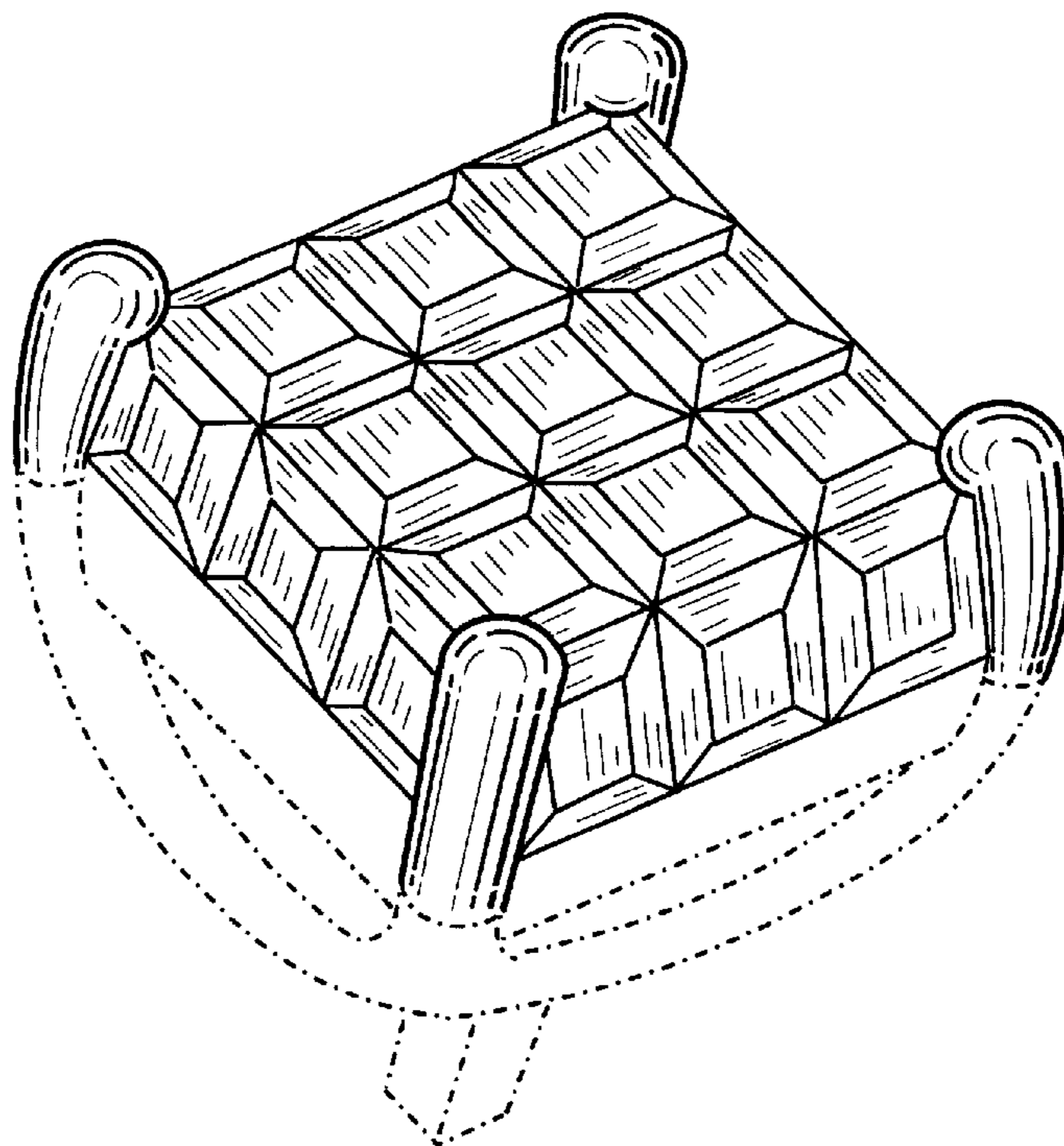
(57) **CLAIM**

The ornamental design of a jewelry setting, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a jewelry setting of my new design; FIG. 2 is a top view of the jewelry setting shown in FIG. 1; FIG. 3 is a perspective view of a second embodiment of the jewelry setting of my new design; FIG. 4 is a top view of the jewelry setting shown in FIG. 3; FIG. 5 is a perspective view of a third embodiment of the jewelry setting of my new design; and, FIG. 6 is a top view of the jewelry setting shown in FIG. 5. 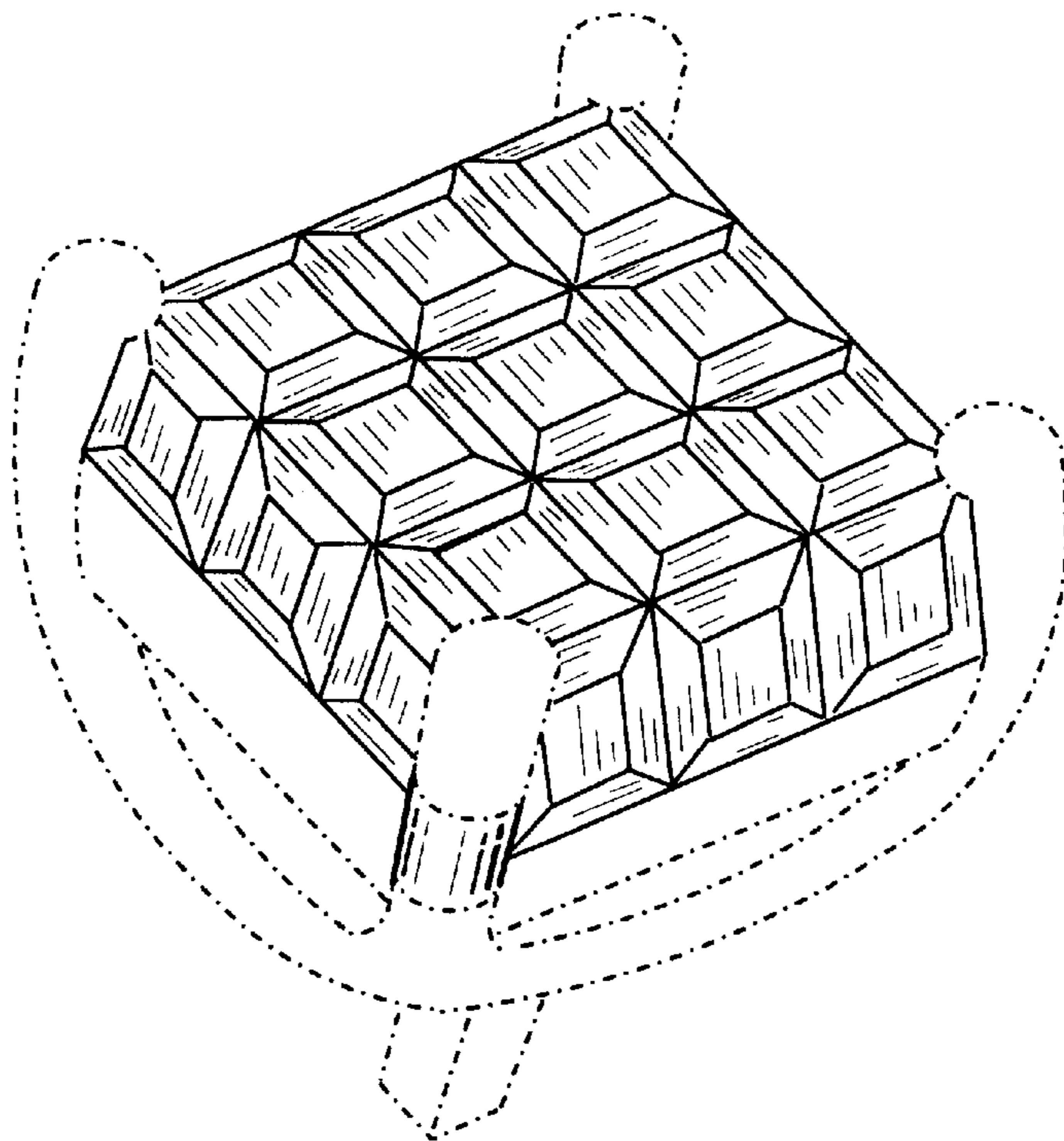

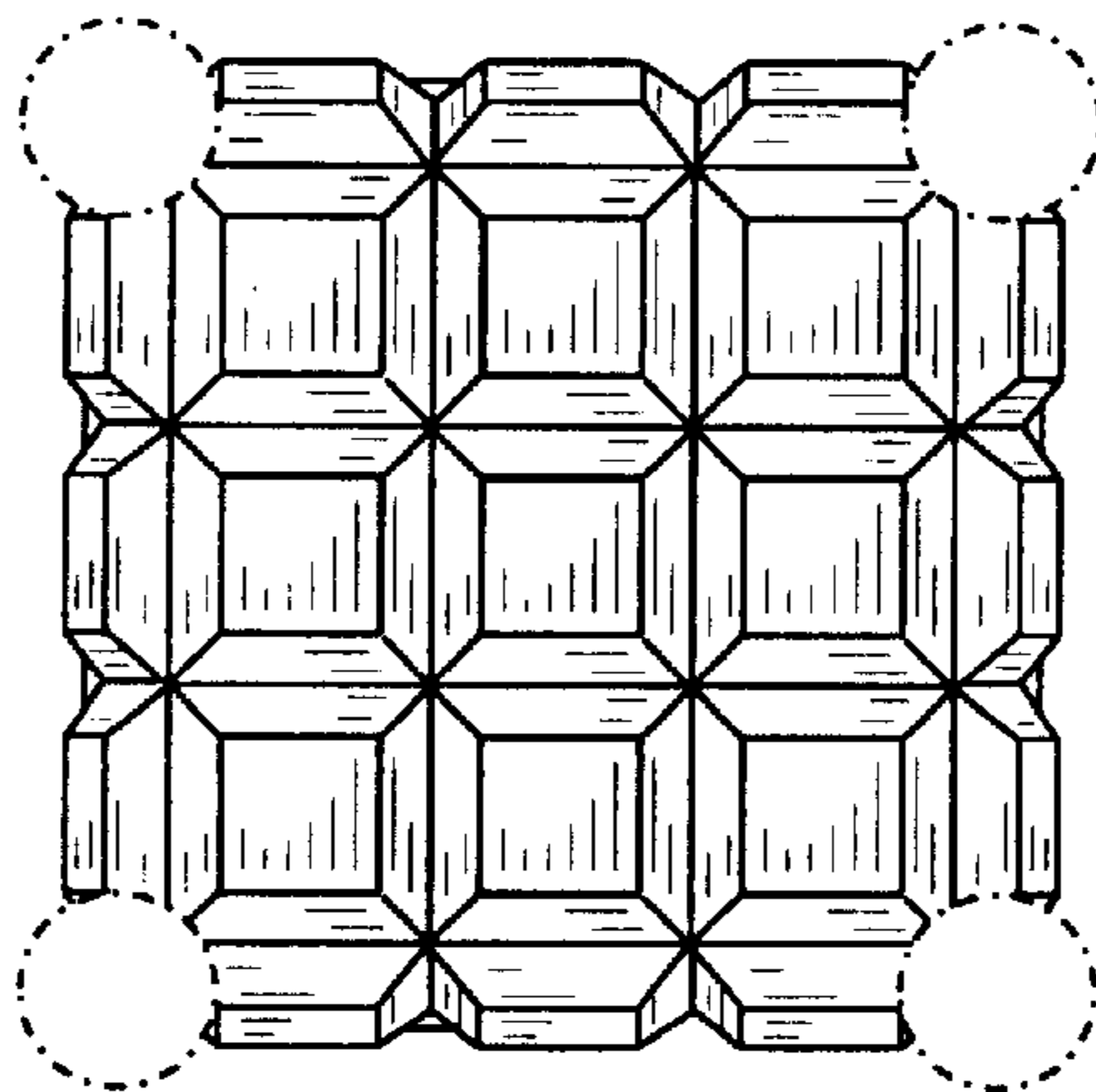

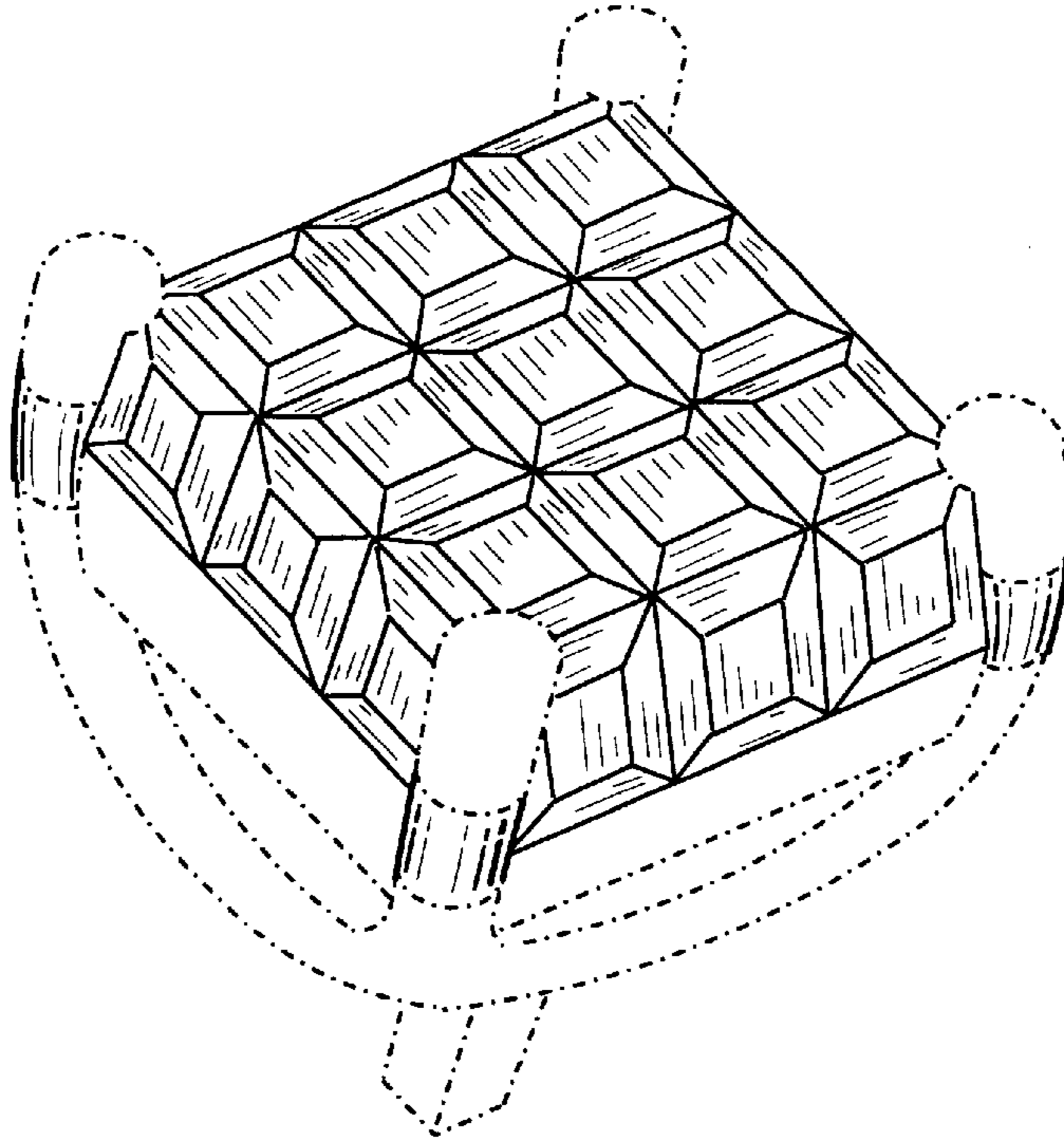

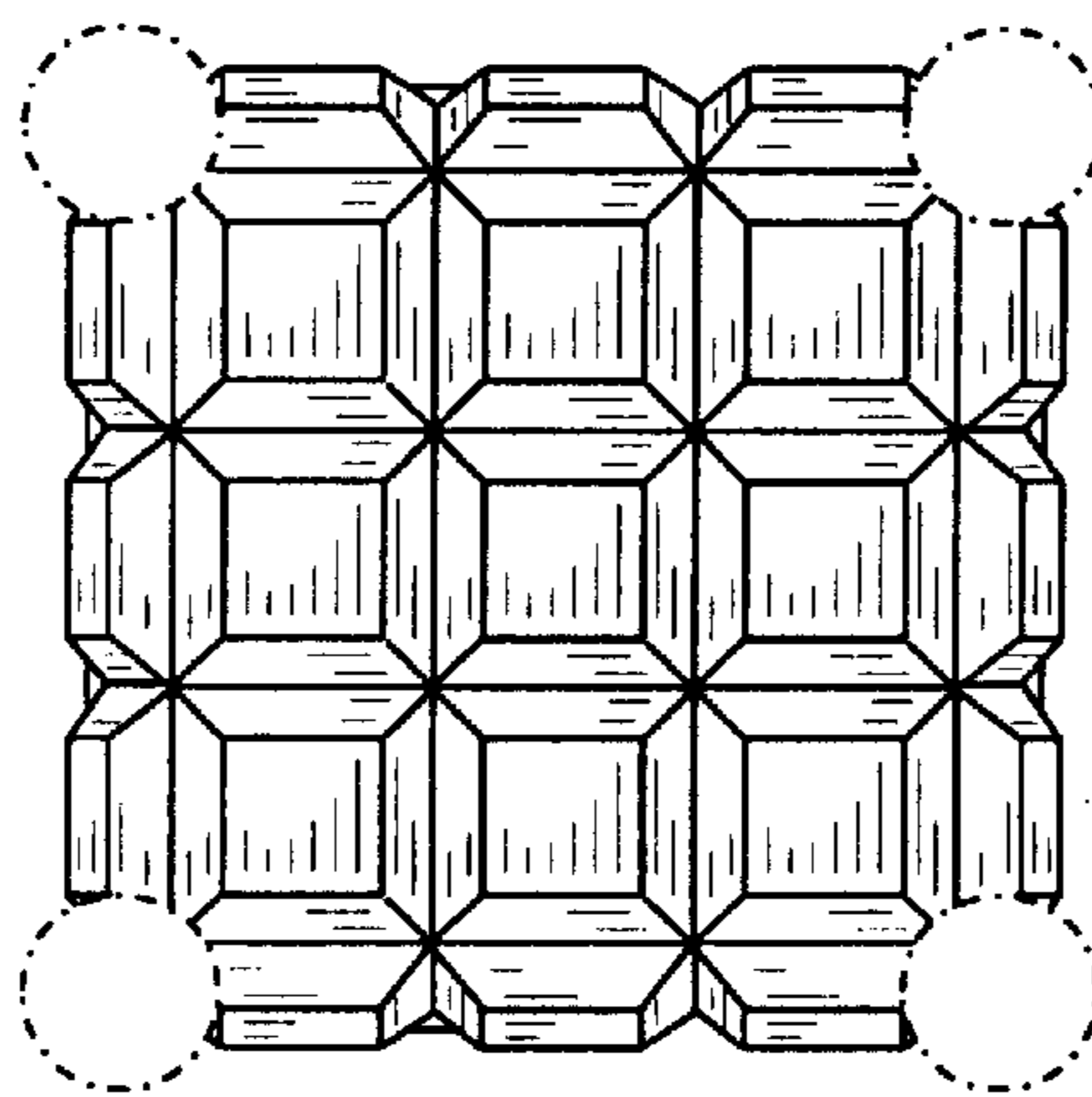

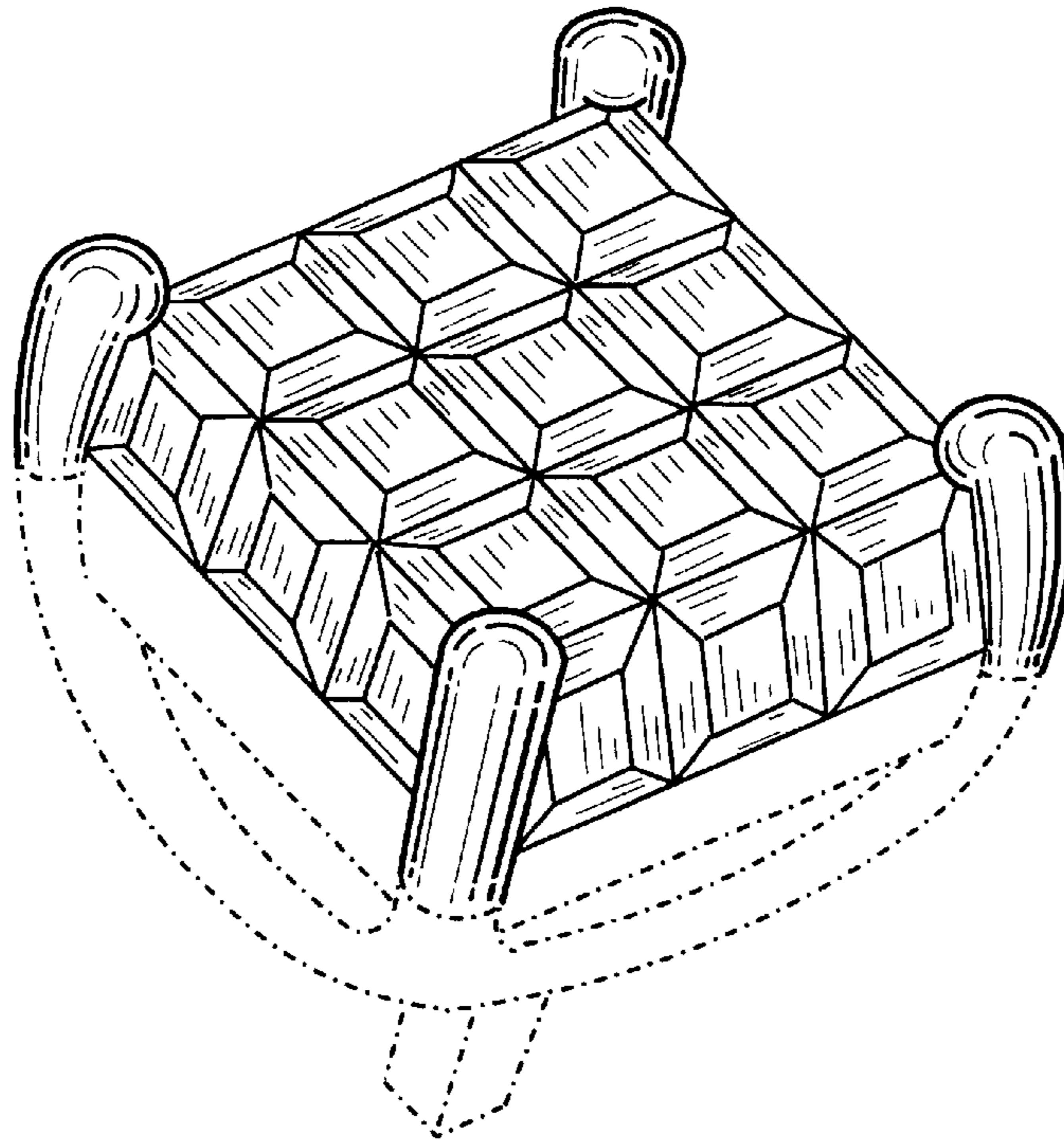

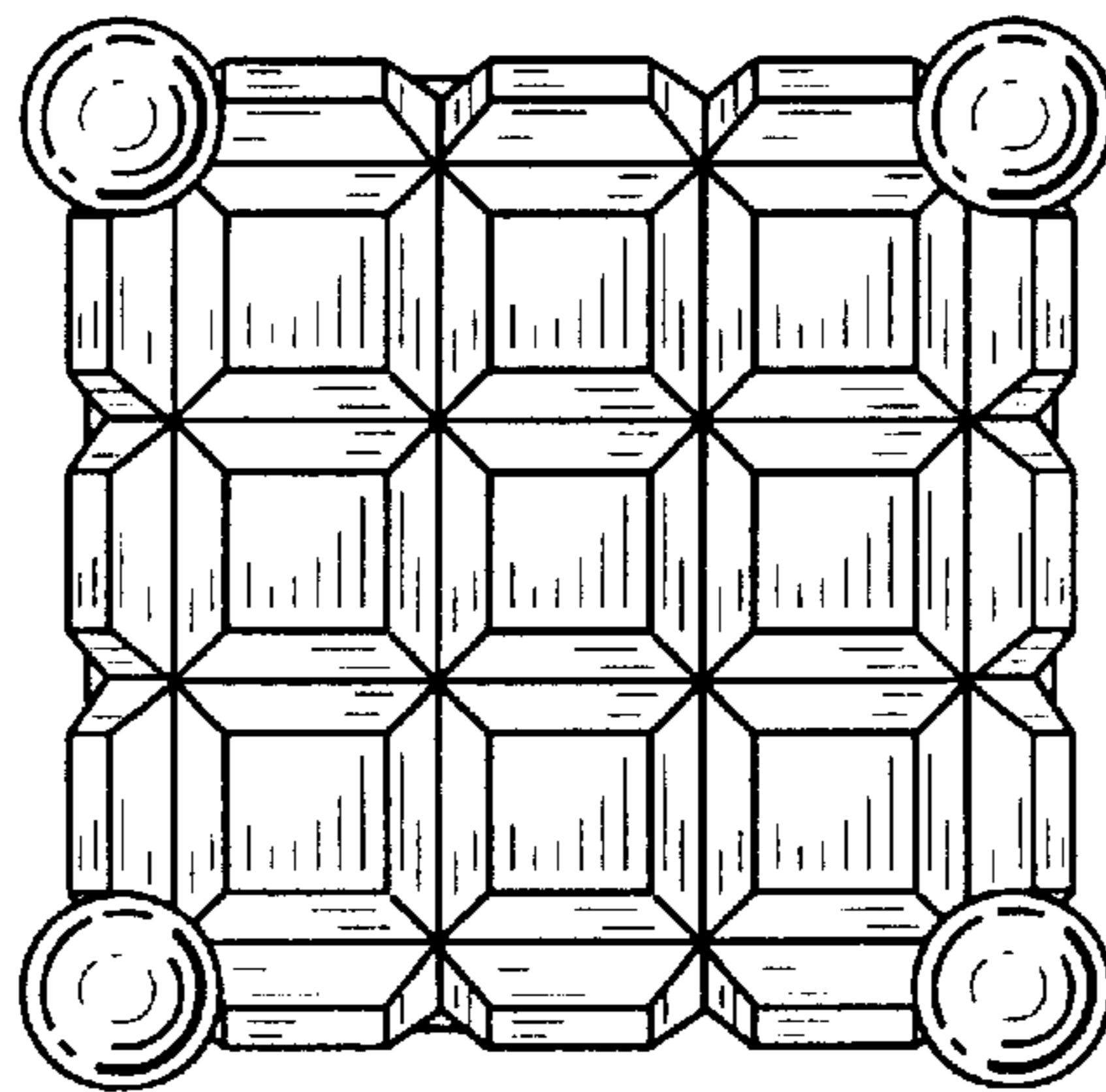
