(57) **CLAIM**

I claim the ornamental design for an educational toy, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a first embodiment of an educational toy, showing my new design;

FIG. 2 is a rear elevation view of the embodiment of FIG. 1;

FIG. 3 is a top plan view of the embodiment of FIG. 1;

FIG. 4 is a bottom plan view of the embodiment of FIG. 1;

FIG. 5 is a right side elevation view of the embodiment of FIG. 1;

FIG. 6 is a left side elevation view of the embodiment of FIG. 1;

FIG. 7 is rear perspective view of the embodiment of FIG. 1;

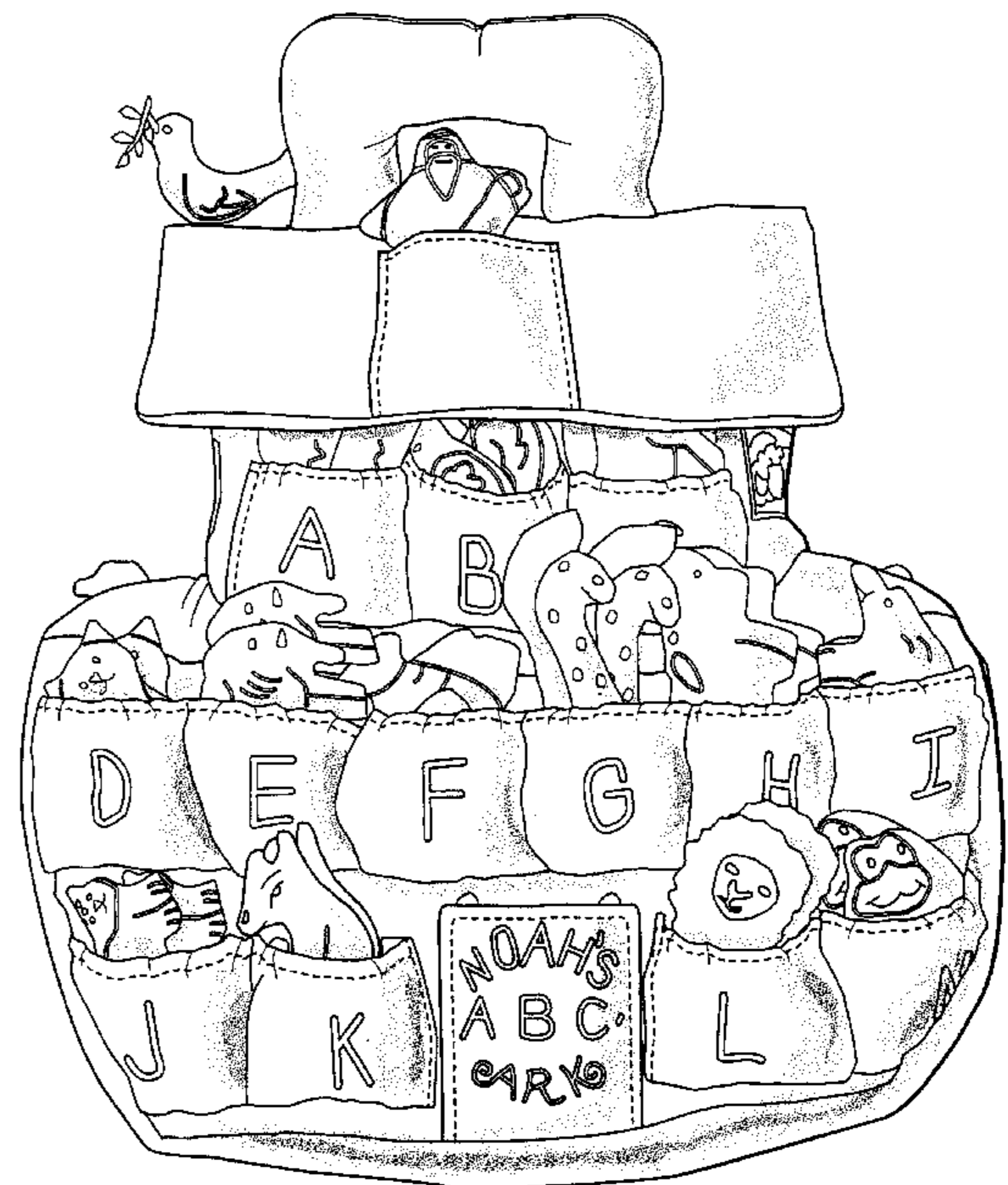
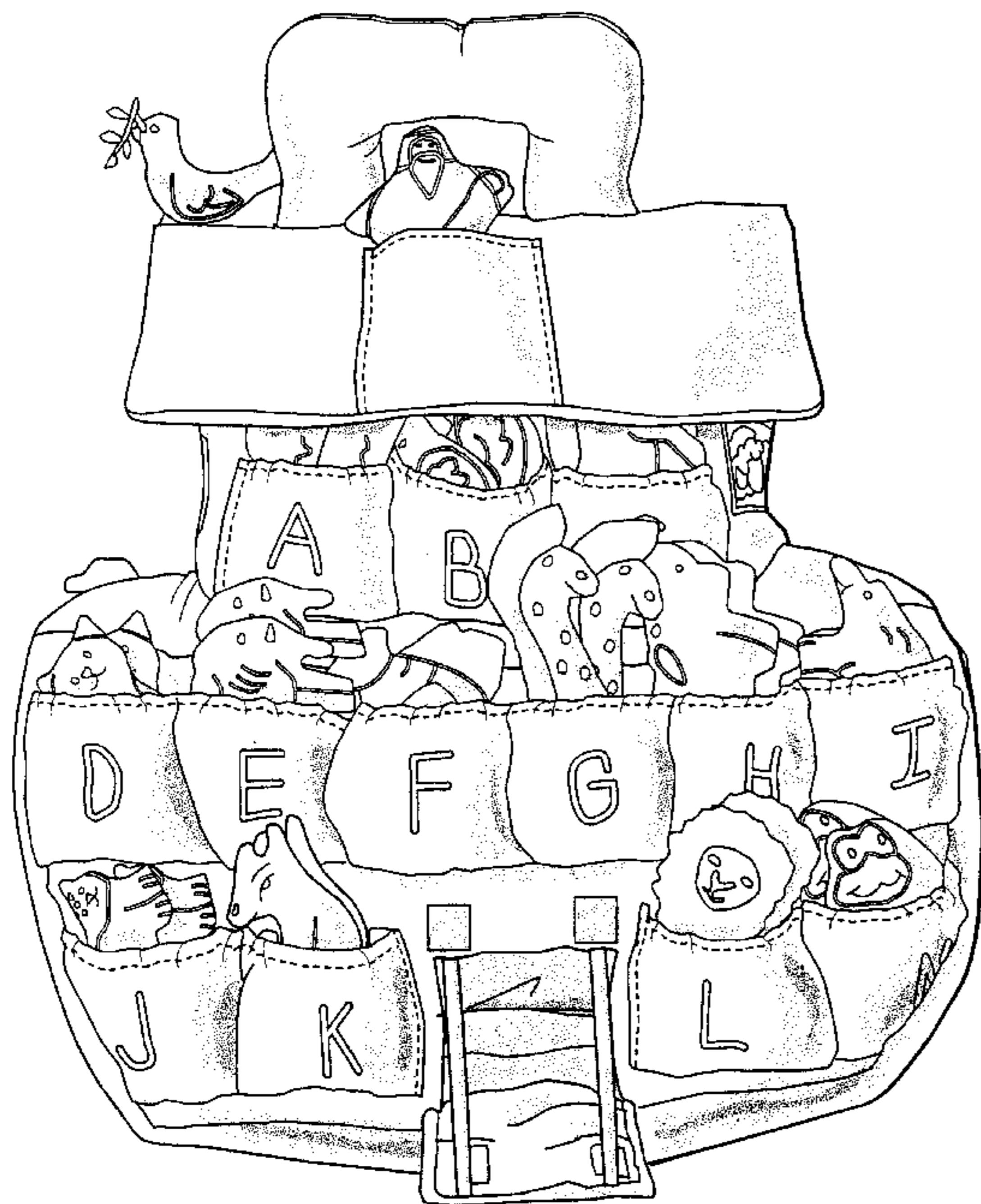
FIG. 8 is a front elevation view of a second embodiment of an educational toy, showing my new design;

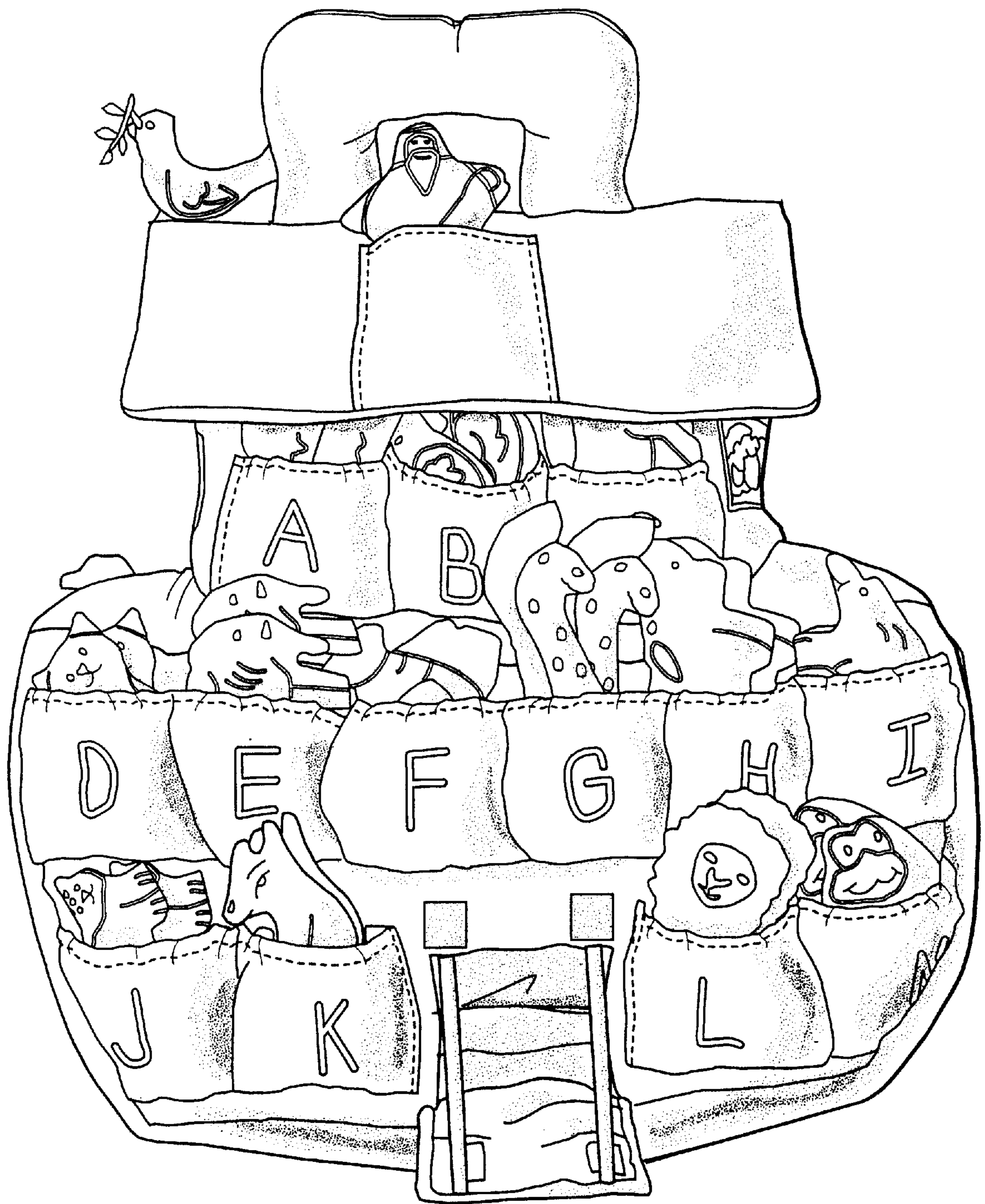

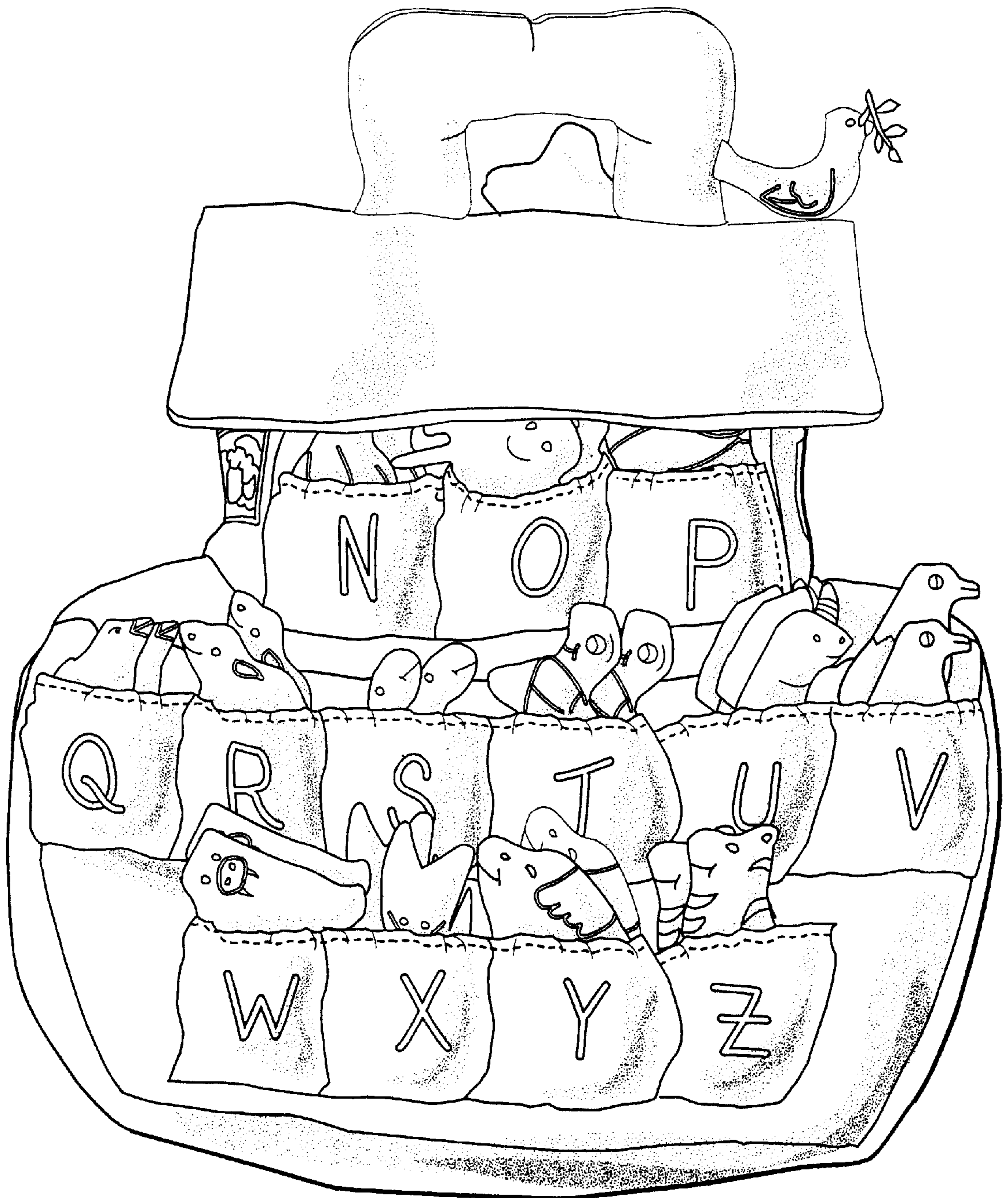

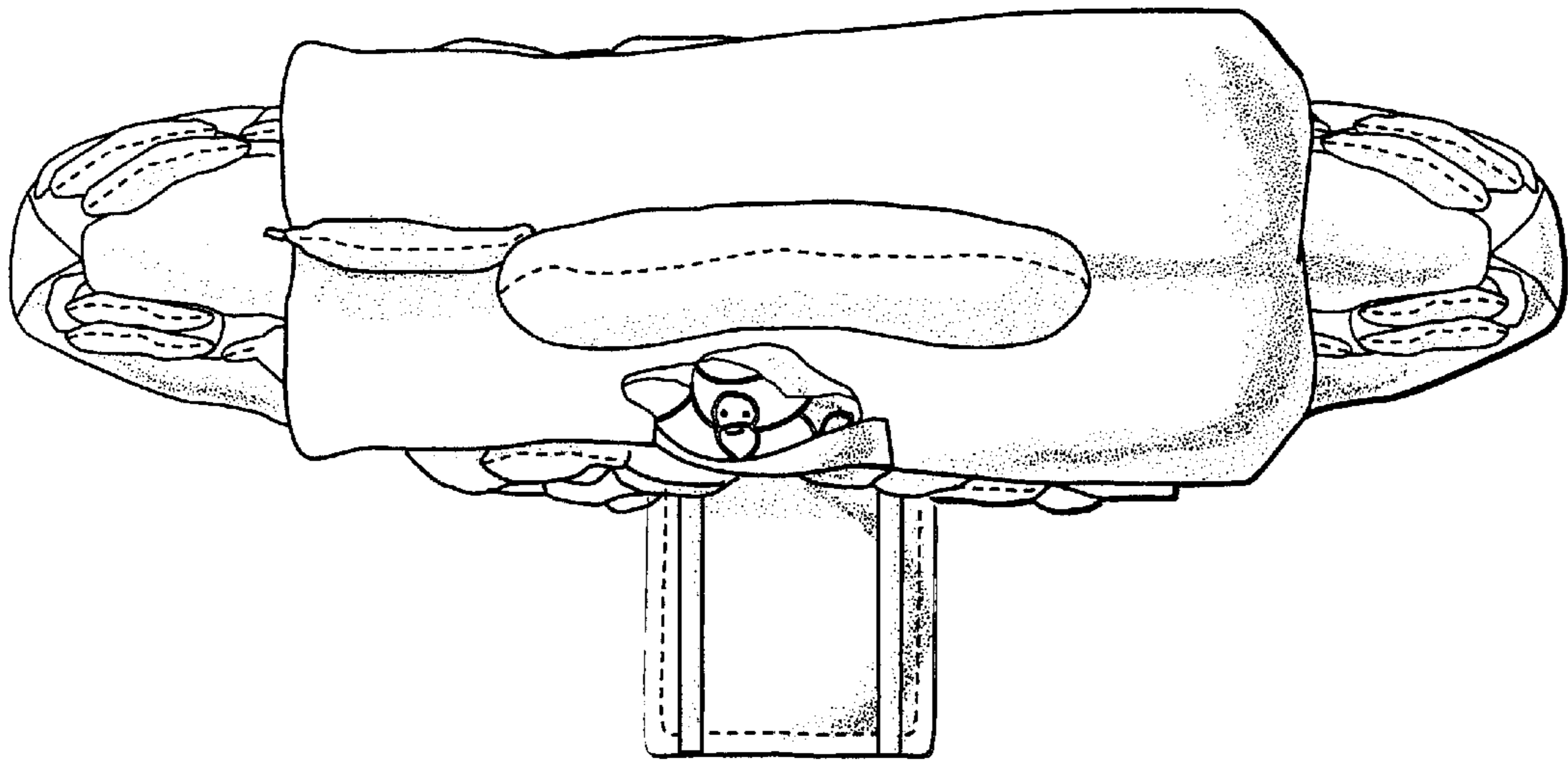

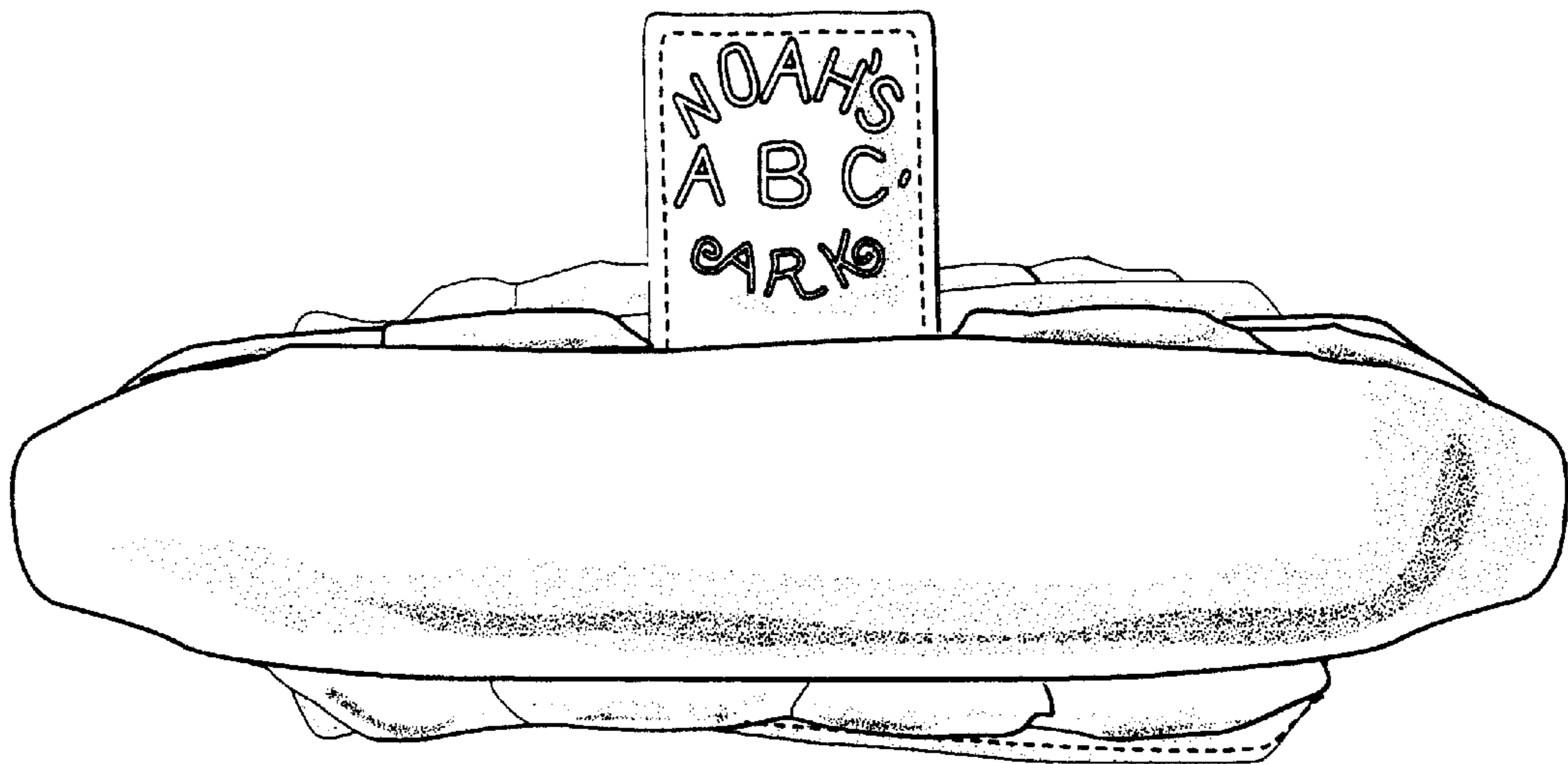

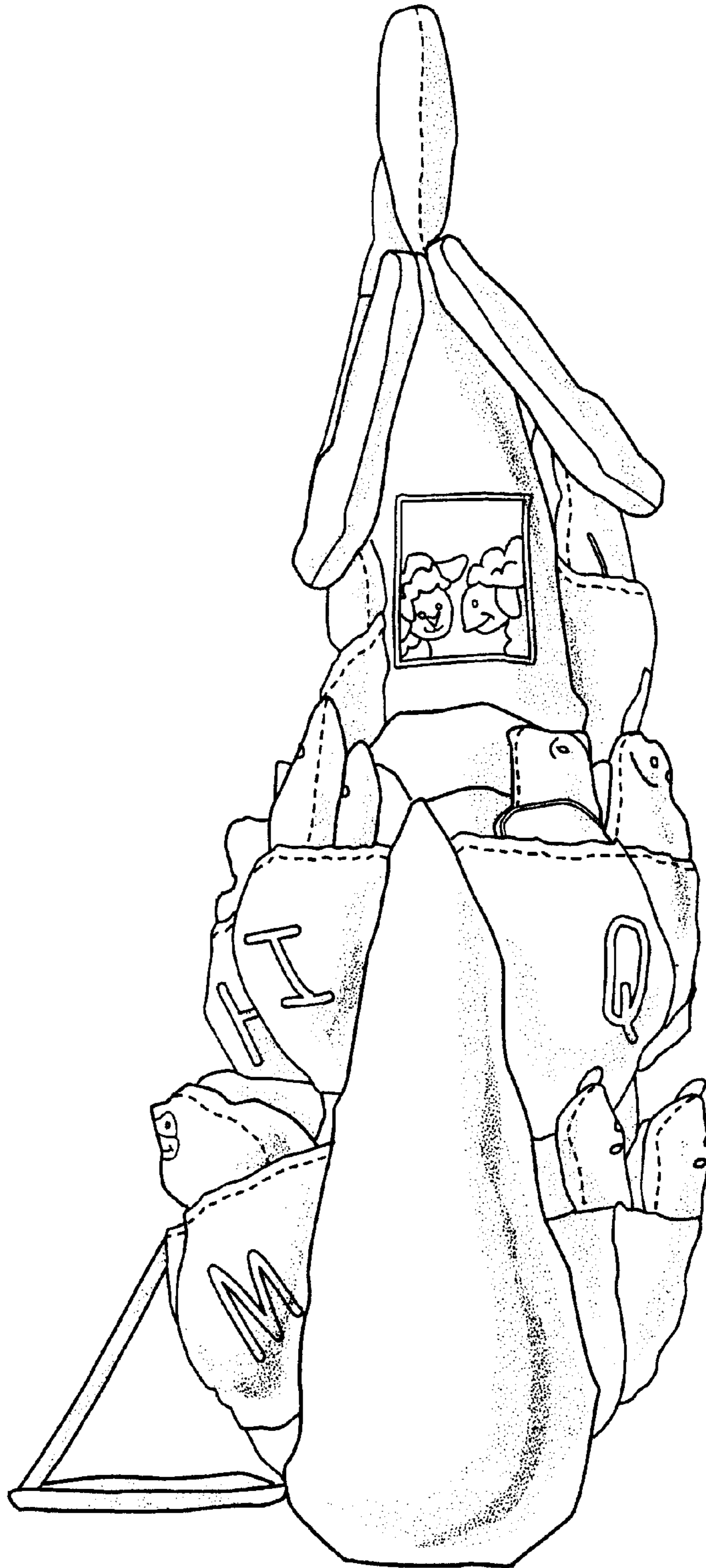

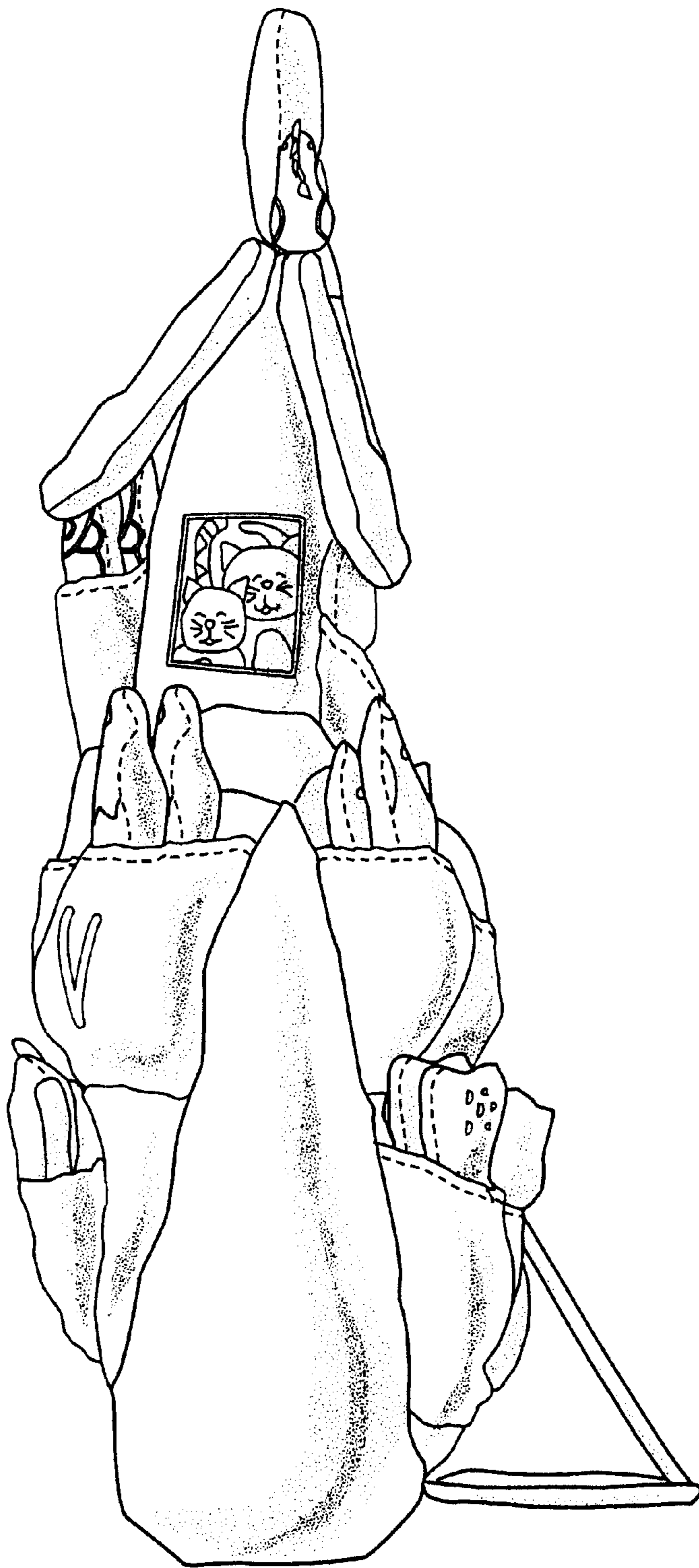

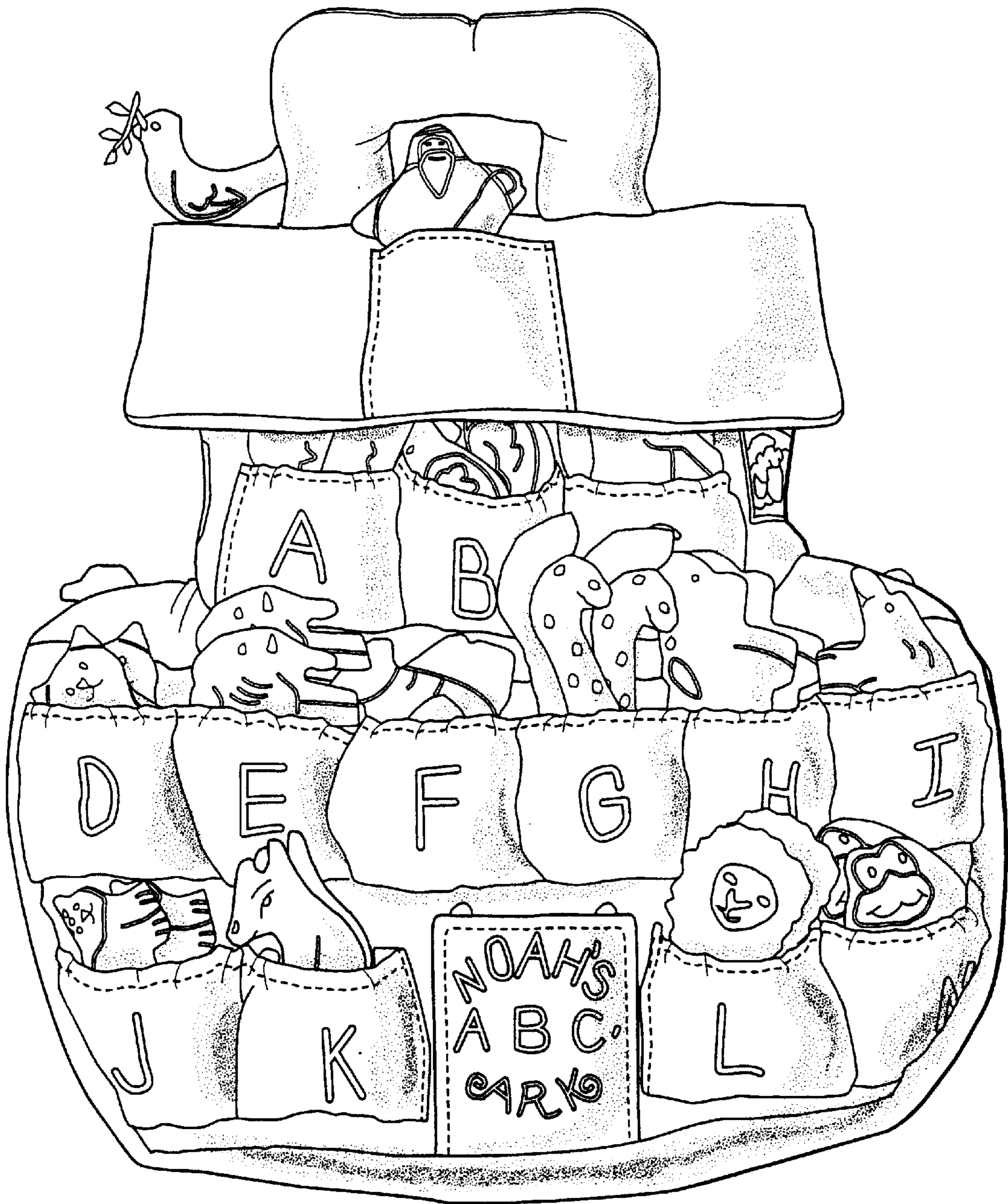

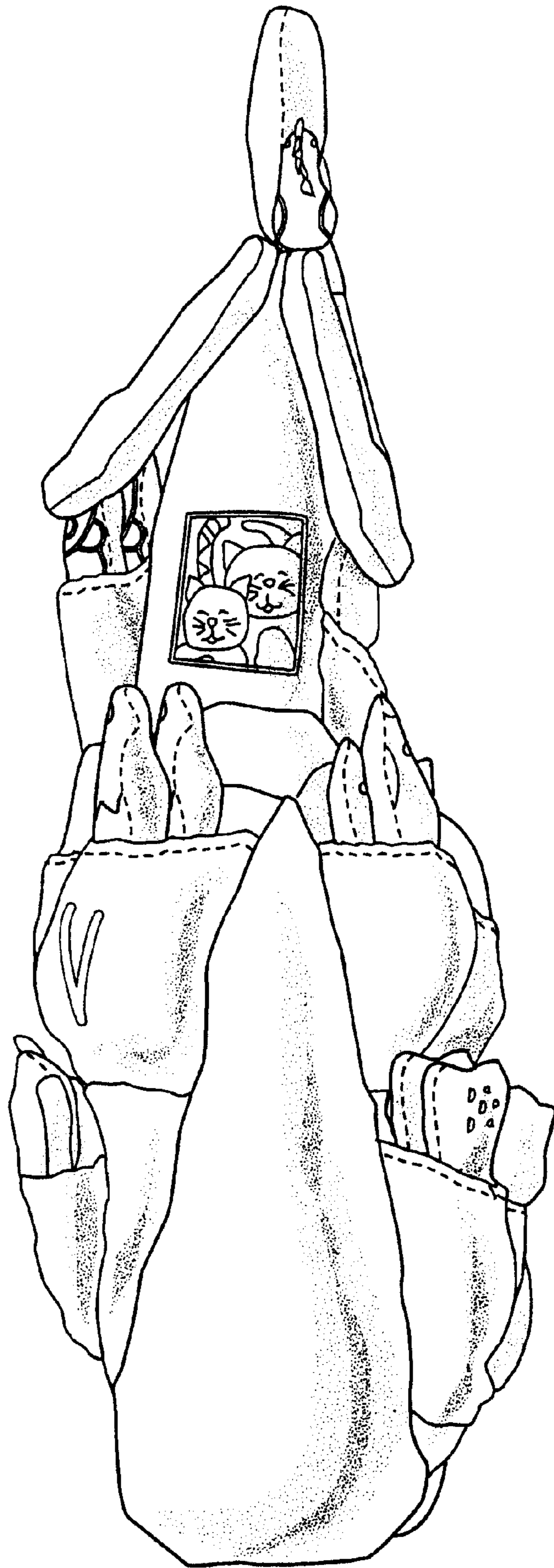

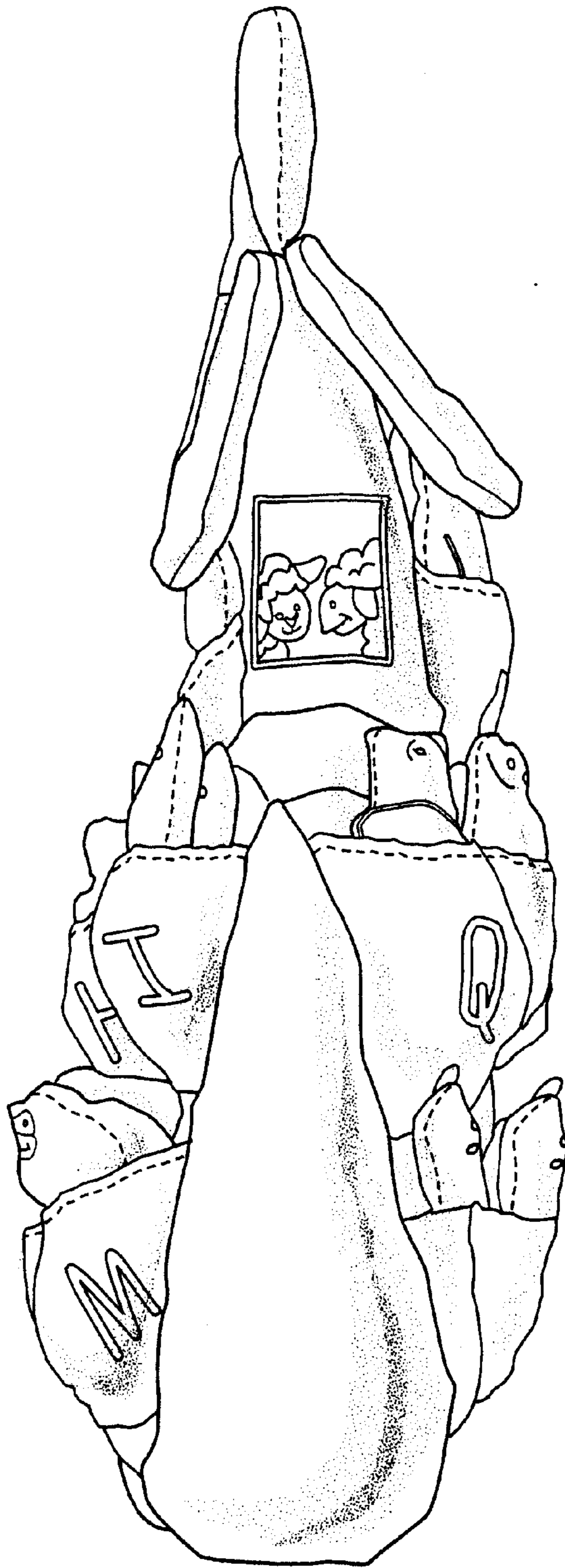

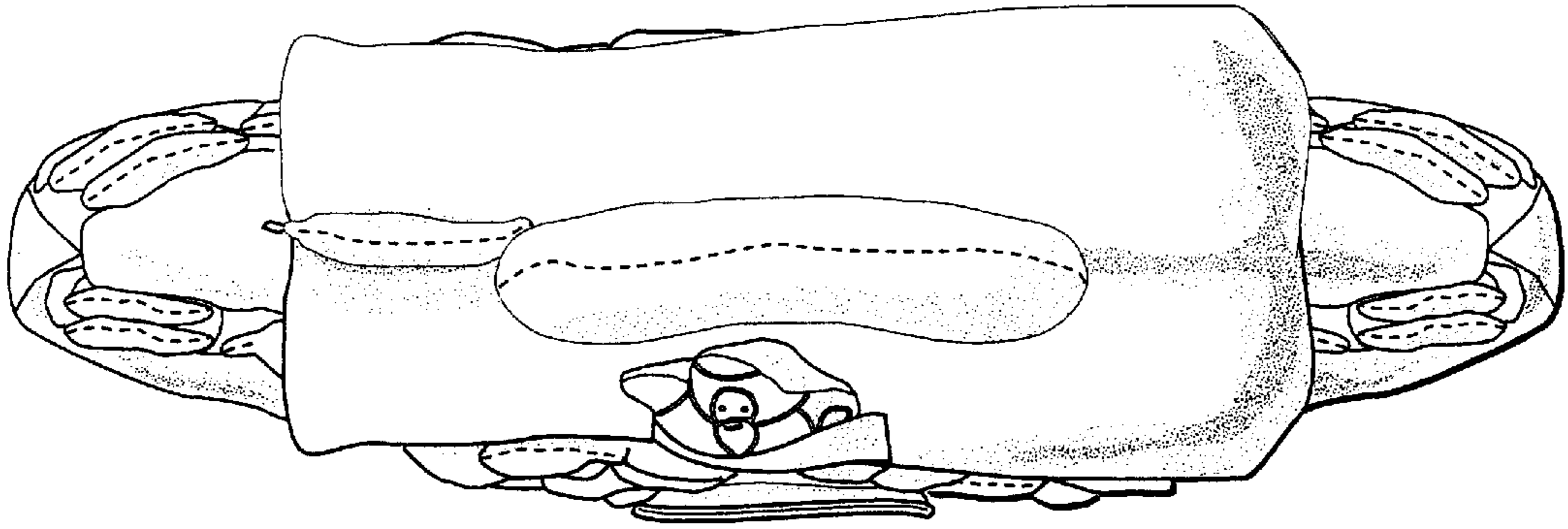

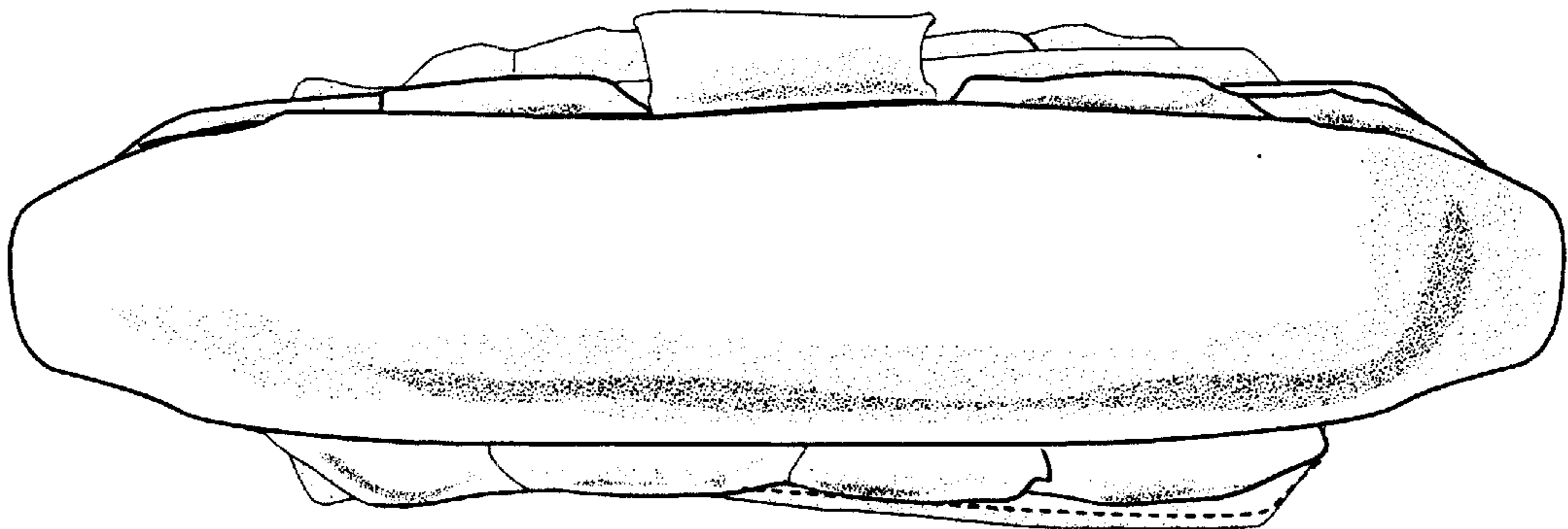
