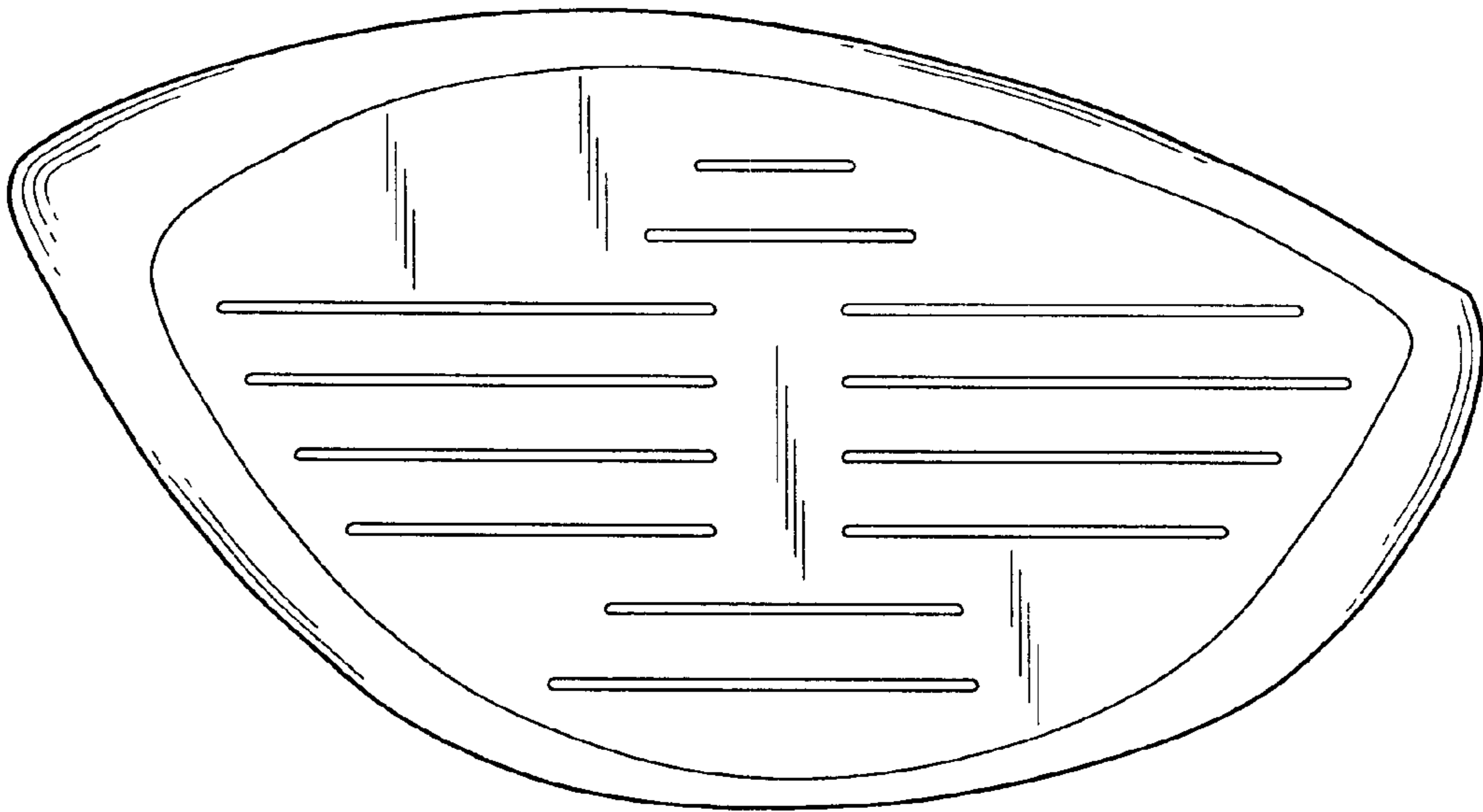
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a golf club head; FIG. 2 is a rear side elevational view thereof; FIG. 3 is a heel end view thereof; FIG. 4 is a toe end view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

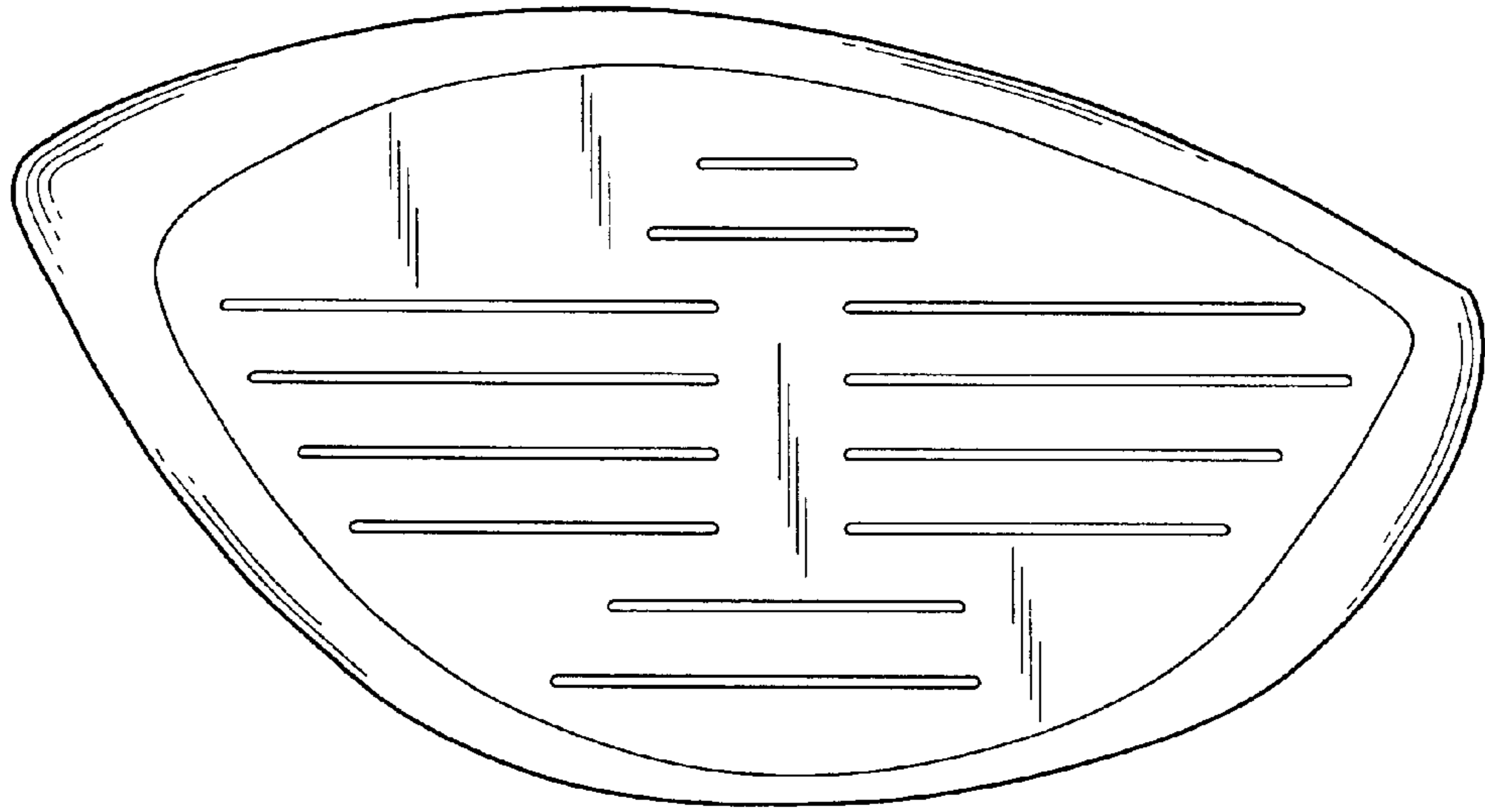

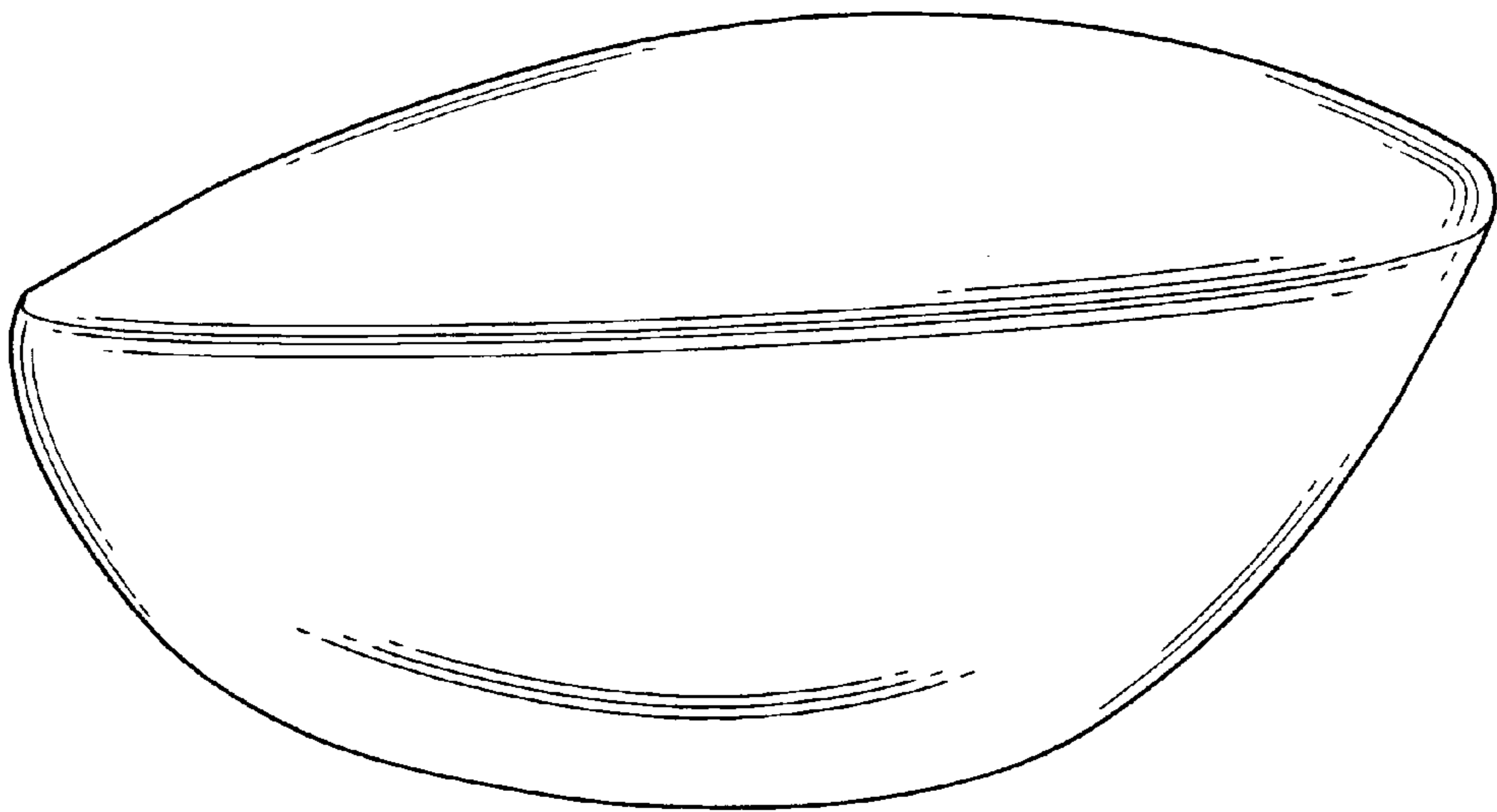

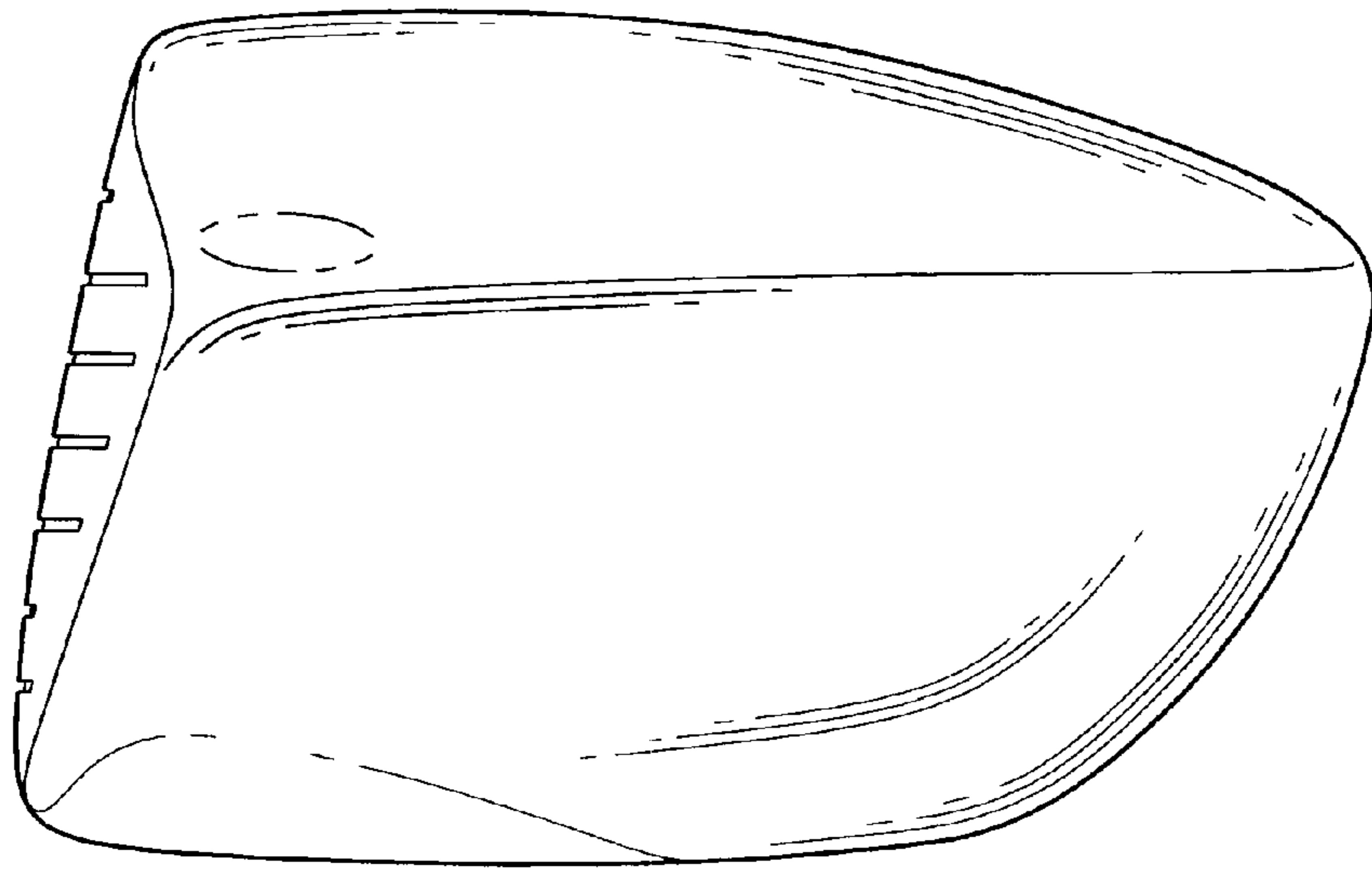

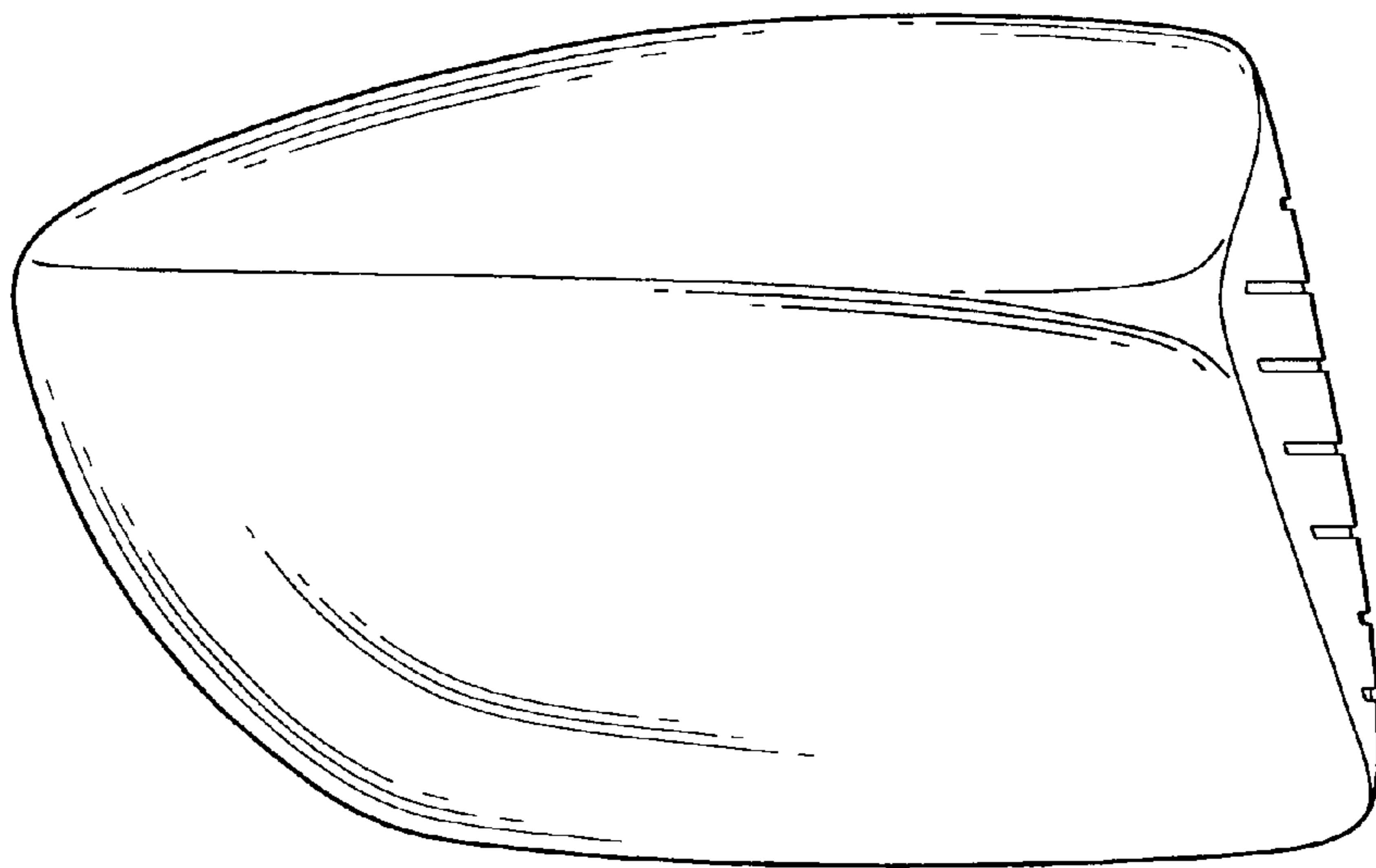

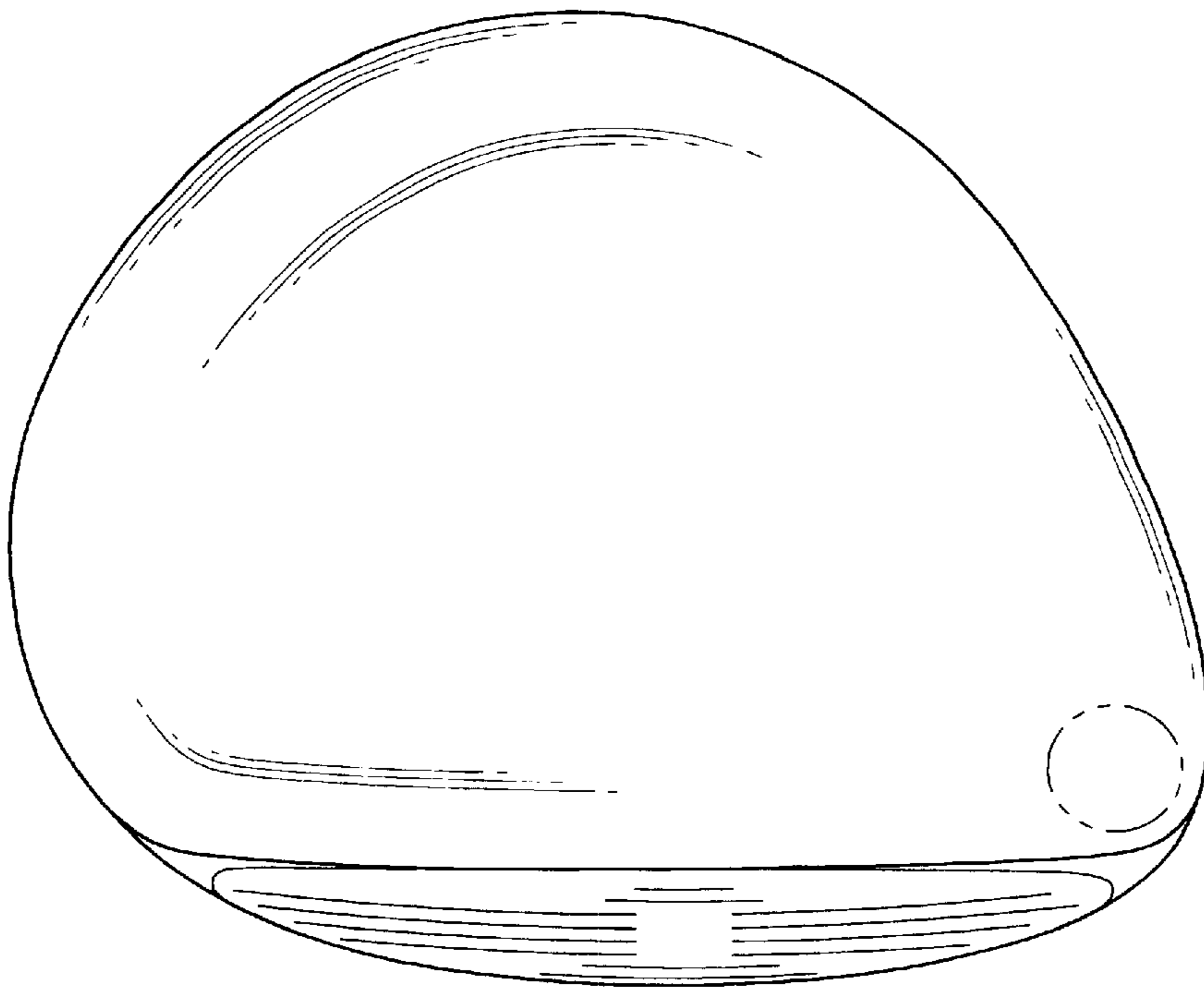

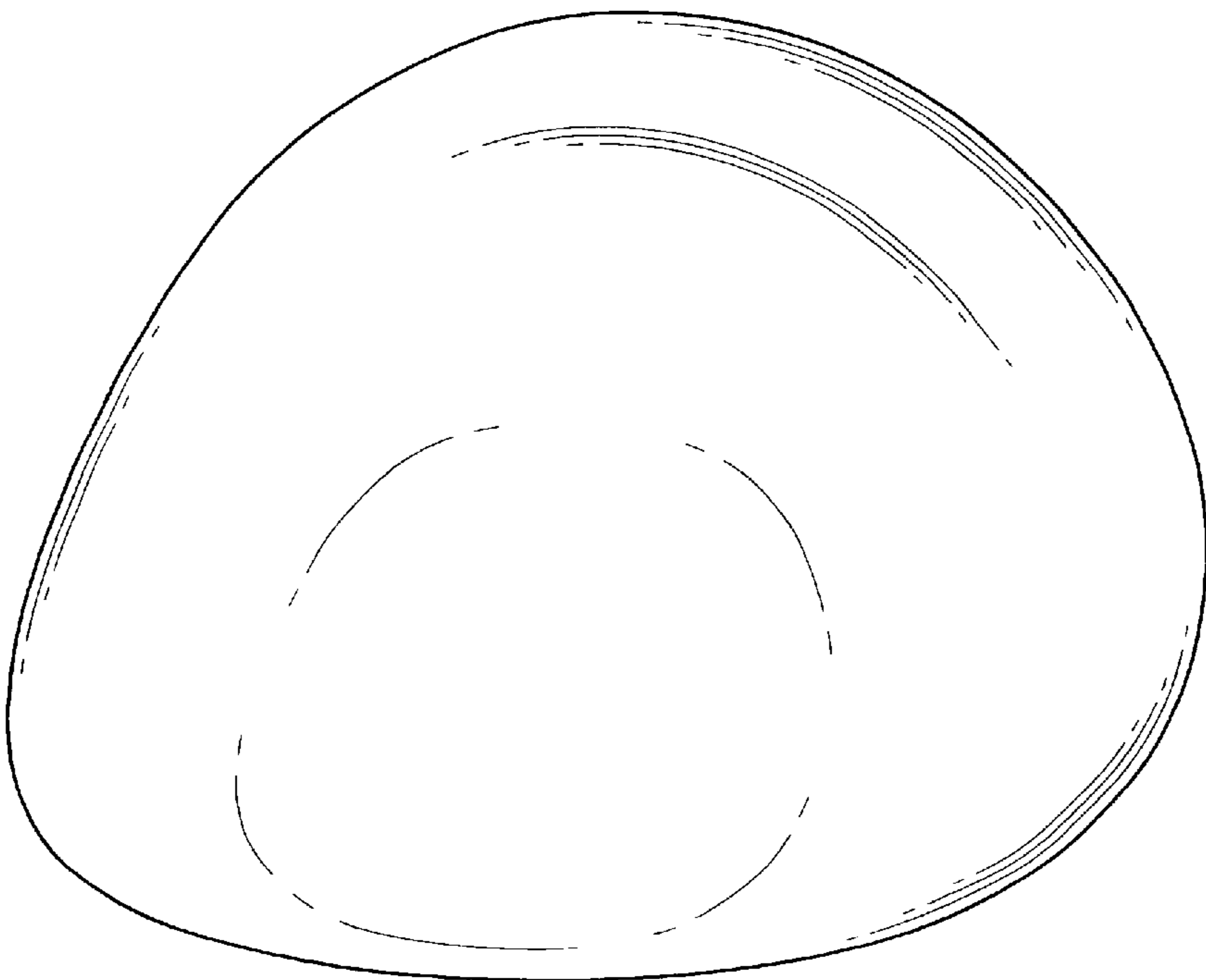
