(57) **CLAIM**

The ornamental design of a base for a floor cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a base for a floor cleaner showing my new design; FIG. 2 is a top, front and right side perspective view without the portion of the vacuum cleaner shown in broken lines of FIG. 1 thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is a right side elevational view thereof;

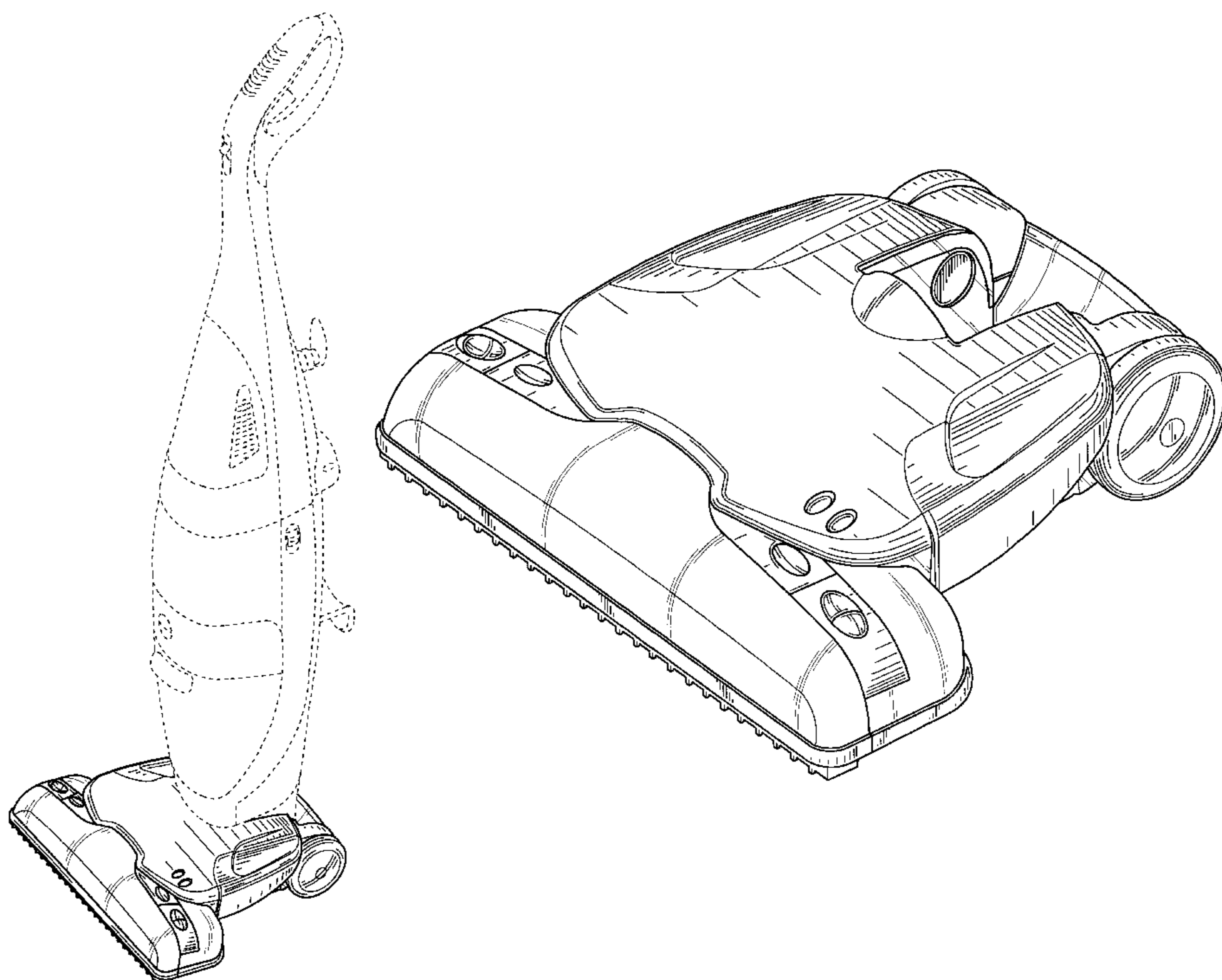
FIG. 6 is a left side elevational view thereof;

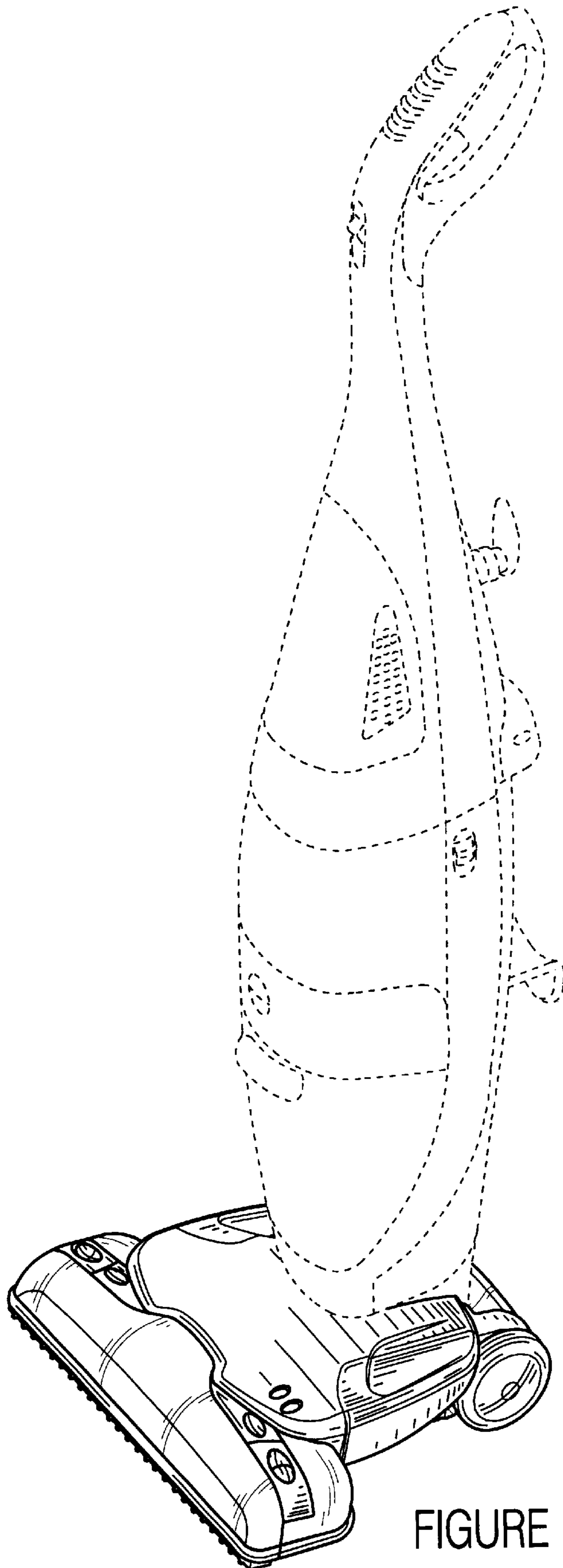

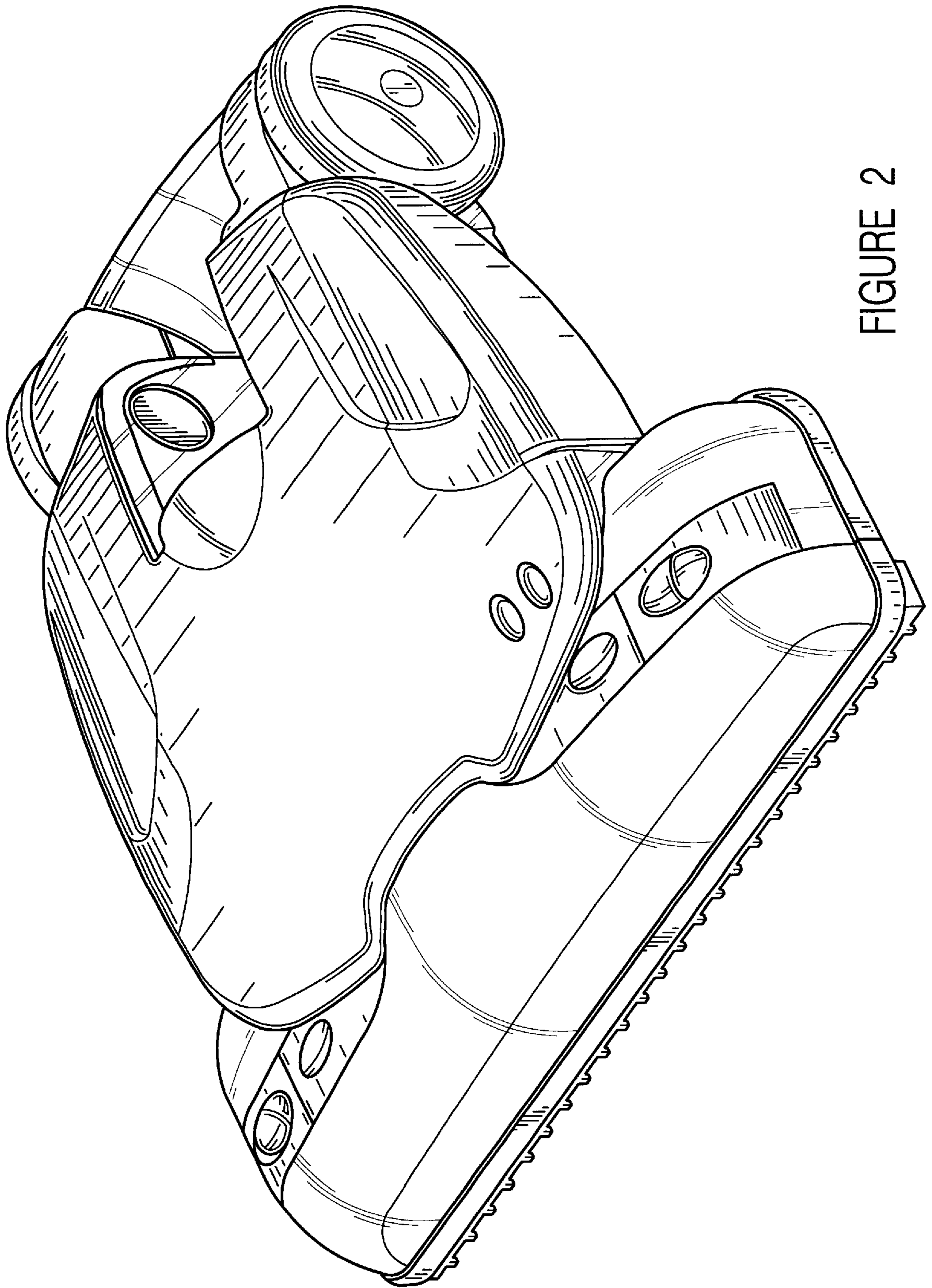

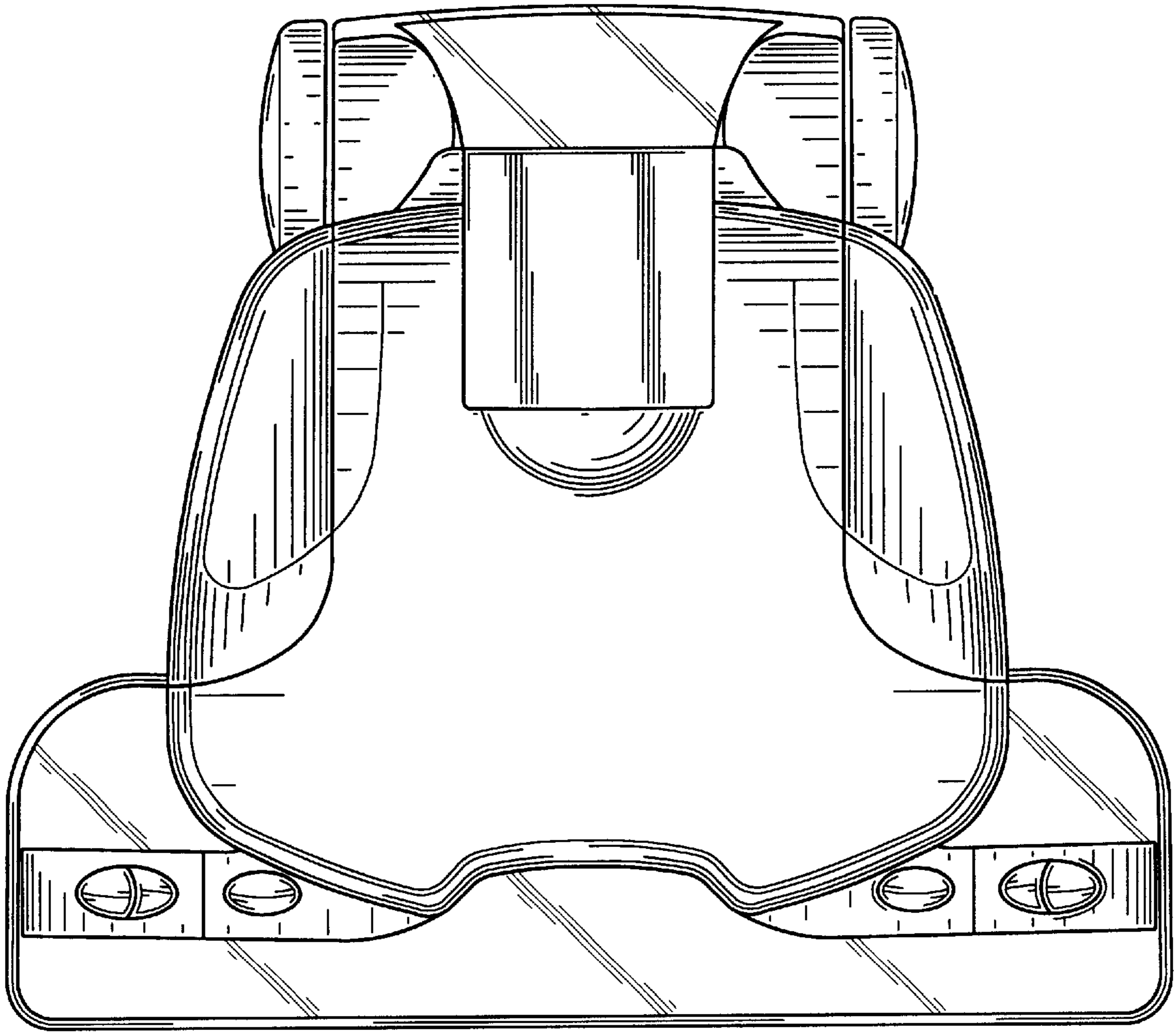

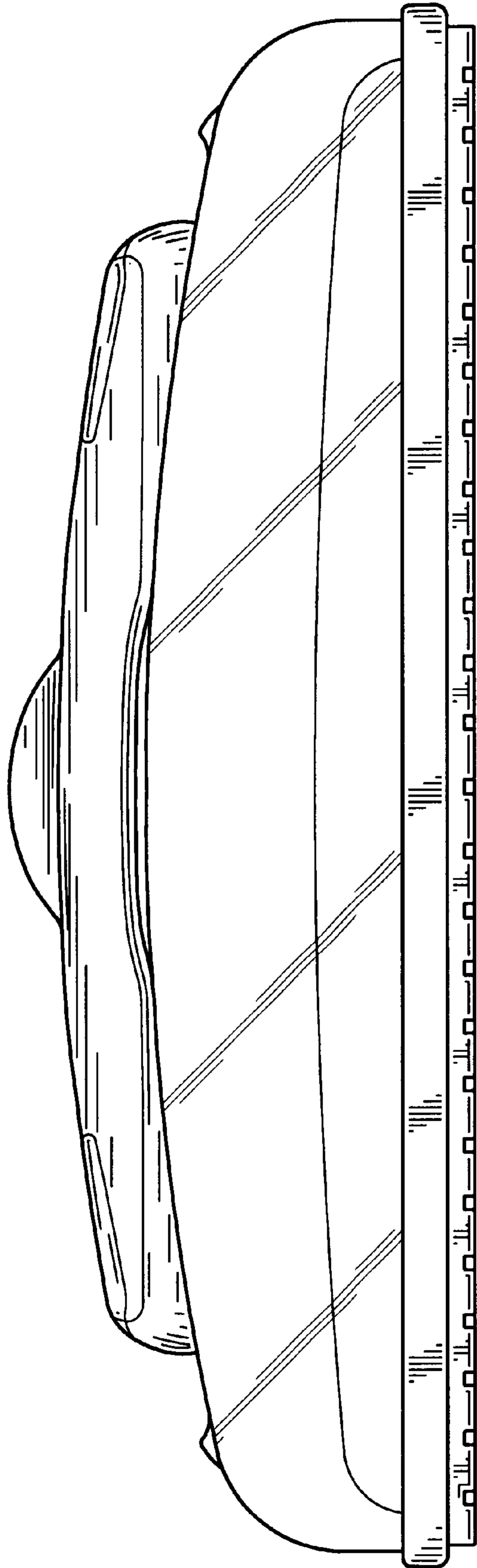

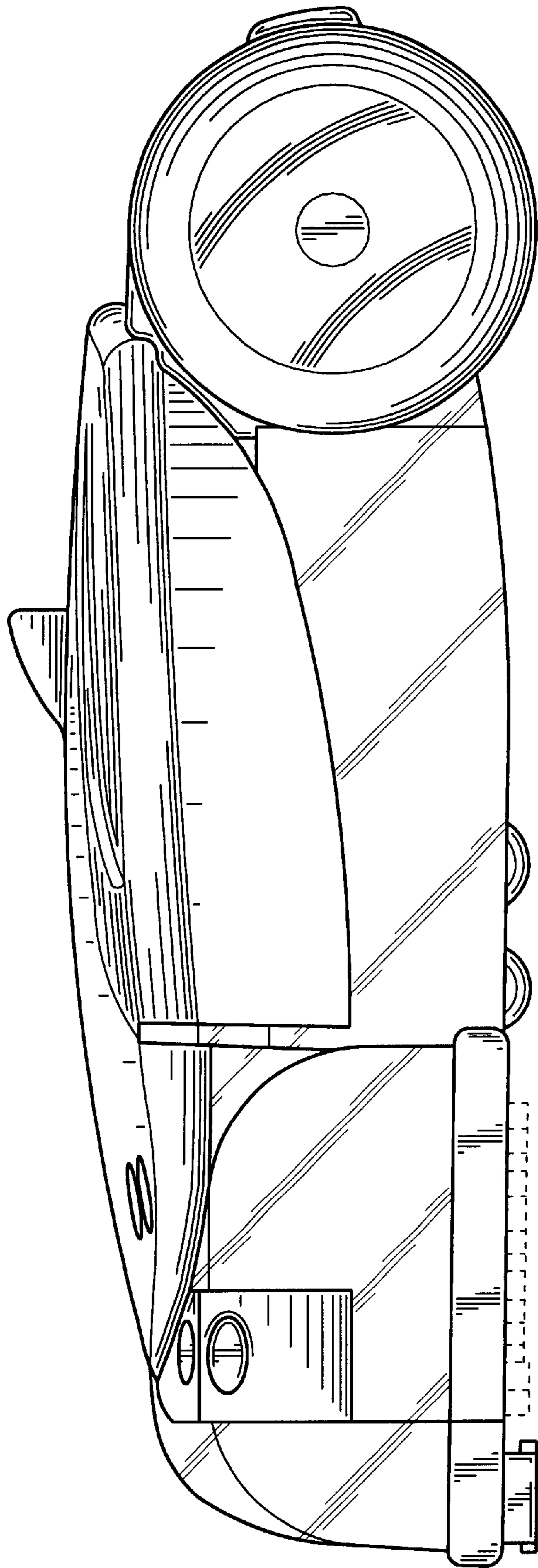

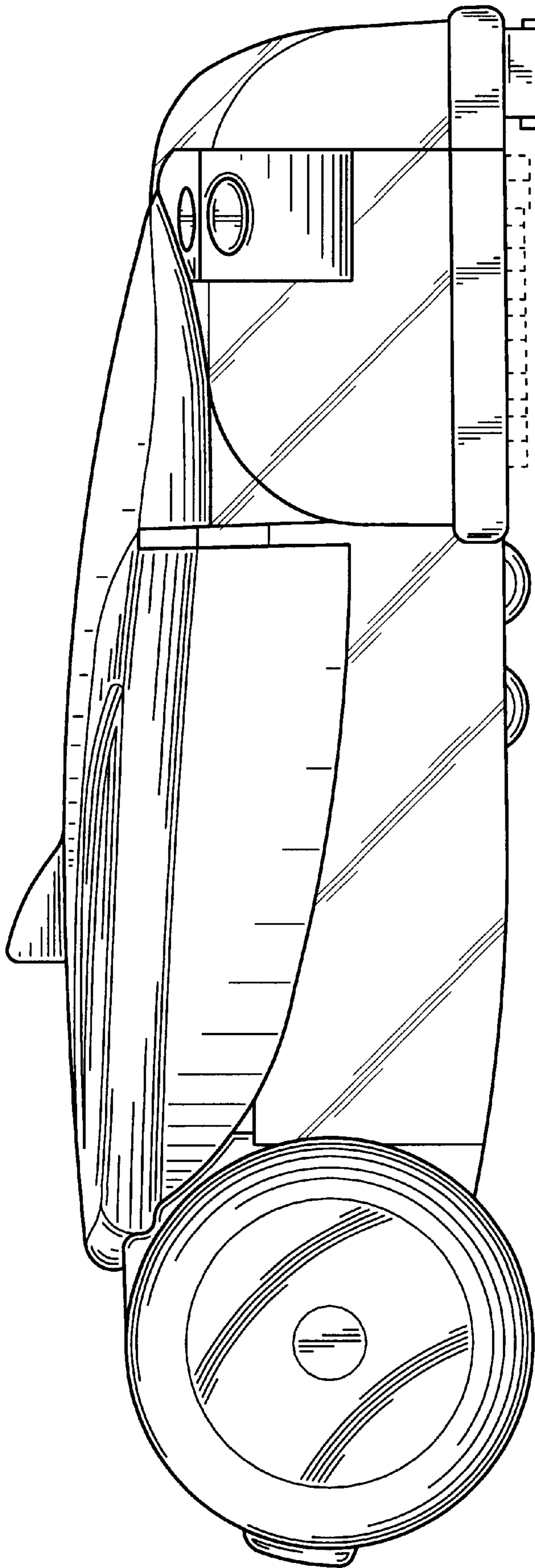

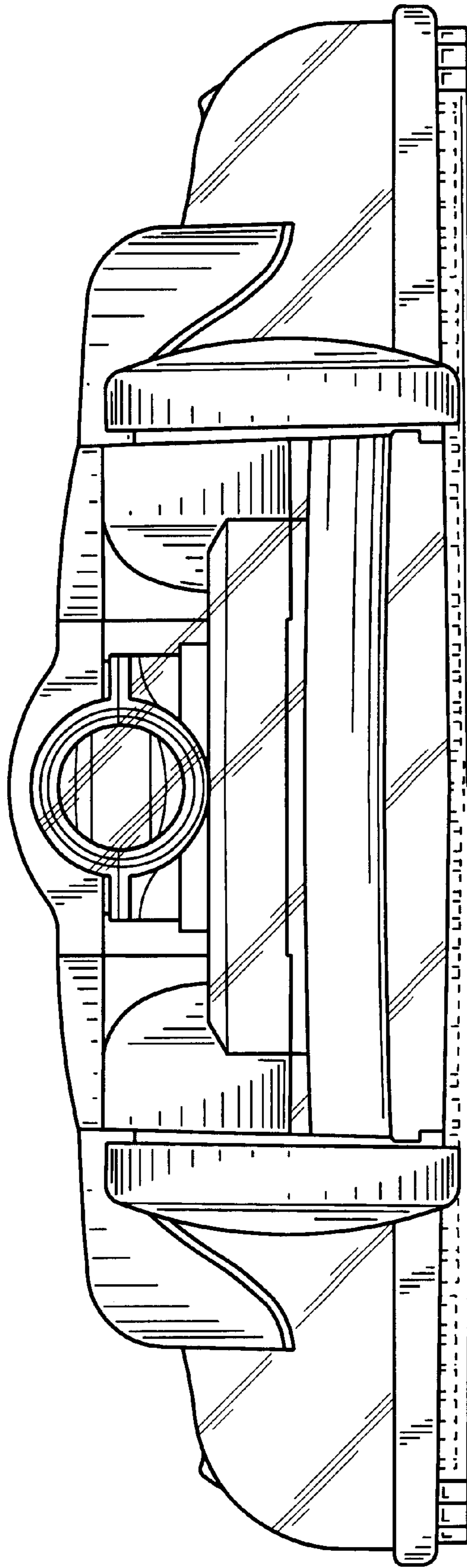

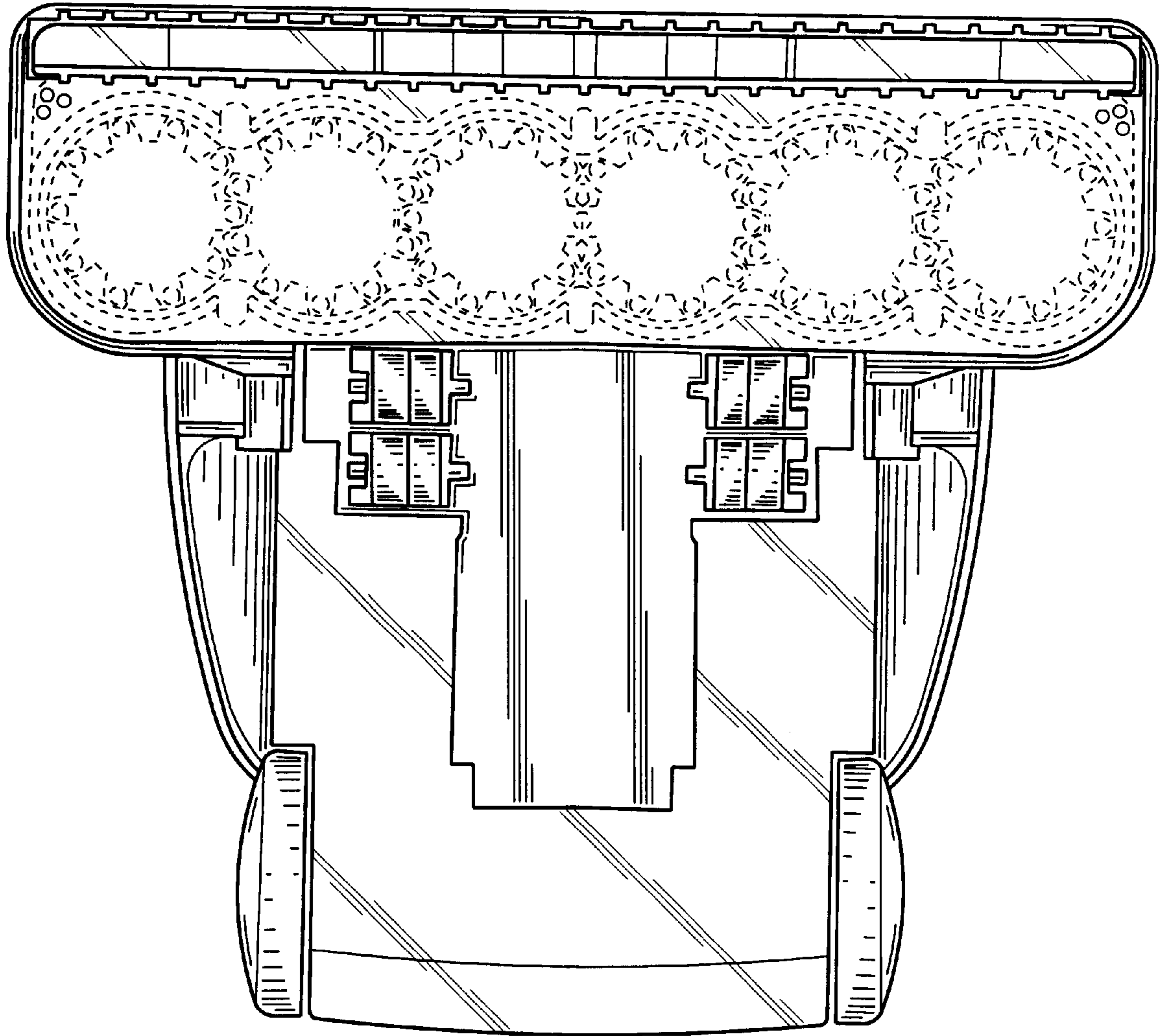
