(57) **CLAIM**

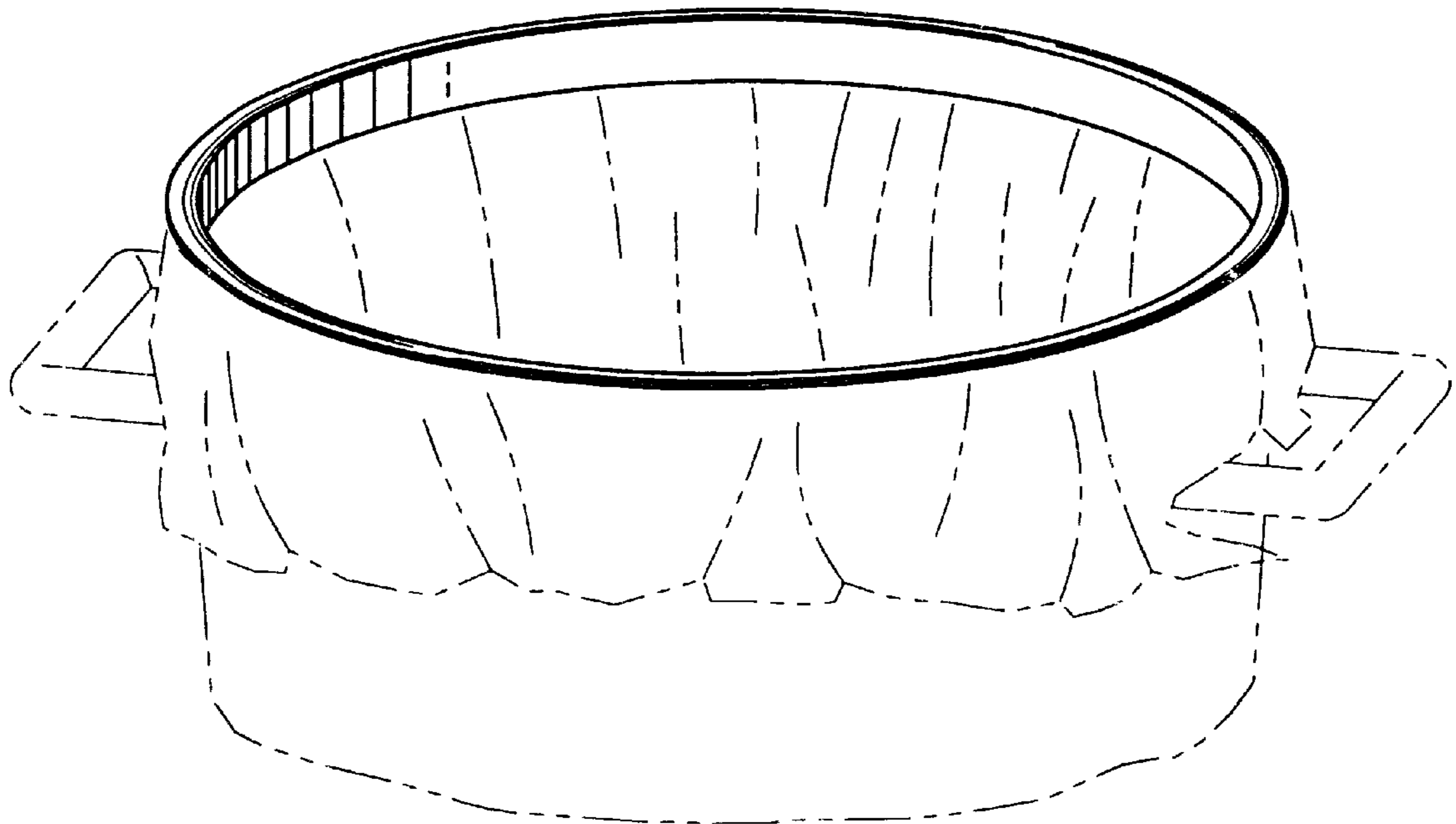
The ornamental design for a refuse bag retainer ring, as shown and described.

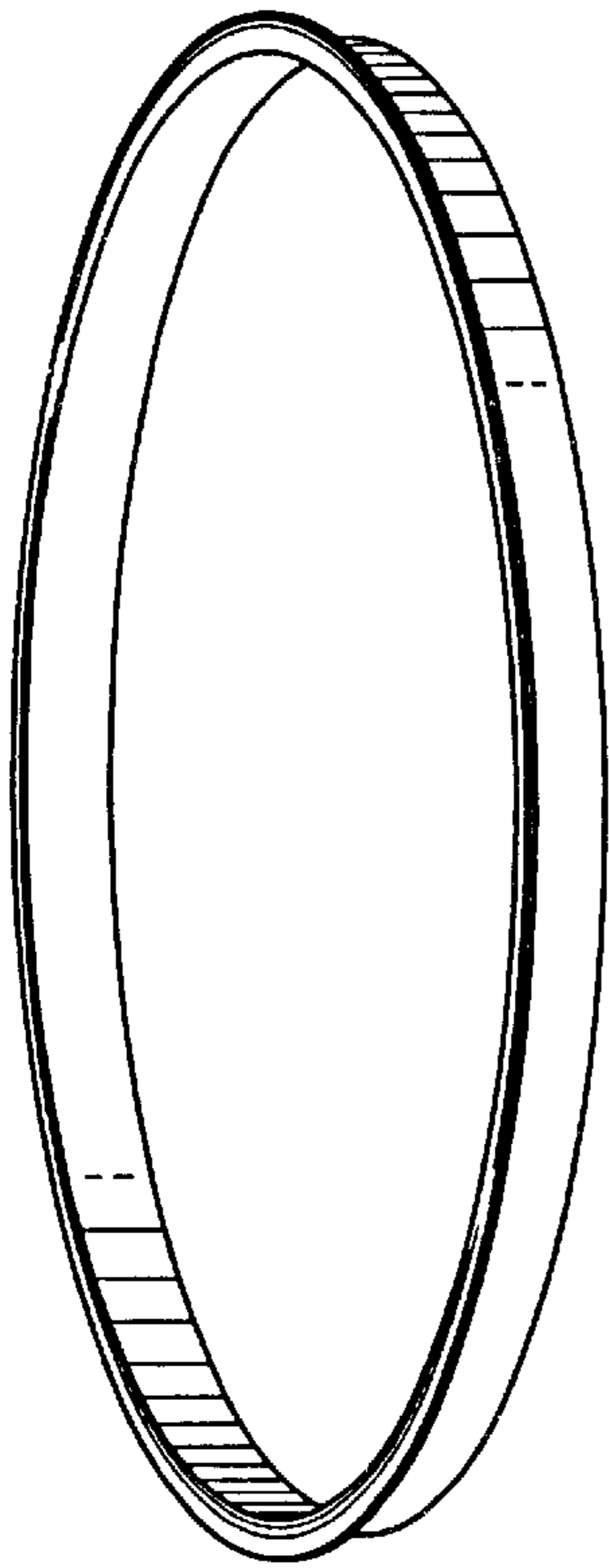

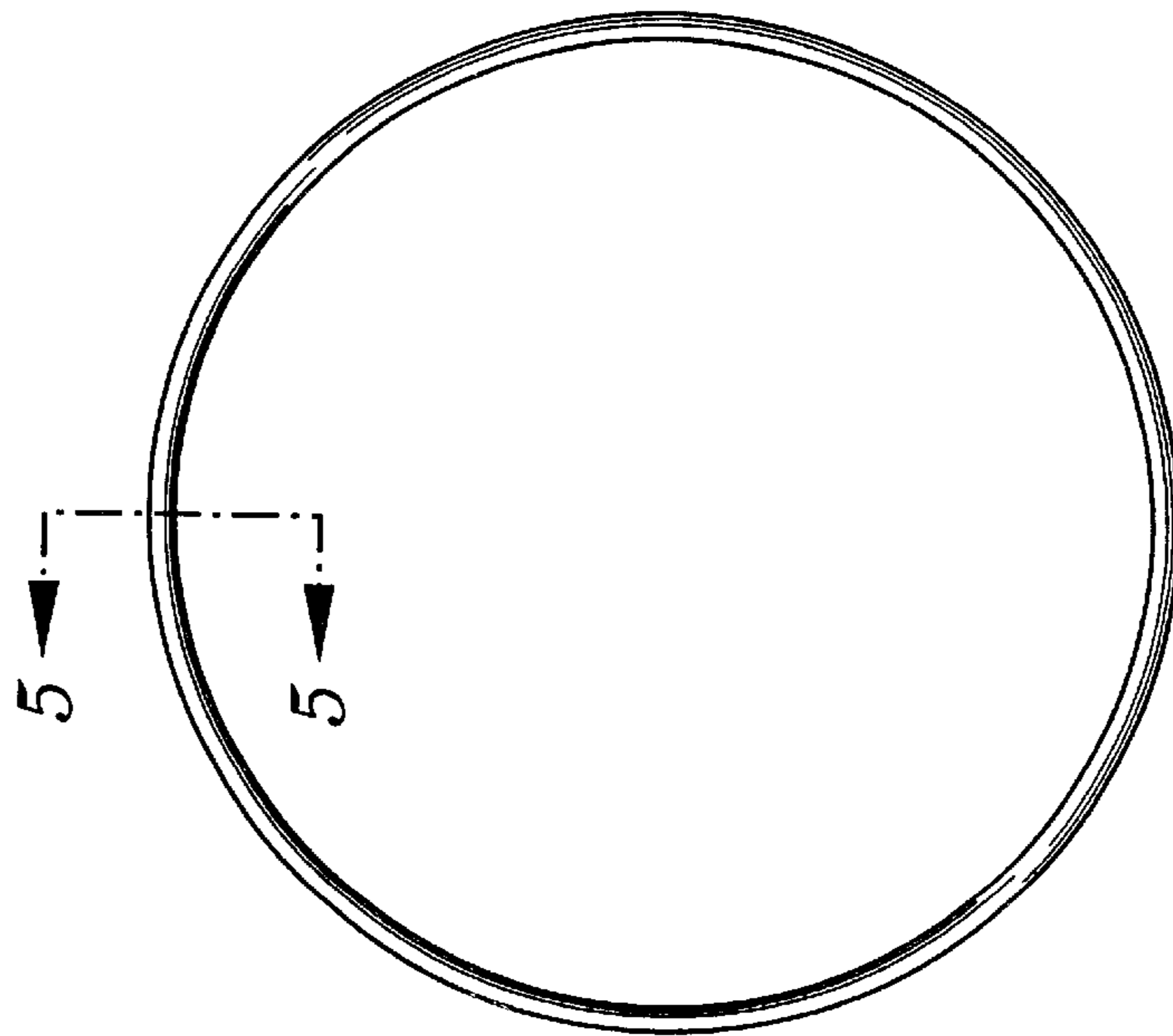

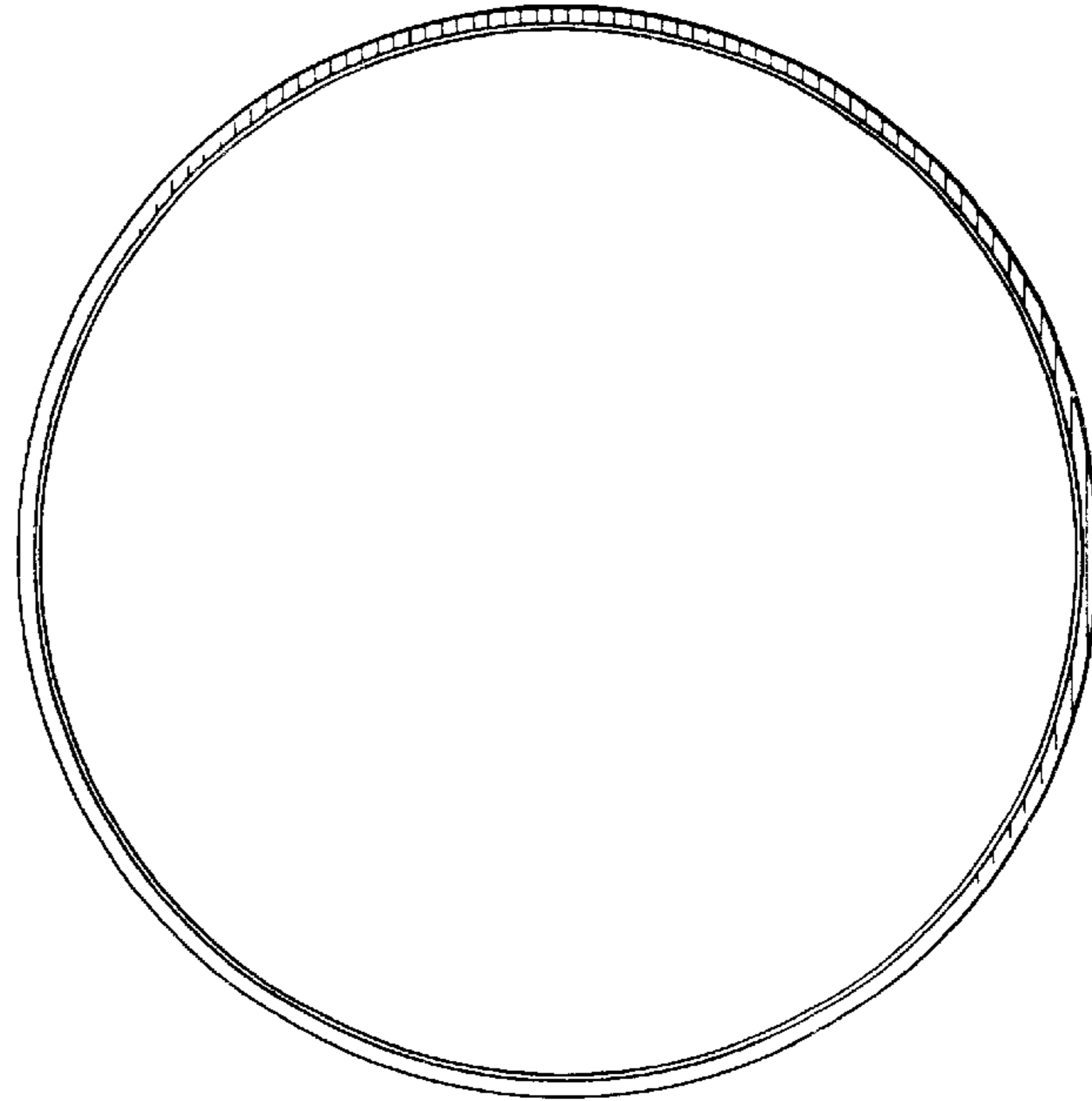

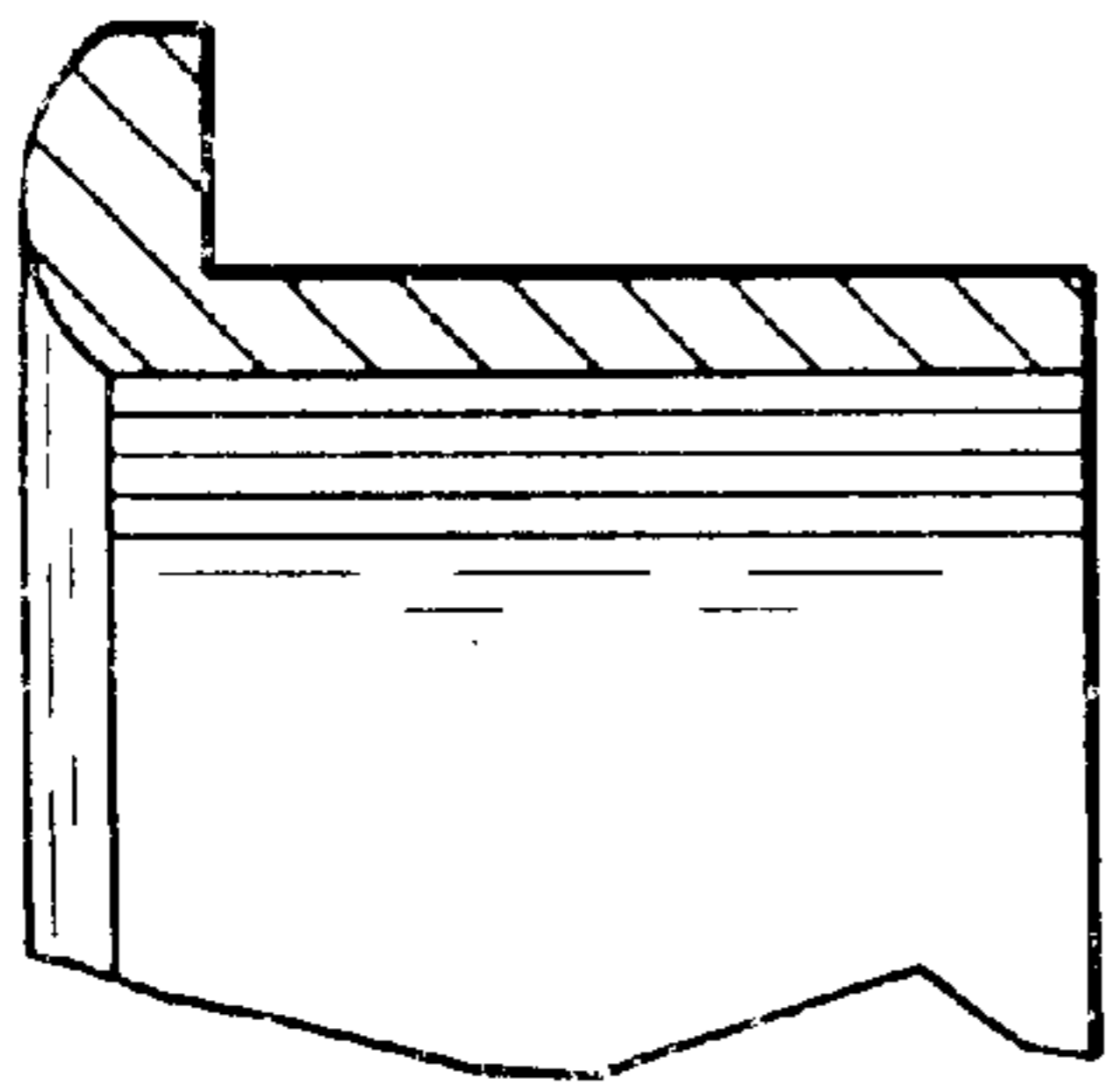

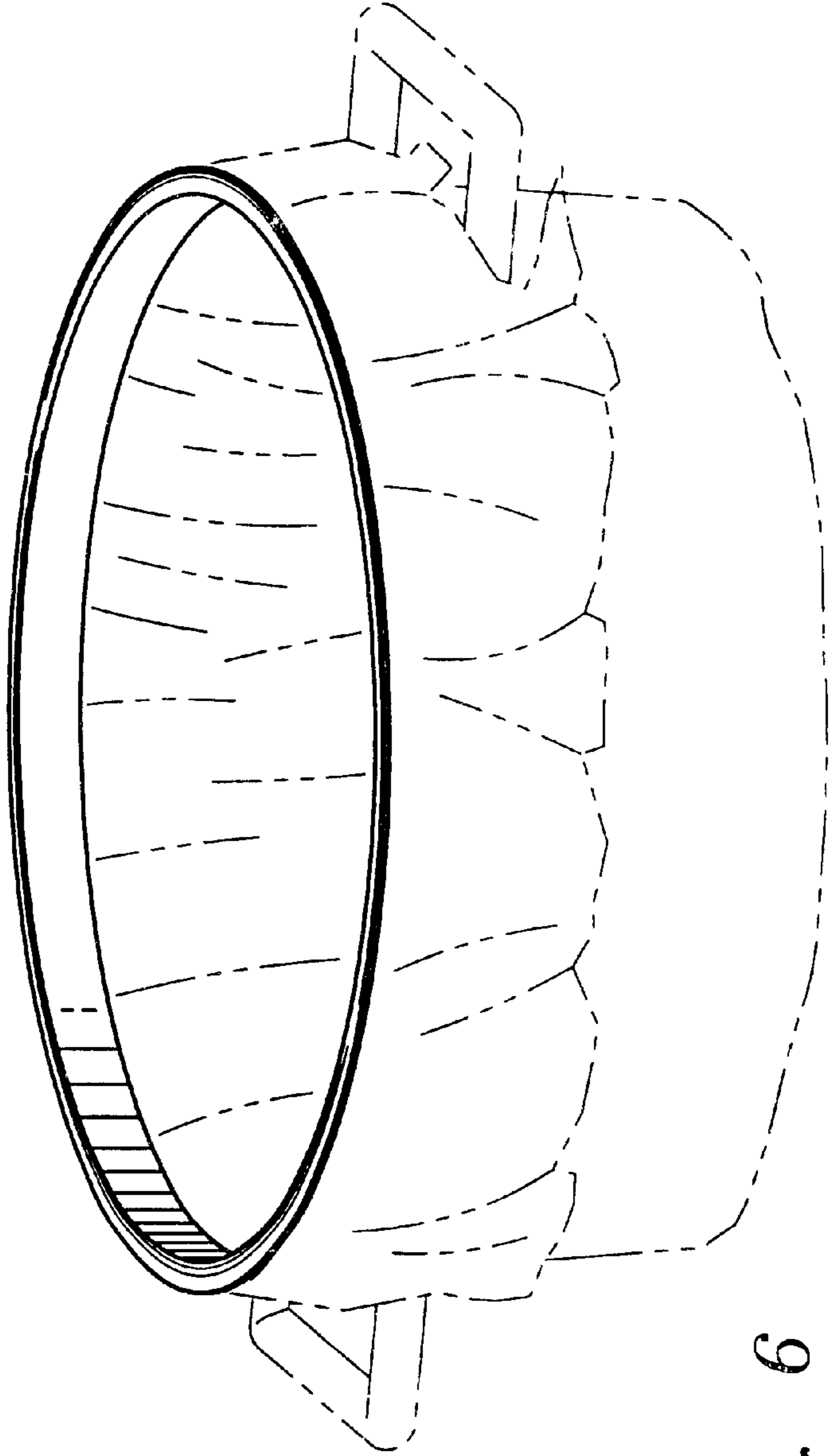
