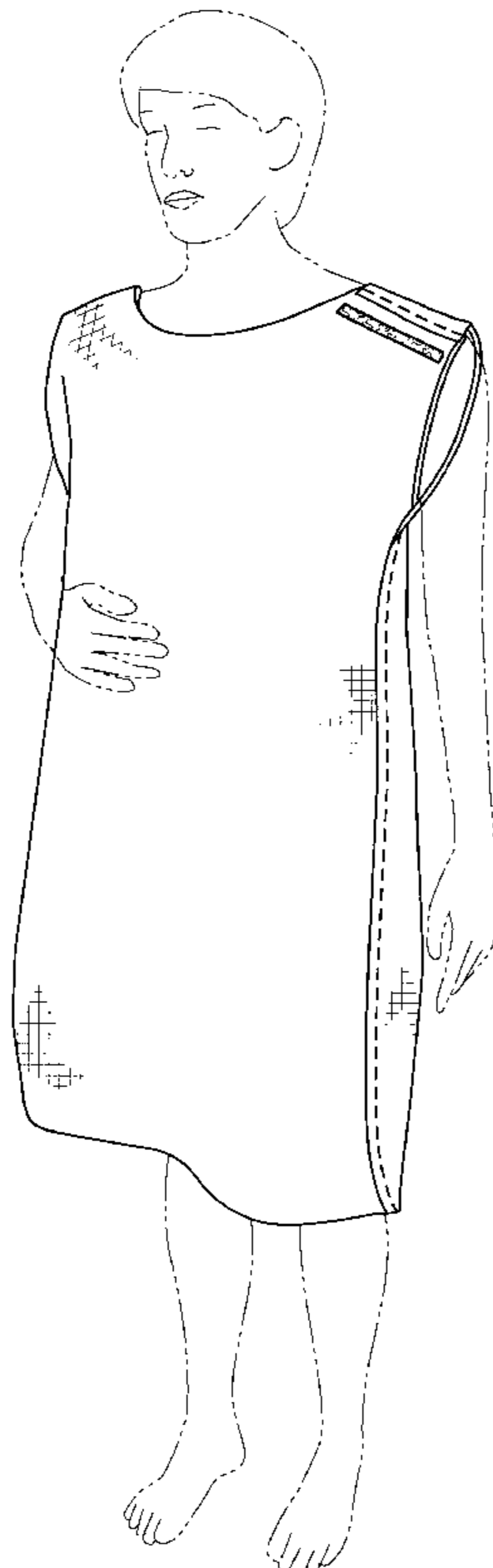
(57) **CLAIM**

The ornamental design for a hospital gown, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the hospital gown as it would be worn;
FIG. 2 is a view of the hospital gown lying flat;
FIG. 3 is a side view of the hospital gown;
FIG. 4 is a front view of the hospital gown; and,
FIG. 5 is a side view of the front view of the hospital gown.
The broken line showing of the figure of a patient, in FIG. 1, is for illustrative purposes only and forms no part of the claimed design.

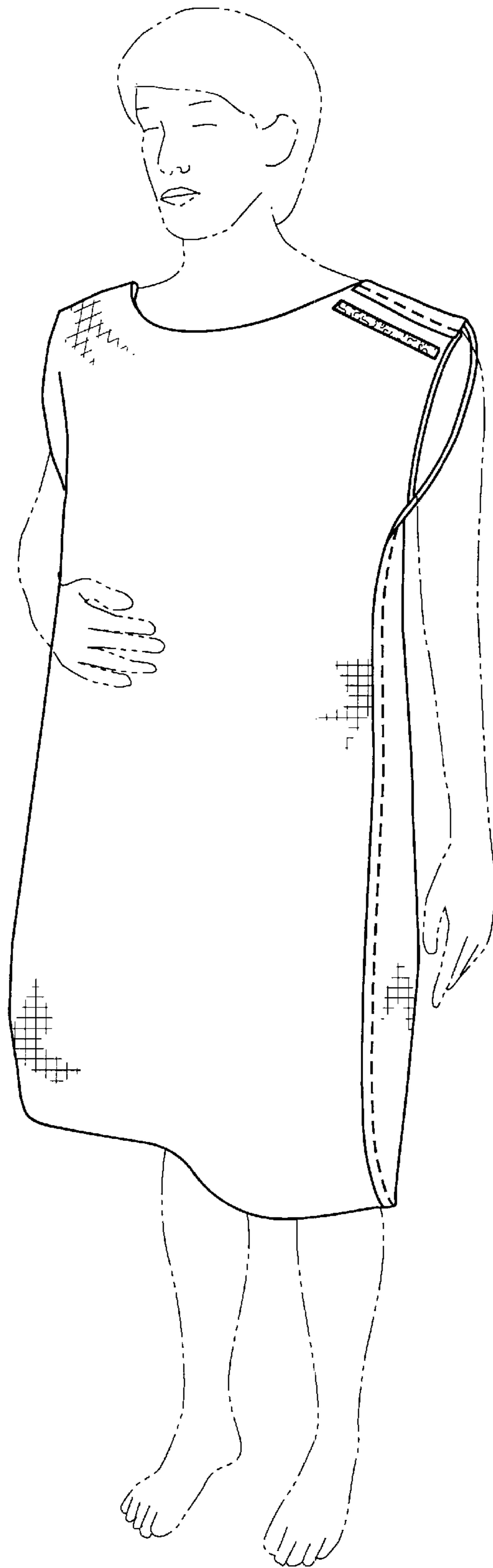

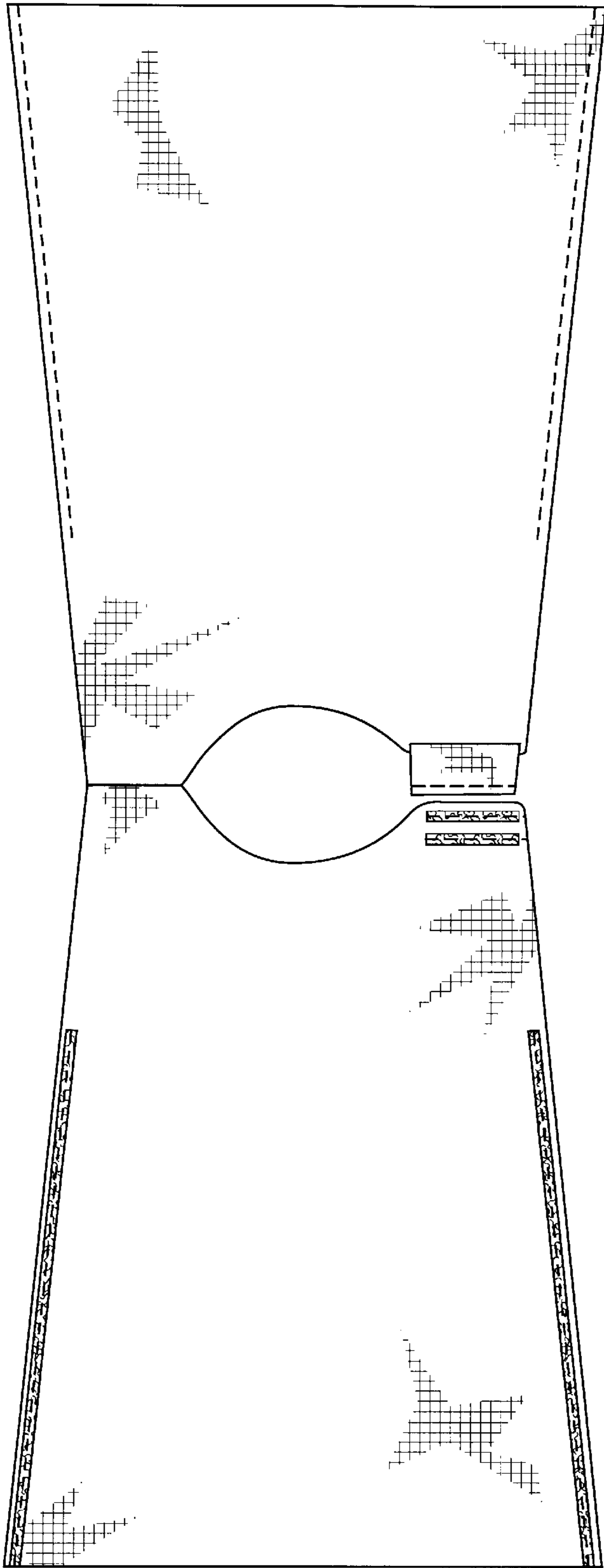

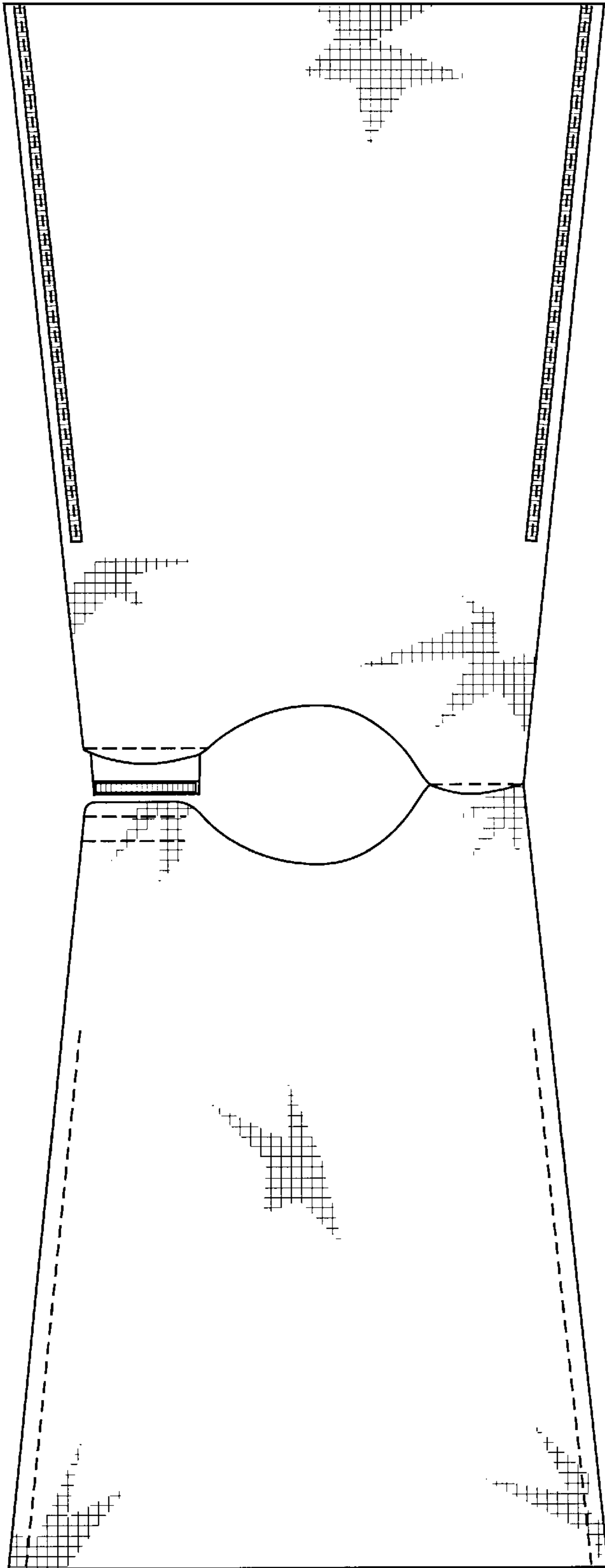
