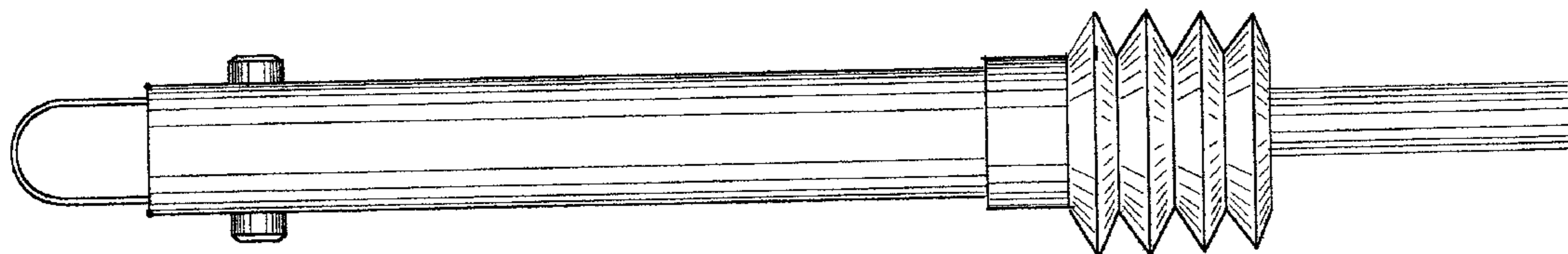
(57) **CLAIM**

DESCRIPTION

FIG. 1. is a front elevation view thereof;

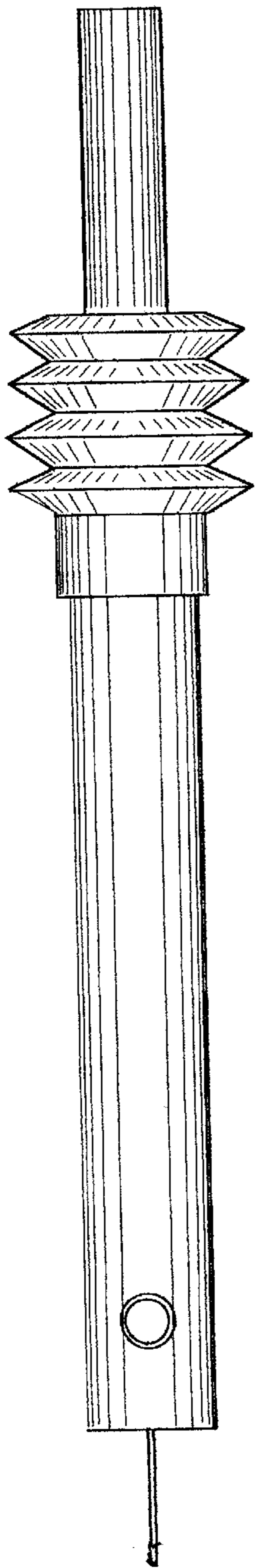

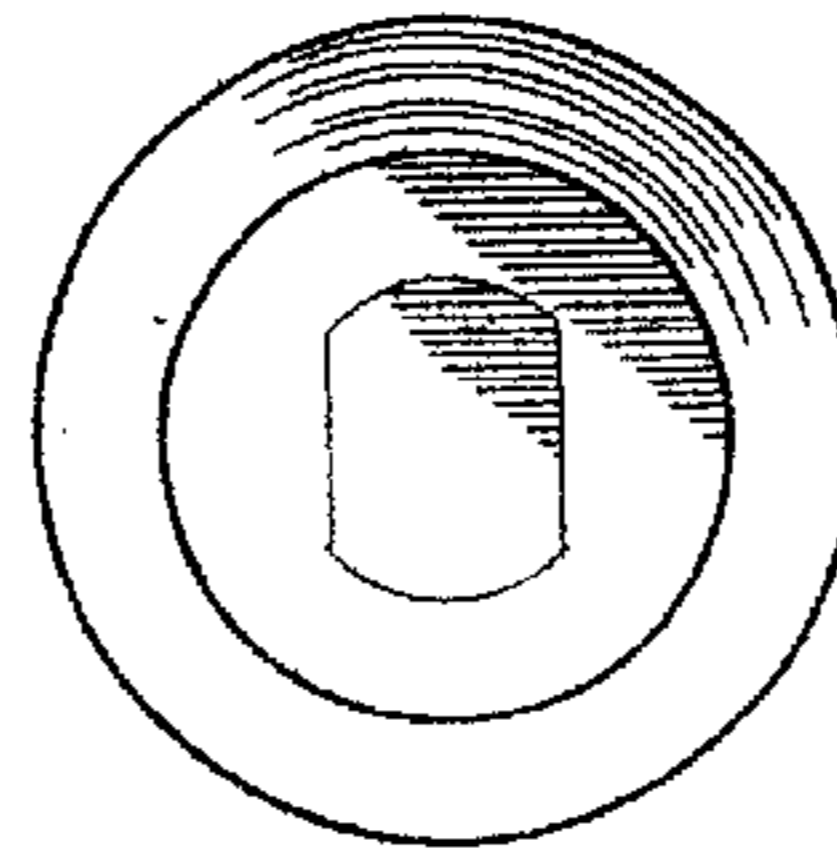

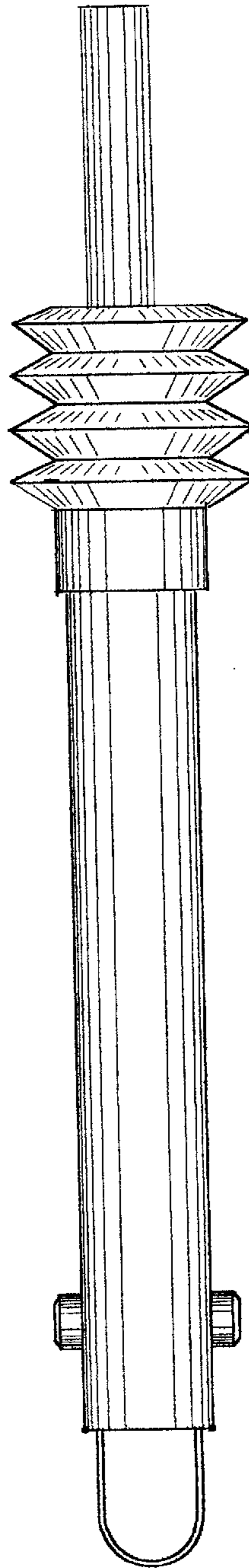

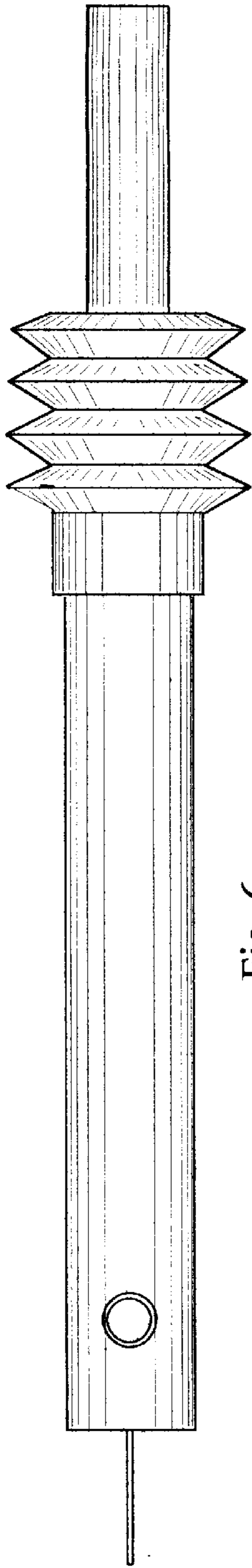

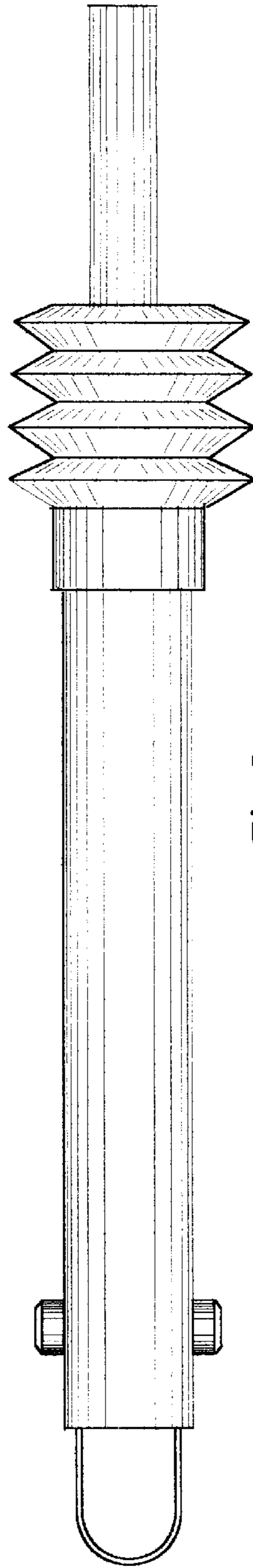

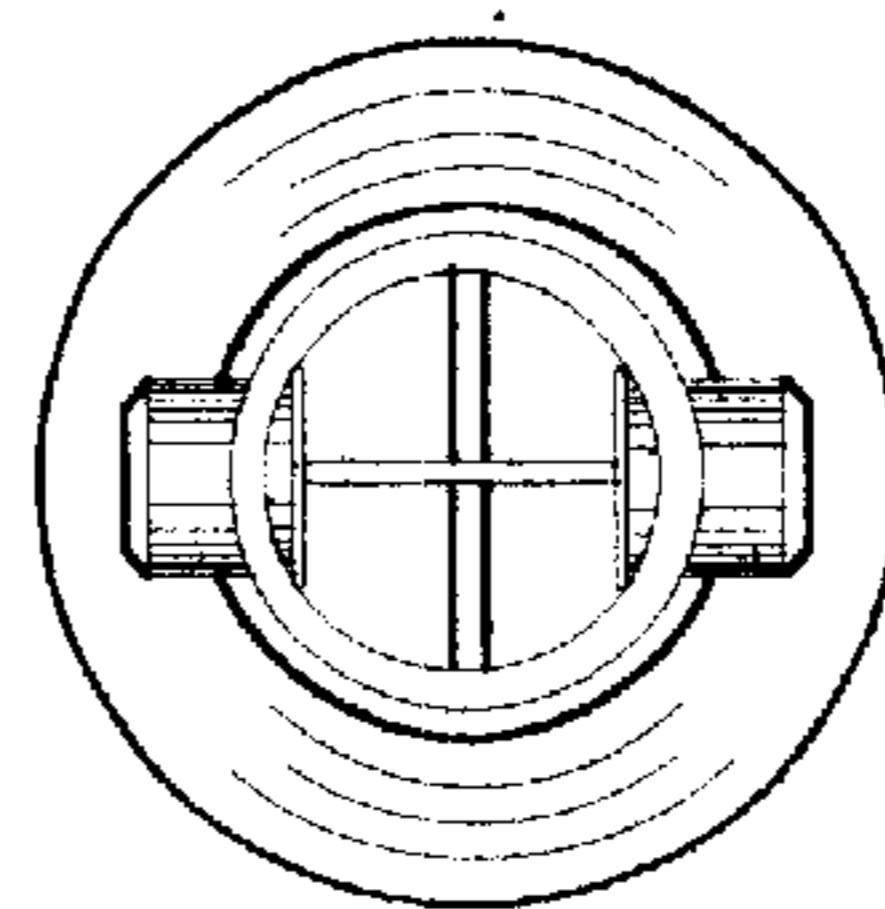
