FIG. 5 is a top plan view thereof.

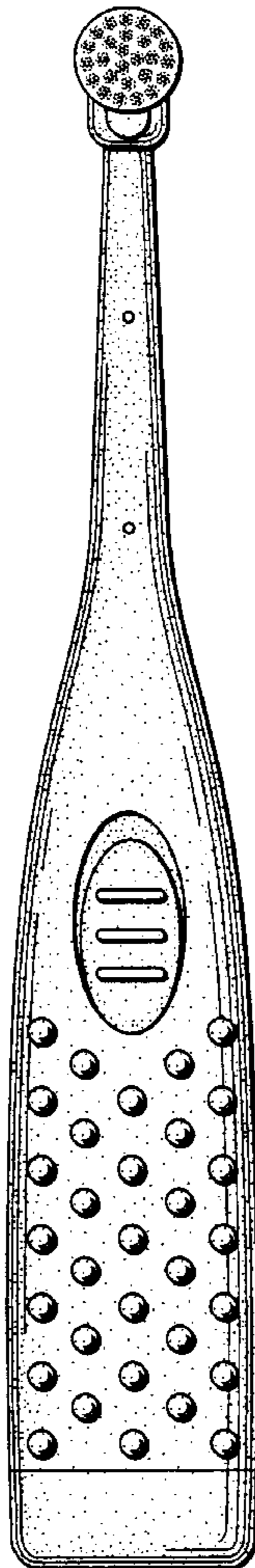
The broken line showing of environmental structure in FIGS. 1, 2, 4 and 5 is for illustrative purposes only and forms no part of the claimed design.

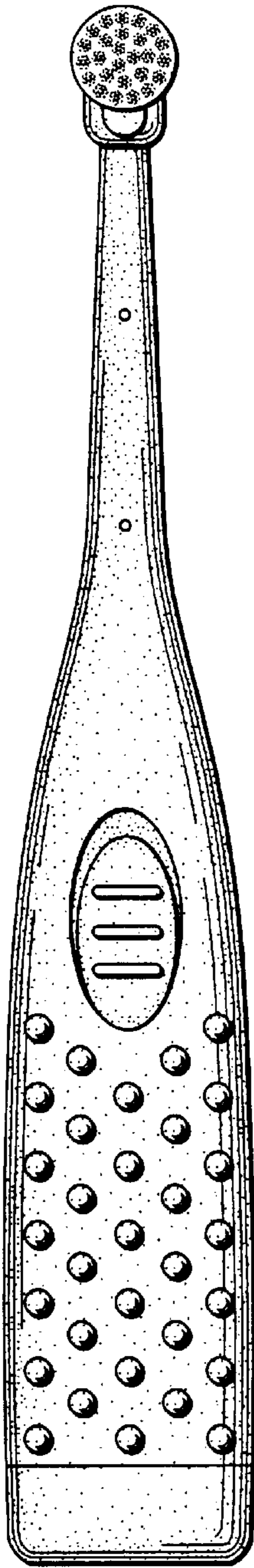

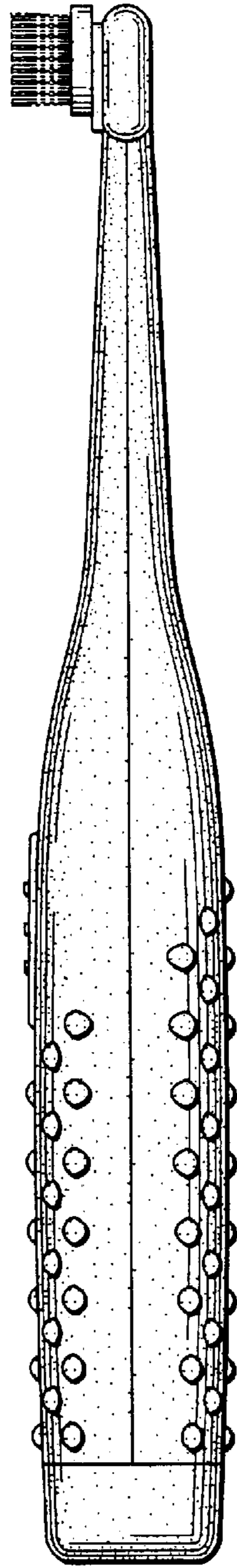

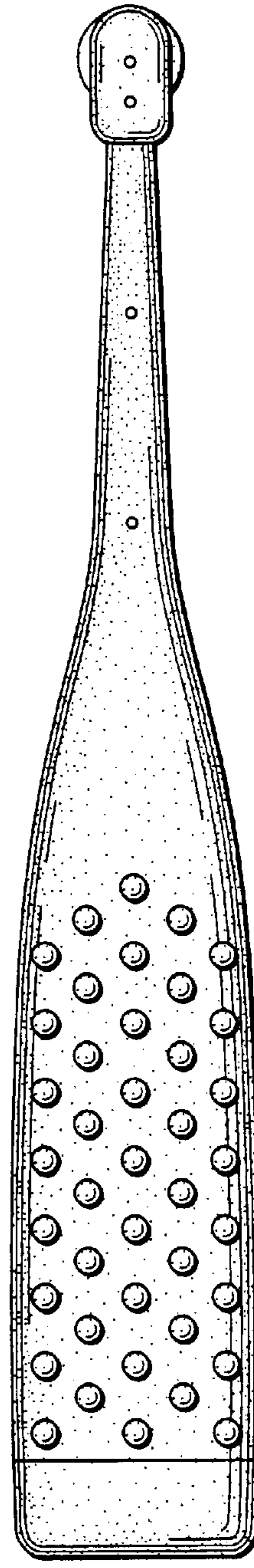

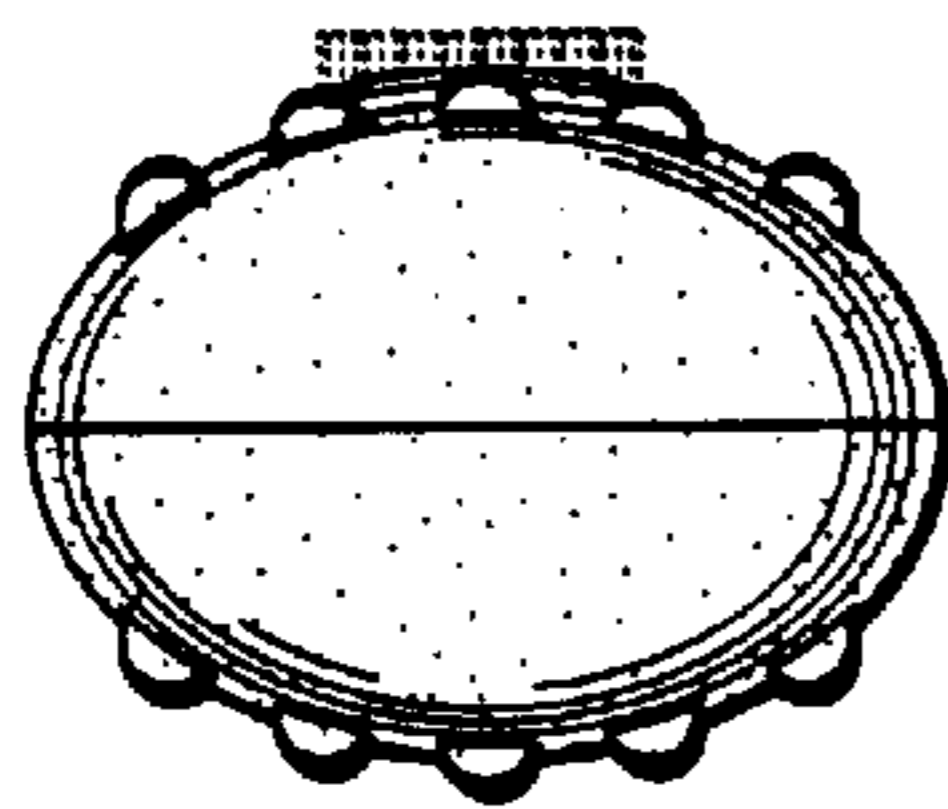

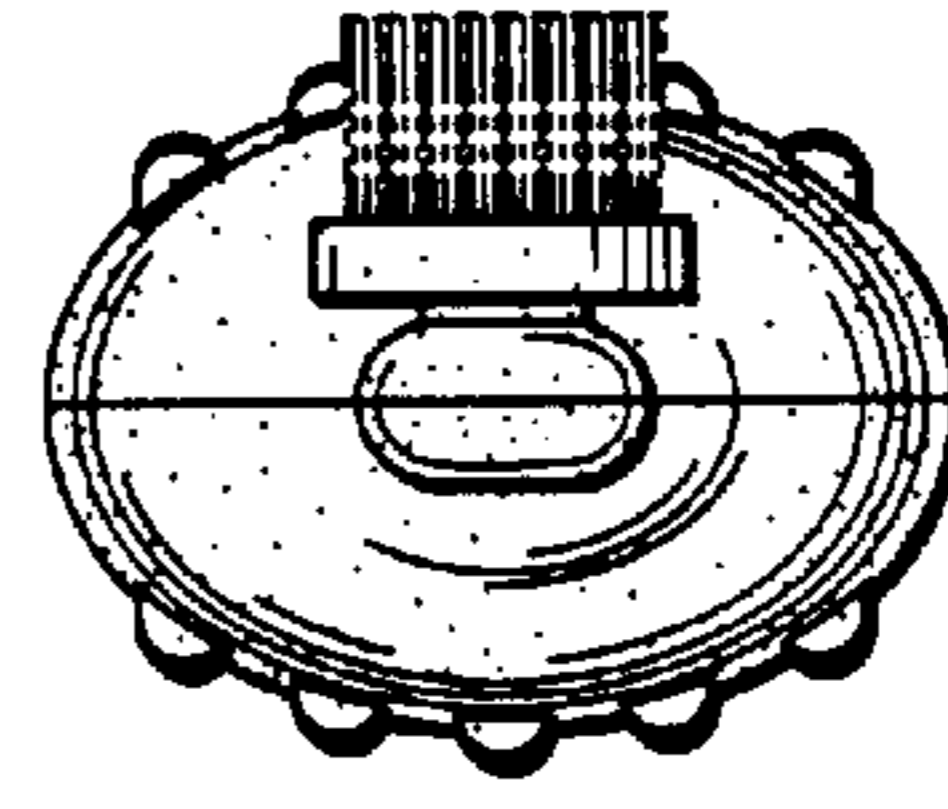

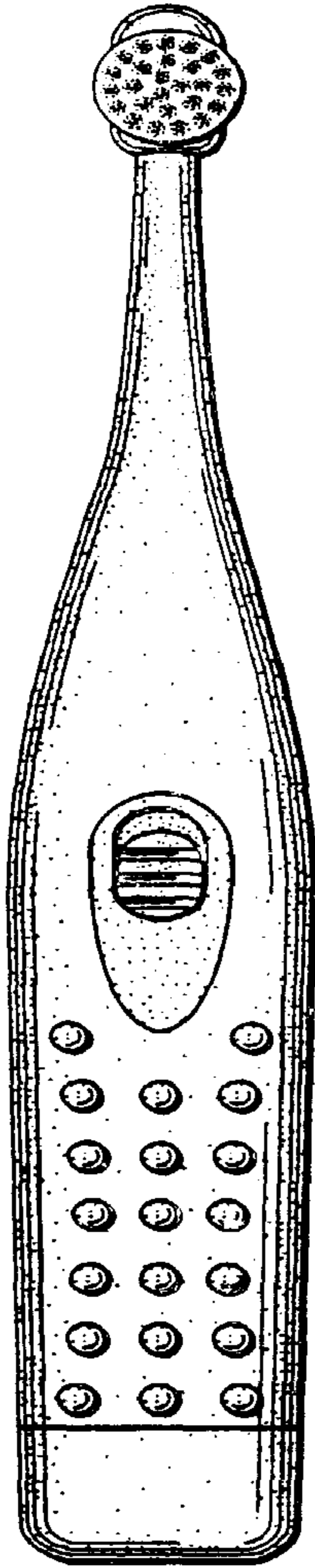

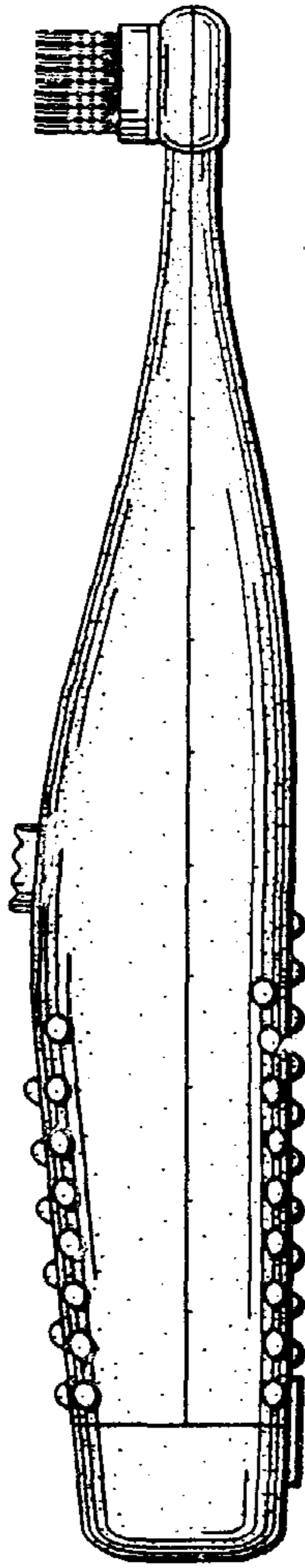

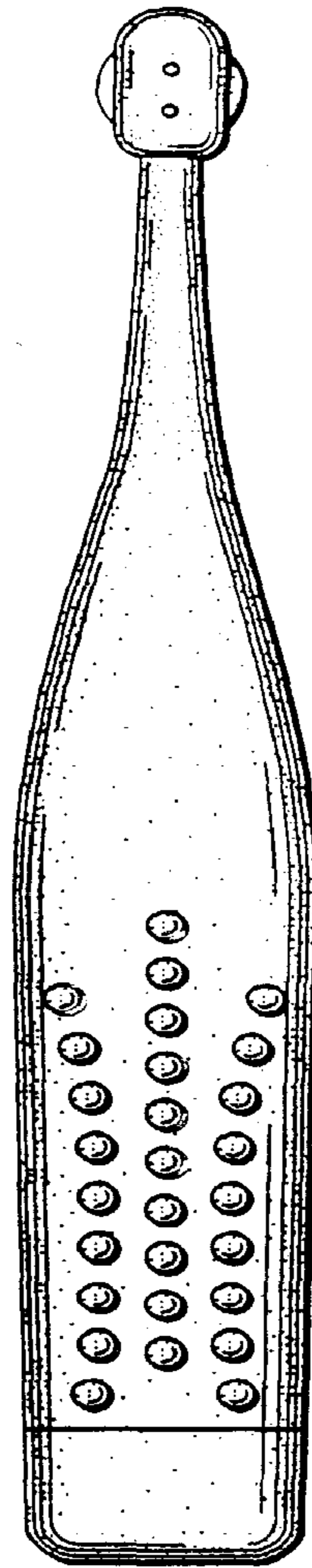

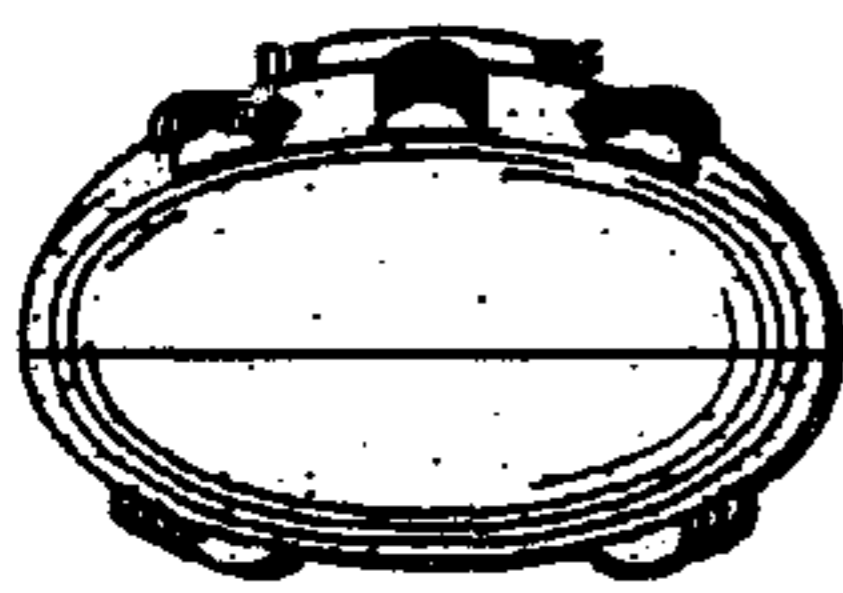

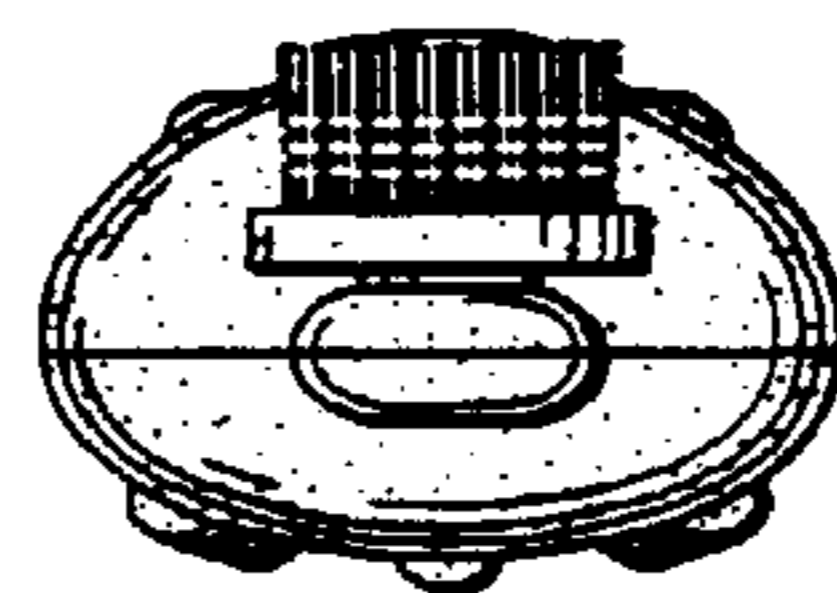
