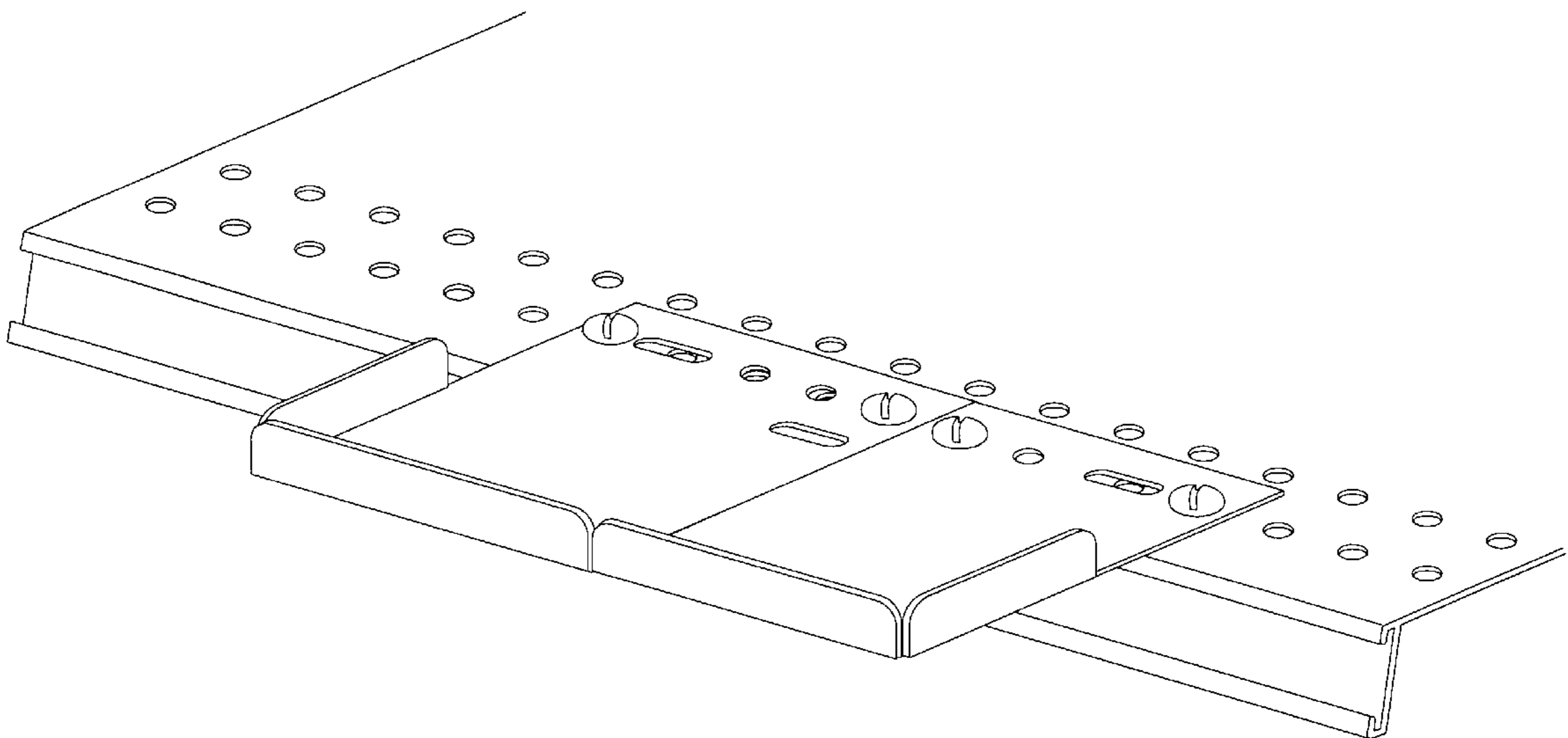
(57) **CLAIM**

The ornamental design for an adjustable merchandise shelf
extender, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the merchandise shelf
extender according to the present design;
FIG. 2 is a top view of the merchandise shelf
extender;
FIG. 3 is a front view of the merchandise shelf
extender;
FIG. 4 is a right side view of the merchandise shelf
extender;
FIG. 5 is a left side view of the merchandise shelf
extender;
FIG. 6 is a rear view of the merchandise shelf
extender; and,
FIG. 7 is a bottom view of the merchandise shelf
extender.

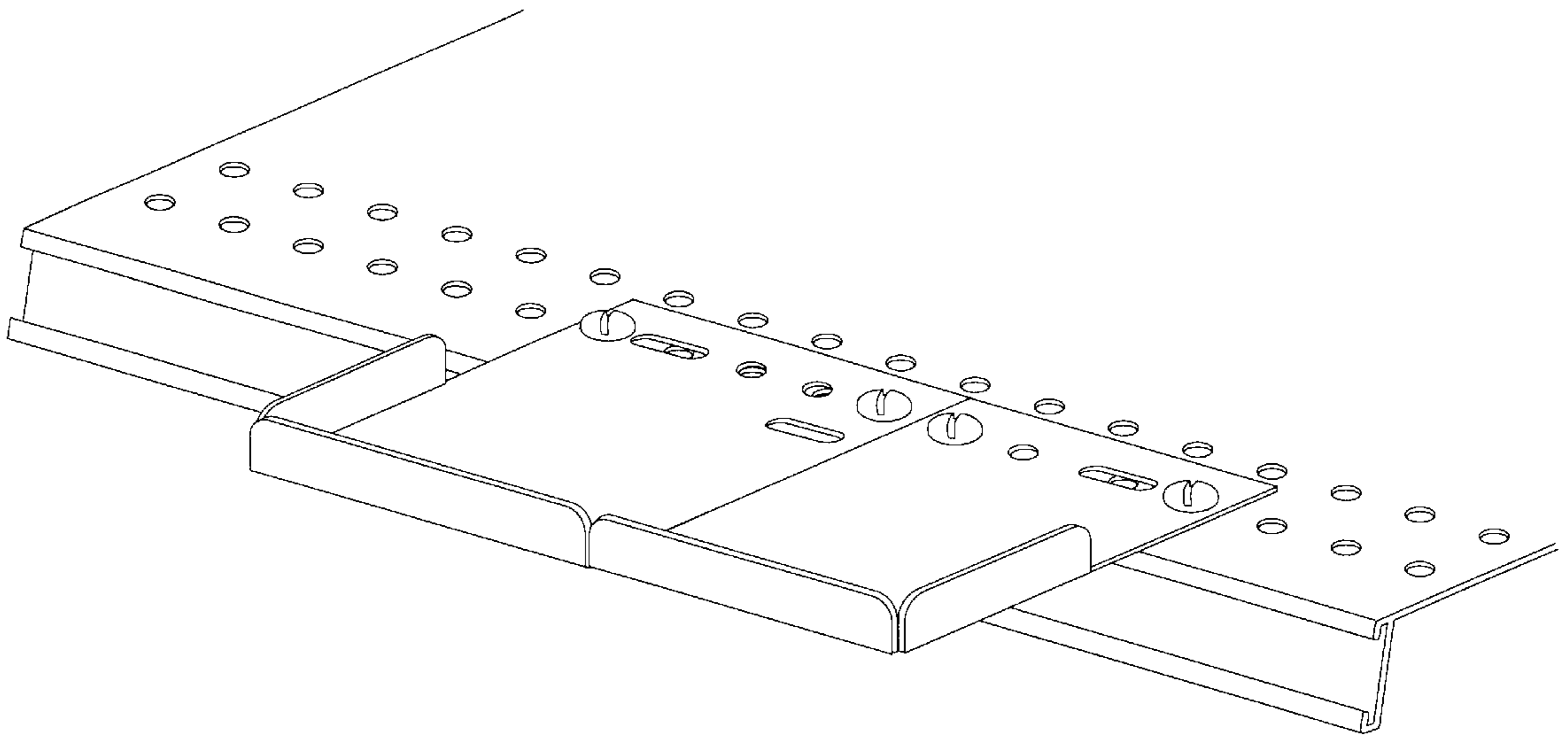

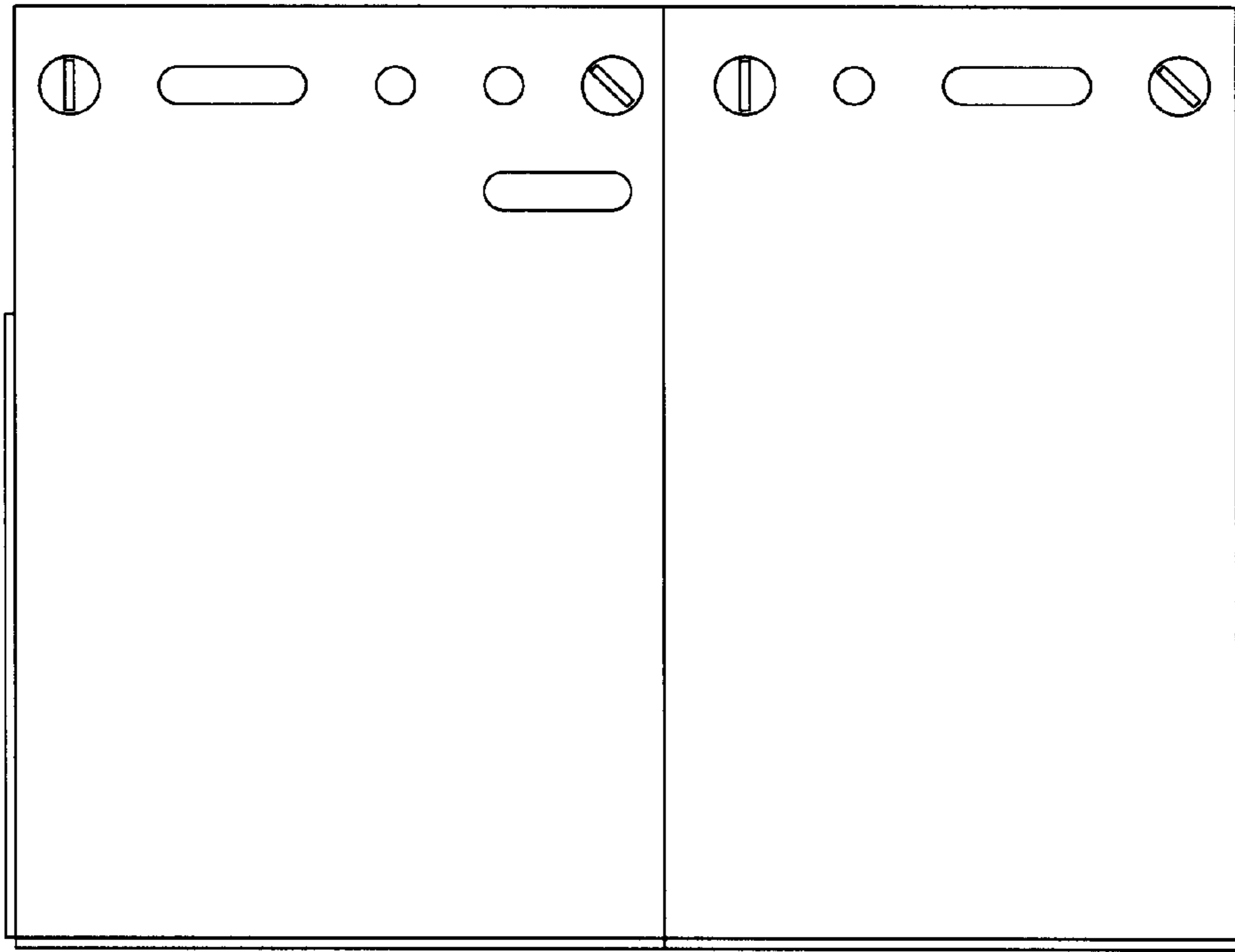

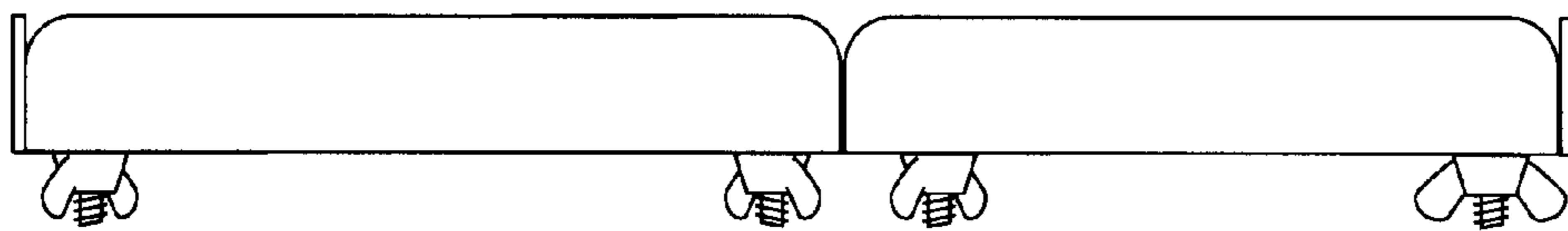

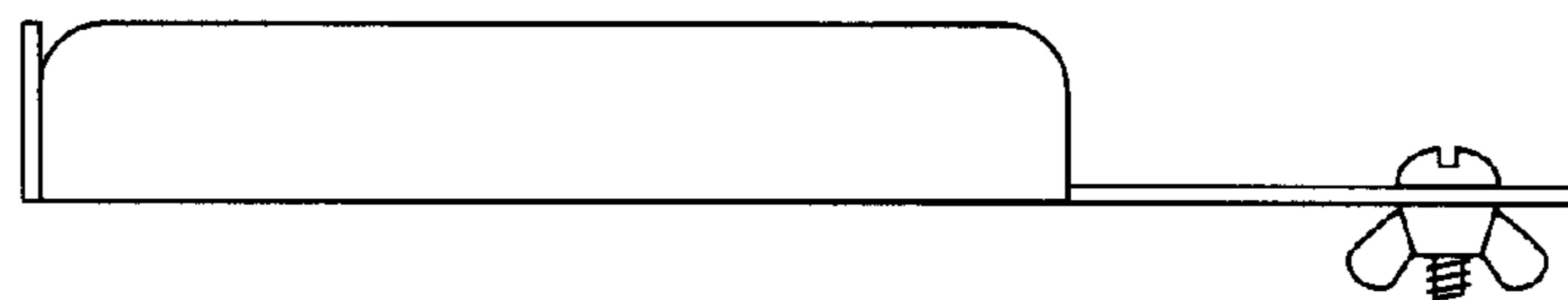

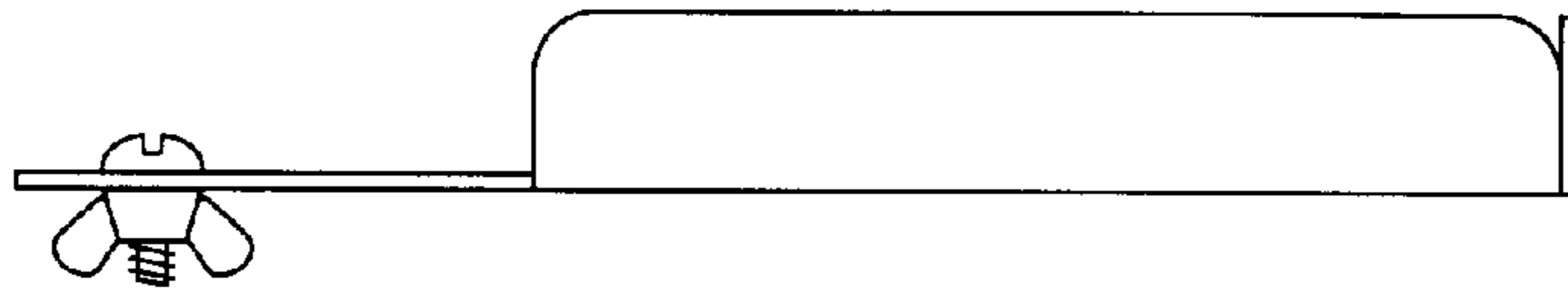

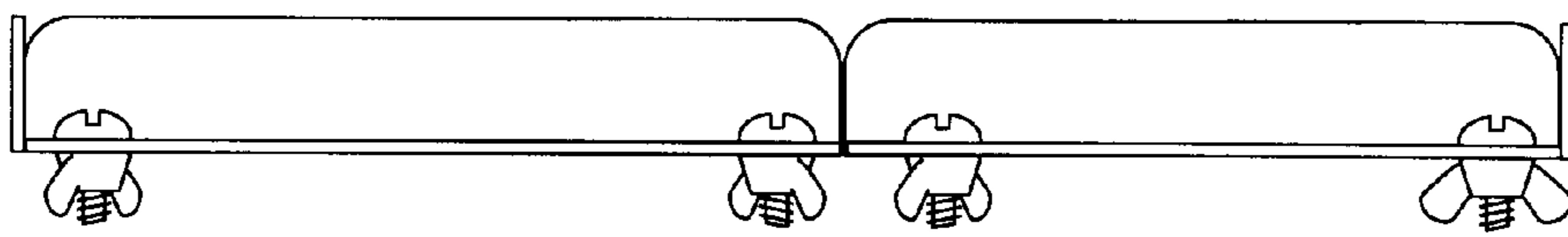

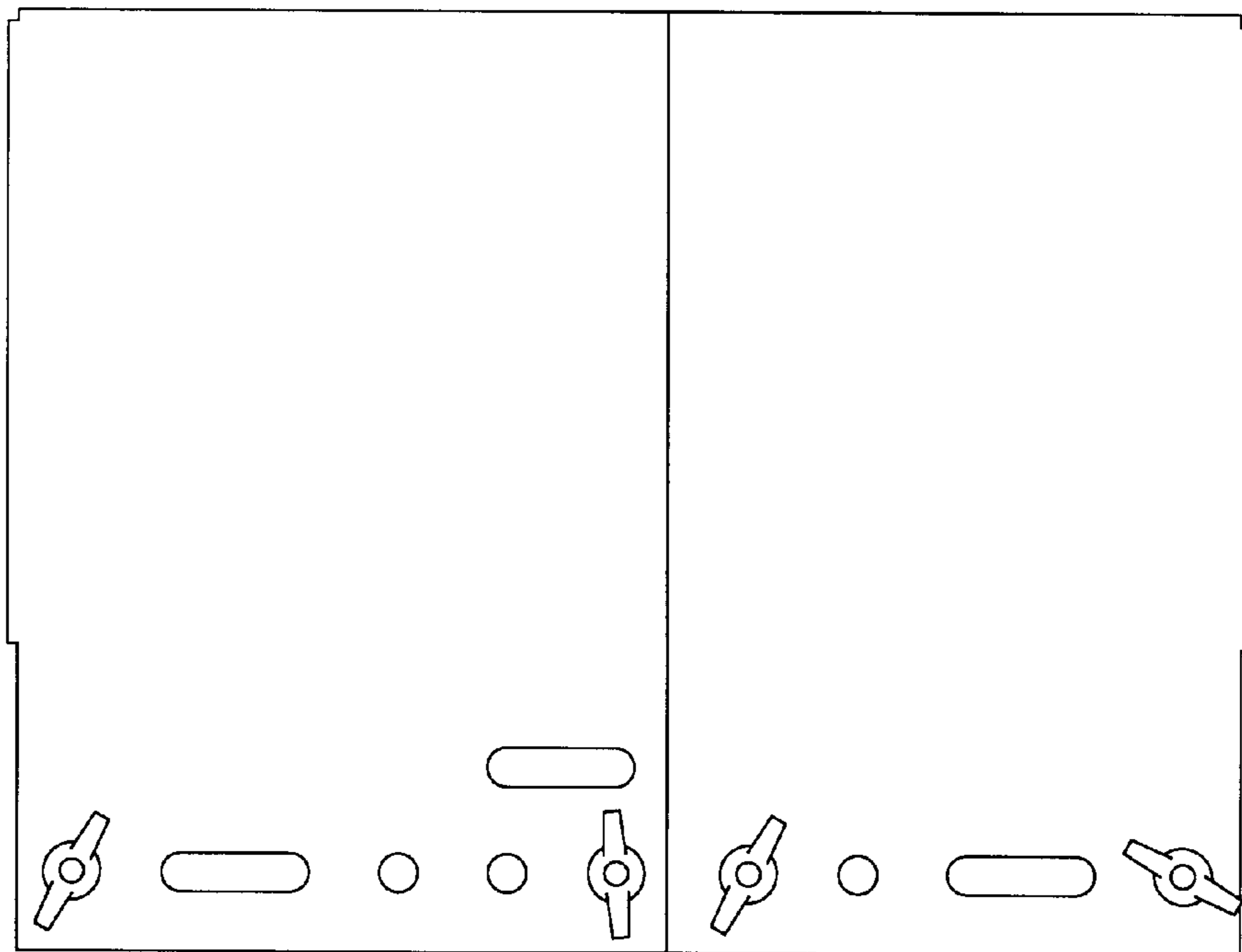
