(57) **CLAIM**

I claim the ornamental design for a golf caddie, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a golf caddie showing my new design, the broken-line disclosure understood to be for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof; and,

FIG. 7 is a fragmentary, vertical cross-sectional view thereof, taken along line 7—7 of FIG. 1.

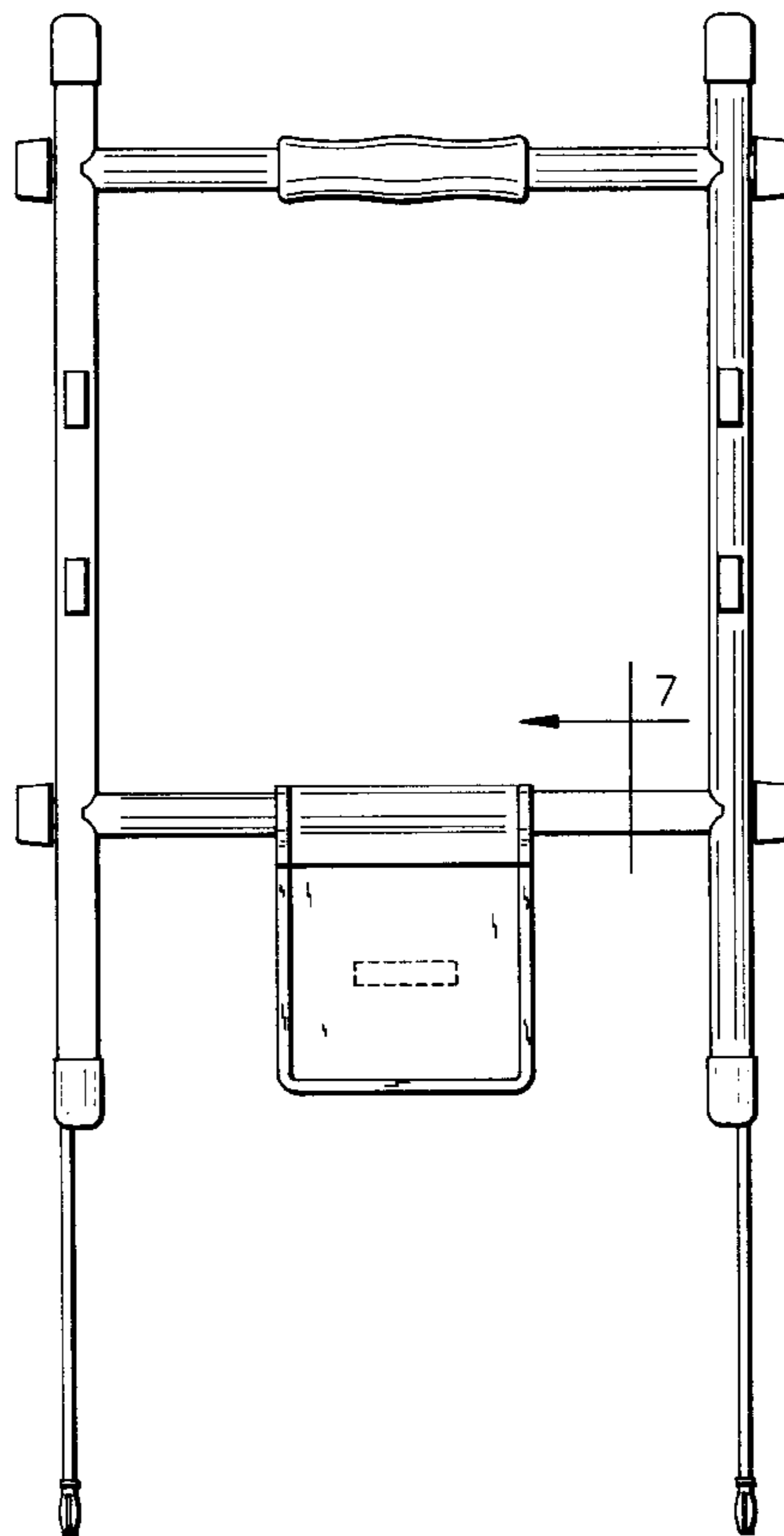

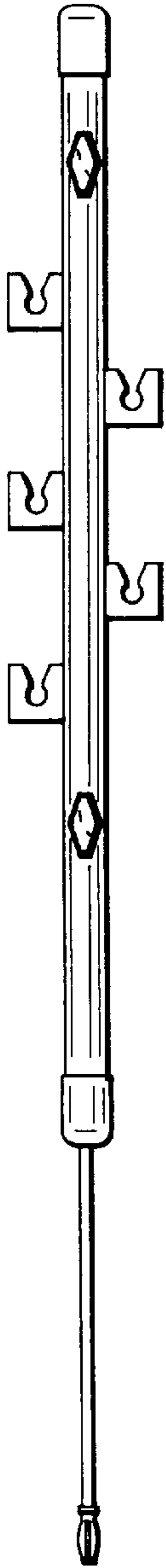

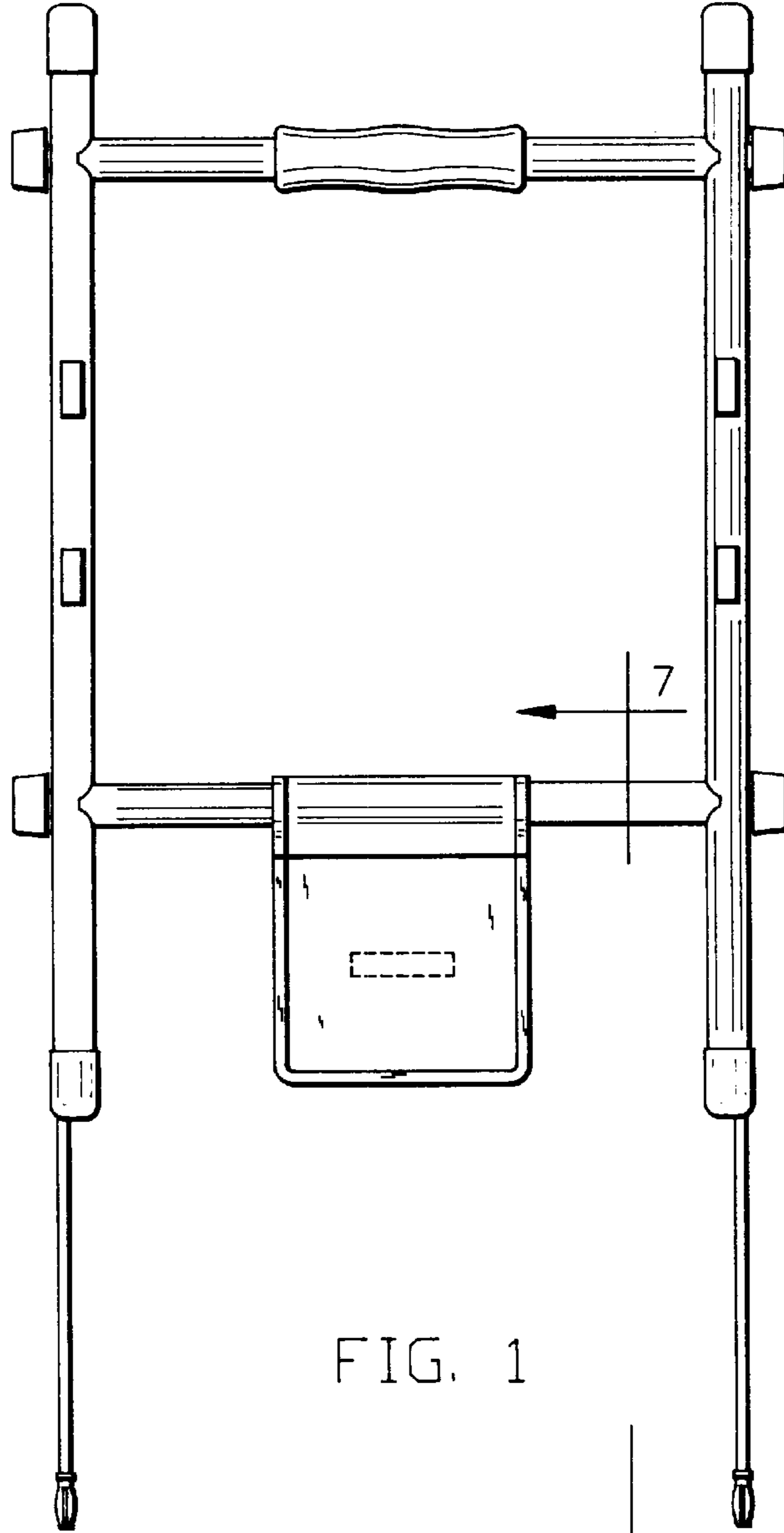

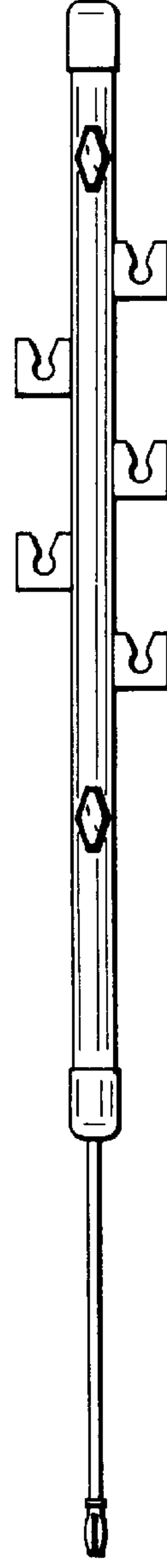

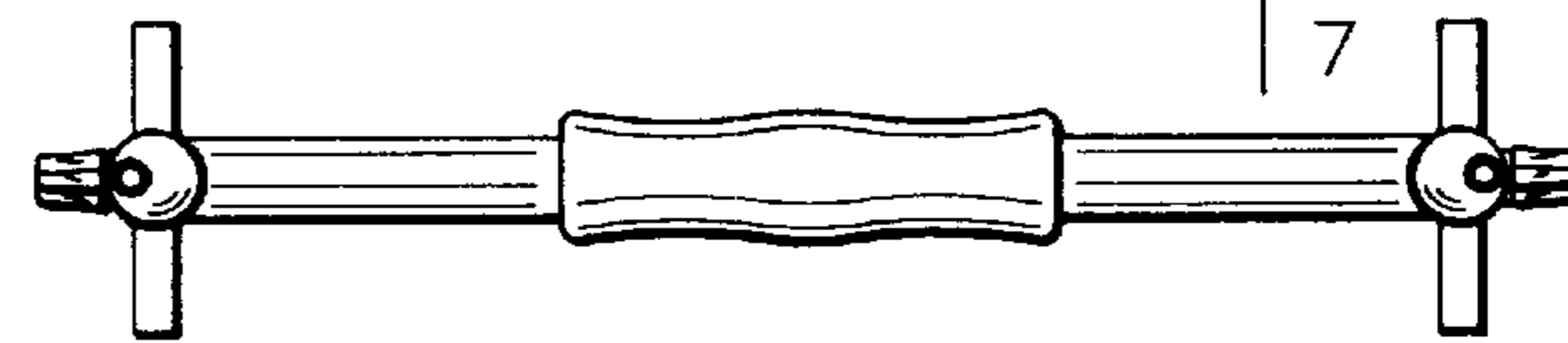

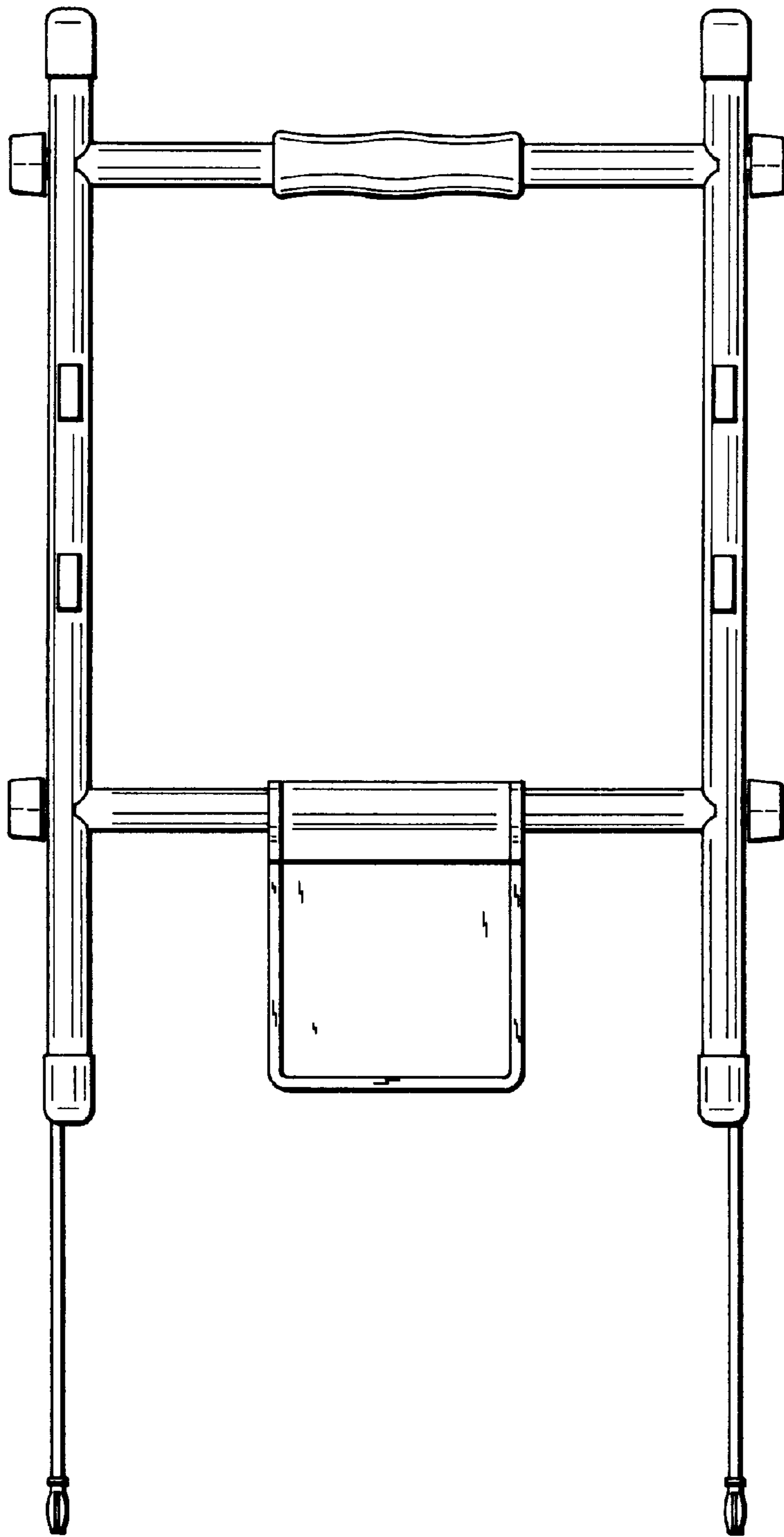
