DESCRIPTION

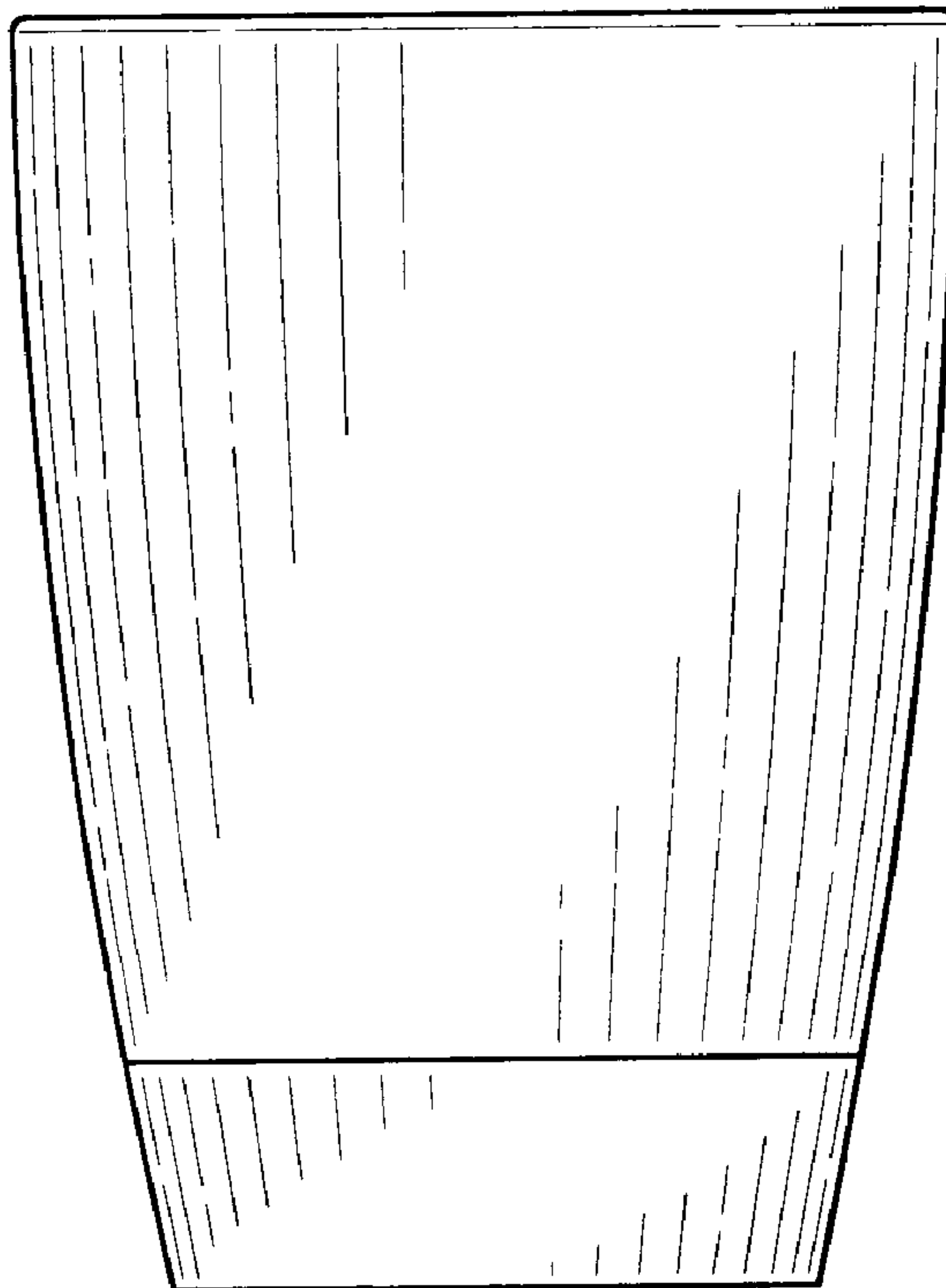
FIG. 1 is a perspective view of the base for containers and holders according to the invention;

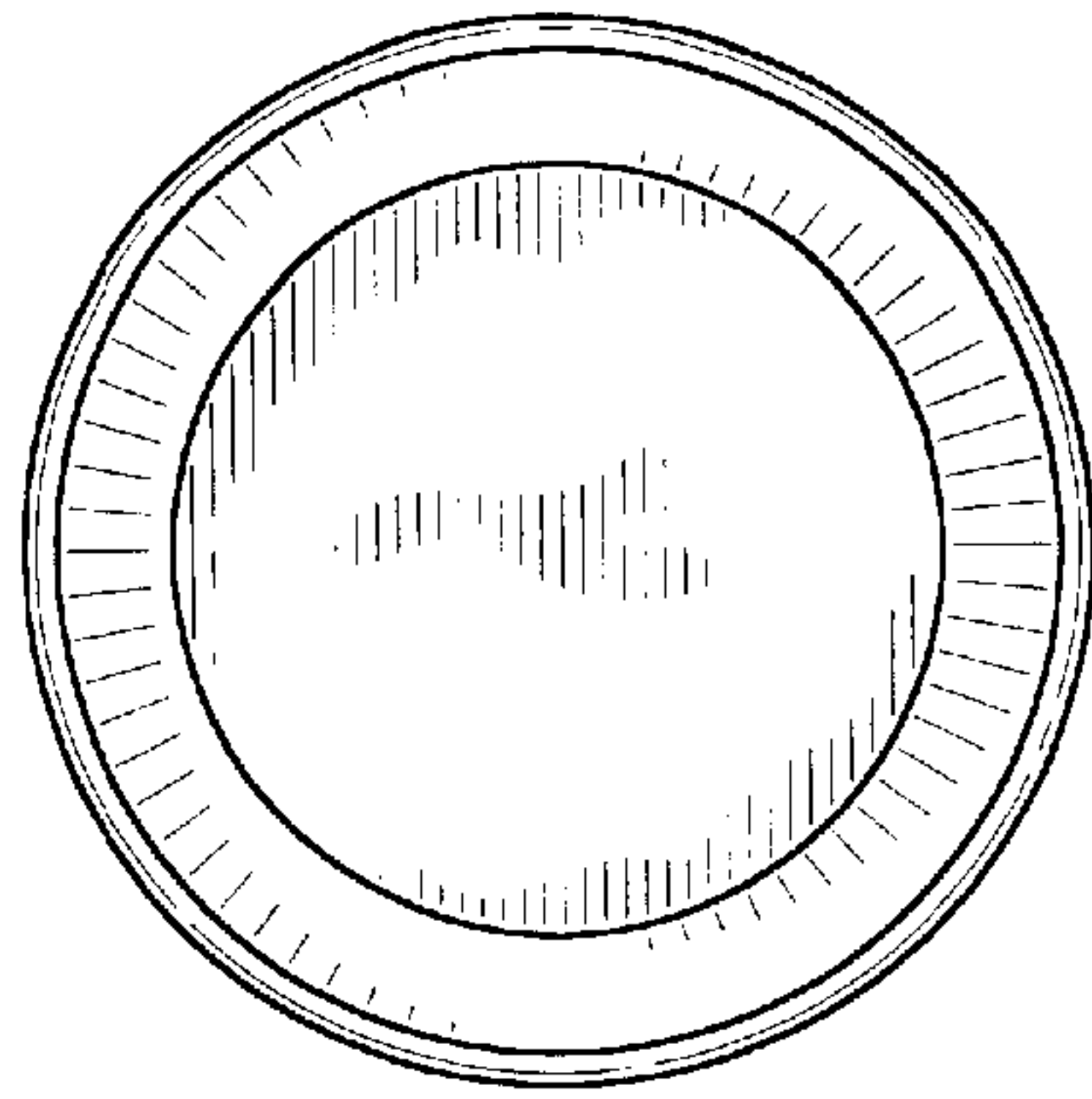

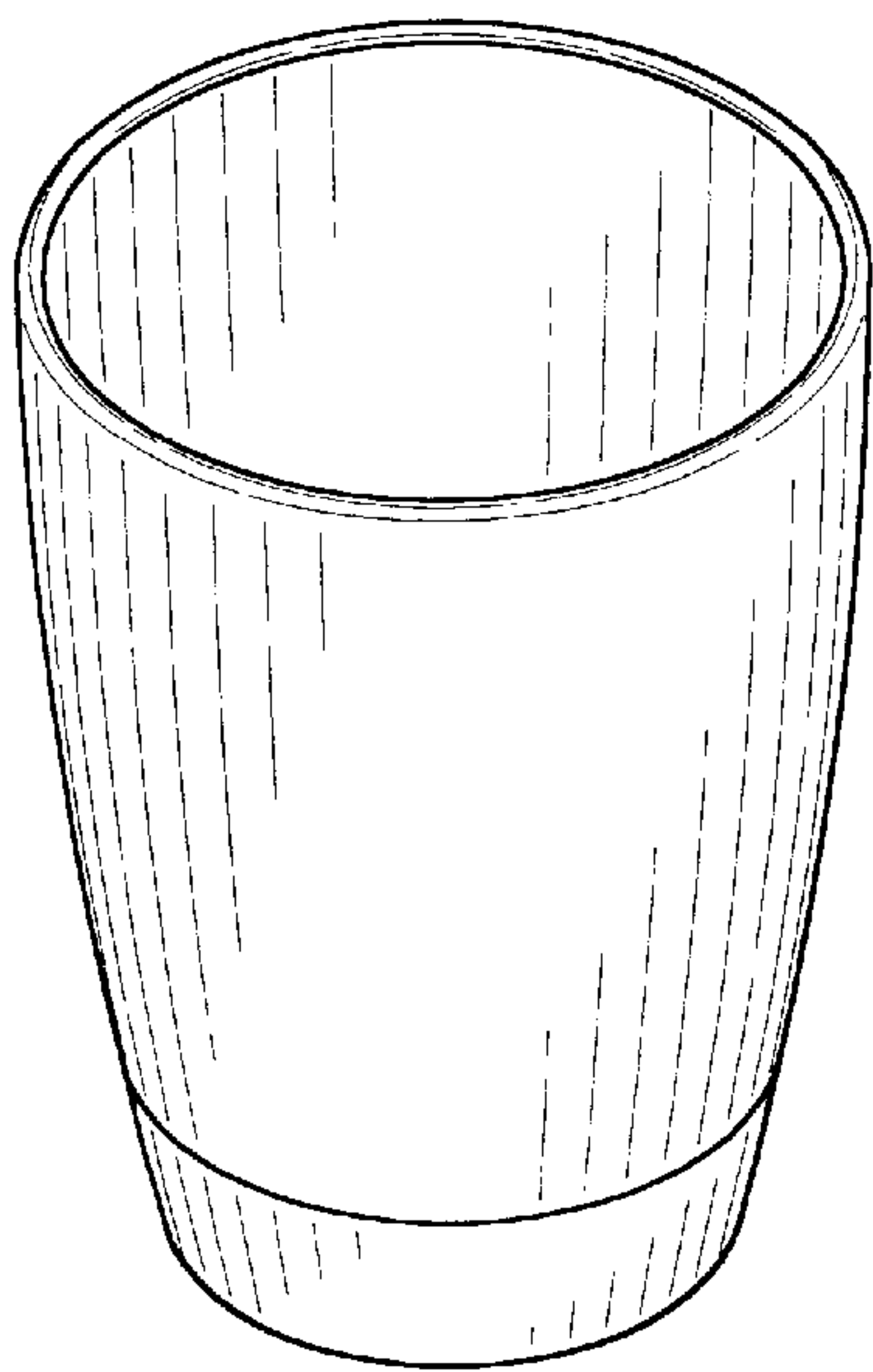

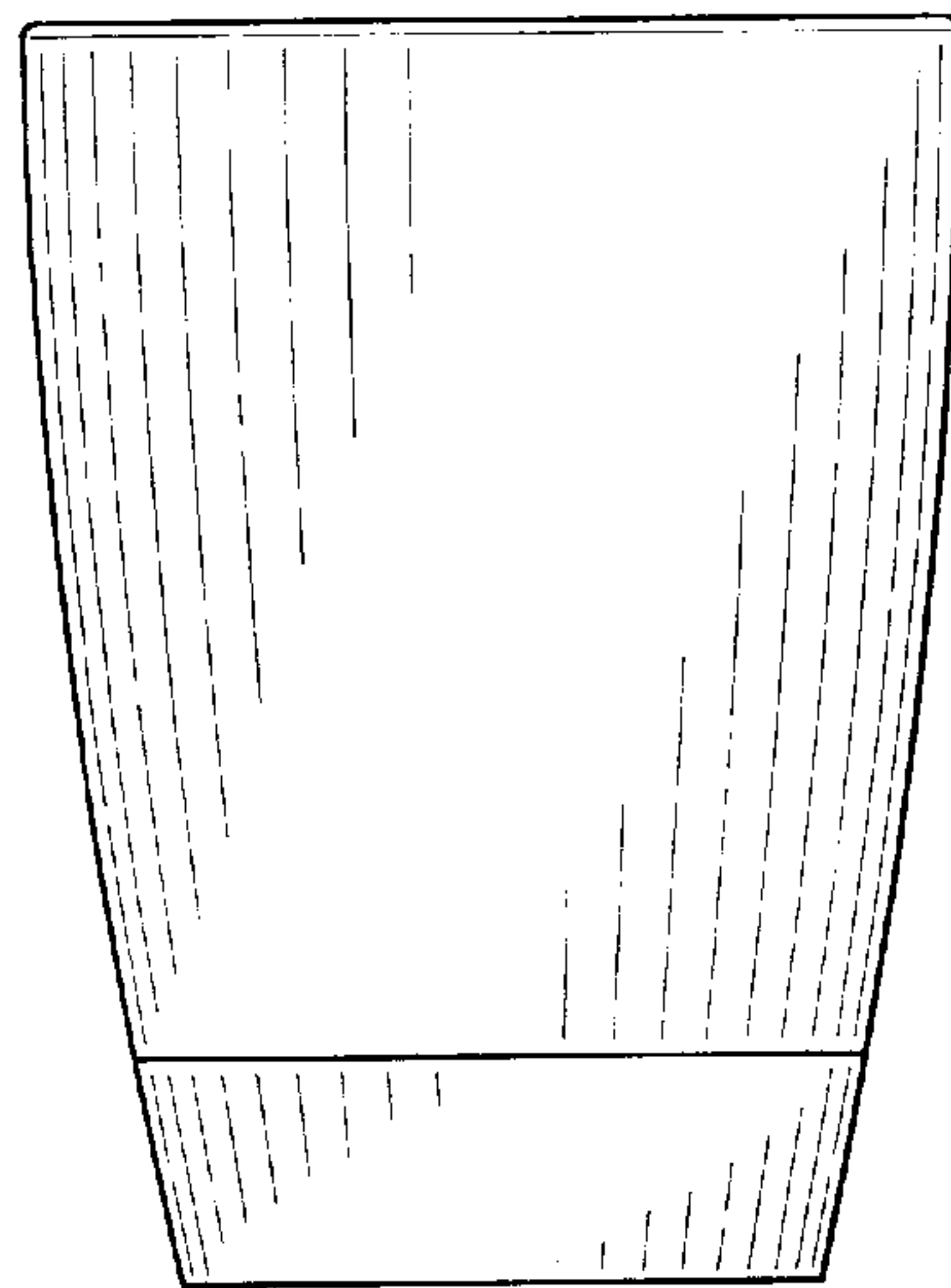

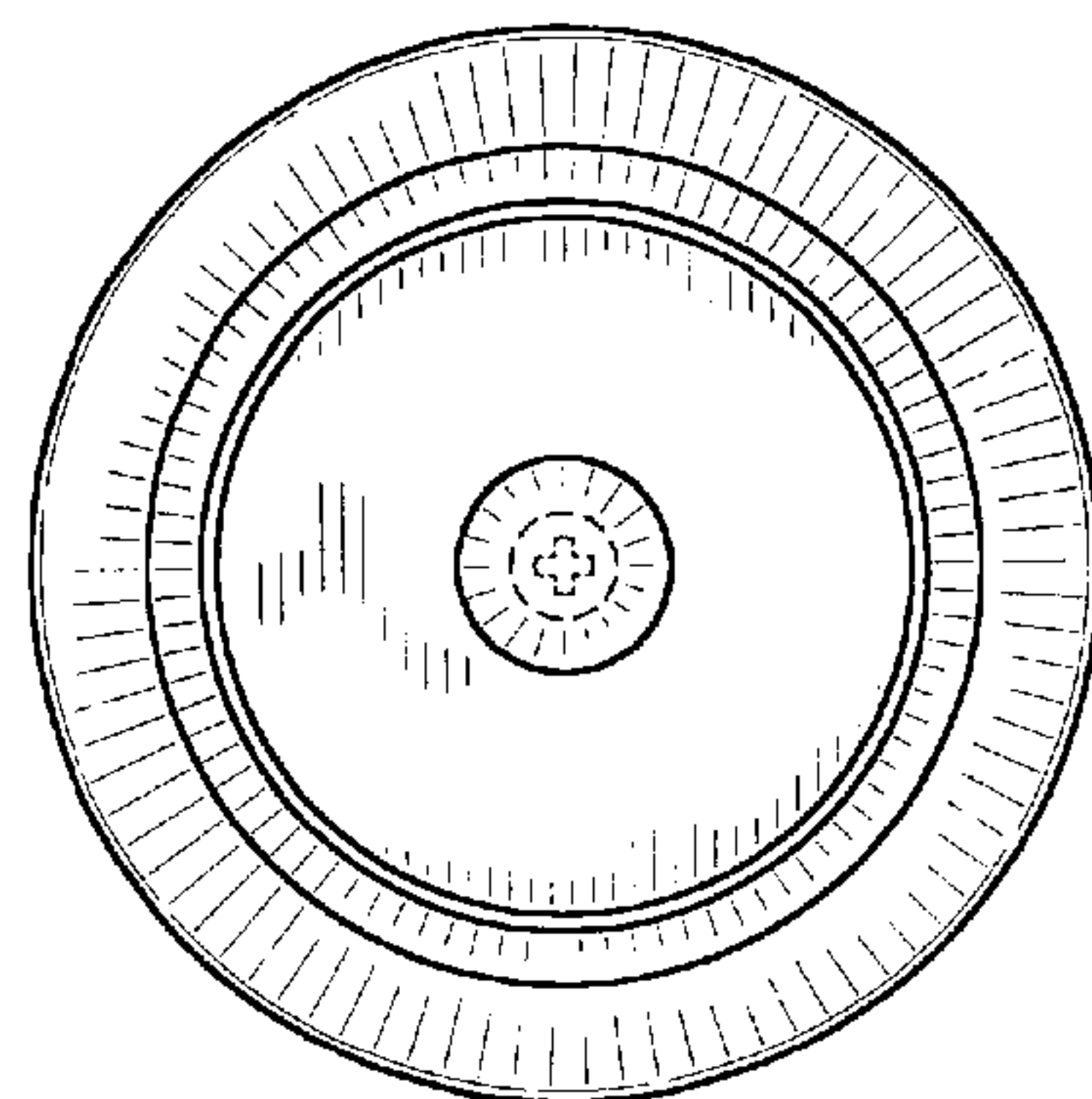
