(57) **CLAIM**

The ornamental design for a frappucino traveler mug, as shown and described.

**DESCRIPTION**

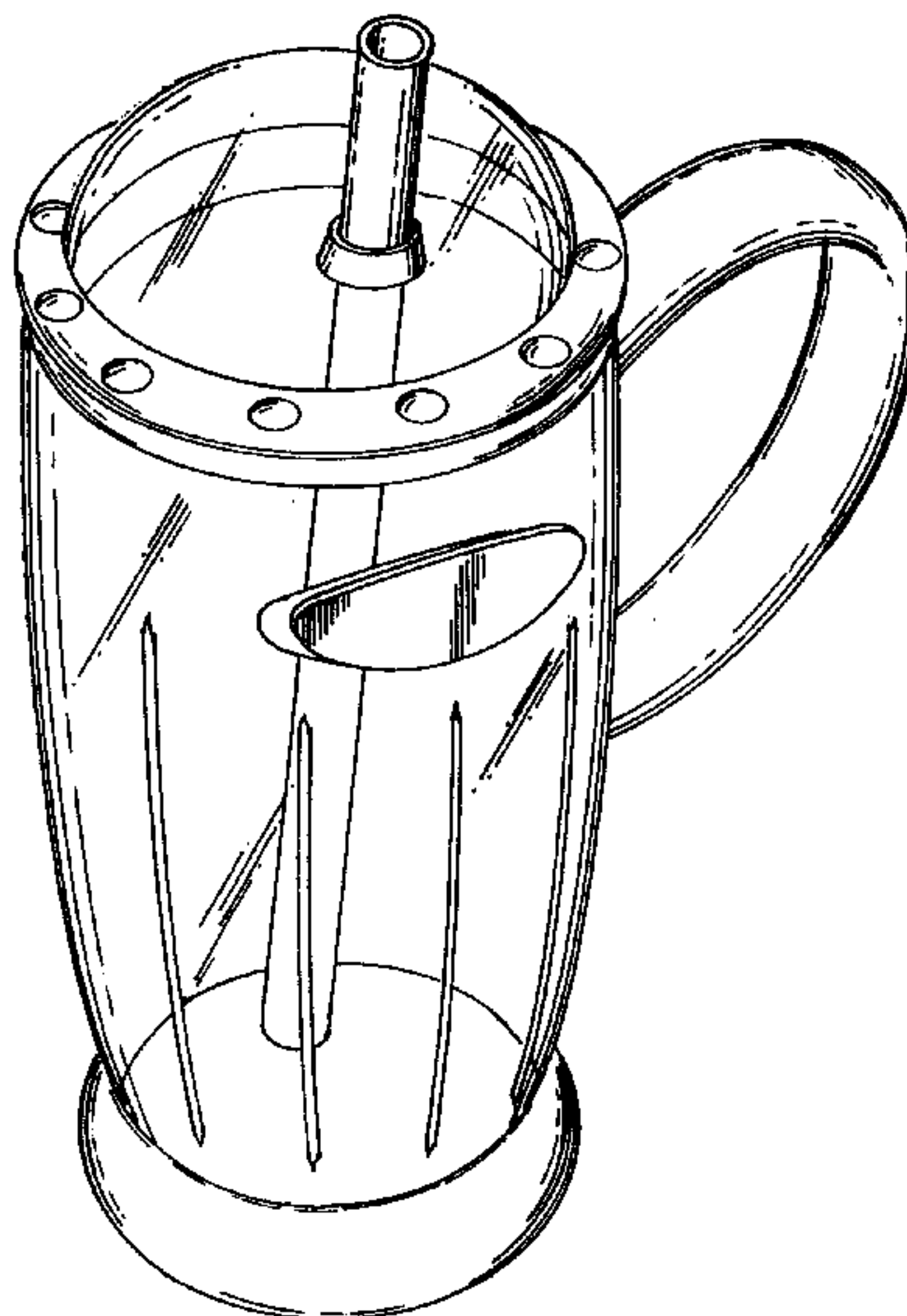

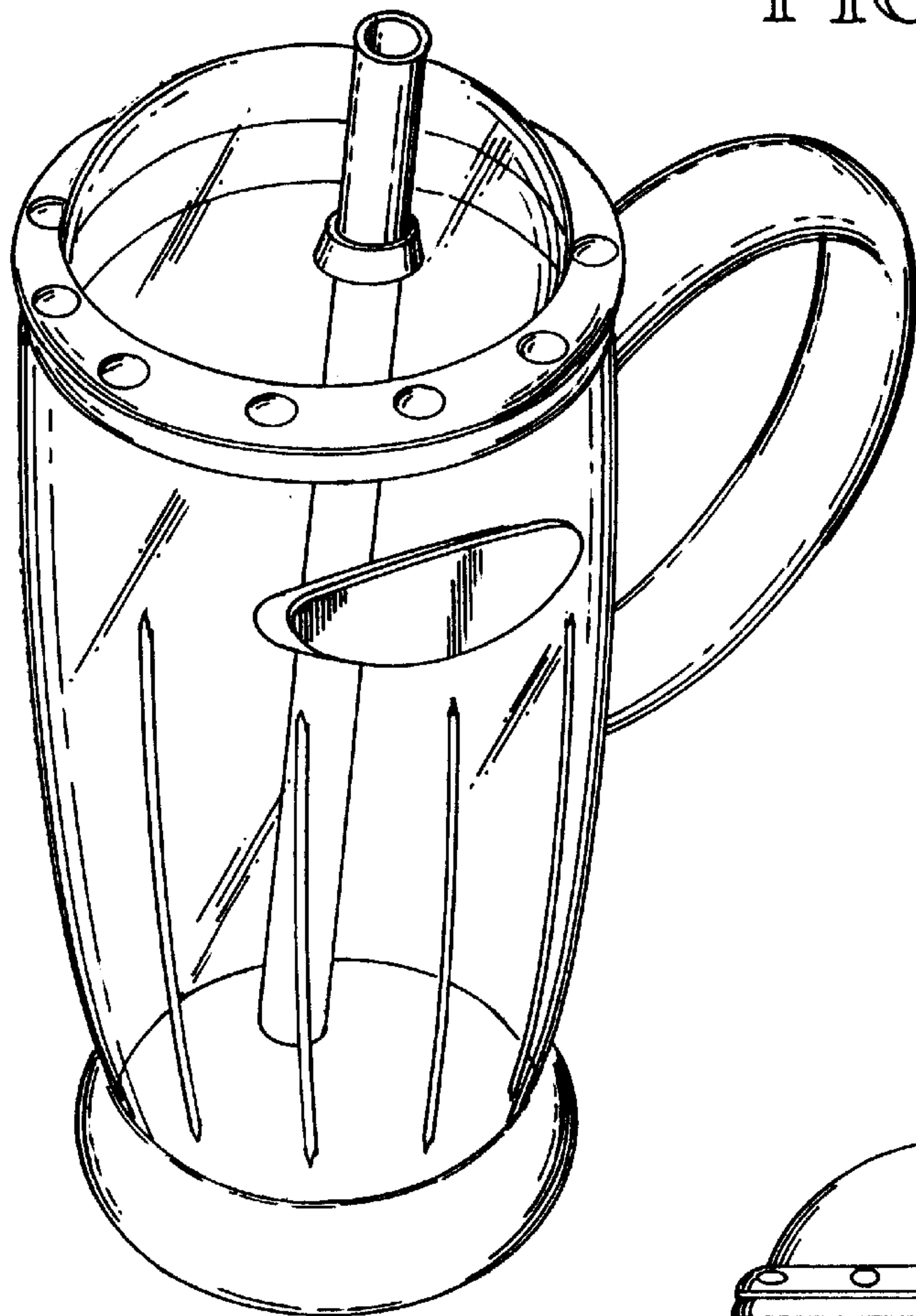
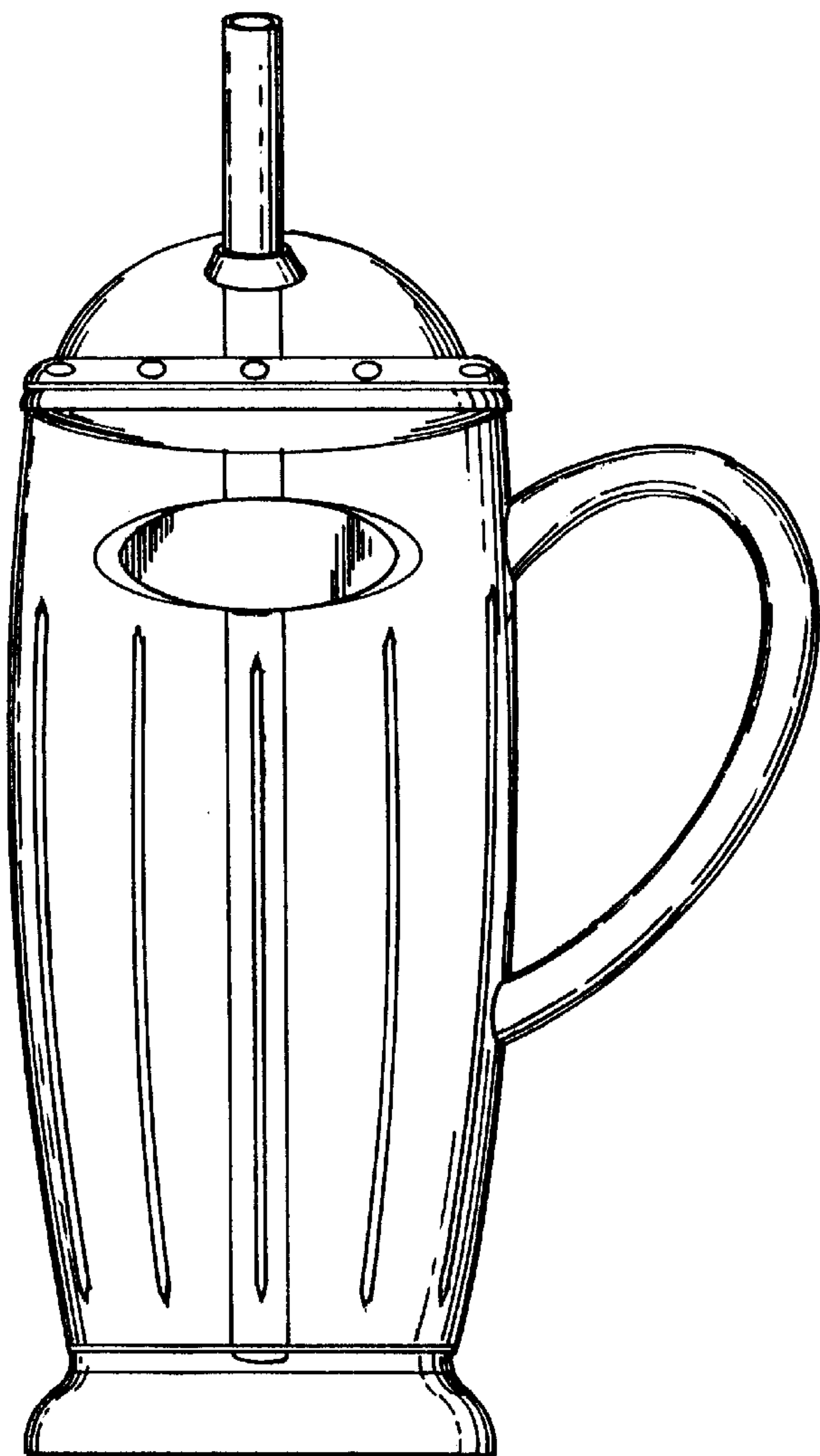

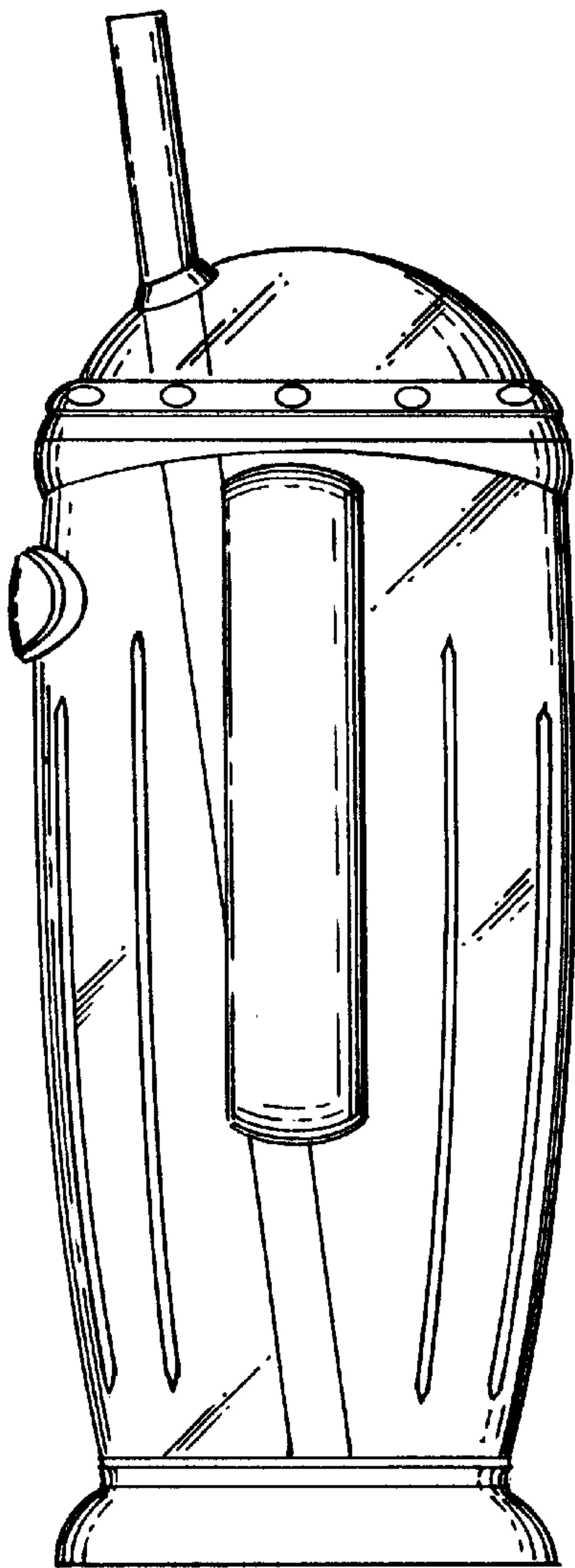

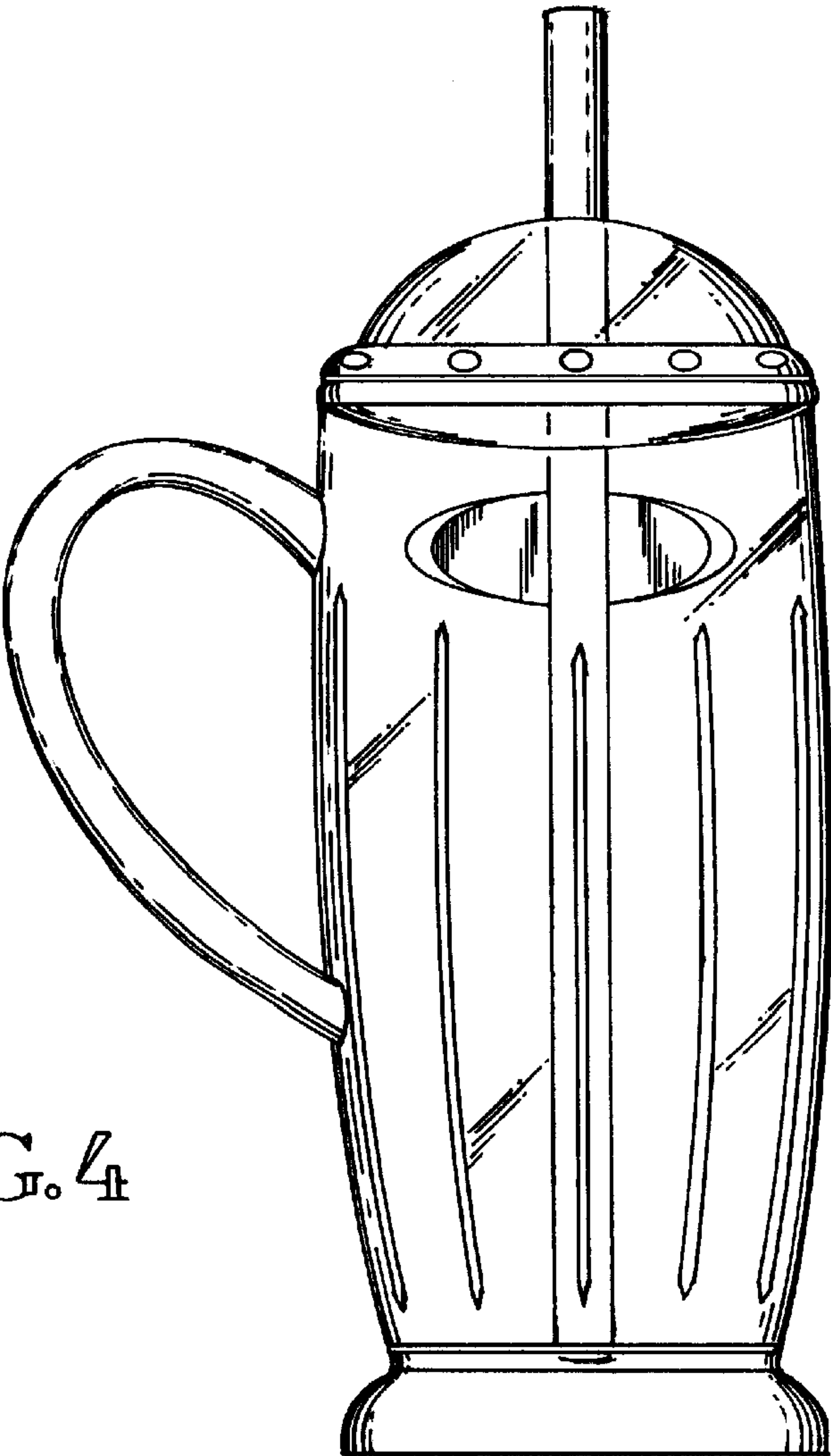

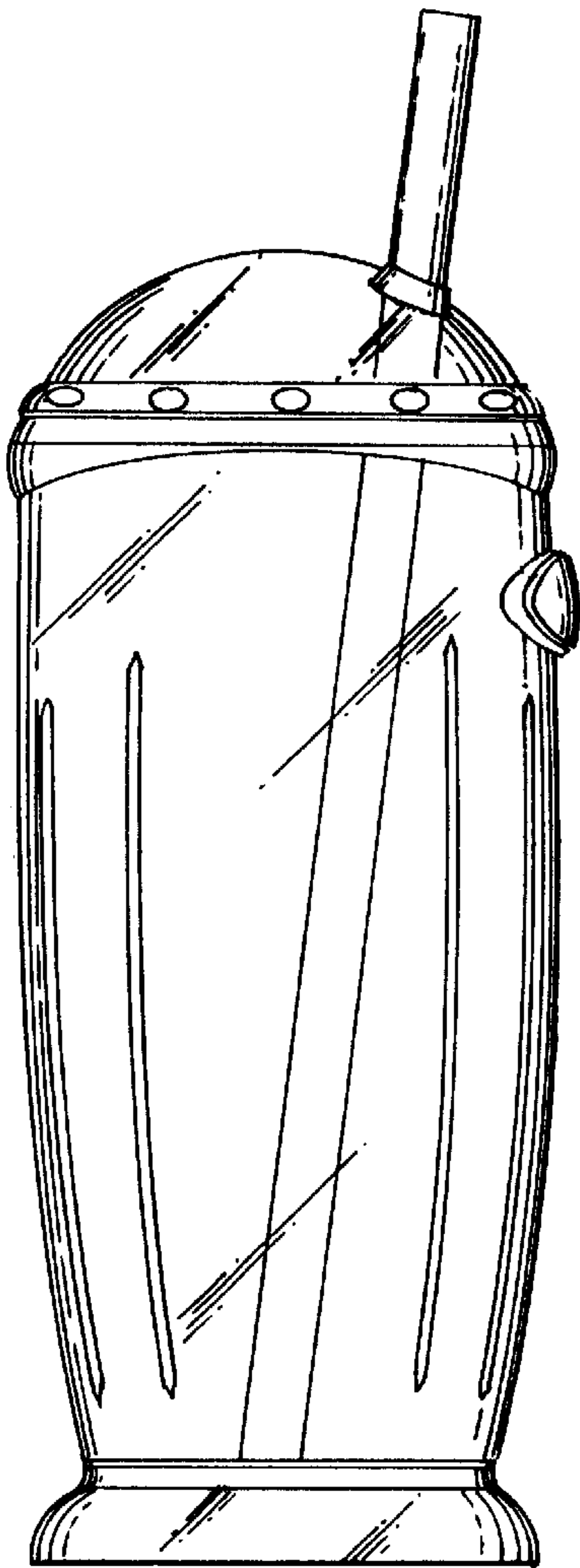

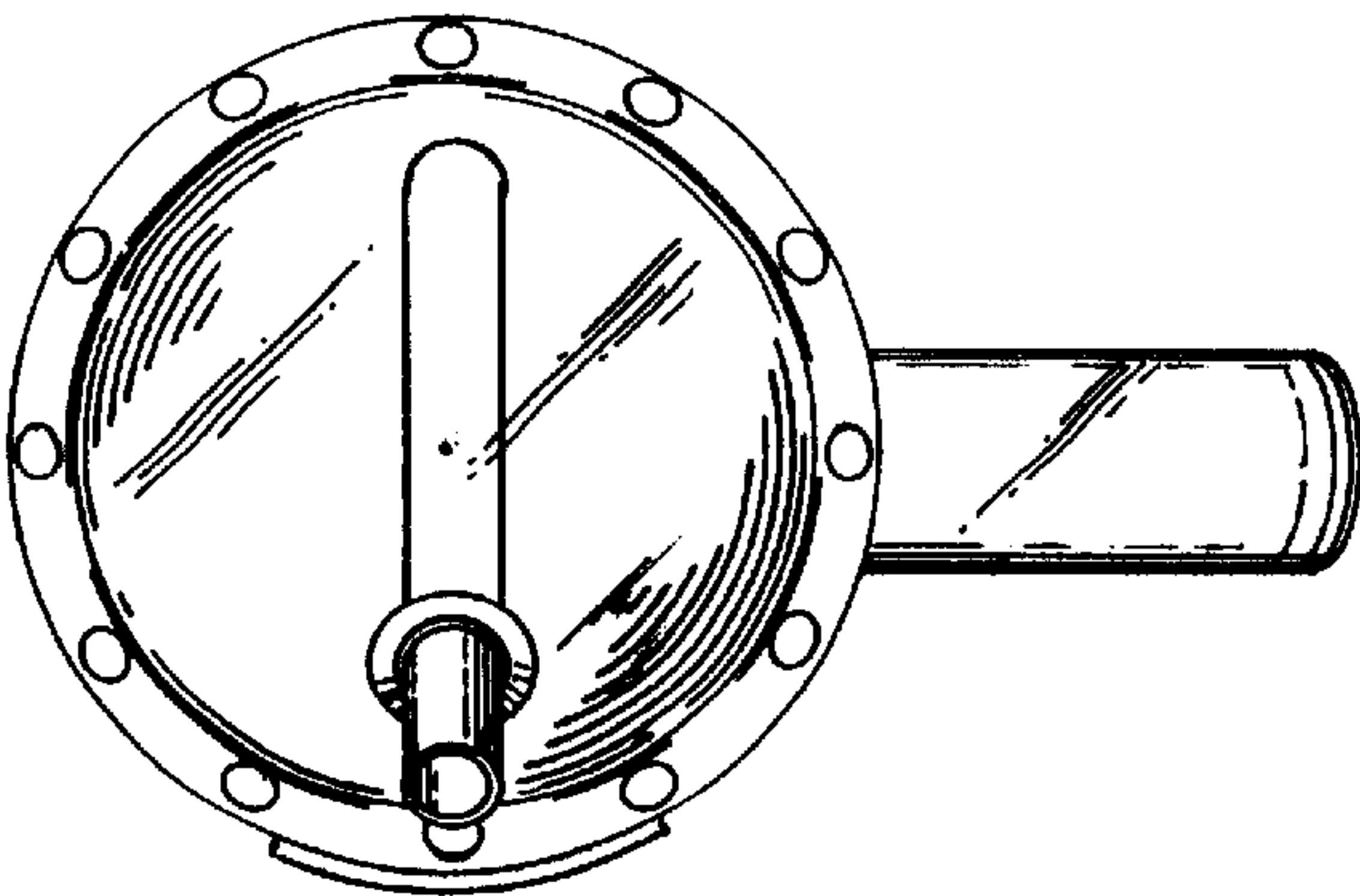

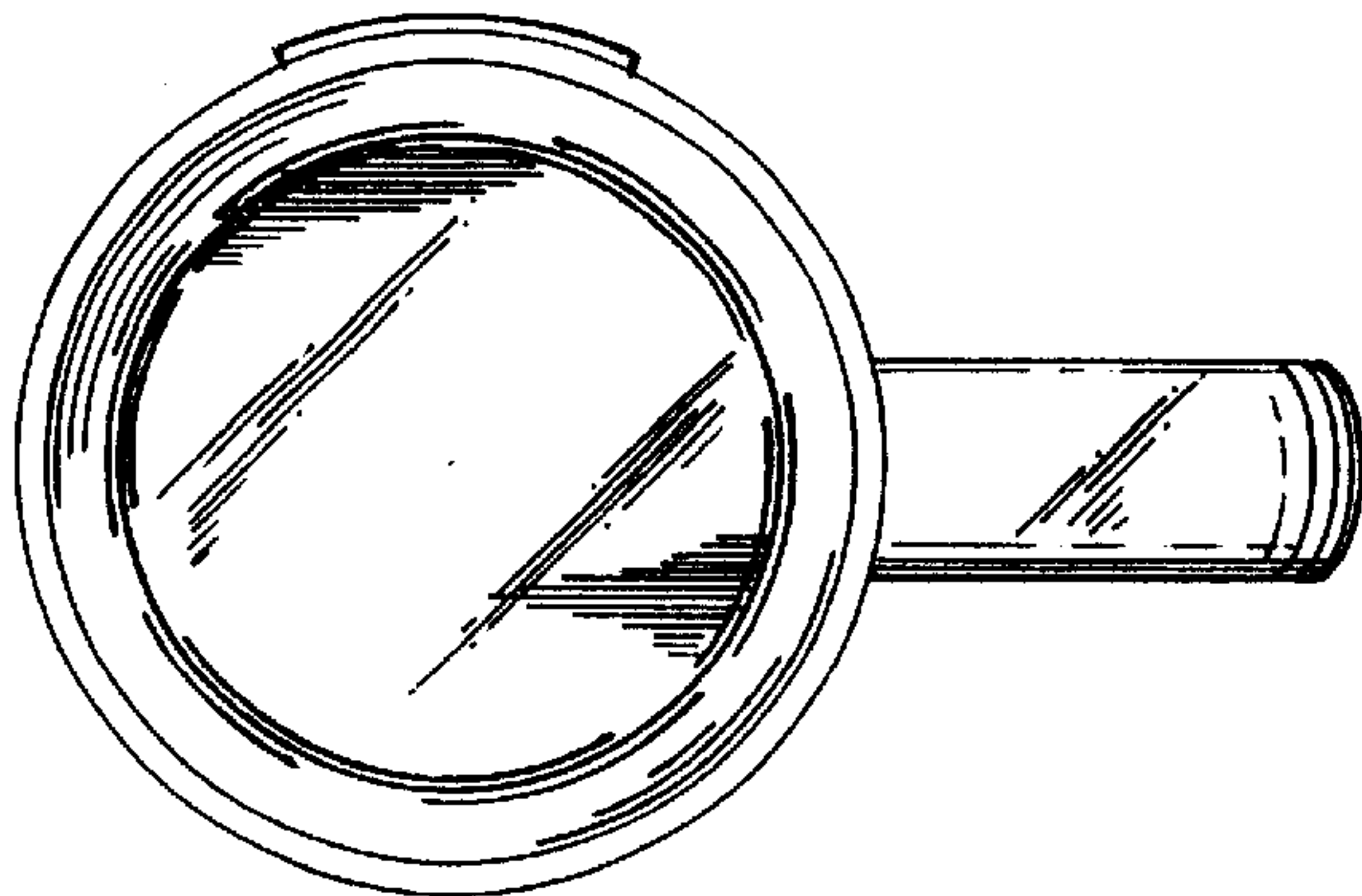
