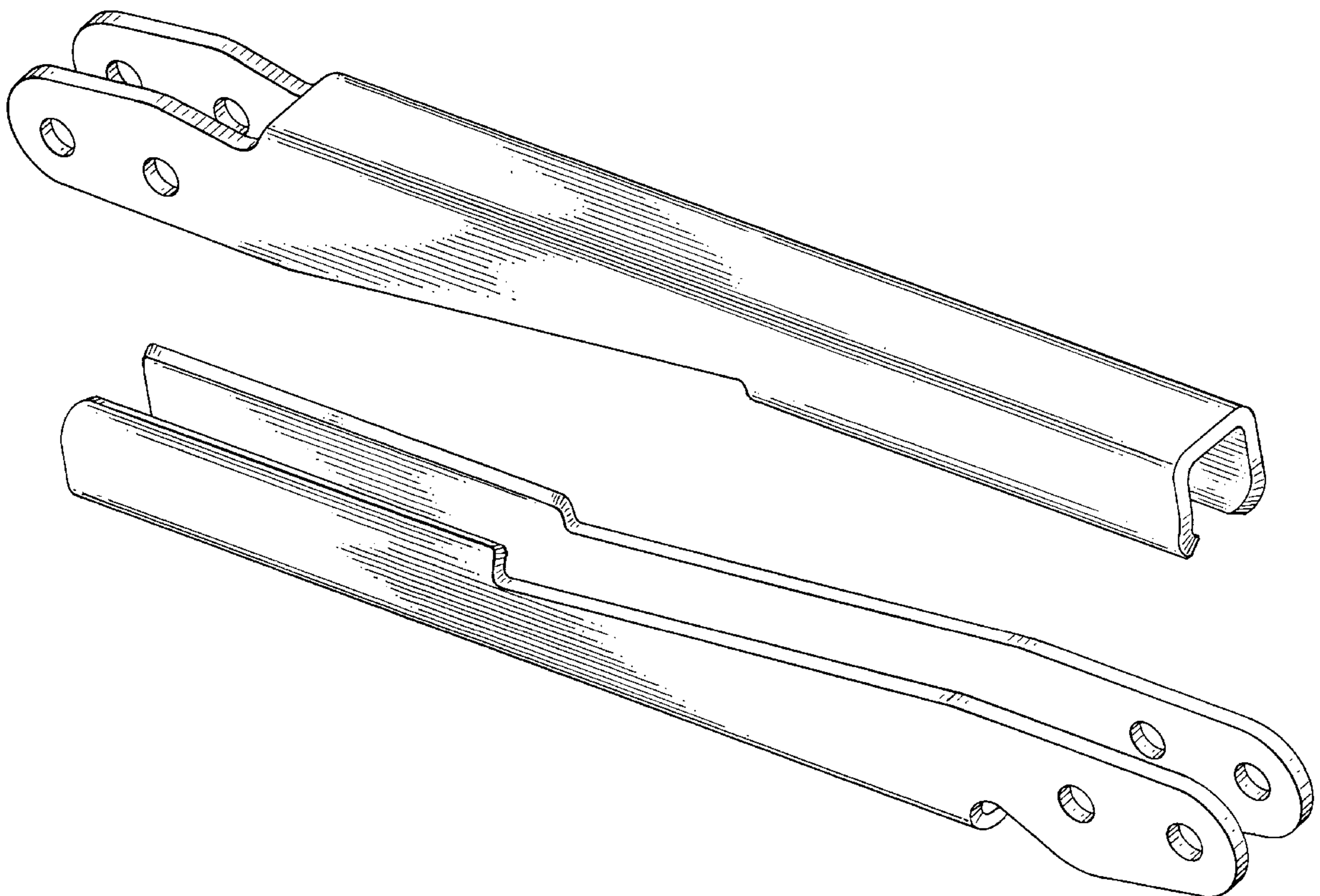
(57) **CLAIM**

The ornamental design for a tool handle, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of the handle design as viewed from the upper side thereof;  
 FIG. 2 is an isometric view of the handle and FIG. 1 as viewed from the underside;  
 FIG. 3 is a side elevation of the handle design of FIG. 1;  
 FIG. 4 is a reduced bottom plan view of the handle design of FIG. 1;  
 FIG. 5 is a reduced outer end view of the handle design of FIG. 1;  
 FIG. 6 is a reduced inner end view of the handle design of FIG. 1; and,  
 FIG. 7 is a reduced top plan view of the handle design of FIG. 1.

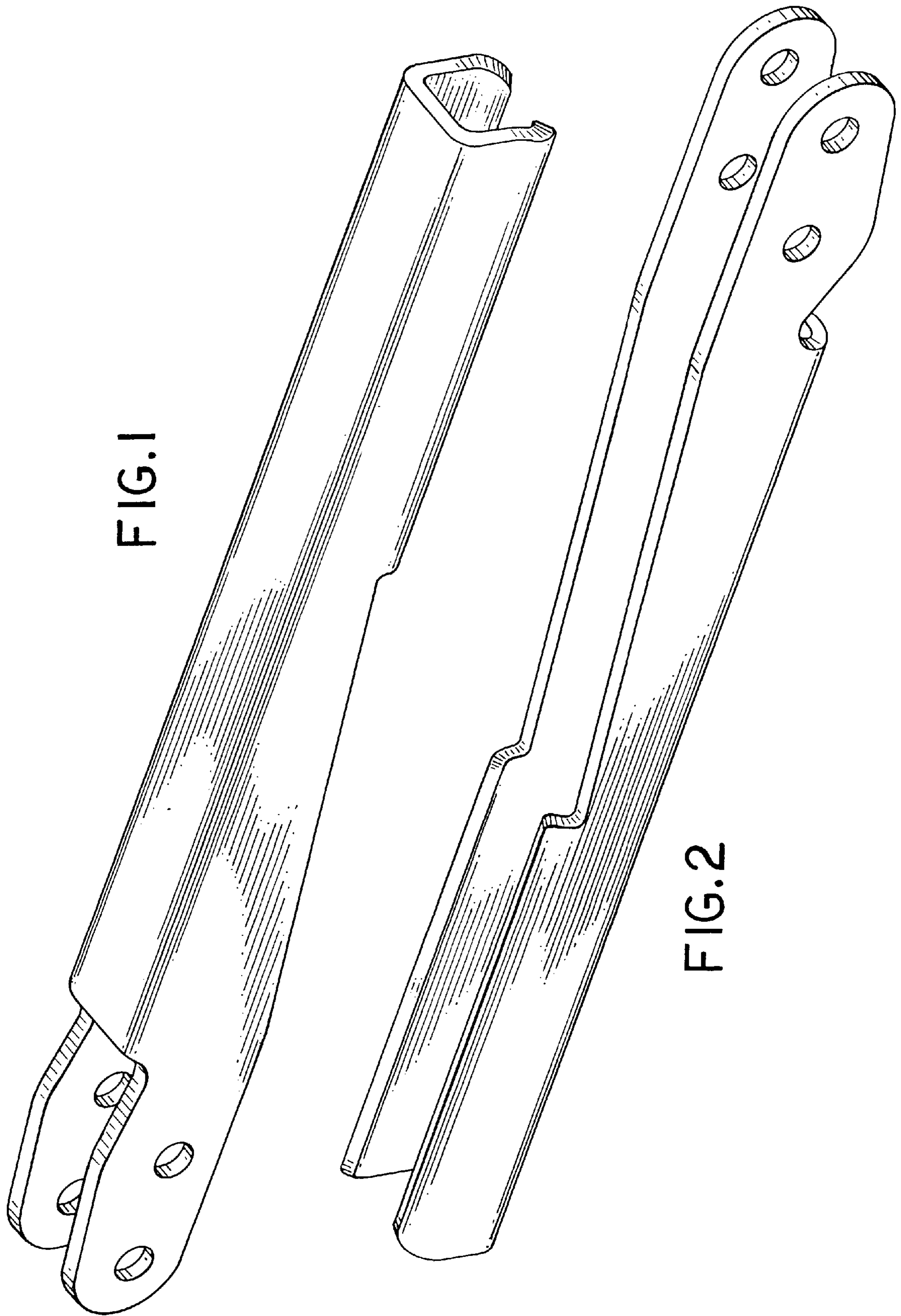

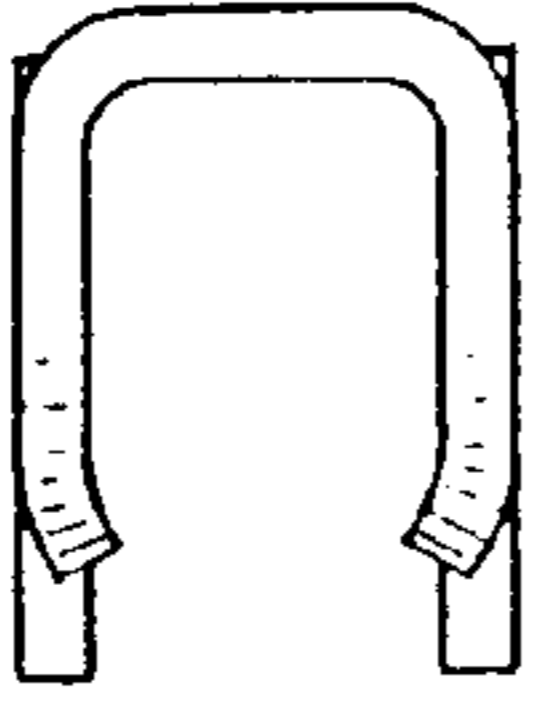

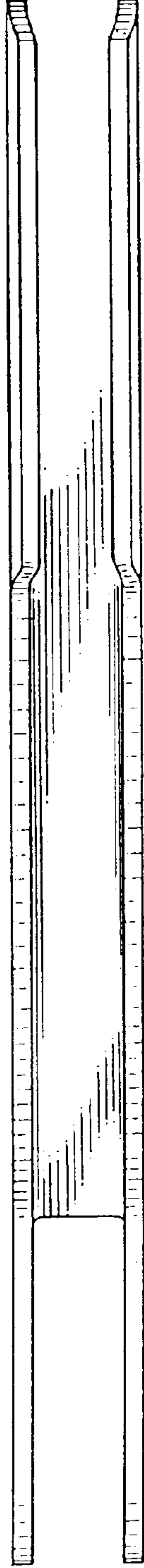

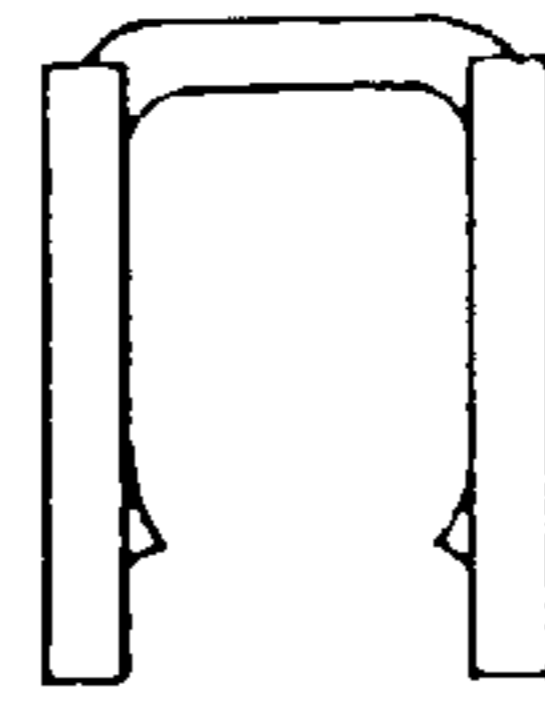
