(57) **CLAIM**

We claim the ornamental design for a plush toy truck hand puppet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a plush toy truck hand puppet according to the new design.

FIG. 2 is a side view of the plush toy truck hand puppet shown in FIG. 1, the opposite side view being identical thereto.

FIG. 3 is a top view of the plush toy truck hand puppet shown in FIG. 1.

FIG. 4 is a bottom view of the plush toy truck hand puppet shown in FIG. 1.

FIG. 5 is a front view of the plush toy truck hand puppet shown in FIG. 1; and,

FIG. 6 is a back view of the plush toy truck hand puppet shown in FIG. 1.

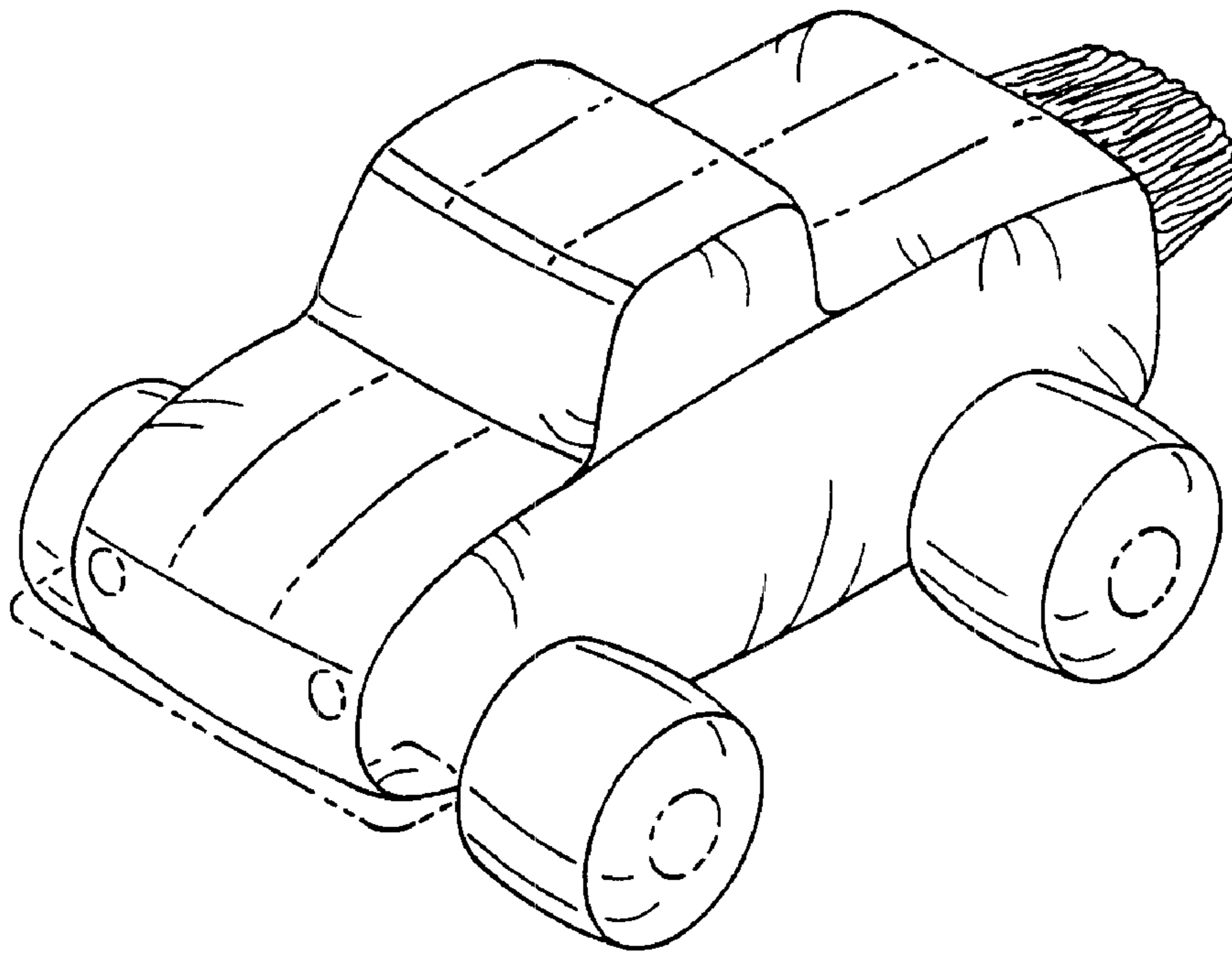

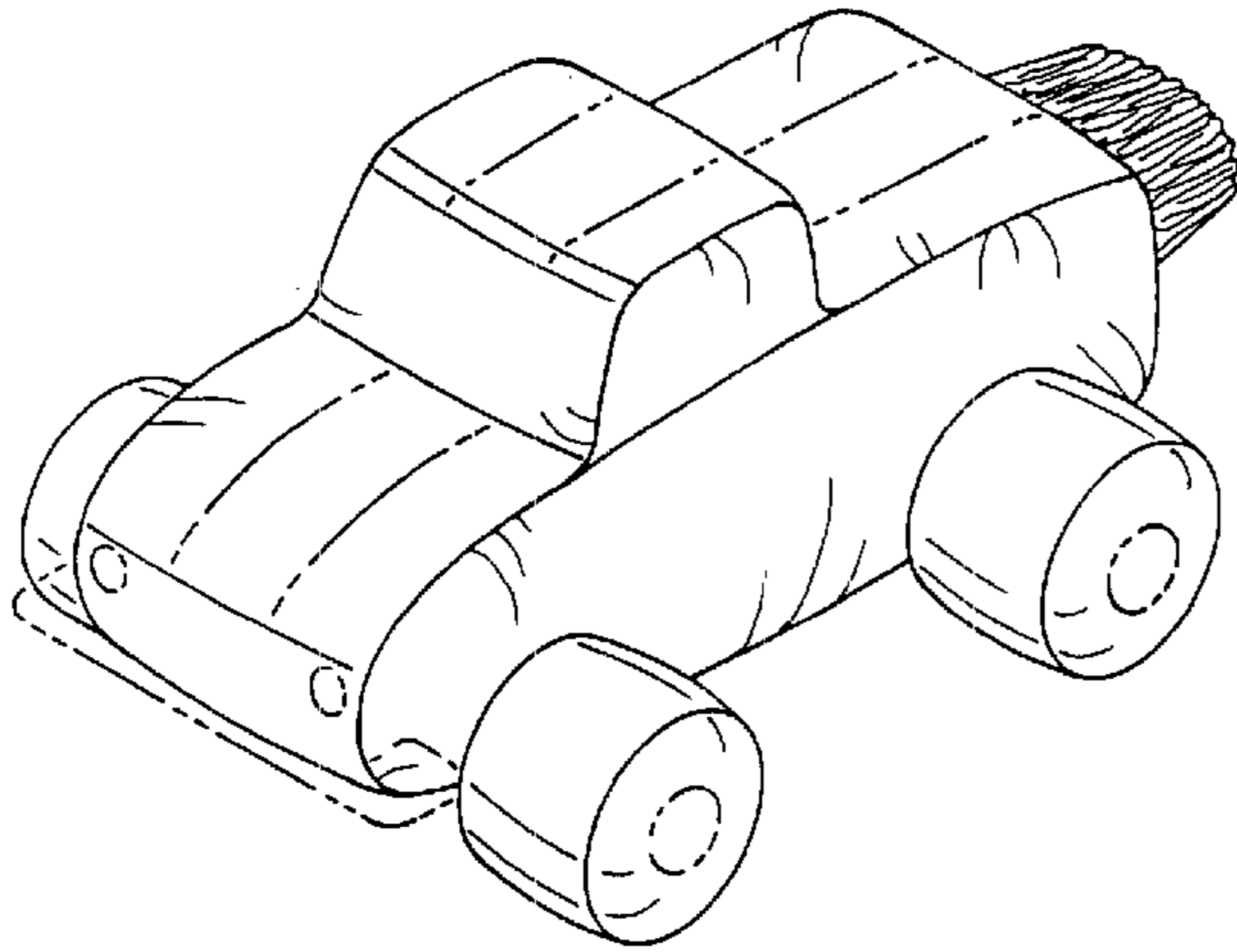

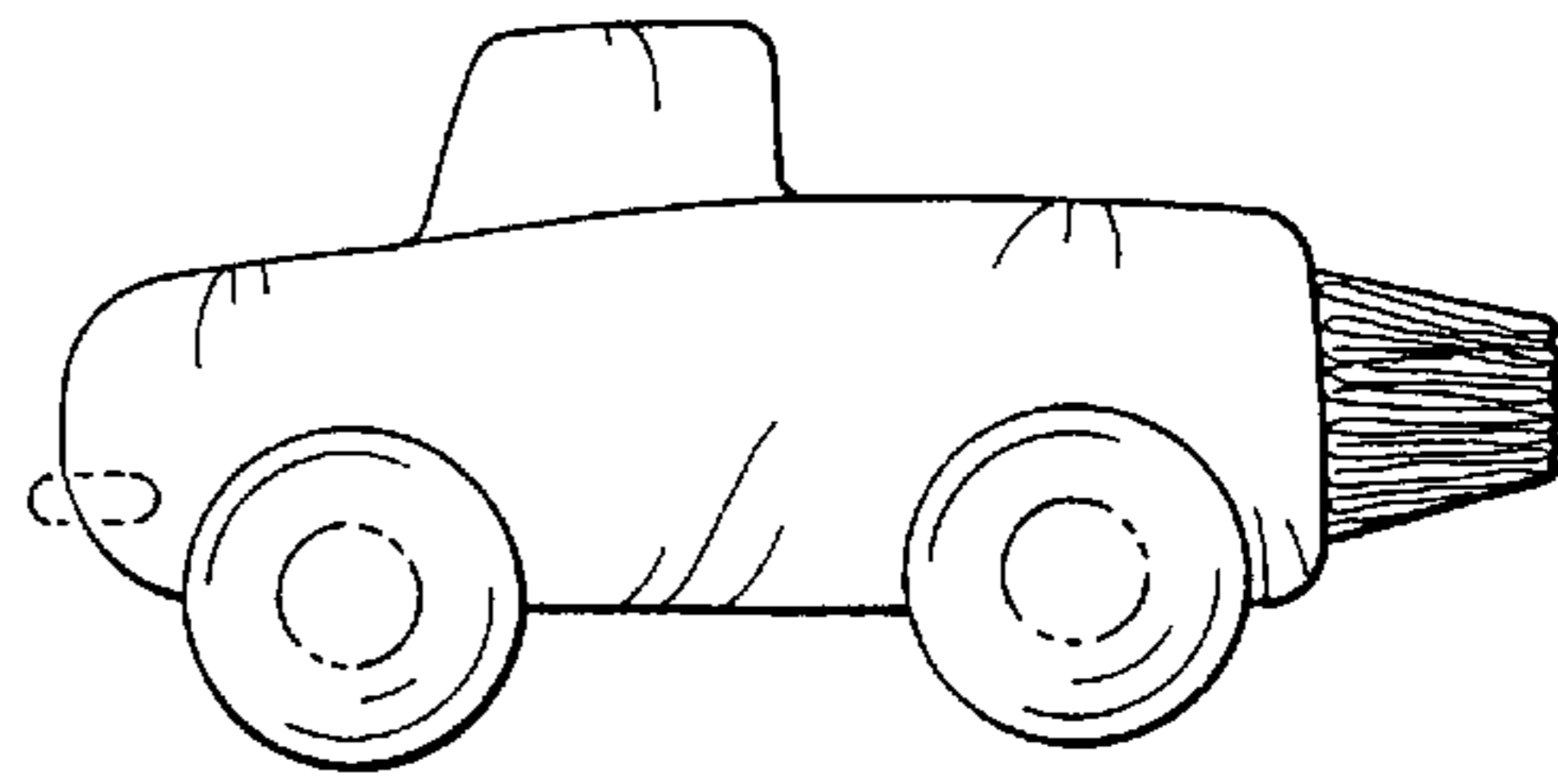

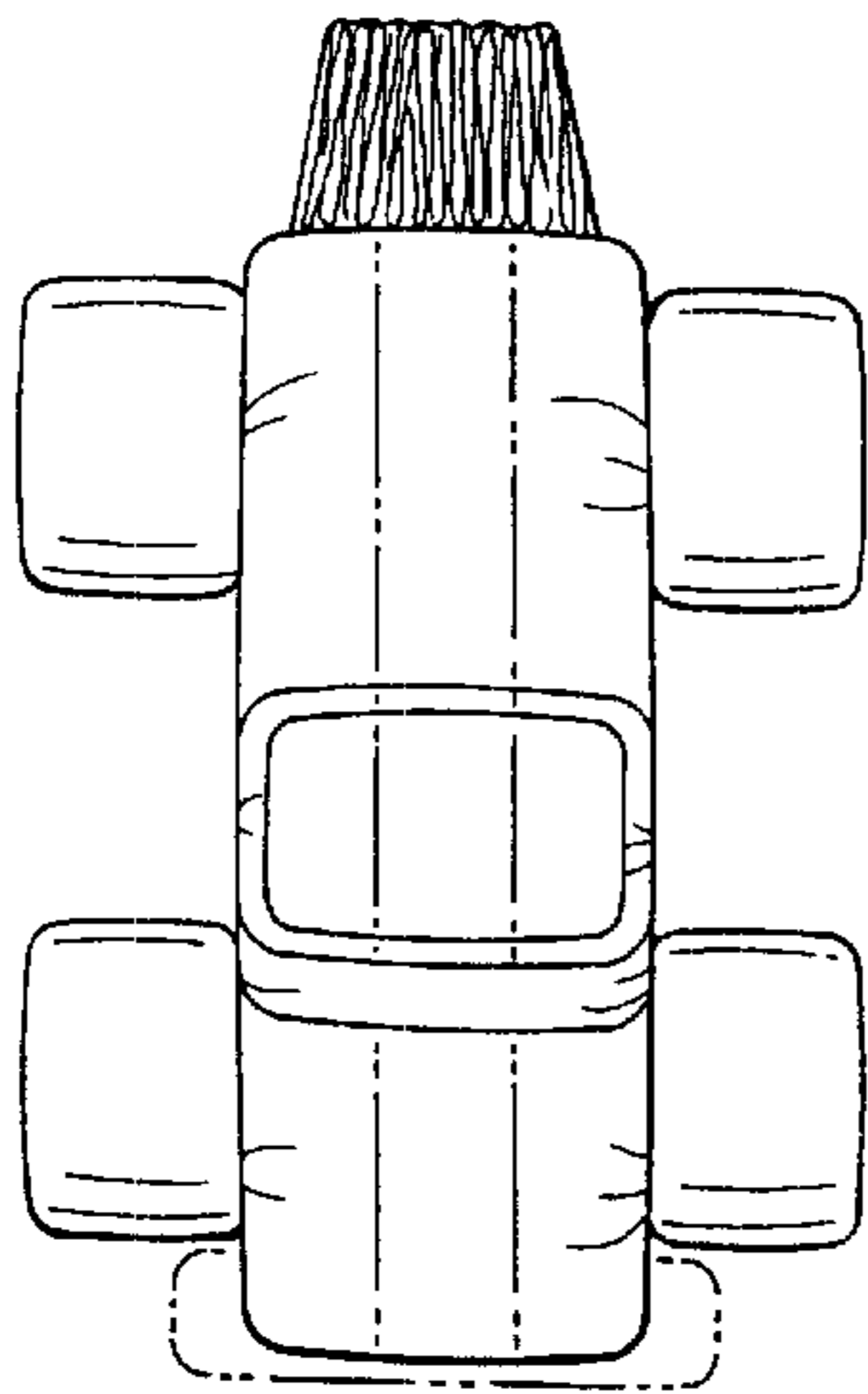

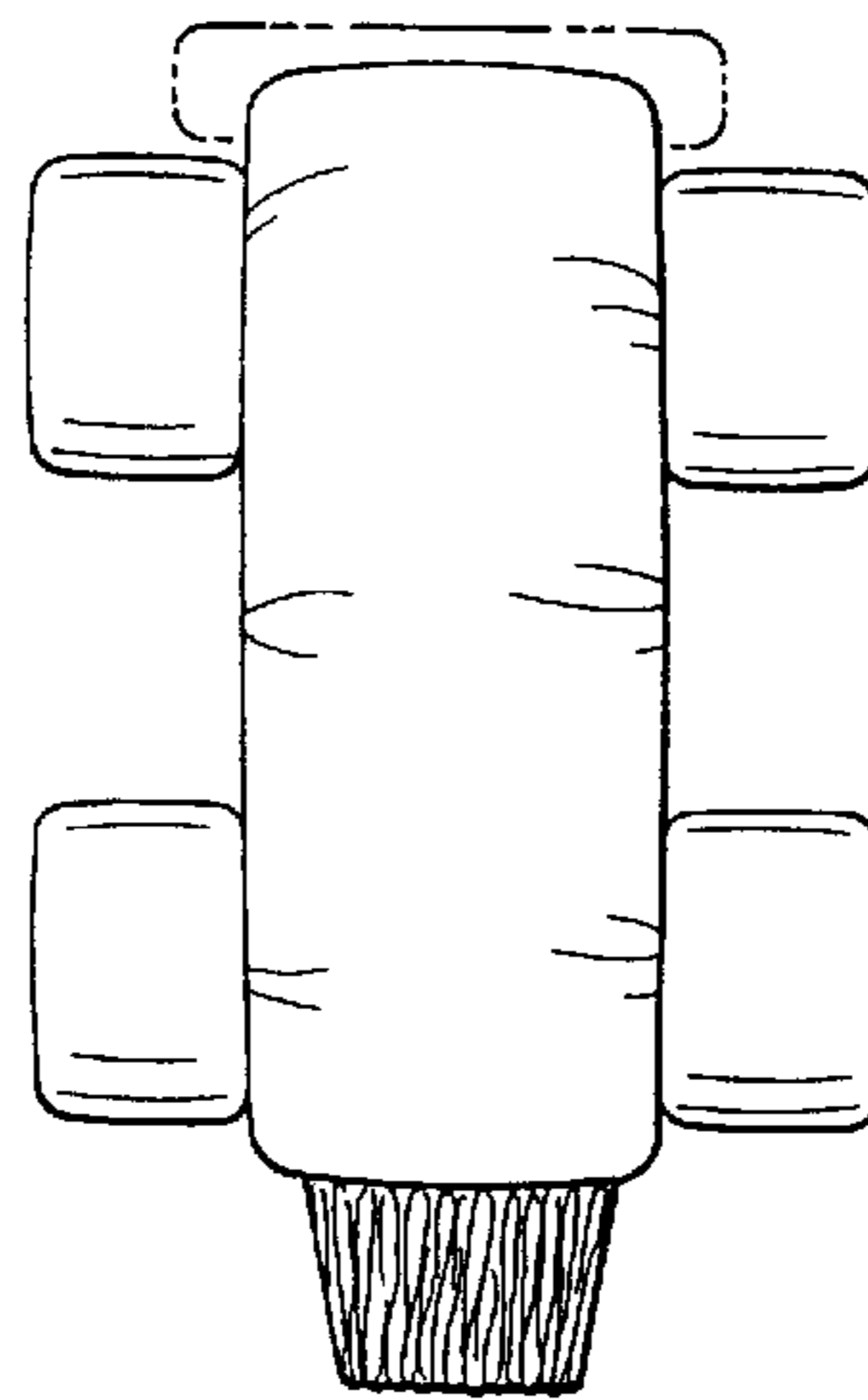

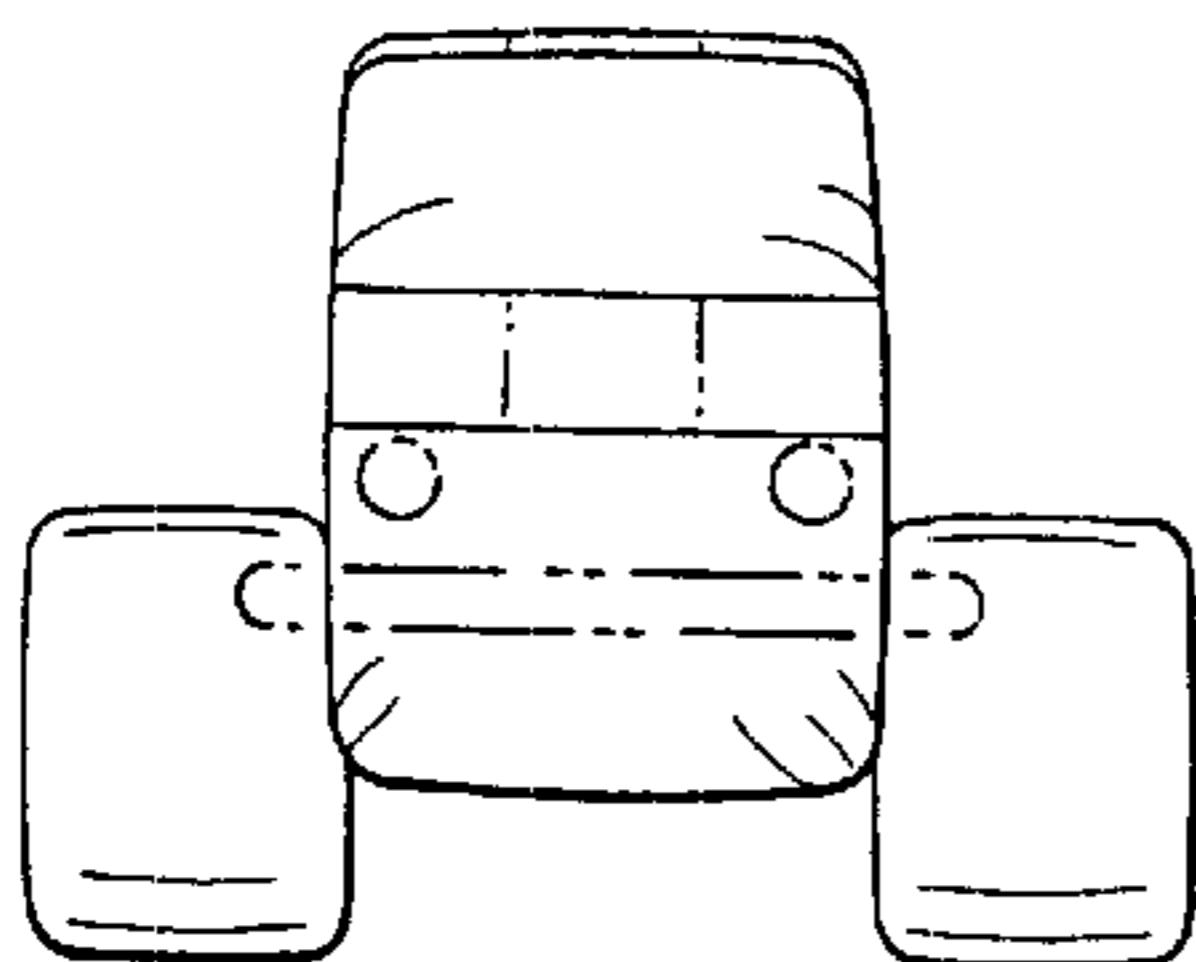
