(57) **CLAIM**

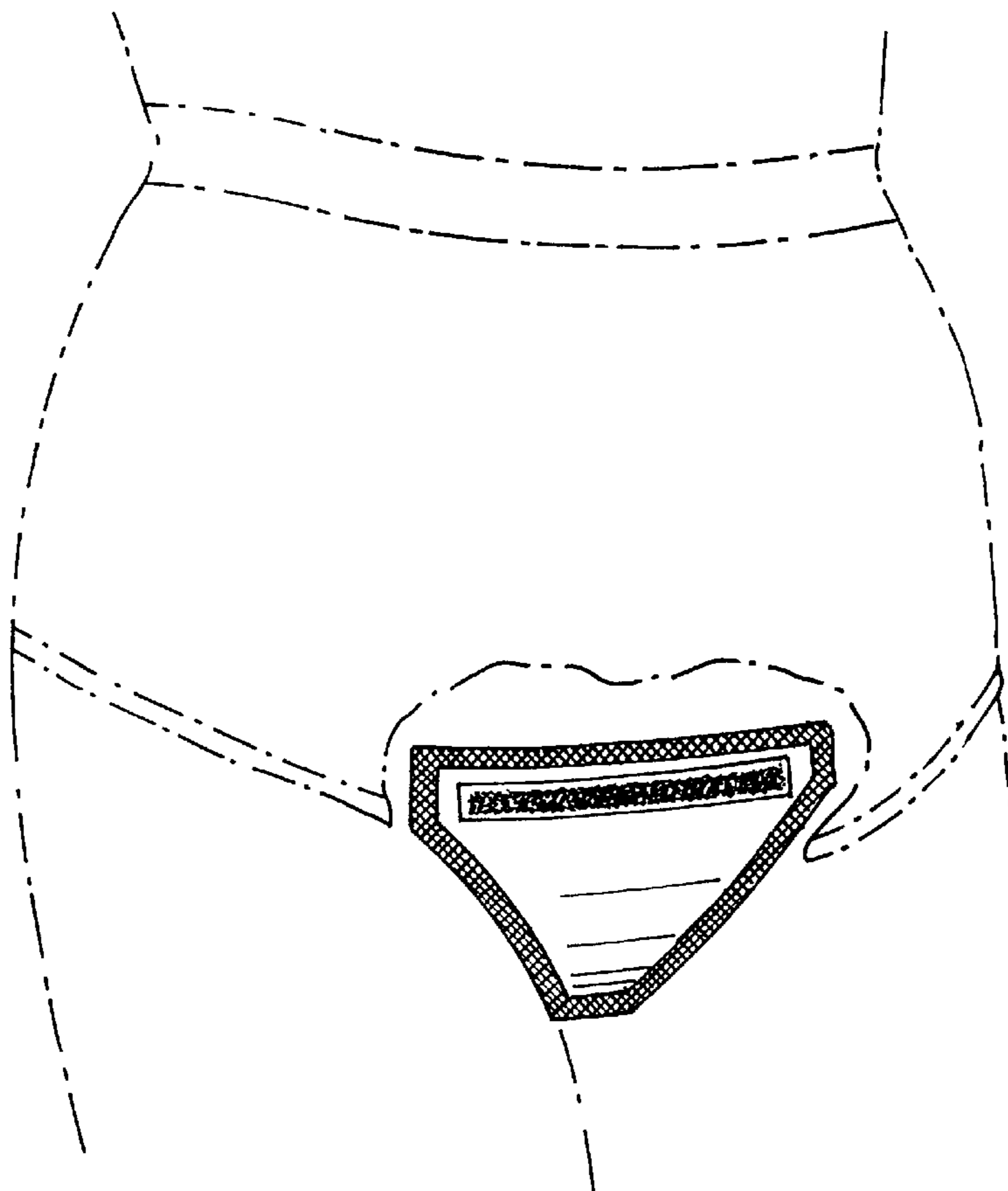
The ornamental design for a radiation shield for everyday use in women's panties, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a radiation shield for everyday use in women's panties shown on a phantom torso; FIG. 2 is a rear elevation of the radiation shield for everyday use in women's panties shown flat; FIG. 3 is a front elevation of FIG. 2; FIG. 4 is a top plan view of FIG. 4; FIG. 5 is a bottom plan view of FIG. 2; and, FIG. 6 is a side elevation of FIG. 2, the opposite side is a mirror image thereto.

The broken lines showing the lower torso of a person in FIG. 1 illustrate environmental structure only and do not form part of the claimed design.

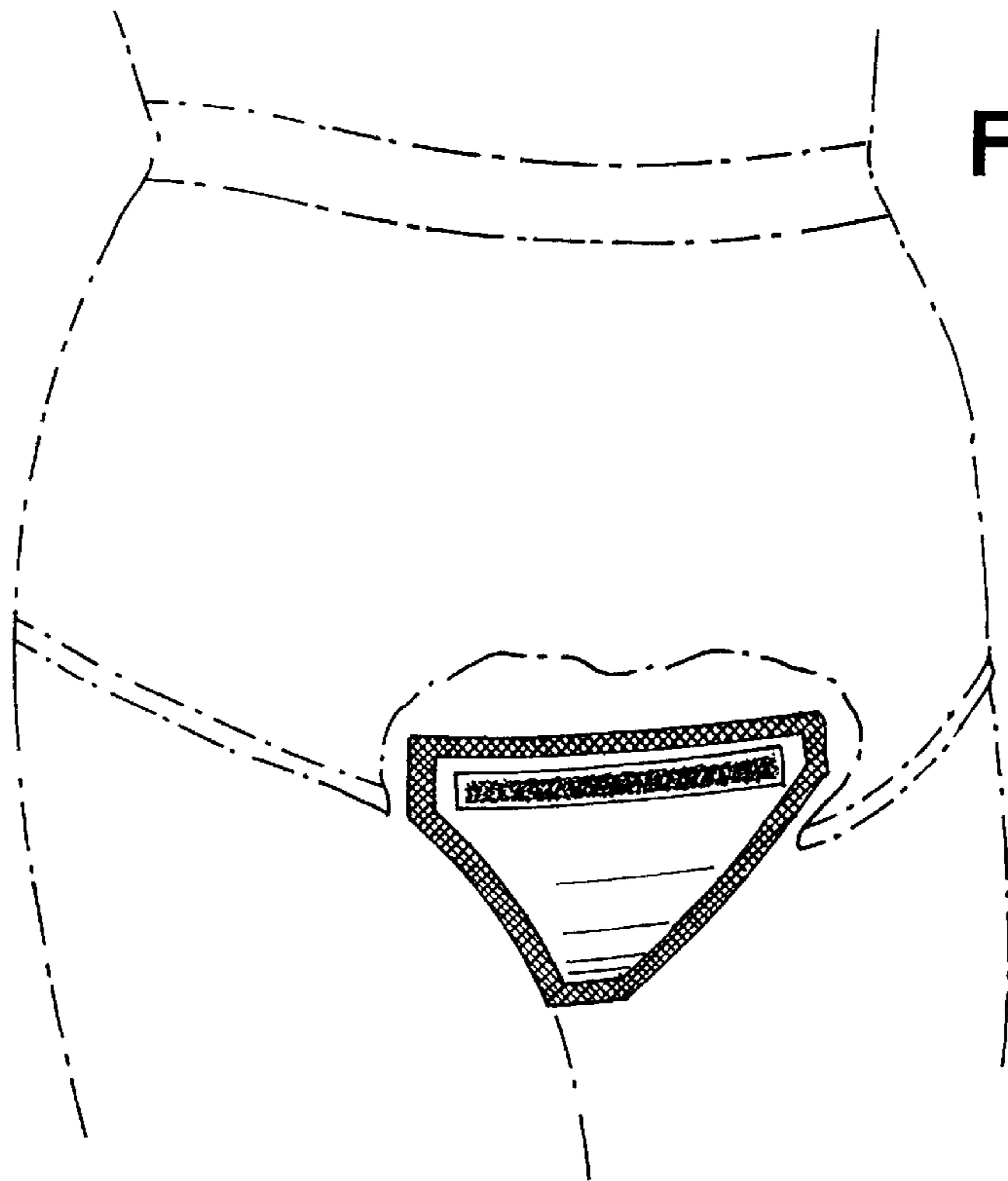

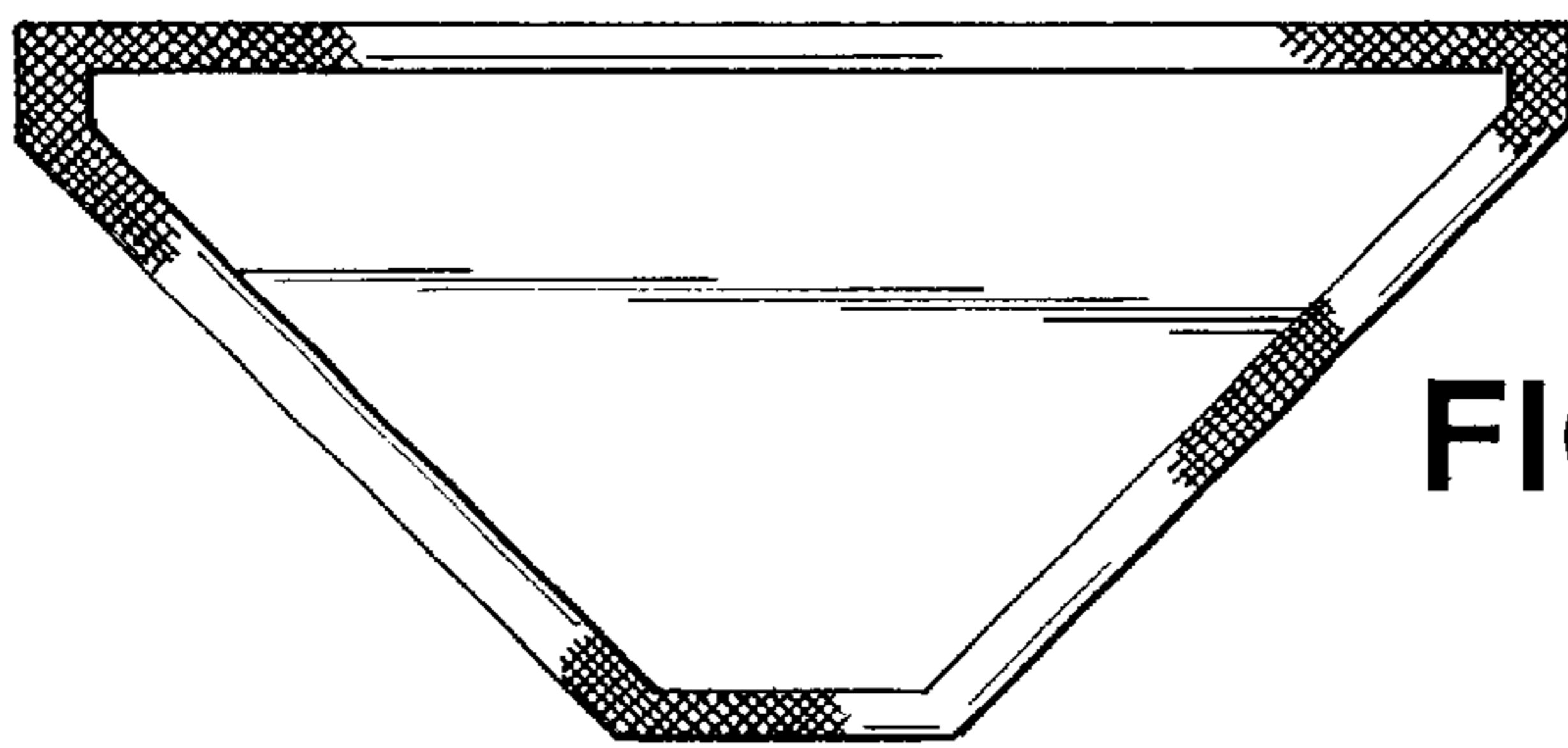

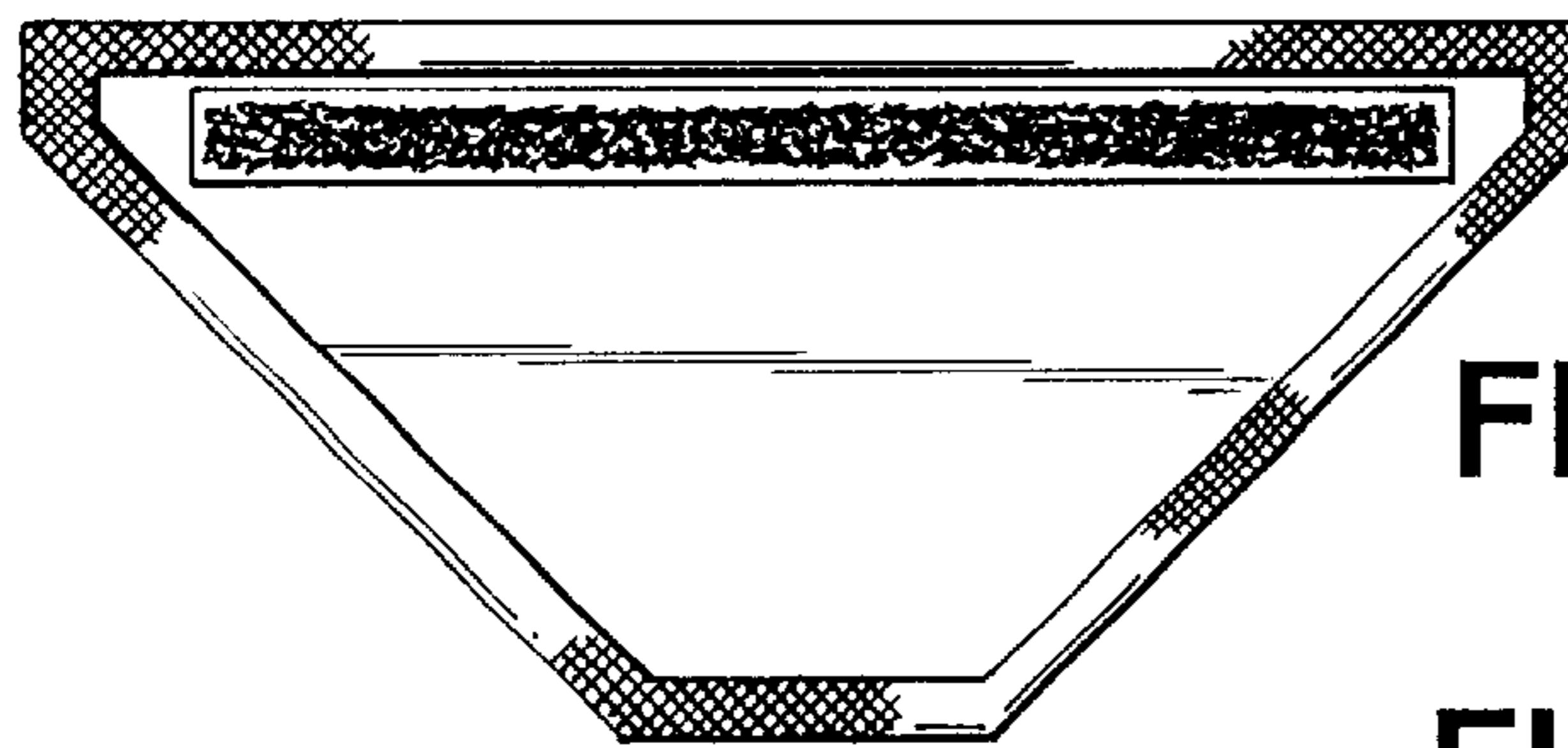
