**DESCRIPTION**

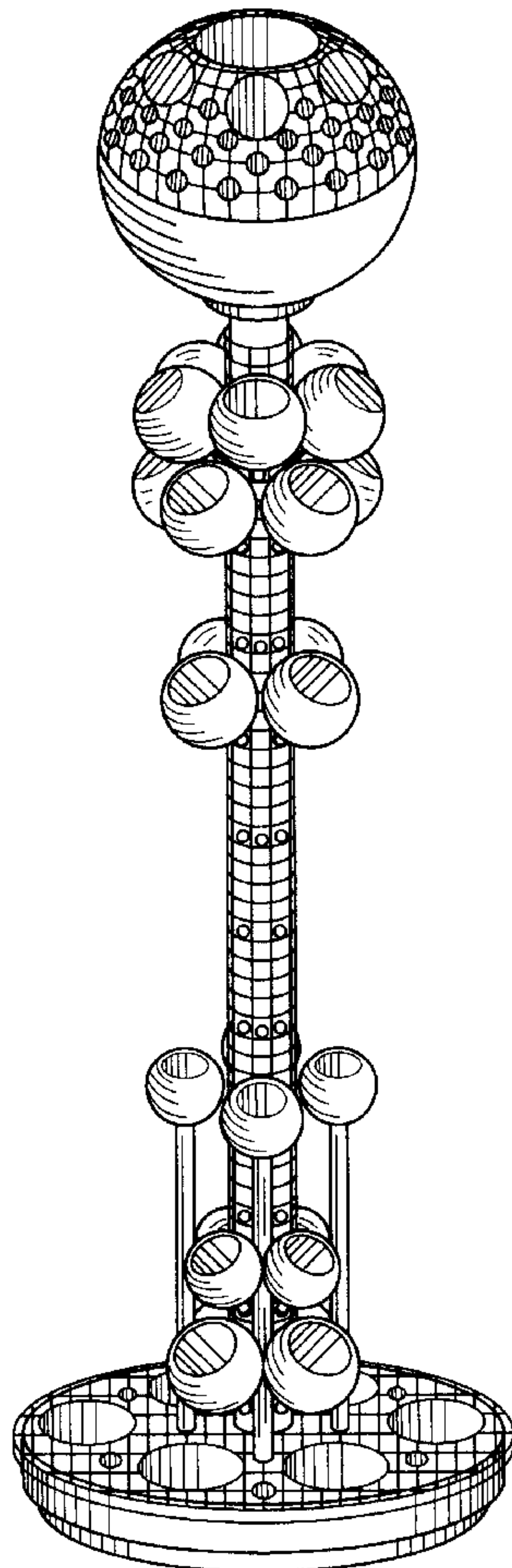
FIG. 1 is a front perspective view of a garden stand showing my new design; the rear side view thereof being a mirror image;

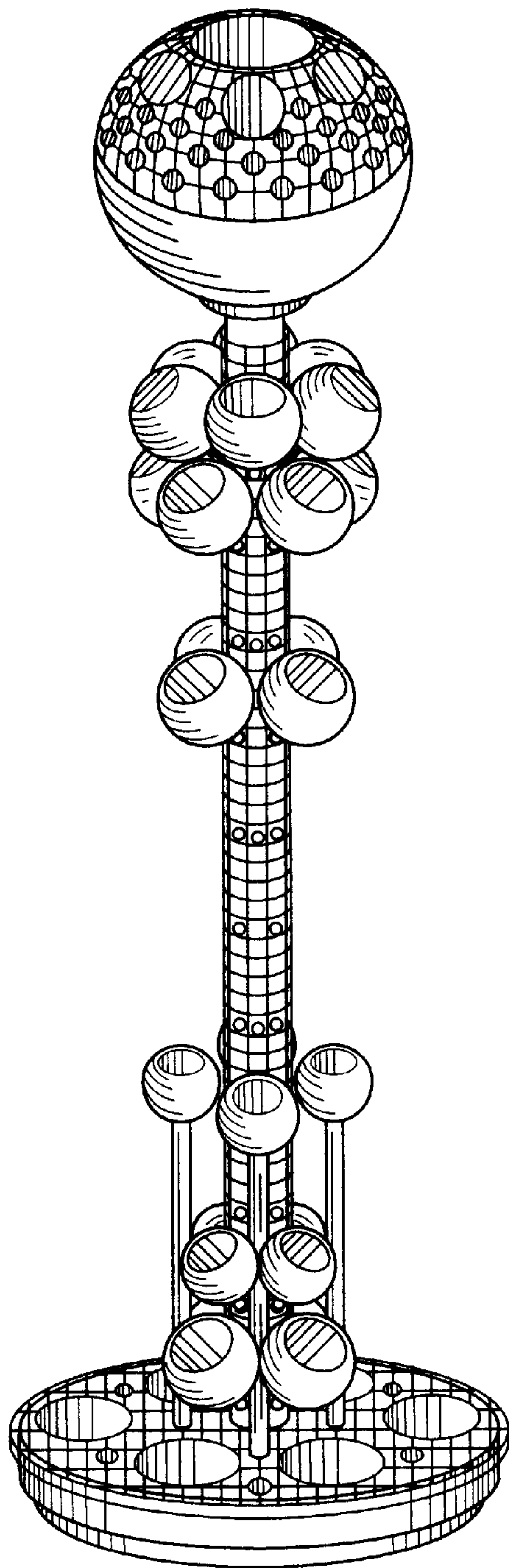

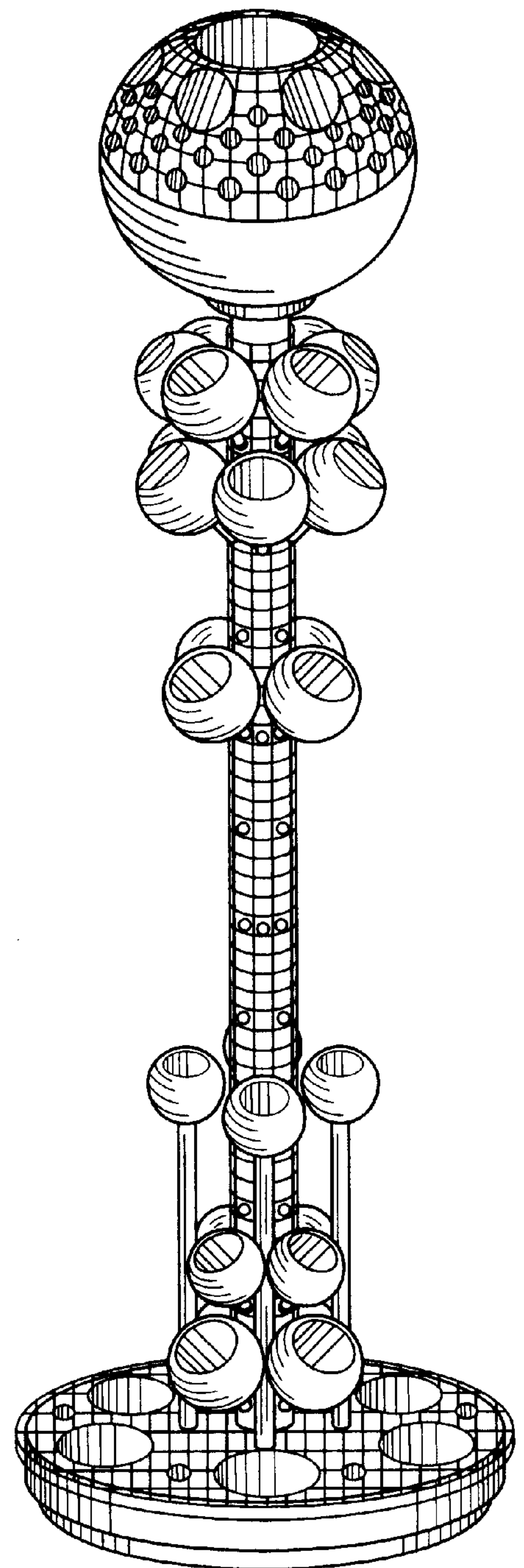

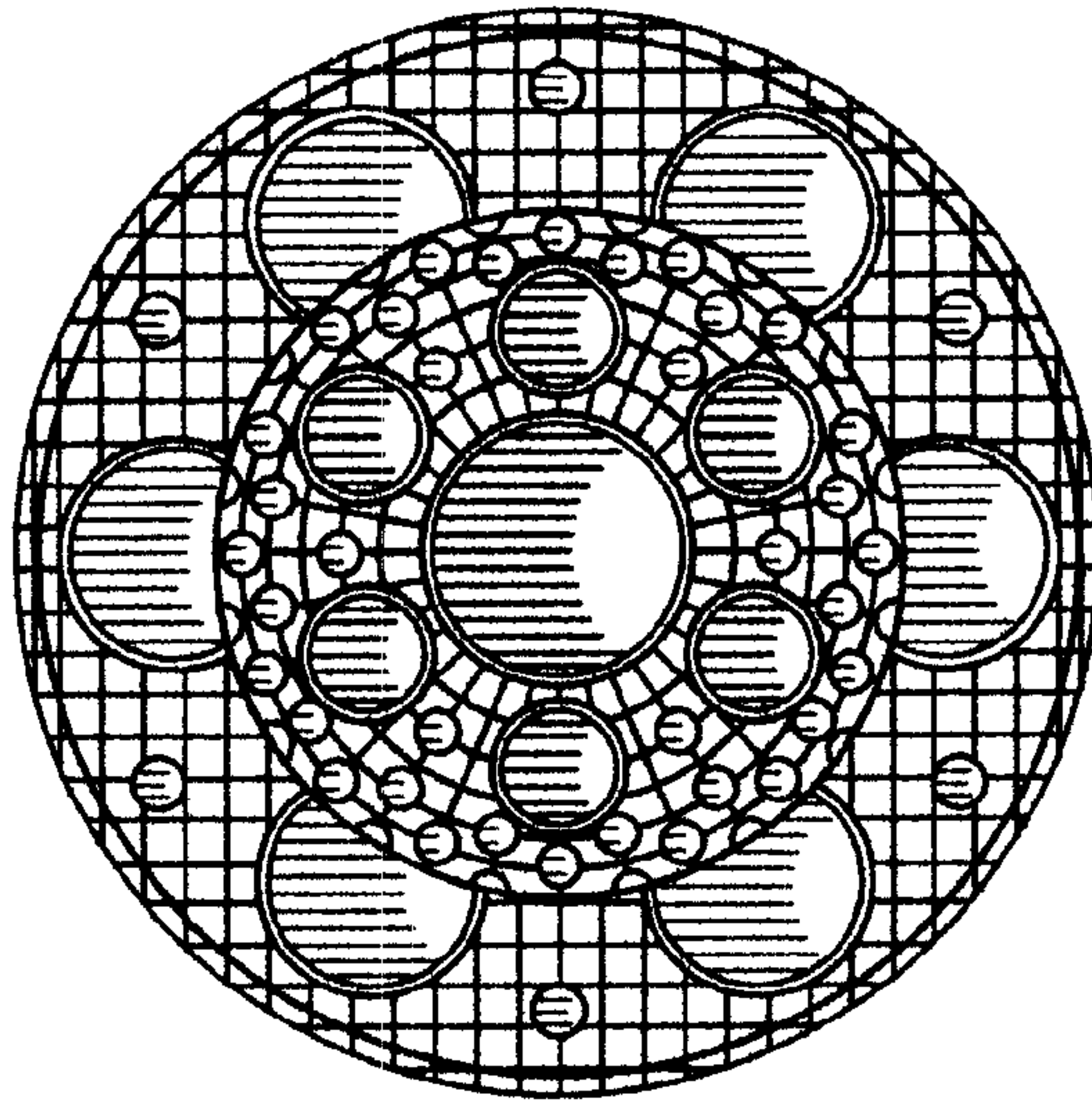

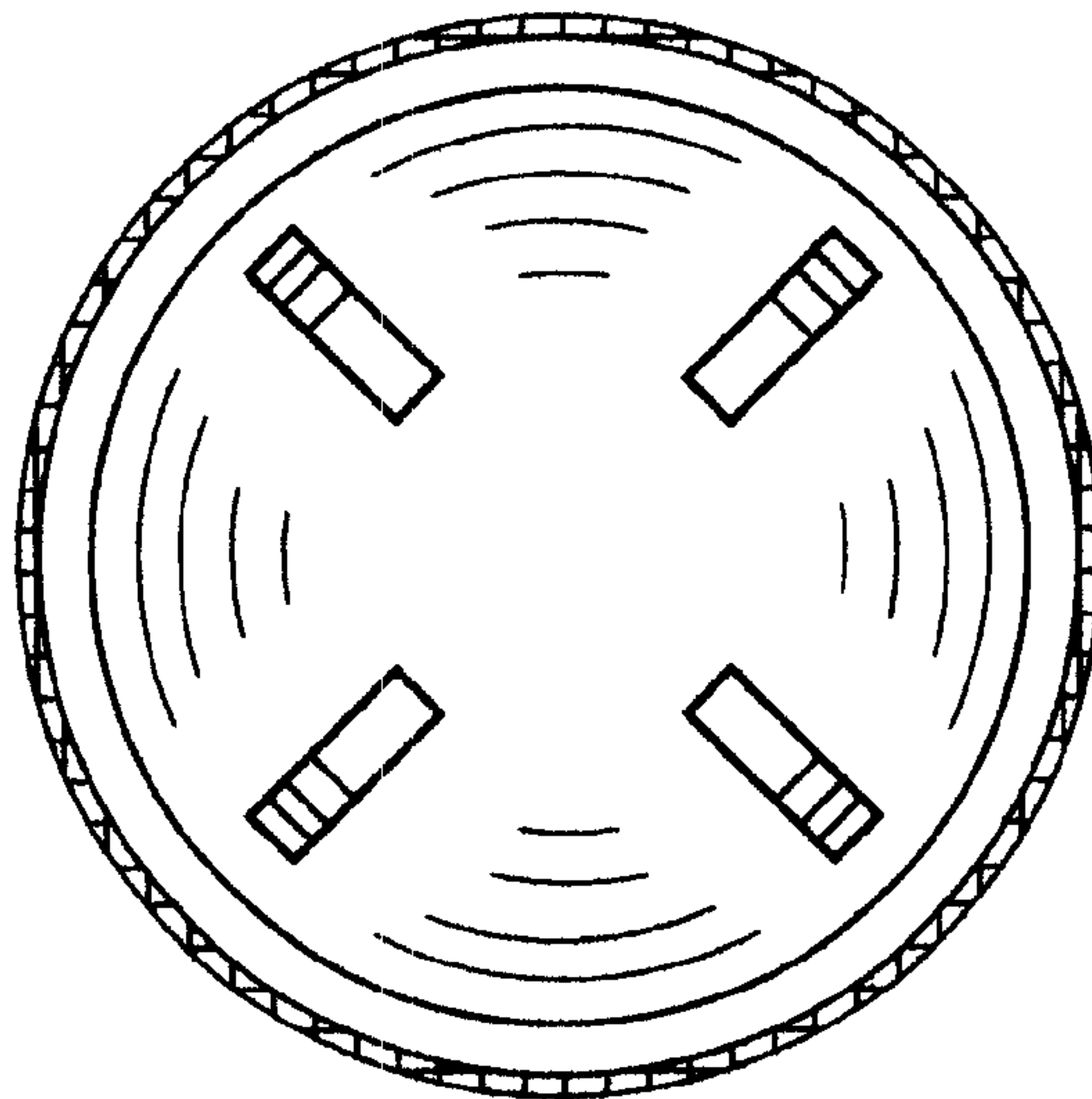
