FIG. 1 is a photograph showing a perspective view, taken from the front, left side, and top, illustrating our new design of a coffeemaker;

FIG. 2 is a photograph illustrating a front elevation view thereof;

FIG. 4 is a photograph illustrating a left side elevation view thereof;

FIG. 5 is a photograph illustrating a rear elevation view thereof;

FIG. 7 is a photograph illustrating a bottom plan view thereof.

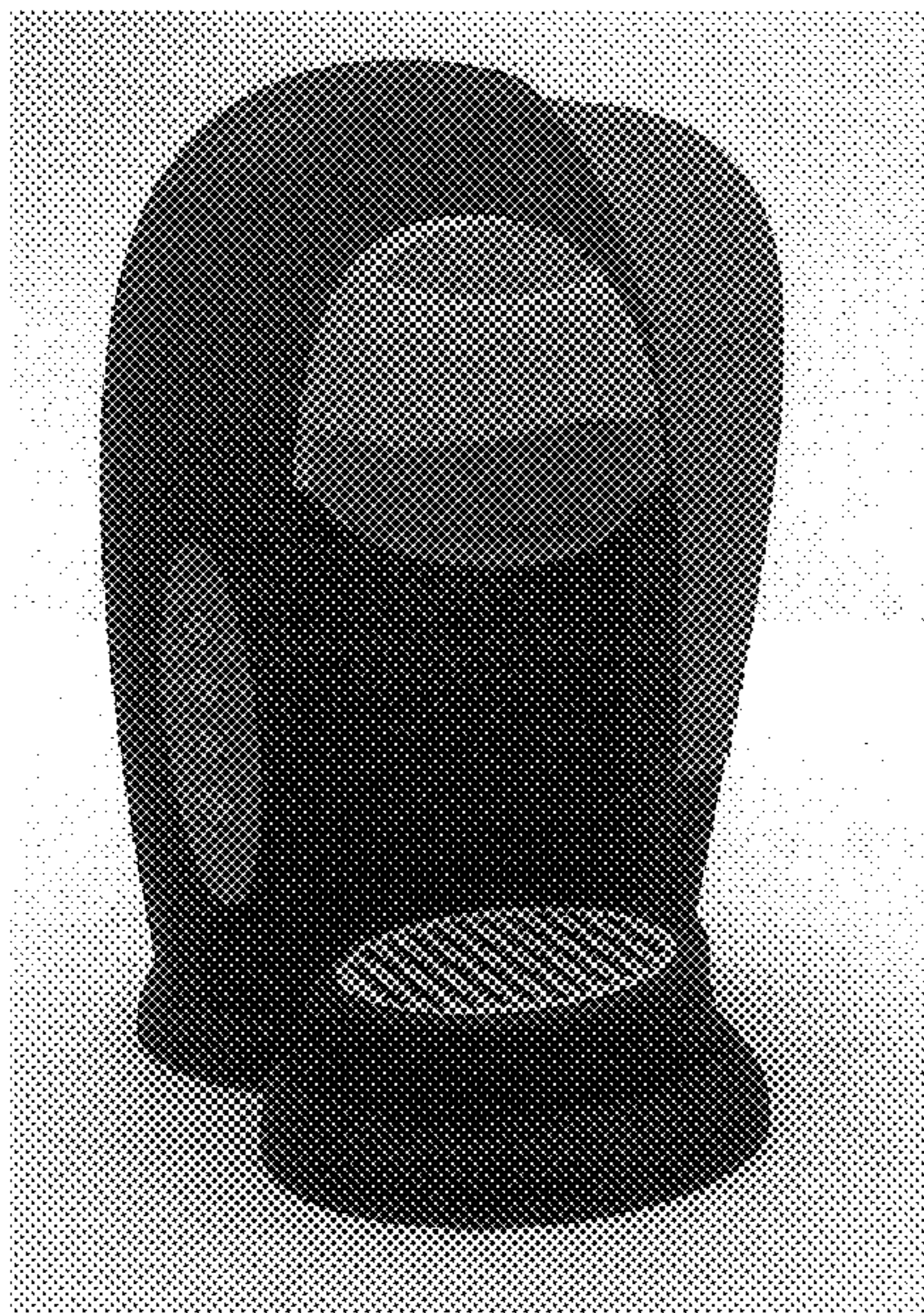
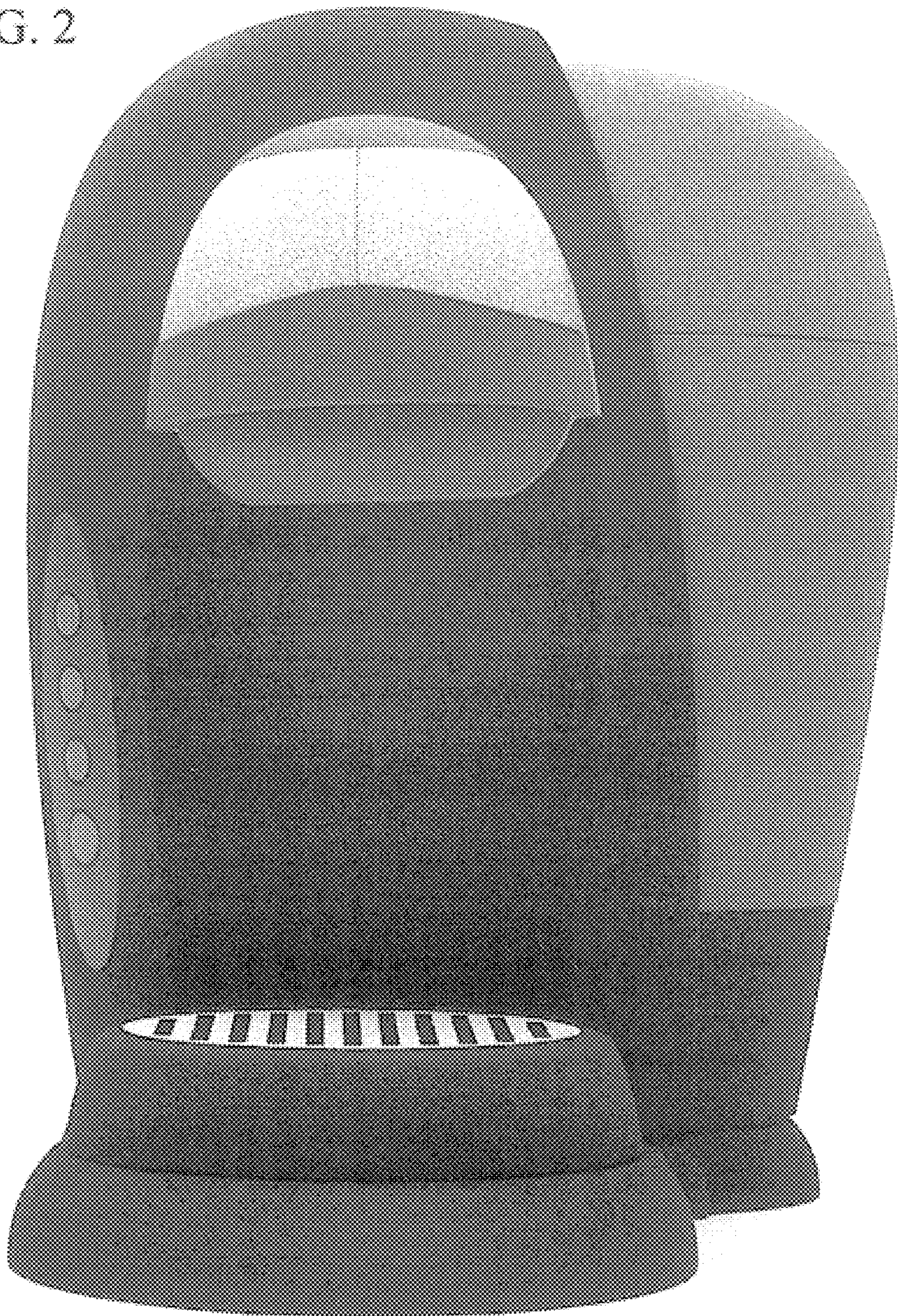
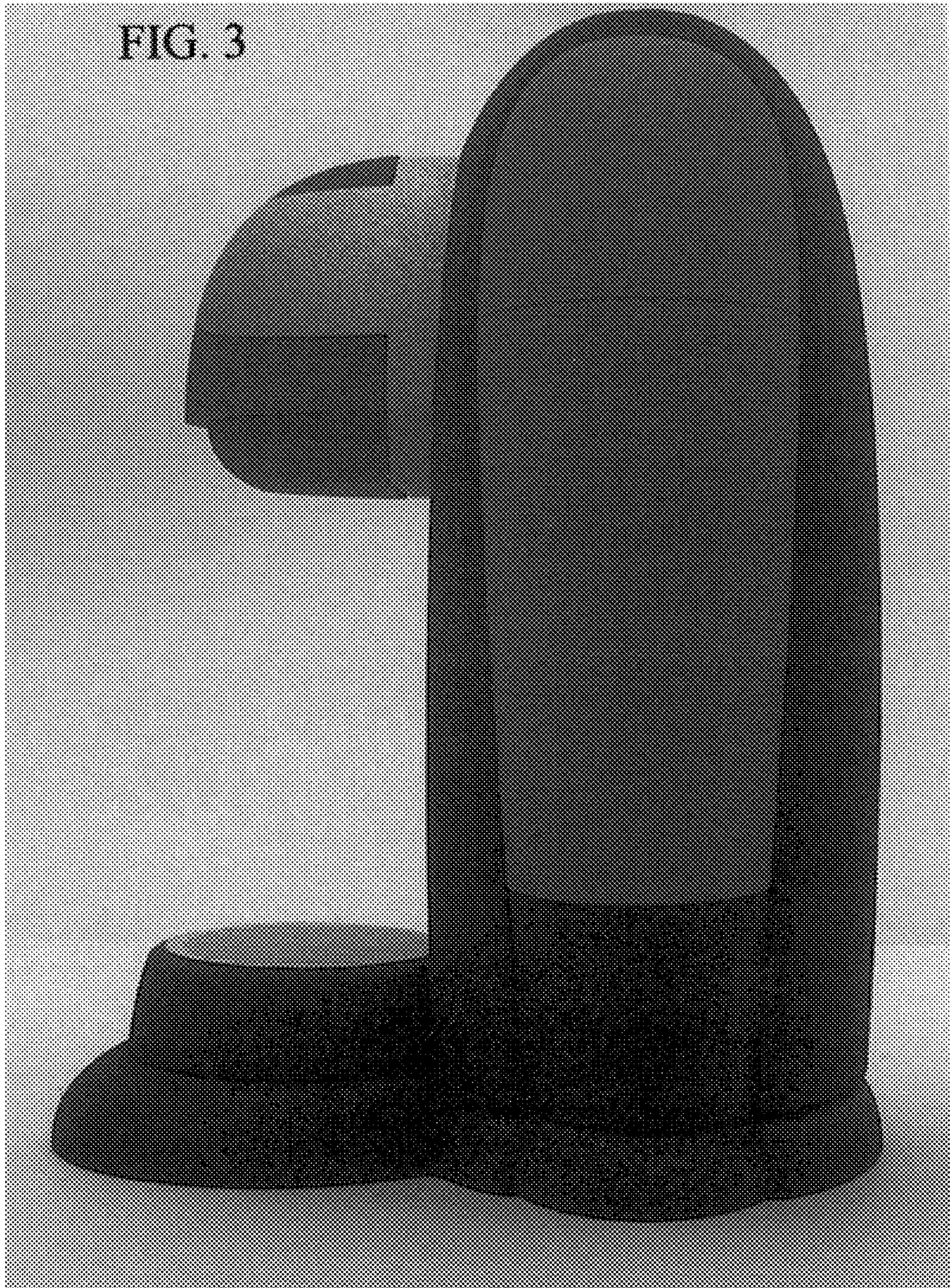

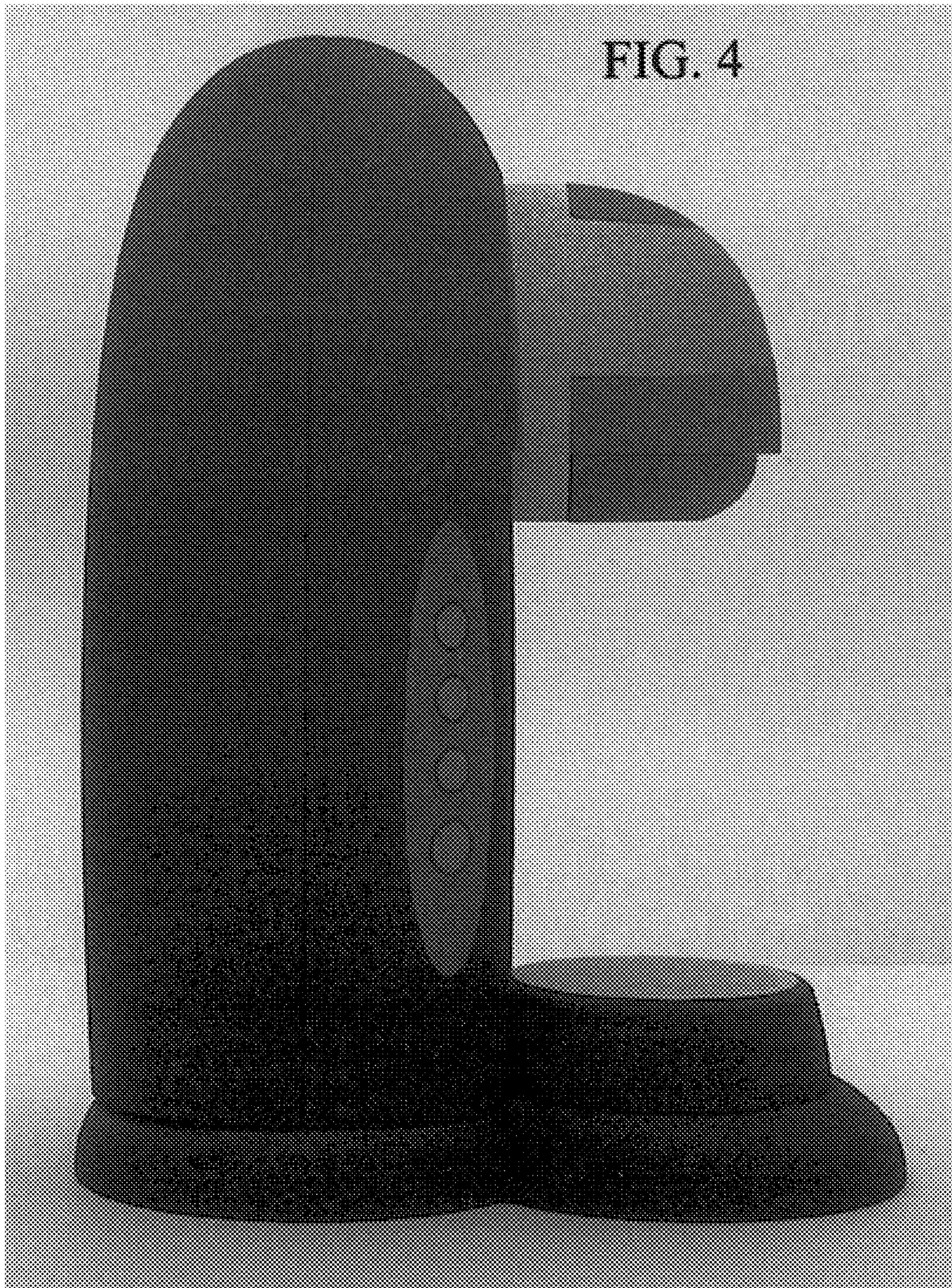
