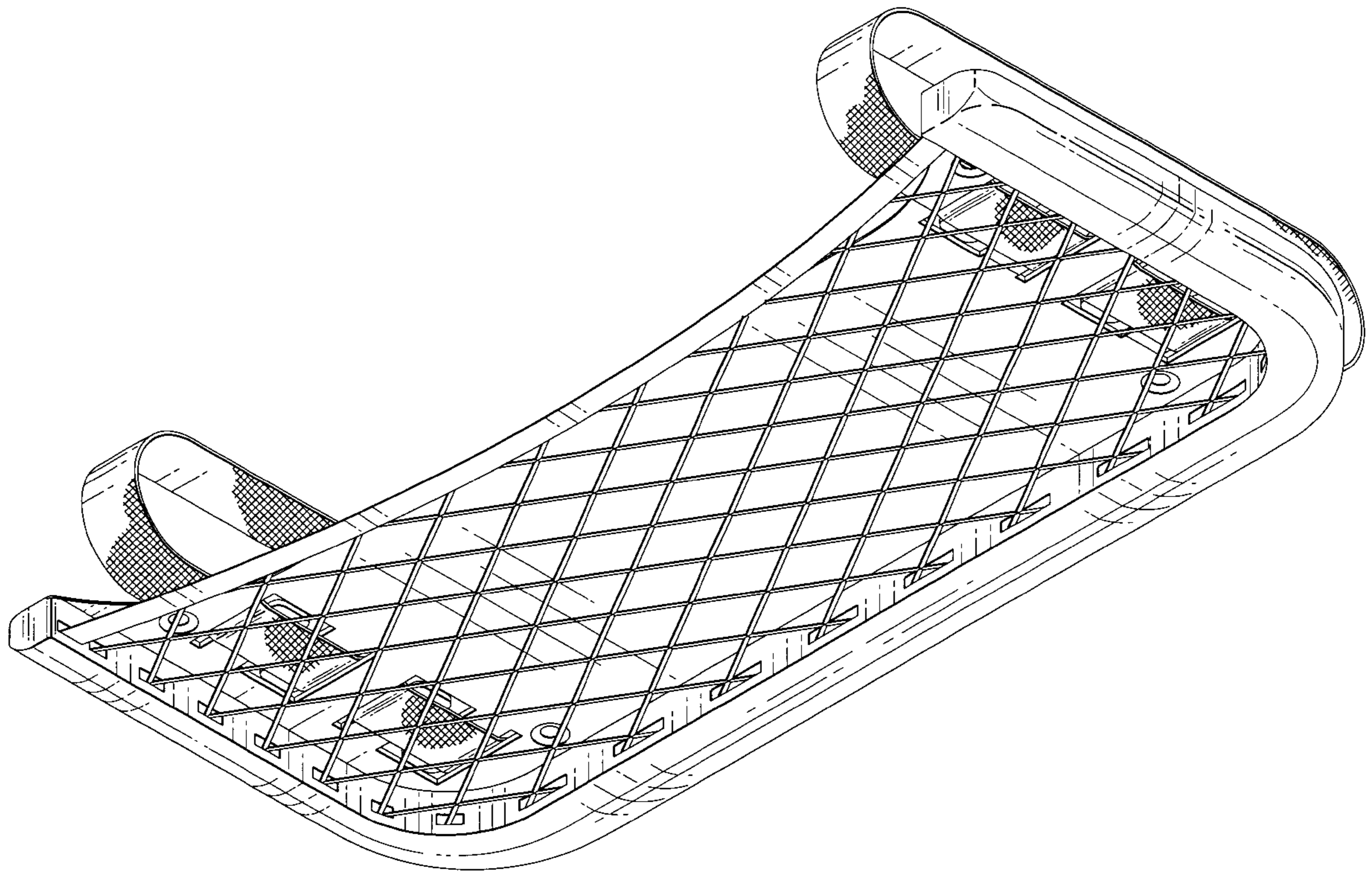
(57) **CLAIM**

The ornamental design for an auto utensil net, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the auto utensil net;
 FIG. 2 is a front view of the auto utensil net shown in FIG. 1;
 FIG. 3 is a top end view of the auto utensil net as shown in FIG. 2;
 FIG. 4 is a right end view of the auto utensil net as shown in FIG. 2;
 FIG. 5 is a rear view of the auto utensil net as shown in FIG. 2; and,
 FIG. 6 is a right end of the auto utensil net as shown in FIG. 5.

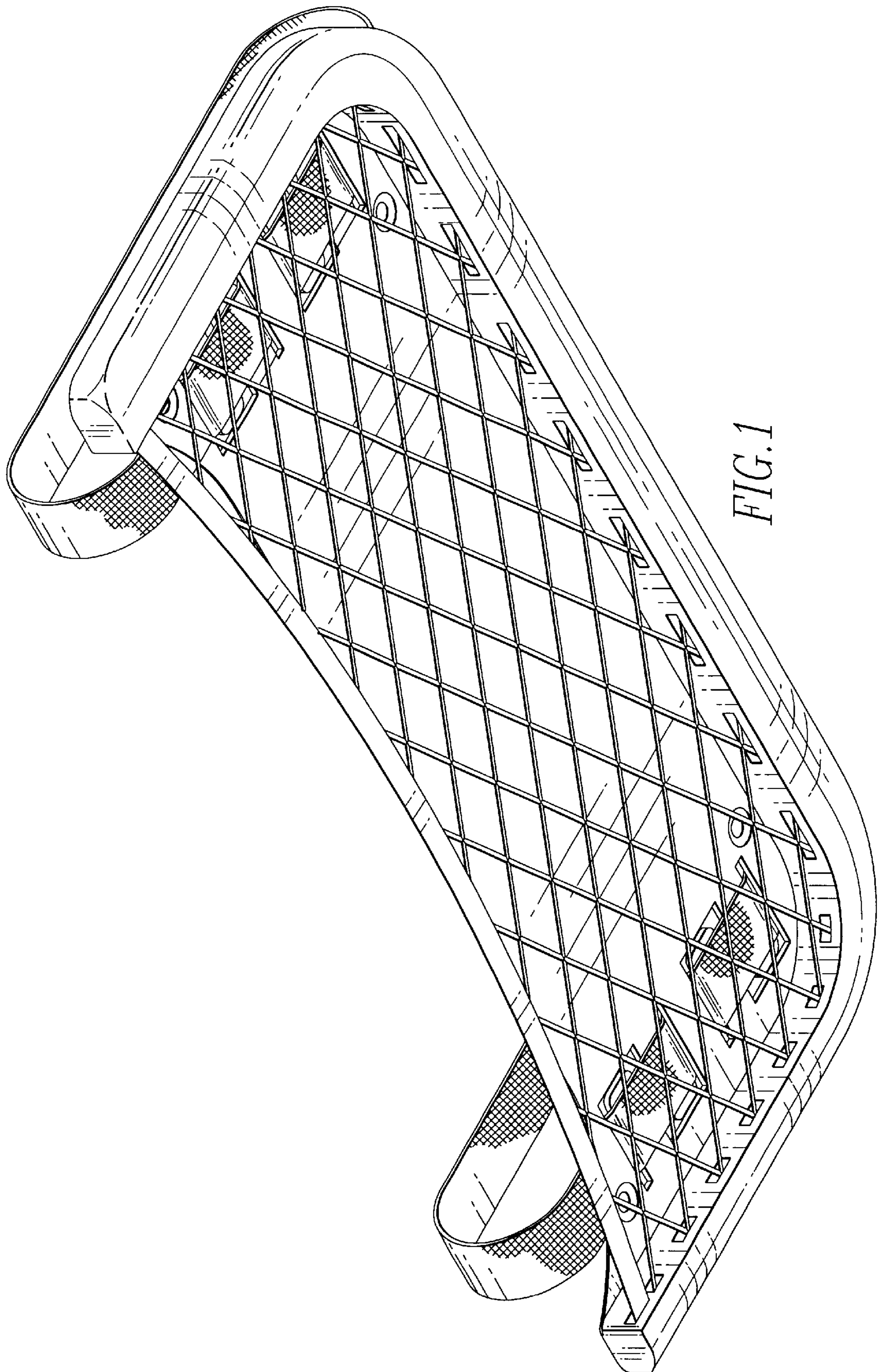

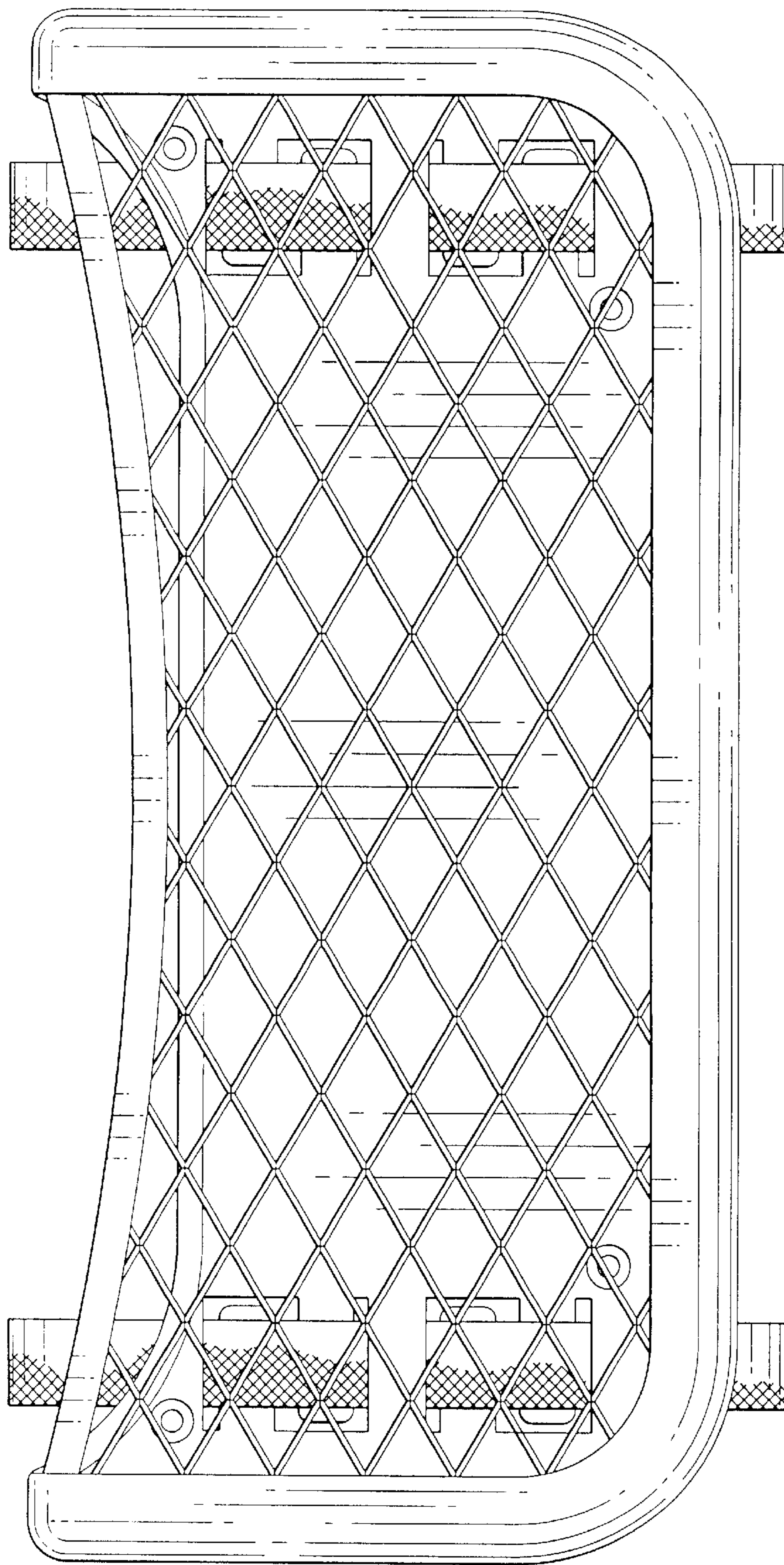

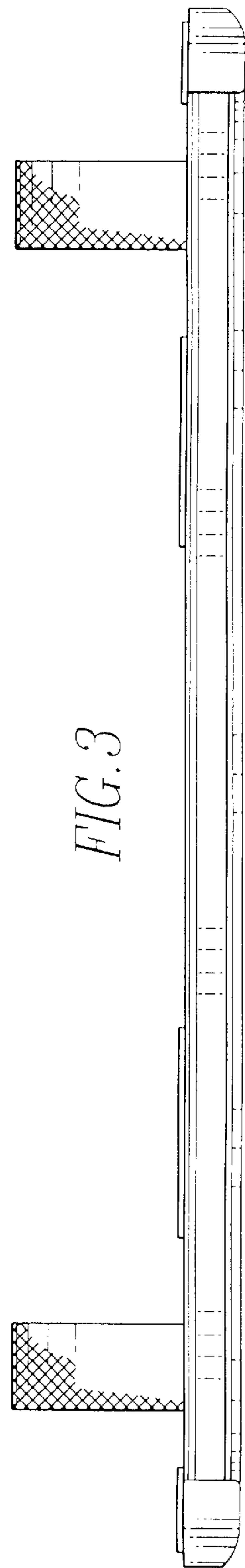

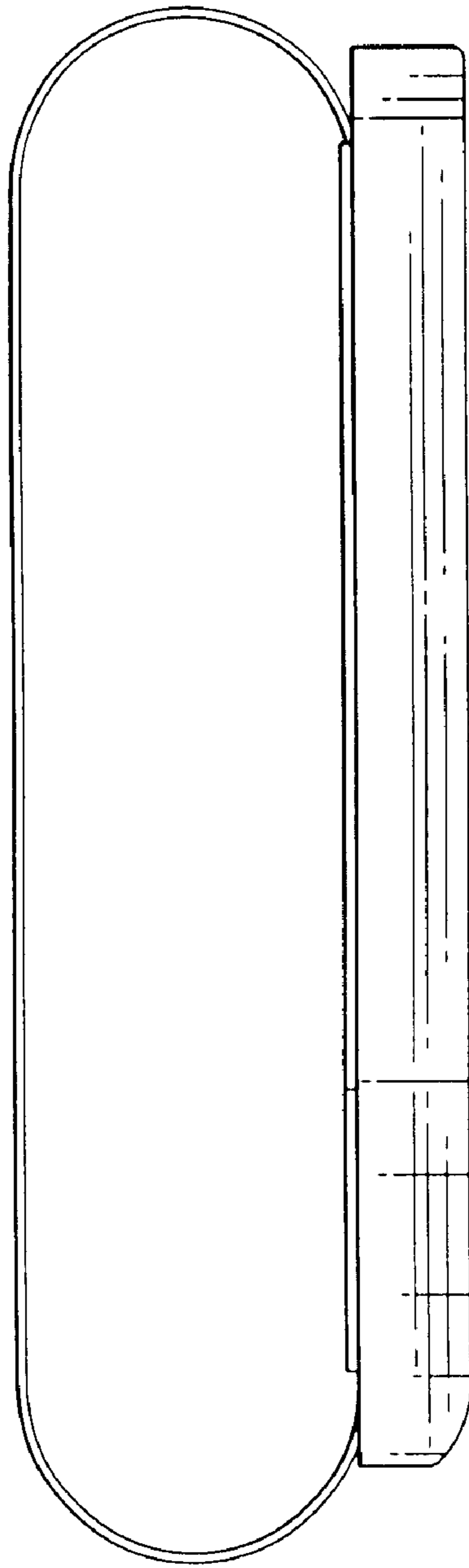
