DESCRIPTION

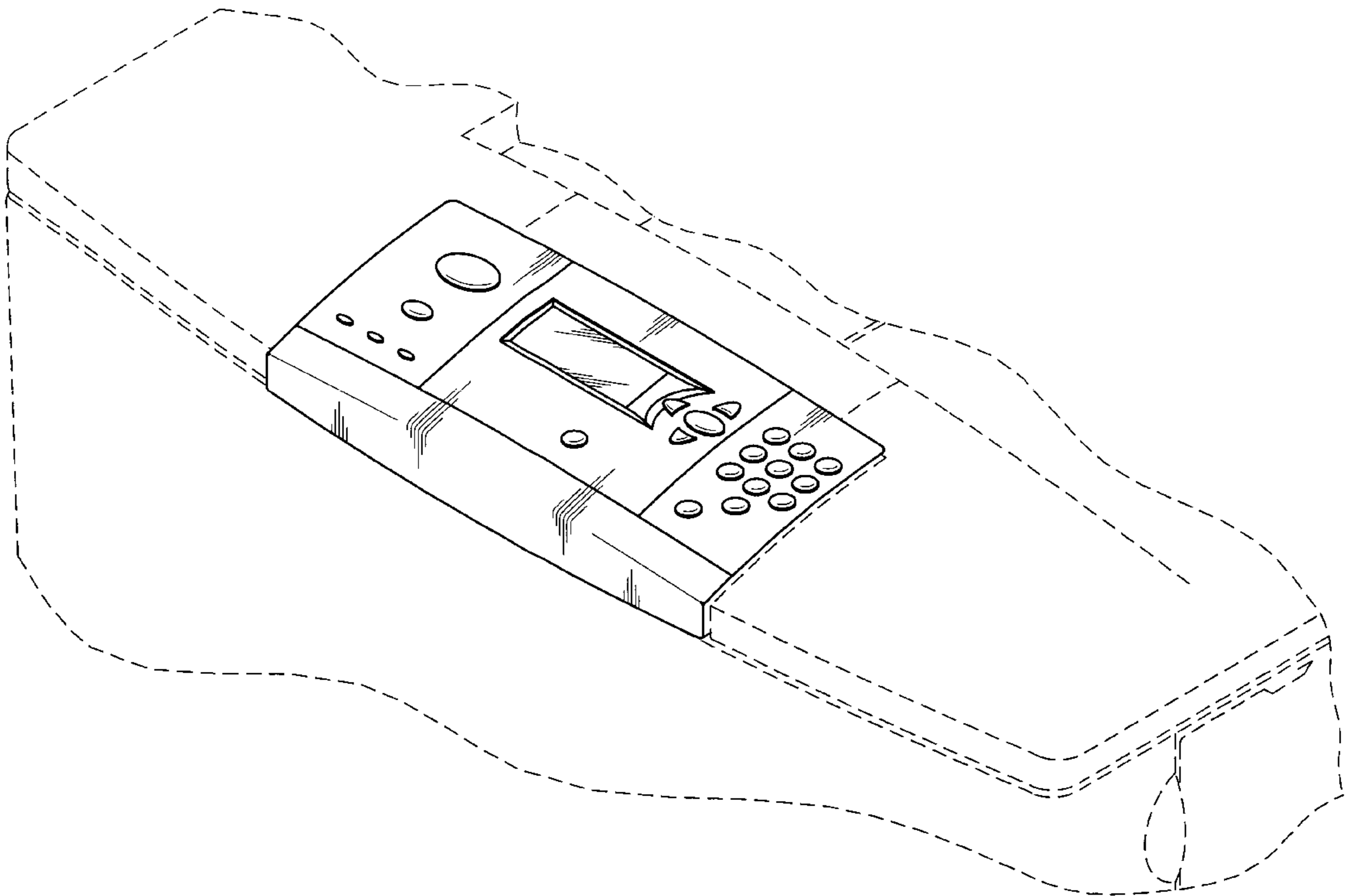
FIG. 1 is a perspective view of a control panel showing our new design;

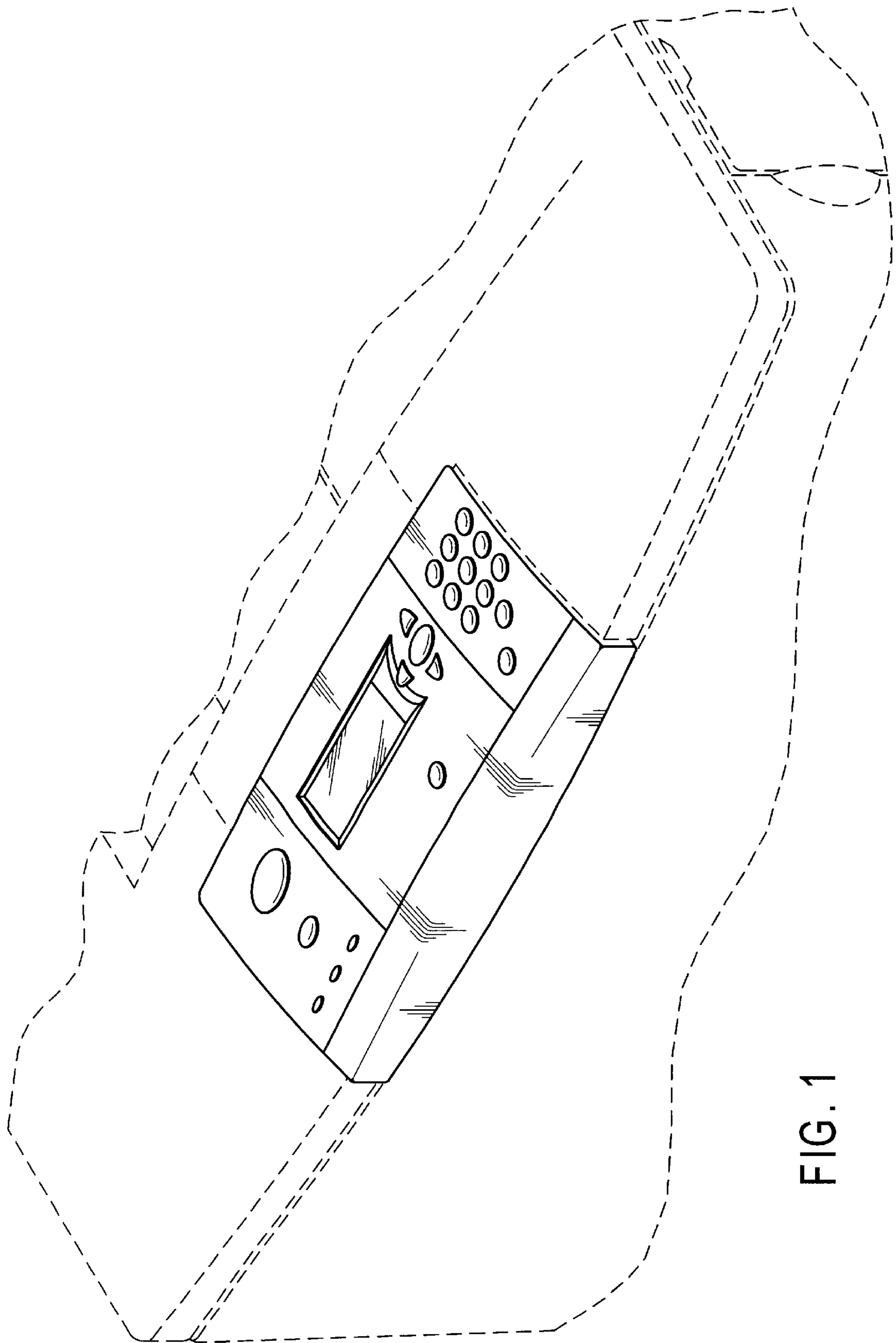

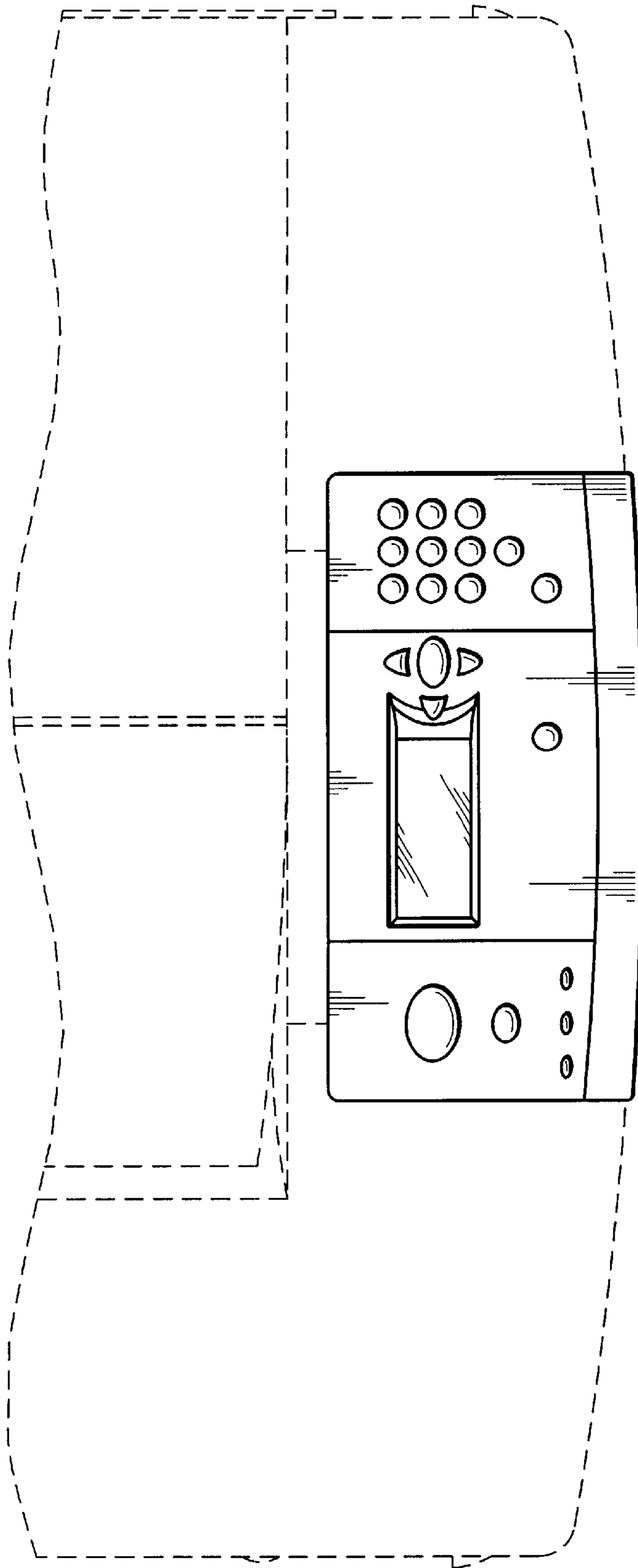

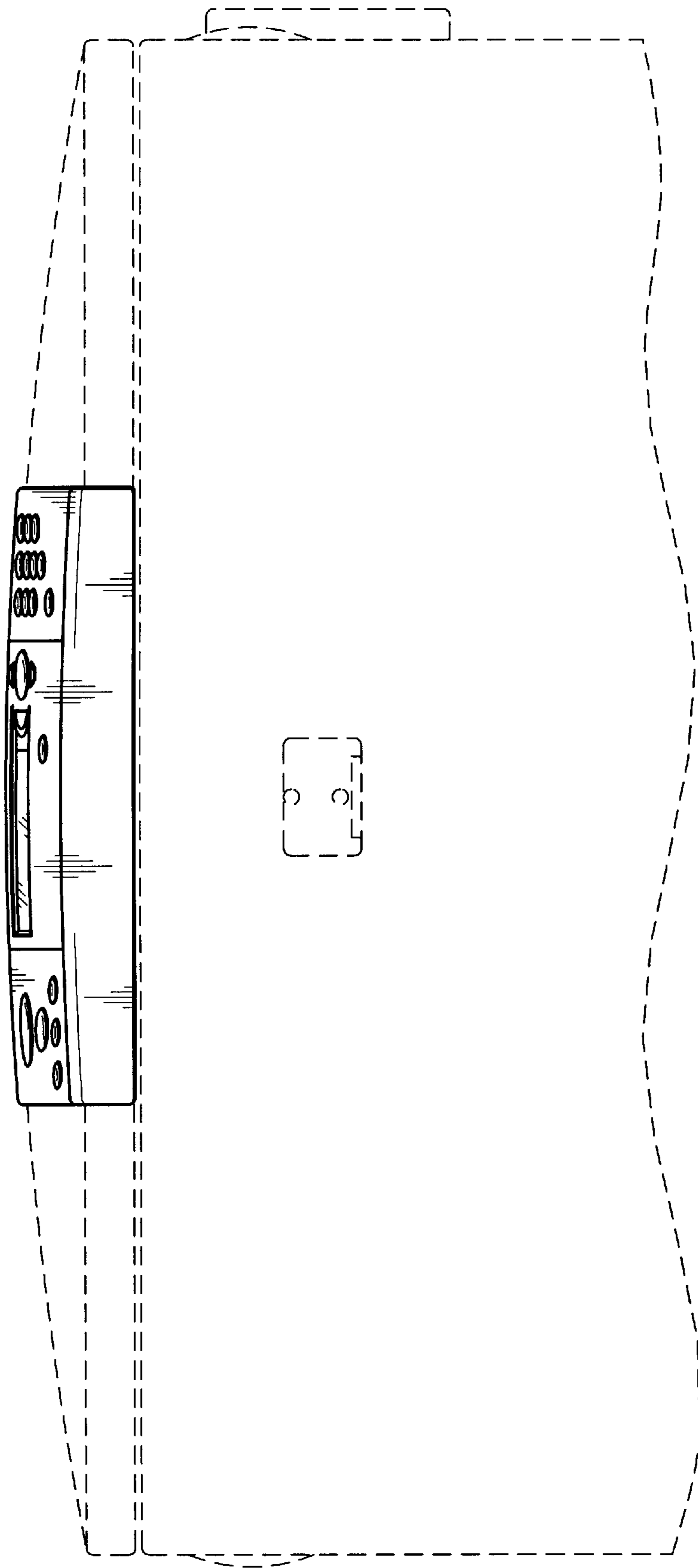
