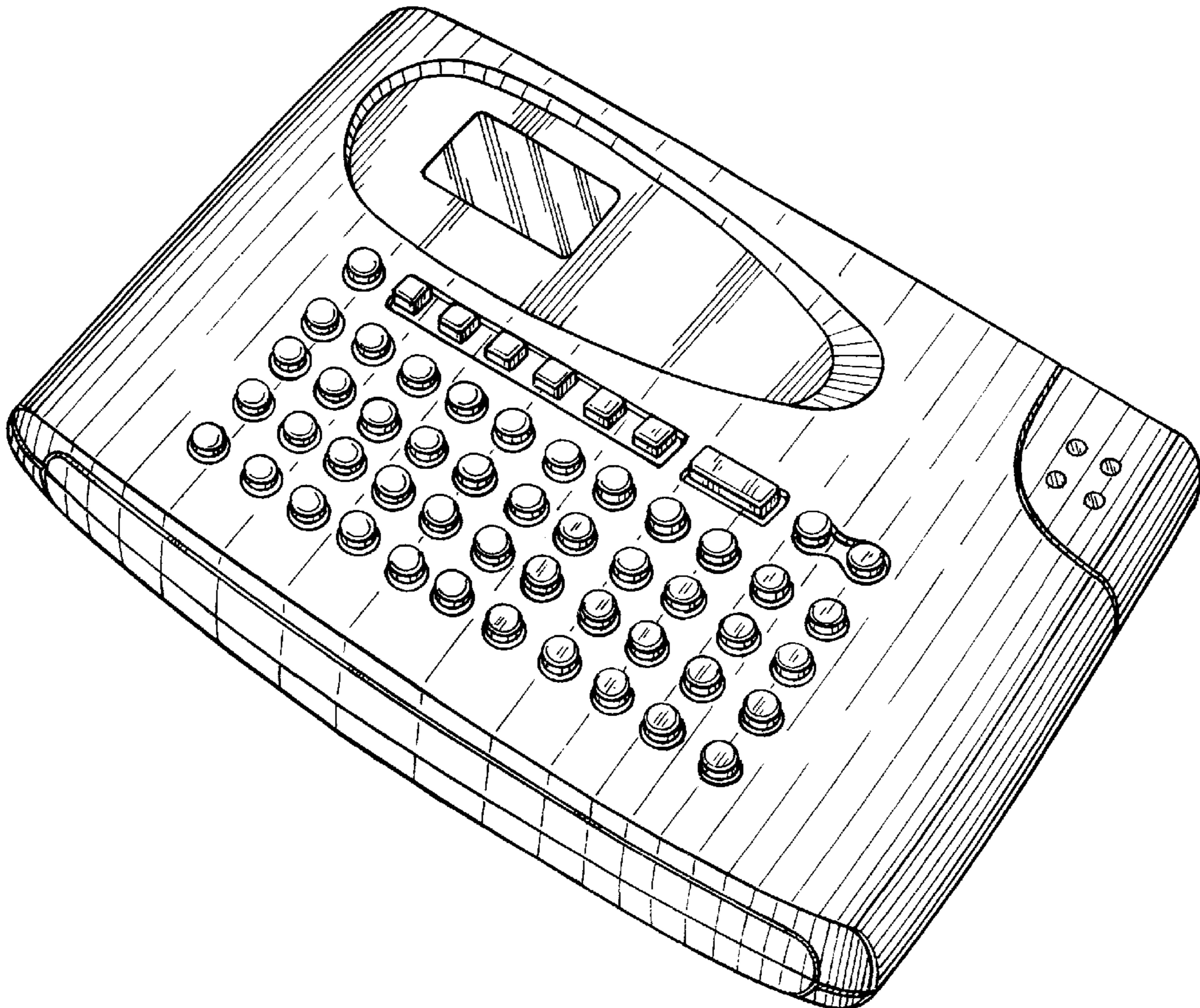

The ornamental design for a label printer, as shown.

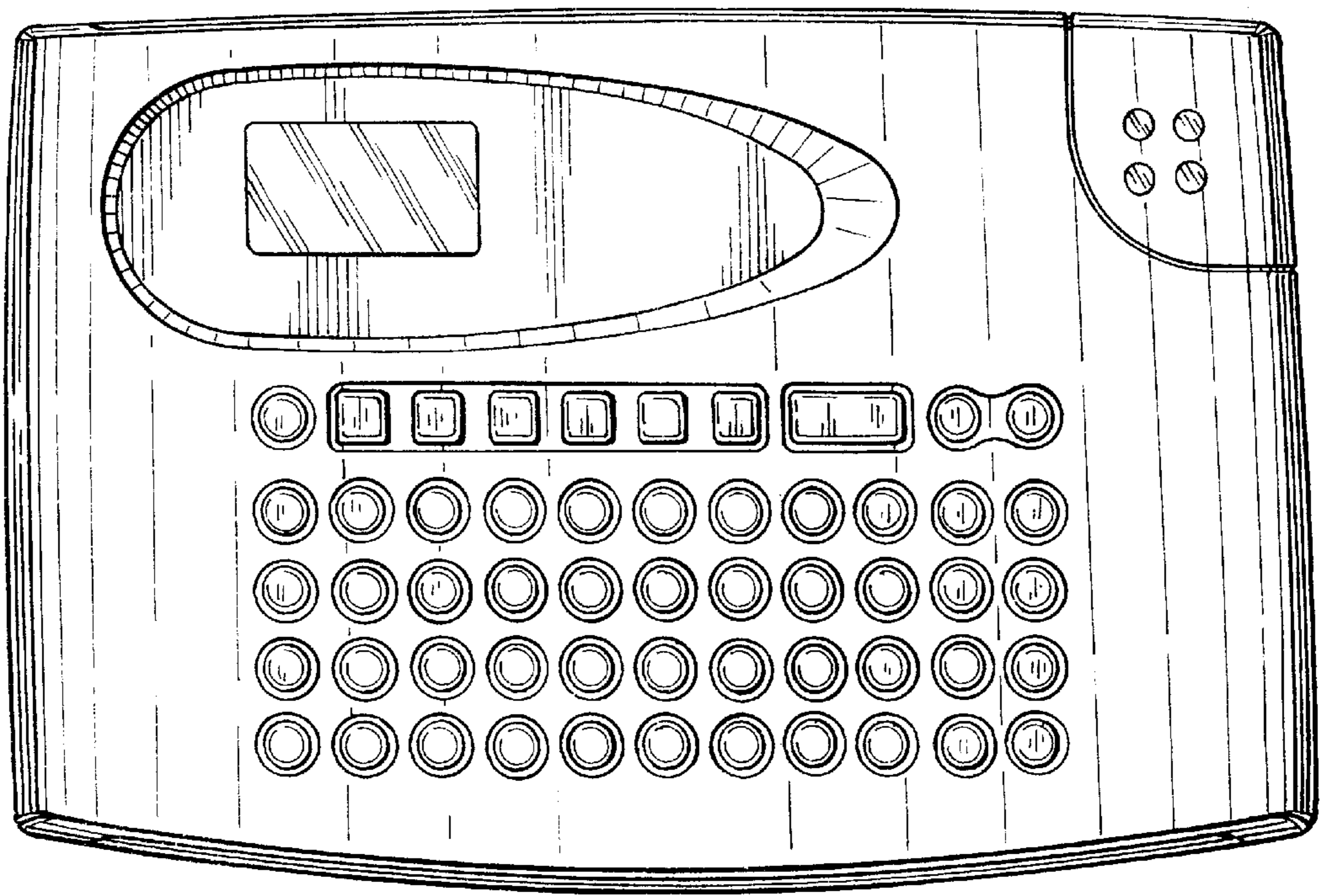
**DESCRIPTION**

FIG. 7 is a top, front, right side perspective view thereof.

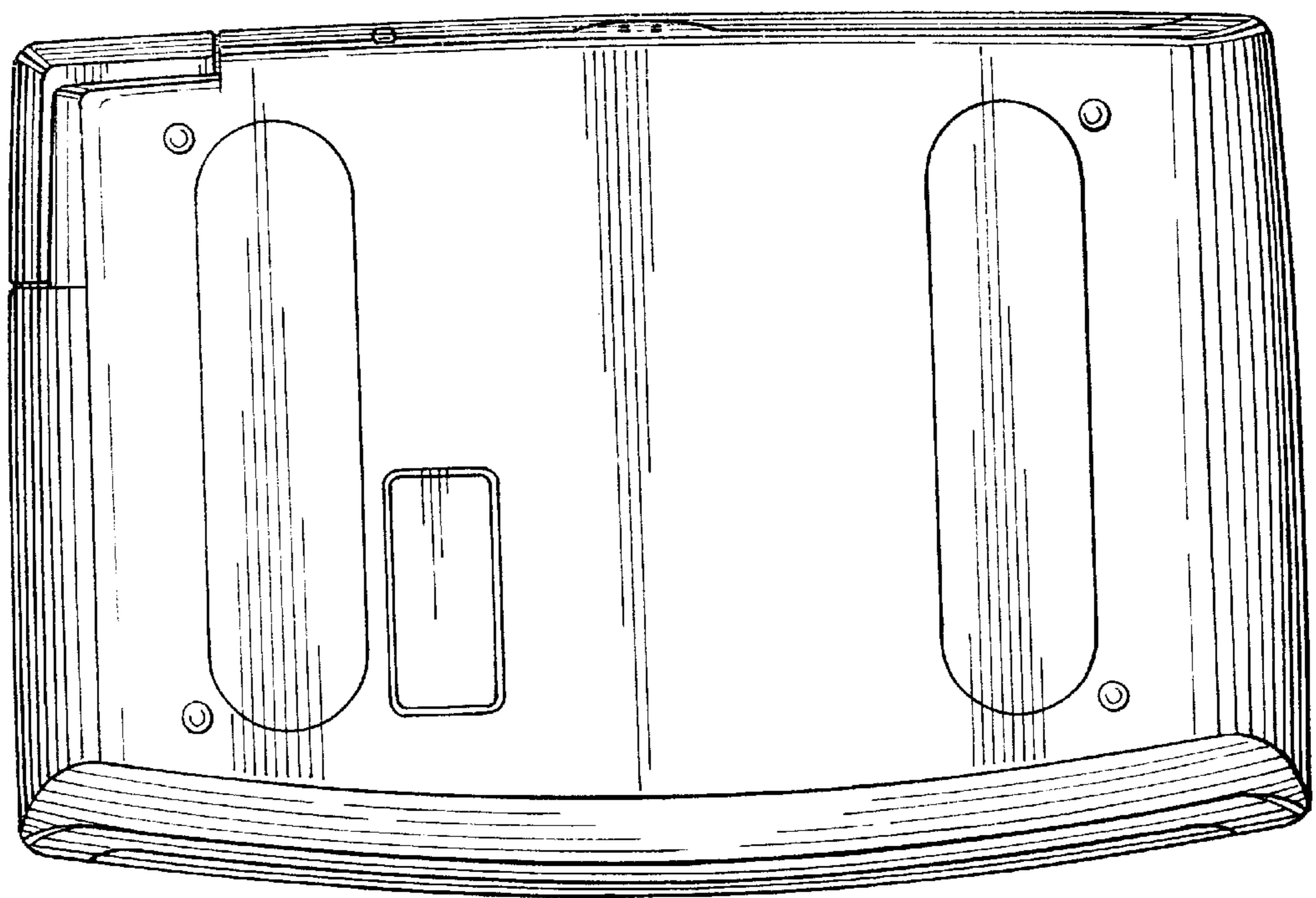

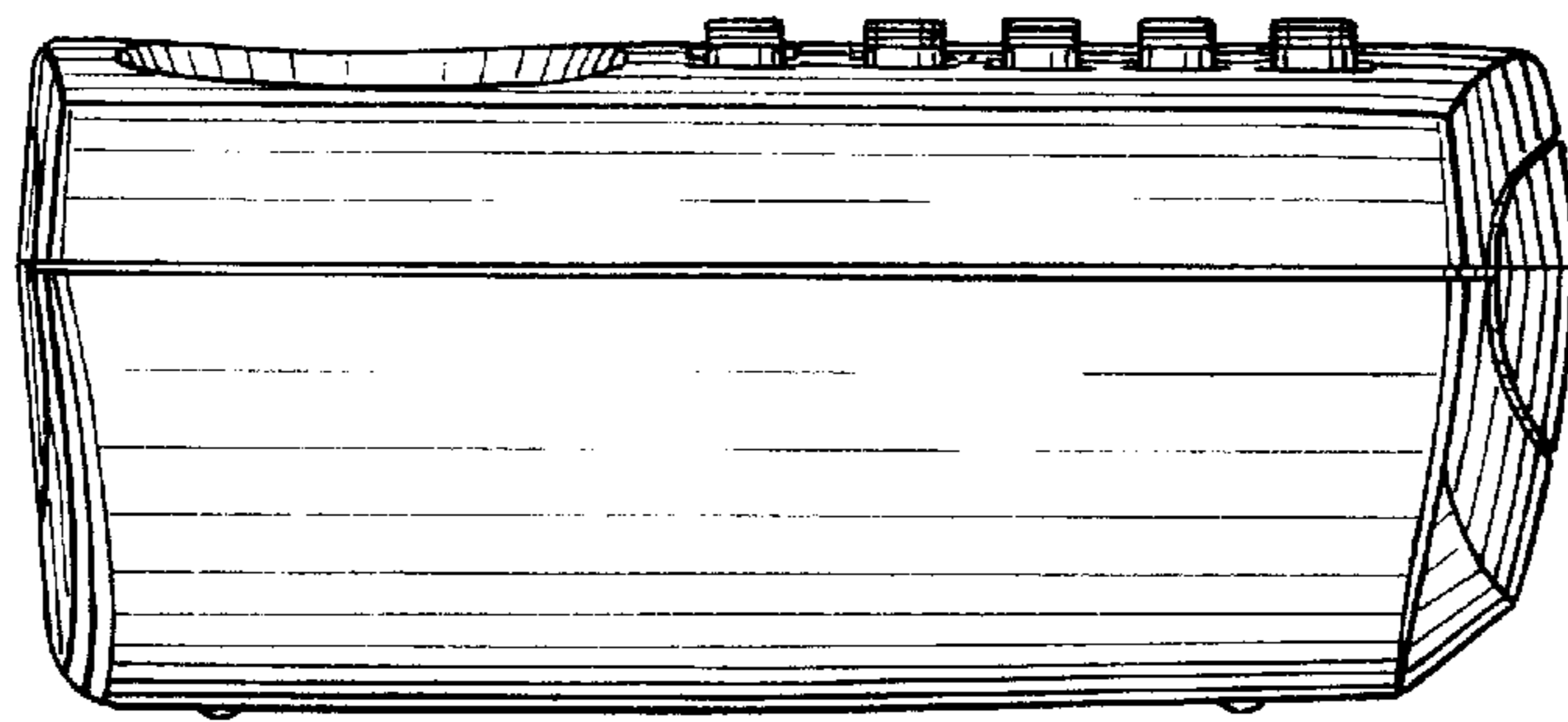




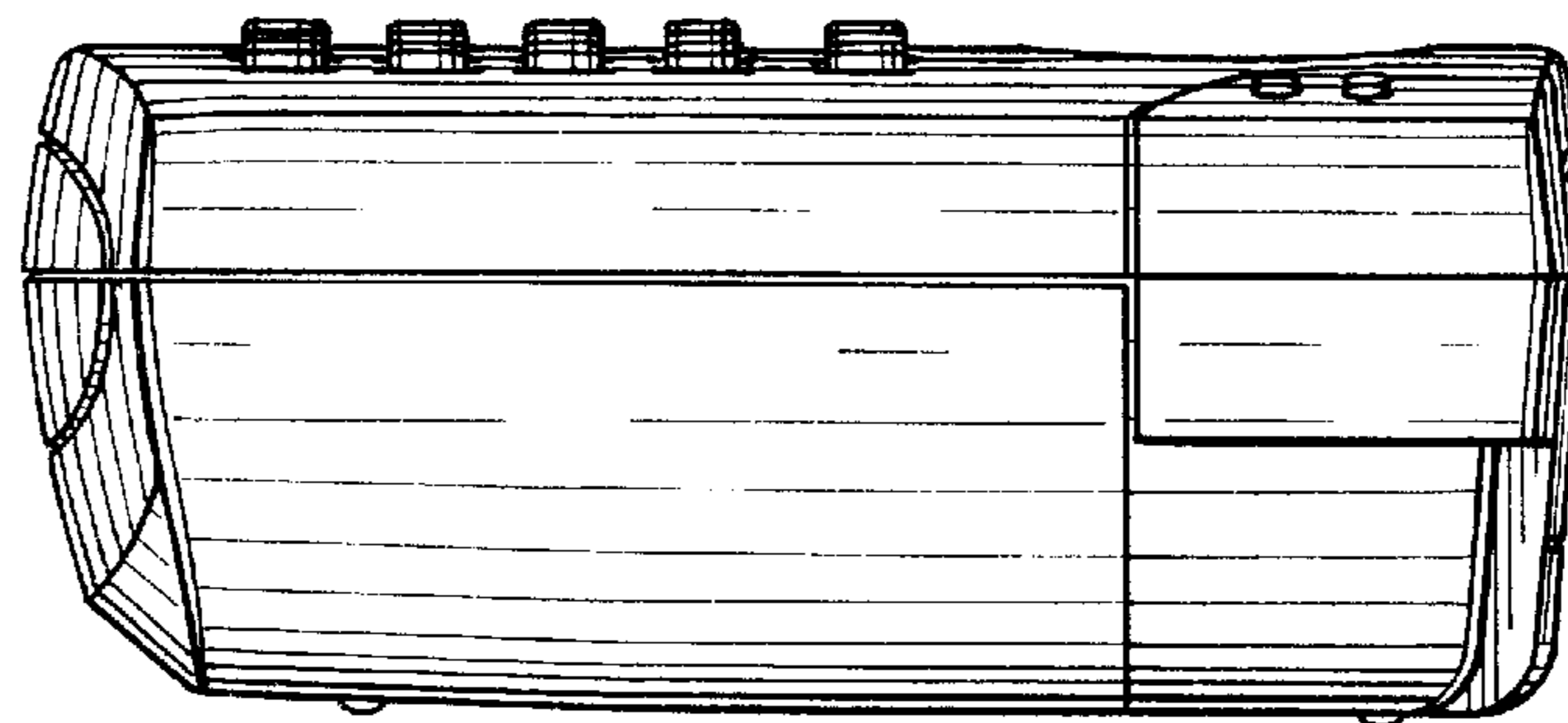

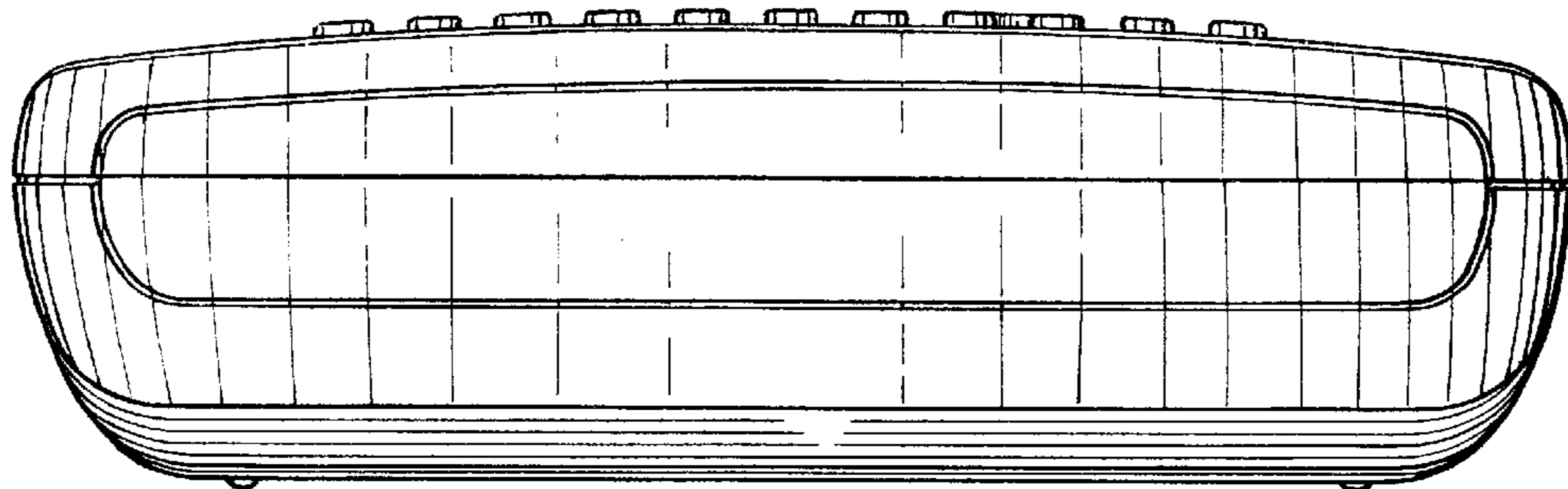

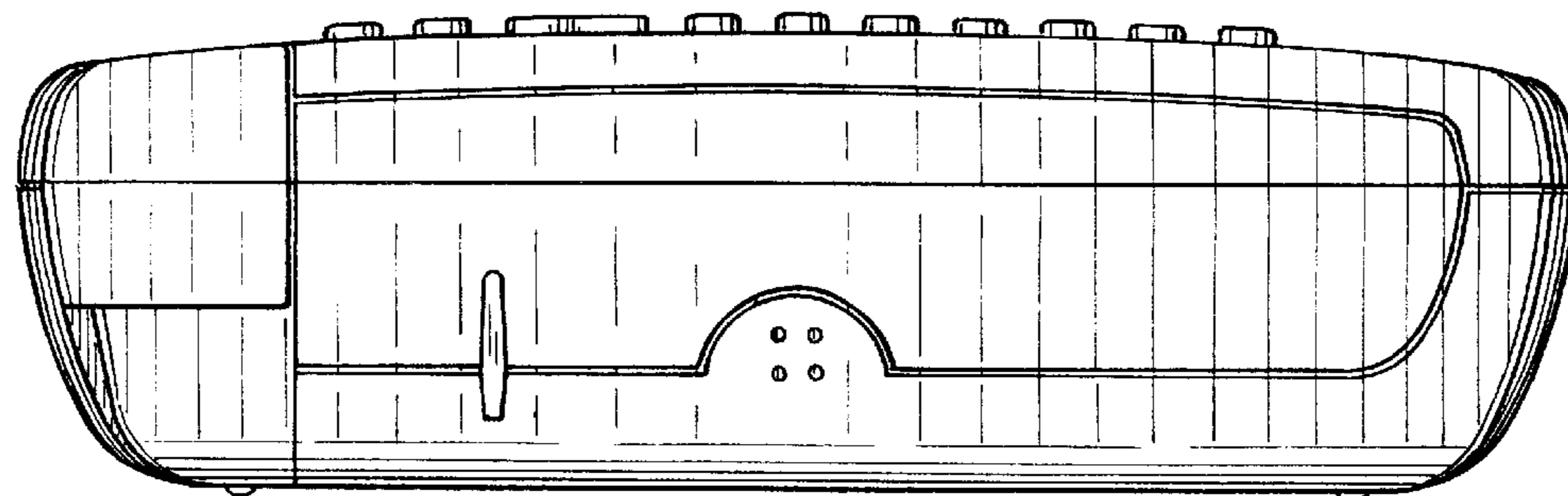

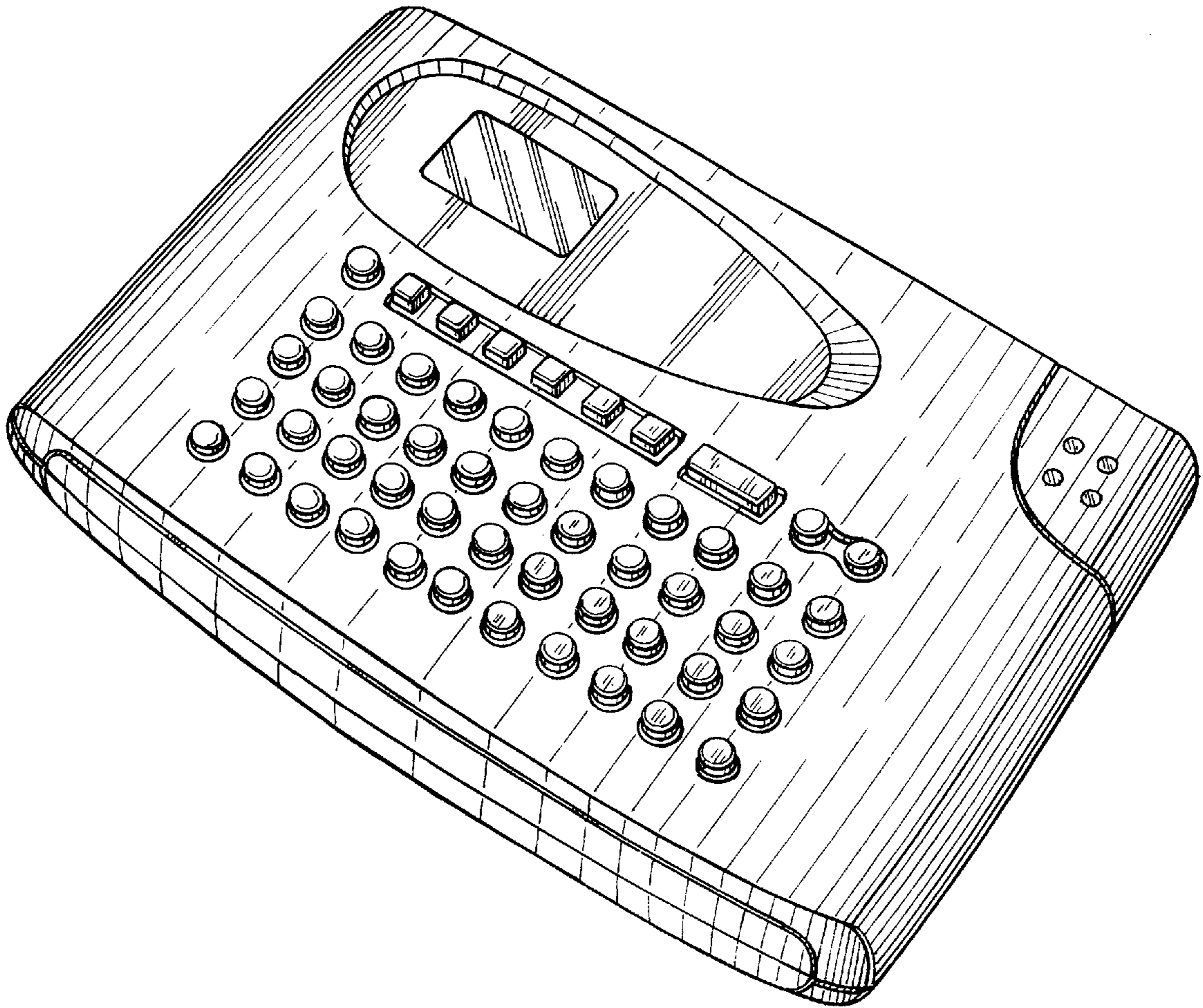
