(57) **CLAIM**

The ornamental design for body suits, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a body suit showing my new design;  
 FIG. 2 is an enlarged bottom plan view thereof;  
 FIG. 3 is an enlarged top plan view thereof;  
 FIG. 4 is a front elevational view of FIG. 1;  
 FIG. 5 is a rear elevational view of FIG. 1;  
 FIG. 6 is a reduced left side elevational view of FIG. 1; and,  
 FIG. 7 is a reduced right side elevational view of FIG. 1.  
 The broken lines shown throughout the views are understood to represent stitching.

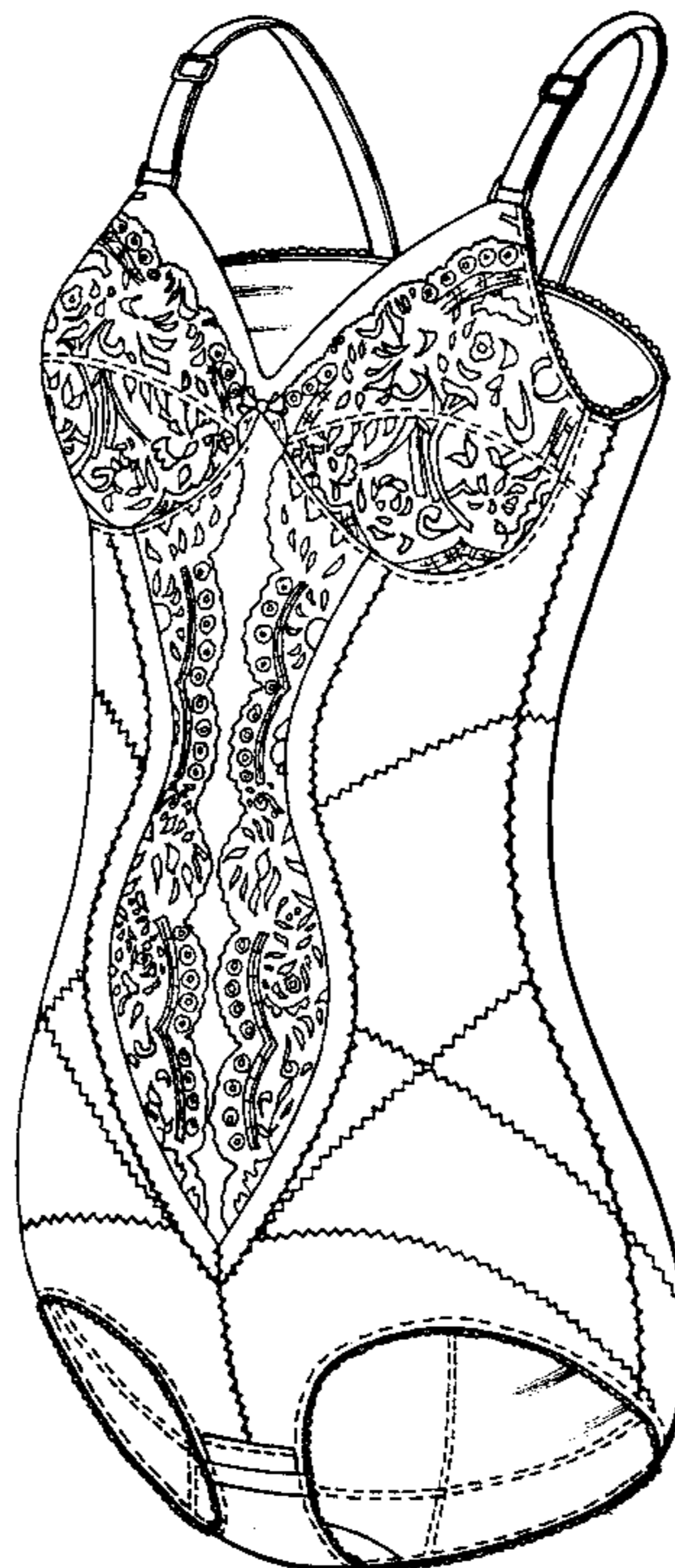

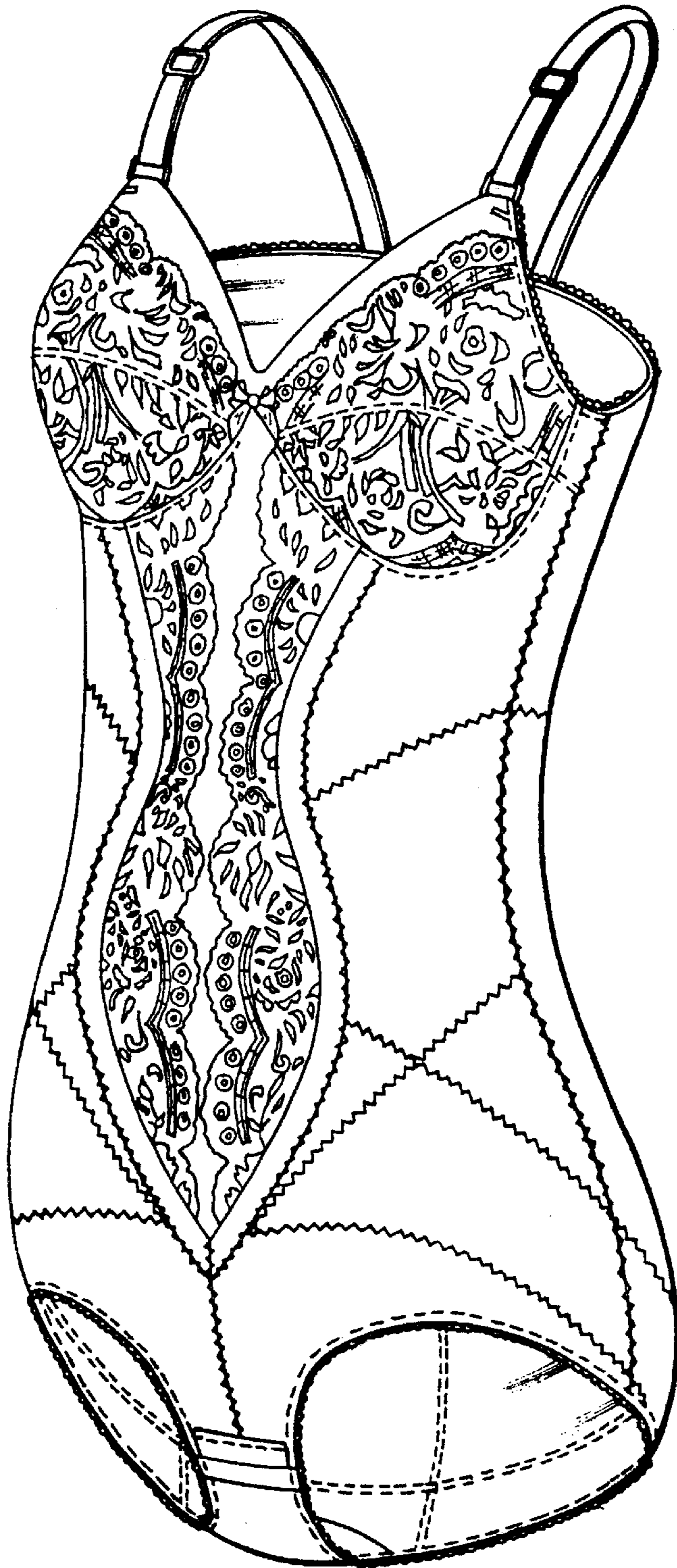

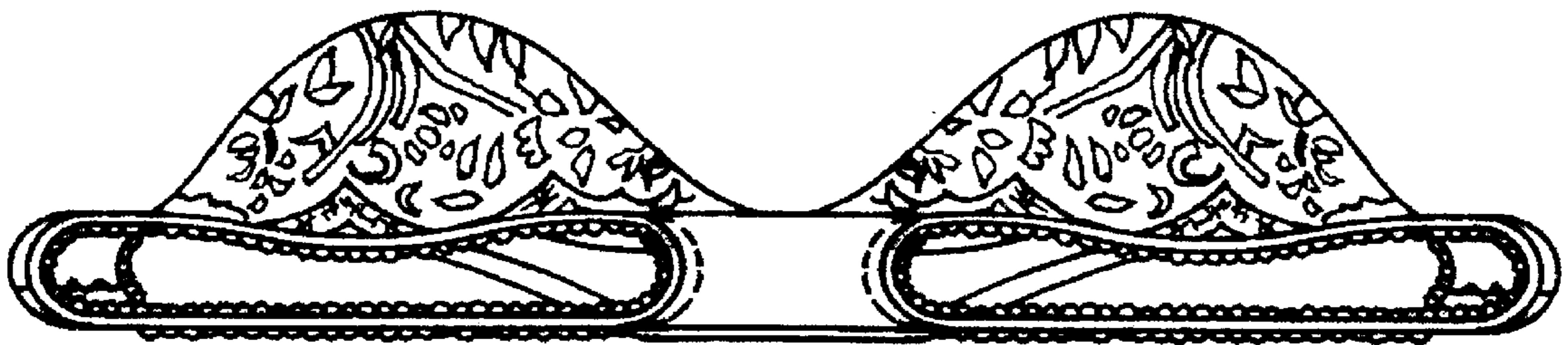

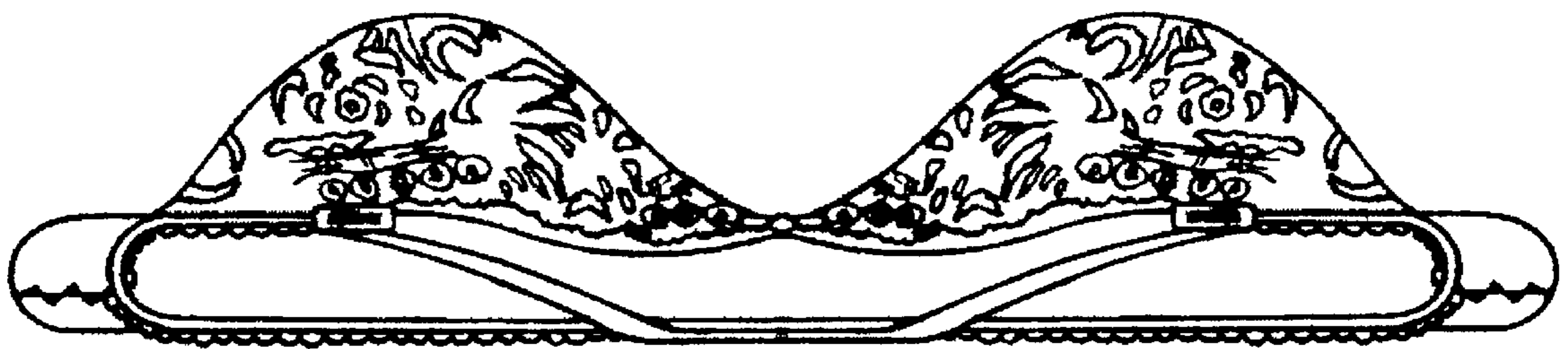

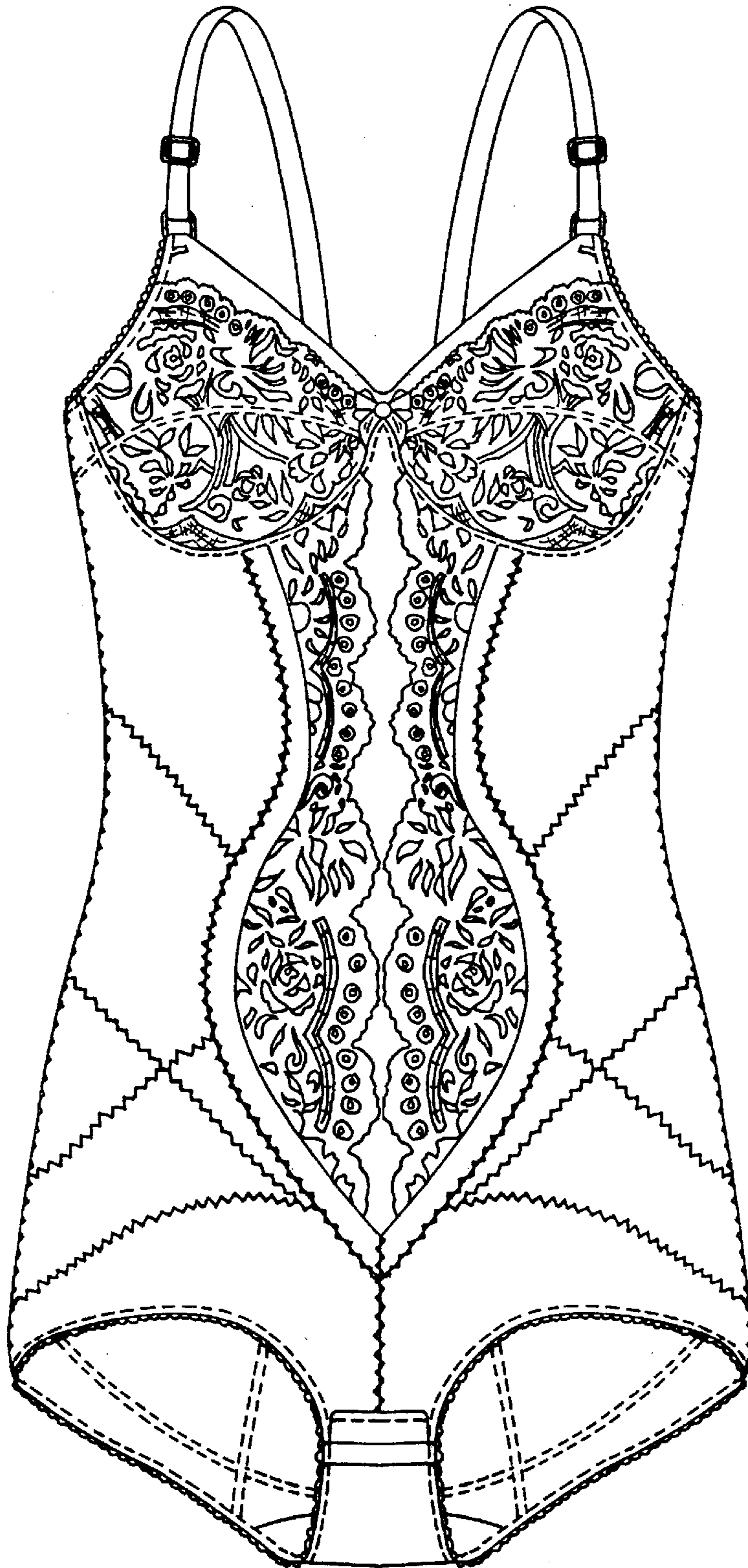

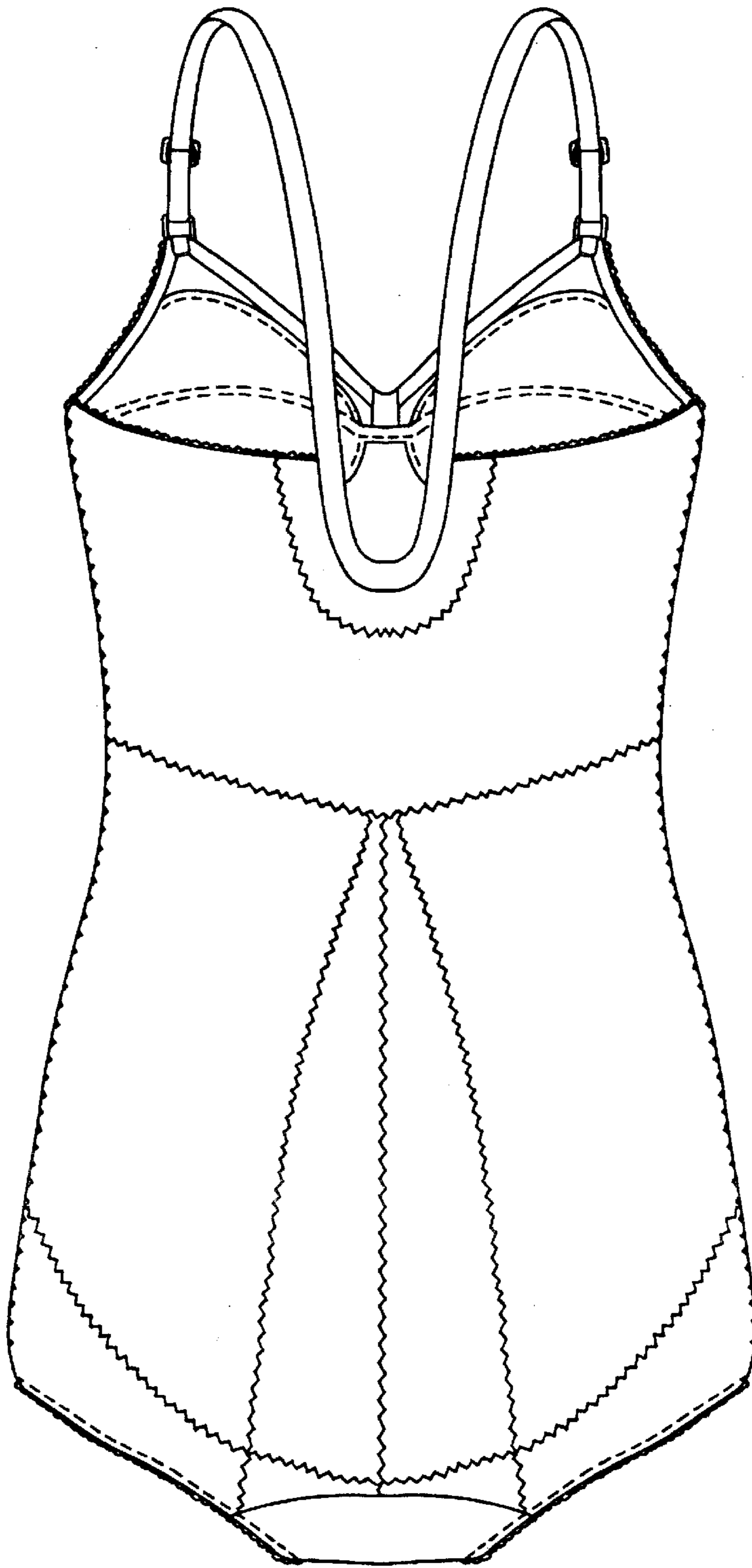

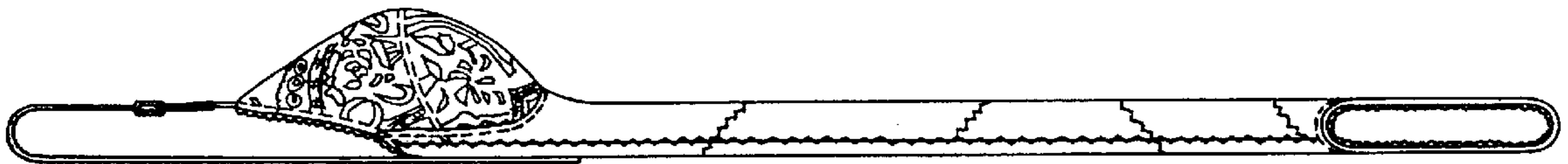
