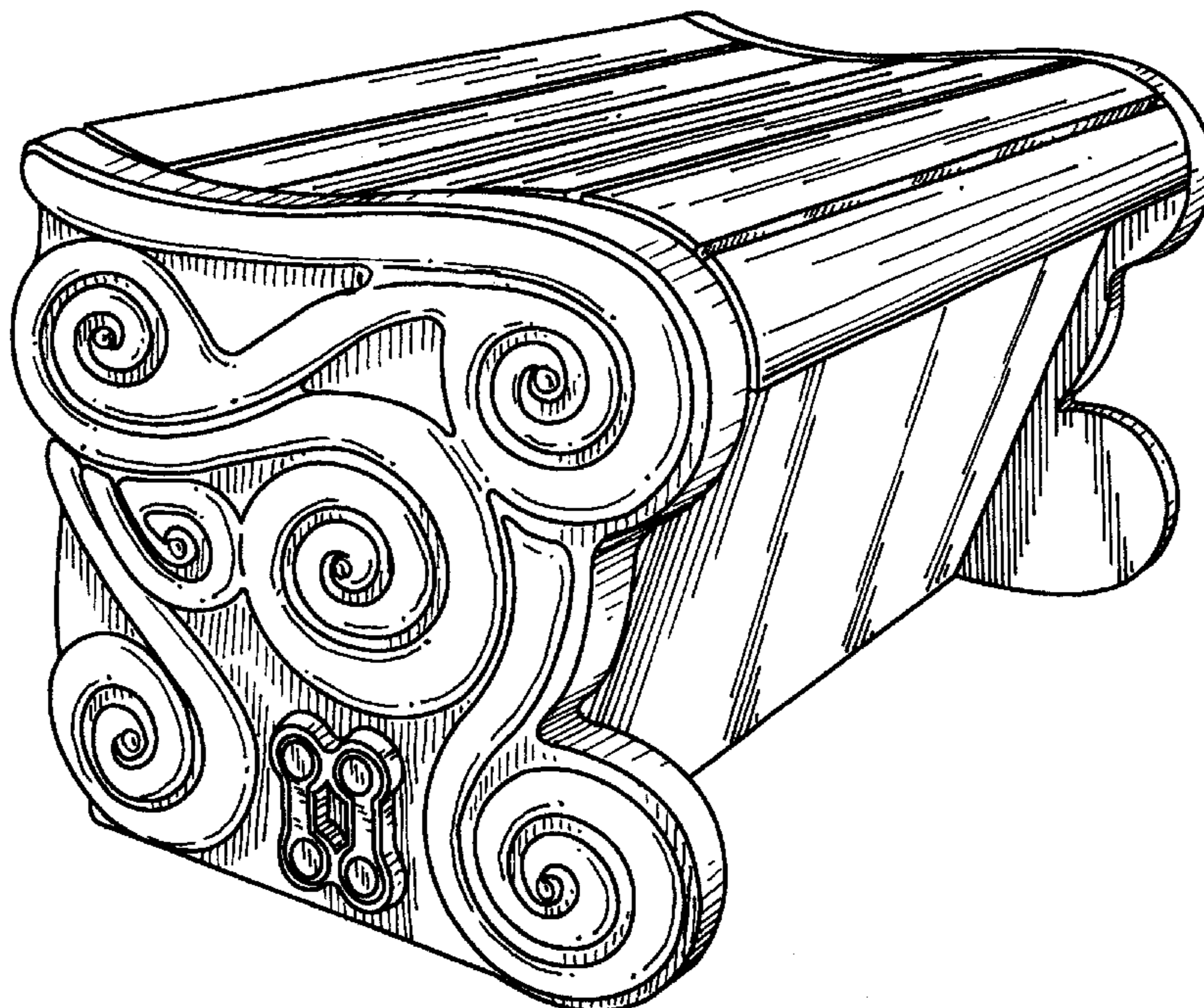
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the waste bench embodying the new design;
 FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;
 FIG. 3 is a top perspective view thereof;
 FIG. 4 is a front elevational view thereof; and,
 FIG. 5 is a rear elevational view thereof.

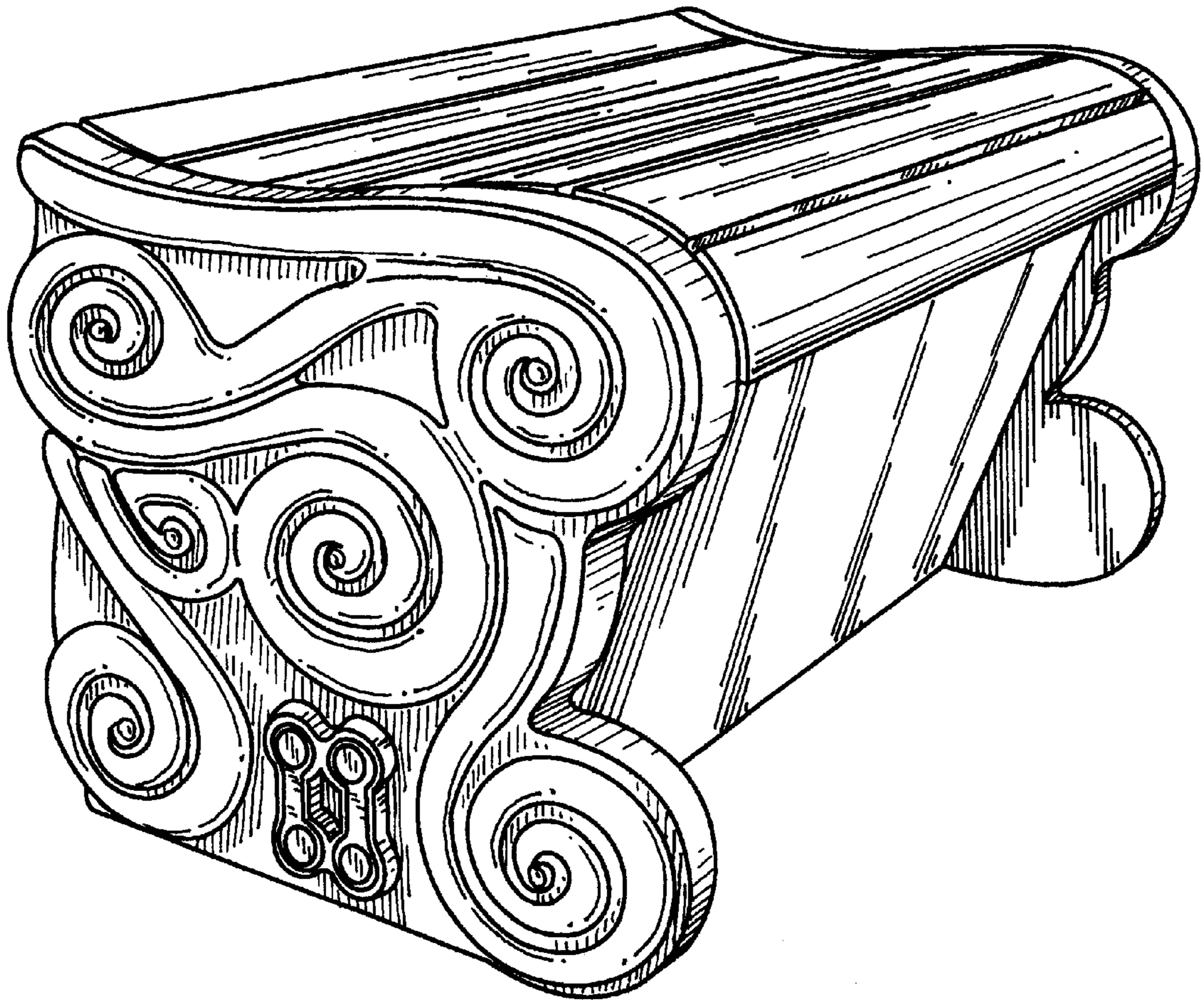

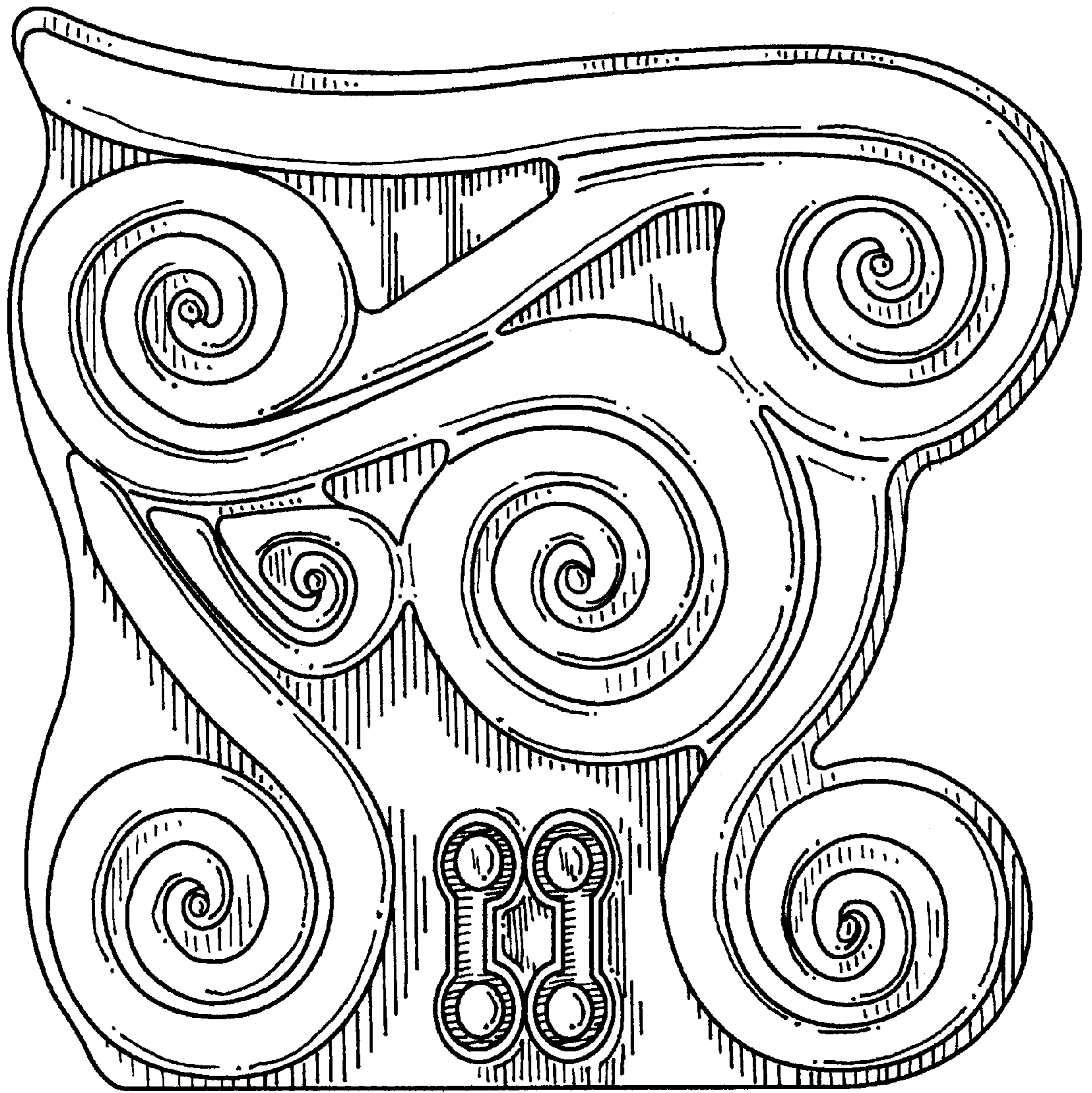

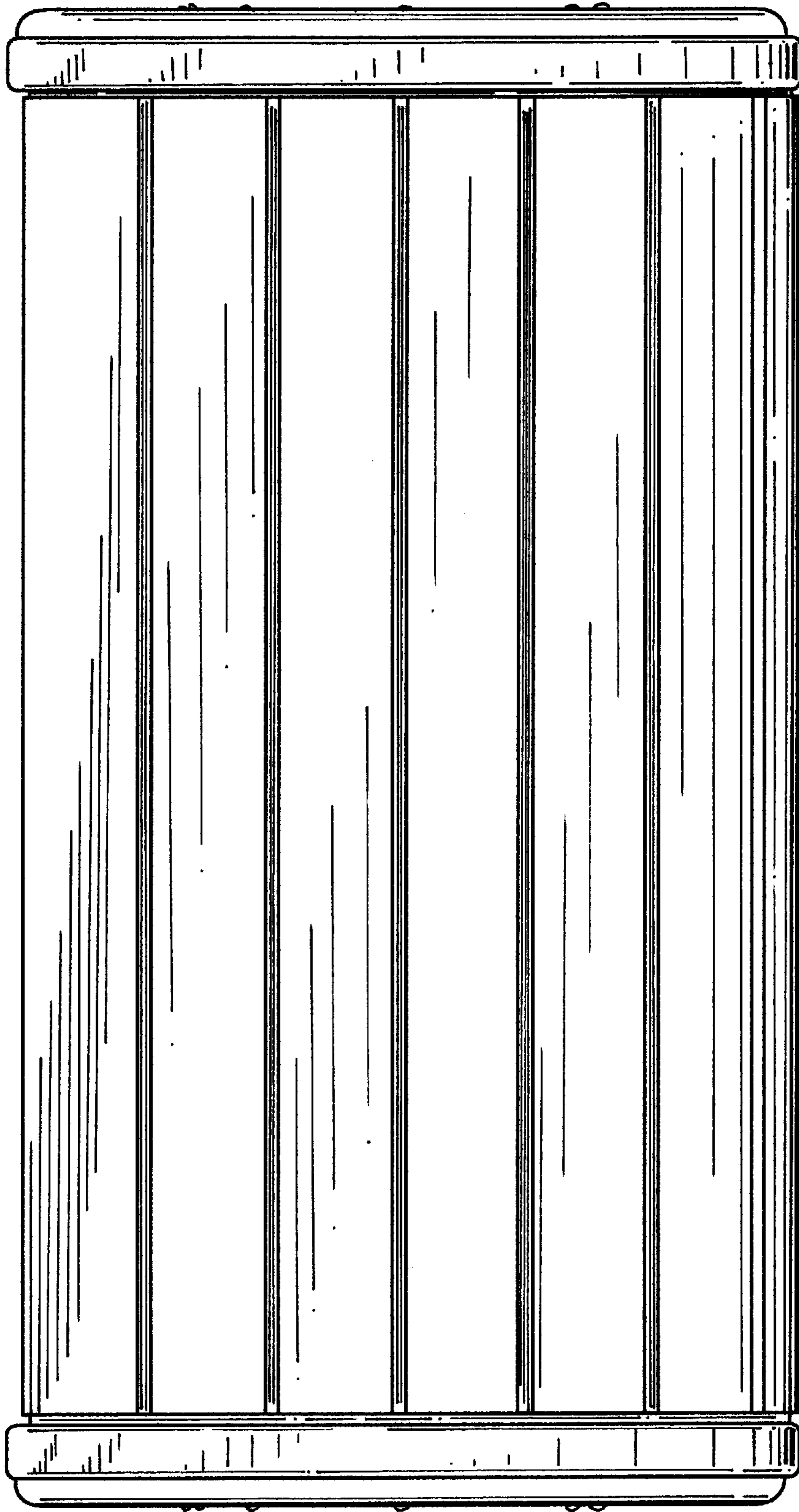

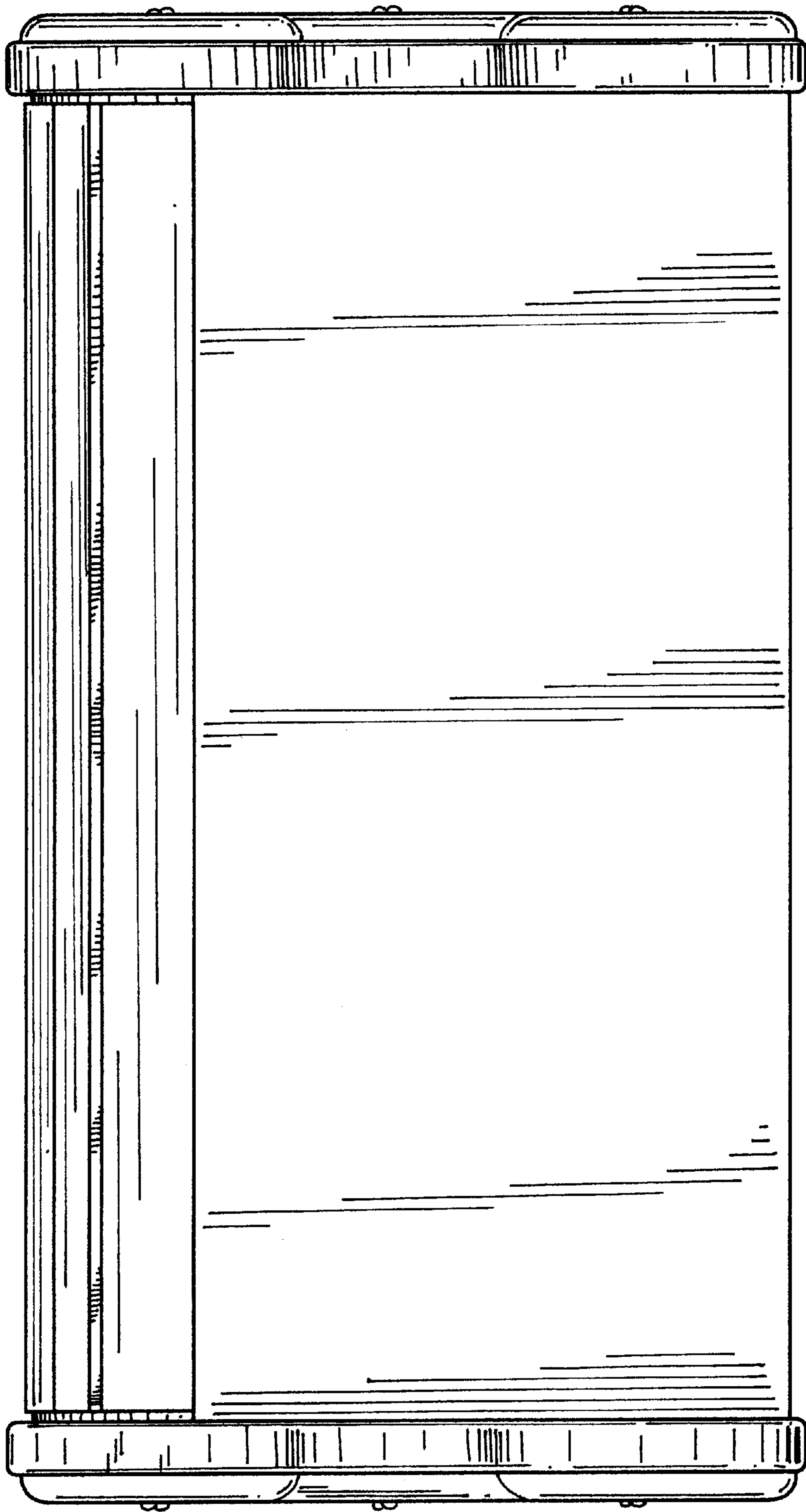

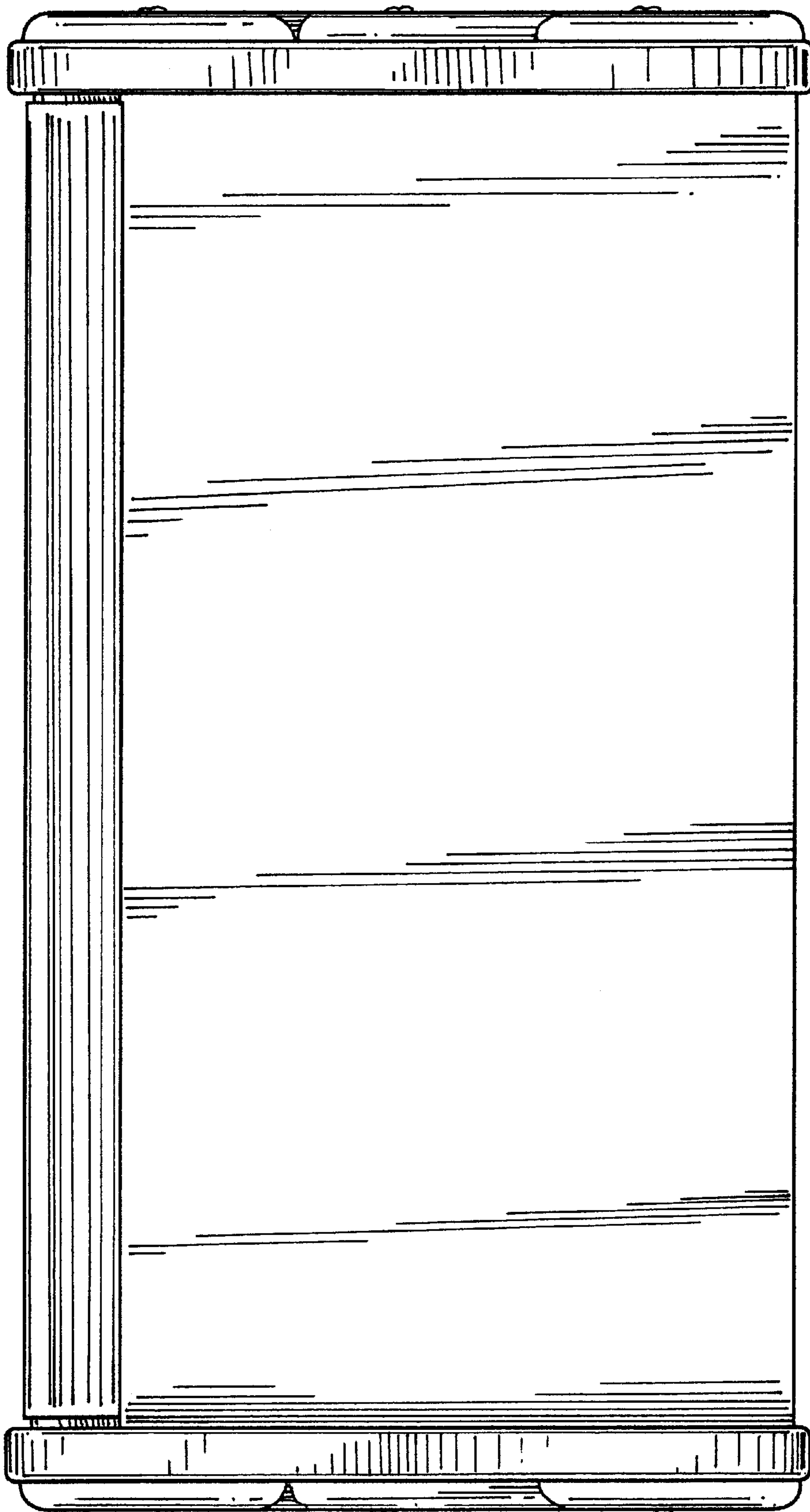
