The ornamental design for the hand held power tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the hand held power tool showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a side elevational view of one side thereof;

FIG. 5 is a top plan view thereof; and

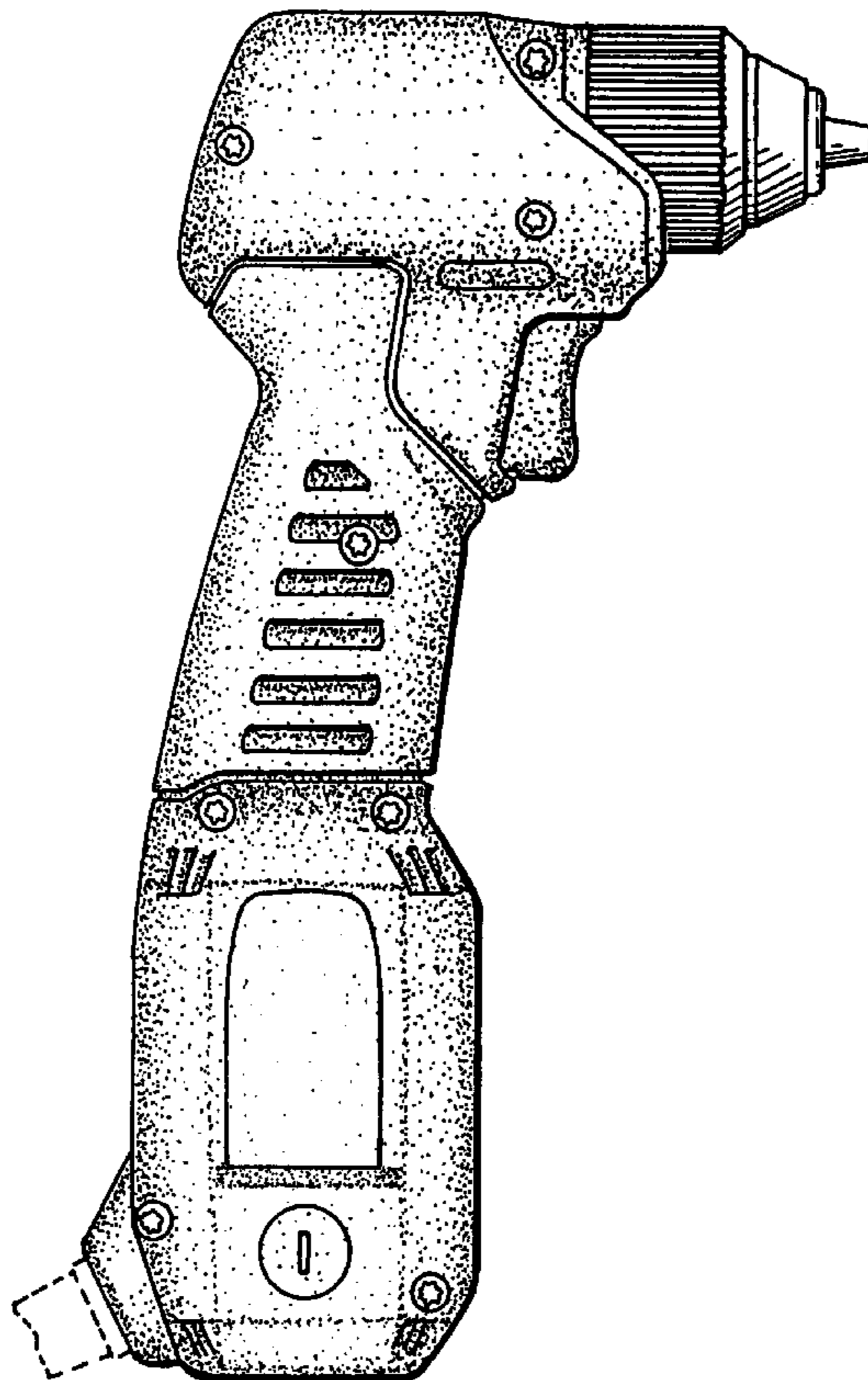

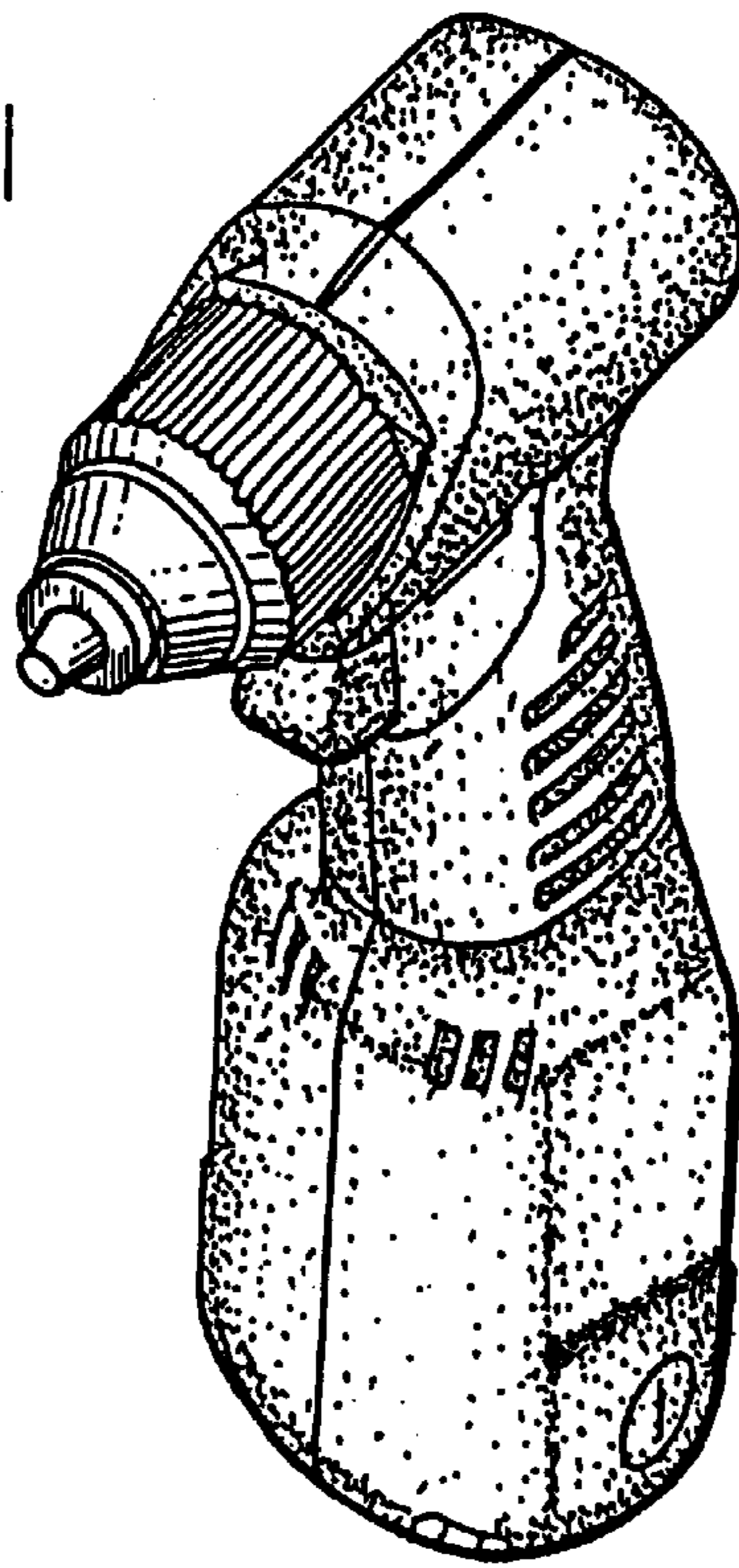

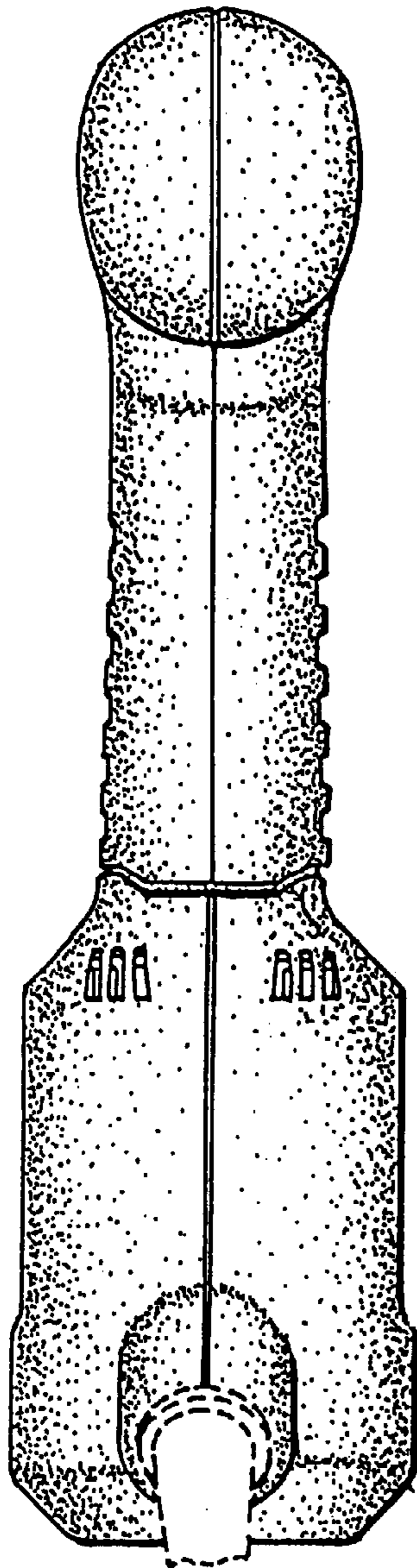

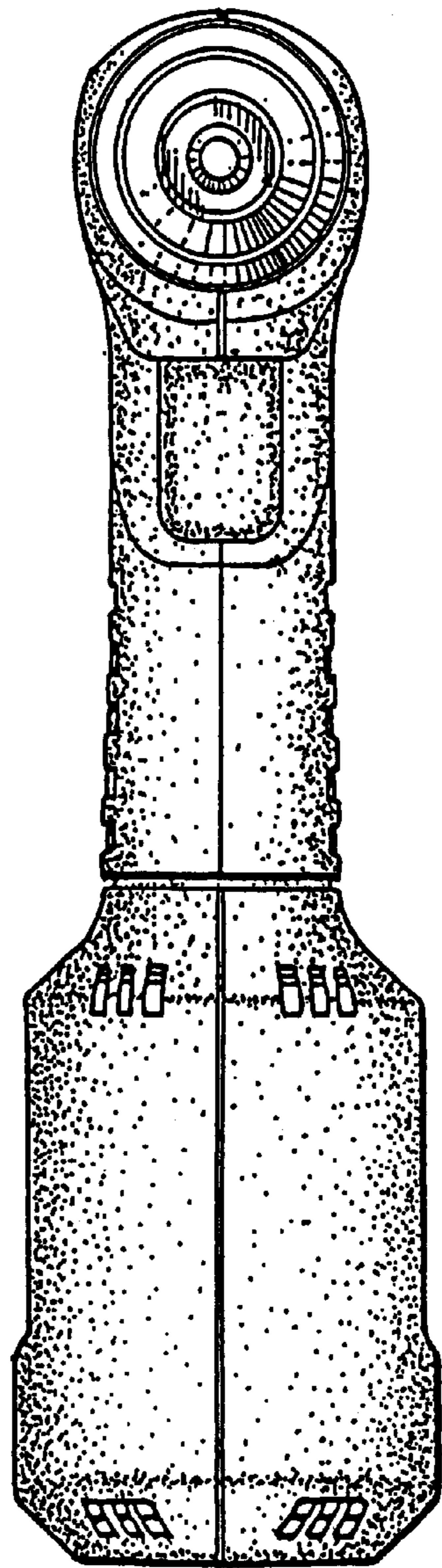

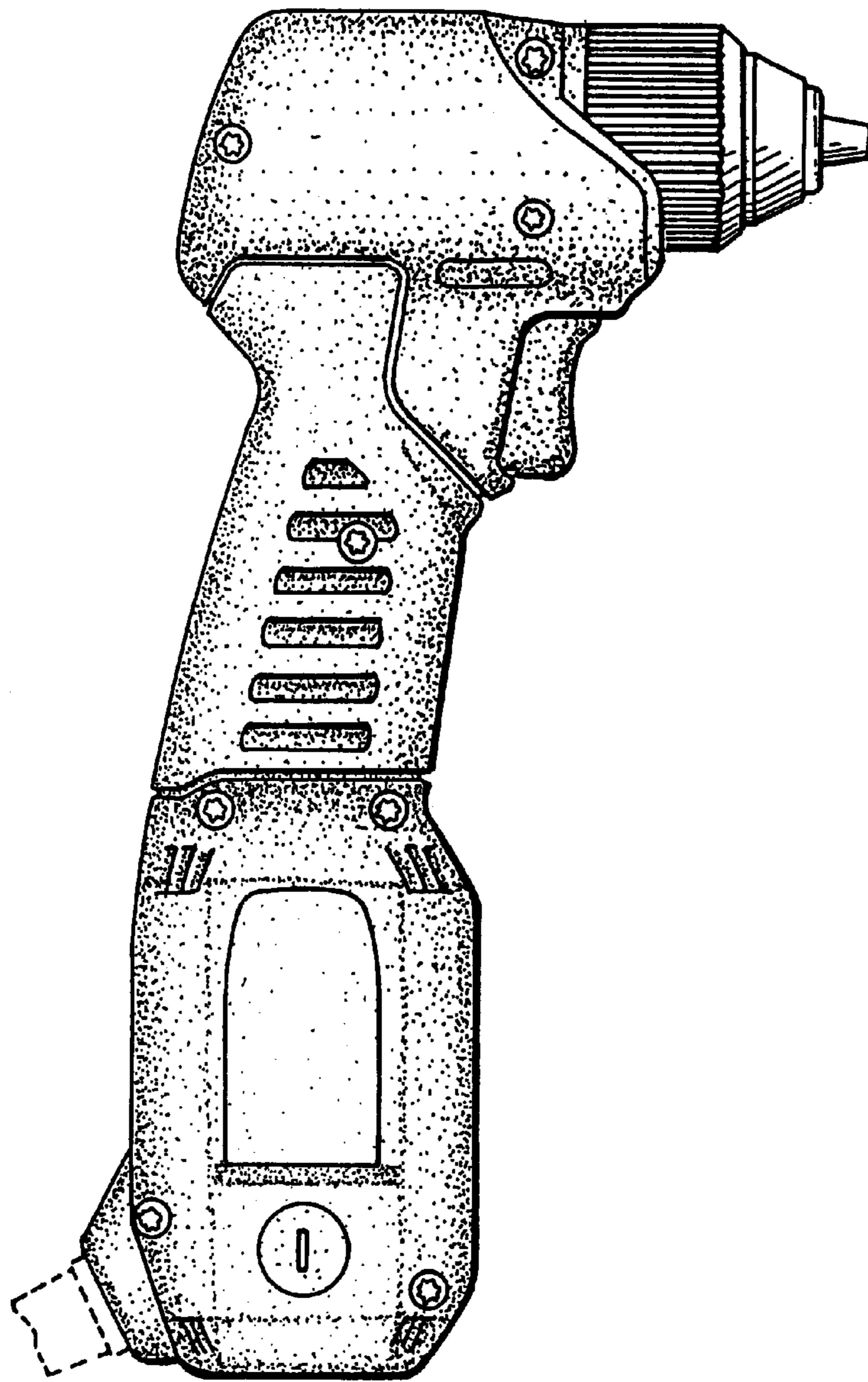

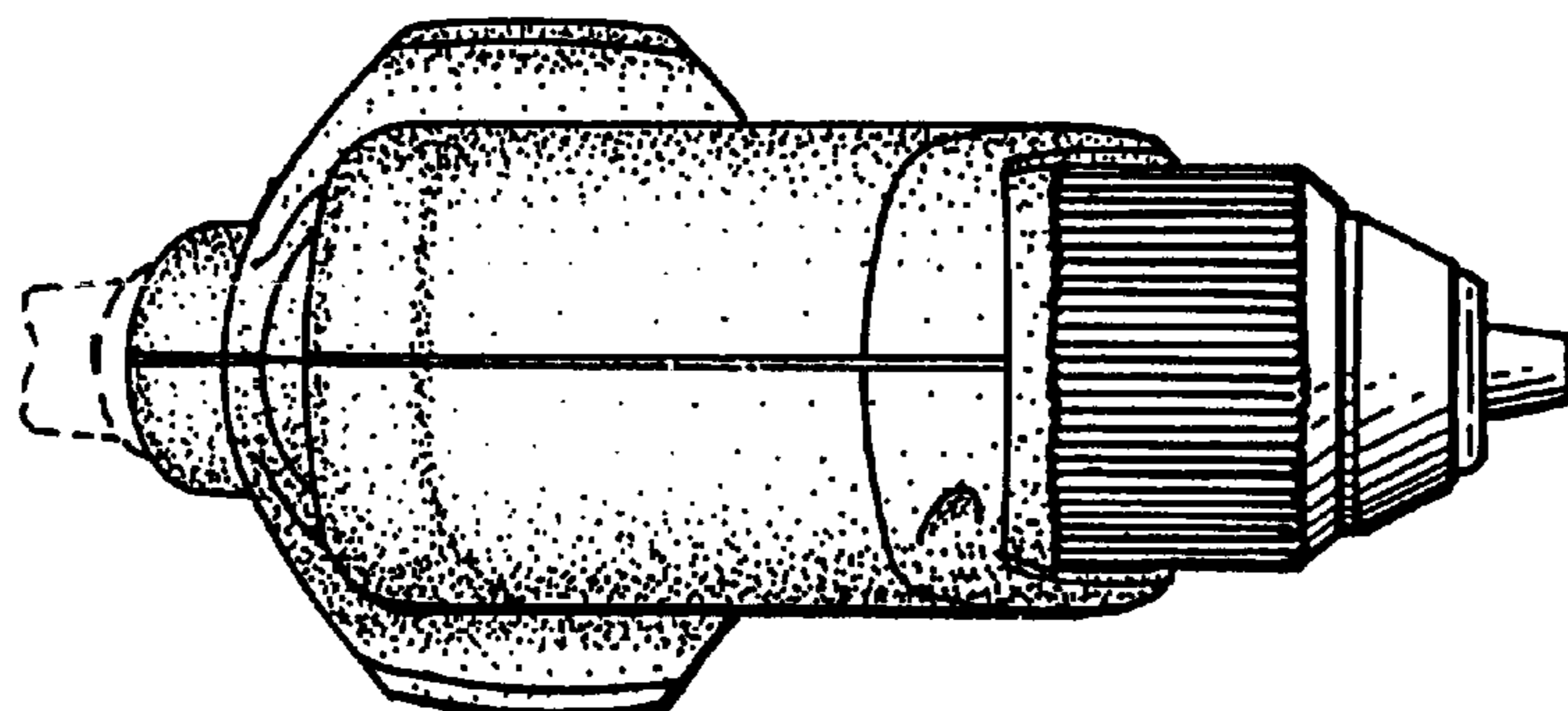

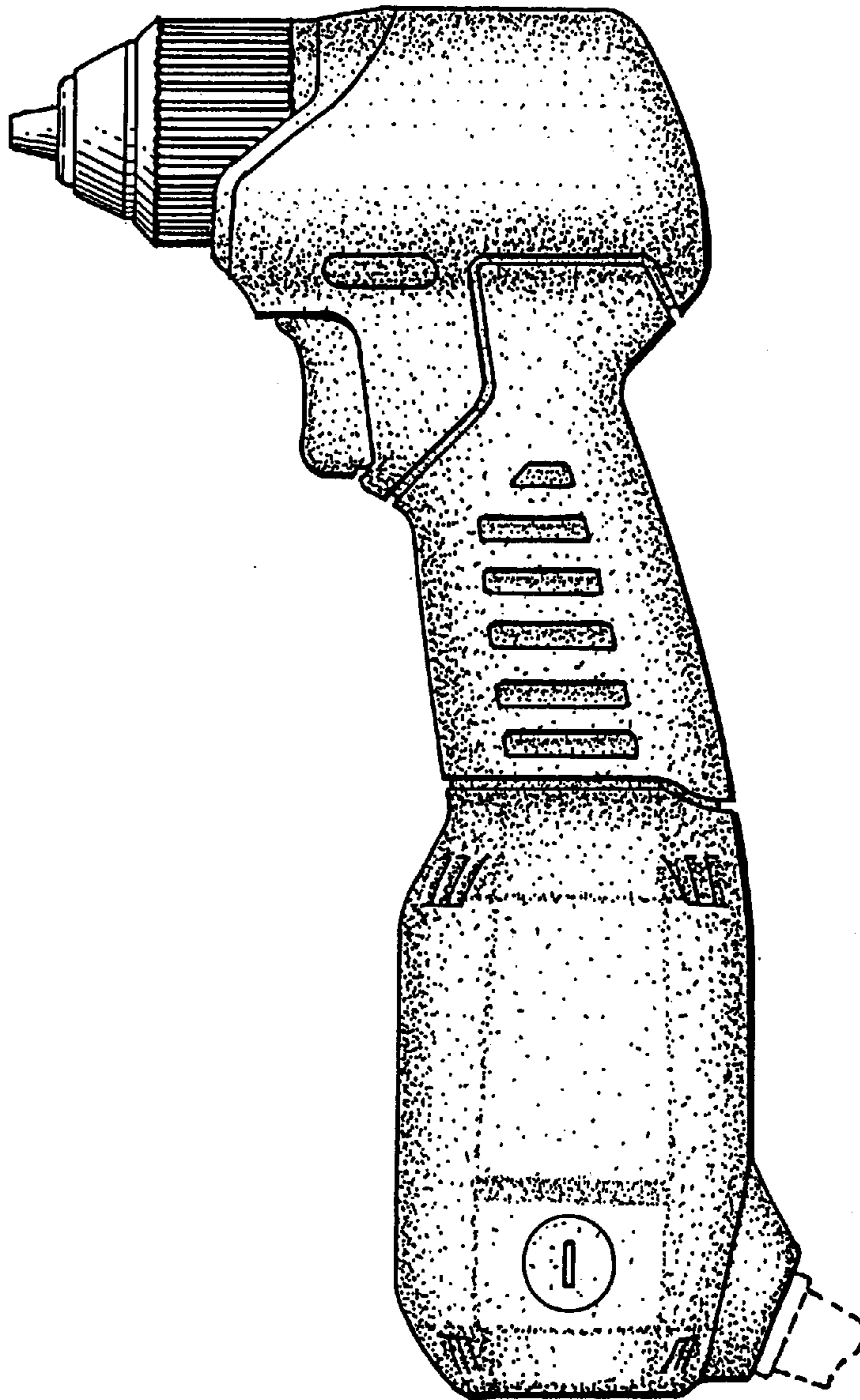
