(57) **CLAIM**

The ornamental design for a flexible package with inside printing, as shown.

**DESCRIPTION**

FIG. 1 is a cross sectional view of the flexible package with inside printing showing my new design;  
 FIG. 2 is a perspective view of one inside wall taken along the lines 2—2 on FIG. 1; and,  
 FIG. 3 is a perspective view of one inside wall taken along the lines 2—2 on FIG. 1, with the graphic panel exposed.  
 The broken line showing on FIGS. 1—3 is for illustrative purposes only and forms no part of the claimed design.

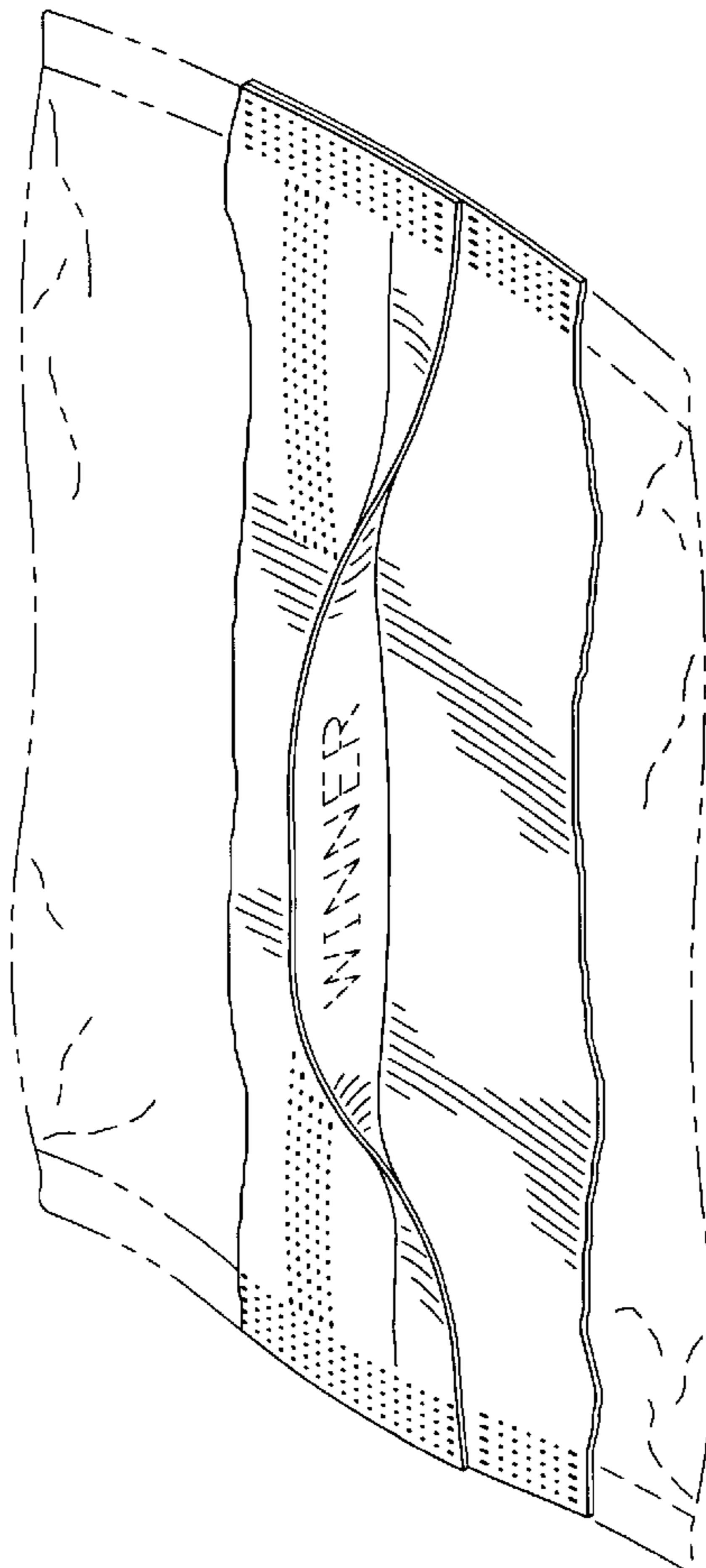

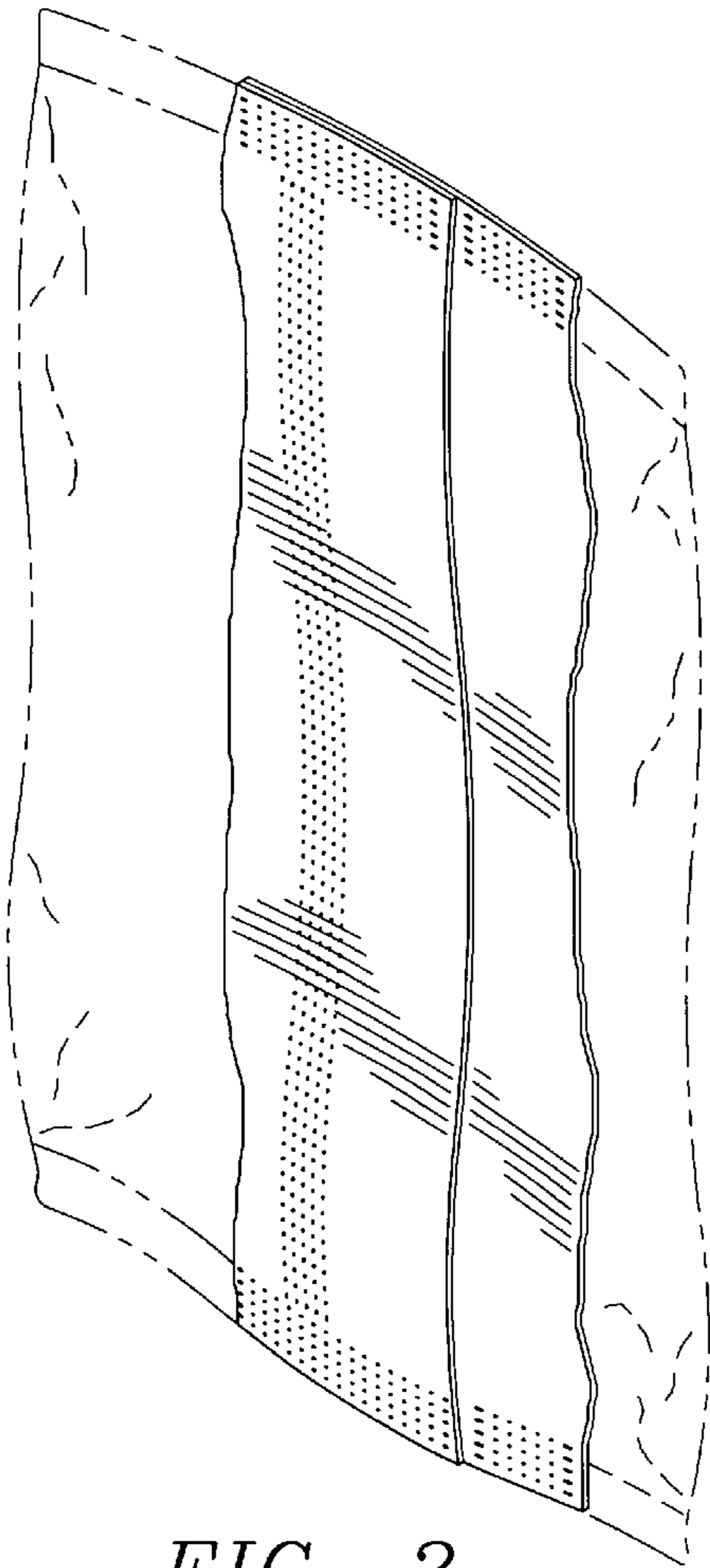

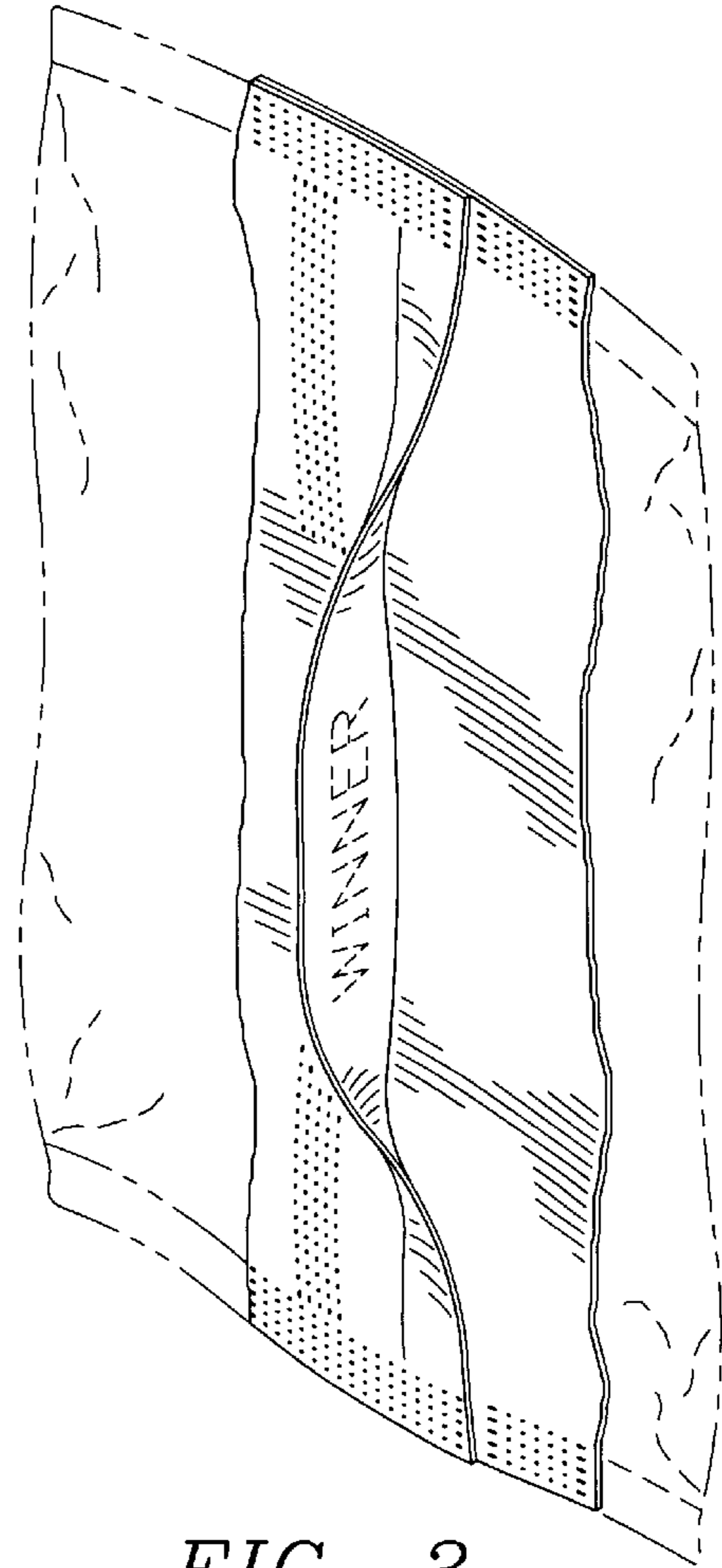
